


- Though the high point is the Conference meeting, the delegate's job Remind G.S.R.s to inform groups and individuals about the A.A. Grapevine and Conference-approved literature.
  - Cooperate with G.S.O. in obtaining information-for example, making sure that up-to-date information reaches G.S.O. in time to
- Attend the Conference meeting in April, fully prepared. Immediately upon election, every delegate is put on the G.S.O. mailing list to receive Conference materials.
- Communicate the actions of the Conference to area committee members and encourage them to pass on this information, and the delegate's enthusiasm, to groups and to intergroups/central offices. If an area is too large for the delegate to cover in person, he or she will ask area officers and committee members to share the load.
- Be prepared to attend all area, state/provincial, and regional service meetings and assemblies. From these meetings, delegates come to better understand their own areas and can make suggestions for the Conference agenda. Here, too, they come in contact with A.A. members who might not be reached otherwise.
- Help area committees obtain financial support for the area and G.S.O.
- Provide leadership in solving local problems involving the A.A. Traditions.

meet the deadline for each Issue 4f the A.A. directory and helping carry out the triennial membership surveys.

Visit groups and districts in the area whenever possible.

- Work closely with committee members and officers, sharing experience throughout the year. After G.S.R.s and committee members have reported on the Conference, learn from these A.A.s how groups and members have reacted.
- Assume added responsibility if the area chair and alternate chair are unable to serve. Or, if an area committee is not functioning effectively, the delegate may take an active role in remedying the situation.
- Keep the alternate delegate fully informed and active, so that the alternate can replace the delegate in an emergency.
- Late in the second term, work with newly elected delegates to pass along a basic knowledge of Conference proceedings and problems.

# **Public Information**

Thank you again for the honor and privilege of serving Area 35 as the PI Chair. We are very fortunate that in Area 35 we have so many members who are willing to serve in any capacity asking in carrying the message. I am very grateful to be a member of Area 35.

We held our Area 35 Committee meeting at Aitkin on June 1, 2008. At 9 a.m. we had our Action Chair Committee meeting. CPC and PI meet together at this meeting. The districts in attendance were 3, 5, 6, 8, 9, 13. We had 12 people in attendance. We went around the room and discussed what PI/CPC work each District was doing and any concerns they may have. Many Districts are providing public information to police stations, hospitals, health fairs, high schools, libraries, Chambers of Commerce, probations offices, and churches, to name a few.

One interesting point brought up is that a number of groups are changing their starting times. As these meetings continue, members would like feedback on the effects of changing the times. One area of concern is that meeting schedules must be changed to keep current. It is so important that our meeting schedules be kept current. It may benefit a District if a home group is deciding to change their meeting time to wait until that District is out of schedules and will be printing new ones. It's food for thought.

We are also schedules to cover Saturday, August 23 and Sunday, August 24 at the State Fair. We in Area 35 have to provide volunteers to cover the booth. We are also contributing \$500 of financial responsibility to support the booth. It is the State Fair Board's policy that this booth be manned at all times. So – please – if you have signed up, show up. Thank you so much.

We are also working on setting up PI/CPC Zonal Workshops. We would like to hold two workshops in 2008 and two workshops in 2009.

Brown University from his daughter. We went to Bemidji June 7 to here the long timers in that area and there experience of there early days of AA there. In AA COMES OF AGE there is a reference to the Stockholm (Sweden) seven steps on page 26. I often wondered what this had to do with AA and here is another example of why singleness of purpose is important. This info is from GSO Archives. When AA first came to Sweden, Alcoholics Anonymous came in the form of a different kind of society. A man named Axel Sällqvist, a nonalcoholic, learned about AA and began a group (with himself and six alcoholics) in Stockholm called "The Link Society" in 1945, to help alcoholics stop drinking. The Link Society was based on AA but soon distanced itself from AA in many ways.

The group shortened and condensed AA's Twelve Steps into something they called the "Seven Points." According to the book *The History of AA in Sweden*, which was written in Sweden and was approved by Sweden's General Service Conference in 1995, the "Seven Points" (short version) read as follows:

1. Admit that you cannot control alcohol.

2. You must believe in a power that is greater than your own.

3. Make no demands on your fellow human beings.

4. We strive for absolute honesty, purity, love for fellow human beings, and unself-ishness.

5. Admit your faults and shortcomings to another person.

6. Make amends to all persons you have harmed in any way.

7. As you have been helped, so you must help others.

The Link Society at first grew rapidly, and was very much associated with AA - -Link groups in the city of Göteborg were registered by our office as AA groups in the late 1940s. Bill visited in 1950, and kept corresponding with Link groups throughout the 1950s, but he was concerned about these groups being on the wrong track.

Eventually, the Link groups splintered, and Swedish alcoholics wrote expressing frustration with the fact that "The Link Society" was not "proper" AA, and was getting involved in too many "outside enterprises." We have letters from alcoholics who say they are founding their own AA group, moving away from the Link Society, "since they do not follow the concepts of Alcoholics Anonymous but are merely friends who still get together." Many "traditional" AA groups began forming all over Sweden, and gradually the Link Society and Alcoholics Anonymous parted ways - there was a particularly big split in 1958. The Link Society continued to influence AA in Sweden up until about the 1980s, however. Yours in service Bob K. Area 35 Archives Chair

It appears that the need for sober members to do Corrections Correspondence is in need again. They have been flooded with inmates asking for members to correspond with them. (Mostly males) There are 30 inmates on the waiting list. I need to do some follow-up work on a few people who were interested in doing a meeting @ Moose Lake, I will be getting in contact with them within the next month or so. That's all for now. If anyone has any questions, please let me know. Thanks for keeping me sober.

- *Treasurer* Greetings Area 35: It is good to be here with you all once again! Summer might actually shape up to pretty nice -- after that lovely winter! First I need to thank District 5 and Kelly for inviting me down, yesterday to join in on their International Day of Gratitude in honor of the upcoming 73rd Anniversary of Dr. Bob's last drink and the birth of Alcoholics Anonymous! It was a day of Fellowship, good food and most importantly sharing from Past Delegate Charlie C and Archivist Brad I. I, as well, was given the privilege of sharing some of my experiences with Gratitude and various ways and whys of expressing my Gratitude.
- Now for the numbers! This opportunity is becoming a bit mind boggling. Just when I think I have it figured out and ready to print, I take one last glance through and find one or more figures that are listed under the wrong category, person, or not listed at all. By the way, I need to thank you all for your patience with me thus far. This morning, while perusing through some past reports in an effort to insure that all expenses have been accurately documented, I made a startling revelation! on the Period II Details and Expenditure Reports and I presume Period I as well; most of the officers and/or Chairs were listed to have spent more for that particular Period, than was documented under the Year To Date column. I have heard rumor and seem to remember past years where people actually brought these errors to the attention of the baffled Treasurer. Evidently I have mystified all of you so much with my astuteness in these areas that you have simply accepted my work as being correct and been blinded to my apparent and implausible imperfections. Having now made you aware of these inaccuracies, I have no doubt you may peruse the figures more carefully and I will no longer be able to get away with anything. Amongst my more glaring inaccuracies are the following: 1) back prior to the GSC, in February , I wrote a check to GSO for \$1200 that was never listed on any reports, 2) and also the cost of the initial printing of the NL, in January was not listed. Both of these expenses would have fallen into Period I.
- Oh yes, the numbers: There are three reports for your perusal today. The first is the listing of Group Contributions. Total Contributions for Period III (April 1 to May 26) was \$3,788.66. This added to the moneys collected from coffee sales and also from the GSR Sharing Session which practiced the 7th Tradition results in a total Income for P-III of \$4,135.77, as noted on the Contributions and Expenditures Report. The expense for the Spring Assembly was \$1,050.88 and total expenditure for the Officers and Chairs was \$3,909.98 (which is documented on the Details and Expenditures Report). On the bottom of the Contributions and Expenditures report is your Statement of Retained Funds; which indicates a starting balance on January 1st, "08 of \$12,293.01 plus the YTD income of \$13,105.29 minus the YTD Expenses of \$14,964.12 giving us a total of \$10,434.18 on May 26, "08. We attempt to retain a prudent reserve of two months operating expenses, or \$6,000 (rounded to the nearest \$1000). This subtracted from the remaining balance gives us \$4,434.18 usable funds. Our expected (Budget) expenses for the remainder of this year are roughly \$21,470 with seven months remaining. Our average spending per month has been \$3,000 thus far and our income has been an average of \$2600. If we are to meet our planned obligations throughout the remainder of this year we will need to amp up our contributions a bit.
- Please do not forget the Birthday Plan as an expression of your Gratitude for this life saving Fellowship. As you can see on the back page of the Contributions Report we currently have only one member who has financially expressed her Gratitude to this Area. Perhaps the rest of us sobered up later in the year. A suggestion from GSO, which I am expecting to put into action, is to incorporate a Fellowship day on October 4th, during the Fall Assembly. The suggestion from GSO is for members to contribute \$2 on that day. I haven't quite figured out the details yet, but I am working on it.
- GSO reported that in 2006 there were 531 registered groups in Area 35, with 239 of these making contributions to GSO. This is 45% which is, in my opinion quite sad, though it is comparable with the National average. Just as a point of interest, NE Quebec reports that 99.9% of their groups contributed to GSO, in 2006; for all of Quebec the average is 60.13%. The only areas in the US that come close to this are Connecticut with 59.3% and Utah with 58.7%. It appears that Canadians exhibit their Gratitude differently than we do; that or maybe their cost of living is lower, which seems doubtful to me. Wouldn't it be nice if Area 35 could have 60% of our groups contributing? Just a thought! Thank you again for your apparent patience with me and for the honor and privilege of serving Area 35 in this capacity. Yours in Service, Beth e.

Area 35 Inventory - Here's the plan: We will be holding breakout sessions at the fall assembly during the time usually designated for the Saturday night Speaker. The inventory will consist of 9 questions, and each group will have 3 questions to discuss, one which will be the common question: What other concerns do you have that are not addressed in this inventory? Four DCM's will proctor the breakout sessions: Kelly-District 5, Mary-District 16, Tim-District 12, and Roger-District 13. After the breakout sessions, we will reconvene in full assembly and use a format similar to what we follow in agenda item discussions, where the DCM will read the question, give a brief summary of the breakout session discussion regarding what we are doing right in the pertinent area, and what we could improve on, then they will open it up to floor discussion. #### NEW BUSINESS

- Cost of Assemblies District Involvement- some people are very opposed to having our assemblies at casinos, partly due to gambling
  - but largely due to the uncontrolled smoke bothering health problems. Second, the cost of hotel rooms and banquet rooms is getting extremely high. So we are caught. Other options include bible-camps, etc, but I really need your help-a sense of direction on which way we need to go. We can stay with hotels and convention centers at a cost of \$1,000 for banquet room and \$100 for hotel rooms, or go cheaper and go with the casinos. The third option is to get away from having the hotel and banquet rooms connected which causes some different difficulties, but would reduce our costs greatly. Floor Discussion: MC- get a committee to search for alternative sites and come back with some recommendations-I know of a huge bible camp that could hold us. SA-the way that it was created was the DCMs in the zone were to meet in a small committee to discuss this, then go out into their communities and find places, and report back with the options. There used to be a packet for the DCM's telling them what information and questions they needed to ask the respective places. I see nothing wrong with meeting at a bible camp, or technical colleges, anywhere, as long as it works out financially. JS- DCM's once they have the hotel information they turn it over to Jay and he negotiates with the hotel. We need to start two years in advance with this stuff. If we have DCM's getting the information on time, then we have more choices. Jay-I am asking DCM's from Zone III, I need you to get together and get a plan of action for the Spring Assembly and go out and find locations for the . Zone IV, I need to know four or five places within a month.
- Printing Area Assembly and Committee Meeting Minutes in the Northern Lights- would the area be interested in printing the minutes in the Northern Light, instead of mailing them out separately? It will save us a large amount of money, as it cost us \$120 to mail out minutes and \$260 to print them, on top of the Northern Light printing and mailing costs. Discussion: Can we have more NL made available. Mike P. absolutely, if you want more just let me know. The minutes will also be available in the NL online in an anonymity protected version, which is a great thing. A motion was made to include the Spring, Fall and Area Committee Meeting minutes in the Northern lights. All in favor.
- *Clarification on Area Chair Zonal Workshops-* confusion over the requirements of area chairs to hold 4 workshops during their rotation. This is nowhere in any of the action booklets. I believe it came from archives that they wanted to do this, but it was never set as an area action. I am asking for clarification on this. It is really more of the local district responsibility, we are more than happy to do these workshops, but we want district involvement and clarification. Discussion: JS-When I first remember this, the corrections committees weren't getting the bang for their buck, and they stopped doing them. But when they were asked by districts, they would be there to participate, which could result in more work with 18

districts, but in my opinion, it should be that chairs go to districts if they are asked. Consider budgeting for these-making sure finances are there for these. SA-I have never heard, or read that committees need to have zonal workshops. A lot do, I think they are really good, you get to go to districts and talk to people, but there was never a "have to." It might be in the guidelines for chair positions. JA- as we don't have the information here, we don't have enough info at this time to make a decision. I request we table it and bring it back up at the August committee meeting.

1. Area Chair calls to cancel and/or re-schedule.


2. Based on DOT report, national weather service, individual safety being paramount

# Let's Ask Bill Wilson

**Question:** If an alcoholic comes to an A.A. meeting under the influence of alcohol, how do you treat him or handle him during the meeting?

Bill W. Groups will usually run amuck on that sort of question. At first we are likely to say that we are going to be supermen and every drunk in town. The fact is that a great many of them just don't want to stop. They come, but they interfere very greatly with the meeting. Then, being still rather intolerant, the group will swing way over in the other direction and say, "No drunks around these meetings." We get forcible and put them out of the meeting, saying, "You're welcome here if your sober." But the general rule in most places is that if a person comes for the first or second time and can sit quietly in the meeting, without creating an uproar, nobody bothers him. On the other hand, if he's a chronic "slipper" and interferes with the meetings, we lead him out gently, or maybe not so gently, on the theory that one man cannot be permitted to hold up the recovery of others. The theory is "the greatest good for the greatest number." (Yale Summer School of Alcohol Studies, June 1945)

# **AREA 35 INVENTORY UPDATE**

We voted at the Spring Assembly 2008 to conduct an area inventory. This inventory will be held on Saturday night of the 2008 Fall Assembly. It will be held at the time we normally have a speaker.

The four DCMs that accepted the responsibility to proctor the questions in these breakout sessions are:

•Kelly Dempski – DCM, District 5. Questions 1, 2, 9

•Mary Coy – DCM, District 16. Questions 3, 4, 9

•Roger Rudolph – DCM, District 13. Questions 5, 6, 9 Tim Herstad – DCM, District 12. Question 7, 8, 9

1The nine questions to be used in this inventory area as follows:

**1.Is the Area passing down and collecting information effectively for General Service Representatives, Districts, and Action Committees?** 

2.Do all Districts feel a part of the Area and receive equal attention and service?

3. Are the Action Committees doing enough to assist Districts in committee work? Are we spending money prudently as an Area? Consider the following:

-expenses

-committee work

-communications (Northern Light, mailings)

-accommodations (coffee, room rates at Assemblies, Workshops, Area Committee meetings

5. When Area decisions are made, is there the correct balance between group conscience and the tradition "Right of Decision"? (Concept III)

6. Are Assemblies conducted expediently and effectively? Consider the following: -length of reports

-Saturday night open meeting or conducting business

-taking a lunch break on Sunday or ending at noon

7. Is adequate opportunity given to all to speak and participate in Area Assemblies, Workshops, and activities?

8. Are Area Workshops worthwhile? How about the format?

9. What other concerns do you have that are not addressed in this inventory?

It is so important that we do all we can at any and every level of service in carrying the message. It is this committee's hope that at this inventory, not only do we point out our deficiencies but also offer suggestions on how to improve our Area. We feel that a good Area inventory will be healthy for Area 35.

## **On Tradition Ten**

"Alcoholics Anonymous has no opinion on outside issues; hence the A.A. name ought never be drawn into public controversy."

No A.A. Group or member should ever, in such a way as to implicate A.A., express any opinion on outside controversial issues -- particularly those of politics, alcohol reform, or sectarian religion. The Alcoholics Anonymous Groups oppose no one. Concerning such matters they can express no views whatever.

To most of us, Alcoholics Anonymous has become as solid as the Rock of Gibraltar. We like to believe that it will soon be as well known and just as enduring as that historic landmark. We enjoy this pleasant conviction because nothing has yet occurred to disturb it; we reason that we must hang together or die. Hence we take for granted our continued unity as a movement.

But should we? Though God has bestowed upon us great favors, and though we are bound by stronger ties of love and necessity than most societies, is it prudent to suppose that automatically these great gifts and attributes shall be ours forever. If we are worthy, we shall probably continue to enjoy them. So the real question is, how shall we always be worthy of our present blessings?

Seen from this point of view, our A.A. Traditions are those attitudes and practices by which we may deserve, as a movement, a long life and a useful one. To this end, none could be more vital than our 10th Tradition, for it deals with the subject of controversy -- serious controversy.

On the other side of the world, millions have not long since died in religious dissension. Other millions have died in political controversy. The end is not yet. Nearly everybody in the world has turned reformer. Each group, society and nation is saying to the other, "You must do as we say, or else". Political controversy and reform by compulsion has reached an all-time high. And eternal, seemingly, are the flames of religious dissension.

Being like other men and women, how can we expect to remain forever immune from these perils? Probably we shall not. At length, we must meet them all. We cannot flee from them, nor ought we try. If these challenges do come, we shall, I am sure, go out to meet them gladly and unafraid. That will be the acid test of our worth.

Our best defense? This surely lies in the formation of a Tradition respecting serious controversy so powerful that neither the weakness of persons nor the strain and strife of our troubled times can harm Alcoholics Anonymous. We know that A.A. must continue to live, or else many of us and many of our brother alcoholics throughout the world will surely resume the hopeless journey to oblivion. That must never be.

As though by some deep and compelling instinct we have thus far avoided serious controversies. Save minor and healthy growing pains, we are at peace among ourselves. And because we have thus far adhered to our sole aim, the whole world regards us favorably.

May God grant us the wisdom and fortitude ever to sustain an unbreakable unity.

## **On Tradition Nine**

"A.A., as such, ought never be organized; but we may create service boards or committees directly responsible to those they serve."

"Each A.A. Group needs the least possible organization. Rotating leadership is the best. The small group may elect its secretary, the large group its rotating committee, and the groups of a large Metropolitan area their central or intergroup committee, which often employs a full-time secretary. The Trustees of The Alcoholic Foundation are, in effect, our A.A. General Service Committee. They are the custodians of our A.A. Tradition and the receivers of voluntary A.A. contributions by which we maintain our A.A. General Service Office in New York. They are authorized by the groups to handle our over-all public relations and they guarantee the integrity of our principal newspaper, "The A.A. Grapevine." All such representatives are to be guided in the spirit of service, for true leaders in A.A. are but trusted and experienced servants of the whole. They derive no real authority from their titles; they do not govern. Universal respect is the key to their usefulness."

The least possible organization, that's our universal ideal. No fees, no dues, no rules imposed on anybody, one alcoholic bringing recovery to the next; that's the substance of what we most desire, isn't it?

But how shall this simple ideal best be realized? Often a question, that.

We have, for example, the kind of A.A. who is for simplicity. Terrified of anything organized, he tells us that A.A. is getting too complicated. He thinks money only makes trouble, committees only make dissension, elections only make politics, paid workers only make professionals and that clubs only coddle slipees. Says he, let's get back to coffee and cakes by cozy firesides. If any alcoholics stray our way, let's look after them. But that's enough. Simplicity is our answer.

Quite opposed to such halcyon simplicity is the A.A. promotor. Left to himself he would "bang the cannon and twang the lyre" at every crossroad of the world. Millions for drunks, great A.A. hospitals, batteries of paid organizers and publicity experts wielding all the latest paraphernalia of sound and script; such would be our promoters dream. "Yes sir," he would bark "My two year plan calls for one million A.A. members by 1950!"

For one, I'm glad we have both conservatives and enthusiasts. They teach us much. The conservative will surely see to it that the A.A. movement never gets over organized. But the promoter will continue to remind us of our terrific obligation to the newcomer and to those hundreds of thousands of alcoholics still waiting all over the world to hear of A.A.

We shall, naturally, take the firm and safe middle course. A.A. has always violently resisted the idea of any general organization. Yet, paradoxically, we have ever stoutly insisted upon organizing certain special services; mostly those absolutely necessary to effective and plentiful 12th Step work.

If, for instance, an A.A. group elects a secretary or rotating committee, if an area forms an intergroup committee, if we set up a Foundation, a General Office or a Grapevine, then we are organized for service. The A.A. book and pamphlets, our meeting places and clubs, our dinners and regional assemblies -- these are services too. Nor can we secure good hospital connections, properly sponsor new prospects and obtain good public relations just by chance. People have to be appointed to look after these things, sometimes paid people. Special services are performed.

But by none of these special services, has our spiritual or social activity, the great current of A.A. ever been really organized or professionalized. Yet our recovery program has been enormously aided. While important, these service activities, are very small by contrast with our main effort.

As such facts and distinctions become clear, we shall easily lay aside our fears of blighting organization or hazardous wealth. As a movement, we shall remain comfortably poor; for our service expenses are trifling.

With such assurances, we shall without doubt, continue to improve and extend our vital lifelines of special service; to better carry out our A.A. message to others; to make for ourselves a finer greater society, and, God willing, to assure Alcoholics Anonymous a long life and perfect unity.



## THE STRANGE OBSESSION By Bill W.

It was a hot night in the midsummer of 1934. I found myself at a noted address in Central Park West, New York City. It was in Charlie Towns Hospital for drying out alcoholics.

Sobering and sweltering out a fearful hangover I laid abed in an upstairs room. Downstairs the doctor looked across his desk at my wife Lois.

She was saying, "Doctor, why can't Bill stop drinking? He always had great willpower. Yet here he is, facing ruin again, and still he can't stop. The more he struggles, the worse he gets. I am scared, heartbroken and confused. I know he is, too. He'd do anything at all to stop. Tell me, Doctor, why can't he?"

Lois was asking the same terrible question that uncounted women had asked before. Her's was a riddle quite as old as man's first discovery that alcohol could be made from grapes and grains.

Again she said, "Please tell me the truth doctor. Why can't Bill stop?"

In his long experience with serious drinkers the good doctor had faced that terrible heartbreaker a thousand times. By nature compassionate, he never failed to wince whenever a distraught wife, husband or friend of a sufferer had profounded anew the burdened riddle of alcoholism. Bill's dilemma had interested and moved him deeply. How could he now bring himself to tell Lois the truth?

The benign little doctor's face turned grave as he began to speak. "When Bill first came to this hospital three years ago, I felt that he might be one of those rare cases who might recover. I hoped that when he better understood himself and the nature of his illness, he might win out. In spite of his several severe relapses since then, I have gone on hoping. For, as you say, he desperately wants to quit and his will to do so is very great. But now I'm discouraged. I'm afraid he's going to be like nearly all the other alcoholics who come my way."

"Well Doctor," cried Lois, "just what do you mean by that. Won't he ever get better?"

Gently, the Doctor went on, "Mrs. W.," said he, "As you already understand, your husband is a sick man. But I've never told you just how sick an alcoholic can be, nor have I ever explained this illness to you as I understand it from my long observation. I think the time is here to tell you more about his illness and how really serious his condition now is. There are a lot of theories about the underlying causes of compulsive drinking like Bill's. Of these we can take our pick. But there are some solid facts, too, which no one who has watched many alcoholics could well dispute.

"Fact one is that innumerable alcoholic men and women really want to control their destructive drinking and then find, to their dismay, that they cannot. They cannot moderate their drinking as other people do. Nor, even when faced with the most terrible consequences, can they stop altogether, no matter how desperate their plight. Never do the excuses they make for their sprees justify their pattern of continuous self-destruction. Their behavior becomes completely illogical and irrational - it really verges on insanity. And even when they well understand all this, they go on as before. Where alcohol is concerned, their minds no longer rule their emotions.

"A new spree can be started upon the slightest of excuses or rationalizations. Sometimes the provocations seem great, but it's always very small when the certain destructive results are considered. When for example life gives the average man a heavy bump, he doesn't seize a hammer and beat himself into insensibility. Yet, in effect, that's what the sick alcoholic does, over and over. All reason, all incentive, even the greatest desire to stop, seems to be swamped when the craving for alcohol takes hold.

"Therefore the biggest fact about alcoholism is its obsessional nature. It is one of the most subtle yet most powerful compulsions known. Once it's grip is firm, the chance for recovery is diminished. How to help the alcoholic to expel his obsession is the problem. But we doctors have had little success: I've seldom helped even one case in a hundred.

"Nor is the drinkers obsession the whole story: alcoholism is a physical malady too. In nearly all cases the bodies of problem drinkers become painfully sensitive to alcohol. In the early stages of their malady some alcoholics can drink quantities of liquor without serious physical reaction. But continued excesses finally cause them to lose that ability; they seem to get allergic to the stuff; so much so that hangovers produce great physical agony and some-times delirium tremens or convulsions too often followed by brain damage and mental deterioration than can be permanent."

#### Again she asked, "Doctor, what can we do?"

So he had to tell her that I would have to be locked up or go mad and die. That it would all end with heart failure during delirium tremons, or that I would develop a wet brain, perhaps within a year. That soon I would have to be given over to an asylum or an undertaker.

I am responsible. When anyone, anywhere, reaches out for help, I want the hand of A.A. always to be there. And for that I am responsible.



# **NORTHERN LIGHT PRIMARY PURPOSE:**

The Northern Light (N.L.), is a general service newsletter that **EDITORIAL POSITION & N.L. COMMITTEE:** serves Area 35 to facilitate bilateral communication between the groups, districts, Area and G.S.O. levels in the Northern Minnesota area. Its purpose is to:

- Publish an informative and attractive newsletter to the Area • in a timely fashion.
- Encourage District reports and be available to work with • Districts on communications. One or more of the N.L. Committee should try to attend area events to report on what's happening in their areas. If they are unable to attend, encourage local members to write short articles about events and happenings to be published in the N.L.
- Provide encouragement for writing articles, particularly to D.C.M.s and Area Action Committee Chairs. This should include the strong encouragement to submit their reports for each issue, if no report is submitted it will be stated, example "Northern Light Report - NOT GIVEN" this is currently being done in the Southern Minnesota Area newsletter.
- Keep informed of activities and issues going on within Alcoholics Anonymous as a whole. The N.L. Committee could subscribe the Grapevine or other pertinent A.A. news sources.
- Gather useful service information to publish from sources within the Area, Region and A.A. as a whole. Obtain, read and use other Area newsletters.
- Listen to comments from the Area on the content of the N.L.

- Editor The Editorial Chair is an elected position held during a two-year rotation.
- Desirable qualifications: Current or past working knowledge of the printing business. Knowledge of current computer printing programs. The person should also consider the time needed to complete the task required. The candidate should have a working knowledge of A.A. as a whole, i.e., prior experience in service work such as G.S.R., D.C.M., or related position.
- N.L. Committee The N.L. Committee consists of two D.C.M.s in Area 35. Currently, these have been picked randomly at the start of the new rotation. They also serve on a two-year rotation basis. They assist the editor in communications with other area newsletters, in recommendations on general improvements, and with general problems and implementations of new policies. They may also represent the editor at functions when the editor is unable to attend. Seek advice and help from former N.L. Committee members and editors.

#### **N.L. COMMITTEE MEETINGS:**

The Committee meets every other month before the start of the Area Workshop and at Spring and Fall Assemblies. Additional meetings may be called for if needed between these times.

#### **Twelve Concepts for World Service (Short Form)**

- I. Final responsibility and ultimate authority for A.A. world services should always reside in the collective conscience of our whole Fellowship.
- II. The General Service Conference of A.A. has become, for nearly every practical purpose, the active voice and the effective conscience of our whole Society in its world affairs.
- III. To insure effective leadership, we should endow each element of A.A.-the Conference, the General Service Board and its service corporations, staffs, committees, and executives-with a traditional "Right of Decision."
- IV. At all responsible levels, we ought to maintain a traditional "Right of Participation," allowing a voting representation in a reasonable proportion to the responsibility that each must discharge.
- V. Throughout our structure, a traditional "Right of Appeal" ought to prevail, so that minority opinion will be heard and personal grievances receive careful consideration.
- VI. The Conference recognizes that the chief initiative and active responsibility in most world service matters should be exercised by the trustee members of the Conference acting as the General Service Board.
- VII. The Charter and Bylaws of the General Service Board are legal instruments, empowering the trustees to manage and conduct world service affairs. The Conference Charter is not a legal document; it relies upon traditional and the A.A. purse for final effectiveness.
- VIII. The trustees are the principal planners and administrators of overall policy and finance. They have custodial oversight of the separately incorporated and constantly active services, exercising this through their ability to elect all the directors of these entities.
- IX. Good service leadership at all levels is indispensable for our future functioning and safety. Primary world service leadership, once exercised by the founders, must necessarily be assumed by the trustees.
- X. Every service responsibility should be matched by an equal service authority, with the scope of such authority well defined.
- XI. The trustees should always have the best possible committees, corporate service directors, executives, staffs, and consultants. Composition, qualifications, induction procedures, and rights and duties will always be matters of serious concern.
- XII. The Conference shall observe the spirit of A.A. tradition, taking care that it never becomes the seat of perilous wealth or power; that sufficient operating funds and reserve be its prudent financial principle; that it place none of its members in a position of unqualified authority over others; that it reach all important decisions by discussion, vote, and, whenever possible, by substantial unanimity; that its actions never be personally punitive nor an incitement to public controversy; that it never perform acts of government, and that, like the Society it serves, it will always remain democratic in thought and action.
