

## **AREA 35 MEETING MINUTES - UNAPPROVED**

Area 35 Spring Assembly Minutes Ely, MN April 2-3, 2022

**Call to Order:** Christine G called the meeting to order at 1:00 p.m. on Saturday, April 2, 2022, and opened with the Serenity Prayer. There were 127 people in attendance.

**Recognition of Past Delegates In Attendance:** Area 35 – Scott J, Panel 38; Susie A, Panel 48; Tom A, Panel 50; Charlie C, Panel 54; Jim K, Panel 62; Jake J, Panel 64; Kelly D, Panel 66; Jim S, Panel 70. Area 36 – Scott A, Panels 57 and 59

**Removal of Motion:** Sally L. withdrew her motion made at the Dec. 5, 2021, Area Committee Meeting. The motion was **"We move on and accept what happened at the Fall Assembly and discuss with the groups what we want to do, in the future, with Past Delegates serving the Area as Officers or Area Chairs." There was no opposition, and the MOTION WAS WITHDRAWN.** 

Additions to Agenda: None

Approval of October 2021 Fall Assembly Minutes: Nels P. motioned to approve the minutes, Jim R. seconded, MOTION PASSED UNANIMOUS-LY.

Agenda Item Sharing Sessions were facilitated by Delegate Steve L.

#### <u>OFFICER REPORTS</u> <u>DELEGATE – STEVEN L</u>

Good Evening Everyone,

Are you full of knowledge about agenda items? Have you had your fill yet? There is a lot more to discuss at this assembly. Thank you for coming and participating in this process. I now have a good sense of what our Areas conscience is pertaining to the agenda items discussed here this weekend.

At my last WCR Delegates meeting on March 28<sup>th</sup>, Mike L., our West Central Trustee, gave a report about what happened at the GV board meeting. There was good news and bad news. The GV's preliminary year end audit was showing a surplus of 24K, but after the final audit analysis, the GV ended up with a 46k loss for the year. The GV board had projected a 300k deficit for 2021. So, the good news is we beat the 300k deficit, the bad news is our end of the year surplus dived into a yearend loss. This happened because of personnel shuffles and departures which caused some bills to be misplaced. Some of these bills were changes in GV distributers, Software overrun and bad debt forgiveness. (For your comfort-please note that GSO is in the process of hiring a new auditor to prevent surprises like this from happening again.)

Stacy M., Area 36 Delegate, gave a report on how this year's WCRSC went. She stated the final count was 438 people in attendance with approximately 83 by zoom. The WCRSC had a revenue of \$9,521 Stacy had a rough breakdown of expenses, unfortunately we ended up with a loss of \$2,005.40. Two big expenses were \$1,920 for the signing interpreters (which weren't needed this time) and a surprise gratuity cost which came to 33%, which Stacy said was buried in the contract saying the hotel could charge what it wanted for its gratuity. I know we warned the next host Area to keep an eye out for that clause. On the bright side the WCRSC is now incorporated in Montana (I think) and 501(c)4 nonprofit approved by the IRS.

I've put on a few miles on my truck in the past few weeks going to different districts and sharing thoughts and ideas about the agenda items. Attendance was varied from 8 to 50 participating. Some meetings had a lot of GSRs some had a few GSRs. Hopefully the intimacy of sharing in the small groups helped in the process this weekend. I want to thank everyone who attended these agenda item discussions. Your Insite was inspiring and educational.

We have some very important topics to discuss at this assembly. We have

#### ALTERNATE DELEGATE – JUSTIN W

Alternate Delegate Report – April 1<sup>st</sup>, 2022 – Spring Assembly Greetings. I did attend the West Central Regional AA Service Conference the first week of March and was able to attend the Delegate's Meeting on Thursday March 3<sup>rd</sup> as an observer. In attendance were Mike L - the West Central Regional Trustee; all 8 Area Delegates and their Alternates, Dennis B - the WCR Administrator, as well as Bob W – General Manager of the General Service Board of Alcoholics Anonymous. The West Central Region is a bit more organized than I realized, registered as a non-profit with a bank account. All of the money comes from registration fees for attendance at the West Central Regional Conference. We discussed some proposed changes to the West Central Regional Guidelines mostly centered around the scope and composition of the Administrator position and responsibilities. Some remaining logistical issues with the Conference itself were addressed, and Bob W mentioned that GSO is returning to the office building in New York City. It was my first time in attendance, and I appreciated the opportunity to attend.

As well, I attended the Delegates and Past Delegates Meeting on Friday. It was like an orientation where the new delegates got to ask questions and hear the shared experience from the folks who have gone before them. There was a live zoom feed with around 8 participants and a room full of experience. I didn't get a count, but I believe there were as many Past Delegates as there were currently serving Delegates and alternates combined, including several from Area 35. Again it was a privilege to have had this opportunity.

Some of the highlights of my experience there were the opportunity to talk to AA friends from other areas within the region, as well as getting to meet and talk with our new General Service Manager – Bob W. We did spend some time with him after his talk expressing our concerns about some recent communications from the general service office, specifically the safety document SMF-209 that was published to aa.org. He seemed to share our sentiment that the ideas that were expressed in the document were unprincipled and stated that the document had been taken down off of the website for editing. While some societal issues will inevitably make their way into Alcoholics Anonymous, we should all recognize this fact as contrary to our principles; a shortcoming rather than a virtue. Each group has but one primary purpose and if we are to develop and express opinions on all of the societal issues outside of AA, we will be drawn into controversy and tread the path of the Washingtonians. We did cover all of the Agenda Items as planned.

The event itself was well put together in my opinion and I enjoyed the hospitality suite that was hosted by Area 36. There was always coffee in there, as well as a whole bunch of stuff we should have eaten, but more importantly a constant supply of great fellowship with the folks in there.

I have done some reading of last year's final conference report and other conference materials like quarterly GSB Meeting Minutes and Highlights. I have not completed these as of yet. As well, I am preparing for next years' service workshop after having something of a fire lit under my....chair...by this guy named Jim. It will be held here in zone 4 and I expect to have the venue selection and speaker selection completed by the June ACM. Thank you for listening and for the opportunity to serve.

#### **CHAIR – CHRISTINE G**

Greeting Area 35, Since the West Central Regional Service Conference, I have been working on getting the agenda set for this assembly. It sure is a learning process and making sure that you have everything on there and it is formatted correctly. Also, I would like to remind you that if you have something to add to the June 5<sup>th</sup> ACM agenda, please get with me by May 1<sup>st</sup>. We may have to add items after the fact but it is nice to see how much business we will have to take care of in June. Please remember that we will be setting up a special meeting in August, before the regular scheduled ACM, for the GSRs to attend if we have some GSC Agenda items to vote on as an area. More information will follow on that.

Jointly with A36 Chair, we have decided to create an Ad Hoc committee to review the current aaminnesota.org joint meeting locator to determine its purpose and usefulness. As this joint committee meets, they will report to the areas of their work.

Archives to debate. We have been warned for the last couple of years that we had to find a new storage place for our archives. So, first we have to decide if we want to continue having an archive. Then, do we want to pay to have a storage location that is suitable to store the archive and monetarily support the archive of possibly up to \$6,600 a year (\$550 a month)? We have to discuss if the assembly body wants to let past delegates continue to serve the Area as an officer and/or action committee chair if they haven't held that position before. It's been said in our literature, "that the good is the enemy of the best". Let's all remember this. It's up to you GSRs to determine what is best for Area 35.Please take the time and discuss these issues during breaks, eating lunch and at dinner.

Any past Delegates that would be interested in the WCR secretary position (Dennis B's job) let me know. Dennis 2 year fill in is done. We will be voting in the WCR lunch at the conference on this.

Lastly, I want to thank all of you for allowing me to be your voice at the general service conference. I'm now well armed with the voice of Area 35.

On 3/2/2022, App Support notified Area 35 Group Records that all of the groups/meetings, listed with the General Service Office (GSO) within District 13, had been routed to an entity not within the service structure of Area 35, nor the upside-down service triangle of Alcoholics Anonymous. This means that when a group listing is viewed on the Meeting Guide App, any updates to the group information, via the Meeting Guide App would be routed to this entity.

After discussions with the Area 36 Chair, I decided to contact App Support immediately asking how this change was made without any communication with me, serving as the Area 35 Chair. Area 35 is a part of the A.A. service structure. I stated to App Support staff, that I do not authorize any further changes. Through continued communication, I learned App Support is managed by staff at GSO. The Meeting Guide is defined by the Meeting Guide App "It is a service of A.A. World Services and the General Service Board. Our goal is to create a resource that provides accurate, up-to-date information to our fellowship, and, in doing so, more closely link our members and service entities." This information is noted from the Contact area on the Meeting Guide App version 3.9.30. In the meantime, Area 36 and Area 35 Chairs had a meeting at the WCRAASC with the West Central Regional Trustee, Mike L., and Bob W., General Manager at the General Service Office, to get a better understanding of the involvement of App Support and

#### <u>CPC – GREG C</u>

The General Manager and our Trustee affirmed that the role and responsibility of being Area Chairs is the maintenance of an Area. I know that this responsibility includes safeguarding the Unity, Health, and Safety of Area 35. I will continue to be focused on this.

On 3/7/22, I received an email from the Digital Product Manager asking for further clarification. On 3/8/22, I emailed the Digital Product Manager, laying out all the concerns which included concerns from groups in District 13. By the end of day, the problem was fixed, and most of the errors have been addressed and/or been fixed.

On 3/22/22 a correspondence was sent to GSO General Manager and WCR Trustee regarding decisions made in 2017 that have had a negative effect on joint A35/A36 unity.

On 3/30/22, I was asked to attend the Wednesday Night Primary Purpose Group in Waite Park to answer some questions they had about the election. The questions and responses were as follows:

What happened leading up to the Assembly? I was asked if I would be willing to stand for Area Chair about 1 week prior to the assembly. I mentioned that once a person has served as delegate they are generally done serving at this capacity. My statement was challenged by stating that there has not been anything noted in the Action Book about past delegates not being able to stand and that there have been some discussions going on about it. I said I would pray about it. Nothing was brought up to me again until Sunday morning of the Fall Assembly and I said I would accept the nomination. I made sure that Gayle was informed so she could take care of her business. I was then questioned why I didn't let the Chair of the election know; I was not aware I was supposed to do that.

**Why did I accept the nomination?** I have been taught that if I am able and willing, I should serve. I did not realize this was a contentious issue and by no means was my intent to be deceiving, malicious or take this position on for any sort of prestige. I have seen other areas, in the WCR, have their past delegates serve.

Why did I accept the subsequent position? If you are asking why I didn't resign at the December ACM, this should be a group conscience decision. If the area assembly feels like they made a mistake and that the third legacy voting process that was followed, was not proper, then proper action would be made to remove me from the position. I came out of the hat and now I need to fulfill the position until I am told otherwise through an informed group conscience.

This explanation was followed by questions, comments, and participation from the homegroup members that were present. I appreciate the group members for asking me to attend their meeting and giving me the opportunity to hear their concerns.

I have reached out to the DCMs in Zones 2 and 3 for facility suggestions for the 2023 assemblies. Thank you to District 13 for checking into the River's Edge Convention Center. I have a facility that may be an option for our Fall Assembly that is located in Isle. I will be visiting with them to see what they have to offer. Once I get the 2023 assemblies set, it will give me some breathing room to work on the next rotation, per the guidelines we should have the assemblies booked out 2 years. If you have any suggestions for venues that fall in these zones, please let me know.

#### ARCHIVIST – MARC N

(This report of Archivist does not necessarily reflect what was spoken at Spring Assembly, rather it is a recap of what I said.)

I traveled to Fargo to get a look at the archive materials in storage. There is a lot, most is boxed, I did not open boxes, so don't know content. There are several file cabinets, a few bookcases, and some open shelf units. There is also a lot of loose paper, open top boxes, etc. The entirety should be easily accommodated by the proposed 450 sq ft of storage space. We will vote later regarding archive repository move and budget changes.

The digital archives that are accessible only go back to 2018 with a few items from the recent period still missing. There had been a lot of effort extended to digitize older recordings from cassette tapes to a cloud drive or other external storage. I had conversation with Brad I. (past archivist) he said that there should be thumb drives with the digital copies of some recordings, I am hoping to find these after the archive move, and then add them to the cloud storage. I am hoping to find that many paper items had been scanned and saved as well. I am continuing to search for the lost cloud storage, it seems that around every corner, at every dead end new information to help recovery of these lost files becomes available.

At my home I have PCs (no MACs, no UNIX, or LINUX) running Vista, Windows7, Windows10, and Windows11. I have a single sheet scanner, I have optical character recognition software (it does read cursive). I partnership with my son's business we will buying a sheet feed scanner, I will use this to scan documents for area archives at my home. My cell phone does not have the app to tolerate shaky hands when taking pictures.

Please contact me to search for items of historical interest, but also note that until archived materials are moved research is limited. Being a newby in this service role I am not certain of my ability to present a display or to speak about AA history at group or district meetings or at events such as roundups, but I will make an honest attempt.

#### **OLD BUSINESS**

**Area Inventory** – The last one was in 2010 when Kelly D. was the Area Chair. Discussion – Do we have a standard procedure/method for the inventory? We have a format, someone from outside of Area 35 chairs the inventory. Last time it was Denny B. from Area 36 who chaired it in International Falls.

Tabled Motion from February ACM re: Archives Storage – The motion made by the Webmaster at the February 27, 2022, Area Committee Meeting was "to move the Archives to the space in Aitkin." This motion was tabled to get the groups' input and vote on the motion. Discussion: Archivist said costs of moving and the annual costs are included in the budget. Other discussion: the roof is being replaced this summer. A lot of info was digitized and saved in the Cloud. The info can't be accessed because passwords are not known. Would it be possible to get two hard drives, one to keep with the archives and one for the Archivist to use at home? The one at the Archives would be updated when Archivist works at the storage space. The archives cannot remain where they are and must be moved. Annual cost needs to be considered, and groups would have to send more money to the Area. Volume may be reduced due to digitizing. Paper is the most secure way to store, digital is vulnerable. Would it be possible to get a fireproof safe? Question was called, Motion to move the Archives to the space in Aitkin PASSED UNANIMOUSLY.

**2022 Budgets** – Corrections Chair wants to meet with Area 36 Corrections. Travel to the Twin Cities may be added. Three trips would cost \$150 to \$180. \$180 was added to the budget. CPC had added \$700 for booths, fairs, etc. Webmaster said budget does not include cost for SSL for website. This would make the site secure and provide us with a certificate that would allow us to be accessed by more websites.

\$150 is added to Webmaster budget. Cathy R. made a motion to approve the budgets. John (a GSR) seconded. Motion PASSED UNANIMOUS-LY.

Past Delegate Service Discussion - Past Delegate is doing an excellent job as Area Chair. Whether past delegates can do more service at the Area level is not a new discussion. No decision was ever made. Other areas allow this. Area acted in good faith. This happened at the 2021 Fall Assembly. We were pushed to be out of the venue by noon. There has been inadequate discussion. There is nothing in the Actions Book about past delegates serving. Actions Book is a guide. Service Manual doesn't say anything about it other than that past delegates should not be GSRs. If past delegates can serve, what happens at next election? This discussion should have taken place at the Fall Assembly. Decisions should be made with substantial unanimity. Another Area in the West Central Region had a negative experience when a past delegate served. Bernard Smith article in the Northern Light explains why we need rotation. Area 35 already has a good way to use past delegates. If a past delegate has not served as Area Chair before, they can serve as Chair. Actions Book is not a guide. Wheels of AA grind slowly but they grind firmly. One group in the Area discussed this topic and arrived at their group conscience, and the GSR from this group, Dani L., made a motion stating, "Past Delegates are eligible to be nominated for Area service positions not previously held." Kyle H. seconded. Another motion was subsequently made by Rachel to table this motion. Seconded by Cathy R. Motion was tabled with two people in opposition.

A Statement is read at the beginning of the meeting: Before we get into tonight's business let's remember we are here to serve, bring the group conscience of our home groups forward and allow God to express himself through this group's conscience. All of our opinions are equally valuable and necessary if we are to develop this group's conscience. To encourage participation we should refrain from cross-talking or directly responding to another member's comment. Once we submit our ideas to the group then they belong to the District Committee as a whole, to be considered and discussed when raising our hands.

Talk to members before and after the meeting. Ask them to move on. Remind the group that time is of the essence. The DCM should shut down disruptions immediately.

#### **GSR SHARING SESSION REPORT – Sarah C.**

Spring Assembly 2022 GSR Sharing Session 1 It was decided to gather a list of questions from members in the room and then open each question up for discussion.

- What if I don't have a group conscience, should I vote or how do I vote? It was encouraged to make every effort possible to get a group conscience from their group with some suggested ways to do this: Copy the materials for group members; hold a business meeting and share information on agenda items; keep meeting minutes showing how the group conscience presented in the group; ask permission of your group to trust you to vote the group conscience on items that may not have been discussed. Others shared it is important to always vote the group conscience to the best of their ability.
- If I financially support myself to come to the assembly, is it ok if I vote the way I want and vice versa, if my group supports me financially, should I only vote group conscience?
- It was suggested that it doesn't matter who's paying the bill you have a responsibility to vote the group conscience no matter how we get here. Someone shared when I give my group info they don't give a group conscience. Another suggested to encourage the group to use time to be productive as it is the GSRs responsibility to present agenda items with importance and support them in understanding the items. Give the group an opportunity to have a group conscience, stay positive, and encourage others to get involved. If I change my vote, I better have a good reason.

Am I supposed to register as a GSR somewhere?

A member shared that their sponsor helped them register and they found the registration form online (area35.org & aa.org). It was suggested to add the alternate GSR, if there is one, to the registration form. It was suggested to ask the DCM for help, if needed. It was suggested to send a copy of the registration form to the area as well as the GSO and that the GSR will receive a welcome kit. backorder and it was shared that they are available for purchase at the assembly for 4.

- How can I get backordered information from the GSO? Go to AA.org; type "GSR" in search box – the materials in the welcome kits will be available electronically. The service manual can be downloaded and printed.
- Are individual votes recorded at the assembly? Names/group names are not recorded. Only the number of votes are recorded.
- If my group is not large or financially stable, how can I raise funds to attend assemblies and workshops? Several smaller groups in the district double up rooms and sometimes the district service members offer to share rooms with smaller groups. It was suggested to plan ahead for necessary expenses, start a separate fund, or keep a prudent reserve since groups are responsible to send GSRs to assemblies, etc. Other ideas shared include: carpool; share rooms; ask the district to help. It was stressed that it is important to attend district meetings as it is a place to ask for help. It was also suggested that a district meeting can pass a basket to help fund smaller groups.

#### 2<sup>nd</sup> Sharing Session:

The question was posed to GSR group if we wanted to go back to the way GSR orientations used to be held. A member asked the more experienced GSRs to share their thoughts. Several reported they found it was helpful to have the area officers deliver presentations. Someone asked why it changed and it was shared that GSRs were in the process of deciding the direction to go with orientation right before COVID. Someone suggested new GSRs attend area committee meetings and available forums to learn more. There was a motion to begin offering the area officer presentations during the first sharing session and use the 2<sup>nd</sup> sharing session to discuss questions; to occur at both assemblies, beginning fall 2022. A second was made. There was one oppose who stated to only do the area chair presentations during the fall assembly, possibly every other year in order to focus on the agenda items during the spring assembly; acknowledged that new GSRs are "in the dark" and we are all "in the dark." It was suggested a separate workshop could be offered. The motion carried.

It was proposed to use the remaining time to review the service manual review. Someone asked how many had read the GSR responsibilities in the service manual and expressed the importance of reviewing the agenda in advance because we are the greatest link to groups, and we need to get the group conscience. In preparation for the assembly, it was shared by a member that they planned meetings in advance to get a group conscience and reviewed the available materials, as well as the informational meeting with our area delegate. It was also discussed the importance of current GSRs to help the alternate and/or new GSRs learn the role. Suggestions were made on what information should be brought to groups when the list of agenda items are so long to include identifying hot topics and reviewing the "consider" agenda items as they have a higher likelihood of going to vote. It was shared that previous delegates have produced a hot topics list, and it was suggested the GSRs could ask them to do this again.

The group decided to read aloud the GSR chapter of the service manual which happened through several members. After the reading was completed, a member referenced page 113 for the Group Information Change form, and page 103 for the service structure triangle. There was a question about the spirit of rotation which is referenced in the FAQ.... several members indicated they felt obligated to stay on as GSR since no one else was offering. It was suggested this may prevent others from volunteering and it was stressed the importance of rotation to avoid "taking charge." It was suggested to identify a replacement GSR in advance and prepare them by helping them learn the roles and responsibilities.

**Officers/Action Chairs Session Report** – It was discussed that we should start a conversation with Area 36 about re-establishing the Joint Workshop. We also discussed our potential path as it relates to technology with entities outside Area 35 service structure. The Northern Light/Group Records/Webmaster developed a strategy for acceptance of articles for the Northern Light

- How can I get a group conscience from my groups with the short amount of time we had to review/discuss a large number of agenda items? It was acknowledged that everyone had a short amount of time because everyone received the agenda items in mid-February. It was suggested that using email to communicate information with the group is effective and it is possible that multiple meetings may need to be held and to pay notice to the agenda items noted as "consider." Several GSRs attended a meeting to learn more about the agenda items and others shared they discussed the items in their district meetings. It was also shared that some used a regular AA meeting to discuss the agenda items.
- How can I learn more about the roles and responsibilities of being a GSR? It was suggested to do the following: review the information in the service manual; review the GSR orientation handout received at the Assembly; consider getting a service sponsor; attend service workshops; talk to past GSRs; review the welcome packet information when you register. It was noted that service manuals are on

Light.

**GSR Sharing Session at future Assemblies** – Sarah C. made a motion stating "**GSR Orientation for the first sharing session at Fall and Spring Assembly to be presentations by Area officers, to begin at the Fall Assembly 2022.**" Motion seconded by Rolf H. **Motion PASSED UNANI-MOUSLY**.

Area Technology Road Map – Webmaster explained that technology is important for communication and carrying the message. We can improve this for the Area and get more people involved in service. We should treat Area 35 as a business, and also maintain access to information. We should provide devices to all Officers and Chairs; we should negotiate the best agreements for services. We ought to have supportable and sustainable system to be able to pass on smoothly. We ought to form a technology committee to gather requests for each officer/chair and to gather quotes and determine the best solutions. We would need at least eleven laptops/tablets for breakout sessions if we use virtual meetings. Districts could consider using such a system. Vicki R. made a Motion to form a technology committee. A friendly amendment to call this an ad hoc committee was added. Amendment accepted. Seconded by Jeff. Discussion: Who will be on the committee? Some people don't have the ability to meet virtually, and sometimes people can't attend. Motion PASSED UNANIMOUSLY.

**Fall Assembly** will be in Crookston in October. Area Chair will visit the hotel to firm up some details.

**General Service Conference Floor Action – Diane R.,** District 9 DCM, made a motion stating, "District 9 would like to make a motion that the **Area 35 Delegate bring forth a Floor Action to the 72<sup>nd</sup> General Service Conference that the Twelve Steps, the Twelve Traditions, and the Twelve Concepts will stay in the existing form in English as in the Fourth Edition of the book of Alcoholic Anonymous.**" Jeff seconded. Ricco R. made a friendly amendment to the motion that stated, "No translated Twelve Steps, Twelve Traditions or Twelve Concepts will be put into the translated version of the Fourth Edition of the book Alcoholics **Anonymous.**" There was discussion about this motion and the friendly amendment being confusing, so the **motion was withdrawn**.

There was more discussion: According to Mike L., West Central Region Trustee, the Twelve Steps may have a translation into plain language under the original text. Bill's Story and Dr. Bob's Nightmare would remain as they are and would not be translated. The background material from the AA Service Manual, Article 3, talks about needing 3/4 of the AA groups as described in the Resolution adopted by the 1955 Conference and Convention. Are they trying to get around this Article?


**Diane R.** then made the motion in Section 1 of their proposal, "We are making a proposal regarding the translation of the book Alcoholics Anonymous (fourth edition) into plain and simple language. We propose that the Twelve Steps, the Twelve Traditions, and the Twelve Concepts not be translated into Plain Language in any way; that these remain in the existing form in English as in the Fourth Edition of the book of Alcoholics Anonymous, and that Steve L., our Area 35 Delegate, bring this proposal up for a floor vote at the 72<sup>nd</sup> Conference." Cathy R. seconded. Motion PASSED WITH SUBSTANTIAL UNANIMITY. Minority opinion – Not translating the Steps defeats the purpose. If Steps are not translated, people can't understand them. Trust the process – they have our backs. Side-by-side translation is needed.



#### Tradition Two by Bill W. Copyright © The A.A. Grapevine, Inc., January 1948

Sooner or later, every AA comes to depend upon a Power greater than himself. He finds that the God of his understanding is not only a source of strength, but also a source of positive direction. Realizing that some fraction of that infinite resource is now available, his life takes on and entirely different complexion. He experiences a new inner security together with such a sense of destiny and purpose as he has never known before. As each day passes, our AA reviews his mistakes and vicissitudes. He learns from daily experience what his remaining character defects are and becomes ever more willing that they be removed. In this fashion he improves his conscious contact with God.

Every AA group follows this same cycle of development. We are coming to realize that each group, as well as each individual, is a special entity, not quite like any other. Though AA groups are basically the same, each group does have its own special atmosphere, its own peculiar state of development. We believe that every AA group has a conscience. It is the collective conscience of its own membership. Daily experience informs and instructs his conscience. The group begins to recognize its own defects of character and, one by one, these are removed or lessened. As this process continues, the group becomes better able to receive right direction from its own affairs. Trial and error produces group experience and out of corrected experience comes custom. When a customary way of doing things is definitely proved to be best, then that custom forms into AA Tradition. The Greater Power is then working through a clear group conscience.

We humbly hope and believe that our growing AA Tradition will prove to be the will of God for us.

Many people are coming to think that Alcoholics Anonymous is, to some extent, a new form of human society. In our discussion of the First Tradition, it was emphasized that we have, in AA, no coercive human authority. Because each AA, of necessity, has a sensitive and responsive conscience, and because alcohol will discipline him severely if he back slides, we are finding we have little need for manmade rules or regulations. Despite the fact that we do veer off at times on tangents, we are becoming more able to depend absolutely on the long-term stability of the AA group itself. With respect to its own affairs, the collective conscience of the group will, given time, almost surely demonstrate its perfect dependability. The group conscience will, in the end, prove a far more infallible guide for group affairs than the decision of any individual member, however good or wise he may be. This is a striking and almost unbelievable fact about Alcoholics Anonymous. Hence, we can safely dispense with those exhortations and punishments seemingly so necessary to other societies. And we need not depend overmuch on inspired leaders. Because our active leadership of service can be truly rotating, we enjoy a kind of democracy rarely possible elsewhere. In this respect, we may be, to a large degree, unique.

Therefore, we of Alcoholics Anonymous are certain that there is but one ultimate authority, "a loving God as he may express himself in our group conscience."

#### <u>Treatment – Ricco R</u>

Since the Area 35 Spring Assembly, I have been working with the PI/CPC committee in District 9, as I had mentioned previously, I am a member of that committee. There is one veteran, (Skip), on the committee and one direction we are going is working with the Military as it is considered a remote community and we are considering ways on how to get our A.A. message out to them. Our Treatment Committee is also looking at ways of getting the message out to remote communities. Peggy M. has already some knowledge of getting into the Veterans Hospital to give our message of recovery. There is a saying, that, a remote community could be just around the corner. That means there is a lot of people with a drinking problem that are not reached mainly because we haven't looked hard enough to find them. I made some preliminary Workbooks out of an assortment of relevant information taken out of A.A. literature to have something to move forward with in working with the Military. The workbook will have to be worked on and added to as we go along and find more information and procedures to move forward with our efforts to share the A.A. message of recovery.

I know that my main responsibility for being a Treatment Chair is to provide assistance and experience in developing projects that would further carry the A.A. message into treatment facilities. It is another responsibility for the Treatment Chair to coordinate and work with Districts on Special Needs/ Accessibilities projects. The Accessibilities workbook has suggestions for working with Underserved or Remote Communities. The Area 35 Northern MN Area Actions Book has my Trusted Service Guidelines in it to do so. That is why I am interested in working with remote communities. In my Treatment Committee workbook, it asks me to invite Corrections, Cooperation with the Professionals (CPC), and Public Information (PI) liaisons to our committee meetings. There are many overlapping responsibilities involved in our service responsibilities and we are encouraged to work with each other to help carry the A.A. message. I felt I had to put some more of my responsibilities in about working with each other so it wouldn't look like I was working out of my boundaries.

#### <u> Archivist – Marc N</u>

Hello again, it's me your Archivist for the next while. "I" volunteered for this role when I became aware of the open service opportunity. "I" quickly became immersed (of my own doing) with finding a new home for our archives. "I" soon gained the knowledge that "I" can't, but "We" can. It has been with the insight and help of many that "I" found the serenity, courage, and wisdom to move forward. At one of my two home groups I was asked "How does what you do at the district or area carry the message to still suffering alcoholics?" "I" did not have an answer. #### AA Archives: A collection of stories telling what it was like, what happened, and what we are like now. A record of "the business" of AA to validate that the 12 Steps, 12 Traditions, and 12 Concepts remain steadfast.

So where to go from here? We need to make our archive materials available to those who seek help, either for themselves, to help others, or to achieve lasting, serene, sobriety. With that in mind we ought to lean on one another in our service roles to seek the best message to present to a still suffering alcoholic. In my humble opinion, that is to be the best copy of the Big Book that we can be, so that we attract others based on our appearance and behavior. When asked about our sober lifestyle we ought to be able to draw on the experiences of others to relate to the newcomer. The archives are here to serve our various area and district committees that have focus on subsets of people of various interests. Now, my personal goal is to provide service of searching for and providing relevant materials to carry our message forward.



# **BLAST FROM** THE PAST!

#### TIMELESS ADVICE FROM A FAITHFUL SERVANT

Vern R., our past delegate from Grand Rapids, was rummaging through some old papers and writings from the time he was a delegate and came across this letter written to the fellowship five years ago. It contains some sage advice and pearls of wisdom which can be of value to us all. Editor.

The letter is printed verbatim as follows:

#### "Our fellowship is for alcoholics and alcoholics only."

"Dear GSR's, Assembly Officers and all A.A.'s,"

"This will probably be my last personal letter to you s your Delegate and I want to thank each of you for allowing me to be your trusted servant. I hope to be able to continue being active and to serve this beautiful ushin

"There are a few things I would like to bring up as I think they are very important

"First of all, I would like to remind all of you, especially the GSR's to share all of the correspondence you receive with your groups. There may be someone who would like do be active but they just don't know how to get started. The theme of the last Conference in April to get started. The theme of the last Conference in April was **The A.A.** Group, Where it Begins. "From active A.A. Groups come active GSR's -from active GSR's come active DCM's and from active DCM's come active Delegates. From all of this activity we see growth and strength in our groups because we are learning from each other and this growth and strength insures the survival of A.A. for those yet to come. One of the pitfalls that we seem to get into is that we would like to be "all things to all people" and get the whole world straightened out. Soomer or later we come to realize that this is not possible. We are alcoholics trying to help alcoholics and Sooner or later we come to realize that this is possible. We are alcoholics trying to help alcoholics and our primary purpose is to stay sober and help other alcoholics to achieve sobriety. There are problems other than alcohol that have benefited by using the A.A. program which they have adapted to their particular problem, and as individuals we can help these programs are strated which they have many means during these programs. proteim, and as incluiduals we can nep these programs get started, but we have many, many drunks that we are not helping and I think we need to take a long hard look at just where we are in our own program of Alcoholics Anonymous, We have agencies and treatment centers sending us non-alcoholics. Do we lead them to believe sending us non-accordings. Do we lead them to believe that they are members of A.A.? If we do, we are hutting them as well as ourselves and we are depriving them of help they might otherwise be getting form a group who has their same problem. I'm sure that none of us want to hurt anyone anymore. Our Fellowship is for alcholics and alcoholics only."

#### "One of the pitfalls that we seem to get into is that we would like to be "all things to all people" ...

"I almost hate to mention the next subject because it seems that I'm always bringing it up. You may say them don't being it up. However, it is a very necessary part of our Fellowship and does need to be talked about MONEY! Our preambel states that we are self-supporting through our own contributions. This means that as a group we support A.A. and A.A. only. All of the Districts in our area voted to contribute \$1.00 per member per year to the District, \$1.00 per member per the Districts in our area voted to contribute \$1.00 per member per year to the District, \$1.00 per member per year to the Assembly and the suggested contribution to G.S.O. is \$3.65 per member per year which totals \$5.65. If we add another \$5.00 for a yearly subscription to the Grapevine, this brings the total of all these things to \$10.65 per member per year. This a a small price to pay for continued sobelety and the rewards we reap from the lowe us and even that was "bouch and go" at times. In A.A. we are equals and we are accepted and lowed wherever we are in sobelety. Our first priority is for the good of the group and most certainly we need a meeting place which is adequate for the group. Because we are self-supporting we pay rent, as a group, for a place to meet. However, in my tavels throughout the area I notice that some groups are allowing group funds to be handled by Aleno Clubs and theig group unds are not being used for A.A. purposes. We should pay rent so the Alano Society (if we have one) but as a group we should also be responsible for purchasing Conference Approved Literature form G.S.O., for taking care of contributions to the district the area a to G S O. and for Literature form G.S.O., for taking care of contributions to Literature form G.S.O., for faxing care or commonions to the district, the area assembly and to G.S.O., and for other necessary expenses of the group. If we say we are A.A. then let's be A.A. all the way and not confuse ourselves and newcomers by being half and half. At this point I must say that there was a time when I thought What difference does does it make and why do some make such a fuss about this? but as I read and studied the A.A. Service Manual, the Guidelines, the Steps, the Traditions and the Concepts, etc. I came to believe that it was necessary to adhere strictly to the guidelines of the Fellowship or there won't be a Fellowship. Someone ha Periovship of mere won't be a realowship. Someone has said that "we will not be destroyed from without, but that our destruction will come from within if we do not learn from the experience of those who have gone before us," Let's keep our minds open and learn form the painfu experiences of those early A.A.'s."







## **NORTHERN LIGHT PRIMARY PURPOSE:**

- Gather useful service information to publish from sources within the Area, Region and A.A. as a whole. Obtain, read and use other Area newsletters.
- Listen to comments from the Area on the content of the N.L.

## EDITORIAL POSITION & N.L. COMMITTEE:

**Editor**: The Editorial Chair position is a two-year rotation picked by the incoming Area Chair and either approved or rejected by the Area Committee at the first Area meeting after the Fall Assembly Elections.

**Desirable qualifications:** Current knowledge of MS Publisher, MS Word, MS Excel and other misc. computer programs as needed. The person should also consider the time needed to complete the task required. The candidate should have a working knowledge of A.A. as a whole, i.e., prior experience in service work such as G.S.R., D.C.M., or related position.

**N.L. COMMITTEE:** The N.L. Committee consists of the Area Group Records Chair, Area Webmaster and Area Audio Technician along with two D.C.M.s in Area 35. DCM's are picked randomly at the start of each rotation and serve on a two-year rotation basis. They assist the editor in communications with other area newsletters, in recommendations on general improvements, and with general problems and implementations of new policies. They may also represent the editor at functions when the editor is unable to attend.

**N.L. COMMITTEE MEETINGS:** The Committee meets every other month, before the start of the Area Workshop and at Spring and Fall Assemblies. If needed, additional meetings may be called.

General submissions are welcome! Feel free to send letters or articles that are pertinent to AA and Area 35. Please note that if space is limited, first priority will be given to reports from Area Officers, Area Standing Committee Chairs and D.C.M.s from Area 35.

  - a) The reason for AA events is to carry the AA message to the still suffering alcoholic
  - (this doesn't have to be printed on the flyer)
  - b) Usually covered in Who and What

## **12 Traditions of Alcoholics Anonymous (Long Form)**

- 1. Each member of Alcoholics Anonymous is but a small part of a great whole. A.A. must continue to live or most of us will surely die. Hence our common welfare comes first. But individual welfare follows close afterward.
- 2. For our group purpose there is but one ultimate authority—a loving God as He may express Himself in our group conscience.
- 3. Our membership ought to include all who suffer from alcoholism. Hence we may refuse none who wish to recover. Nor ought A.A. membership ever depend upon money or conformity. Any two or three alcoholics gathered together for sobriety may call themselves an A.A. group, provided that, as a group, they have no other affiliation.
- 4. With respect to its own affairs, each A.A. group should be responsible to no other authority than its own conscience. But when its plans concern the welfare of neighboring groups also, those groups ought to be consulted. And no group, regional committee, or individual should ever take any action that might greatly affect A.A. as a whole without conferring with the trustees of the General Service Board. On such issues our common welfare is paramount.
- Each Alcoholics Anonymous group ought to be a spiritual entity having 5. but one primary purpose-that of carrying its message to the alcoholic who still suffers.
- 6. Problems of money, property, and authority may easily divert us from our primary spiritual aim. We think, therefore, that any considerable property of genuine use to A.A. should be separately incorporated and managed, thus dividing the material from the spiritual. An A.A. group, as such, should never go into business. Secondary aids to A.A., such as clubs or hospitals which require much property or administration, ought to be incorporated and so set apart that, if necessary, they can be freely discarded by the groups. Hence such facilities ought not to use the A.A. name. Their management should be the sole responsibility of those people who financially support them. For clubs, A.A. managers are usually preferred. But hospitals, as well as other places of recuperation, ought to be well outside A.A.-and medically supervised. While an A.A. group may cooperate with anyone, such cooperation ought never go so far as affiliation or endorsement, actual or implied. An A.A. group can bind itself to no one.
- 7. The A.A. groups themselves ought to be fully supported by the voluntary contributions of their own members. We think that each group should soon achieve this ideal; that any public solicitation of funds using the name of Alcoholics Anonymous is highly dangerous, whether by groups, clubs, hospitals, or other outside agencies; that acceptance of large gifts from any source, or of contributions carrying any obligation whatever, is unwise. Then too, we view with much concern those A.A. treasuries which continue, beyond prudent reserves, to accumulate funds for no stated A.A. purpose. Experience has often warned us that nothing can so surely destroy our spiritual heritage as futile disputes over property, money, and authority.
- Alcoholics Anonymous should remain forever non-professional. We define professionalism as the occupation of counseling alcoholics for fees or hire. But we may employ alcoholics where they are going to perform those services for which we may otherwise have to engage nonalcoholics. Such special services may be well recompensed. But our usual A.A. "12 Step" work is never to be paid for.
- Each A.A. group needs the least possible organization. Rotating leadership is the best. The small group may elect its secretary, the large group its rotating committee, and the groups of a large metropolitan area their central or intergroup committee, which often employs a full-time secretary. The trustees of the General Service Board are, in effect, our A.A. General Service Committee. They are the custodians of our A.A. Tradition and the receivers of voluntary A.A. contributions by which we maintain our A.A. General Service Office at New York. They are authorized by the groups to handle our over-all public relations and they guarantee the integrity of our principal newspaper, the A.A. Grapevine. All such representatives are to be guided in the spirit of service, for true leaders in A.A. are but trusted and experienced servants of the whole. They derive no real authority from their titles; they do not govern. Universal respect is the key to their usefulness.

## **12** Concepts of **Alcoholics Anonymous (Short Form)**

- Final responsibility and ultimate authority for A.A. world services I. should always reside in the collective conscience of our whole Fellowship.
- The General Service Conference of A.A. has become, for nearly II. every practical purpose, the active voice and the effective conscience of our whole Society in its world affairs.
- III. To insure effective leadership, we should endow each element of A.A.-the Conference, the General Service Board and its service corporations, staffs, committees, and executives-with a traditional "Right of Decision."
- IV. At all responsible levels, we ought to maintain a traditional "Right of Participation," allowing a voting representation in a reasonable proportion to the responsibility that each must discharge.
- V. Throughout our structure, a traditional "Right of Appeal" ought to prevail, so that minority opinion will be heard and personal grievances receive careful consideration.
- VI. The Conference recognizes that the chief initiative and active responsibility in most world service matters should be exercised by the trustee members of the Conference acting as the General Service Board.
- VII. The Charter and Bylaws of the General Service Board are legal instruments, empowering the trustees to manage and conduct world service affairs. The Conference Charter is not a legal document; it relies upon traditional and the A.A. purse for final effectiveness.
- VIII. The trustees are the principal planners and administrators of overall policy and finance. They have custodial oversight of the separately incorporated and constantly active services, exercising this through their ability to elect all the directors of these entities.
- Good service leadership at all levels is indispensable for our future IX. functioning and safety. Primary world service leadership, once exercised by the founders, must necessarily be assumed by the trustees.
- Every service responsibility should be matched by an equal service Χ. authority, with the scope of such authority well defined.
- XI. The trustees should always have the best possible committees, corporate service directors, executives, staffs, and consultants. Composition, qualifications, induction procedures, and rights and duties will always be matters of serious concern.
- XII. The Conference shall observe the spirit of A.A. tradition, taking care that it never becomes the seat of perilous wealth or power; that sufficient operating funds and reserve be its prudent financial principle; that it place none of its members in a position of unqualified authority over others; that it reach all important decisions by discussion, vote, and, whenever possible, by substantial unanimity; that its actions never be personally punitive nor an incitement to public controversy; that it never perform acts of government, and that, like the Society it serves, it will always remain democratic in thought and action.

"The Twelve

- 10. No A.A. group or member should ever, in such a way as to implicate A.A., express any opinion on outside controversial issues—particularly those of politics, alcohol reform, or sectarian religion. The Alcoholics Anonymous groups oppose no one. Concerning such matters they can express no views whatever.
- 11. Our relations with the general public should be characterized by personal anonymity. We think A.A. ought to avoid sensational advertising. Our names and pictures as A.A. members ought not be broadcast, filmed, or publicly printed. Our public relations should be guided by the principle of attraction rather than promotion. There is never need to ourselves. We feel it better to let our friends recommend us. praise
- 12. And finally, we of Alcoholics Anonymous believe that the principle of anonymity has an immense spiritual significance. It reminds us that we are to place principles before personalities; that we are actually to practice a genuine humility. This to the end that our great blessings may never spoil us; that we shall forever live in thankful contemplation of Him who presides over us all.

## Q: Why list our past Delegates?

## A: They are a resource to you!

In Alcoholics Anonymous we value experience. Our Twelve Steps did not exist when Bill stepped into the lobby of a hotel in Akron, Ohio. Even after meeting with Dr. Bob and soon founding our program, there were only six steps until the experiences of 100 Alcoholics were summed up. Soon after a book followed, but it was a few years later when the Twelve Traditions were discussed and agreed on. Twelve Traditions that were "hammered out on the anvil of experience". Our past Delegates are a wealth of experience, an interactive living archive if you will. When you plan your next service workshop or need an outside voice to offer help, consider this resource available to you. Some of them even offer great company while fishing!

## The Delegate's Duties

Though the high point is the Conference meeting, the delegate's job goes on year-round and involves all aspects of the Conference structure. The delegate should:

- Remind G.S.R.s to inform groups and individuals about the A.A. Grapevine and Conference-approved literature.
- Attend the Conference meeting in April, fully prepared. Immediately upon election, every delegate is put on the G.S.O. mailing list to receive Conference materials.
- Communicate the actions of the Conference to area committee members and encourage them to pass on this information, and the delegate's enthusiasm, to groups and to intergroups/central offices. If an area is too large for the delegate to cover in person, he or she will ask area officers and committee members to share the load.
- Be prepared to attend all area, state/provincial, and regional service meetings and assemblies. From these meetings, delegates come to better understand their own areas and can make suggestions for the Conference agenda. Here, too, they come in contact with A.A. members who might not be reached otherwise.
- Help area committees obtain financial support for the area and G.S.O.
- Provide leadership in solving local problems involving the A.A. Traditions.

- Cooperate with G.S.O. in obtaining information—for example, making sure that up-to-date information reaches G.S.O. in time to meet the deadline for each Issue of the A.A. directory and helping carry out the triennial membership surveys.
- Visit groups and districts in the area whenever possible.
- Work closely with committee members and officers, sharing experience throughout the year. After G.S.R.s and committee members have reported on the Conference, learn from these A.A.s how groups and members have reacted.
- Assume added responsibility if the area chair and alternate chair are unable to serve. Or, if an area committee is not functioning effectively, the delegate may take an active role in remedying the situation.
- Keep the alternate delegate fully informed and active, so that the alternate can replace the delegate in an emergency.
- Late in the second term, work with newly elected delegates to pass along a basic knowledge of Conference proceedings and problems.
