

AREA 35 MEETING MINUTES - UNAPPROVED

Area 35 August 2022 ACM Minutes Aitkin, MN August 7, 2022

Call to Order: Area Chair Christine G. called the meeting to order at 10:30 a.m. on Sunday, August 7, 2022, and opened with the Serenity Prayer.

Recognition of Past Delegates in Attendance: Charlie C, Panel 54; Jim K, Panel 62; Jim S, Panel 70

Area Chair opened the Special Assembly:

We will now open for a Special Assembly session to allow voting on the GSC proposals and to allow GSRs to participate and vote.

- Welcome to all who have joined via Zoom. Please keep yourself muted, raise your hand when you have something to share. Raise your hand by pressing the REACTIONS icon at the bottom of the screen, next to RECORD or SHARE SCREEN. Then select RAISE HAND. Once you have been called on, you can select LOWER HAND.
- After we are done discussing and voting on the (4) proposals, we will log off Zoom and proceed with reports.
- We will be using 2/3 majority for the vote being these items are being forwarded to the GSC. Voting members are Area Officers, Area Action Committee Chairs, DCMs (Alt DCMs if your DCM is not present) GSRs (Alt GSRs if your GSR is not present) – District Action Committee Chairs do not vote. All voting members please raise your hands. (Take a count)
- We will be allotting 2 mins of sharing at the microphone with sharing only once until everyone has had an opportunity.
- Let's avoid cross talking as it gets disruptive and hard to hear discus-
- When asking questions or speaking, please go to the mic or raise your hand on Zoom. We will alternate between microphone and Zoom.
- The purpose of this discussion is to determine if the (4) proposals should get forwarded to the Conference Committees for them to determine if the proposal should be added to 2023 GSC Agenda Items.

GSC Proposals

GSC Proposal Service Material – District 8

District 8 Alt. DCM Craig T. read the motion:

Any new, updated or addition to existing service material be sent to the appropriate conference committee for review before being printed or posted on our website www.aa.org. Those items that clearly do not fit under a specific committee can be referred to the Report and Charter **Committee.** Sally T. seconded the motion. Charlie C. from the Gilbert Group gave a review of the background material. Discussion: Anything on www.aa.org is assumed to be AA's voice. Vote was taken, none opposed, Motion PASSED unanimously.

GSC Proposal BB Translation - District 9

District 9 DCM Diane R. read the motion:

We are making a proposal regarding the translation of the book Alcoholics Anonymous (Fourth Edition) into plain and simple language. We propose that the Twelve Steps, the Twelve Traditions, and the Twelve Concepts, not to be translated into plain language in any way; that these remain in the existing form in English as in the Fourth Edition of the **Book Alcoholics Anonymous.** Denise R. seconded the motion. Discussion: Delegate Steve L. brought this item up as a floor action at the Conference, and the Conference voted not to consider, so District 9 is resubmitting the proposal. Diane R. read parts of the bylaws, including the part about needing ³/₄ written consent of groups to make changes. Calling the changes, a translation makes it an accessibility issue. It is not a translation because it is English to English. Have to stick to what it is being called, a translation. Vote: 39 in favor, 7 opposed, motion PASSED with substantial unanimity. No minority opinion given.

GSC Proposal Blue Card - District 13

District 13 Jim R. read the motion:

We propose to change the wording of the Open Meeting Statement on the Primary Purpose Statement F-17 (blue card) to incorporate the Open Meeting Statement in the AA Group Pamphlet-

The new "Open Meeting Statement" to read:

This is an open meeting of Alcoholics Anonymous. Open meetings are available to anyone interested in Alcoholics Anonymous' program of recovery from alcoholism. We are glad you are all here - especially newcomers. In support of our Third Tradition that states "The only requirement for A.A. membership is a desire to stop drinking" we ask that non alcoholics attend as observers only. Heidi B. seconded the motion. The reason the proposal was made was that there is confusion about what is an open meeting and what is a closed meeting. The blue card does not match what the literature says. Discussion: Don't exclude families. One group will not vote for the proposal if it does not include the phrase "singleness of purpose." Greg C. made a friendly amendment to add "singleness of purpose" to the motion. Friendly amendment accepted by Jim R. Revised motion reads:

We propose to change the wording of the Open Meeting Statement on the Primary Purpose Statement F-17 (blue card) to incorporate the Open Meeting Statement in the AA Group Pamphlet-

The new "Open Meeting Statement" to read:

This is an open meeting of Alcoholics Anonymous. Open meetings are available to anyone interested in Alcoholics Anonymous' program of recovery from alcoholism. We are glad you are all here - especially newcomers. In support of our singleness of purpose and our Third Tradition that states "The only requirement for A.A. membership is a desire to stop drinking" we ask that non-alcoholics attend as observers

Further discussion: Issue with word "non-alcoholics." What if there is a newcomer who does not know if they are an alcoholic or not? One group does not kick anyone out for not knowing whether they are an alcoholic. We need clarity to eliminate confusion. Groups that let anyone in, including nonalcoholics, was torn apart by "trying to fix everything." Vote: 38 in favor, 8 opposed. PASSED Point of order: Need to count abstentions. 3 abstained. Recount: 40 in favor, 6 abstentions. Point of order: Went over who can vote-53 voters. Revote: 44 in favor, 8 opposed, one abstention. Motion PASSED with substantial unanimity. Minority Voice did not wish to speak.

GSC Proposal 12x12 - District 9

District 9 DCM Diane R. read the motion:

The 2002 Conference unanimously recommended the Advisory Action that the text in the book, Twelve Steps and Twelve Traditions, written by Bill W, remain as is recognizing the Fellowships' feeling that Bill's writings be retained as originally published. We propose that changes made by the 71st General Service Conference:

Advisory Action 18 for changes to page 117 phrase "opposite sex" with the word "partner"

Advisory Action 19 changes to page 66, "No one wants to be angry enough to murder, lustful enough to rape, gluttonous enough to ruin his health" with "No one wants to commit the deadly sins of anger, lust or gluttony" in the book Twelve Steps and Twelve Traditions, be returned to their original text.

Note: This would include the Introduction be returned to its original text.

Denise R. seconded. Reason for proposal: The Conference not to consider when it was brought up as a floor action by our delegate. Discussion: Return the language to what it was. Language at the time it was written is Bill's writing. It may be outdated but it can be explained. One woman said she is not offended by the language since if she takes a drink, she may be capable of all of it. Vote: 44 in favor, 8 opposed, one abstention. Motion PASSED with substantial unanimity. Minority Voice did not wish to speak.

All four proposals will be submitted to the General Service Board before the September 15th deadline.

Area Chair Christine G. thanked the GSRs for bringing their groups' consciences to the Assembly portion of the meeting, then closed the Assembly portion at 11:40 a.m. and logged off the hybrid session.

Good morning, Ladies and Gentlemen,

I apologize for not being here. Currently, I'm on a big silver bird heading home from Las Vegas. I was attending a conference for another organization that I'm involved with.

I have given nine General Service Conference reports since I've been back from the GSC. The latest reports were given to District 21, Bemidji and at the Isanti Alano Club for Districts 5, 6 and 11. Coming up in the middle of August are reports for Districts 3, August 13th and District 4, August 20th. Also, on August 13th, is a Zonal Forum at the Perham Alano Club. I can't thank you all enough for the wonderful hospitality and participation I have received from all the Districts regarding GSC reports.

The Joint Trustees' Literature Committee and the Conference Committee on Literature is having a zoom meeting Aug. $8^{\rm th}$. We are going to discuss two agenda items (draft pamphlet, "The Twelve Steps Illustrated" and the existing version of the pamphlet, "Twelve Traditions Illustrated"). I'm hoping A.A.W.S. has something to show us about the changes we requested.

At the July 25th WCR Delegates' meeting a few things of interest were discussed.

I asked the question about the cost of the *Plain and Simple Big Book*. Mike L., our WCR Trustee, stated that in 2021, \$15,000 was budgeted and spent on its development and in 2022, \$50,000 has been budgeted for development of the *Plain and Simple Big Book*. Mike will find out more info during the next Trustees' finance committee.

There is a printing error in some editions of the English-language book, "Twelve Steps and Twelve Traditions" (both in hard and soft cover editions). Only 80,000 copies were printed, and half had been distributed before finding the misprint.

Because of an advisory action from the 71st GSC, the same one that changed the text of Bill's writings, included in that Advisory action was the inclusion that the long form of the Traditions be added at the end of each Tradition essay. The typographical error is, that the text of the Long Form of Tradition Eight was inadvertently repeated in the Long Form of Tradition Nine (page 177) in the newest printing. The accurate full text of Tradition Nine (Long Form) appears on page 178. For you amateur archivists, here is an easy hunt for you to locate for your displays.

We then discussed the 72nd GSC final conference report. I received an email stating that the 72nd GSC final report would be late. Their excuse was that they were being impacted by major circumstances they could not control. This included unforeseeable staffing changes that were affecting all projects and timelines in the Publishing Department as well as global supply chain issues. To be honest, I wasn't too concerned at first, but after our discussion, I became alarmed. Given that the Equitable Distribution Workload trial, the final report will not be distributed until after the deadline for the GSC agenda item submissions Sept. 15th, and that's the problem. Katie B., the Delegate from S. Dakota, stated that her Area was submitting an agenda item on this issue. Concern was raised by all Regional Trustees too. If you have any questions about the final GSC report, please email conference@aa.org or contact the Conference Coordinator at 212-870-3122.

There is an update on 2023 WCRAASC per Cara G., the Nebraska Delegate. She stated that we now have a signed agreement with the Doubletree by Hilton in downtown Omaha Nebraska, 1616 Dodge St., Rooms will be \$119/night. There are 200 Rooms blocked for the event. Parking will be \$10/night for hotel guest, slightly higher for non-guests. The host committee is working on lowering the parking allowance for us. Mike asked if there was a force majeure clause (in the event of a covid outbreak we could cancel with no fees or costs charged to us) answer was, yes there is.

There is an update on the Regional Forum in Missoula, Room charges for the 2023 Forum will be \$139/night. Dates for the event will be August 25 – 27, 2023, at the Hilton Garden Inn in Missoula Montana.

My apologies again for missing out on the four agenda item discussions and discussing the upcoming Area inventory. I think the Google forms' poll is a great idea and the questions are spot on. Enjoy the day. In Service, Steven L

Area inventory questions have been created and have been put into Google Forms so we can start conducting the inventory online. The dates that the survey will be open is August 12th – September 23rd. I will send out a link that the DCMs can share with the GSRs in their districts. We will compile all the responses and make those available prior to assembly. We will also go over the questions and have discussion at the Fall Assembly. An inven-

tory is only good if we take action so after the Fall assembly, so I would like to create an Ad hoc committee to review the responses and create a list of action items. We can have more discussion about this inventory under old business if anyone has any concerns that need to be addressed about this proposed process.

I have signed the contract and paid \$700 deposit for Fall Assembly 2023 at the River's Edge Convention Center in St. Cloud. The dates are October 7th and 8th, 2023. The cost for the weekend is \$2675 for the room and I still need to work on coffee. As of right now, the convention center does not have coffee available so I will need to work with one of their approved caterers.

I continue to make weekly deposits for the contributions that we receive. Thank you to all the groups that are contributing to the area. Your contributions are appreciated. And a huge thank you to A35 Alt. Delegate for all your hard work and commitment to keeping our checkbook balanced and reports completed.

Been working with A36 and A35 Statewide Correction's in obtaining a facility for the Statewide Correction Workshop that will be held in October. Contract is being reviewed and need to have the contract returned by 8/8/22. I will also be working with Area 35 Corrections Chair to get coffee lined up for the workshop. NEW BUSINESS

Diane R. made a motion stating: I propose that we contribute to the MN State Fair this year 1/3 actual costs up to \$700. Jim R. seconded. Motion PASSED. Minority voice did not wish to speak.

Hybrid Fall Assembly – Do we want a hybrid (in person and via internet) meeting for the Fall Assembly so GSRs whose groups can't afford to send them to the Assembly can vote? Denise R. made a motion to make the 2022 Fall Assembly hybrid. Vicki R. seconded. Discussion: Why can't we bring them along like we did before all this technology? Not all groups have the money to send GSRs. Logistics for hybrid meeting in a big room can be tricky. Need camera showing the room. Can use polling feature to record votes on Zoom. What about anonymity on Zoom? Can use passwords, and people at home should be on Zoom in a separate location from others – personal responsibility. People online said the ACM today said Zoom was awful. Vote: 52 voted in favor of making the Fall Assembly hybrid, 1 voted in opposition. Motion PASSED with substantial unanimity. Minority voice did not wish to speak.

Group Records MS Office – Group Records chair needs the tools to be able to do her job. Kyle H. made a motion to buy a single license for Microsoft Office 365 for Group Records. Jim R. seconded. Motion PASSED unanimously.

Calendar of Events was read.

Motion to adjourn – Jim R. made a motion to adjourn, Kyle H. seconded. Meeting adjourned at 2:40 p.m. Closed with the Responsibility Statement.



Your Experience, Strength and Hope

The AA Preamble (Old – Wilmington Preamble)

We are gathered here because we are faced with the fact that we are powerless over alcohol and unable to do anything about it without the help of a Power greater than ourselves. We feel that each person's religious views, if any, are his own affair. The simple purpose of the program of Alcoholics Anonymous is to show what may be done to enlist the aid of a Power greater than ourselves regardless of what our individual conception of that Power may be.

In order to form a habit of depending upon and referring all we do to that Power, we must at first apply ourselves with some diligence. By often repeating these acts, they become habitual and the help rendered becomes natural to us.

We have all come to know that as alcoholics we are suffering from a serious illness for which medicine has no cure. Our condition may be the result of an allergy which makes us different from other people. It has never been by any treatment with which we are familiar, permanently cured. The only relief we have to offer is absolute abstinence, the second meaning of A. A.

There are no dues or fees. The only requirement for membership is a desire to stop drinking. Each member squares his debt by helping others to recover.

An Alcoholics Anonymous is an alcoholic who through application and adherence to the A. A. program has forsworn the use of any and all alcoholic beverage in any form. The moment he takes so much as one drop of beer, wine, spirits or any other alcoholic beverage he automatically loses all status as a member of Alcoholics Anonymous. A.A. is not interested in sobering up drunks who are not sincere in their desire to remain sober for all time. Not being reformers, we offer our experience only to those who want it.

We have a way out on which we can absolutely agree and on which we can join in harmonious action. Rarely have we seen a person fail who has thoroughly followed our program. Those who do not recover are people who will not or simply cannot give themselves to this simple program. Now you may like this program or you may not, but the fact remains, it works. It is our only chance to recover.

There is a vast amount of fun in the A.A. fellowship. Some people might be shocked at our seeming worldliness and levity, but just underneath there lies a deadly earnestness and a full realization that we must put first things first and with each of us the first thing is our alcoholic problem. To drink is to die. Faith must work twenty-four hours a day in and through us or we perish.

In order to set our tone for this meeting I ask that we bow our heads in a few moments of silent prayer and meditation. I wish to remind you that whatever is said at this meeting expresses our own individual opinion as of today and as of up to this moment. We do not speak for A.A. as a whole and you are free to agree or disagree as you see fit. In fact, it is suggested that you pay no attention to anything which might not be reconciled with what is in the A. A. Big Book. If you don't have a Big Book, it's time you bought one. Read it, study it, live with it, loan it, scatter it, and then learn from it what it means to be an A.A.

Through the AA Looking Glass by Bill W Copyright © The A.A. Grapevine, Inc., November, 1950

This is a plug for the Gravpeviners and all their works. May they live long and prosper.

One looks in one's mirror to powder, shave, or admire. But the good AA is apt to look deeper. Every morning he gives thanks for a sober countenance, he asks forgiveness for lingering resentment, he hops for grave to live the coming day well. At nightfall he takes another look, saying, "Well, my friend, how did we do today? Thanks be to thee for the privilege of living."

Thus the AA's mirror reflects not rough, but gratitude; not conceit, but humility; not froth, but reality. It reflects a priceless experience.

Reading the Grapevine is something kindred. But the Grapevine is a far bigger mirror. Here we get an inspiring glance over the other fellow's shoulder as he meditates. We're magically transported into the midst of our brothers and sisters everywhere. We feel at one with them. Alice in Wonderland was never like that. Through the AA looking glass we joyously roam the spacious mansion which Providence has provided us – that incredible freedom house called AA.

For the Grapevine is truly your magazine and mine. Its contents, month by month, are your thoughts, your ideas – about AA and anything else that may be on your mind. Each month more than two hundred of you, on an average, send in something to be printed. The Grapevine is not written by a bunch of high-domed ivory tower boys in New York. You write it.

Acceptance was the Answer

This is one of my favorite readings in the Big Book - pages 416 - 417. It's so important to my recovery and peace of mind. I encourage everyone to read the entire story.

At last, acceptance proved to be the key to my drinking problem. After I had been around A.A. for seven months, tapering off alcohol and pills, not finding the program working very well, I was finally able to say, "Okay, God. It is true that I—of all people, strange as it may seem, and even though I didn't give my permission—really, really am an alcoholic of sorts. And it's all right with me. Now, what am I going to do about it?" When I stopped living in the problem and began living in the answer, the problem went away. From that moment on, I have not had a single compulsion to drink.

And acceptance is the answer to all my problems today. When I am disturbed, it is because I find some person, place, thing, or situation—some fact of my life —unacceptable to me, and I can find no serenity until I accept that person, place, thing, or situation as being exactly the way it is supposed to be at this moment. Nothing, absolutely nothing, happens in God's world by mistake. Until I could accept my alcoholism, I could not stay sober; unless I accept life completely on life's terms, I cannot be happy. I need to concentrate not so much on what needs to be changed in the world as on what needs to be changed in me and in my attitudes.

Shakespeare said, "All the world's a stage, and all the men and women merely players." He forgot to mention that I was the chief critic. I was always able to see the flaw in every person, every situation. And I was always glad to point it out, because I knew you wanted perfection, just as I did. A.A. and acceptance have taught me that there is a bit of good in the worst of us and a bit of bad in the best of us; that we are all children of God and we each have a right to be here.

AREA OFFICERS & ACTION COMMITTEE NL REPORTS

OFFICER REPORTS DELEGATE – STEVEN L

Howdy Everyone, Summer might be over, and fall is in the air but, there is still loads of things happening in AA. Unfortunately, I was absent for the Zonal Forum at the Perham Alano Club. Covid was in the air. My wife contracted Covid on our jaunt to Las Vegas, so I decided to error on the side of caution and not attend. Luckily, I tested negative through her bout with Covid. She has fully recovered and can now play the piano. I've given GSC reports to District 4, Alexandra and District 2, Thief River Falls which makes twelve GSC reports I have given since returning from the General Service Conference. The Final GSC report is out in PDF format. I've emailed a copy to all the DCMs to share with their Districts. If you would like me to send a report to you just drop me a line and I will email you the report. The challenge with the Final Report is now that we have it ready to go to print, we don't have the material to print on. GSO has made a decision to switch the type of paper to use. The paper on the Final Report is going to be a lighter weight, 35 pound, which is similar to the paper we used to use for the directories. Hopefully, I will be bringing copies of the final report to the Area Assembly in Crookston in October.

I sent in the four proposed agenda items to the conference coordinator. I made some slight changes to a couple of the proposals. In the What level of group conscience question I added this phrase," it passed the District then Area with substantial unanimity." And I added my name to the contact information.

I attended a Zoom meeting of the combined Conference Literature (CLC) and Trustees Literature Committees (TLC). Most of the discussion was on giving clarity to the Trustees on what the CLC was asking them to do. Such as, the illustrations on the Twelve Traditions Pamphlet and the new Twelve Steps Pamphlet. One thing I was surprised at was that the TLC has had informal discussions on QR coding. It was brought up that their hands were tied until an Agenda Item expressing the need to explore QR codes is brought up.

At the Delegates' meeting a few important things were mentioned. Grapevine is still experiencing a decrease in circulation of the printed magazine. Offset by an increase of other GV items being published. There is going to be a price increase of the top ten Grapevine books. The price is going up because publishing supply costs are greater than the price, we currently sell the books for. This price increase will go in effect the 4th quarter, around November. This will only affect the top ten selling GV books, we have over twenty GV titles. On a positive side, other ventures we have on the Grapevine side have been doing fantastic. We just got this message that the podcast has over 200,000 downloads and increasing at the rate of about 20,000 downloads every couple of weeks. We budgeted \$187,000 for GV publishing items and the cost has doubled what we anticipated, our publishing expenses are currently at \$350,000. Our actual year-to-date income \$799,585 is \$295 short of what we budgeted. When you look at GV expenses, that is where things get off kilter. The cost of goods for publication has increased significantly. GV had budgeted \$841,000 for expenses, the actual costs came in at \$980,000. This is a difference of \$138,000. Our net income was negative \$181,000 for the year. We are budgeted to be at a deficit of \$41,770. Without the additional materials cost we would be on track with where we were planning to be.

Couple of items on Literature: One of them is the Big Book. Decision was made to not have the dust cover. First printing is scheduled for mid-October and completed by November/December 2022. This is coming out as a cost saving and time saving measure. Nothing is changing in the book. Last order of books with the dust cover will be August/September. There will be a message going out in the Fall edition of Box 4-5-9 as well as communication to all Conference members, Board members and Central Offices. We are also printing without dust jackets the English and French versions of the Twelve and Twelve, with the same timeline as the Big Books.

The expected cost savings on the new jacketless format for the Big Book and the "Twelve Steps and Twelve Traditions.":

Big Books

We should save about \$135,000.00 on just our initial order of 300,000 jacketless B-1s

12 x 12s

We should save about \$25,000.00 on just our initial order of 135,000 jacketless B-2s.

Turnaround time savings:

Once we start printing these jacketless books, we'll save roughly, between 30 to 60 days in manufacturing turnaround per order, and we'll be able to get larger quantities of books shipped to our warehouses at once, as opposed to the current shipments that are necessarily staggered over weeks. The savings per Big Book works out to \$0.45 per book and the 12 x 12 works out to \$0.185 per book.

Equally as important as the cost savings, reducing the lead time by 30 to 60 days when we are experiencing out of stock conditions due to supply chain issues is huge.

The Trustees PI Committee (TPIC) must have made the suggested changes to the AA Membership Survey that was discussed during my GSC reports.

TPIC has sent to me a list of randomly picked groups to partake in the survey. Our Area was assigned eight groups to take the survey. Out of the first eight groups, I was only able to get in touch with two of the groups. The other six groups contact information was inaccurate, discontinued numbers and such. In the second batch of eight groups, I was able to confirm and get a thumbs up on seven groups wanting to participate in the survey. The survey will be sent out sometime in October. This is a great example on why it is important keeping our Group Records Secretary up to date on your group's information.

There has been some staff changes recently. We have a new HR Director. We have a new staff member that is handling legal assistant to Bob, GSO office manager, and will also be handling international licensing and taking care of some of the translations. Other staff changes, Steve S. and Craig W. have moved on and are no longer staff members at GSO. Karina C., La Vina editor has accepted the position of Craig's role in Group Service the second week of September. There will be another opening posted. Until that one is filled, Sandra will be stepping in to cover some of the responsibilities. Adrienne B. is going to come back and do some temporary work helping with the West Central Region correspondence.

WCR Service Conference Speaker is locked in: Carolyn W. /General Service Trustee from Surry BC. and the coffee will have a Venmo option. Now I have to go do dishes, I lost at backgammon. Humbly in service, Steven L

Thanks to district 3 for being such gracious hosts as well as all who attended the forum. I was a pleasure to be a part of.

There has been nothing remarkable in the treasury work since the ACM. Standard work of bookkeeping entries for the group contributions we've received as well as writing a couple of checks. We are still looking for candidates for the Area Treasury position and will be looking to elect someone at the Fall Assembly in October. It's a privilege to serve the groups in Area 35

Greetings Area 35, Since the August Committee meeting, I have made the Area Inventory available on Google Forms and have started to receive some feedback. Thank you to all who have participated, you all will have an opportunity again at the Fall Assembly.

There are two Trusted Servant budgets that were missed in the NL. Corrections and Tech/Audio were missed and those will be distributed via email and added to the budgets for the Fall Assembly. The grand total for 2023 budget is \$88,757.21. These will be brought forward for a vote of approval at the assembly.

12 Traditions of Alcoholics Anonymous (Long Form)

- 1. Each member of Alcoholics Anonymous is but a small part of a great whole. A.A. must continue to live or most of us will surely die. Hence our common welfare comes first. But individual welfare follows close afterward.
- 2. For our group purpose there is but one ultimate authority—a loving God as He may express Himself in our group conscience.
- 3. Our membership ought to include all who suffer from alcoholism. Hence we may refuse none who wish to recover. Nor ought A.A. membership ever depend upon money or conformity. Any two or three alcoholics gathered together for sobriety may call themselves an A.A. group, provided that, as a group, they have no other affiliation.
- 4. With respect to its own affairs, each A.A. group should be responsible to no other authority than its own conscience. But when its plans concern the welfare of neighboring groups also, those groups ought to be consulted. And no group, regional committee, or individual should ever take any action that might greatly affect A.A. as a whole without conferring with the trustees of the General Service Board. On such issues our common welfare is paramount.
- 5. Each Alcoholics Anonymous group ought to be a spiritual entity having but one primary purpose—that of carrying its message to the alcoholic who still suffers.
- 6. Problems of money, property, and authority may easily divert us from our primary spiritual aim. We think, therefore, that any considerable property of genuine use to A.A. should be separately incorporated and managed, thus dividing the material from the spiritual. An A.A. group, as such, should never go into business. Secondary aids to A.A., such as clubs or hospitals which require much property or administration, ought to be incorporated and so set apart that, if necessary, they can be freely discarded by the groups. Hence such facilities ought not to use the A.A. name. Their management should be the sole responsibility of those people who financially support them. For clubs, A.A. managers are usually preferred. But hospitals, as well as other places of recuperation, ought to be well outside A.A.—and medically supervised. While an A.A. group may cooperate with anyone, such cooperation ought never go so far as affiliation or endorsement, actual or implied. An A.A. group can bind itself to no one.
- 7. The A.A. groups themselves ought to be fully supported by the voluntary contributions of their own members. We think that each group should soon achieve this ideal; that any public solicitation of funds using the name of Alcoholics Anonymous is highly dangerous, whether by groups, clubs, hospitals, or other outside agencies; that acceptance of large gifts from any source, or of contributions carrying any obligation whatever, is unwise. Then too, we view with much concern those A.A. treasuries which continue, beyond prudent reserves, to accumulate funds for no stated A.A. purpose. Experience has often warned us that nothing can so surely destroy our spiritual heritage as futile disputes over property, money, and authority.
- 8. Alcoholics Anonymous should remain forever non-professional. We define professionalism as the occupation of counseling alcoholics for fees or hire. But we may employ alcoholics where they are going to perform those services for which we may otherwise have to engage nonalcoholics. Such special services may be well recompensed. But our usual A.A. "12 Step" work is never to be paid for.
- 9. Each A.A. group needs the least possible organization. Rotating leadership is the best. The small group may elect its secretary, the large group its rotating committee, and the groups of a large metropolitan area their central or intergroup committee, which often employs a full-time secretary. The trustees of the General Service Board are, in effect, our A.A. General Service Committee. They are the custodians of our A.A. Tradition and the receivers of voluntary A.A. contributions by which we maintain our A.A. General Service Office at New York. They are authorized by the groups to handle our over-all public relations and they guarantee the integrity of our principal newspaper, the A.A. Grapevine. All such representatives are to be guided in the spirit of service, for true leaders in A.A. are but trusted and experienced servants of the whole. They derive no real authority from their titles; they do not govern. Universal respect is the key to their usefulness.
- 10. No A.A. group or member should ever, in such a way as to implicate A.A., express any opinion on outside controversial issues—particularly those of politics, alcohol reform, or sectarian religion. The Alcoholics Anonymous groups oppose no one. Concerning such matters they can express no views whatever.
- 11. Our relations with the general public should be characterized by personal anonymity. We think A.A. ought to avoid sensational advertising. Our names and pictures as A.A. members ought not be broadcast, filmed, or publicly printed. Our public relations should be guided by the principle of attraction rather than promotion. There is never need to praise ourselves. We feel it better to let our friends recommend us.
- 12. And finally, we of Alcoholics Anonymous believe that the principle of anonymity has an immense spiritual significance. It reminds us that we are to place principles before personalities; that we are actually to

12 Concepts of Alcoholics Anonymous (Short Form)

- I. Final responsibility and ultimate authority for A.A. world services should always reside in the collective conscience of our whole Fellowship.
- II. The General Service Conference of A.A. has become, for nearly every practical purpose, the active voice and the effective conscience of our whole Society in its world affairs.
- III. To insure effective leadership, we should endow each element of A.A.—the Conference, the General Service Board and its service corporations, staffs, committees, and executives—with a traditional "Right of Decision."
- IV. At all responsible levels, we ought to maintain a traditional "Right of Participation," allowing a voting representation in a reasonable proportion to the responsibility that each must discharge.
- V. Throughout our structure, a traditional "Right of Appeal" ought to prevail, so that minority opinion will be heard and personal grievances receive careful consideration.
- VI. The Conference recognizes that the chief initiative and active responsibility in most world service matters should be exercised by the trustee members of the Conference acting as the General Service Board.
- VII. The Charter and Bylaws of the General Service Board are legal instruments, empowering the trustees to manage and conduct world service affairs. The Conference Charter is not a legal document; it relies upon traditional and the A.A. purse for final effectiveness.
- VIII. The trustees are the principal planners and administrators of overall policy and finance. They have custodial oversight of the separately incorporated and constantly active services, exercising this through their ability to elect all the directors of these entities.
- IX. Good service leadership at all levels is indispensable for our future functioning and safety. Primary world service leadership, once exercised by the founders, must necessarily be assumed by the trustees.
- X. Every service responsibility should be matched by an equal service authority, with the scope of such authority well defined.
- XI. The trustees should always have the best possible committees, corporate service directors, executives, staffs, and consultants. Composition, qualifications, induction procedures, and rights and duties will always be matters of serious concern.
- XII. The Conference shall observe the spirit of A.A. tradition, taking care that it never becomes the seat of perilous wealth or power; that sufficient operating funds and reserve be its prudent financial principle; that it place none of its members in a position of unqualified authority over others; that it reach all important decisions by discussion, vote, and, whenever possible, by substantial unanimity; that its actions never be personally punitive nor an incitement to public controversy; that it never perform acts of government, and that, like the Society it serves, it will always remain democratic in thought and action.

NORTHERN LIGHT PRIMARY PURPOSE:

The Northern Light (N.L.), is a general service newsletter that serves Area 35 to facilitate bilateral communication between the Groups, Districts, Area and G.S.O. levels in the Northern Minnesota area. Its purpose is to:

- Publish an informative and attractive newsletter to the Area in a timely fashion.
- Encourage District reports and be available to work with Districts on communications. One or more of the N.L. Committee should try to attend area events to report on what's happening in their areas. If they are unable to attend, encourage local members to write short articles about events and happenings to be published in the N.L.
- Provide encouragement for writing articles, particularly to D.C.M.s and Area Action Committee Chairs. This should include the strong encouragement to submit their reports for each issue, if no report is submitted it will be stated, example "Northern Light Report NOT GIVEN" this is currently being done in the Southern Minnesota Area newsletter.
- ♦ Keep informed of activities and issues going on within Alcoholics Anonymous as a whole. The N.L. Committee could subscribe to the Grapevine or other pertinent A.A. news sources.
- ♦ Gather useful service information to publish from sources within the Area, Region and A.A. as a whole. Obtain, read and use other Area newsletters.
- Listen to comments from the Area on the content of the N.L.

EDITORIAL POSITION & N.L. COMMITTEE:

Editor: The Editorial Chair position is a two-year rotation picked by the incoming Area Chair and either approved or rejected by the Area Committee at the first Area meeting after the Fall Assembly Elections.

Desirable qualifications: Current knowledge of MS Publisher, MS Word, MS Excel and other misc. computer programs as needed. The person should also consider the time needed to complete the task required. The candidate should have a working knowledge of A.A. as a whole, i.e., prior experience in service work such as G.S.R., D.C.M., or related position.

N.L. COMMITTEE: The N.L. Committee consists of the Area Group Records Chair, Area Webmaster and Area Audio Technician along with two D.C.M.s in Area 35. DCM's are picked randomly at the start of each rotation and serve on a two-year rotation basis. They assist the editor in communications with other area newsletters, in recommendations on general improvements, and with general problems and implementations of new policies. They may also represent the editor at functions when the editor is unable to attend.

N.L. COMMITTEE MEETINGS: The Committee meets every other month, before the start of the Area Workshop and at Spring and Fall Assemblies. If needed, additional meetings may be called.

NORTHERN LIGHT SUBMISSIONS:

- 1. Who is involved or sponsoring the event? Examples:
 - a) AA Group
 - b) District
 - c) Area
- 2. What type of event is it? Please include itinerary. Examples:
 - a) An open or closed meeting
 - b) Speaker meeting
 - c) Call up meeting
 - d) Big Book meeting
 - e) Workshop with itinerary
 - f) Conference with itinerary
 - g) Fellowship (ice cream socials, potlucks, chili cook offs, etc.)
 - h) AA must appear somewhere on the flyer
- 3. When is the event to take place?
 - a) Date and time
 - b) Does it reoccur
- 4. Where will the event take place?
 - a) Name of the facility and the address
 - b) Maps are sometimes helpful but not necessary
- 5. Why is the event taking place?
 - a) The reason for AA events is to carry the AA message to the still suffering alcoholic (this doesn't have to be printed on the flyer)
 - b) Usually covered in Who and What

*For safety reasons, if a phone number is listed on the flyer consider NOT putting a name in association with the number.

Only Area 35 AA members may submit a flier. Fliers for AA sponsored events only.

Please submit flyers in PDF format when possible. Flyers will be posted on area35.org and in the Northern Light at the Area 35 Webmaster's and Northern Light Editor's discretion. Email northernlight@area35.org with any questions.


AREA 35 EVENTS INCLEMENT WEATHER PROCEDURE

Q: Why list our past Delegates?

A: They are a resource to you!

In Alcoholics Anonymous we value experience. Our Twelve Steps did not exist when Bill stepped into the lobby of a hotel in Akron, Ohio. Even after meeting with Dr. Bob and soon founding our program, there were only six steps until the experiences of 100 Alcoholics were summed up. Soon after a book followed, but it was a few years later when the Twelve Traditions were discussed and agreed on. Twelve Traditions that were "hammered out on the anvil of experience". Our past Delegates are a wealth of experience, an interactive living archive if you will. When you plan your next service workshop or need an outside voice to offer help, consider this resource available to you.

The Delegate's Duties

Though the high point is the Conference meeting, the delegate's job goes on year-round and involves all aspects of the Conference structure. The delegate should:

- Attend the Conference meeting in April, fully prepared. Immediately upon election, every delegate is put on the G.S.O. mailing list to receive Conference materials.
- Communicate the actions of the Conference to area committee members and encourage them to pass on this information, and the delegate's enthusiasm, to groups and to intergroups/central offices. If an area is too large for the delegate to cover in person, he or she will ask area officers and committee members to share the load.
- Be prepared to attend all area, state/provincial, and regional service meetings and assemblies. From these meetings, delegates come to better understand their own areas and can make suggestions for the Conference agenda. Here, too, they come in contact with A.A. members who might not be reached otherwise.
- Help area committees obtain financial support for the area and G.S.O.
- Provide leadership in solving local problems involving the A.A. Traditions

- Remind G.S.R.s to inform groups and individuals about the A.A. Grapevine and Conference-approved literature.
- Cooperate with G.S.O. in obtaining information—for example, making sure that up-to-date information reaches G.S.O. in time to meet the deadline for each Issue of the A.A. directory and helping carry out the triennial membership surveys.
- Visit groups and districts in the area whenever possible.
- Work closely with committee members and officers, sharing experience throughout the year. After G.S.R.s and committee members have reported on the Conference, learn from these A.A.s how groups and members have reacted.
- Assume added responsibility if the area chair and alternate chair are unable to serve. Or, if an area committee is not functioning effectively, the delegate may take an active role in remedying the situation.
- Keep the alternate delegate fully informed and active, so that the alternate can replace the delegate in an emergency.
- Late in the second term, work with newly elected delegates to pass along a basic knowledge of Conference proceedings and problems.
