




#### The Delegate's Duties

Though the high point is the Conference meeting, the delegate's job goes on year-round and involves all aspects of the Conference structure. The delegate should:

- Attend the Conference meeting in April, fully prepared. Immediately upon election, every delegate is put on the G.S.O. mailing list to
   receive Conference materials.
- Remind G.S.R.s to inform groups and individuals about the A.A. Grapevine and Conference-approved literature.
- Cooperate with G.S.O. in obtaining information—for example, making sure that up-to-date information reaches G.S.O. in time to meet the deadline for each Issue of the A.A. directory and helping

- Communicate the actions of the Conference to area committee members and encourage them to pass on this information, and the delegate's enthusiasm, to groups and to intergroups/central offices.
   If an area is too large for the delegate to cover in person, he or she will ask area officers and committee members to share the load.
- Be prepared to attend all area, state/provincial, and regional service meetings and assemblies. From these meetings, delegates come to better understand their own areas and can make suggestions for the Conference agenda. Here, too, they come in contact with A.A. • members who might not be reached otherwise.
- Help area committees obtain financial support for the area and G.S.O.
- Provide leadership in solving local problems involving the A.A. Traditions.

Visit groups and districts in the area whenever possible.

- Work closely with committee members and officers, sharing experience throughout the year. After G.S.R.s and committee members have reported on the Conference, learn from these A.A.s how groups and members have reacted.
- Assume added responsibility if the area chair and alternate chair are unable to serve. Or, if an area committee is not functioning effectively, the delegate may take an active role in remedying the situation.
- Keep the alternate delegate fully informed and active, so that the alternate can replace the delegate in an emergency.

#### Area Chair's Report:

It was such a wonderful experience and I hope that I am able to provide you with well-informed information come the Spring Assembly in Crookston, MN. Hope to see you all there. DCM's, remember it is your responsibility to inform your GSR's of what you learned so they can inform their groups, thus creating an informed body when it is time to give our Delegate how we want her to vote at the General Service Conference this year. #### CPC/PI breakout session-

Collaboration with other committees: The MN depart of corrections only sees AA, not two different areas within MN. So we have the joint committee on corrections. When first making contact with a detention center do you have Cpc go in first or just corrections committee? In district 7 Bismarck, a Cpc chair started two half way homes and talks directly with the judges to get women into these homes. In district 5 Fargo, what they have tried to do is set up a committee structure that facilitates a better transition from one rotation to the next. When an institution opportunity arises a cpc rep goes in first before the institution meeting starts up so the facility understands what AA is and what AA is not. Area 36 corrections chair, when they would go into correctional facilities they would talk directly with the inmates, but when they spoke with the workers they were more interested in the traditions then the steps. Area 35 cpc chair, does not understand the difference between corrections and Cpc?

Communications between CPC/PI chairs: Historically the CPC chair would drive throughout the state to meet with professionals as an area committee chair. She would like to move towards getting the district Cpc chairs. She has not had much success with that. One district put a forum up on their website to help facilitate discussion. Fargo Cpc committee goes through the CPC workbook. Fargo CPC, it seems like most people are not well informed on Cpc when new people come to the committee.

What professionals do we approach with CPC/What are some ways to make meaningful connections with professionals: These two topics were combined Area 35 Pi committee. When dealing with the professional community be sensitive to their schedules, for instances schools, be aware of breaks and teacher conferences. If you are a committee chair, try to find people from the professions that you are interested in pursuing to help you get a leg in. One opportunity could be bringing pamphlets to emergency rooms. Montana past delegate, persistence is mandatory as you never know when the professional will be able to make time. In Bismarck, when a person comes into the emergency room that has alcohol related problems the doctor has the nurse call the hotline to make a 12 step call for the patient. If it's possible to have continuing education units applicable with the Cpc luncheon that helps get professionals there. When working with professionals documentation and organization go along way with them. AA fact file is a pamphlet that has great information for professionals.

#### Area Officer Breakout Session-

Does anyone have an alternate treasurer to help with the work load: Area 41 treasurer they used to have an alt treasurer but now they do not. Is an alt-treasurer an elected? Area 35 uses Quickbooks and online banking as tools to help her do her position. Area 52 has an audit performed once a year. Several areas in the discussion have finance committees to help with the work load.

and Alternate Delegates. In this session reports were given from the conference host committee. A long discussion took place on a large contribution that the host committee received from an AA member. The delegates voted to return this contribution due to its size as it was in conflict with the long-from of Tradition 7. I will also be assisting District 13 in discussion of agenda items and would be happy to visit any other districts for these discussions.

I attended a break- out session on Literature/GV that was moderated by Skip D. our Area Literature Chair. I also attended an informative session for Delegates. In this session Delegates discussed different approaches to their reporting back to their areas on the General Service Conference.

Does any area have a "taper" or "recorder": One area has a recorder and it is coded under technology. Area 35 has their archivist do the recording, he records the meeting in MP3 and then becomes a part of their archives.

Does any other area combine literature and secretary: This simply seems to be too large of a job for anyone person. Were these positions combines due to a lack of participation? Area 52 ND combined the two positions did it out of financial reasons so save money, they did not understand what work load they were creating for one person. Seems like it would make more sense to combine secretary and group records/fnv/registrar.

Does any other area have a mentor program to train in the new member from one rotation to the next: Outgoing secretary is making a list of helpful hints for the next person who is coming into the next rotation. One person had made a hard copy of all of her documentation so that the next person could receive that information and receive the full rotation of minutes/ news letters etc. one area does rotation meetings in December prior to the new rotation taking over. Use the golden rule, do onto others as you would like done to you.

Do other areas use emails to communicate between officers? One of the troubles in using emails is when a disagreement ensues. Then phone calls are a better choice. The use of a news letter is another way to help communicate. Area 36 has 3 assemblies a year where the area officers

have a meeting during these assemblies. Some area use a free service call freeconference call.com. It isn't necessarily free if you press the wrong button. Skype is another tool that is useful for communicating with each other.



#### Archivist's Report:

As the result of attending 22 WCRAASC's I have come to the conclusion that we can never underestimate the power of a frothy emotional appeal in Alcoholics Anonymous. I speak to the proposed "plain language" translation of the book "Alcoholics Anonymous" Proponents of this endeavor site several issues to said items necessity.

- In response to a comment that several plain language versions of "Alcoholics Anonymous" are available on the Web from other business concerns; the response was that the intended target audience lacked web access and cell phones, yet the author of the item cites texting as a key contributor to the degradation of language skills. How do you text if you don't have a phone?
- Another proponent's response was he, e.g. a singular he, was asking for a tool to help carry the message to an alcoholic who still suffers that is illiterate. I took a dyslexic, bi-polar FASD individual through the book "Alcoholics Anonymous" and didn't whine that I needed AAWS to help me. I asked for help from an eminent resource with a Doctorate in Education emphasizing Learning Disabilities. She told me to use personal examples to illustrate the points and principles. We are most effective when we share <u>our</u> experience strength and hope to surmise "Working With Others". Rewriting the "Big Book" on the level of "Green Eggs and Ham" is a derisive assault on the dignity of any suffering alcoholic and belittling to anyone trying to carry <u>our</u> message of recovery.
- The background opens with an out of context quote from the "Plain Language Association International. The Institute does not espouse retroactive re writings but encourages jargon free writing to the target audience. If we follow the guidelines of said association the sentence "Some of us tried to hold on to our old ideas and the result was nil until we let go absolutely" does not pass muster. The item writer puffed out his chest with his credentials, offered a few examples, and implied that he would like to be considered to write this translation. He also takes a shot at what he refers to as "Hardliners" who will bluster at this translation. It has been "Hardliners" who have kept this program of recovery going since 6/17/1935. Oblique historical reference, self- described "Progressives" Vincent Tracy, Edward J. M.Jr. and Chuck D. Sr. had their ideas on how to simplify the "Program of Recovery". Can you attend one of their meetings within one week of

Professionals with whom many of us interact frequently include doctors, members of the clergy, a law enforcement officer or court official, social worker, lawyer or public health official. Please contact me through the Area Web page or call me at 218-270-3151. I will help to walk you through and discuss opportunities to connect with professionals so we can share the message of hope we have found in our recovery.

An initial plan for this year contemplates meetings with professionals in the medical field, law enforcement community and those in social services at three locations in the southern end of the Area. The Area Chair has received a proposed budget which is less than 2015, but its success will rely on much cooperation and joint efforts from many of us. Those of us in recovery who have been blessed with material success may be in a position to help underwrite some costs. But the financial toll of alcoholism on many of us leaves us challenged to meet the essentials of living. For those who want to help but fear they may not be able to afford participation, speak up. Hold out your hand to offer assistance and your needs to pay for travel, lodging and meals will be met. Join us as we Trudge the Road to Happy Destiny.

#### <u>Cooperation with the Professional Community (CPC) Committee Chair's</u> <u>Report:</u>

As the incoming chair of the Cooperation with the Professional Community (CPC) for this rotation I first seek assistance from all members of the area and especially from the CPC committee members in each district. Our work to communicate the message of recovery in Alcoholics Anonymous needs to be delivered in many ways and in many different forums. Our CPC Workbook reminds us, "Through professionals, alcoholics may be reached who might otherwise never find this program, or they may be reached sooner with the help of informed non-AA's." Group Records: At our area committee meeting we discussed registering District Service positions. When out district service positions are registered through Area 35 Group Records will also be registered for the Northern Lights.

<u>New Position Kits:</u> The GSO Records department generates requests for the following new position kits only, New Groups (regular, foreign and correctional), new GSRs, new DCMs and DCMCs receive new position kits.

<u>New Groups:</u> New Group kits are ordered once the 30-day pending period has expired. The request moves from the Records department to the GSO's Inventory control who forward the days requests to one of our warehouses (Kansas City, KS or Canada). Allow 7-10 business days for receipt of the kit

> <u>GSR:</u> GSR kits are ordered when a former GSR is removed from the (Continued on page 8)

<u>DCM/DCMC</u>: DCM kits are ordered when a former DCM/DCMC is removed from the group's record and a new DCM/DCMC is added. We receive a daily report showing newly added DCMs. The request moves from the Records department to the GSO's Inventory Control department which forwards the day's requests to one of our warehouses (Kansas City, KS or Canada). Allow 7-10 business days for receipt of the kit.

Formatting issues will be an uphill battle as servants and contributors have a wide variety of software with many variants of file type and format for submission. Mike from Grand Rapids and I learned how having different versions of Microsoft Word could affect a document.

I attended the WCRAASC in Bismarck, ND and was able to make it to the CPC/PI, and Corrections/Treatment breakout sessions. I made all general sessions but had to take a break from the speaker. The chairs were murder, especially for someone who has a lower back injury exacerbated by prolonged sitting. Our Area Chair has delivered a fine example of how to report on an event that one attends. tion to complete the paper during the following week due to a heavy workload from my job. My laptop has proven to be quite finicky, and I went several days without being able to open Publisher files. I decided to start porting over to a free and open source document publisher called "Scribus" in order to avoid this problem in the future, but mid project it has proven to be quite daunting to learn a radically different software program. It is one thing to edit text, but it is another to have to build a 24 page newsletter from scratch. When I played with it before, I cheated by copying images instead of actually formatting, which is a lot of work in the long run. I will continue to work on building a document in Scribus, as I can run it with a Linux based operating system from a usb memory stick, also known as a "pen drive" or "flash stick". This will reduce the necessity of having to find a computer with a current version of Microsoft Publisher should my computer fail again. My local library was not using Publisher 2016 and this revealed some formatting errors when trying to open the documents. In a later issue I will discuss some of the pros and cons of abandoning Microsoft Publisher and utilizing a flashdrive based operating system. Whatever I do will not affect the end product, which is a .pdf file submitted to our printer.

It has been frustrating to have the ability to serve my fellow alcoholics, but then be blindsided by learning experiences whose timeliness was less than ideal. I am in the process of getting a new business started and I have some flexibility, but usually only in swapping a couple of hours in a day, with almost no evening flexibility. Consequently, my weekends start out free but are my buffer for finishing what didn't happen during the week, though the weekend following the WCRAASC was when I had budgeted enough time to edit this publication. This is affecting my ability to get a timely quality paper in your hands. I have done some inventory and am learning from this experience. I will resolve to making my schedule more free and flexible throughout the week of a NL deadline, as setting aside a day or two does not work when things go wrong. Last month it was my desktop and this month it has been a combination of my laptop and vehicle both successively needing repair. I am both embarrassed by the situation I am putting the Area in, and humbled by those who have been helpful and patient. I thought I was prepared to serve this rotation, in this technical capacity but it is becoming clear that my headstrong, "I'll fix it" attitude is more of a liability than an asset. #### Webmaster's Report:

Greetings Area 35. If you are uncertain about exactly who the webmaster for Area 35 don't feel alone. As the first area committee meeting approached we had a couple of possible solutions that were based on my earlier decision to step down. However, upon arriving in Aikin and talking to our area chair, Jim, I became aware of a new possibility, one which involved my staying on as webmaster. This solution as later detailed by Jim consisted of making use of a midnight hour connection who Jim discovered at a meeting. After discussing the situation with him, this new connection volunteered to convert our website from html to a Wordpress maintained website which is in line with Bob B.'s goal as stated at the December area committee at the close of the last rotation. Jim was assured that the conversion would be reasonably swift and that upon completion anyone with Microsoft Word knowledge and skill could maintain the website.

I attended the WCRAASC in Bismark, ND this past weekend. Something very important for groups to keep in mind. If you have chosen to enact your power of the purse by withholding contributions, please continue to support your district and area, specifically through a GSR, Alt. SGR, or contact person so that you are aware of the agenda items and other issues that will go forth to be discussed at the conference. Many of these items have to do with pamphlets or other literature which are a source of revenue-a source of revenue which if left unguarded basically may nullify your power of the purse. When we rely on literature sales to enable our fellowship to operate in the black, instead of relying on the contributions which make us self-supporting, you, as a group, lose your power to continue steering our fellowship in its necessary principled direction rather than a material and monetary direction

which has arisen from agenda items being passed which perpetuate the use of literature to support out fellowship.

I am always speaking at meetings on the subject of responsibility that we have to enable the continued existence of the fellowship, that gratitude alone will not do this; even though not all of us are suited to service work at the district, and area, and conference levels, we all, as individuals have the responsibility to steer members active in those service in a principled direction through, 1) sharing our view and experience, and, 2) contributing appropriately for our 7<sup>th</sup> tradition so that those within the general service structure can continue making those spiritually oriented decisions without being hoodwinked by carefully and manipulatively worded agenda items that are based on an expectation of projected funding.

The discussion during the last part of the conference involved the report from the General Service Board subcommittee on the feasibility study. I felt several strong point being made over and over throughout the discussion. These include that the delegates at the conference should overlook (forgive or forgo might be better words) the error or perceived error of the report's inclusion of the conference discussion, should not get "hung up" on certain words or phrases used by its author, West Central Regional Trustee Andrew W. (words like brainstorming), should look to and remain aware of the meat of the report, should keep the traditions in mind at all times. The report is intended to bring about lively discussion conducive to a more open minded conscience at the Conference, which will then fall under review by the GSB to determine what issues should be brought to future conferences. Another recurring theme of the discussion was that we need to move cautiously—If not slowly—with anything that comes from the report and subsequent discussion or actions.

I thank everyone for giving me the opportunity to be a part of their recovery and serve the fellowship with them. I am especially thankful for everyone's support through this uncertain time regarding the webmaster position and my decision to step down or remain. In loving service, Rodney S.

# How To Write An Informative Report

After editing many reports and submissions for this issue, it has become apparent that as an Area, we do not always offer informative reports on events we are being asked to attend. This corner of the paper will be just a start to what I hope becomes an ongoing dialog.

Our Area Chair, Jim S., wrote a very informative report on what he did and what information he felt pertinent to the Area, after attending the WCRAASC. Discussion with him has shown he is very passionate about the role we play as conduits of information. After reading his report from Bismarck, ND, it is clear where we could all improve. Thank you Jim for the leadership by example! (The editor will likely highlight other hallmark submissions in the future by any AA member!)

To give an idea on where to start, we have to understand our purpose as servants. Why are our fellow AAs sending us to an event? The answer is very simple, they are sending us to gather information that they believe may benefit the group and our fellowship as a whole. They are sending us because they believe we are the best candidate to attend the whole of the event and bring back the information they may not have access to. They are sending us because they believe our presence at the event will help ensure the context of the minutes of the event stays true to the experience and tone of the event. We have an obligation to provide the most "bang for the buck" while at the event.

Since our memories have limitations, experience shows we should take notes. This thought segueways into what our notes should include:

Each event we attended

What topics were discussed

Ideas that were expressed

Who else participated and how. (Not a rollcall list, rather a resource for serving as a point of information for follow up)

-Did an experienced service member offer insight, and if so, what?

What questions were asked

What answers were provided

Were documents or other media were provided (Did you collect any)

What information were you exposed to that the group may not receive if relying on minutes alone

This is by no means a full and comprehensive list, but a starting point. Each group is free to decide for itself what expectations it has on it's servants, so hopefully a discussion is started.

Now, after gathering the information, what do we do with it? We take some time to reflect on our experience at the event, and begin writing a complete report, maybe organized by topics of discussion, or each individual meeting. We may begin or end the document with a clearly identified impression of the experience. Perhaps you would like to submit to the Northern Light for the benefit of the Area, an experience on receiving a poor versus a well written report. Thank you for your consideration. Jacob C. #### **REQUEST FOR NORTHERN LIGHT MAILING LIST** I had a request from a Round Up for our Northern Light Mailing List.

I questioned if I had our Assembly Approval to give our Northern Light Mailing list to be used outside of area 35 Assembly business.

- Prior Group Records were giving out copies of our mailing list.
- Action Book -- 6/2/2002. Provide mailing labels to a round up or other outside entity for their use: reimbursement to cover best estimated costs of the labels and postage to mail them.
- The Northern light mailing list is made up of names and address that are used to update GSO Group Records database.
- GSO will not allow this information to be used outside of GSO business. Example. The Grape Vine cannot use data in the GSO database. National A.A. Technology Workshop cannot use the information in the GSO data base.
- When collecting personal information, we do not get permission to use this information outside of Assembly or GSO business.

I provided the Round Up with our procedures to have their flyer added to the Northern Light, information to have the flyer put on our calendar, I would be happy to distribute flyers at our meetings, and that I would ask our assembly about giving our personal information to outside agencies.

I feel that personal information was given to support assembly and GSO business and not intended to be used as a mailing list for Round Ups or other outside assembly and GSO business. ### SUBMISSIONS FROM MEMBERS AT LARGE

#### What Do We Stand For?

I had a sponsor who used to say "AA stands for Attitudes and Actions". He believed that our attitude is the catalyst of our behavior. He believed if I have an attitude of gratitude, if I believe that I am "happy, joyous, and free", I will act in consort with that attitude. This philosophy echoes the title of chapter six of the Big Book - "Into Action". This also assumes to be true what Abraham Lincoln once said "most people are as a happy as they make up their minds to be".

In a recent discussion with an AA friend we talked about responsibility in the program. I told him I though AA could stand for "Accountable Alcoholics". This program teaches accountability. This program teaches me that "I am responsible". Whether I am making coffee, or serving as a GSR, or District Chair, or at Area, I have a responsibility to carry out the duties of my position to the best of my ability.

Sometimes being accountable means doing things that are hard. Sometimes it means showing up at a meeting early to get the coffee started, even though the weather is less than desirable and I'd rather stay home, and I don't even drink coffee. Sometimes it means staying late to help clean-up not because I want to, but because it's the "right thing to do". As a recovered alcoholic I try to live my life according to the tenets of an Accountable Alcoholic.

Being an Accountable Alcoholic means I focus on "my side of the street". I keep my attention on my words and my actions. Being an Accountable Alcoholic means I use the principles of this program as my moral compass. I use the principles of the 12 Steps like: loyalty, duty, responsibility, service, honesty, integrity, and perseverance, to guide my everyday thoughts and actions.

But what do I do when I come across behavior within my group or district that is not in accordance with my values and principles? What do I do when I notice that there are unexplained shortages in the group's funds? What do I do when I notice that a member of the group is becoming a little too friendly with the newcomers? What do I do?

As an Accountable Alcoholic I feel duty bound to say something. If I remain quiet and turn a blind eye and deaf ear to the behavior, I have endorsed it – silence condones.

In my office place we have a mantra for safety that goes "see something – say something". That's also a pretty good slogan for recovery especially when we know that "secrets keep us sick". If I ignore the safety risk or try to wish it away, I have moved from being accountable to being avoidant.

There are those in our program who decry this "see something, say something" sort of behavior. They believe that raising an issue or concern is not in keeping with our first tradition of "unity". They think it is better to let "sleeping dogs lie" for the good of the group or the fellowship.

Unfortunately, I cannot afford that kind of thinking anymore. For it was that type of thinking that led me to believe I could address my drinking problem tomorrow. It was that kind of thinking that taught me to run from problems rather than to face them.

When Bill W. had his spiritual awakening in December of 1934 he said "it burst upon me that I was a free man." To paraphrase another famous author...the price of freedom is eternal vigilance. If this program has truly given me my freedom, do I live up to that responsibility by being an Accountable Alcoholic or an Avoidant Alcoholic?



**N.L. COMMITTEE** - The N.L. Committee consists of two D.C.M.s in Area 35. Currently, these have been picked randomly at the start of the new rotation. They also serve on a two-year rotation basis. #### **TWELVE CONCEPTS for WORLD SERVICE (Short Form)**

I. Final responsibility and ultimate authority for A.A. world services should always reside in the collective conscience of our whole Fellowship.

II. The General Service Conference of A.A. has become, for nearly every practical purpose, the active voice and the effective conscience of our whole Society in its world affairs.

III. To insure effective leadership, we should endow each element of A.A.—the Conference, the General Service Board and its service corporations, staffs, committees, and executives—with a traditional "Right of Decision."

IV. At all responsible levels, we ought to maintain a traditional "Right of Participation," allowing a voting representation in a reasonable proportion to the responsibility that each must discharge.

V. Throughout our structure, a traditional "Right of Appeal" ought to prevail, so that minority opinion will be heard and personal grievances receive careful consideration.

VI. The Conference recognizes that the chief initiative and active responsibility in most world service matters should be exercised by the trustee members of the Conference acting as the General Service Board.

VII. The Charter and Bylaws of the General Service Board are legal instruments, empowering the trustees to manage and conduct world service affairs. The Conference Charter is not a legal document; it relies upon traditional and the A.A. purse for final effectiveness. VIII. The trustees are the principal planners and administrators of overall policy and finance. They have custodial oversight of the separately incorporated and constantly active services, exercising this through their ability to elect all the directors of these entities.

IX. Good service leadership at all levels is indispensable for our future functioning and safety. Primary world service leadership, once exercised by the founders, must necessarily be assumed by the trustees.

X. Every service responsibility should be matched by an equal service authority, with the scope of such authority well defined.

XI. The trustees should always have the best possible committees, corporate service directors, executives, staffs, and consultants. Composition, qualifications, induction procedures, and rights and duties will always be matters of serious concern.

XII. The Conference shall observe the spirit of A.A. tradition, taking care that it never becomes the seat of perilous wealth or power; that sufficient operating funds and reserve be its prudent financial principle; that it place none of its members in a position of unqualified authority over others; that it reach all important decisions by discussion, vote, and, whenever possible, by substantial unanimity; that its actions never be personally punitive nor an incitement to public controversy; that it never perform acts of government, and that, like the Society it serves, it will always remain democratic in thought and action.

#### **TWELVE TRADITIONS OF ALCOHOLICS ANONYMOUS—LONG FORM**

#### Our A.A. experience has taught us that:

- 1. Each member of Alcoholics Anonymous is but a small part of a great whole. A.A. must continue to live or most of us will surely die. Hence our common welfare comes first. But individual welfare follows close afterward.
- 2. For our group purpose there is but one ultimate authority—a loving God as He may express Himself in our group conscience.
- 3. Our membership ought to include all who suffer from alcoholism. Hence we may refuse none who wish to recover. Nor ought A.A. membership ever depend upon money or conformity. Any two or three alcoholics gathered together for sobriety may call themselves an A.A. group, provided that, as a group, they have no other affiliation.
- 4. With respect to its own affairs, each A.A. group should be responsible to no other authority than its own conscience. But when its plans concern the welfare of neighboring groups also, those groups ought to be consulted. And no group, regional committee, or individual should ever take any action that might greatly affect A.A. as a whole without conferring with the trustees of the General Service Board. On such issues our common welfare is paramount.
- 5. Each Alcoholics Anonymous group ought to be a spiritual entity having but one primary purpose—that of carrying its message to the alcoholic who still suffers.
- 6. Problems of money, property, and authority may easily divert us from our primary spiritual aim. We think, therefore, that any considerable property of genuine use to A.A. should be separately incorporated and managed, thus dividing the material from the spiritual. An A.A. group, as such, should never go into busite
  6. Problems of money, property, and authority may easily divert us for service, for true leaders in A.A. are but trusted and experi-enced servants of the whole. They derive no real authority from their titles; they do not govern. Universal respect is the key to their usefulness.
  10. No A.A. group or member should ever, in such a way as to im-

Then too, we view with much concern those A.A. treasuries which continue, beyond prudent reserves, to accumulate funds for no stated A.A. purpose. Experience has often warned us that nothing can so surely destroy our spiritual heritage as futile disputes over property, money, and authority.

- 8. Alcoholics Anonymous should remain forever non-professional. We define professionalism as the occupation of counseling alcoholics for fees or hire. But we may employ alcoholics where they are going to perform those services for which we may otherwise have to engage nonalcoholics. Such special services may be well recompensed. But our usual A.A. "12 Step" work is never to be paid for.
- 9. Each A.A. group needs the least possible organization. Rotating leadership is the best. The small group may elect its secretary, the large group its rotating committee, and the groups of a large metropolitan area their central or intergroup committee, which often employs a full-time secretary. The trustees of the General Service Board are, in effect, our A.A. General Service Committee. They are the custodians of our A.A. Tradition and the receivers of voluntary A.A. contributions by which we maintain our A.A. General Service Office at New York. They are authorized by the groups to handle our over-all public relations and they guarantee the integrity of our principal newspaper, the A.A. Grapevine. All such representatives are to be guided in the spirit of service, for true leaders in A.A. are but trusted and experienced servants of the whole. They derive no real authority from their titles; they do not govern. Universal respect is the key to their usefulness.
- 10. No A.A. group or member should ever, in such a way as to implicate A.A., express any opinion on outside controversial issues—particularly those of politics, alcohol reform, or sectarian religion. The Alcoholics Anonymous groups oppose no one. Concerning such matters they can express no views whatever.

ness. Secondary aids to A.A., such as clubs or hospitals which require much property or administration, ought to be incorporated and so set apart that, if necessary, they can be freely discarded by the groups. Hence such facilities ought not to use the A.A. name. Their management should be the sole responsibility of those people who financially support them. For clubs, A.A. managers are usually preferred. But hospitals, as well as other places of recuperation, ought to be well outside A.A.—and medically supervised. While an A.A. group may cooperate with anyone, such cooperation ought never go so far as affiliation or endorsement, actual or implied. An A.A. group can bind itself to no one.

- 7. The A.A. groups themselves ought to be fully supported by the voluntary contributions of their own members. We think that each group should soon achieve this ideal; that any public solicitation of funds using the name of Alcoholics Anonymous is highly dangerous, whether by groups, clubs, hospitals, or other outside agencies; that acceptance of large gifts from any source,
- 11. Our relations with the general public should be characterized by personal anonymity. We think A.A. ought to avoid sensational advertising. Our names and pictures as A.A. members ought not be broadcast, filmed, or publicly printed. Our public relations should be guided by the principle of attraction rather than promotion. There is never need to praise ourselves. We feel it better to let our friends recommend us.
- 12. And finally, we of Alcoholics Anonymous believe that the principle of anonymity has an immense spiritual significance. It reminds us that we are to place principles before personalities; that we are actually to practice a genuine humility. This to the end that our great blessings may never spoil us; that we shall forever live in thankful contemplation of Him who presides over us all.
