





The Delegate's Duties

Though the high point is the Conference meeting, the delegate's job goes on year-round and involves all aspects of the Conference structure. The delegate should:

- Attend the Conference meeting in April, fully prepared. Immediately upon election, every delegate is put on the G.S.O. mailing list to receive Conference materials.
- Communicate the actions of the Conference to area committee members and encourage them to pass on this information, and the delegate's enthusiasm, to groups and to intergroups/central offices.
 If an area is too large for the delegate to cover in person, he or she will ask area officers and committee members to share the load.
- Be prepared to attend all area, state/provincial, and regional service meetings and assemblies. From these meetings, delegates come to better understand their own areas and can make suggestions for the Conference agenda. Here, too, they come in contact with A.A.
 members who might not be reached otherwise.
- Help area committees obtain financial support for the area and G.S.O.
- Provide leadership in solving local problems involving the A.A. Traditions.

- Remind G.S.R.s to inform groups and individuals about the A.A. Grapevine and Conference-approved literature.
- Cooperate with G.S.O. in obtaining information—for example, making sure that up-to-date information reaches G.S.O. in time to meet the deadline for each Issue of the A.A. directory and helping carry out the triennial membership surveys.
- Visit groups and districts in the area whenever possible.
- Work closely with committee members and officers, sharing experience throughout the year. After G.S.R.s and committee members have reported on the Conference, learn from these A.A.s how groups and members have reacted.
- Assume added responsibility if the area chair and alternate chair are unable to serve. Or, if an area committee is not functioning effectively, the delegate may take an active role in remedying the situation
- Keep the alternate delegate fully informed and active, so that the alternate can replace the delegate in an emergency.



On April 30th, I had the opportunity to present at a GSR Workshop in District 4 at the Alexandria Alano Club. There were about 13 people in attendance and 3 of those were brand new GSRs. I presented on what the responsibilities are of the GSR to the Group and the Group to the GSR. The more I have the opportunities to present on various topics the more I learn. Most of our larger expenses come the first 4 months of the year. As we receive more contributions over the upcoming months, our YTD ratio of income to expenses should even out.



Contributions compared to last year are up by \$2,213.06. That is good because we always have more expenses at the beginning of a new rotation. ering. Some of the most useful contacts we encounter are those who work in the Courts system on a daily basis and can direct to us those individuals who seek an answer to their alcohol problem.

Please contact me if you know when a group of professionals meets in your community. This year we have adopted an approach to take CPC to those who can assist us. So if your local ministerium, hospital staff, or law enforcement department hold regular training meeting, CPC wants to be present for a 20-30 minute presentation. As you speak with those in your city or town, and you find that they want more information about recovery from alcoholism, please contact me on the web site.

WHAT IS THE NEXT GENERATION OF A.A.'S?

For decades, members of Alcoholics Anonymous have focused on the youth of our society and how we create for them...through our steps, traditions and concepts... an attractive, welcoming place to recover from alcoholism. Each day our local media outlets hammer home the auto accidents, accidental drownings, and in rare acknowledgements, suicides attributable to alcohol abuse or personal histories of alcoholism in the young. Many in our fellowship work feverishly to bridge real or perceived generational differences so that behaviors of "Bleeding Deacons" won't send a sixteen-year-old running out the door.

It is all well and good that we look to the youth, our young men and women who come through the doors commit to these positions! willingly or otherwise. The newcomer is our lifeblood. The young and the middle aged in many meetings dominate the group. But what of the aged, the men and women who have happily moved into a well-earned retirement, such as the Big Book recitation of the man who retired at fifty-five after a long period of sobriety with the belief that he could drink as other men; "out came his carpet slippers and a bottle." Hospitalized in two months, puzzled and humiliated he gathered all his forces and found he could not stop. He went to pieces quickly and was dead within four years.

I phoned a friend and asked if he could cover for me. After conferring with his family he accepted and I thanked him for helping out.

Later that evening he called and thanked me. He said that he had an awesome meeting and stayed after the meeting talking with the speaker whom he had just met that night. He also talked about connecting with a few of the residents from the facility and how refreshed he felt just from being there.

This was not new to me as it's one of the reasons why I have committed myself to this facility and also to service work in general. Later, this same month, when I arrived at the Iron Range Get Together, in Grand Rapids, I was greeted by an excited young man who had been a former resident of that same facility. He told me how he was almost 8 months sober and was having a tough time finding a sponsor. Because of service work I knew of several men in that general area that I was able to introduce him to. I also gave him my number so that we might stay in contact. Also while attending this event I ran into some friends who began their sober journey in Superior where we became friends. They have since moved to Grand Rapids and are members of that community and it was great to see how well they are doing and how lovely their little family have turned out. At the Superior Round-up I was introduced to an extended family member of one of their friends.

I guess what I'm really trying to say is that sometimes it seems really difficult to get people involved in service work. If only there was a way for me to show how much love and joy and happiness there really is to it all and the feeling of fulfillment I have just by being of service to my fellow AA's. If everyone knew how good it felt, we would probably be waiting in line to

This last week I was able to attend the Statewide Corrections Meeting and was really impressed to all of the people who showed up to be a part of carrying the message. Northern Light Editor's Report:

Hello all. This has been a grueling but cathartic experience. I am humbled by the trust put on me to continue in the duty of being the Northern Light Editor, despite some of my deficiencies. Attempting to serve fellow AA's and receive input of both support and criticism has not been the easiest thing for me as of late. Certainly I cannot appease all people but have done considerable inventory on myself to highlight strengths and weakness within myself, and address concerns by others. Of course because of the tardiness of two NL's in a row, there exists an understandable concern for whether I can do this job. Technically I am finding this a very easy role to fill, but spiritually and working with other alcoholics has been hard. I thank everyone who has offered support and guidance.

One of the things that has become a theme is that when I have asked many servants of their opinion of our newsletter, almost all have said, "I didn't read that" or "I don't read it as much as I should.". Very few have given me any feedback as far as my appeals for content. I pressed a couple of servants to participate, with both stating a lack of writing skill as a reason why their levels of participation are low. This highlighted how easily as a fellowship we take for granted the skills and abilities of our fellow servants. Getting creative, one of the servants said he'd be happy to write out his thoughts and send me a picture of his hand written submission. I was in tears as I transcribed the shared experience.

Both from the beauty of his expressed experience and the ability to help a fellow servant out. Our two "halves" made a whole and that is the essence of serving alcoholics. We are in the business of helping people grow towards being God's people, and organizing our fractions so as to make whole servants. We shouldn't have to carry everyone, everyday, nor do we, but it is amazing what a cup of coffee or a phone call can do.

I have spent the month before the due date mapping the templates for publishing the newsletter for the express purpose of building a webpage that can edit our Newsletter. For the last couple of years Google's Android operating system is the most popular and common operating system in the planet, eclipsing Apple, Microsoft, and their mobile derivatives, put together. In English this means most people access information either by tablet pc or smartphone, and so bulky publishing suites like Microsoft Publisher, are diminishing in popularity and offerings. My successor may choose to use the foundation I build for a webpage, Publisher or other document creating choice, but the technology is such now, a person can plug in a key sized device into a television and use it like a computer, with modern televisions having QWERTY keyboards built into the remote or the ability to be attached to a tablet pc or smart phone. Public Information Committee Chair's Report:

Good Morning from the Area 35 Spring Assembly.

We had 12 people attending our break out session, representing districts 7, 5, 9, 12, and 13 as well as 2 past delegates and 1 past delegate/trustee. The first half of the meeting we spoke to Communication with Professionals and Public Information working topics. Such as the Importance of using the Information kits we get from the General Service Office they contain pamphlets and literature that has been vetted through the experience of PI chairs and delegates. These kits are updated yearly and are excellent tools to use in getting started in our general service.

Things we are working on are CPC/PI luncheon that will be held in conjunction with the Hibbing area AA 75th anniversary celebration August 26 at noon in the Hibbing Memorial building.

The upcoming St. Louis County Health and Human Service Conference in October 2016, 3 districts were involved with it last year and may work together again this year.

Other things we talked about were Public Speaking and giving presentations, it was suggested that if we are nervous about presenting perhaps we could practice our gig in front of our home group. Practice and play/acting are good tools to use to help improve our personal approach and material. Get on the mailing/phone list and use them to keep in communication with our fellow CPC/PI chairs. Take the presentations to the people we want to inform, such as when the social service department holds a monthly meeting perhaps we could be invited to attend, or nurses and doctors when they meet at the hospital, or for college public safety or nursing programs or high school health classes. There are many opportunities for us to inform the public of the presence of Alcoholics Anonymous.

There are also Public Service announcements available from the GSO for radio and television. Hello, Gayle Alcoholic Treatment Chair.. From our Treatment Committee meeting we had 6 persons present, districts 3,7,12,9 and 14 represented. We followed an agenda type format, District 15, is meeting commitments. They are working with District 4 & District 13 to get more volunteers which is going well. District 3 is getting Temporary Contact forms to the Treatment centers along with Pamphlets and schedules. District 7's new treatment chair, Tony, stepped in in February so she has not really started getting to facilities however she knows she has 5 facilities and that Teen Challenge really does not want us to come in... District 9 has 3 facilities one in which the share with District 8 and one they share with District 6.. A facility in Hibbing wants us to go in every 8 weeks. They also have a beginners group for treatment and that is not supported or encouraged by a local non 12 step treatment facility... They are planning a CPC luncheon in August and considering inviting treatment centers. District 12 has volunteers to cover all facilities they go in.. Working on getting into the facilities we don't go in. They are working on a treatment committee meeting. Bethal is an open speaker meeting that is now showing 60-100 persons attending.. District 14 (GSR filling in for

Treatment chair) Unsure of what we should be doing, are we carrying in the wrong message.. There is an inpatient facility that host a non-GSO registered closed AA meeting that opens to AA members only, passes the 7th tradition basket that only outside AA's contributeshe is wondering why??? I INCOURAGE ANY THOUGHTS ON THIS!!

I encouraged Districts to find 1 male and 1 female for a temporary contact person in their districts, perhaps even 1 on each in the larger communities. We discussed the Purpose of the Treatment Committee. Most of those attending we not at the Area Committee Meeting in February so I handed out forms used for treatments...

We discussed questions formed at the Committee Meeting, "Problems getting into treatment facilities because of political correctness due to pressure to present all forms of recovery" (seems as if facilities wants a generic 12 program... and also, "How to emphasize sponsorship to treatment facilities, defining their definition of a sponsorship." We closed with the Responsibility Statement.. Thank you for allowing me to serve as your Area 35 Treatment Chair... Gayle R.

Point made we have correspondence programs for people in correctional facilities, could the same be done for people in other countries. Bruce B. stated the proposal came

You do not have the current NL in hand and will not be receiving it until later this week. The website version has been online for over a week. I had a very short window to produce the NL and believed I could do it in a span of a couple of days. Such as the Importance of using the Information kits we get from the General Service Office they contain pamphlets and literature that has been vetted through the experience of PI chairs and delegates. These kits are updated yearly and are excellent tools to use in getting started in our general service.

Things we are working on are CPC/PI luncheon that will be held in conjunction with the Hibbing area AA 75th anniversary celebration August 26 at noon in the Hibbing Memorial building. The upcoming St. Louis County Health and Human Service Conference in October 2016, 3 districts were involved with it last year and may work together again this year.

Other things we talked about were Public Speaking and giving presentations, it was suggested that if we are nervous about presenting perhaps we could practice our gig in front of our home group. Practice and play/acting are good tools to use to help improve our personal approach and material.

Get on the mailing/phone list and use them to keep in communication with our fellow CPC/PI chairs.

Take the presentations to the people we want to inform, such as when the social service department holds a monthly meeting perhaps we could be invited to attend.

or nurses and doctors when they meet at the hospital, or for college public safety or nursing programs or high school health classes. There are many opportunities for us to inform the public of the presence of Alcoholics Anonymous.

There are also Public Service announcements available from the GSO for radio and television.

Addressing Singleness of Purpose

Singleness of purpose is ever common issue and topic within our groups and members. So how can we keep the singleness with in our fellowship. The very life of our fellowship requires its preservation, states Bill in the book Alcoholics Anonymous Comes of Age page 106. That book and also the book Twelve Steps and Twelve Traditions compares our fellowship and others like ours to doctors. Each fellowship has their own specialty but still a fellowship so we can mix and match right? Would anyone send a heart patient to a baby doctor? Still a medical doctor, they are all the same right? Would that patient live, maybe but the heart issue may never get better without a cardiologist. How about an alcoholic to a fellowship of over eaters, that alcoholic may lose some weight but most likely still drink. Yet it is so common for treatment centers to send drug addicts to alcoholics anonymous. They teach it's all the same, we are the ones who say it's not. If we look at that drug addict as that heart patient, and Alcoholics Anonymous as that Pediatrician doctor the drug addict may live but the drug problem is not being treated and his heart may stop beating. One member once said, by allowing those without a drinking problem in our fellowship we are not helping them we are in fact hurting them, which could kill them.. Something to think about. Gayle R. An Observation

When I came into Alcoholics Anonymous some 19 years ago I was not made aware of general service in the beginning. I had a definite spiritual experience at my first meeting and new from day one that I would do what ever was asked of me to get what the people in that first meeting had. I knew what ever it was, had to be better than what I was experiencing at the time. I focused on the 12 steps and the inventory taking and the work that that entailed with making amends and practicing these principles in all my affairs a large undertaking needless to say but I stuck with it and felt I had made a complete turn around by year five. The meetings that I went to back in them days did not do the General service routine. I ended up moving to another state and went to a lot of great meetings but there again I was not put in touch with general service, I did make the coffee and lead the meetings and all the other things, working with alcoholics and 12 step work, so I wasn't a complete slacker but I pretty much remained in the dark concerning the goings on at the District/ Area/ General Service Conference and related entities. It just wasn't shown to me, I do remember a friend mentioning going to an assembly type event in Wisconsin but never did it nor felt compelled, I suppose if he had roped me like a calf and hauled me in I might have got there but no go there. So you see a person can exist in AA and really have no clue as to the General service structure and its importance to their sobriety/serenity. I am exhibit number one.

So what happened? I moved back to my hometown and joined a new home group that had a past Delegate as a long time member and numerous people in the group who were involved at the District and Area level. It did not take long in that meeting for them to rope me like a calf and haul me into a District meeting, just kidding I did what was suggested to me and went to a District meeting just to observe ha hah. I observed for two meetings and became secretary at the second meeting imagine that.

Then a DCM and so on, it has been a great experience and a humbling one with a lot of personal growth. So what does all this have to do with anything anyway?

I will attempt to explain, I went to the Winter Workshop in Saint Cloud this past January, it was my first time back to Area in 4 years, do to employment issues so I am relearning things that I had forgotten about. I was listening to Brook the past Delegate from Wyoming talk about Bill W. and his experiences and trials getting the Trustees and Fellowship on board with the idea of a General Service Conference, and it occurred to me that the bulk of the Fellowship remains in the dark concerning The General Service Conference and the immense personal exertion that Bill W. had put into getting it off the ground and here we are 75 years later and we pay so little attention to it and remain so much in the dark concerning it. We do such a great disservice to Bill and the founders for this lack of interest, it borders on disrespect, I feel ashamed thinking of this and feel compelled to do what I can to change the situation. I feel I can speak to this, I am one of the many who remained in the dark them 10 years, I was never really educated on it nor taken to a service meeting, the groups I went to did not encourage me to go, I believe a little bit of encouragement is all I needed and that's what in the end got me there.

So what to do? I am going to start by putting together a presentation for the Fellowship. My first presentation will be brought to an Alano Club which has shown an interest in general service lately. We have a nice film from the General Service Office that shows all the cool stuff at the offices out in New York, I intend to relate the story of Bill W. How he put so much into getting the conference and his trust in us that we as a fellowship would step up to the plate and be the collective conscious that would be the ultimate authority to keep this thing on track and going for many years to come. We will introduce people to the Service Manual and ask them to bring business meetings to their groups and read the 12 Traditions at their meetings.

I will practice a 30 second elevator speech. So when ever I have opportunity when visiting the many meetings I go to I will let them have it, I will also bring the events happening in the General service to the meetings when ever some one asks if there are any announcements.

I will continue to come up with ideas and try them out as I go to do what ever I can to generate interest in service work. If you have ideas or an interest in this I would love to talk to you about it. You can find my contact information in the Northern Light.

I don't think that we overlook the General Service Structure on purpose it just isn't brought to our attention in some cases out of neglect, issues from the past with some of the old timers or any number of reasons. I think if a concerted effort is made to bring this information to the groups and the story of Bill is told and retold it can't hurt and may even help. I will at least try.





The person should also consider the time needed to complete the task required. The candidate should have a working knowledge of A.A. as a whole, i.e., prior experience in service work such as G.S.R., D.C.M., or related position.

N.L. COMMITTEE - The N.L. Committee consists of two D.C.M.s in Area 35. Currently, these have been picked randomly at the start of the new rotation. They also serve on a two-year rotation basis. They assist the editor in communications with other area newsletters, in recommendations on general improvements, and with general problems and implementations of new policies. They may also represent the editor at functions when the editor is unable to attend. Seek advice and help from former N.L. Committee members and editors.

TWELVE CONCEPTS for WORLD SERVICE (Short Form)

- I. Final responsibility and ultimate authority for A.A. world services should always reside in the collective conscience of our whole Fellowship.
- II. The General Service Conference of A.A. has become, for nearly every practical purpose, the active voice and the effective conscience of our whole Society in its world affairs.
- III. To insure effective leadership, we should endow each element of A.A.—the Conference, the General Service Board and its service corporations, staffs, committees, and executives—with a traditional 'Right of Decision."
- IV. At all responsible levels, we ought to maintain a traditional "Right of Participation," allowing a voting representation in a reasonable proportion to the responsibility that each must discharge.
- V. Throughout our structure, a traditional "Right of Appeal" ought to prevail, so that minority opinion will be heard and personal grievances receive careful consideration.
- VI. The Conference recognizes that the chief initiative and active responsibility in most world service matters should be exercised by the trustee members of the Conference acting as the General Service
- VII. The Charter and Bylaws of the General Service Board are legal instruments, empowering the trustees to manage and conduct world service affairs. The Conference Charter is not a legal document; it relies upon traditional and the A.A. purse for final effectiveness.

- VIII. The trustees are the principal planners and administrators of overall policy and finance. They have custodial oversight of the separately incorporated and constantly active services, exercising this through their ability to elect all the directors of these entities.
- IX. Good service leadership at all levels is indispensable for our future functioning and safety. Primary world service leadership, once exercised by the founders, must necessarily be assumed by the trus-
- X. Every service responsibility should be matched by an equal service authority, with the scope of such authority well defined.
- XI. The trustees should always have the best possible committees, corporate service directors, executives, staffs, and consultants. Composition, qualifications, induction procedures, and rights and duties will always be matters of serious concern.
- XII. The Conference shall observe the spirit of A.A. tradition, taking care that it never becomes the seat of perilous wealth or power; that sufficient operating funds and reserve be its prudent financial principle; that it place none of its members in a position of unqualified authority over others; that it reach all important decisions by discussion, vote, and, whenever possible, by substantial unanimity; that its actions never be personally punitive nor an incitement to public controversy; that it never perform acts of government, and that, like the Society it serves, it will always remain democratic in thought and action.

TWELVE TRADITIONS of ALCOHOLICS ANONYMOUS—LONG FORM

Our A.A. experience has taught us that:

- 1. Each member of Alcoholics Anonymous is but a small part of a great whole. A.A. must continue to live or most of us will surely die. Hence our common welfare comes first. But individual welfare follows close afterward.
- 2. For our group purpose there is but one ultimate authority—a loving God as He may express Himself in our group conscience.
- Our membership ought to include all who suffer from alcoholism. Hence we may refuse none who wish to recover. Nor ought A.A. membership ever depend upon money or conformity. Any two or three alcoholics gathered together for sobriety may call themselves an A.A. group, provided that, as a group, they have no other affiliation.
- With respect to its own affairs, each A.A. group should be responsible to no other authority than its own conscience. But when its plans concern the welfare of neighboring groups also, those groups ought to be consulted. And no group, regional committee, or individual should ever take any action that might greatly affect A.A. as a whole without conferring with the trustees of the General Service Board. On such issues our common welfare is paramount.
- Each Alcoholics Anonymous group ought to be a spiritual entity having but one primary purpose—that of carrying its message to the alcoholic who still suffers.
- Problems of money, property, and authority may easily divert us from our primary spiritual aim. We think, therefore, that any considerable property of genuine use to A.A. should be separately incorporated and managed, thus dividing the material from the spiritual. An A.A. group, as such, should never go into busi-10. No A.A. group or member should ever, in such a way as to imness. Secondary aids to A.A., such as clubs or hospitals which require much property or administration, ought to be incorporated and so set apart that, if necessary, they can be freely discarded by the groups. Hence such facilities ought not to use the A.A. name. Their management should be the sole responsibility of those people who financially support them. For clubs, A.A. managers are usually preferred. But hospitals, as well as other places of recuperation, ought to be well outside A.A.—and medically supervised. While an A.A. group may cooperate with anyone, such cooperation ought never go so far as affiliation or endorsement, actual or implied. An A.A. group can bind itself to no one.
- The A.A. groups themselves ought to be fully supported by the voluntary contributions of their own members. We think that each group should soon achieve this ideal; that any public solicitation of funds using the name of Alcoholics Anonymous is highly dangerous, whether by groups, clubs, hospitals, or other outside agencies; that acceptance of large gifts from any source,

- or of contributions carrying any obligation whatever, is unwise. Then too, we view with much concern those A.A. treasuries which continue, beyond prudent reserves, to accumulate funds for no stated A.A. purpose. Experience has often warned us that nothing can so surely destroy our spiritual heritage as futile disputes over property, money, and authority.
- Alcoholics Anonymous should remain forever non-professional. We define professionalism as the occupation of counseling alcoholics for fees or hire. But we may employ alcoholics where they are going to perform those services for which we may otherwise have to engage nonalcoholics. Such special services may be well recompensed. But our usual A.A. "12 Step" work is never to be paid for.
- Each A.A. group needs the least possible organization. Rotating leadership is the best. The small group may elect its secretary, the large group its rotating committee, and the groups of a large metropolitan area their central or intergroup committee, which often employs a full-time secretary. The trustees of the General Service Board are, in effect, our A.A. General Service Committee. They are the custodians of our A.A. Tradition and the receivers of voluntary A.A. contributions by which we maintain our A.A. General Service Office at New York. They are authorized by the groups to handle our over-all public relations and they guarantee the integrity of our principal newspaper, the A.A. Grapevine. All such representatives are to be guided in the spirit of service, for true leaders in A.A. are but trusted and experienced servants of the whole. They derive no real authority from their titles; they do not govern. Universal respect is the key to their usefulness.
- plicate A.A., express any opinion on outside controversial issues—particularly those of politics, alcohol reform, or sectarian religion. The Alcoholics Anonymous groups oppose no one. Concerning such matters they can express no views whatever.
- 11. Our relations with the general public should be characterized by personal anonymity. We think A.A. ought to avoid sensational advertising. Our names and pictures as A.A. members ought not be broadcast, filmed, or publicly printed. Our public relations should be guided by the principle of attraction rather than promotion. There is never need to praise ourselves. We feel it better to let our friends recommend us.
- 12. And finally, we of Alcoholics Anonymous believe that the principle of anonymity has an immense spiritual significance. It reminds us that we are to place principles before personalities; that we are actually to practice a genuine humility. This to the end that our great blessings may never spoil us; that we shall forever live in thankful contemplation of Him who presides over us all.
