



AREA 35 EVENTS INCLEMENT WEATHER PROCEDURE


- ♦ Area Chair calls to cancel and/or re-schedule.

Q:

Why list our past Delegates?

A: They are a resource to you!

In Alcoholics Anonymous we value experience. Our Twelve Steps did not exist when Bill stepped into the lobby of a hotel in Akron, Ohio. Even after meeting with Dr. Bob and soon founding our program, there were only six steps until the experiences of 100 Alcoholics were summed up. Soon after a book followed, but it was a few years later when the Twelve Traditions were discussed and agreed on. Twelve Traditions that were "hammered out on the anvil of experience". Our past Delegates are a wealth of experience, an interactive living archive if you will. When you plan your next service workshop or need an outside voice to offer help, consider this resource available to you. Some of them even offer great company while fishing!

The Delegate's Duties

Though the high point is the Conference meeting, the delegate's job goes on year-round and involves all aspects of the Conference structure. The delegate should:

- Attend the Conference meeting in April, fully prepared. Immediately upon election, every delegate is put on the G.S.O. mailing list to receive Conference materials.
- Communicate the actions of the Conference to area committee members and encourage them to pass on this information, and the delegate's enthusiasm, to groups and to intergroups/central offices. If an area is too large for the delegate to cover in person, he or she will ask area officers and committee members to share the load.
- Be prepared to attend all area, state/provincial, and regional service meetings and assemblies. From these meetings, delegates come to better understand their own areas and can make suggestions for the Conference agenda. Here, too, they come in contact with A.A. members who might not be reached otherwise.
- Help area committees obtain financial support for the area and G.S.O.
- Provide leadership in solving local problems involving the A.A. Traditions

- Remind G.S.R.s to inform groups and individuals about the A.A. Grapevine and Conference-approved literature.
- Cooperate with G.S.O. in obtaining information—for example, making sure that up-to-date information reaches G.S.O. in time to meet the deadline for each Issue of the A.A. directory and helping carry out the triennial membership surveys.
- Visit groups and districts in the area whenever possible.
- Work closely with committee members and officers, sharing experience throughout the year. After G.S.R.s and committee members have reported on the Conference, learn from these A.A.s how groups and members have reacted.
- Assume added responsibility if the area chair and alternate chair are unable
 to serve. Or, if an area committee is not functioning effectively, the delegate may take an active role in remedying the situation.
- Keep the alternate delegate fully informed and active, so that the alternate can replace the delegate in an emergency.
- Late in the second term, work with newly elected delegates to pass along a basic knowledge of Conference proceedings and problems.

Zonal Forums. Good Morning Everyone,

I have been looking through the evaluations from the Fall Assembly and there were some points people brought up. I do appreciate the time you take to complete these as the feedback can help make future assemblies just that much better. I will have a complete list at the Dec ACM and ask Rodney to post to the website for everyone to see at their leisure.

This is likely a duplicate of something Kelly will discuss, but she has created a poster that details the time line for the agenda items to be out for the groups. I bring this up as this was a major topic of evaluations from the Spring Assembly. This poster is on the website for everyone to see. I bring it up as it is the DCM's responsibility once they receive them from Kelly to get them to the GSR's so they can be brought back to the groups. It would be a good idea to start talking in your district meetings when a good time for a meeting on the agenda items would be as this will come quicker than you can imagine. GSR's should also start thinking about when to go through them with their groups so we get a true group conscience when voting in April. This would also be a good time to ask any Area officers or committee chairs you would like at your district meetings. GSR's should start thinking about talking with their DCM's about attending any meeting that may want some support during their discussion as well. I will be bringing this up at every chance I can to remind everyone how fast this will be here.

A flier for the Spring Assembly is being created as I type this. Once it is done, it will be up on the website along with the room registration form for Rutgers Resort as well. A question was brought up to me about how to register multiple people for a room. After talking with Rutgers, they suggested having the name of all people staying in your room ready when you make the reservation. Remember, they do not accept personal checks. They will take checks from your group, so if you make your reservations early you can have your group or district send in your check instead of using your own funds which may or may not help some people out. You should plan to make your reservations early enough in order to mail in your check, which I would suggest about a month and half early. No reservations will be taken 3 weeks prior to the event. Your cost includes room and meals for the weekend. Coffee is just \$10 for the weekend payable at the registration desk when you arrive. I want to thank both Cathy R. and Scott M. for helping with finding locations for the 2017 Fall Assembly. I am now in contact with the Hibbing Park and Hotel about signing a contract with them. It looks like we will be getting the conference room for around \$700 for the weekend, room rates will be around \$110 for a two-person room per night. I will be going to visit the location after deer season to ensure the location is adequate before signing a contract.



Good afternoon. My name is Steve D. and I am an Alcoholic. Currently serving as your Archives Committee Chair.

I would like to encourage all Districts to have someone that can attend our committee meetings. If you do not have someone, I would like to provide the DCM from each district and information that we would pass forward.

Also, I would be very willing to attend any of your District meetings and provide a brief presentation on the importance of archiving our history.

We had 3 districts represented, District 8, District 18 and District 13.

District 8 is putting together and Archives workshop in December at Pike Sandy Town hall. There will be an Old timers panel and a presentation by past Archivist Scott J. and Kevin V. alternate Archives chair.

District 18 is busy gathering group histories and collecting oral history interviews of old timers.

District 13 has been able to obtain the District Archives from the former Archives Chair and is sorting and cataloging the material.

Brad I.gave a report on his recent activities and discussed how we can organize material, digitizing oral history, as tapes and CD's do not last forever.

Two questions were discussed. The first was what is the purpose of the Area Archives Committee. We will distribute the current Area 35 Archives Committee guidelines and review them. We will also develop a Mission Statement or Statement of Purpose.

Another question was "What should we not keep for Archives?" We developed a short list of documents to start with which include:

- Minutes
- District Events, Flyers, Speaker Meetings.
- District Oral History

There was a consensus to develop a proposal to present to an area function a brief presentation on the history of the traditions and how they were developed.

Finally, we discussed gathering information on how the old-timers used to organize roundups. We discussed how roundup attendance has decreased and how those who have been successful can provide us ideas on developing a re-

Archivist:

Since the Fall Assembly I brought the Archives display to the Saint Cloud Round-up. The display was well received and enthusiastically toured. However, there was one person who I sorely missed. I will go into the whys later.

In the years I have been Archivist and the decades I have been a member of Alcoholics Anonymous I have observed a disturbing trend. Attendance at Round-Ups is rapidly decreasing. This is forcing the events to try and cut costs Due to a busy work schedule and some family responsibilities, that I am grateto remain viable. The obvious solution is to get more attendees. I could conjecture upon several reasons as to the attendance drop but I will focus on one aspect. I hear from a lot of long-timers that the cost has gone up so much. I will use a historical example to bring this into perspective. The Upper Midwest Round-up that was held in 1946 in Iowa had an admission of \$3.25. This included a floor show with 18 acts at an Auditorium and a chicken dinner at the club. There was only one speaker. Sounds like a bargain right? A mixed drink at Sadri's in New York City in 1946 with a call liquor was 45 cents. The minimum wage in 1946 was 40 cents. The admission was 7.22 mixed drinks or over an 8-hour work day. Now take that 7.22 times what a call drink would cost now or an 8-hour work day at minimum wage and an 18-dollar admission to a Round-up is a bargain.

To extrapolate on this theme; those of us who come to an AA meeting with a 5 -dollar Caribou Turtle Latte and drop a dollar in the basket are cheating themselves of their opportunity to be freed of the Bondage of Self and help preserve Gratefully yours this Fellowship of ours. My late first sponsor and the man that I wanted to emulate the most when I was a scared shaky newcomer hammered into my head that I would not find sobriety by osmosis and I would not find serenity sitting at home watching television or going to a college sporting event. I would find this only in being of maximum service to God and mankind.

Rick L. of Saint Cloud was that man I wanted to emulate. We shared an obsession for guitars and Merle Haggard. He was 10 years sober when I first walked through the doors and I was amazed by that. We shared countless hours talking about the premises and principles of our Program of Recovery. He had a gift of getting down to the nuts and bolts of How It Works to counter my philosophical, psychological and physiological flights of intellectual fantasy. He saved my life. He was so proud and grateful how this Program of Recovery had worked for me. He was so proud of where I had taken the Archives Display. He contributed a one of a kind item to the display that is very coveted by several other archivists. Rick took his own life on the Tuesday before the Round-Up. He was going to meetings, reading his Big Book, working with others and being of service to the Fellowship. None of us are immune from overwhelming despair. Experience has taught me by 2 instances, that if I am at that point where I don't know what to do, when I feel the world as I perceive it crashing down on me, when my ego and sense of self are gone, and I ask for help and guidance from God with no qualifiers I will receive it.

My biggest hope is when Rick crossed dimensions and became a part of the Universal Mind, his perception was expanded and he could see not only the effect of the message he carried had on the people he was in direct contact with but the effect his message had on other's expanding outward exponentially. I will miss him until I draw my last breath. Thank you for this opportunity to be of service and for saving my life.

Cooperation with the Professional Community:

The most recent activities of the Cooperation with the Professional Community Committee have focused on outreach to the certain professionals in 9 of our Area's counties. In an effort to bring our message to professionals "where they are", as Chair of the CPC committee I have mailed a letter and two appropriate grouprecords@area35.org AA pamphlets to the Sheriffs, Health, or Health and Human Services Directors in Crow Wing, Wadena, Cass, Aitkin, Itasca, Becker, Todd, Douglas and Hubbard counties.

Each personal letter asks these county officials to contact me if, in future department in-house training events, they are willing to provide opportunities for a 15-20 minute presentation regarding Alcoholics Anonymous. The intention is for us to take our story of recovery through the 12 Steps of AA into the work place and to contact an audience which is already gathered to receive training for their respective profession. Deputy Sheriffs and Social Workers, particularly, experience daily the ravages of alcoholism in homes and businesses. If those professionals have not received direct information regarding what we do and how we do, this brief introduction can at least put in their hands pamphlets and information upon which they can further build knowledge.

Much of my professional life has been spent working with county offices and departments which see and viscerally feel the impact of alcoholism. The frontline workers who can be reached through this approach are often the first people outside the affected individuals or families to see the effects of alcoholism. This effort to educate does not ask the county workers to do our work; they are professionals hired to cover a huge waterfront of daily tasks and duties. We simply want them to be aware of our option for recovery from alcoholism and to tap into it if there is opportunity to do so. It could be that a family has heard about AA, but simply don't know how to reach us. Front line workers can offer contact numbers for clients or customers to reach.

Future mailings to all other counties in Area 36 will follow. This approach is a "one step at a time" undertaking. Should you in any of the communities within these 9 counties be contacted because of this letter, but you already have an established relationship with Sheriffs, Jails or Human Services professionals please continue to build on that relationship. Let me know what you need to supplement work you already are doing. Let me or the Literature Chair know if materials are needed. As always, please contact me should you have need for CPC outreach or if you have questions regarding this report.

Public Information:

Greetings from the Area 35 Public Information Chair; When we met for our breakout session at the Fall Assembly in Alexandria we discussed at length a few issues of importance concerning getting the message of AA out to the general public.

One was the use of P.I. Luncheons, where we choose a date well in advance and ask the groups to invite members of the community who come in contact with active alcoholics in their daily routines to come and have lunch pick up some AA literature and listen to a few presentations on what AA does and doesn't do. I have been involved in a few of these and some were fairly successful as far as turnout of interested people and some not so successful. It was pointed out by someone this low turnout is not just a problem with AA functions but other organizations can have similar problems with or without food, getting the invites out in timely manner or what have you. It seems we can do everything right on occasion and still not be as successful as we would like it to be.

Some people thought it makes more sense to take the information directly to the organization, hospital, school, probation centers, etc. either through personal presentations or literature and pamphlet displays. How do we best get the AA message in front of people who are busy and have very little free time during their day for informational presentations of 15 to 30 minute duration. How do we get the information of AA General Service to the groups and membership? It seems there is a lack of knowledge and interest in AA general service and the service conference. There is a nice DVD out there of Bill W. discussing the 12 traditions that can be used for a special meeting of your home group or pass it around to other groups for them to view. I did try a presentation at an Alano club but with limited results it's something I need to work on. One thing to keep in mind is that if we are planning a presentation its best to include more people than just yourself to plan it, run your ideas of what you want to do past someone to get a second opinion, this helps keep the session interesting and practice some of your presentation ahead of time, work with in a committee of interested people and meet together more than once to discuss it. The more planning the better the outcome.

his month has been focused on the 10th Step in the Daily Reflections which has brought up my willingness to actually work this step. I sat here the other day drinking my coffee, taking my inventory for once, and realizing that I don't really execute this step that much. I get lazy sometimes and think well I go to meetings, talk to my sponsor on a somewhat regular basis and stay in contact with other alcoholics. I think I am doing enough. The lies that my alcoholic brain will tell me are amazing. The other thing my screwed up complacent brain will say is that I got this or I'm fine. Well we ALL know what FINE stands for. The denial and games that my disease will try to play on me are astounding. Anyway I REALIZED that I am not really working that great of a program. I work a program probably 80% of the time. I tell you what though that 20% is a big 20% of not doing what I am supposed to be doing. In doing this reflective exercise I realized that the hardest place to work the spiritual principals of my program is in my home life and with my family. Someone put it to me this way one time, "It's not what you do between the Serenity Prayer and the Lord's Prayer, it's what you do from the Lord's Prayer to the next Serenity Prayer." This is the saying that popped in my head while doing my weekly inventory. So with that ruminating around and around in my head at the same time as thinking about the words, thoughts and actions that have been said, thought, and done.........I have not been doing the deal as the old timers tell me. What a kick in the pants. Everything for me starts with a thought, then turns into words and eventually turns into the action. I have been judgmental and snippy, cussing all the time, almost acting like a miserable dry drunk. What was I missing? Why is it that I was doing what I thought was so good and now all of the sudden this drastic attitude change? What is really going on? Hmmmm......what could it be? Then it hit me. I had completely kicked God out of the driver's seat and had decided that things were going so good in my life that I could be in control for a while. WRONG!!!!!!! (The last time I decided to do that I went back out drinking again after 3 years in the program.) So I had to make the choice. Am I going to work this program to the best of my ability or am I going to work this program to the best of my willingness? I can tell you my best ability isn't that great. That's what got me to this program in the first place. I know me if I don't get back on the right track and work these Steps then it is only a matter of time before the thought of a drink comes in my head, then I am saying I want to drink and then eventually whether right away or in due time I am sitting at a bar pounding on it wondering how did I get here. Just like the one paragraph in the Big Book talks about. I'll be mixing whiskey in my glass of milk because the booze won't hurt me then. My main issue is that I had gotten complacent on having God in my life directing me down the path that he already has laid out of me. I decided that my way was the easier softer way. WRONG!!!! Again....imagine that. An alcoholic trying to take back control being wrong, oh the irony. Thank God for this program and the people in it. Without the fellowship, meetings, and 12 Steps there is a chance that I could or would have been drunk very soon. The moral of the story is this: (it may seem obvious to some if not most of you but I am a slow learner.) Without God I can have no quality sobriety or life. It is a DAILY inventory for a reason. It's the step to hold me in check every day multiple times a day. Not once a week or once a month when things in my

Income, Expense, & Contribution Statement: We have received \$5839.45 in contribution for Aug and Sept plus another \$90 in Birthday contributions plus a contribution of \$878.66 from the Gopher State Roundup plus NL flyer income and interest. Giving us a total of \$7097.30 in income.

We had \$1926.88 in event expenses (\$1500 of that is for down payment for the Spring Assembly) and then \$2330.33 in Area Officer and Chair expenses = \$4257.21 in expenses for the period.

COMMITTEE CHAIR AND DCM REPORTS

CPC - Jim T.

One of my great discoveries in sobriety is that I will never get to be anything other than human. Those many years of alcohol-driven day dreams of being the biggest guy in town (my diet my get me there) ...being a millionaire by age 30...living in a house with a picket fence, 2 kids, two cars, and enjoying the "good life" ... are rather normal experiences of non-alcoholics, I suspect. But if you're like me, I carried those "dreams" to heights of insanity while pumping full the pocket books of the Pabst Blue Ribbon Brewery.

How does this pertain to CPC? Well, as your Chairman I have returned to some of those practices of dreaming rather than taking action. I cannot report a huge number of successes these past four months, so this report will focus on what you can do to help Alcoholics Anonymous to work under the banner of Cooperation with the Professional Community. The presentation this evening will provide you hands-on material to bring back to your districts and make contact with local professionals so they may come to better understand what AA offers to them and their clients, customers, or patients. Two remind-

- 1. This isn't about you. By that I mean that all of us carry a fear factor when approaching a judge, a doctor, social worker, or police officer. Some of that fear is simply "I will look stupid' or "I don't know what I'm doing." Welcome to the club. Bill W. and Dr. Bob had to have felt some of those fear factors when they approached Bill D. Alcoholic No. 3. They had the nerve to tell that rough and tough Irishman that they "had a program whereby we think we can stay sober" and that they needed to give it away if they were to maintain sobriety. Were they nervous? I should think so. But they acted...they did it...even to the point of telling Bill D. that if he didn't want what they offered they would go on to the next guy.
- The person you approach may be nervous too. Not all ministers have received the basics of alcoholism...that it is a disease and not a moral failure. The behaviors we exhibit when drunk may be sinful in the eyes of religion, but the underlying cause is an illness which is incurable, but can be arrested. If the minister or other professional is unaware of the facts of alcoholism, you can arm yourself with a variety of pamphlets which will provide answers to both basic and advanced questions. If you are comfortable to sit with your professional contact, do so over lunch when the atmosphere may not be so intense. And always recognize that you may be the only face of alcoholic recovery your contact my experience. Carry the message with confidence, understanding that not all responses will be positive. But such a contact will help to keep you sober.
- <u>Procrastination.</u> My biggest enemy. Don't let it be yours. Take action. As one public speaker stated: "Procrastination is the bad habit of putting off until the day after tomorrow what should have been done the day before yesterday."

How can we get more volunteers, working on pitching the 12 steps, sponsors bringing sponsees? If we are not enthused about what we are doing, what message are we sending to those we are asking. Speak from the heart. In Paynesville, we take in one speaker a month, the treatment center now wants one weekly speaker...

Carrie from District 6 is new treatment chair. District 6 needs help taking meetings into Dellwood and Cambridge. Frustration by lack of communication within the district. Has fears about not reaching the youth. There are non-AA meetings being perceived as AA. A treatment center allows clients to come to local meeting as a privilege, seems to be going well. How can we help the bleeding deacon that goes into a facility from hurting us as a whole...?

Trustee Responsibilities – Tom A.

During the first year Tom will be invited to observe meetings of both corporate boards. Traditionally, the West Central Regional Trustee has served on the Grapevine Corporate Board. Agenda Item Process – Kelly D.

He attended a 3-hour Grapevine writing workshop and found the best part to be listening to the stores and sharing afterward. Dave told us each month of the year has a theme. Articles for the December issue are selected in August, then edited, and released in November. Carla, Grapevine and LaViña Chair Area 36, stated our areas are similar, we are similar. She also stated the LV in overlooked as a tool to reach Spanish speaking alcoholics.

CPC/PI Workshop – Jim T. and Mark N.

Jim T. talked about the CPC work book as a valuable tool for doing CPC work. CPC is for everyone, "you are an expert in your own recovery". Jim encouraged member working in CPC to approach police, doctors, lawyers, social workers, and ministers if they would like a presentation about AA. Jim provided each district with a packet of CPC related information. Jim pointed out employee assistance programs can be accessed to help the still suffering alcoholic.

Mark N. stated he was in AA for 10 years before he was introduced to general service work. It wasn't until he moved back to Brainerd and attended the Sleepy Hollow group where others were involved that he became active in service work. He reminded us it's important to share our experience of general service with other groups and individual members. He encouraged us to work harder to get AA member aware of the general service conference.

NEW BUSINESS:

Redistricting:

Liz L. suggested redistricting of Districts 7 and 17 because District 17 is dark. District 7 is absorbing District 17 at this time to provide opportunities for service to all interested. She requested this be discussed at a Zonal Forum. Kelly D. provided some background: Former Area Chair, Sarah K., visited Dist. 17 and they chose not to be represented at the area level. There 15 meetings in District 17. District 14 has 8 meetings and was dark but is up and running now. Roger R. thought there might be 2 issues: Redistricting of 17 and a large re-districting of Area 35. Scott J. informed us there were fewer districts in the past but members were tired of having to drive so far. AA grew in the 1970-80's so members made a decision to form their own districts. It's up to the groups to make decisions about district activities. He suggested talking with District 17 to find out how we can be helpful to them. He also stated it's our job to communicate with them as to how important this issue is.

Meeting Guide - Bob B.

Bob wants to test Area 35 meetings in an app called Meeting Guide which runs well on cell phones, lap tops, etc. and is used by several areas. Bob wants to test the app and have results to present at the Joint Workshop. AA Meeting Locator has been running for 9-10 years and no other areas have asked to joint. Kathy R. made a motion "to authorize the appropriate Area 35 leadership to initiate a demo of an additional meeting locator methodology." The motion was seconded by Chuck R. Discussion followed: Scott M. asked a question about the data base. Will use FNV, Bob will find out if it automatically updates. Addy R. had concerns about FNV being accurate. Allen stated 39 other areas are using it including Mpls. Bill C suggested we need as many apps as possible to reach the still suffering alcoholic. Jim S. called for a vote, greater than 2/3 majority voted to accept the motion, minority was asked to speak but declined, the motion passed.

7th Tradition Responsibility – Kelly D. and Christine G.

Christine and Kelly shared a power point presentation on the 7th tradition. Christine referred to the 7th Tradition Illustrated pamphlet and explained we are not self-supporting because not all of GSB operating funds come from member donations but rather Grapevine and other literature sales. Of the 1,348,000 members and 65,741 groups only 40% contribute to the GSO. If each registered group donated \$146.00/year and each member gave \$7.14 per year AA would be fully supporting. With just 40% of the groups and members actually contributing it would take \$387.77 from each group and \$19.05 per member donated to directly to the GSO to achieve our goal of being self-supporting through our own contributions. We currently have a 25% shortfall. Over the next three years our expenses will increase, if our donations do not also increase our reserve fund could be depleted. Ways we can encourage selfsupport: Bring the power point presented today back to our groups-Kelly will email power point to DMCs, committee chairs, officers and past delegates. We can share 7th tradition fact sheet and pamphlet with our groups, read Self Support Card at meetings. Ways members can contribute directly to GSO: Birthday envelopes, on-line options, and GSO self-addressed envelopes. Kelly sits on the Finance Committee and learned members can have money automatically drafted from their bank account and sent directly to GSO. Our area has 577 registered groups but only 191 contribute to GSO. Since the GSC there has been an overall increase of 4% in donations. A question was asking regarding where the prudent reserve came from. Tom A. explained the fund grew over the decades when income was greater than expenses and is equal to approximately 11 months of operating expenses. He also stated literature prices go up and down depending on the amount of money in the prudent reserve.

DCM Sharing Session Report – Brian P.

- 1. Zonal Forum- input on being a part of the zonal forum, and what we would like to see from the area officers when they come. Zone 3: 5, 6 11, 13, 18, 7 & 17.
 - ♦ We voted not to have zonal forums unless the DCM's specifically requested them because we did not think that it was financially worth it. What the point on having the vote to decide something if it doesn't get followed through on.
 - Roger R. approached me that the action booklet states that he will talk to whoever will be holding the zonal form that they get to each of the zones one time throughout that 2-year period. It is zone 3's s turn to have the zonal forum. I am looking for input to see if the districts are interested in having a zonal forum. I asked my district about what if we had more time to plan the zonal forum would you want that to occur. Getting a flyer together etc. we are discussing redistricting. I thought it would be an opportunity to discuss the redistricting between 17 & 7.
 - Explanation of a zonal forum.
 - Our district has declined from the hosting perspective.
 - ♦ We dealt with some redistricting in district 14 & 8. If the district doesn't want to do it, then the district doesn't want to do it. If my district is not in favor of it then we will not do it.
 - ♦ After we had enough people to reform district 14, we are 100 miles from everyone; it doesn't seem feasible for us. Maybe the redistricting needs to come from the larger areas, and maybe more districts need to be added so that we can have more DCM's to get to these groups, where you are splitting it up instead of having one person try to get to all these meetings.

You get the areas that are always busy, we wonder if we should just put them in the areas where it is busy, or do you put them in the areas where people aren't showing up. That is what we are discussing. We are dealing with the same thing. Until I got a new sponsor. And then I got involved in service. You just learn as you go.
- Moving district meetings.
- ♦ We rotate Monday through Friday the first full week of the month, at the same time, but the day changes during that week, and a different group hosts it. So we are always traveling around the district
- I like that because some people do not like missing their meetings.
- ♦ We picked a time where no one had a meeting, but everyone shows because there is no conflict.
- Who had the heartland? What part of that does the district put on?
- The district does not run it. The group runs it.

- Us being here and doing these things, and getting out there and taking the actions, people will see it, and we might not have a ton Ask it Basket - Past Delegates of participation, I remember I was a treatment chair during the rotation when district 14 showed up to district 8 and asked to join us, and pretty soon random people started coming to the district meeting and they decided they were going to try having a district meeting again, they didn't fill all the chairs but they did take ac-
- This has been going up for many years. We need to let people know that it is not the truth that this is survival.
- Do you find that people, who are against service, are against having a sponsor and working the steps?
- Yes, absolutely.
- Part of our deal is to make sure that AA is there for the next guy that hasn't come in yet, we have pretty good recovery, we need to have unity, we argue once in a while but we have unity, it is 3rd leg of the stool, service that is a little weak, we are trying to pay back this debt that we owe, but it is also there for the guy that hasn't come into the door yet. I want to make sure AA is there.
- Anyone who comes to a district meeting can carry that information back to that group, most people go to more than one meet-
- DCM split up different things within the district and have them visit meetings so that the DCM is not doing it all.
- Communication within the district. When there are a lot of meetings within the district. A lot of meetings just aren't aware that there is a district and there is opportunity for service work. They need to be informed.

Editor - The Editorial Chair position is a two-year rotation picked by the incoming Area Chair and either approved or rejected by the Area Committee at the first Area meeting after the Fall Assembly Elections.

Desirable qualifications: Current or past working knowledge of the printing business. Knowledge of current computer printing programs. The person should also consider the time needed to complete the task required. The candidate should have a working knowledge of A.A. as a whole, i.e., prior experience in service work such as G.S.R., D.C.M., or related position.

N.L. COMMITTEE - The N.L. Committee consists of two D.C.M.s in Area 35. Currently, these have been picked randomly at the start of the new rotation. They also serve on a two-year rotation basis. They assist the editor in communications with other area newsletters, in recommendations on general improvements, and with general problems and implementations of new policies. They may also represent the editor at functions when the editor is unable to attend. Seek advice and help from former N.L. Committee members and editors.

N.L. COMMITTEE MEETINGS:

The Committee meets every other month, before the start of the Area Workshop and at Spring and Fall Assemblies. Additional meetings may be called for if needed between these times.

TWELVE CONCEPTS for WORLD SERVICE (Short Form)

- I. Final responsibility and ultimate authority for A.A. world services should always reside in the collective conscience of our whole Fel-
- II. The General Service Conference of A.A. has become, for nearly every practical purpose, the active voice and the effective conscience of our whole Society in its world affairs.
- III. To insure effective leadership, we should endow each element of A.A.—the Conference, the General Service Board and its service corporations, staffs, committees, and executives—with a traditional "Right of Decision."
- IV. At all responsible levels, we ought to maintain a traditional "Right of Participation," allowing a voting representation in a reasonable proportion to the responsibility that each must discharge.
- V. Throughout our structure, a traditional "Right of Appeal" ought to prevail, so that minority opinion will be heard and personal grievances receive careful consideration.
- VI. The Conference recognizes that the chief initiative and active responsibility in most world service matters should be exercised by the trustee members of the Conference acting as the General Service
- VII. The Charter and Bylaws of the General Service Board are legal instruments, empowering the trustees to manage and conduct world service affairs. The Conference Charter is not a legal document; it relies upon traditional and the A.A. purse for final effectiveness.
- VIII. The trustees are the principal planners and administrators of overall policy and finance. They have custodial oversight of the sep-

- arately incorporated and constantly active services, exercising this through their ability to elect all the directors of these entities.
- IX. Good service leadership at all levels is indispensable for our future functioning and safety. Primary world service leadership, once exercised by the founders, must necessarily be assumed by the trus-
- X. Every service responsibility should be matched by an equal service authority, with the scope of such authority well defined.
- XI. The trustees should always have the best possible committees, corporate service directors, executives, staffs, and consultants. Composition, qualifications, induction procedures, and rights and duties will always be matters of serious concern.
- XII. The Conference shall observe the spirit of A.A. tradition, taking care that it never becomes the seat of perilous wealth or power; that sufficient operating funds and reserve be its prudent financial principle; that it place none of its members in a position of unqualified authority over others; that it reach all important decisions by discussion, vote, and, whenever possible, by substantial unanimity; that its actions never be personally punitive nor an incitement to public controversy; that it never perform acts of government, and that, like the Society it serves, it will always remain democratic in thought and ac-

TWELVE TRADITIONS OF ALCOHOLICS ANONYMOUS—LONG FORM

Our A.A. experience has taught us that:

- 1. Each member of Alcoholics Anonymous is but a small part of a 8. great whole. A.A. must continue to live or most of us will surely die. Hence our common welfare comes first. But individual welfare follows close afterward.
- For our group purpose there is but one ultimate authority—a loving God as He may express Himself in our group conscience.
- Our membership ought to include all who suffer from alcoholism. Hence we may refuse none who wish to recover. Nor ought 9. A.A. membership ever depend upon money or conformity. Any two or three alcoholics gathered together for sobriety may call themselves an A.A. group, provided that, as a group, they have no other affiliation.
- 4. With respect to its own affairs, each A.A. group should be responsible to no other authority than its own conscience. But when its plans concern the welfare of neighboring groups also, those groups ought to be consulted. And no group, regional committee, or individual should ever take any action that might greatly affect A.A. as a whole without conferring with the trustees of the General Service Board. On such issues our common welfare is paramount.
- Each Alcoholics Anonymous group ought to be a spiritual entity having but one primary purpose—that of carrying its message to the alcoholic who still suffers.
- Problems of money, property, and authority may easily divert us from our primary spiritual aim. We think, therefore, that any considerable property of genuine use to A.A. should be separately incorporated and managed, thus dividing the material from the spiritual. An A.A. group, as such, should never go into business. Secondary aids to A.A., such as clubs or hospitals which require much property or administration, ought to be incorporated and so set apart that, if necessary, they can be freely discarded by the groups. Hence such facilities ought not to use the A.A. name. Their management should be the sole responsibility of those people who financially support them. For clubs, A.A. managers are usually preferred. But hospitals, as well as other places of recuperation, ought to be well outside A.A.—and med- 12. And finally, we of Alcoholics Anonymous believe that the prinically supervised. While an A.A. group may cooperate with anyone, such cooperation ought never go so far as affiliation or endorsement, actual or implied. An A.A. group can bind itself to
- The A.A. groups themselves ought to be fully supported by the voluntary contributions of their own members. We think that each group should soon achieve this ideal; that any public solicitation of funds using the name of Alcoholics Anonymous is highly dangerous, whether by groups, clubs, hospitals, or other outside agencies; that acceptance of large gifts from any source, or of contributions carrying any obligation whatever, is unwise. Then too, we view with much concern those A.A. treasuries which continue, beyond prudent reserves, to accumulate funds for no stated A.A. purpose. Experience has often warned us that nothing can so surely destroy our spiritual heritage as futile dis-

- putes over property, money, and authority.
- Alcoholics Anonymous should remain forever non-professional. We define professionalism as the occupation of counseling alcoholics for fees or hire. But we may employ alcoholics where they are going to perform those services for which we may otherwise have to engage nonalcoholics. Such special services may be well recompensed. But our usual A.A. "12 Step" work is never to be paid for.
- Each A.A. group needs the least possible organization. Rotating leadership is the best. The small group may elect its secretary, the large group its rotating committee, and the groups of a large metropolitan area their central or intergroup committee, which often employs a full-time secretary. The trustees of the General Service Board are, in effect, our A.A. General Service Committee. They are the custodians of our A.A. Tradition and the receivers of voluntary A.A. contributions by which we maintain our A.A. General Service Office at New York. They are authorized by the groups to handle our over-all public relations and they guarantee the integrity of our principal newspaper, the A.A. Grapevine. All such representatives are to be guided in the spirit of service, for true leaders in A.A. are but trusted and experienced servants of the whole. They derive no real authority from their titles; they do not govern. Universal respect is the key to their usefulness.
- 10. No A.A. group or member should ever, in such a way as to implicate A.A., express any opinion on outside controversial issues—particularly those of politics, alcohol reform, or sectarian religion. The Alcoholics Anonymous groups oppose no one. Concerning such matters they can express no views whatever.
- 11. Our relations with the general public should be characterized by personal anonymity. We think A.A. ought to avoid sensational advertising. Our names and pictures as A.A. members ought not be broadcast, filmed, or publicly printed. Our public relations should be guided by the principle of attraction rather than promotion. There is never need to praise ourselves. We feel it better to let our friends recommend us.
- ciple of anonymity has an immense spiritual significance. It reminds us that we are to place principles before personalities; that we are actually to practice a genuine humility. This to the end that our great blessings may never spoil us; that we shall forever live in thankful contemplation of Him who presides over us all.
