Treasurer:

Greeting Area 35,

I attended the Spring Assembly at Ruttger's Bay Lodge in April. My report including the financials are printed in the minutes.

It was a great assembly and I was impressed by the involvement of the group and districts. It goes to show the passion and care that we have in Area 35 regarding preserving Alcoholics Anonymous and making sure, the program continues down the right path. I was very impressed with the stance that out Area is taking on Social Media and letting our Traditions guide us in this endeavor. It has been clearly spoken that AA should not be getting involved in these areas and we need continue talking to our members in our homegroups and educating them on what how we should not be posting on Facebook and other sites. It is not our right to break anonymity on Facebook at the expense of others. We have to realize how our actions effect the people we are connected to and how we effect AA as a whole.

At the end of the day, I don't have control over the actions of others but I can lead by example and I can do the best that I can to "practice these principles in all my affairs" and to make sure that I am following the Traditions.

I met with the Financial Oversight Committee to go over your bank accounts and they reported that all your money is accounted for in all accounts. I appreciate that Jim and Neil were willing to meet at the Spring Assembly being I missed our regular scheduled meeting at the Area Committee Meeting in February due to an illness. A special thank you to both of them.

As of April 30th, your checking account has a balance of \$13,197.54 plus \$6,043.54 in the savings account for your prudent reserve for a total of \$19,241.08. The prudent reserve is there to cover 2-3 months of operating expenses in case a decline in group contributions and expenses needed to be covered.

With our 2017 Financial Statement of Responsibility of about \$50,000, we need about \$4,200 per month in contributions to be on track to cover the expenses. Almost half of the Financial Statement of Responsibility has been incurred the first four months of this year so with continued group support

throughout the remaining year, I anticipate contributions will meet the expenses.



For the month of April we have received \$2,283.64 in group contributions and had \$4,446.97 in expenses. This compares to 2016 of \$3,018.55 in con-



tributions and \$6,654.77 in expenses.

Comparing 2016/2017 through the month of April, we received \$10,420.93 in 2016 and \$7,486.97 in 2017 in group contributions. We are about \$3,000 down from last year and as you will see in the next graph, our expenses have



only increased a little bit.

Expenses in 2016, through April, were \$19,874.33 and in 2017 are at \$20,529.87 for a difference of about \$700. I am confident that that groups will pull together and send in their contributions. If your groups have any questions on where contributions are going, please visit this link:

Attendance;

District 13, District 18, District 8, District 4. Area Archivist

Archivist:

Greetings every one;

I made through the Superior Round-up without getting wet. I wasn't sure if I was going but that is another story. At the Round-up I chaired an open discussion meeting with a topic of my choice, Singleness of Purpose. With the sharing on this topic, I heard about several locales, which have opened their meetings to non-alcoholics due to the lack of any other fellowship available nearby. This is a break of Tradition 5. We are choosing an easier softer way to deal with an ongoing issue that is going to increase exponentially in the near future. Rhetorical Question. What is going to happen to an Alcoholics Anonymous meeting when alcoholics are outnumbered by non-alcoholics? I am sympathetic to the misdirected nobility and the overwhelming desire to help others. In the short term, it can be beneficial to the non-alcoholic but long term wise this misdirected nobility is detrimental to the non-alcoholic and Alcoholics Anonymous as a whole.

There is an ancient Chinese parable, Give a man a fish and he will eat for one day. Teach a man how to fish and he will eat for a lifetime. I would suggest to those who feel this moral obligation to break tradition to help, not as A.A. members, but as caring citizens to help these non- alcoholics start a meeting of the fellowship that is more suitable to their problem. Help them develop a meeting format. Help them find a meeting place. Help them buy their own literature. I would like to remind them. Their meeting was started by a single alcoholic who had nowhere else to go 60 years ago with help from other alcoholics.

tives for her final trip to New York and the General Service Conference. The aspects of the General Conference pertinent to CPC did not take center stage among the various topics. I complement both Kelly and Area Chair Jim S. as they maintained a good pace to guide us through the Agenda items. We look forward to Kelly's report within our various Districts.

On March 14th District 15 DCM Melissa A. and I presented the CPC message to 30 Public Health and Social Workers from several north central Minnesota Counties. First, thanks to Melissa for her excellent message which resonated with an all-female audience and gave rise to great questions regarding her personal story as well as her role to reach out to the professionals in all communities. Second, our presence in their comfortable space and within their schedule for many topics pertinent to their jobs was another example of "let's take the message to them".

CPC is ready to work with each District. As noted in previous information I will be glad to arrange for a trip to your District meeting or to other events, which serve the fellowship to share the message with the still-struggling alcoholic. Perhaps more than we know, that still-struggling alcoholic who is sober in AA but remains confused, anxious and unable to express their needs. We want the hand of AA always to reach out to our neighbors.

Before I turn off the light at bedtime, I make it a commitment to read something from AA material. Sometimes from the Big Book, or the 12x12, or the Grapevine. The other night I read an article from Vol. 1 of the Best of the Grapevine authored by one of our great non-AA members of the Board of Trustees, Dr. John Norris. He addressed in a 1977 article "Our Primary Purpose and the Special-Purpose Group". It seems somethings don't change...at least not much

Dr. Norris observed, "We have never discouraged AAs from forming special -purpose meetings of any or all kinds to meet the needs of interested individuals, but we have been hesitant to consider as *groups* those that might seem to exclude any alcoholic, for whatever reason...However, the fact is that such groups *do* exist—in the United States and Canada, at least. There are women's groups, stag groups, young people's groups, and groups for priests, doctors, lawyers, and homosexual members. These groups feel that the "labels" serve the purpose of attraction (*double* identification) and are not intended to imply exclusion of other alcoholics."

He goes on to observe, "The adversaries of the special-purpose group would say that this is an instance where the good became the enemy of the best, to use co-founder Bill W.'s phrase. Once AA had accepted one kind of special-purpose group (such as a women's group), it became difficult, if not almost impossible, not to accept others."

Dr. Norris observed, "When we make a distinction between AA groups and AA meetings, we are emphasizing a *concept* rather than the *format* of what actually happens when AAs get together. We think of an AA group as something that continues to exist even when there is no meeting-taking place, because a group does many other things besides holds meetings. On the other hand, special-purpose *meetings*, which take care of the needs of interested individuals, are usually informal gatherings with no particular structure."

So forty years ago a very astute observer and strong advocate for AA made suggestions which resonate today. A group? A meeting? To which do you belong?

I attribute that to the individual districts being well informed on the agenda topics background and the discussions and overall feel brought back from the West Central Regional Alcoholics Anonymous Service Conference.

We had a lengthy discussion in our Area Officers and Committee Chairs meeting involving the need for all of us in Area 35 to look for someone willing to take over the position of Archivist and continue with the same fortitude, enthusiasm, and commitment as Brad has.

Group records chair, Bob B. presented an example of aameetinglocator converted to a Wordpress site, just as we have done with the Area35.org. He also shared his experience in trying to maintain the continually changing group information using the GSO database (also known as the Fellowship New Vision database). Bob suggested that we use the GSO database to initially load all group data to aameetinglocator, but then use a Wordpress friendly plug-in locator to keep that information updated; this is to be maintained by the Group Records Chair as he/she already receives new or changing group information. His suggestion brought forth much controversial discussion. He agreed to having a model of the site and a clear proposal for Area 35 consideration at a future Area event.

It's been a busy month for me, personally, with work and my writing endeavors. I also took some time off to visit relatives and friends in Kansas, and to do some traveling in southeast and northeast Wisconsin. Adding flyers to the events calendar and making changes to some of the district pages has been the bulk of my activity for this month since the Spring Assembly.

It was reported to me at the assembly that the pictures at the end of the 2016 Delegate's Report Back were a violation of our traditions. I am actually surprised that no one had brought this up any sooner. With little more than a month remaining before the new report came out I simply removed it. After speaking with Kelly about this, she thought maybe for this year we would use password protection so that, ideally only members of Alcoholics Anonymous would be able to view the report pages.

I will soon be making arrangements with Kelly to meet her with the projector and screen for her first report back, which will take place at Brainerd on May 18th.



Participation at the Service level-How to get AA members involved in GSR Service?:

- Bring new people along to the steering committee/group conscience meetings; be attractive.

- It's a sponsor's job to encourage their sponsee's to get involved in service work.

What information we take from the District to the group and from the group to the District including how to give a report to each:

- Get registered as a GSR with GSO and receive the GSR packet through
- Updating the District with current information about your group as well as upcoming events etc. From the district meetings the GSR takes back what is taking place at the District level, what's been voted on, what the committee chairs are doing, where and what help is needed at
- GSR takes back questions and concerns from the District.
- Depending on your Group Conscience, find out what your group wants to know about the District and what the District wants to know about your group.

How to respond to the conflict of Anonymity:

- Anonymity is important for each individual to disclose or not disclose
- Micro fine, macro not fine. On a small level it's okay, on the larger level it's not okay.
- Give your name and phone number to your group for a call list, it's our responsibility to be open to newcomers to be of service.
- Make sure that it's okay with someone before you give out their personal number.
- Anonymous at the level of press radio and films, on an individual basis it's personal preference.
- When connecting with newcomers, make sure to grab THEIR phone number instead of giving them your number and make sure to call them if you feel comfortable doing so.
- Common sense, information, and some knowledge. Ask others about their own experience with anonymity at your home group. Own anonymity is not our own. It belongs to each and every one of us.
- When someone disrespects the tradition, not only are they hurting themselves they're hurting every one of us.
- If you have a question about anonymity, there is a wonderful pamphlet called "Understand Anonymity" that answers many questions about it.
- It's okay to talk about things shared at meetings as long as the person who said it isn't named, implied, or easily identified.

Treasurer – Christine G. Greetings Area 35,

I met with the Financial Oversight Committee regarding the Area Finances and they would like to report that all your money balances and is accounted for.

I have filed the 2016 990N for Area 35, which is for Tax-Exempt Organizations not required to File Form 990 or 990-EZ.

Our Delegate, Kelly, sent out a District/Group contribution report from GSO. The report shows that there are 572 groups in Area 35 and of those groups 264 or 46.15% have contributed to GSO in 2016. I ran the number for Area 35 and 238 or 42% of the groups are contributing to the Area. I have printouts for all the DCMs to take back to your districts. It will show what groups contributed during 2016. I have also included a printout of what the group contributions to the Area help support so you can share that with them.

That brings us to our Period 2 Area 35 financials.

- Balance Sheet Balance in all accounts total \$20,196.03
- Income, Expense and Contribution Statement
 - ♦ P-2, we have received \$2,339.15 in group contributions and YTD we have received \$5,203.33.
 - ♦ P-2 expenses = \$6,915.63 and YTD = \$13,690.57
 - * We have had some major expenses go out for 1st quarter and that does include our \$1,600 expense to send our Delegate to the General Service Conference in NY to carry the group conscience on the agenda items we have been discussing this weekend.
 - * The WCRAASC was in Wyoming.
 - * Some of this weekend's expenses have been recorded

All contributions are appreciated and I would like to thank everyone for your support. If you have, any questions please feel free to see at any time this weekend.

The G.S.O. January unaudited financial report revealed that net sales were \$190,610 over budget. Contributions were \$227,289 over budget and expenses were \$58,641 less than budgeted. This resulted in a profit for the month of \$387,371 compared with a one-month budgeted loss of \$122,799.

Preliminary results through February showed net sales approximately \$210,000 greater than budgeted, and contributions \$290,000 more than budget. Total expenses were on budget and a preliminary net profit of approximately \$643,000 was reported compared with a budgeted net profit of \$4,610 for the two months, which is \$499,400 higher than the same period last.

Ask it Basket – Past Delegates.

- 1. Have times or issues changed very much from earlier years (70"s) to today and how were/are they handled or dealt with? Scott J.-There was no archive or archivist. No GSR orientation, GSR or DCM sessions, area actions booklet. No webmaster, pre-conference. We're not supposed to move fast. Take time to discuss things.
- 2. Has your service work caused you to miss your home group meetings? Jake-Very little. When I miss, it's hard, difficult. Home group is in your heart.
- 3. Do you think that the conference agenda selection process in balanced so that the fellowship has equal access to the process? Not equal vetting. Improvement needed.
- 4. Can you share your experience with the importance of "singleness of purpose"? John C.-We are doing a disservice to Alcoholics Anonymous if we deal with other problems.
- 5. Define the third tradition. Tom A.-The long form has more information. We ought to include all who suffer from alcoholism but we have only one requirement. Open meetings are held to see if you do have a problem. Scott J.-we don't want anyone to die so we help them find where they need to go for help.
- 6. Do you think there is a good balance of Class A Trustees to Class Trustees? Suzie A.-There are 7 Class A, non-alcoholic trustees and 14 Class B, Alcoholic Trustees. Thinks we may not need class A's as we have come a long way. Scott J.-most of us feel that way.
- 7. How long was it until you felt comfortable with understanding the agenda items? Bruce B.-Scott made one mistake when he though I made a mistake. At Bruce's first district meeting, he heard about VCR, DMZ, the 12 conflicts, and PCP committees. Had no idea what was going on at first assembly; talk and talk and did not make a decision. Took 3-4 assemblies before he felt comfortable. Hot topics had more weight-were items where decisions might be made. If you don't understand, please come back.
- 8. What is a steering committee? Jim K.-Definition: a committee that decides on the priorities or order of business of an organization and manages the general course of its operation. (From Service Manual pg. S-27). Common in larger groups. Acts on behalf of members.
- 9. When are past delegates going to write an article for the NL? John C. Their job is to sit in the back of the room and help when things get muddled, get things back on track. Thought they could write articles.
- 10. Is the blue blazer required attire for past delegates? What's the story behind that? Tom A.-It's tradition to wear a blue blazer, grey pants, and crazy socks. Board meetings the attire is a piece suite and a tie for trustees. The delegates were once asked if they were a convention of funeral directors.
- 11. Have times changed in AA? Jim K.-When topics come up we always look at them in light/eyes of the traditions. Traditions give us a pathway.
- 12. How would a district handle a meeting that allows all addictions to attend and speak of their addictions? Doesn't this violate our traditions? Is this still an AA meeting? Suzie A.-We are Alcoholic Anonymous! Suggested the DCM go to the group and talk about singleness

of purpose. These groups usually fall apart on their own.

- 13. If a group or district has a lot of extra money around-what would be some ways to spend it down? Bruce B.-When money goes in the basket it belongs to AA. If a group has too much money, they should contribute to the entities. If a district has too much they could send officers to WCRAASC. Don't buy hot dogs!
- 14. If somehow controlled, wouldn't a Facebook or Twitter account through AA be helpful to reach young people or introverts who are afraid to or are more isolated a way for them to learn about AA? Jake-Possibly. Decisions about social media must hold up in light of our traditions. If you think someone needs to be reached, then reach out to them. Try to reach in a way that is not outside of yourself.

Additional Past Delegate Comments: They are against the 3 cases of Big Books for the Moose Lake Correctional Facility. 18 new GSRs-we need new people. Contributions are up, let's all participate. The participation level here was great; this is how AA gets better. Thanks were given to Bob B. and Brad I. for their service. Jake is a candidate for trustee at large. Kelly was given a warm send off to General Service Conference. Kelly reported she has been eating, sleeping, and breathing the agenda items but last night she didn't think about them. We are guardians of the traditions in the WCR, we keep the traditions first in our decisions.

Adjourn: Assembly was closed with the responsibility statement.

In March, District 13 conducted a district inventory in order to take stock of

Lessons Learned from a Failed Inventory

our assets and liabilities. Like the Big Book says on page 64, "A business which takes no regular inventory usually goes broke." What we learned was conducting the inventory incorrectly can almost be as damaging as not conducting an inventory at all. As a result of a skewed and improper surveying procedure, the entire inventory was declared "null and void". Here are the lessons we learned from a failed inventory.

- 1. Don't Rush to Failure: Some GSRs felt that the process was rushed and ultimately that haste made waste. It was mentioned that if we had taken more time we could have been more successful.
- 2. Communication is Key: Some GSRs reported that they didn't understand the directions for filling out the inventory. Others thought it was unclear what portions of the inventory they were supposed to complete. Before proceeding with the inventory process, ensure everyone is clear about the directions and expectations.
- 3. Know What You are Grading: Many of the GSRs reported that they were supposed to grade the performance of the district chairs, but they had little to no idea what the chair had done. This confusion and lack of clarity could be ameliorated by having the chairs give verbal reports or to provide a written year-in-review summary of their service work.
- 4. Determine Your Audience: The inventory was sent out to over 100 people although only 20-25 GSRs attend our monthly district meetings. The lesson learned here is to ensure you know what you are asking and from whom you are asking it.
- 5. Right Person for the Right Job: Ensure you have someone who is thoroughly versed in the conducting of a survey/inventory and facilitating it. Our survey sample was too small for the size of audience that it was sent to. This resulted in skewed results and gave a false picture of the district. Ultimately, the inventory had to be declared null and void.

Going forward here are suggestions for improving the process for future inventories:

- 1. Distribute the inventory only to those GSRs and chairs who are attending the district meeting. This will ensure a 1:1 ratio of respondents to inventories.
- 2. Do not send the inventory out electronically, rather hand them to the GSR or District Chairs at the district meeting.
- 3. Include instructions on how to fill out the inventory and an expected completion date.
- 4. Provide inventories a minimum of three months in advance of the expected inventory meeting. This will allow ample time for groups and committees to discuss the inventory.
- 5. Do not conduct the inventory until a minimum of 75% of them have been returned.

The candidate should have a working knowledge of A.A. as a whole, i.e., prior experience in service work such as G.S.R., D.C.M., or related position.

N.L. COMMITTEE - The N.L. Committee consists of two D.C.M.s in Area 35. Currently, these have been picked randomly at the start of the new rotation. They also serve on a two-year rotation basis. Q: Why list our past Delegates?

A: They are a resource to you!

In Alcoholics Anonymous we value experience. Our Twelve Steps did not exist when Bill stepped into the lobby of a hotel in Akron, Ohio. Even after meeting with Dr. Bob and soon founding our program, there were only six steps until the experiences of 100 Alcoholics were summed up. Soon after a book followed, but it was a few years later when the Twelve Traditions were discussed and agreed on. Twelve Traditions that were "hammered out on the anvil of experience". Our past Delegates are a wealth of experience, an interactive living archive if you will. When you plan your next service workshop or need an outside voice to offer help, consider this resource available to you. Some of them even offer great company while fishing!

The Delegate's Duties

Though the high point is the Conference meeting, the delegate's job goes on year-round and involves all aspects of the Conference structure. The delegate should:

- Attend the Conference meeting in April, fully prepared. Immediately upon election, every delegate is put on the G.S.O. mailing list to receive Conference materials.
- Communicate the actions of the Conference to area committee members and encourage them to pass on this information, and the delegate's enthusiasm, to groups and to intergroups/central offices. If an area is too large for the delegate to cover in person, he or she will ask area officers and committee members to share the load.
- Be prepared to attend all area, state/provincial, and regional service meetings and assemblies. From these meetings, delegates come to better understand their own areas and can make suggestions for the Conference agenda. Here, too, they come in contact with A.A. members who might not be reached otherwise.
- Help area committees obtain financial support for the area and G.S.O.
- Provide leadership in solving local problems involving the A.A. Traditions.

- Remind G.S.R.s to inform groups and individuals about the A.A. Grapevine and Conference-approved literature.
- Cooperate with G.S.O. in obtaining information—for example, making sure that up-to-date information reaches G.S.O. in time to meet the deadline for each Issue of the A.A. directory and helping carry out the triennial membership surveys.
- Visit groups and districts in the area whenever possible.
- Work closely with committee members and officers, sharing experience throughout the year. After G.S.R.s and committee members have reported on the Conference, learn from these A.A.s how groups and members have reacted.
- Assume added responsibility if the area chair and alternate chair are unable to serve. Or, if an area committee is not functioning effectively, the delegate may take an active role in remedying the situation.
- Keep the alternate delegate fully informed and active, so that the alternate can replace the delegate in an emergency.
- Late in the second term, work with newly elected delegates to pass along a basic knowledge of Conference proceedings and problems.

Twelve Concepts for World Service (Short Form)

- I. Final responsibility and ultimate authority for A.A. world services should always reside in the collective conscience of our whole Fellowship.
- II. The General Service Conference of A.A. has become, for nearly every practical purpose, the active voice and the effective conscience of our whole Society in its world affairs.
- III. To insure effective leadership, we should endow each element of A.A.—the Conference, the General Service Board and its service corporations, staffs, committees, and executives—with a traditional "Right of Decision."
- IV. At all responsible levels, we ought to maintain a traditional "Right of Participation," allowing a voting representation in a reasonable proportion to the responsibility that each must discharge.
- V. Throughout our structure, a traditional "Right of Appeal" ought to prevail, so that minority opinion will be heard and personal grievances receive careful consideration.
- VI. The Conference recognizes that the chief initiative and active responsibility in most world service matters should be exercised by the trustee members of the Conference acting as the General Service Board
- VII. The Charter and Bylaws of the General Service Board are legal instruments, empowering the trustees to manage and conduct world service affairs. The Conference Charter is not a legal document; it relies upon traditional and the A.A. purse for final effectiveness.

- VIII. The trustees are the principal planners and administrators of overall policy and finance. They have custodial oversight of the separately incorporated and constantly active services, exercising this through their ability to elect all the directors of these entities.
- IX. Good service leadership at all levels is indispensable for our future functioning and safety. Primary world service leadership, once exercised by the founders, must necessarily be assumed by the trustees
- X. Every service responsibility should be matched by an equal service authority, with the scope of such authority well defined.
- XI. The trustees should always have the best possible committees, corporate service directors, executives, staffs, and consultants. Composition, qualifications, induction procedures, and rights and duties will always be matters of serious concern.
- XII. The Conference shall observe the spirit of A.A. tradition, taking care that it never becomes the seat of perilous wealth or power; that sufficient operating funds and reserve be its prudent financial principle; that it place none of its members in a position of unqualified authority over others; that it reach all important decisions by discussion, vote, and, whenever possible, by substantial unanimity; that its actions never be personally punitive nor an incitement to public controversy; that it never perform acts of government, and that, like the Society it serves, it will always remain democratic in thought and action.

Twelve Traditions of Alcoholics Anonymous (Long Form)

Our A.A. experience has taught us that:

- 1. Each member of Alcoholics Anonymous is but a small part of a great whole. A.A. must continue to live or most of us will surely die. Hence our common welfare comes first. But individual welfare follows close afterward.
- 2. For our group purpose there is but one ultimate authority—a loving God as He may express Himself in our group conscience.
- 3. Our membership ought to include all who suffer from alcoholism. Hence we may refuse none who wish to recover. Nor ought A.A. membership ever depend upon money or conformity. Any two or three alcoholics gathered together for sobriety may call themselves an A.A. group, provided that, as a group, they have no other affiliation.
- 4. With respect to its own affairs, each A.A. group should be responsible to no other authority than its own conscience. But when its plans concern the welfare of neighboring groups also, those groups ought to be consulted. And no group, regional committee, or individual should ever take any action that might greatly affect A.A. as a whole without conferring with the trustees of the General Service Board. On such issues our common welfare is paramount.
- 5. Each Alcoholics Anonymous group ought to be a spiritual entity having but one primary purpose—that of carrying its message to the alcoholic who still suffers.
- 6. Problems of money, property, and authority may easily divert us from our primary spiritual aim. We think, therefore, that any considerable property of genuine use to A.A. should be separately incorporated and managed, thus dividing the material from the spiritual. An A.A. group, as such, should never go into business. Secondary aids to A.A., such as clubs or hospitals which require much property or administration, ought to be incorporated and so set apart that, if necessary, they can be freely discarded by the groups. Hence such facilities ought not to use the A.A. name. Their management should be the sole responsibility of those people who financially support them. For clubs, A.A. managers are usually preferred. But hospitals, as well as other places of recuperation, ought to be well outside A.A.—and medically supervised. While an A.A. group may cooperate with anyone, such cooperation ought never go so far as affiliation or endorsement, actual or implied. An A.A. group can bind itself to
- 7. The A.A. groups themselves ought to be fully supported by the voluntary contributions of their own members. We think that each group should soon achieve this ideal; that any public solicitation of funds using the name of Alcoholics Anonymous is highly dangerous, whether by groups, clubs, hospitals, or other outside agencies; that acceptance of large gifts from any source,

- or of contributions carrying any obligation whatever, is unwise. Then too, we view with much concern those A.A. treasuries which continue, beyond prudent reserves, to accumulate funds for no stated A.A. purpose. Experience has often warned us that nothing can so surely destroy our spiritual heritage as futile disputes over property, money, and authority.
- 8. Alcoholics Anonymous should remain forever non-professional. We define professionalism as the occupation of counseling alcoholics for fees or hire. But we may employ alcoholics where they are going to perform those services for which we may otherwise have to engage nonalcoholics. Such special services may be well recompensed. But our usual A.A. "12 Step" work is never to be paid for.
- 9. Each A.A. group needs the least possible organization. Rotating leadership is the best. The small group may elect its secretary, the large group its rotating committee, and the groups of a large metropolitan area their central or intergroup committee, which often employs a full-time secretary. The trustees of the General Service Board are, in effect, our A.A. General Service Committee. They are the custodians of our A.A. Tradition and the receivers of voluntary A.A. contributions by which we maintain our A.A. General Service Office at New York. They are authorized by the groups to handle our over-all public relations and they guarantee the integrity of our principal newspaper, the A.A. Grapevine. All such representatives are to be guided in the spirit of service, for true leaders in A.A. are but trusted and experienced servants of the whole. They derive no real authority from their titles; they do not govern. Universal respect is the key to their usefulness
- 10.No A.A. group or member should ever, in such a way as to implicate A.A., express any opinion on outside controversial issues—particularly those of politics, alcohol reform, or sectarian religion. The Alcoholics Anonymous groups oppose no one. Concerning such matters they can express no views whatever.
- 11.Our relations with the general public should be characterized by personal anonymity. We think A.A. ought to avoid sensational advertising. Our names and pictures as A.A. members ought not be broadcast, filmed, or publicly printed. Our public relations should be guided by the principle of attraction rather than promotion. There is never need to praise ourselves. We feel it better to let our friends recommend us.
- 12. And finally, we of Alcoholics Anonymous believe that the principle of anonymity has an immense spiritual significance. It reminds us that we are to place principles before personalities; that we are actually to practice a genuine humility. This to the end that our great blessings may never spoil us; that we shall forever live in thankful contemplation of Him who presides over us all.
