#### **Cooperation with the Professional Community:**

Although there remains several months in this rotation of your officers and committee chairs, it is never too early to seek and find those in our fellowship who can step forward (reluctantly or "both feet in") to carry the message to the alcoholic who still suffers. As I wind down my commitment during these final months of 2017, I also seek those who will step forward to assume the responsibility for the coordination of the Area's Cooperation with the Professional Community (CPC) Committee in the next rotation. There are many in Area 35 who have taken responsibilities to meet with and offer the A.A. message of recovery to doctors, social workers, law enforcement and other professionals. Thank you for your work at the local level.

In the "A.A. Guidelines for CPC": <u>Which A.A. Members are Best Suited for</u> <u>Cooperation with (Agencies)?</u> These are the suggestions for A.A. members who want to step forward:

- Have several years continuous sobriety, serenity and steadfastness, mixed with a clear grasp of the purpose of 12<sup>th</sup> Step work;
- Have had wide A.A. experience, not only in more than one group, but also...in general service affairs;
- Have an understanding of A.A. experience recorded in the Big Book, *A.A. Comes of Age, Twelve Steps and Twelve Traditions*, and other A.A, publications.

Also in the "A.A. Guidelines" appears a general summary of C.P.C.

"Members of these committees provide information about A.A. to those who have contact with alcoholics through their profession. This group includes healthcare professionals, educators, members of the clergy, lawyers, social workers, union leaders, and industrial managers, government officials, as well as those working in the field of alcoholism. Information is provided about where we are, what we are, what we can do, and what we cannot do."

Those who respond to the call for commitment to this important aspect of "carrying the message" can learn much through a visit to the G.S.O.'s A.A. Web site (www.aa.org). Under the tab "Information on A.A." there are three additional tabs which will lead you to many sources and materials for CPC work.

You will find at least 8 basic pieces of literature regarding C.P.C. There is a long list of pamphlets for Professionals as well as for people who Professionals serve.

Though it is not a requirement that individuals who seek to serve in C.P.C work be professional presenters, it is suggested that C.P.C. members be comfortable in their skills to present to small groups as well as to contact professionals by phone and written messages.

Your next step to pursue your interest to serve C.P.C. is to talk to your sponsor, your District C.P.C. Committee, Area Chair Jim S. or me. I have many materials to pass on to the next Committee Chair. I offer my service Sponsorship for all who follow this rotation. Those who work with them share the successes of this committee, and from that commitment, build on their contented sobriety.

When I was one year, three years, or 10 years sober I simply did not understand the calling to serve at the Area level. There were those with longer periods of sobriety who asked me to "jump in"; there were those who kicked my a\*\* and simply said, "Do this!" There has been nothing done to me to cause me harm as this work progresses. No one called me out. I learn to live this program of recovery through commitment and simply moving forward. I can never learn in the "outside" world the benefits which we as alcoholics can gain from simply saying "yes" to our call to give away what we have been given.

areas in my personal life. I have had a minimal number of flyers and updates to the website and the events calendar.



# **Humility and Egoes - Hmmmm**

Meaning maybe we don't have to follow the traditions any longer, maybe we can take what we like and leave the rest, we need to change with the times etc... always another rationale so that we don't need to do what we know to be the right and good thing-follow the 12 Traditions set before us by our founders.

What are other reasons why we like to announce sobriety dates on social media? I have asked myself that very question and have to ask what are my motives? I too have been tempted to share my sobriety celebration on Face book to let the world know how grateful I am for my new way of life in recovery. To let people know what God is doing in my life and how thankful I am for that God and a new way of living. To let people know there is hope out there for anyone else that suffers from the disease of alcoholism. There are many reasons to share it on social media. But really what are our motives? If all these reasons were truly my motives, I wouldn't need to announce it on social media because people would already see this new way of life working in me. They would see how grateful I am, they would see what I already am doing in my life and I should already be giving people hope. People should already be seeing these things that I profess on social media in my everyday life. If I have worked the steps and have been given the solution as a result of the steps, people will know it and I don't need to advertise it. Remember the tradition of attraction rather than promotion? I certainly don't need to promote myself or AA. I need to be attracting people in my everyday life by the new life I have been given. So, what are my motives? Hmmm- maybe just to gain a few pats on the back, and congratulations, maybe just to simply reassure my ego that I am a success today.

There's that ego again. If we are following our traditions, as we should be, we would see there is no place for the ego, only humility and service. In following our traditions, we are to stay humble, keep our name out of the limelight. Then of course we have those that post their sobriety dates and just don't use the word AA or Alcoholics Anonymous. They are in recovery or have recovered-hmm- that certainly is not in the spirit of the traditions just because you don't use the word alcoholics anonymous. I think that is just skirting around the issue and the true meaning of Tradition 12. It goes back to checking our motives and egos.


Principles before personalities. We have all heard it and even said it. Generally, when someone is doing something or saying something we don't agree with, we brush it off and say, "ah well, principles before personalities" and move on. Certainly we can say that and it is helpful in being loving and tolerant to all. However, after listening and learning from an old timer who said, "Read through the tradition in the 12x12 and learn that that has nothing to do with it." What? So, after reading through tradition 12 in our 12 Steps and 12 Traditions book and learning, of course, the old timer was correct. That tradition is about the principle of anonymity at the level of press, radio, film and now social media. The principle of humility, putting our own personal ambitions and egos, agendas aside for the unity of AA. Experience tells us that anonymity is real humility at work in us. We try to give up our natural desires for personal distinction. We are sure that humility, expressed by anonymity, is the greatest safeguard that Alcoholics Anonymous can ever have. As stated in our Twelve Steps and Twelve Traditions book, because AA's twelve traditions repeatedly ask us to give up personal desires for the common good, we realize that the sacrificial spirit-well symbolized by anonymity- is the foundation of them all. We must give up our own personal desires and thinking that we know best. If we continue, we will surely be jeopardizing Alcoholics Anonymous and then there will be no hope for the still suffering alcoholic. Let us put aside our egos and well-intentioned plans and ideas, listen and learn from our founders and adhere to the traditions of Alcoholics Anonymous. Who are we, who is any one of us to disregard or "get around" our traditions? For AA to survive and help those still suffering, we must adhere to what we have been taught and what has been so freely given to us.

# What Did I Do at the Forum Today?

#### Notes and Thoughts from attendees to the West Central Regional Forum

WCRAA-Forum Treatment report. Was able to get there in time for the first timer orientation, even though this wasn't my first time at a forum. We heard from both our Class A (non-alcoholic) and Class B (alcoholic) trustee on what they have been doing since being elected, or drawn from the hat back in April. Beau, AAWS Director, stated, "GSO is here to make sure the fellowship has what they need to carry the message." There are 85 employees at AAWS which handles 90,000 emails-letters or phone calls annually, 73,000 contribution envelopes, 1500 requests for the archives and ships 7.3 million books-pamphlets or materials. The www.aa.org website has been revamped to make it more mobile friendly. During the first year (20 years ago) of the website there was 100,000 visits. Today there are 100,000 per day. There are three different venues, for the future alcoholic, the professional and the AA member. There are 9 employees at AA Grapevine and over the last 4 years \$815,000 went to reserve fund.

We enjoyed some PowerPoint presentations, topics sprinkled with personal stories from Delegates from areas 40, 52, 36, and our very own Delegate Kelly. Several staff gave reports on their departments. I enjoyed the report from David M, non-alcoholic, he is a CPC and the General Service Board Freasurer and Finance. He stated that the reserve fund cannot be larger than a 12-month reserve, it is currently at 10.3 months. If it gets above the 12 months, that's when we could see perhaps a price drop in literature or something similar.

I attended two breakout sessions, the first was American Sign Language Accessibility. In the session we learned the difficulties two women from Area 36 faced when they sobered up. Ashley moved from Washington and only had ASL meetings Monday and Friday, like a lot of us she felt she needed a meeting every day. At some point she was paying out of her own pocket for (Continued on page 16)

Une of the workshops I attended was on Implied Affiliation. In that session, it mentioned there is a district in Nebraska with a Facebook page. On their Facebook page, they show pictures of faces, full names and have treatment center ads. I thought this was big news until I looked on line at other Intergroup and other recovery pages that have AA links to them. Tradition 11 on public Anonymity looks shattered. WOW, I was surprised and deeply saddened by this wide spread ignorance and lack of respect for AA Traditions.

David M. the GSO Treasurer made a great presentation and if you would like his complete 90-page report, email him at david.morris.cpa@gmail.com. In the Friday Night Grapevine presentation it was mentioned how the GV is operating in the black and has for the past few years. With the surplus GV has paid back the monies withdrawn from its prudent reserve. I asked the GV general manager how was that accomplished. She stated that it was through the lessening of operation overhead, and the increase in the selling of other GV books though GV subscriptions have remained flat. I found all the GSO staff present were easy to talk with and easily accessible.

The other breakout workshop I attended was on using the Traditions as a Club. Mostly stories about groups in Alano Clubs. How the people in these groups don't have any awareness of the Traditions and truly think people who try to inform and educate about our Traditions become ostracized. No matter if you are Tradition conservative or Tradition stretcher the only real person wielding a club is John Barleycorn. He wins when we disregard or tighten the Traditions and groups falter and die.

There were questions put to the GSO staff about litigation on a temporary restraining order by New York State Supreme Court to prevent a manuscript (printers' copy of the Big Book) from being sold at auction. This Manuscript has handwritten notes from Bill W. and others and shows the evolution of what became the first published edition of the Big Book. There is more to come on this, since the GSO staff said they could not comment now because of current litigation. They promised full disclosure when settled.

Thank you for sending me to the West Central Regional Forum. There was a nice sprinkling of experienced service people. Past Trusties, Past Delegates, Past Area Committee people with a healthy mix of new people to General Service along with first time Forum Attendees. I had some great fellowship, pie and ice cream.

One of the last things I heard from the mike was," Many people say they are able and willing to do something in AA. Challenges test your willingness, by having you do something.'

A group of us had the opportunity to have dinner with David Morris, CPA, GSO Treasurer. What a wonderful privilege to meet David and ask questions about our fellowship finances. Our fellowship is doing a great job of sending in contributions and we just need to fire it up a little bit more. Can you believe we are only about 2 million away from being self-supporting? That seems like a lot but if we break like this. There are only about 40% of groups contributing and if we could get that up to 60% and that would be approximately 15,000 additional groups contributing at \$135 total. We could be completely self-supporting through our own contributions. WOW! That is obtainable. Please remember that if your home group does not contribute to the three entities, you can contribute on an individual basis. GSO offers online contributions and recurring payments if this is something you're interested in doing.

# Area 35 Committee Meeting Minutes Aitkin, MN August 6, 2017

**Call to Order: Jim S.** Called meeting to order. Opened with the Serenity Prayer.

**Recognition of Past Area 35 Delegates in Attendance:** Tom A. Panel 50; Susie A. Panel 48; Mike J. Panel 64; Jim Kath Panel 62.

Approval of the 2017 Spring Assembly Minutes: Motion made and seconded to approve minutes. Minutes were approved.

## **OFFICER REPORTS**

#### DELEGATE-Kelly D. Greetings Area 35.

It is good to be here with all of you today as we come together to share our experiences carrying our message of hope through the service we do within our Districts and Area 35. I recently sent out the June "AAWS Highlights" to all of you. Quoting from that report under Finance "While noting some of the variances between the 2017 budget and year-to-date results in the finance report, it was reported that sales were running considerably ahead of budget, with contributions ahead of budget as well. One reason for the higher than anticipated sales related to the availability of the new A.A.W.S./Grapevine catalog which was recently mailed with Box 4-5-9. The G.S.O. four-month unaudited financial report revealed that gross sales were \$127,650 or 2.62% ahead of budget. Contributions were \$368,923 or 16.35% ahead of budget and total operating expenses were \$202,622 or 3.67% less than budget. Net profit for the four months was \$719,374 compared with a budgeted loss of \$155,197. The committee also discussed the switch to new paper for the Big Book last year, which has already saved as much as \$70,000 so far, and the overall reduction of Conference expense in the travel, meals and accommodations cost line. Additionally, it was noted that a meeting between the Finance and IT departments and Class A Trustee David Morris, treasurer of the General Service Board, took place to discuss immediate changes on how to process contributions more effectively and efficiently." It is great to see the positive totals and changes so far for this year, thank you all that are contributing to our GSO to make this possible! I hope you all take the time to read all of the other "Highlights" and the work that is being done by so many that are committed to carrying our message.

Since the last Committee Meeting in June where I presented my report back to all of you, I have traveled and presented to Districts 8, 13, 15, 1, 2, 21 and 11. I will be finishing up with Districts 3, 4, 5, 6 and 12 throughout this month and the last in September. As you know, there has been a world of information that came out of this year's General Service Conference and it has been great to see the questions and conversations that have occurred because of it. I am truly grateful to be a part of Area 35 that is so involved in our Agenda Items process and all that is going on at our GSO. I am also humbled from receiving such wonderful comments and feedback from many and I want to thank you all for the opportunity to be able to serve and present that information to you! Again, once I have completed all Districts I will send my power point of my report back to Rodney, to have him post it on our Area 35 website. I will then send out an email with a pass-protected password to access it. I will be receiving the hard copies of the "Final Conference Report" via the mail sometime in the middle of August. They will be available for distribution at our upcoming Fall Assembly from Skip, our Literature Chair, be sure to grab a copy. I also received it anonymity protected digitally and asked Rodney to post it to our Area 35 website. Because the document is so large, he has run across some difficulty. I have no doubt he will get it figure out and posted. I will let him explain it further in his report today. Once it is posted,  $\hat{I}$  will send out and email to all of you with a password to access it.


# Dear Patrick,


The Treatment Chair from Area 35 asked me to write to you about "carrying the message" to the active duty and veteran communities. I am happy to do so.

First allow me to introduce myself. I am Maj. John D. with the Minnesota National Guard. I am on active duty and I recently celebrated 39 years of sobriety. I will retire from the Armed Forces in January of 2018. While on active duty I have had the honor of starting English speaking A.A. meetings in Germany, putting on an A.A. Roundup for sober GIs and civilians in Augsburg, Germany, working as a liaison to German speaking A.A., starting an A.A. meeting in Basra, Iraq and attending A.A. meetings in Talill and Balad, Iraq. I also had the honor of speaking at our last Int'l Convention during the "Sober and Serving Our Country" meeting.

Here are some of the ways that I have carried the message to our veteran and active duty community within the context of military life, to alcoholics who are veterans and active duty members of the Armed Services.

- a. I bring a meeting into the St. Cloud VA six times a year. The St. Cloud VA cooperates with the local A.A. groups and has A.A. meetings brought inside to their treatment facility on a weekly basis.
- b. I often do A.A. talks to Soldiers in the Minnesota National Guard on my alcoholism and recovery therefrom.
- c. I conducted an A.A. workshop for Chaplains of the Minnesota National Guard in January of this year. We used the CPC PowerPoint and showed the video Hope as well as conducted a lively Q&A session.
- d. I have contacted the St. Cloud VA about our upcoming A.A. convention in Sept. We have made arrangements to pay for the registration fee for any veteran who wants to attend the convention as well as providing transportation from the VA to the convention and back.
- e. I wrote a story for the Grapevine on A.A. and the Armed Services. It was published in the October 2017 edition of the <u>Grapevine</u> on page 26.

I was seven years sober when I joined the Armed Services. However, one barrier I encountered was my background check for my security clearance. I was getting ready for deployment and I had to have a secret security clearance. A background check was conducted and during the interview the investigator asked, "Are you a member of A.A.? Do you attend A.A. meetings?

I froze momentarily picturing my military career going down the toilet, but I responded, "Yes, I am a sober member of A.A."

The investigator replied, "Meet another friend of Bill W."

Astonished I asked him, "How is this going to affect my security clearance

Does my recovery move out from myself and into the world, the people I interact with? Do I look like a person with a spiritual program, in and out of service?

Adhering to the basics, listening to the voice of the collective conscience, and utilizing available literature, specifically the service manual and *Alcoholics Anonymous Comes of Age*, combined with responsibility and humility will most assuredly bring positive responses to these questions for me and you.

Finally, a couple of items regarding spirituality and newcomers: How am I welcoming newcomers and what is my attitude toward them, especially diverse A.A.'s. It takes money to advance spiritual matters; am I paying my way in A.A.? Carl B. has stated, if someone is getting a free lunch in A.A., someone else is paying for it! On this topic of finance and self-support, David M., the General Service Board Treasurer gave a thorough financial presentation, in which our 7<sup>th</sup> Tradition contributions were up.

# **Third Legacy Procedure**

**A.A.** 's Third Legacy Procedure is a special type of electoral procedure, used primarily for the election of delegates and regional and at-large trustees. It is considered to be unique to A.A., and at first glance, appears to introduce a strong element of chance into a matter that should depend solely on the judgment of the majority. In practice, however, it has proved highly successful in eliminating the influence of factions or parties that seem to thrive on most political scenes. The railroading of a candidate for election is made difficult, if not impossible, since voters have a wide selection of candidates to choose from. More importantly, a second-place candidate who may be extremely well qualified but without early popular support is encouraged to stay in the balloting rather than withdraw.

## Third Legacy Procedure is as follows:


- The names of eligible candidates are posted on a board. All voting members (of the area or Conference body) cast written ballots, one choice to a ballot. The tally for each candidate is posted on the board.
- The first candidate to receive two-thirds of the total vote is elected.
- Withdrawals start after the second ballot. If any candidate has less than one-fifth of the total vote, his or her name is automatically with-drawn—except that the top two candidates must remain. (In case of ties for second place, the top candidate and all tied runners-up remain as candidates.)
- After the third ballot, candidates with less than one-third of the total vote will be withdrawn automatically, except the two top candidates remain. (In case there are ties for second place, the top candidate and all tied runners-up remain as candidates.)
- After the fourth ballot, if no candidate has two-thirds of the total vote, the candidate with the smallest total is automatically withdrawn, except that the top two candidates remain. In case there are ties for second place, the top candidate and all tied second place candidates remain. At this point, the chairperson asks for a motion, second, and a simple majority of hands on conducting a fifth and final ballot. If this motion is defeated, balloting is over and the choice is made by lot—"going to the hat"—immediately. If the motion carries, a fifth and final ballot is conducted.
- If after the fifth ballot no election occurs, the chairperson announces that the choice will be made by lot (from the hat). At this point, the top two candidates remain. In case there are ties for first place, all tied first place candidates remain. In case there are no ties for first place, the top candidate and any tied second-place candidates remain.
- Lots are then drawn by the teller, and the first one "out of the hat" is the delegate (or trustee or other officer). delegate (or trustee or other officer).

# **Guardians of the Fellowship**

he Guardians of the Universe are a fictional race of extraterrestrials appearing in American comic books published by DC Comics, commonly in association with The Green Lantern.

Guardians of the Galaxy is a 2014 American superhero film based on the Marvel Comics superhero team of the same name.

Guardian of our Traditions is a label often used to describe the General Service Conference. On July 3, 1955 in St. Louis, by resolution, Bill W. et al turned over the stewardship of the AA society to the movement. The Conference became the **Guardian of the Traditions** and voice of the group conscience of the entire Fellowship. The resolution was unanimously adopted by the Convention by acclamation and by the General Service Conference by formal resolution and vote. (AACOA ix, 47-48, 223-228).

an interpreter. Could any of us afford \$40 a meeting just to be able to attend AA. A group in District 8 Area 36 came up with the idea of a Green Can, which is similar to the pink can for prisons/jails. It seems the big issue is always the cost, why does some have to have a low price to get recovery? The other woman, Miranda, lived in Rochester, then the cities, went to meeting in the cities. There is now a meeting daily, she attended. Miranda then moved back to Rochester and she received a culture shock, there were no meetings. She is working on that. I do not know of any ASL meetings in Area 35.

The other session I attended was Our Connection to Veterans. We discussed a couple of questions, What challenges we face reaching our veterans & Grapevines in the VA-send a gift subscription. For the challenges we face reaching veterans, the discussion was long, we had many veterans in our session, some with war history some without. A big obstacle is veterans are to proud to admit they need help. PTSD is a huge part of some veterans, not all veterans have PTSD. One veteran stated his alcoholism did not cause PTSD nor did PTSD cause his alcoholism. We need more veterans helping veterans, based on relating to some of the same outside issues. Alcoholics Anonymous can only help with alcoholism. Grapevine to veterans, simply send a gift subscription to a VA hospital, living facilities. Even perhaps old grapevines there as well. Someone mentioned Racks and pamphlets in the VA's.

In A.A. we go to great lengths to avoid the use of titles. Although we have a DCM, PI Chair, Treatment Chair, etc., these are job descriptions and not job titles. We do not use titles like ISO 9001 Certified or "Guardian of the Traditions" to describe individuals. Ours is a society of equals.

This label of Guardian of the Traditions was meant for the General Service Conference. Let's leave it for this body that is made of more than a hundred individuals from across the U.S. and Canada.

Lastly, let's remember the wise counsel given to us in our eleventh tradition... "This tradition is a constant and practical reminder that personal ambition has no place in A.A. In it, each member becomes an active guardian of our Fellowship". (pg. 183 in Twelve Steps and Twelve Traditions)

Guardian of the fellowship is call to action not a title.

- Gather useful service information to publish from sources within the Area, Region and A.A. as a whole. Obtain, read and use other Area newsletters.
- Listen to comments from the Area on the content of the N.L.

## EDITORIAL POSITION & N.L. COMMITTEE:

**Editor** - The Editorial Chair position is a two-year rotation picked by the incoming Area Chair and either approved or rejected by the Area Committee at the first Area meeting after the Fall Assembly Elections.

**Desirable qualifications:** Current or past working knowledge of the printing business. Knowledge of current computer printing programs. The person should also consider the time needed to complete the task required. The candidate should have a working knowledge of A.A. as a whole, i.e., prior experience in service work such as G.S.R., D.C.M., or related position.

**N.L. COMMITTEE** - The N.L. Committee consists of two D.C.M.s in Area 35. Currently, these have been picked randomly at the start of the new rotation. They also serve on a two-year rotation basis. They assist the editor in communications with other area newsletters, in recommendations on general improvements, and with general problems and implementations of new policies. They may also represent the editor at functions when the editor is unable to attend. Seek advice and help from former N.L. Committee members and editors.

## N.L. COMMITTEE MEETINGS:

The Committee meets every other month, before the start of the Area Workshop and at Spring and Fall Assemblies. Additional meetings may be called for if needed between these times.



# Q: Why list our past Delegates?

## A: They are a resource to you!

In Alcoholics Anonymous we value experience. Our Twelve Steps did not exist when Bill stepped into the lobby of a hotel in Akron, Ohio. Even after meeting with Dr. Bob and soon founding our program, there were only six steps until the experiences of 100 Alcoholics were summed up. Soon after a book followed, but it was a few years later when the Twelve Traditions were discussed and agreed on. Twelve Traditions that were "hammered out on the anvil of experience". Our past Delegates are a wealth of experience, an interactive living archive if you will. When you plan your next service workshop or need an outside voice to offer help, consider this resource available to you. Some of them even offer great company while fishing!

# The Delegate's Duties

Though the high point is the Conference meeting, the delegate's job goes on year-round and involves all aspects of the Conference structure. The delegate should:

- Remind G.S.R.s to inform groups and individuals about the A.A. Grapevine and Conference-approved literature.
  - \_ \_\_\_\_\_
- Attend the Conference meeting in April, fully prepared. Immediately upon election, every delegate is put on the G.S.O. mailing list to receive Conference materials.
- Communicate the actions of the Conference to area committee members and encourage them to pass on this information, and the delegate's enthusiasm, to groups and to intergroups/central offices. If an area is too large for the delegate to cover in person, he or she will ask area officers and committee members to share the load.
- Be prepared to attend all area, state/provincial, and regional service meetings and assemblies. From these meetings, delegates come to better understand their own areas and can make suggestions for the Conference agenda. Here, too, they come in contact with A.A. members who might not be reached otherwise.
- Help area committees obtain financial support for the area and G.S.O.
- Provide leadership in solving local problems involving the A.A. Traditions.

- Cooperate with G.S.O. in obtaining information—for example, making sure that up-to-date information reaches G.S.O. in time to meet the dead-line for each Issue of the A.A. directory and helping carry out the triennial membership surveys.
- Visit groups and districts in the area whenever possible.
- Work closely with committee members and officers, sharing experience throughout the year. After G.S.R.s and committee members have reported on the Conference, learn from these A.A.s how groups and members have reacted.
- Assume added responsibility if the area chair and alternate chair are unable to serve. Or, if an area committee is not functioning effectively, the delegate may take an active role in remedying the situation.
- Keep the alternate delegate fully informed and active, so that the alternate can replace the delegate in an emergency.
- Late in the second term, work with newly elected delegates to pass along a basic knowledge of Conference proceedings and problems.

# **Twelve Concepts for World Service (Short Form)**

I. Final responsibility and ultimate authority for A.A. world services should always reside in the collective conscience of our whole Fellowship.

II. The General Service Conference of A.A. has become, for nearly every practical purpose, the active voice and the effective conscience of our whole Society in its world affairs.

III. To insure effective leadership, we should endow each element of A.A.—the Conference, the General Service Board and its service corporations, staffs, committees, and executives—with a traditional "Right of Decision."

IV. At all responsible levels, we ought to maintain a traditional "Right of Participation," allowing a voting representation in a reasonable proportion to the responsibility that each must discharge.

V. Throughout our structure, a traditional "Right of Appeal" ought to prevail, so that minority opinion will be heard and personal grievances receive careful consideration.

VI. The Conference recognizes that the chief initiative and active responsibility in most world service matters should be exercised by the trustee members of the Conference acting as the General Service Board.

VII. The Charter and Bylaws of the General Service Board are legal instruments, empowering the trustees to manage and conduct world service affairs. The Conference Charter is not a legal document; it relies upon traditional and the A.A. purse for final effectiveness. VIII. The trustees are the principal planners and administrators of overall policy and finance. They have custodial oversight of the separately incorporated and constantly active services, exercising this through their ability to elect all the directors of these entities.

IX. Good service leadership at all levels is indispensable for our future functioning and safety. Primary world service leadership, once exercised by the founders, must necessarily be assumed by the trustees.

X. Every service responsibility should be matched by an equal service authority, with the scope of such authority well defined.

XI. The trustees should always have the best possible committees, corporate service directors, executives, staffs, and consultants. Composition, qualifications, induction procedures, and rights and duties will always be matters of serious concern.

XII. The Conference shall observe the spirit of A.A. tradition, taking care that it never becomes the seat of perilous wealth or power; that sufficient operating funds and reserve be its prudent financial principle; that it place none of its members in a position of unqualified authority over others; that it reach all important decisions by discussion, vote, and, whenever possible, by substantial unanimity; that its actions never be personally punitive nor an incitement to public controversy; that it never perform acts of government, and that, like the Society it serves, it will always remain democratic in thought and action.

# **Twelve Traditions of Alcoholics Anonymous (Long Form)**

## Our A.A. experience has taught us that:

- 1. Each member of Alcoholics Anonymous is but a small part of a great whole. A.A. must continue to live or most of us will surely die. Hence our common welfare comes first. But individual welfare follows close afterward.
- 2. For our group purpose there is but one ultimate authority—a loving God as He may express Himself in our group conscience.
- 3. Our membership ought to include all who suffer from alcoholism. Hence we may refuse none who wish to recover. Nor ought A.A. membership ever depend upon money or conformity. Any two or three alcoholics gathered together for sobriety may call themselves an A.A. group, provided that, as a group, they have no other affiliation.
- 4. With respect to its own affairs, each A.A. group should be responsible to no other authority than its own conscience. But when its plans concern the welfare of neighboring groups also, those groups ought to be consulted. And no group, regional committee, or individual should ever take any action that might greatly affect A.A. as a whole without conferring with the trustees of the General Service Board. On such issues our common welfare is paramount.
- 5. Each Alcoholics Anonymous group ought to be a spiritual entity having but one primary purpose—that of carrying its message to the alcoholic who still suffers.
- 6. Problems of money, property, and authority may easily divert us from our primary spiritual aim. We think, therefore, that any considerable property of genuine use to A.A. should be separately incorporated and managed, thus dividing the material

or of contributions carrying any obligation whatever, is unwise. Then too, we view with much concern those A.A. treasuries which continue, beyond prudent reserves, to accumulate funds for no stated A.A. purpose. Experience has often warned us that nothing can so surely destroy our spiritual heritage as futile disputes over property, money, and authority.


- 8. Alcoholics Anonymous should remain forever non-professional. We define professionalism as the occupation of counseling alcoholics for fees or hire. But we may employ alcoholics where they are going to perform those services for which we may otherwise have to engage nonalcoholics. Such special services may be well recompensed. But our usual A.A. "12 Step" work is never to be paid for.
- 9. Each A.A. group needs the least possible organization. Rotating leadership is the best. The small group may elect its secretary, the large group its rotating committee, and the groups of a large metropolitan area their central or intergroup committee, which often employs a full-time secretary. The trustees of the General Service Board are, in effect, our A.A. General Service Committee. They are the custodians of our A.A. Tradition and the receivers of voluntary A.A. contributions by which we maintain our A.A. General Service Office at New York. They are authorized by the groups to handle our over-all public relations and they guarantee the integrity of our principal newspaper, the A.A. Grapevine. All such representatives are to be guided in the spirit of service, for true leaders in A.A. are but trusted and experienced servants of the whole. They derive no real authority from their titles; they do not govern. Universal respect is the key to their usefulness.
- 10.No A.A. group or member should ever, in such a way as to implicate A.A., express any opinion on outside controversial issues-particularly those of politics, alcohol reform, or sectarian religion. The Alcoholics Anonymous groups oppose no one. Concerning such matters they can express no views whatever. 11. Our relations with the general public should be characterized by personal anonymity. We think A.A. ought to avoid sensational advertising. Our names and pictures as A.A. members ought not be broadcast, filmed, or publicly printed. Our public relations should be guided by the principle of attraction rather than promotion. There is never need to praise ourselves. We feel it better to let our friends recommend us. 12.And finally, we of Alcoholics Anonymous believe that the principle of anonymity has an immense spiritual significance. It reminds us that we are to place principles before personalities; that we are actually to practice a genuine humility. This to the end that our great blessings may never spoil us; that we shall forever live in thankful contemplation of Him who presides over us all.

from the spiritual. An A.A. group, as such, should never go into business. Secondary aids to A.A., such as clubs or hospitals which require much property or administration, ought to be incorporated and so set apart that, if necessary, they can be freely discarded by the groups. Hence such facilities ought not to use the A.A. name. Their management should be the sole responsibility of those people who financially support them. For clubs, A.A. managers are usually preferred. But hospitals, as well as other places of recuperation, ought to be well outside A.A.—and medically supervised. While an A.A. group may cooperate with anyone, such cooperation ought never go so far as affiliation or endorsement, actual or implied. An A.A. group can bind itself to no one.

7. The A.A. groups themselves ought to be fully supported by the voluntary contributions of their own members. We think that each group should soon achieve this ideal; that any public solicitation of funds using the name of Alcoholics Anonymous is highly dangerous, whether by groups, clubs, hospitals, or other outside agencies; that acceptance of large gifts from any source,
