Soon after a book followed, but it was a few years later when the Twelve Traditions were discussed and agreed on. Twelve Traditions that were "hammered out on the anvil of experience". Our past Delegates are a wealth of experience, an interactive living archive if you will. When you plan your next service workshop or need an outside voice to offer help, consider this resource available to you. Some of them even offer great company while fishing!

Please keep in your thoughts the friends and family of **Bill Perrizo**, Panel 46 Delegate, who recently passed away. Maybe take a moment to also remember those who are no longer with us, who have played a role in our own service experience.

delegate's enthusiasm, to groups and to intergroups/central offices. • If an area is too large for the delegate to cover in person, he or she will ask area officers and committee members to share the load.

- Be prepared to attend all area, state/provincial, and regional service meetings and assemblies. From these meetings, delegates come to
   better understand their own areas and can make suggestions for the Conference agenda. Here, too, they come in contact with A.A. members who might not be reached otherwise.
- Help area committees obtain financial support for the area and G.S.O.
- Provide leadership in solving local problems involving the A.A. Traditions.
- Work closely with committee members and officers, sharing experience throughout the year. After G.S.R.s and committee members have reported on the Conference, learn from these A.A.s how groups and members have reacted.
- Assume added responsibility if the area chair and alternate chair are unable to serve. Or, if an area committee is not functioning effectively, the delegate may take an active role in remedying the situation.
- Keep the alternate delegate fully informed and active, so that the alternate can replace the delegate in an emergency.
- Late in the second term, work with newly elected delegates to pass along a basic knowledge of Conference proceedings and problems.

#### **Delegate:**

#### Greeting Area 35,

I hope this finds you all well and are enjoying the summer months. I have been busy traveling around northern Minnesota doing my report back from this year's General Service Conference and have enjoyed my time with all you. I have been told by some that came before me that one of the best "highlights" you will experience being Delegate is visiting all the Districts after the conference. This has been proven to be very true. The business discussed on the Agenda Items, the amazing fellowship before and after (along with food and plenty of sweets) has been a wonderful experience for myself and hopefully those that attended.

We have had some great discussions on some of the issues we are facing today in Alcoholics Anonymous which has included our finances, one of the main topics I find many are concerned with. It is very troublesome when we see that the budget for 2016 is at a -\$23,000.00 deficit and that we have been at \$7,000,000 for the last two years on contributions but the expenses continue to go up. I really feel and have heard from others that this is a topic that as an Area we need to discuss in depth at our upcoming Fall Assembly. I will see that Jim, our Area Chair gets it on the Agenda for discussion. I encourage all of you to contact me with any comments/concerns you may have especially if they are directly related to the Feasibility Study that was recently completed at the conference that does include revenue. I have not heard anything further as of yet on this study and any plans they may have to move forward with the feedback they were given on the 4 topics. Please let me know if you have not received those results and I will gladly email them out to you.

I would like to extend a special thank you to all those Districts that I have visited so far and I look forward to the time with the rest of the Districts I am scheduled with in the upcoming months. I hope to see many of you at our upcoming Aitkin Committee meeting and as always thank you for the honor and privilege to serve Area 35 as your Delegate, Kelly D

#### Alt. Delegate:

I am looking forward to our 41 st Annual Area 35 Service Workshop. This workshop will take place in Bemidji on January 14 and 15. I have invited Howard L. who is a past Delegate and Southwest Regional Trustee of the General Service Board to be our guest speaker and work with us in the workshop. Howard has accepted our offer. The theme for our workshop will support the selected theme for the 2017 General Service Conference, which is: "Supporting our Future". Topical presentations at the GSC will examine three areas: growth, participation and contributions. I am thinking that our District presentations and guest (Howard L.) will also enlighten us in these three topical areas.

Each January about half of our districts have an opportunity to present at our Area 35 workshop. So, if your district did not have this opportunity in 2016 I will be in touch with your DCM soon. I would like to thank my officer cohorts for presenting in the first Area 35 Zonal Forum of this rotation. This forum was well attended and took place after Kelly D,'s Delegate report on Sunday June 12 in Erskine MN. A special thank you goes to Leslie H. DCM of District 1 and Myron H. DCM of District 2 for organizing this event and serving up some great treats and food. I very much appreciate the opportunity you have given me to continue serving Area 35 as we work together to carry our message. In service, Roger brisco, who is the service I am using to secure these facilities and who we have used before feels room rates for Spring Assemblies are going to be more in the \$120.00/night before taxes and in the Fall Assemblies \$135.00/night before taxes. With that being said, we are currently in negotiations with a resort that does look promising. I would give more details, but as soon as I do the deal could change and I would rather not give out information I would later have to retract. I would like to fellowship to be prepared as time goes on that we will be looking at higher rates for rooms, meals, conference rooms etc. I remember the first Fall Assembly I was at in Thief River Falls and if my memory serves me correctly, we paid \$500 for the weekend. The Grand Casino gave us a quote for \$3200 for a weekend for next year.

I received the budgets from Christine after she reviewed them and they do look reasonable. Thanks to everyone who submitted their budget and the effort taken to be vigilant when making them. The budget will be larger this year as we have a Regional Forum this year which happens every other year and the West Central Regional Service Conference is in Cheyenne, WY next year which will create some extra expense. The budgets will be coming out in the next issue of the Northern Light in conjunction with the expectations set forth in the Area Actions Booklet.

#### Area Chair:



What I have been finding is that our goal of getting rooms for \$109.00/night seems to be a dwindling opportunity. We have been turned down by several facilities because they just don't feel they can make enough money off of us. Based upon what I am getting from Helms-

For the month of June, we received \$2,315.77 in income and paid \$1,459.70 in expenses. Year-to-date, we have received \$18,106.91 in income and paid \$22,198.38 in expenses.

To condense, it was a series of people willing to shut up and get in the car. I have heard varying degrees of concern over our lack of growth in recent years and the possible impact this will have upon the fellowship. If we can keep the momentum that has been crucial since 1935 we won't have any problems. If we become complacent and allow our home groups and meetings to become overly integrated we will collapse as a fellowship. We can't be everything to everybody and it would be arrogant to think we could. The apparent solution is sponsorship, both on a recovery level and a service level. Every one of us needs to be committed to our home groups, our districts, our areas and Alcoholics anonymous as a whole. We need to choose the best possible people for our service commitments e.g. those that will fulfill all the aspects of the position. What service is a GSR rendering if they can't or won't make district meetings. What service is a DCM if they can't make committee meetings. 23 plus years of service experience has taught me that the most dangerous thing to AA unity is an uninformed group conscience. Your group is meeting tonight because 5, 10, 15 or 75 years ago someone shut up and got in a car to help a suffering alcoholic find the Road of Happy Destiny. Yours is service, Brad I. #### Northern Light:

Greetings All. I have been enjoying getting into the grove of collecting reports and assembling a paper, however am finding it frustrating to get more participation. Though, in fairness, more participation is a problem throughout service. I would like to offer commentary on why this is the case for all aspects of service in AA, though I will keep the scope to the job I'm charged with now. I believe most are intimidated about writing as much as most of us were and in many cases still are intimidated by speaking to large groups. There is no simple way to get over these fears, but by "jumping in" and abandoning yourself completely, (see page 57 of our Big Book) you have nothing to fear. My job isn't just to get the Northern Light out, it is to make it relevant to all serving AA in Area 35, and to all interested in what Area 35 is doing. This means I'm here to help you. I'm not an accomplished writer but two alcoholics working on something can do better than just one. There is a reason why all of your servants contact info is published at the beginning of this volume.

I've had a couple of request by members to change some things up in the layout so I will have tried some of those changes in this addition. This is YOUR publication; thus your input is very much appreciated. I don't think it is used nearly as much as it could be. Yours in Service, Jake C.







**Desirable qualifications:** Current or past working knowledge of the printing business. Knowledge of current computer printing programs. The person should also consider the time needed to complete the task required. The candidate should have a working knowledge of A.A. as a whole, i.e., prior experience in service work such as G.S.R., D.C.M., or related position.

**N.L. COMMITTEE** - The N.L. Committee consists of two D.C.M.s in Area 35. Currently, these have been picked randomly at the start of the new rotation. They also serve on a two-year rotation basis. They assist the editor in communications with other area newsletters, in recommendations on general improvements, and with general problems and implementations of new policies. They may also represent the editor at functions when the editor is unable to attend. Seek advice and help from former N.L. Committee members and editors.

#### **TWELVE CONCEPTS for WORLD SERVICE (Short Form)**

I. Final responsibility and ultimate authority for A.A. world services should always reside in the collective conscience of our whole Fellowship.

II. The General Service Conference of A.A. has become, for nearly every practical purpose, the active voice and the effective conscience of our whole Society in its world affairs.

III. To insure effective leadership, we should endow each element of A.A.—the Conference, the General Service Board and its service corporations, staffs, committees, and executives—with a traditional "Right of Decision."

IV. At all responsible levels, we ought to maintain a traditional "Right of Participation," allowing a voting representation in a reasonable proportion to the responsibility that each must discharge.

V. Throughout our structure, a traditional "Right of Appeal" ought to prevail, so that minority opinion will be heard and personal grievances receive careful consideration.

VI. The Conference recognizes that the chief initiative and active responsibility in most world service matters should be exercised by the trustee members of the Conference acting as the General Service Board.

VII. The Charter and Bylaws of the General Service Board are legal instruments, empowering the trustees to manage and conduct world service affairs. The Conference Charter is not a legal document; it relies upon traditional and the A.A. purse for final effectiveness. VIII. The trustees are the principal planners and administrators of overall policy and finance. They have custodial oversight of the separately incorporated and constantly active services, exercising this through their ability to elect all the directors of these entities.

IX. Good service leadership at all levels is indispensable for our future functioning and safety. Primary world service leadership, once exercised by the founders, must necessarily be assumed by the trustees.

X. Every service responsibility should be matched by an equal service authority, with the scope of such authority well defined.

XI. The trustees should always have the best possible committees, corporate service directors, executives, staffs, and consultants. Composition, qualifications, induction procedures, and rights and duties will always be matters of serious concern.

XII. The Conference shall observe the spirit of A.A. tradition, taking care that it never becomes the seat of perilous wealth or power; that sufficient operating funds and reserve be its prudent financial principle; that it place none of its members in a position of unqualified authority over others; that it reach all important decisions by discussion, vote, and, whenever possible, by substantial unanimity; that its actions never be personally punitive nor an incitement to public controversy; that it never perform acts of government, and that, like the Society it serves, it will always remain democratic in thought and action.

#### **TWELVE TRADITIONS OF ALCOHOLICS ANONYMOUS—LONG FORM**

#### Our A.A. experience has taught us that:

- 1. Each member of Alcoholics Anonymous is but a small part of a great whole. A.A. must continue to live or most of us will surely die. Hence our common welfare comes first. But individual welfare follows close afterward.
- 2. For our group purpose there is but one ultimate authority—a loving God as He may express Himself in our group conscience.
- 3. Our membership ought to include all who suffer from alcoholism. Hence we may refuse none who wish to recover. Nor ought A.A. membership ever depend upon money or conformity. Any two or three alcoholics gathered together for sobriety may call themselves an A.A. group, provided that, as a group, they have no other affiliation.
- 4. With respect to its own affairs, each A.A. group should be responsible to no other authority than its own conscience. But when its plans concern the welfare of neighboring groups also, those groups ought to be consulted. And no group, regional committee, or individual should ever take any action that might greatly affect A.A. as a whole without conferring with the trustees of the General Service Board. On such issues our common welfare is paramount.
- 5. Each Alcoholics Anonymous group ought to be a spiritual entity having but one primary purpose—that of carrying its message to the alcoholic who still suffers.
- 6. Problems of money, property, and authority may easily divert us from our primary spiritual aim. We think, therefore, that any considerable property of genuine use to A.A. should be separately incorporated and managed, thus dividing the material from the spiritual. or of contributions carrying any obligation whatever, is unwise. Then too, we view with much concern those A.A. treasuries which continue, beyond prudent reserves, to accumulate funds for no stated A.A. purpose. Experience has often warned us that nothing can so surely destroy our spiritual heritage as futile disputes over property, money, and authority.

- 8. Alcoholics Anonymous should remain forever non-professional. We define professionalism as the occupation of counseling alcoholics for fees or hire. But we may employ alcoholics where they are going to perform those services for which we may otherwise have to engage nonalcoholics. Such special services may be well recompensed. But our usual A.A. "12 Step" work is never to be paid for.
- 9. Each A.A. group needs the least possible organization. Rotating leadership is the best. The small group may elect its secretary, the large group its rotating committee, and the groups of a large metropolitan area their central or intergroup committee, which often employs a full-time secretary. The trustees of the General Service Board are, in effect, our A.A. General Service Committee. They are the custodians of our A.A. Tradition and the receivers of voluntary A.A. contributions by which we maintain our A.A. General Service Office at New York. They are authorized by the groups to handle our over-all public relations and they guarantee the integrity of our principal newspaper, the A.A. Grapevine. All such representatives are to be guided in the spirit of service, for true leaders in A.A. are but trusted and experienced servants of the whole. They derive no real authority from their titles; they do not govern. Universal respect is the key to their usefulness.
- 10. No A.A. group or member should ever, in such a way as to implicate A.A., express any opinion on outside controversial issues—particularly those of politics, alcohol reform, or sectarian religion. The Alcoholics Anonymous groups oppose no one. Concerning such matters they can express no views whatever.

ness. Secondary aids to A.A., such as clubs or hospitals which require much property or administration, ought to be incorporated and so set apart that, if necessary, they can be freely discarded by the groups. Hence such facilities ought not to use the A.A. name. Their management should be the sole responsibility of those people who financially support them. For clubs, A.A. managers are usually preferred. But hospitals, as well as other places of recuperation, ought to be well outside A.A.—and medically supervised. While an A.A. group may cooperate with anyone, such cooperation ought never go so far as affiliation or endorsement, actual or implied. An A.A. group can bind itself to no one.

- 7. The A.A. groups themselves ought to be fully supported by the voluntary contributions of their own members. We think that each group should soon achieve this ideal; that any public solicitation of funds using the name of Alcoholics Anonymous is highly dangerous, whether by groups, clubs, hospitals, or other outside agencies; that acceptance of large gifts from any source,
- 11. Our relations with the general public should be characterized by personal anonymity. We think A.A. ought to avoid sensational advertising. Our names and pictures as A.A. members ought not be broadcast, filmed, or publicly printed. Our public relations should be guided by the principle of attraction rather than promotion. There is never need to praise ourselves. We feel it better to let our friends recommend us.
- 12. And finally, we of Alcoholics Anonymous believe that the principle of anonymity has an immense spiritual significance. It reminds us that we are to place principles before personalities; that we are actually to practice a genuine humility. This to the end that our great blessings may never spoil us; that we shall forever live in thankful contemplation of Him who presides over us all.
