

AREA OFFICERS AND COMMITTEE CHAIR REPORTS

Delegate:

Greetings Area 35,

It has been a busy time of the year. I am still learning the ropes being your Delegate and a lot has been going on. I returned from the West Central Regional AA Service Conference and left for a vacation that was scheduled last summer. I would like to give a BIG THANK YOU to Kelly D. and Jim S. for all your help and support through this transition.

The Service Conference started on Thursday evening with a meeting held by our WCR Trustee, Tom A. He updated us on his service and what has happened at GSO over the past couple months. Tom reported that there are 71 translations of the Big Book. Tom stated it has been an amazing process to see translations come alive and how our contributions make this happen. This is a great example of carrying the message to the "still suffering."

GSO has 85 staff members that are doing a great job at answering 90 thousand letters. Corrections answers 6,500 letters per year. Archives 1,300 requests annually. AAWS ships out approximately eight million books, pamphlet and materials annually. 73,000 pieces of mail are processed in finance. AA.org has had about 12 million visits.

2017 contributions to GSO are up 6% and operating expense up 4% from 2016. The profits of \$1.6 million in 2017 were used to pay down the pension plan. \$1.5 million of expenses will be cutout once the plan is paid off. This could happen as soon as this year. Only 40% of the active AA groups are providing these contributions.

Online contributions continue to grow in amount and frequencies which cuts the costs of processing the contributions. Saves a fair amount of time and money.

Grapevine is the voices of AA. We need to support the GV just like we support our Area, District and GSO. Grapevine is really needing help through subscriptions. Please consider supporting the Grapevine with a personal subscription or even giving it as a gift to your sponcees. My homegroup supports the Grapevine by ordering a couple subscriptions and sharing them with the members in the group. There are many great uses for the Grapevine and we should all consider supporting it if we want the publication to continue.

Major points from the General Service Board:

- · Using Third Legacy procedure to nominate chairs
- New auditor was chosen through a RFP process. Selected an auditor that can bring forth new skills at a lower cost
- Pay down debt of the pension obligation
- Manuscript litigation was in NY city and the GSB was presented with a letter that they owned the manuscript. A temporary restraining order was placed on the manuscript and the person in possession did not take kindly to the request of returning it. The Board took a fiduciary responsibility to obtain the manuscript. As stated in Warranty 5, sometimes the best that we can do is mediate. Mediation would keep conversation private and not disclose information like litigation would make people's names public. The board decided it was time to put an end of this process and to pull out they had to settle and offered the person 135K to go towards attorney fees and gave up all rights to the manuscript.
- Technology Communication Services Analyzing website and it will be completely redone. Looking at providing a unified meeting locator so people can find meetings. The committee is looking into an App that we will be able to use that will not be giving up our integrity or Traditions to provide information for people who want it. We don't want to be pushing information on people.

During this meeting with all the Delegates in the region, we also discussed the WCR checkbook that gets passed on to the area that will be hosting the next service conference and there was discussion about the frustrations that are happening at the banks when trying to change signers. Area 35 will be hosting the next conference and I will be working on getting the checkbook transferred to our area. Some of the thoughts are that we could have the Area that is hosting the conference add another checking account to their bank for the conference but then the area would also have to assume the added income when they report the 990EZ and this may exceed the \$50k limit. Another option would be to file a 501(c3) or 501(c7) non-profit status. I will have more information on this for you to take back to your groups at the Spring Assembly.

Friday evening, we started the process of going through the conference material and had a sharing session. Saturday, we continued on with sharing sessions and conference material. I would like to thank everyone in Area 35 for the opportunity to attend this great conference. I would also like to thank Christine for asking me to accompany her to the delegate's meetings Thursday night and Friday. I had no idea how much work goes into putting this event on.

CONFERENCE NOTES:

FRIDAY NIGHT:

aa.org is getting a complete redo. \$8.4 million in 2017 in 7th Tradition contributions and literature sales was \$13,898,550, literature profits were \$9,361,614. AAWS paid down a significant portion of the pension plan with the profits. Budget for 2018 in literature sales is \$14,000,000 and literature profits to be \$9.2 million and 7th Tradition is \$8.2 million. 82% of operating expenses could be covered by 7th Tradition, bringing us closer and closer to fully self support. Potential profits for 2018 could be a half million. Just over 40% contributed to GSO. We always need to advocate that groups give whatever they can. Electronic contributions are much more profitable then mailed in contributions because someone doesn't have to open the letter, read the letter, match the group number or research if there isn't one etc. etc. Grapevine had a profit of \$126,000 for 2017. Subscriptions have been dropping over time, the board has worked hard to reorganize the office to eliminate as much waste as possible. There is a projected loss for 2018. In my opinion, the only opportunity for the Grapevine to be profitable at this point is increased subscriptions. What if we looked at the Grapevine becoming the voice of AA as a whole.

Friday 8pm General Session: Inclusion not Exclusion

Tradition 3 was read. AA has no membership rules, we do not want to build any walls that may exclude anyone who wants what AA has to offer. May God grant us a useful life and a long life. AA Big Book page 46 the realm of spirituality. Long form of Tradition 3: We may never refuse membership to anyone, any two people who meet may be an AA meeting assuming they have no affiliation with any other organization.

The speaker's opinion was that special interest groups exclude people although they make those in attendance more comfortable. However, this flies in the face of Tradition 3.

We are starting the planning process for a successful conference in 2019. Jim is chairing this event and we will be working on forming committees to help with all the activities that need to get done. If anyone is interested in helping out, please send Jim or myself an email. The 2019 WCRAASC will be held in Moorhead at the Courtyard Marriot on February 28^{th} – March 2^{nd} , 2019. Another guy, who I agree with, made the analogy of linked and affiliation saying we should look at the similarities versus the differences. One person mentioned this is a professional webpage and we have a Tradition mentioning we are not professionals AA gives us suggestions about social media but then make a motion that we use it because they found out a way that we could use it. This is hypocritical. Wouldn't a Linkedin page take away from the districts CPC committee activity?

General Session II: Participation in all of AA

These conferences are about reflection and intention. Is my triangle balanced? Recovery unity and service these three legs of AA. The first gives us the chance to recovery, the second is the need to stay together and the third tells us what we should do with what we have received.

Unity 12 Traditions. Suggests we join a home group and make sure the doors are open for the new comers. Do I have a group that I am involved with and participate in. Service in AA is based upon the 12 Concepts, 12th Step, am I taking others through the 12 Steps, when we go to meetings are we being of service. Making coffee, shaking hands, taking out garbage. What did your sponsor do to get your involved? What are you doing to get others involved?

Why do you think service is important? What are you doing to keep your triangle balanced? Service gives us the chance for the old timers to pass on their knowledge to the new comers as old timers don't stick around forever. The Four Absolutes: unselfishness, purity, honesty: total absence of any intent to deceive, love:

CPC continued:

- A: Just more discussion on pros and cons.
- B: No comments
- C: No comments
- D: Thoughts were that the changes seemed to be in line with the AA message.
- E: Couple questions regarding the pamphlets in the workbook

Corrections:

A: Lets not make another pamphlet but replace <u>Sure Beats Sitting in a</u> <u>Cell</u>, one person thought this was demeaning. Let's use what we have, AA in the prison, inmate to inmate.

Breakout Session: Concept 3 - Make up your own mind

Last nights talk on inclusion vs exclusion this person had a shopaholic come to their meeting and would not identify as an alcoholic. She got backlash from some people for suggesting she go to a meeting for her problem. Some were supportive.

A: Open meetings are for AA members only, but open meetings are open to anyone looking for info on AA. How does this person's attendance affect AA as a whole? If I have a problem with something that is going on in a meeting I need to bring it up at the steering committee instead of just handling it myself, so I am certain I have a good perspective on the matter and get a groups conscience. There is no Tradition that states we must identify ourselves as an alcoholic. When we do approach someone about a Tradition break we should approach them with the idea of helpfulness.

How do the people going to GSC when the Area wants a different vote then

they do now. There were problems when the board started to include staff members.

You can do three things with right of decision:

- 1. You must stay within the scope of your position.
- 2. You can't use it as an excuse to not consult your group.
- 3. I need to report what I did. These were very good points.

How do we reconcile the difference between the Trustees Committee picking agenda items versus what past Delegates and other members of the conference think should be on the agenda?

The conference does have the right to reorganize the boards, meaning kick them out and get new members in as board members. What is motivating me to take this action? The intent of being a Trusted Servant was to be humble and obedient. We should always use the principles of AA to make our decisions. Anything within these boundaries are useful to our purpose. If I make decision outside there parameters that creates the opportunity to bring something outside of AA into AA. If we look at what we think about a topic, we don't give ourselves the chance to learn about the topic.

Breakout Session: Concept 4 - Hey I have a Voice 2 pm

Does the Tradition of only having two Trustees on AAWS continue or has it changed? Short answer is yes, when it was seven directors two were Trustees and now that the AAWS board has nine Directors four are Trustees. QUES-TION TO ASK TOM A. HOW MANY DIRECTORS ARE ON THE BOARD, HOW MANY ARE CLASS A?

What does the right of participation everyone can bring something to the table for the informed group decision. One person brought up the idea that right of participation meant voting members, this is not the case as in the example in the staff members of the GSO are invited to the conference to bring their perspectives to the conference although they do not get the right to vote. We have a right and a responsibility to participate in AA.

How does our spiritual condition apply to the concepts?

Page 19 of service manual there is another good reason to participate we all have the need to belong and it is a shingling ideal that everyone is equal and that there are no people who are then the other's participating in AA. It shouldn't matter whether you have two days or twenty years each of us should have an opinion that should be listened to.

What does "in reasonable proportion" mean as it pertains to the scope of their responsibility? Who determines what reasonable proportion is? One person one vote.

Corrections continued:

- A: Will this pamphlet give them the information they need to start a life on the outside? The need for another pamphlet suggest we aren't doing our job in going out and finding the new comer regardless of where they are at, in their case the jails and prisons. One person's experience who was in jail had a hard-enough time getting a Big Book let alone a pamphlet. He didn't think an inmate would have much of a chance to even get a pamphlet cuz the inmates can't receive anything that doesn't come straight from the publishers.
- B: Review content of kit and workbook: couple items that are directed to people who are carrying the message to the individual he wants more pamphlets in the workbook. The videos in the workbook are outdated, should be updated.

Finance:

A: There wasn't much discussion except some people didn't think it needed to be raised, others thought it should be reviewed every four years.

Grapevine:

A: No info providing security issues and how they would be handled. Doesn't tell us how these forms would be used or who would be responsible for using it, this person does IT security for a living and bringing all the potential problems and the conference isn't addressing these items, just how to make a Facebook post, make a tweet etc. etc. things most people already know. Google for nonprofits is still trying to make a buck, so we would always be hit with advertising.

the Delegate wants? How do you determine when to engage right of decision?

Christine mentioned that what she heard was that my opinion and she is not there to represent her opinion but the opinion of the Area. Unless something is brought up that significantly changes the meaning of the item. It's important when talking to the groups about representativeness groups etc. etc. that it's important to hear people out and listen to the entire discussion. If we practice this principle when talking with our group when we go to these voting events if something does change they would have a good idea of what the group thinks they could make an informed decision if they think their vote should be changed. At what point does trust come into play. If we can't trust our elected servants should we really be concerned if they change their vote after new info has been introduced.

Is the pursuit of the manuscript an example of Concept 3?

The Warranties don't say that to one person. Warranty 5 says AA may come under sharp public attack. WE should maintain complete silence. His thought is that we are to protect AA not put it in the public eye. Curt: there is no one Concept or Tradition that applies to this. This could be looked at with multiple Concepts, Warranties or Traditions. In Concept 5, the part about participation, the board didn't always include the staff members as

<u>Treasurer:</u>

This is my second report as your Area Treasurer. It is a privilege to serve Alcoholics Anonymous.

I attended my first West Central Region AA Service Conference in Des Moines the first weekend in March. More than 400 members were in attendance. Four presentations and eight breakout sessions were held on various topics having to do with how to carry the A.A. message to the alcoholic.

During the rest of the conference, we discussed the agenda items for the General Service Conference. We were able to complete list of 78 items by 11pm Saturday evening. It was a long day, but everyone in A.A. has a voice and those voices were heard.

The Income and Expense Trend below charts show income compared to expenses for each month in 2017 and 2018:



Our officers met for breakfast with the officers from Area 36. We set a tentative date of Saturday, November 17, 2018 for our next Area 35/36 Joint Workshop, to be held in St. Cloud. We also discussed the content and purpose of the workshop, AA Meeting Locator, and the State Fair booth. Since my last report, I have:

- Filed the Area's annual IRS form 990-N for tax year 2017
- Reconciled 2 months bank statements
- Made deposits of all contributions received as of March 9th
- Completed financial reports and bank reconciliation statements for review by the Financial Oversight Committee
- Completed balance sheets and income/expense/contribution statements for Period 7 of 2017, Period 1 of 2018, and to-date Period 2 of 2018

I have deposited all contributions and paid all expenses received as of March 9th. Our Area checking and savings accounts have a balance total of \$22,708.24. Group contributions year-to-date are \$7,300. For all of 2017, group contributions totaled \$24,961. If we continue at our current pace, our contributions for 2018 will exceed \$35,000. That would be an outstanding level of self-support!

Our year-to-date expenses include a \$1,000 deposit for the venue for the Fall Assembly, and an \$1,800 contribution to the General Service Board for the GSO Conference. Minus these future event outlays, we have net income yearto-date of \$517.

Written acknowledgment letters to the groups for contributions are still forthcoming. I apologize for the delay. You will receive them prior to the Area Assembly. Your group's total contribution for 2017 will be included in the letter, and if you note any discrepancies, please bring them to my attention.

Treatment:

I had the good fortune to attend the West Central Regional AA Conference in Des Moines Iowa on March 2 - 4, 2018.

What a wonderful experience this was. Not only did we discuss the Agenda items, on Saturday until 11:00pm, but there were some interesting presentations.

Some of the subjects covered were:

- Concepts
- What do past delegates do
- The Grapevine
- The Webmaster
- Technology and the AA Traditions

One of the areas that struck me, in particular, was the discussion about anonymity and technologies, like Google, Facebook and YouTube. My personal opinion is that I never discuss my AA relationship on line. It was suggested to the delegates both current and past, as well as the trustee that the end results (loss of anonymity) need to be more thoroughly investigated before implementation.

Additionally, there seemed to be an over-abundance of pamphlets proposed. Some of the thoughts covered the loss of identity (we are alcoholics first), confusion to the newcomer and insults to the particular group. For instance, there was a request for a brochure for the Spanish-speaking woman. The AA for the Woman is translated into Spanish already.

My personal opinion is that perhaps in our zeal to include everyone e.g. internet users, women, lgbt+, etc. we may be pushing everyone back into their "terminal uniqueness."

On March 11, 2018, area 35 will hold its first area meeting. I am looking forward to meeting the district treatment chairs within our area. It is my hope that we will hear from each district about their various approaches to treatment centers. Hopefully we will have times to set area goals.

Webmaster:

I attended the West Central Regional AA Service Conference in Des Moines, Iowa. I am available to assist any district with reviewing the agenda items. I chaired the Webmaster Break Out session at the WCRAASC and am grateful to have had that experience. Melissa A. was our secretary. The topic was Webmaster: Geek Squad or Carrying the Message. The four questions or topics we came up with and a summary of the discussion follow: depends on the flyer, some areas don't post picnics or golf tournaments. One area's guideline is to ask if GSO would put it on the web; if the answer is no then they don't either. Another area only posts events within their area. Discussion about whether or not district minutes should be posted on an Intergroup website took place. Anonymity in print was discussed. We also discussed what areas are doing to provide information to people asking questions through their district or area website. AAMeetingLocator was brought up as a way questions get sent to both area 35 and 36. One Webmaster provides analytics regarding the number of visits and how many were new or returning users. Another area has a contact us page on their website where the incoming emails are forwarded to the appropriate person depending on the nature of the question and where they are located in the area. Another area is finding most of their question are related to group records.

- 2: What are the procedures for posting AA approved literature as far as what can be posted and what is considered copy write materials? One member stated that AA is pretty liberal as long as we give them credit for what they own. This member doesn't put anything on the area website that belongs on another website and will provide a link to the appropriate website. Another member talked about the fact that we can download a pamphlet from GSO for our own personal use. A PI chair stated webmaster is part of his job description. He state they have several AA pamphlets and videos on their site; no one from New York has contacted them requesting they take anything down. Someone suggested searching for guidelines as there is a specific content use policy which is found on AA.org-SMF29.
- 3: What can be done to prevent contact names from being public but still be able to be available for people to contact us? One district has its own website and uses generic email address which are connected to personal email addresses. District minutes are removed of personal information before they are posted on the website. Another person has a Google phone number on the area website. Several Areas/ Districts have AA phone hotline. A person expressed concern that with technology we might lose face to face contact and we need to also communicate by paper for those who are not technology savvy.
- 4: How can AA protect its reputation on line? When searching AA on line several sites come up that are not necessarily official AA sites. The only official site we have is AA.org. One person stated that if we associate our district or area website with AA and fail to follow AA principles we hurt AA as a whole. Someone brought up the issue that Webmaster is a subcommittee of Public Information and perhaps it should be a standing committee in our service structure. The Communications Services Coordinator at GSO informed us a new website will kick off on March 12th.

CIRCLE OF CHAIRS

Recently I overheard a comment about the Area just changing people in positions, this got me thinking. Why do we accept several positions in service before stepping aside? Even within our group we take several positions, sometime the same position more than once, or even for multiple years. Why do we do this? Why don't we just sit back on the bench and let others do the work that needs to be done.

It is my belief we learn every job we do, not because we are well trained but because we are growing in our own sobriety. I have not ever seen anyone go from Greeter or Coffee Maker to Area Delegate, even in service it's like the steps. Greeter or coffee maker to group chair, perhaps sponsorship chair to GSR-A, to GSR or group Treasurer.

Each position we grow, we make a step. From our group level some of us go to the district, usually we are introduced when we become our groups GSR, sometimes our sponsors take us along on a district committee. Sometimes we will be a committee chair one rotation than a district secretary or treasurer the next rotation an Alt DCM or no ALT about that the next rotation. Then stepping down to the Area level of service doing multiple chairs to better understand being the Area Chair or Delegate.

1: Sharing experience on what others have done to effectively get appropriate things on the website. One person stated they only post meetings that are registered with GSO. Area 35 talked about how we rotate the Webmaster position every two years and use WordPress which helps to post things on the website faster and makes for a smoother transition between Webmasters. Area 35 also talked about cancelling an ACM for the first time in 20 years and how the Area Chair and Webmaster worked (with help from Bob B.) to put a notice on the website regarding the cancelation. Another issue brought up by Area 35 involved a new AA member wanting to have a flyer for an AA golf league placed on the area website. It was decided it was an advertisement and not appropriate for the website. The member was contacted and the AA golf league name was changed to Friends of Bill W. Golf League. How to determine which flyers are appropriate for a website were discussed: areas stated it

I have heard throughout my sobriety that I have a greater chance of staying sober if I am in the middle of AA and being of maximum service. I have seen within my homegroup those with 30 plus years of sobriety taking a group service position with several years between positions. When I was DCM I had a guy with 25 years sober as a GSR and a guy with 30 years sober as CPC Chair, 8 years later that GSR is currently the groups treasurer and that CPC person just finished a rotation as the District PI Chair. Do we have term limits in AA? Do we need them?

BLAST FROM the PAST

In this edition from Blast From the Past is an article from the fourth issue of the Northern Light printed April of 1983. Called

REALITY: A SHOVEL OR HAMMER

When I became old enough to realize just what people meant by a person having responsibility in life, I was already to a point where I really did not care. To me reality was a thing I avoided from the start. I hid from it in my own world and in my books. In discovering alcohol at a very young age, reality became a shovel of fear. Fear ruled my life. Fear of being "different" from my friends, fear of failing or succeeding, fear of God's wrath. I had a great fear of people and of being "crazy."

Slowly, with my shovel of fear, I began to dig a hole. As I became older, and my mind more soaked with alcohol, reality demanded more of me. I felt as if the people around me, my family especially, wanted more than I could give. Not trying anything became a way out of my reality. Drinking and digging, digging deeper and deeper into my own world. I'd tell myself, "everything is all right. You'll grow out of this stage, sooner or later". I did. Everything got worse. Friends disappeared and problems came.

People tried to help me. My parents found me a psychologist. My school counselors found me drug and alcohol counselors, and the drug counselors got me to treatment. Finally, a break in my digging. I put down my shovel and tried to climb out of the hole I had dug. Again, people tried to help, but I wanted to do it alone. I didn't need anyone!

As you may have guessed, fear struck again and I picked up my shovel. I started to dig again, this time faster and faster. The break I had taken only made me want to catch up for lost time. There was a difference now, though, I knew where I would end up at. The people in Alcoholics Anonymous had told me. The thought that in some way I would be the exception, that things would turn out different than A.A. predicted, kept me going double-time.

Suddenly it happened; rock bottom. I had reached the end, just as A.A. had said I would. I couldn't dig anymore. At the very bottom of the hole I had dug myself into, I sat in utter despair. As the walls started to crumble, I gave up all hope. I wanted to be buried in my self-dug grave. I had nothing left.

Then came the light, and the hand of A.A. I grasped it with both hands and held on. It led me to a staircase of 12 steps. Steps that would lead me into a new Reality; one of hope, not of despair, one of self-respect, not self-condemnation.

In working the 12 steps of Alcoholics Anonymous, each day, to the best of my ability, and practicing the principles of A.A. in all my affairs, I now have a reality that is hope; a hammer. Now I can build a new life for myself with my Architect, my Higher Power, and with my assistants, the A.A. fellowship, to help me. I can build this new, wonderful, sober, real life.

I have heard that 10 percent of all AA members do 90 percent of all the service work. How can we get the other 90 percent of the members to become active in service work? Such as become a GSR-A, when your group does not have a GSR, that way your group is still informed but the GSR position is still open for someone to step up. A few years back I started a new job that prevented me from committing to a service position, I hated those three years. I was irritable, discontent and literally miserable. Is rotation preventing me from serving as DCM. The answer is I need to continue to serve to grow spiritually.



As the result of the agreement, A.A.W.S. waives any claims to ownership of the Manuscript and will pay \$135,000 to reimburse a portion of the holder's out-of-pocket costs, expenses and legal fees associated with the action. I am anticipating some more discussion about this at the WCRAASC as there is an agenda Item under Trustee Item F – Review proposal to reorganize the General Service Board.

AAWS did end up with a copy of the manuscript but not the original manuscript. There is an agreement of confidentiality between the parties that no public statement will be made but AAWS does have the ability to discuss the matter with the fellowship. Communications from AAWS will be coming out but I do not know when or what the contents will be. For more complete information you can ask Tom A to expand on this. You can simply ask Roger our Chair to add this in during new business.

According to Rick Delegate for Iowa, the Service conference looks to be well attended. This year's chairperson is going to meet with Christine, myself and the Delegate and likely Alt Delegate from the Area where the 2020 Service Conference is going to happen. We discussed the idea of delegates being more involved in the selection process of agenda items coming from a motion made last year to include delegates in the process. There will be more information coming out and I'm sure that Christine will get that out to us as soon as she gets it.

I have contacted the Holiday Inn in Detroit Lakes about holding the Annual Workshop there next Jan 11th and 12th as they are not available the following weekend which is the one I wanted. The prices are fantastic, the hold up I have and would like committee input on is that they will not book a block of rooms off for us more then ten at a time. Meaning, we would get ten rooms blocked off; once those are taken another ten would be blocked off. My concern is that if this weekend turns out to be a hockey tournament weekend and the fellowship doesn't book rooms far enough in advance we may run out of rooms and people would have to find different hotels. This isn't the end of the world, but pretty close to it. My other choices are the Holiday Inn in Alex, which we are going there in April for the Spring Assembly, the Big Woods Convention Center in Fergus Falls and the Marriot in Moorhead. I have not gotten proposals from those three yet. I will bring that information to the Spring Assembly in April.

We received our Area annual contribution report from GSO and all DCMs should have received their letter along with the breakdown of your groups contributing. In 2016 45.58% of the active groups contributed to GSO versus 45.06% in 2017. We did have decline in contributions this last year and it could be because there are less groups that are active in our area versus what is registered. It is important that the DCMs make sure that all the groups listed in your district are active and communicate any non-existing groups to our Group Records or directly to GSO. Feel free to email me if you have any questions or concerns. Preliminary reports regarding 2017 finances with GSO are looking very promising and we are excited to see what the final report looks like.

There is an opening for non-Trustee Appointed Committee Member (A.C.M.). GSO is requesting resumes for Trustees' Committee on Coopera-

Lastly, I will be in attendance at the Service Conference this coming weekend. I will do my best to gather as much information as possible to bring to the Spring Assembly. If a district would like me to attend to provide any help in going through the agenda items please feel free to contact me and I will make every effort to accommodate you.

This year has started off as a busy one, trying to learn all of my roles and responsibilities as your incoming secretary. I have a pretty detailed report that will be in the Northern Light discussing what information I have gathered from the West Central Region Alcoholics Anonymous Service Conference. If anyone is interested in receiving my minutes/notes from the conference please get in touch with me via email or today and I will get that information to you. If you are in need of someone to help your district go over the agenda items please let me know and I will do my best to be available. I look forward to the Spring Assembly. There are still some flyers left over that are on placed on the back table if you are in need of more. Reports will be due Monday by 5pm in order for me to get the reports done and sent to Steve for the Northern Light by Tuesday.

Saturday evening. It was a long day, but everyone in A.A. has a voice and those voices were heard.

Our officers met for breakfast with the officers from Area 36. We set a tentative date of Saturday, November 17, 2018 for our next Area 35/36 Joint Workshop, to be held in St. Cloud. We also discussed the content and purpose of the workshop, AA Meeting Locator, and the State Fair booth.

Since I began this rotation, I have managed to accomplish the following tasks:

- Filed the Area's annual IRS form 990-N for tax year 2017
- Successfully reconciled 3 months bank statements
- Made deposits of all contributions received as of March 9th
- Completed financial reports and bank reconciliation statements for review by the Financial Oversight Committee
- Completed balance sheets and income/expense/contribution statements for Period 7 of 2017, Period 1 of 2018, and to-date Period 2 of 2018
- Compiled preliminary budgets for calendar year 2018

On the back table you will find copies for you of 1) the balance sheets and income/expense/contribution statements for Period 7, which contain 2017 year-end totals, and 2) the same statements for Period 1 (January 1st through February 15th) of the current year. I encourage you to look through the contribution section, find your group's contribution line, and let me know if you have any concerns about the amounts listed.

To summarize last year, we ended with a cash balance (savings and checking accounts) of \$24,991 and a net loss of \$4,413. So far this year (as of March 9th) we have a cash balance of \$22,708 and a net loss of \$2,283. I'd like to point out that our year-to-date expenses include a \$1,000 deposit for the venue for the Fall Assembly, and an \$1,800 contribution to the General Service Board for the GSO Conference. Not including these future event outlays, we would have a year-to-date net income of \$517.

We are solvent and are maintaining a prudent reserve. As always, we need to be self-supporting and not rest on our laurels. It is truly amazing to go to the post office box and collect so many contribution checks. Keep up the good work.

I have deposited all contributions and paid all expenses received as of March 9th. Group contributions year-to-date are \$7,300. For all of 2017, group contributions totaled \$24,961. If we continue at our current pace, our contributions for 2018 will exceed \$35,000. That would be an outstanding level of self -support!

This past week I was made aware that our QuickBooks 2015 software version will no longer be supported by the developer, Intuit, as of May 31st, 2018. We will need to address this issue by either purchasing a new desktop version or by moving to their online version. I will conduct some research and come up with a recommendation in time for the Spring Assembly.

Written acknowledgment letters to the groups for contributions are still forthcoming. I apologize for the delay. You will receive them prior to the Area Assembly. Your group's total contribution for 2017 will be included in the letter, and if you note any discrepancies, please bring them to my attention. WCRAASC Breakout Session 2 Concept 5

Minorities are not encouraged; we throw apples and veggies at them to get them off the stage.

In what ways are minority opinions are encouraged? Has anyone put this concept in action?

- One of the things that I have found in my home group that helps encourage minority opinions in my group conscious meetings, is that we have a script that whoever is chairing that business meeting goes off of, when we have a motion we get a second, then we ask if there is a minority opinion, then we listen and we talk about it and see if someone wants to change their vote. Voice your opinion in the discussion earlier.
- My group recently had a situation come up that the district made a decision that my group did not agree with, we drafted a minority opinion and brought it fourth to the district meeting, we had a great discussion, and we were encouraged by feeling welcomed and it was taken very seriously, we don't know where that is going to go.
- In Area 40, its not that we actively encourage, when you are area chair and you are chairing an assembly and you forget to ask minority opinion you will be reminded that it has to be heard, it is a good reminder especially to the new people that it is part of the process here. It is a unique part of the process, I had some conversations with the communication chair of trustees, and he shared with me on nearly every phone call, just how the impression of AA had on him, about the importance of the minority opinion, he said you don't see this our there in the corporate world.
- I rotated out from DCM last year, we had a situation that we voted on, there was a group that disagreed with our decision in the process that we made, they said so to myself and to the chair of our area at the time, Alternate DCM and I went out to dinner with these folks, and we listened to there concerns, was not done at a formal district meeting, listened to them and took it back to the district, nothing changed as a result of it but it was expressed.
- Home group, through Box 459, we heard from our GSO that a decision was made to do away with printing the directories, home group disagreed with that action, our minority opinion was hey this is what you say you do for us, we withheld contributions for a while, we verbally wrote something and the power of the purse, conversations were had.
- Whenever there is a vote and the goal is 2/3rds there is always that pause for minority opinion.
- Hearing some of the discussion, I'm thinking about the difference between encouraged and allowed. The things that I have seen, the minority speaks but the horse is already dead, I'm just wondering how am I acting when I'm in the majority, am I still open minded enough to encourage them their points of view, actually listening and giving that minority opinion merit rather then oh here we go again.
- We need to make sure that we are taking this home to our groups because the next group of service is coming out of that group of people. I was trained up. We have to make sure that the concepts are being followed.
- I had an experience at one of my first district meeting, there was motion made that there was an idea we read a Concept, there was motion made instead of doing the concept to read a Tradition instead and to read that every month, everyone thought it was a good idea, and then the minority came up and said "in my home group that I go to we discuss the Traditions but we never hear the Concepts" and you can see the light bulbs going on, the person who actually made the motion withdrew it, maybe what we are doing is the right thing to do.
- This involves a lot of opportunity for spiritual growth, I'm often in the minority, in our district and even in our area and even here I am, the question how can we encourage that minority opinion? What I need to do for myself because I will get really closed minded when I get around the majority, I have to get right sized and really ask my higher power to open my mind. For me I have to do that and lead by example, thank goodness we have groups that we can come to and talk about.
 When people really listen and hear more information they change their vote, living within AA and the service structure and letting go of myself, that vote is not about me, I don't need to get my way, a lot of it is just letting go of the ego, watching the process of AA in action, service in action to see how things happen, I don't know what's best for me, and I'm also going to trust God in the process no matter what the decision is that is the group conscious.

- Minority opinion that sometimes does and does not get expressed as the item is being discussed, a lot of the reason why its not discussed, there is a lot of fear, they will hear the majority going in one direction that lays out reasons that are complete opposite of how they see things, the importance of that person stepping forward, past delegate "any given item, we can have someone who approaches it from way over it on this side, way over on this side, we desperately need both, it shows us the range of solutions that we need to hear, and we are able to find the middle, workable solution." Concept 3- we need to get all the information available to us, it comes from every perspective and that helps us to find our solution.
- Its really God inspiring to see one minority opinion change things.
- We had money that we had given and we wanted to disperse it, minority opinion came, we actually rescinded that vote and made the GSR's to bring it back to their groups, these votes not have to happen over night. We need to make the correct decision.

When Did We Become the Program of No?

When I came into the program of A.A. almost forty years ago I was taught it was a program of "yes". We said "yes" to surrendering and admitting we had a problem. We said "yes" to the concept of God. We said "yes" to turning our will and lives over to the care of God and so on...

Furthermore, I was taught that when the program of A.A. asks we don't have the luxury of saying "no". When A.A. asks for volunteers - we say, "yes". When we are asked to go on a 12th Step call - we say, "yes". When we are asked to do service work - we say, "yes"!

Sadly, that spirt of "yes" seems to have been replaced with the spirit of "no". Or even worse, "no, I won't and you shouldn't either".

Recently I have heard around the tables:

"You can't share A.A. information with professionals – that would be affiliation."

"You can't put on an A.A. function at a treatment center – that would be affiliation."

"We are going to take the summer off from bringing meetings into a sober house."

"Those people in the sober house just need to go to meetings on the outside – they don't need meetings brought into them."

And perhaps most disheartening... One night while cleaning up after a meeting I found a letter. I saw that the postmark on the letter was from 2015, but the letter hadn't been opened. Upon reading the letter I discovered it was from an inmate who was requesting help from A.A. upon his release from prison. He had asked for help over two years ago and his request had gone unanswered!?

I have found it important to remember that service work is not a burden, but rather an opportunity to grow. When professionals in my community want information on A.A., this gives me an opportunity to "carry the message". When the staff of a sober house requests an A.A. meeting be brought to their facility, this gives me an opportunity to "carry the message". When an inmate writes for information on A.A. in my local area, this gives me an opportunity to "carry the message".

- If we are not listening to the minority then we are not listening to the voice of God. Why am I here? Its not for me, its not for me to get my voice heard its for me to be a part of this collective consciousness of God through everyone in this room and if I'm listening to the minority opinion then there is something wrong with me at that point in time.
- If you are in service long enough you have been involved where a minority opinion has been expressed and it changed that vote, if you talk about it and let people know that story, and it is valid and pass that message on to other people, that can take away some of the edge and fear from them wanting to express that minority opinion at that point in time.

So why all this insistence on "carrying the message"? Why is that so important?

Perhaps co-founder of A.A., Dr. Bob, said it best in his story <u>Dr. Bob's</u> <u>Nightmare</u> on page 181 of the book <u>Alcoholics Anonymous</u>.

"I spend a great deal of time passing on what I learned to others who want and need it badly. I do it for four reasons.

- 1. Sense of duty.
- 2. It is a pleasure.
- 3. Because in so doing I am paying my debt to the man who took time to pass it on to me.
- 4. Because every time I do it I take out a little more insurance for myself against a possible slip."

- N.L. COMMITTEE The N.L. Committee consists of two D.C.M.s in Area 35. Currently, these have been picked randomly at the start of the new rotation. They also serve on a two-year rotation basis. They assist the editor in communications with other area newsletters, in recommendations on general improvements, and with general problems and implementations of new policies. They may also represent the editor at functions when the editor is unable to attend. Seek advice and help from former N.L. Committee members and editors.

N.L. COMMITTEE MEETINGS:

The Committee meets every other month, before the start of the Area Workshop and at Spring and Fall Assemblies. Additional meetings may be called for if needed between these times.

- Provide encouragement for writing articles, particularly to D.C.M.s and Area Action Committee Chairs. This should include the strong encouragement to submit their reports for each issue, if no report is submitted it will be stated, example "Northern Light Report - NOT GIVEN" this is currently being done in the Southern Minnesota Area newsletter.
- Keep informed of activities and issues going on within Alcoholics Anonymous as a whole. The N.L. Committee could subscribe the Grapevine or other pertinent A.A. news sources.
- Gather useful service information to publish from sources within ٠ the Area, Region and A.A. as a whole. Obtain, read and use other Area newsletters.
 - Listen to comments from the Area on the content of the N.L.



Q: Why list our past Delegates?

A: They are a resource to you!

In Alcoholics Anonymous we value experience. Our Twelve Steps did not exist when Bill stepped into the lobby of a hotel in Akron, Ohio. Even after meeting with Dr. Bob and soon founding our program, there were only six steps until the experiences of 100 Alcoholics were summed up. Soon after a book followed, but it was a few years later when the Twelve Traditions were discussed and agreed on. Twelve Traditions that were "hammered out on the anvil of experience". Our past Delegates are a wealth of experience, an interactive living archive if you will. When you plan your next service workshop or need an outside voice to offer help, consider this resource available to you. Some of them even offer great company while fishing!

The Delegate's Duties

Though the high point is the Conference meeting, the delegate's job goes on year-round and involves all aspects of the Conference structure. The delegate should:

- Remind G.S.R.s to inform groups and individuals about the A.A. Grapevine and Conference-approved literature.
- Attend the Conference meeting in April, fully prepared. Immediately upon election, every delegate is put on the G.S.O. mailing list to receive Conference materials.
- Communicate the actions of the Conference to area committee members and encourage them to pass on this information, and the delegate's enthusiasm, to groups and to intergroups/central offices. If an area is too large for the delegate to cover in person, he or she will ask area officers and committee members to share the load.
- Be prepared to attend all area, state/provincial, and regional service meetings and assemblies. From these meetings, delegates come to better understand their own areas and can make suggestions for the Conference agenda. Here, too, they come in contact with A.A. members who might not be reached otherwise.
- Help area committees obtain financial support for the area and G.S.O.
- Provide leadership in solving local problems involving the A.A. Traditions.

- Cooperate with G.S.O. in obtaining information—for example, making sure that up-to-date information reaches G.S.O. in time to meet the deadline for each Issue of the A.A. directory and helping carry out the triennial membership surveys.
- Visit groups and districts in the area whenever possible.
- Work closely with committee members and officers, sharing experience throughout the year. After G.S.R.s and committee members have reported on the Conference, learn from these A.A.s how groups and members have reacted.
- Assume added responsibility if the area chair and alternate chair are unable to serve. Or, if an area committee is not functioning effectively, the delegate may take an active role in remedying the situation.
- Keep the alternate delegate fully informed and active, so that the alternate can replace the delegate in an emergency.
- Late in the second term, work with newly elected delegates to pass along a basic knowledge of Conference proceedings and problems.

It reminds us that we are to place principles before personalities; that we are actually to practice a genuine humility.
