

Greetings from your Area Treasurer. It is an honor and a privilege to serve you.

Since my last report, I have:

- Reconciled 3 monthly bank statements and created reports for review by the Financial Oversight Committee
- Deposited all contributions received as of October 23<sup>rd</sup> (I've been on vacation for 2 weeks)
- Paid all bills and expenses received as of November 2<sup>nd</sup> (I paid them the day I returned)
- Completed a balance sheet and an income/expense/contribution statement for Period 5 (August/September)

As of November 2<sup>nd</sup>, our checking and savings accounts have a combined total balance of \$22,185. Year-to-date total income and expenses are \$31,216 and \$34,022, respectively.

Year-to-date Group contributions for 2018 and 2017 are \$25,823 and

\$20,972, respectively, a 23% increase over last year. Based on the contributions received thus far, we could end the year with contributions exceeding \$31,000. That amount would outpace the \$24,961 we received in 2017, and the \$29,862 we received in 2016. Note that I am talking about Group contributions only, as we also receive additional income from Area events, Roundups, Northern Light flyers, and Grapevine sales. Our Groups and their members continue to do an outstanding job of supporting Area 35!

All Officers and Committee Chairs are operating below their respective budgets for the year. Our total year-to-date expenses are \$11,757 below budget.

At the Fall Assembly the members approved a 2019 budget totaling \$46,942, or about \$844 less than our 2018 budget of \$47,786. However, actual expenses for 2018 should end up being approximately \$35,000.

I have completed the mailing of contribution acknowledgments received through the end of August. I am once again behind on this task! If you have questions or concerns about any of your group contributions, please email me at treasurer@area35.org.

All of the above has required me to order additional "Bridging the Gap" brochures – what a wonderfully happy problem.



### GSO Announcement OnLine Meeting Guide

November 2, 2018 Dear trusted servant,

We are pleased to announce that Alcoholics Anonymous World Services, Inc., has licensed the Meeting Guide technology. Meeting Guide was launched in November 2015 and provides a platform for local A.A. entities (Areas, Intergroup/Central Offices, Districts, etc.) to post their local A.A. meetings and currently provides information to more than 100,000 users, reflecting some 86,000 meetings. Since the meeting information is all made available through the app's mobile-friendly interface, those seeking a meeting have a simple, one-stop place to look.

The collated meeting information will be available in the future through G.S.O.'s website, www.aa.org, and will be a component of the proposed A.A.W.S. app. The intent of incorporating the Meeting Guide component is to make it easier for members to find A.A. meetings.

A.A. Intergroup/Central Offices, Districts and Areas that provide online meeting lists are invited to have their meetings displayed through the Meeting Guide. If you are already synchronizing your meetings through the Meeting Guide app there is no additional action necessary. When the new aa.org website launches at some point in 2019, your information will be seamlessly included.

Please note the meeting information database will operate completely independently from the Fellowship New Vision (FNV) database that is currently supported by G.S.O. Meeting Guide is a separate tool that offers A.A. entities full control of their local meeting information and collects it in one place. Users of this new portal will be linked to the service entity providing the information. Participation is, of course, voluntary, but the more connected the service is to the Fellowship as a whole, the more powerful a tool it will become.

The current listing of Intergroups and Central Offices and other local entities in "A.A. Near You" on aa.org will not be impacted. Those wishing to contact A.A. in their community will still have access to the information that is currently available on the site.

We have developed instructions about how to connect with this new resource at https://meetingguide.aa.org. If you have any questions about this initiative or how to synchronize your meetings to this database, dedicated support is in place. We welcome your input and suggestions.

### What is a Nontrustee Director? A Director?

here is a total of six nontrustee directors (NTD) in Alcoholics Anonymous. Ask most AA members, and they likely are unfamiliar with the position. About the one conclusion that can be drawn is that this person is not one of the twenty-one trustees, but beyond that, most would be perplexed. However, these six people could come from virtually any AA Group. The requirements are not extensive and many AA members with at least seven years of sobriety could turn in a resume to be a NTD trusted servant.

The revealing word is "Director". Directors are people who are members of a corporate board that manage the affairs of a corporation. Seldom are they mentioned, but in fact, they perform the primary work in managing AAWS and the AA Grapevine. Below are the descriptions of the two corporations' composition, and the directors are the people who are on the firing line of service for each corporation:

> AAWS CORPORATE BOARD: Currently, A.A. World Services, Inc. has nine directors: two general service trustees, two regional or at-large trustees, three nontrustee directors, one paid staff member, and the general manager of G.S.O., who is president of the corporation. The board meets ten times a year and considers agenda items such as budget preparation for the service and publishing operations, pricing of new and revised publications, G.S.O. service activities, implementation of Conference and General Service Board recommendations, copyright concerns, and reprint permissions.

> AAGV CORPORATE BOARD: The A.A. Grapevine, Inc. currently has nine directors: two general service trustees, two regional trustees, one Class A trustee, three nontrustee directors, and the executive editor, who serves as president of the corporation. The board meets quarterly to consider such matters as circulation, enhancement, finance, and development of new related items. It also holds four meetings a year as a planning committee of the whole.

As is seen from the descriptions of the corporations, there are three NTD's on each corporate board, or a total of six for all of AA. On the corporate board, they participate fully with the other members of the corporate board directorships, which are either trustees or employees of the respective corporation. The NTD's work shoulder-to-shoulder with the regional and general service trustees, chairing corporate board committees and are members of several of the committees, take on additional ad hoc committee assignments as needed, and attend all of the same corporate board meetings as the trustees. There is one exception to committee membership: NTDs are never on the Nominating Committee of either AAWS or AAGV. Only the trustee members of the affiliate corporations are members of the Nominating Committees.

A clear line of "Right of Decision" is in place with regard to the term "managing" the corporations mentioned above. The management exercised by directors is more in the realm of policy, not in day-to-day operations. The general manager of AAWS and the Executive Editor of AAGV are the designated managers of the corporations. These managers are most often tasked with the policy implementation determined to be in the best interest of the affiliate by the directors, but the directors maintain a hands-off position as to implementation. The chief executives request this delineation take place, to insure their proper effectiveness.

The term of a director is different based on the member's service position. My experience is with AAWS, so I will use it as the example. As a regional trustee I was assigned to AAWS as a director for 2 years. General Service Trustees (GST) are a director for their entire four years. Also, they most likely have served as a NTD prior to their term of service, so these GST's have 4 years of directorship prior to their 4 years as a GST and director. NTD's are selected for 4 one-year terms, or a total of 4 years. The Staff Coordinator, an employee at GSO, is a director during their 3 years as staff coordinator. And finally, the General Manager of GSO is a director (and President of AAWS) during his entire tenure as GM.

I mentioned earlier the directors perform the "primary work", and that it is policy oriented. At AAWS, we have the following committees to perform this work: 1) Finance 2) Technology/Communication Services (TCS) 3) Internal Audit Committee (IAC) 4) Publishing 5) Nominating. In addition, we currently have two ad hoc committees: Self-Support and DELTA, which I wrote about a couple months ago. These committees meet during each AAWS Board meeting, but the vast majority of work is done between AAWS Board meetings through conference calls, web sessions, and simply dividing up work and each director doing their share. Each committee has a staff member assigned to it as both a secretary as well as to do as much of the work as possible, so directors are not always tasked with the actual development of work-product.

NTDs and trustees are divided up as chairs and members of these committees. An NTD may not always get a chair position of a committee in their first year. Because the chairperson of AAWS rotates each year between a GST and a regional, this person is not assigned to committees as a chair or member, but instead is an ex offico member of all committees. Hence, with three directors and only three of the 4 trustees available to chair a committee plus the ad hoc's in action, chairing at least one committee is a likely possibility. Last year I was the chair of the inaugural year of the IAC and

chair of the newly formed ad hoc DELTA committee. This year I chair Nominating and DELTA, and I am a member of Publishing and TCS.

The nine directors each have a bit of different perspective due to their primary position, which sometimes results in differing perspectives at the Board table. While the NTD is solely focused on their directorship of the affiliate corporation, the staff coordinator and general manager spend all of their time as employees of AAWS so their viewpoint may be different. General Service Trustees have a fiduciary responsibility to the General Service Board as they are assigned to the affiliate, but they also have had four years as a director prior to their term as GST, and they do not represent an AA service structure, e.g., region, like the regional trustees. And then there's the regionals that are serving in two capacities during their tenure as a director during years two and three of being a regional trustee. There's always the responsibility of bringing the regional perspective to the table of the AAWS Board meeting, the regional (like the GST) is embedded onto the affiliate by the General Service Board to insure its proper functioning, and they also must serve AAWS (or AAGV) to the best of their ability. Yes, all these "flavors" of people provide a mixture, that when we factor the final catalyst into the equation, our Higher Power, this is yet one more divine alchemy that serves the still-suffering alcoholic.

Thank you for having the opportunity to be your servant.

### **Proof of Attendance at Meetings**

here is a question that comes up repeatedly around the rooms of the program - what about these people the courts are sending here? What should we

The written guidance from the General Service Office in NY, New York is pretty clear on this issue. It says in part... Some judges require written proof that offenders attend a certain number of meetings. Often, when the court ordered newcomer attends an A.A. meeting, the group secretary (or other group officer) signs his/her first name, to a slip furnished by the court.

Of course, in keeping with A.A.'s public relations policy, A.A. has no opinion on this practice. A.A. speaks neither against nor for this protocol. However, in the spirit of cooperation group members will often comply with the requirement and sign the slip. Hopefully, all involved recognize that neither the group nor its members are "bound" in any way by the signature. This compliance does not signify affiliation of the A.A. group with any other program; it simply illustrates cooperation.

Many around the tables affectionately refer to these individuals as slip signers. They are required by a court, treatment center, probation officer, or other outside agency to attend the meeting. Some attend willingly and look at the slip as a mere formality to something they would do anyway.

Still others see the mandatory requirement as an impingement upon their personal freedoms. They resent having to attend the meeting. They rush into the room about a minute before the meeting starts, sit in the aisle of denial, and say nothing during the meeting and rush to get their slip signed a minute after the meeting ends. My brother was one of these individuals.

About forty years ago, my brother was convicted of driving while intoxicated. He was court ordered to attend A.A. meetings. Since he did not have the "desire to stop drinking", he only attended Open A.A. Meetings. He would often come "high" to the meeting, come late, or rush in at the last second. He would sit in stubborn silence and the only thing he would share during the meeting was his name. Otherwise, he would sit and stare at the clock and wait for sixty minutes to pass. When the clock struck sixty-one minutes and the meeting was over, he was on his feet to get his slip signed and then he was out the door. He did this for the required three months of meetings and the group never saw him again until...

About eighteen months later, after his last court ordered A.A. meeting, my brother finally hit bottom. He found himself in detox and then he went into an in-patient treatment center. He finished the treatment program and after a momentary slip with some of his "old using buddies", he started working the program of A.A. He recently celebrated 38 years of sobriety.

A few years ago, I was thinking about my brother's recovery journey. I wondered why he attended A.A. after all those court ordered meetings he went to and loathed. He seemed to despise the meetings and absolutely hated going to them. So, I asked him, "Why did you go back to A.A. after all those court ordered meetings that you hated?"

He smiled, looked at me and simply said, "They were nice to me".

We never know what impact we are going to have on another individual. A random act of kindness; an offer of a cup of coffee; a non-judgmental smile when the newcomer takes a seat after the meeting starts; or agreeing to sign a slip of paper - all of these simple gestures may have far reaching consequences known only to that person and God. At least they did in my brother's case...

### **GSO Contributions**

During the past Fall Assembly a question was asked, by my home District. It concerned whether or not a District could contribute to the GSO.

The answer from a past Delegate was yes. Even though another past Delegate reminded the group to proceed with caution that this could be a contentious subject within the District.

According to the 2018 Final Report from the 68<sup>th</sup> Annual Meeting of the General Service Conference, page 117, footnote (1) "A special contribution is one that come from any number of AA entities that is not an AA Group."

I was confused for a few minutes until I remembered that District 9 had written to the GSO and they said we couldn't contribute because we didn't have a number.

It is my opinion that contributing to the GSO is a Group's, NOT A DISTRICT'S, responsibility. Reasonably, it is important the message of the rest of page 117 be shared with the group – that is the GSO needs more money to continue to offer the services they currently offer. Only 43.7% of the known Groups in AA contribute. That comes to \$6.00 per capita; which is short by a little more that \$1 per capita.

Perhaps at the next Assembly we could offer a panel discussion about this topic.





**TREASURER-Mike F.** Greetings from your Area Treasurer. It is an honor and a privilege to serve you.

Please take copies of our current financial reports and our 2019 budget back to your Groups. They are stacked on the table on the left side of the room. There are also pre-printed contribution envelopes to the area and to the General Service Office. Please take as many as you need.

Since my last report, I have:

- Reconciled 2 monthly bank statements and created reports for review by the Financial Oversight Committee
- Deposited all contributions received as of October 5<sup>th</sup>
- Paid all expenses received as of October 5<sup>th</sup>
- Completed a balance sheet and income/expense/contribution statement for Period 5 (August/September)

As of September 30<sup>th</sup>, the end of our financial period P5, our checking and savings accounts have a combined total balance of \$25,402.87, a net increase of \$412 compared to the beginning of 2018. When I compare our financial situation for the same time frame for 2017 and 2016, we had a net decrease of \$4,352 and a net increase of \$1,266, respectively.

As of October 5<sup>th</sup>, our checking and savings accounts have a combined total balance of \$26,039. This includes the balance sheet total as of the end of September plus another \$1,016 in deposits that I made yesterday and \$380 in expenses paid this past week.

Group contributions as of October 5<sup>th</sup> for 2018 and 2017 are \$24,065 and \$18,813, respectively, a 28% increase over last year. Total expenses for the same period are \$10,795 below budget.

We will discuss and approve the 2019 budget this weekend.

At the Spring Assembly April 4, 1982 the NL was approved for publication Issue #1 was published October 7,1982

At Midnight the NL has been in existence thirty six years. The NL has morphed from a four-page newsletter on 8 1/2x11 paper to a Twenty-page newspaper on newsprint. The NL has come from a humble beginning to the #1 source for all the Areas written communication.

The NL had a rough start with Issue One being published six times in the first eight years.: Oct 82, June 85, June 88, Oct 88, Feb 89, June 89

Here is a reprint From the December, 1989 issue of the NL. Which is just as meaningful today.

Kathy D., NL Editor wrote Who Wants It, Anyway?

"In the recent months since I volunteered to edit <u>The Northern Light</u>, it has become more and more apparent to me that a potentially valuable and useful communication tool is being overlooked. Rumors abound that many don't receive copies, that those who do don't read it, and that the material printed is outdated and irrelevant to the few readers. If these rumors are true, then Area 35 is wasting its money.

Frankly, the way our newsletter looks now, I think Area 35 is wasting its money. But rather than "throw the baby out with the bathwater," I believe we could make an effort to inject some life into our voice and use our printed messenger to bring new unity and a sense of real fellowship to our 500+ groups. The most important ingredient for this revival is your support. What would y\_o\_u like to see in your newsletter? What would get your blood rushing in anticipation of each issue in your mailbox? When I asked this question at the November 16th District 9 meeting, here were some of the answers I heard: "Delegate reports . . . Calendar of events . . . announcements of open AA meetings . . . results of GSR sharing sessions ... how groups solve problems ... personal recovery stories . . . original poems and artwork , " What a great list! And guess what? We could do it! Do you want it?

As Bill W. told readers of the then one-year-old <u>Grapevine</u>, "This is your periodical. It will be the vehicle for your thoughts, your feelings, your experience, and your aspirations ... if you care to make it that." ... And . . . . did you know anyone can contribute.

Give yourself a real present for the new year - - - a Northern Light you look forward to reading!"

### HOW DISTRICTS CAN BECOME STRONGER AND MORE EFFECTIVE....

- Jim S.

Why are Districts important to Alcoholics Anonymous? Home Groups within the District have the purpose of dealing with people who need support to recover from alcoholism. That's an important purpose and can take up a lot of time. In order for Groups to survive the Districts, help the Groups by communicating between them and the rest of Alcoholics Anonymous through GSRs from the Groups, District Chairs, the Area that they are located in and the GSO. If the groups in the District area are strong and have a good track record one would think the District would also follow suit. My sobriety depends on giving back for what was done for me many years ago. This needs to be instilled in Home Groups and the District itself. DCMs and District Chair people need to carry that message.

Promoting District service work within Alcoholics Anonymous can be a tough sell. Some may feel they don't need to pitch in and help because they are quite content with their own recovery program and sobriety. Making a point for personal gratitude for what was done for them way back when and even now can persuade some to participate in service work in the District. Strong and effective Districts must have a full complimentary of Chairmen for Literature, Grapevine, PI, CPC, Corrections and Treatment. Subcommittees creates stronger Districts. It is more effective and less burdensome to have more than one person working on a project.

Getting people to volunteer can be a problem. Again gratitude and humility are necessary to continue to have a happy and sober lifestyle. I've heard replies to help out like "I don't think I have enough time". To stay sober you must take the time or you will lose what you so valuably already have. Then where are you? I've heard replies like "I don't think I know anything about that". Well quite possibly this is exactly what you need to learn because you don't know anything about that.. Kind of like me giving this presentation. I've heard replies like "I don't think I'd be very good at it or I don't think I could actually do it at all". I would ask them "did you think you could or would be good at being sober and do you know how to continue your sober life and not relapse? Be careful here because your gonna get an earful of more excuses. If nothing else maybe you've helped this person somehow.

District Groups need to have a good avenue of communication with the organization that owns the building where meetings are held. A well maintained, attractive meeting place is a positive motivating factor in keeping people coming back. District Chairman can learn how to solve their own problems by talking to other Districts. If a District appears to be growing stronger and more effective, ask them what they are doing especially in Areas your District maybe lacking. Utilizing the Northern Light newsletter can be a great help to Districts. DCM's can publish their reports at Assembly's and committee meetings. Articles from people in your District are and should be promoted from within. Districts should tell their Groups how informative the news letter is and how to find it. Informing members of all the resources available to them from the Grapevine to online websites is a positive attitude you can bring to your District.

Diplomacy is the ability to let someone have your way. Compromising is necessary for things to get done always placing principles of the way Alcoholics Anonymous was set up for us before our personalities and ego driven ideas. So how again can we make our Districts stronger and more effective? DCMs-at your District meeting ask those in attendance to ask one person to come to the next District meeting, pick them up and bring them. You may have brought your new successor. If you are a District Chair, Committee member or GSR you should be looking for someone right now to take your spot when your rotation is over. Ideally there should be a back-up already but we all know that doesn't always happen. Districts should be informed of activities and issues going on within Alcoholics Anonymous (I stole that from the Northern Light). Thanks Steve. Steve does a good job. When Steve does a good job the Northern Light helps make Districts stronger and more effective. It really is a trickle down series of events that help keep Districts growing.

Ideas presented at District meetings are expanded and sometimes not used at all but none the less are needed and can really get the ball rolling. Districts should have a bulletin board of some sort at their meeting location to post District meeting dates and times along with printed out minutes of previous meetings, future events and things that are needed for your District for all to see. I as a DCM do this at our club with the help of anyone that wants to help. Things like this can have a positive effect on members as they come to their Home Group meetings. This simple thing can promote and show members the District is a trusted body working for them and just might get them to participate more. If alot of people participate more things should get done. Members often state ideas on different subjects. Ask them if they would be willing to come to a District meeting and present their ideas in a nice way if you can. If they say no ask them how will their idea be brought to the Districts attention then? If they say you do it, tell them your not sure how their idea works and I might not have that quite right.

Past Delegates, Area Chairs, Committee members are valuable resources for advice as they have either seen situations happen or will know someone who has. DCM's and District Secretaries should work with the Delegate and Area group records Chairs by doing the foot work of updating District Groups information along with the respective GSRs. Districts who are strong and effective have Groups within their Area who are carrying the message to newcomers who come through the door and continue to return.

Service work within the District has guide lines for length of sobriety for those positions. One thing that's been exciting to me as DCM has been seeing positions being filled that were open and seeing them already doing things in that position before they even came to the District meeting to accept the position. This in return gets the District going to help that person get what they need to carry the message. It really is a trickle down effect but needs to be followed up and through. Take time to have fun doing District service work. Enjoy working with others, sometimes successful sometimes not. If your just going through the motions, letting others do things you won't learn and won't have fun. Setting examples, being enthusiastic will make your District stronger and more effective.

There seems to be a gap in communications and transfer of information to groups through GSR's in Alcoholic Anonymous according to impact collaborative, an audit by A.A. It is very important to know what the responsibilities of your position are. If you are unsure you should ask. Area 35 has GSR your District, a good place to get ideas and answers. In bringing positive attitudes and ideas to your District and not dwelling on past problems and bringing, them up over and over will just make things less problematic. Grapevine published a Traditions checklist in 1969 thru 1971 which was published originally for individuals. Many groups use them as a basis for discussion now so why not your District. Inventory for the District can be a tool for correcting less effective policies and decisions. During inventory each District Chair can discuss job responsibilities and determine if those responsibilities are being done. Districts have the function of being an intermediate body to serve and protect Alcoholics Anonymous; the Twelve Steps, Traditions and Concepts. This should be done without governing but by informing and suggesting. The District Group purpose has one ultimate authority-A loving God expressing himself in our inventories and Group conscience. I personally do not look for or want credit for helping and sharing but rather often find inner peace. It gives me what I need today.

A District needs to have people who are in it attend its meetings. Working with others at the District level is necessary. We cannot do it alone. We cannot rest on our laurels. We must report what we are doing and have done. People helping people will keep your District strong no matter how many problems arise. Being able to solve those problems depends on ideas, a little research and unity. The AA triangle has three points. Districts are in the Service point. The Service point should be aware of the Unity and Recovery points and what they mean and need. Defining the Districts weaknesses and ineffectiveness according to position responsibilities and trying to improve those Areas can be a starting point to making Districts better. If your District is lacking say in the CPC field, you can get the CPC literature Kit to guide the CPC Chair to improve those Areas of communication with professionals. Likewise would be Literature, PI, Grapevine etc.

So how do we measure the strength of our Districts? Is it by how much money we have in the treasury? Is it by having all the positions filled? Is it by how well we serve the Groups, GSRs, Delegate and Area? Perhaps some of you can answer this. Minutes of District meetings can be sent to groups who do not have a GSR either by e-mail or regular mail. Minutes also should be sent to the Delegate and appropriate Area 35 people. Keeping others informed is important. District action Chairs should attend workshops of their position. Area 35 have workshops all the time. All these ideas can make your District better. The Treasurer of your District can make a budget showing how much needs to be spent on what and when. I read somewhere Districts are made to have similar numbers of groups in each one. So I'm wondering how this works in rural, sparsely populated areas. What can be done to help the Districts where there is just not enough people. What can we do to help? Perhaps some of you can try to answer this. Another question to think about perhaps-are there too many meetings in the District? Would less meetings make larger Groups, more Home Group members? Would that attract members to become alternates, especially GSRs who are part of the District. So now if anyone would like to come to the microphone and answer some of the questions I've asked or just make a comment or suggestion please do.

### **West Central Region Business**

### **Business Item #1:**

The West Central Region is non-compliant with IRS filing requirements, due to our income exceeding \$5,000 per year. Additionally, the ability to set up a bank account by the hosting area has become increasingly difficult, due to stricter policies at banks. The region does have an employer identification number, but that provides only a partial solution. To be compliant, two options have been considered by the delegates

Identity during the time that the respective area is responsible for the WCRAASC. This reporting would likely span two years, as the transfer from one area to the successive area takes place during the summer after the WCRAASC. Because this transfer is from one independent organization to another, this money would need to be recorded as income for that area's reporting year. The income generated from registrations, etc., likely starting late in the year through early March of the next year would also be considered income. Depending on the respective area's reporting requirements, costs and profits may or may not need to be reported. Each area would want to consider the reporting requirements for the time the area is hosting the WCRAASC. We likely will need unanimity from the eight Areas to be able to utilize this option. in meetings with the WCR Trustee.

The first option: is for each area to fully assume the recording and reporting to the IRS with their organization's legal

The second option: is for the West Central Region to file for formal recognition as some sort of organization, e.g., 501-C-3, 501C7, etc. Because the annual revenue for the WCR is below \$50,000, the current filing requirements are a simple, online form that is required each year, declaring our annual revenues. There are some initial filing requirements, plus some costs. An estimate at this time is it would be in the neighborhood of \$400-\$500. The Region would want to also develop a consistent reporting process, especially who the responsible person would be to fulfill this requirement.

**Note:** Currently, the 2019 hosting area is operating the checking account under the EIN of the WCRAASC that was obtained by South Dakota a number of years ago. If no other action is taken to become compliant, the legal and ethical ramifications should be discussed.

Option 1 VOTE: No One In Favor, A Lot Opposed

Option 2 VOTE: A Lot In Favor, 2 Opposed

### **Business Item #2:**

WCR Delegates voted to move the region's archives to an online storage system to free up the WCR Trustee's laptop. We need to determine who will perform any work associated with these two items. There has been discussion of restoring the Regional Secretary, and Gerry (MT) has provided us a recommendation, which was furnished at the GSC.

### **BACKGROUND INFORMATION ON WCR SEC/TREASURER**

September 9, 1988 Mr. Don B. West Central Regional Trustee Bloomington, IA 55438

Dear Don:

The meeting of the Iowa Area Committee met in Marshalltown, Iowa on Sunday, August 28, 1988. Part of my report concerned the West Central Regional Guidelines as they were formed at the meeting of the Delegates of the West Central Region along with yourself in Rapid City, South Dakota in early July.

The committee responded favorably to the Guidelines but were quite concerned about one portion of the action taken at: that meeting and have instructed me to send their concerns on to you with copies of this letter Item #1:

The West Central Region is non-compliant with IRS filing requirements, due to our income exceeding \$5,000 per year. Additionally, the ability to set up a bank account by the hosting area has become increasingly difficult, due to stricter policies at banks. The region does have an employer identification number, but that provides only a partial solution. To be compliant, two options have been considered by the delegates in meetings with the WCR Trustee

The first option is for each area to fully assume the recording and reporting to the IRS with their organization's legal identity during the time that the respective area is responsible for the WCRAASC. This reporting would likely span two years, as the transfer from one area to the successive area takes place during the summer after the WCRAASC. Because this transfer is from one independent organization to another, this money would need to be recorded as income for that area's reporting year. The income generated from registrations, etc., likely starting late in the year through early March of the next year would also be considered income. Depending on the respective area's reporting requirements, costs and profits may or may not need to be reported. Each area would want to consider the reporting requirements for the time the area is hosting the WCRAASC. We likely will need unanimity from the 8 areas to be able to utilize this option.

The second option is for the region to file for formal recognition as some sort of organization, e.g., 501-C-3, 501C7, etc. Because the annual revenue for the WCR is below \$50,000, the current filing requirements are a simple, online form that is required each year, declaring our annual revenues. There are some initial filing requirements, plus some costs. An estimate at this time is it would be in the neighborhood of \$400-\$500. The region would want to also develop a consistent reporting process, especially who the responsible person would be to fulfill this requirement.

### Item #2:

The region's archives/documents are currently being stored on the trustee's laptop and Dropbox. Two delegates (Gerry and Scott) have researched storage options and presented them to the WCR delegates. The cloud storage options provide the opportunity to provide adequate storage and access to the file with permission control. Depending on the granularity of users (i.e., each delegate plus trustee having a login and designated permissions versus a general login for administrator versus others) the costs can be controlled. The information on each option and cost were distributed at the WCR luncheon on Wednesday at the GSC.

This item is a bit more urgent, as the next host will want access and it would be best to insure the flow of documents that has taken place over the past year and upcoming ones are filed appropriately. In addition to a storage provider, we need to determine who would perform the work, provided we plan on saving our archival documents.

### Item #3:

If the decision is to incorporate and/or to maintain our documents online, we need to determine who will perform any work associated with these two items. There has been discussion of restoring the regional secretary, and Gerry (MT) has provided us a recommendation, which was furnished at the GSC. Being sent to the other Delegates also present at that meeting.

The concern that the committee wishes voiced is based on their understanding of Concepts 111, IV and V (the Right of Decision, the Right of Participation and the Right of Appeal) as it concerns the portion of those Guidelines to eliminate the position of Regional Secretary—Treasurer to be replaced by a Secretary—Treasurer to be selected by each host area for each West Central Regional Forum or Conference.

Their strong feeling is that the Delegates did not have the right to eliminate that position; one which was created by the Region itself and which was elected by the voting body at the Regional Conference (held in Sioux Falls, South Dakota in early March of this year). Therefore, the committee believes the decision made at Rapid City in July by the Delegates to eliminate this position should be declared invalid.

Their suggestion is that the position of Regional Secretary— Treasurer be retained (including the recognition of the election of Jan P.) and that this position be handled in the context of a liaison working with the Host Commit-

tee's elected Secretary— Treasurer. There would be an advantage in having only one Regional bank account which would solve a problem with having different bank ID numbers in each state for each conference.

As Iowa Area Delegate, I would support the Iowa Area Committee's recommendation.

### Q: Why list our past Delegates?

### A: They are a resource to you!

In Alcoholics Anonymous we value experience. Our Twelve Steps did not exist when Bill stepped into the lobby of a hotel in Akron, Ohio. Even after meeting with Dr. Bob and soon founding our program, there were only six steps until the experiences of 100 Alcoholics were summed up. Soon after a book followed, but it was a few years later when the Twelve Traditions were discussed and agreed on. Twelve Traditions that were "hammered out on the anvil of experience". Our past Delegates are a wealth of experience, an interactive living archive if you will. When you plan your next service workshop or need an outside voice to offer help, consider this resource available to you. Some of them even offer great company while fishing!

### The Delegate's Duties

Though the high point is the Conference meeting, the delegate's job goes on year-round and involves all aspects of the Conference structure. The delegate should:

- Attend the Conference meeting in April, fully prepared. Immediately
  upon election, every delegate is put on the G.S.O. mailing list to receive
  Conference materials.
- Communicate the actions of the Conference to area committee members and encourage them to pass on this information, and the delegate's enthusiasm, to groups and to intergroups/central offices. If an area is too large for the delegate to cover in person, he or she will ask area officers and committee members to share the load.
- Be prepared to attend all area, state/provincial, and regional service meetings and assemblies. From these meetings, delegates come to better understand their own areas and can make suggestions for the Conference agenda. Here, too, they come in contact with A.A. members who might not be reached otherwise.
- Help area committees obtain financial support for the area and G.S.O.
- Provide leadership in solving local problems involving the A.A. Traditions

- Remind G.S.R.s to inform groups and individuals about the A.A. Grapevine and Conference-approved literature.
- Cooperate with G.S.O. in obtaining information—for example, making sure that up-to-date information reaches G.S.O. in time to meet the deadline for each Issue of the A.A. directory and helping carry out the triennial membership surveys.
- Visit groups and districts in the area whenever possible.
- Work closely with committee members and officers, sharing experience throughout the year. After G.S.R.s and committee members have reported on the Conference, learn from these A.A.s how groups and members have reacted.
- Assume added responsibility if the area chair and alternate chair are unable to serve. Or, if an area committee is not functioning effectively, the delegate may take an active role in remedying the situation.
- Keep the alternate delegate fully informed and active, so that the alternate can replace the delegate in an emergency.
- Late in the second term, work with newly elected delegates to pass along a basic knowledge of Conference proceedings and problems.

# I2 Concepts for World Service (Short Form)

# I 2 Traditions of Alcoholics Anonymous (Long Form)

- 1. Each member of Alcoholics Anonymous is but a small part of a great whole. A.A. must continue to live or most of us will surely die. Hence our common welfare comes first. But individual welfare follows close afterward.
- 2. For our group purpose there is but one ultimate authority—a loving God as He may express Himself in our group conscience.
- 3. Our membership ought to include all who suffer from alcoholism. Hence we may refuse none who wish to recover. Nor ought A.A. membership ever depend upon money or conformity. Any two or three alcoholics gathered together for sobriety may call themselves an A.A. group, provided that, as a group, they have no other affiliation.
- 4. With respect to its own affairs, each A.A. group should be responsible to no other authority than its own conscience. But when its plans concern the welfare of neighboring groups also, those groups ought to be consulted. And no group, regional committee, or individual should ever take any action that might greatly affect A.A. as a whole without conferring with the trustees of the General Service Board. On such issues our common welfare is paramount.
- 5. Each Alcoholics Anonymous group ought to be a spiritual entity having but one primary purpose—that of carrying its message to the alcoholic who still suffers.
- 6. Problems of money, property, and authority may easily divert us from our primary spiritual aim. We think, therefore, that any considerable property of genuine use to A.A. should be separately incorporated and managed, thus dividing the material from the spiritual. An A.A. group, as such, should never go into business. Secondary aids to A.A., such as clubs or hospitals which require much property or administration, ought to be incorporated and so set apart that, if necessary, they can be freely discarded by the groups. Hence such facilities ought not to use the A.A. name. Their management should be the sole responsibility of those people who financially support them. For clubs, A.A. managers are usually preferred. But hospitals, as well as other places of recuperation, ought to be well outside A.A.—and medically supervised. While an A.A. group may cooperate with anyone, such cooperation ought never go so far as affiliation or endorsement, actual or implied. An A.A. group can bind itself to no one.
- 7. The A.A. groups themselves ought to be fully supported by the untary contributions of their own members. We think that each group should soon achieve this ideal; that any public solicitation of funds using the name of Alcoholics Anonymous is highly dangerous, whether by groups, clubs, hospitals, or other outside agencies; that acceptance of large gifts from any source, or of contributions carrying any obligation whatever, is unwise. Then too, we view with much concern those A.A. treasuries which continue, beyond prudent reserves, to accumulate funds for no stated A.A. purpose. Experience has often warned us that nothing can so surely destroy our spiritual heritage as futile disputes over property, money, and authority.
- 8. Alcoholics Anonymous should remain forever non-professional. We define professionalism as the occupation of counseling alcoholics for fees or hire. But we may employ alcoholics where they are going to perform those services for which we may otherwise have to engage non-alcoholics. Such special services may be well recompensed. But our usual A.A. "12 Step" work is never to be paid for.
- 9. Each A.A. group needs the least possible organization. Rotating leadership is the best. The small group may elect its secretary, the large group its rotating committee, and the groups of a large metropolitan area their central or intergroup committee, which often employs a full-time secretary. The trustees of the General Service Board are, in effect, our A.A. General Service Committee. They are the custodians of our A.A. Tradition and the receivers of voluntary A.A. contributions by which we maintain our A.A. General Service Office at New York. They are authorized by the groups to handle our over-all public relations and they guarantee the integrity of our principal newspaper, the A.A. Grapevine. All such representatives are to be guided in the spirit of service, for true leaders in A.A. are but trusted and experienced servants of the whole. They derive no real authority from their titles; they do not govern. Universal respect is the key to their usefulness.
- 10. No A.A. group or member should ever, in such a way as to implicate A.A., express any opinion on outside controversial issues—particularly those of politics, alcohol reform, or sectarian religion. The Alcoholics Anonymous groups oppose no one. Concerning such matters they can express no views whatever.
- 11. Our relations with the general public should be characterized by personal anonymity. We think A.A. ought to avoid sensational advertising. Our names and pictures as A.A. members ought not be broadcast, filmed, or publicly printed. Our public relations should be guided by the principle of attraction rather than promotion. There is never need to praise ourselves. We feel it better to let our friends recommend us.
- 12. And finally, we of Alcoholics Anonymous believe that the principle of anonymity has an immense spiritual significance. It reminds us that we are to place principles before personalities; that we are actually to practice a genuine humility. This to the end that our great blessings may never spoil us; that we shall forever live in thankful contemplation of Him who presides over us all.

- I. Final responsibility and ultimate authority for A.A. world services should always reside in the collective conscience of our whole Fellowship.
- II. The General Service Conference of A.A. has become, for nearly every practical purpose, the active voice and the effective conscience of our whole Society in its world affairs.
- III. To insure effective leadership, we should endow each element of A.A.
  —the Conference, the General Service Board and its service corporations, staffs, committees, and executives—with a traditional "Right of Decision."
- IV. At all responsible levels, we ought to maintain a traditional "Right of Participation," allowing a voting representation in a reasonable proportion to the responsibility that each must discharge.
- V. Throughout our structure, a traditional "Right of Appeal" ought to prevail, so that minority opinion will be heard and personal grievances receive careful consideration.
- VI. The Conference recognizes that the chief initiative and active responsibility in most world service matters should be exercised by the trustee members of the Conference acting as the General Service Board.
- VII. The Charter and Bylaws of the General Service Board are legal instruments, empowering the trustees to manage and conduct world service affairs. The Conference Charter is not a legal document; it relies upon traditional and the A.A. purse for final effectiveness.
- VIII. The trustees are the principal planners and administrators of overall policy and finance. They have custodial oversight of the separately incorporated and constantly active services, exercising this through their ability to elect all the directors of these entities.
- IX. Good service leadership at all levels is indispensable for our future functioning and safety. Primary world service leadership, once exercised by the founders, must necessarily be assumed by the trustees.
- X. Every service responsibility should be matched by an equal service authority, with the scope of such authority well defined.
- XI. The trustees should always have the best possible committees, corporate service directors, executives, staffs, and consultants. Composition, qualifications, induction procedures, and rights and duties will always be matters of serious concern.
- XII. The Conference shall observe the spirit of A.A. tradition, taking care that it never becomes the seat of perilous wealth or power; that sufficient operating funds and reserve be its prudent financial principle; that it place none of its members in a position of unqualified authority over others; that it reach all important decisions by discussion, vote, and, whenever possible, by substantial unanimity; that its actions never be personally punitive nor an incitement to public controversy; that it never perform acts of government, and that, like the Society it serves, it will always remain democratic in thought and action
