Nothing about price of coffee, room setup, price for individual rooms etc. I was supposed to see that updated information last week and I thought being the 4th last week I would give them a couple days into this week before moving on. I talked with Mike F. a couple weeks ago who offered to go down and talk with them directly as we have not been in Grand Rapids for quite some time. I know the Crookston Inn is available and we had a good experience there the last time except there was a miscommunication about how coffee was to be set up. I feel a location absolutely needs to be locked in shortly. I have been given several names who would be good guest speakers by Tom A.

I hope all of you are considering the opportunity that Area 35 has to offer for you with the upcoming elections. It is important that we consider taking that next challenge. Even if you don't think you are qualified you should take the chance and let God make the decision. Income After Expenses: Two months ago, our expenses exceeded income by **\$8,125**. Now expenses exceed income by only **\$4,326**. Thank you for your continued support!

If our Group contributions were to continue to come in at the same rate as they have thus far, we can expect to receive approximately **\$28,500** for the year. That would be slightly less than in **2018** (**\$30,566**), but more than in **2017** (**\$24,961**).

<u>Account Balances</u>: as of July 8^{th} , our checking and savings accounts have a combined balance of \$21,036, which is \$1,014 (5%) more than on this date last year.

<u>Group Contributions</u>: as of July 8th, our year-to-date Group contributions are **\$14,719**, which is **\$1,461 (9%)** less than on this date last year.

Special Contributions: these are contributions made to the Area by various roundups. None have been received yet this year.

<u>Miscellaneous Area Income</u>: this includes registration fees from the service workshop, coffee income from assemblies, Grapevine sales, and Northern Light flyer insert fees. We have received **\$2,224** thus far, about **\$19** less than on this date last year.

<u>Miscellaneous Expense</u>: this includes all costs associated with the Service Workshop, both Assemblies, the Joint Workshop with Area 36, Area Committee Meeting rent, Grapevine purchases, and Financial Oversight Committee travel/meals. Our miscellaneous expenses thus far are \$3,547, which is 41% less than on this date last year.

<u>Officer/Chairs Expense</u>: this includes all expenses submitted for reimbursement by Officer and Chairs for meals, travel, lodging, supplies, printing, postage, and audio equipment. These expenses thus far are \$17,787, which is 6% less than on this date last year.

To summarize, our bank account balances are up 5% from last year. Our Group contributions are down 9%, overall income is down 14%, expenses are down 14%, yet our net income is up 13%.

As we know, we are self-supporting, so please continue to encourage members to show their gratitude for their sobriety by contributing to the GSO, Area 35 and their District.

Recently I had the opportunity to attend Founders Day Weekend in Akron, Ohio, birthplace of Alcoholics Anonymous! and what a wonderful time it was. The speaker's that shared their stories that weekend were really good. Personally though for me the highlights of the weekend surrounded our founding. Our first stop Saturday morning was at Dr. Bobs house. It was at that time that a lot of the stories and experience that has been shared through literature started to come to life. I was able to see first hand the magnificent archives the 855 Ardmore Ave. holds.

The bible that that they read out of and the first edition Big Book that they used sitting at the table reminded of other members homes that I've been to. I was overcome by a sense of gratitude and humility walking through that house. Our next stop was St. Thomas Hospital to visit the Chapel and dedication to Sister Ignatious. It was there that I kinda had a little moment and was able to kneel and pray and give thanks for all the wonderful blessings in my life. We as a fellowship owe a huge debt of gratitude to the work that was done there.

Afterwards we travelled to Akron Intergroup to view Archives on display whereas well. I walked through slowly and was able to spend a little time reading some of the correspondence letters from early AA dignitaries. My favorite letter was written by Carl Jung. In the end of his letter notes that only the spirit is capable of defeating Spirits. Spiritus contra Spiritum as he puts it in Latin. The final stop for the day before we went back to clean up for the speaker meeting that night was to the Sieberling gatehouse where Bill had met Bob for the first time. Words really can't describe what I was feeling being in that very room We also toured the mansion there as well to see how the "other half live. If your ever in Akron take the time to do the tour, its rather interesting.

Sunday morning I found myself riding in a motorcade of roughly 2500 motorcycles enroute to Dr. Bobs resting place. There, a beautiful speech was given to commemorate our Founders, and duly noted that Ann Smith and their children, were a huge part of AA's success as well, as we were reminded of the sacrifices they made in giving up their Husband and Father to the cause. As the weekend wrapped up I found myself reflecting on some of my own personal experiences with guys I've sponsored throughout the years. The thought that I must continue to try and carry the AA message so that this saving grace can be found by others and ensure that I may remain sober to continue to live a sane and useful life.

Group Records:

Greetings, Area 35.

The switch-over to the new Enterprise Resource Planning (ERP) is rapidly approaching. GSO sent out a letter to the Fellowship explaining how this will be scheduled. The letter is below.

Dear A.A. friends,

As you may know, G.S.O. is immersed in an exciting major project to modernize our office business systems and consolidate nearly all of our business functions to a single platform.

We are taking these measures with the goal of providing increased efficiencies, security, and enhanced overall support of the A.A. community.

However, this important upgrade will necessitate a shutdown of some of our online systems -- most notably our literature ordering and contributions systems -- as we transition to the new platform. During this transition period we will be unable to accept literature orders via phone, fax, online webstore, or any other means. We will also be unable to process or accept online contributions, as well as any changes or updates to service records currently housed in FNV or elsewhere.

Important: Our literature ordering and contributions systems will be shut down during the change-over period from Friday, July 26, 2019 at the close of business until Monday, August 5, 2019 when the new system will be available. Also, July 22, 2019 is the last day for us to receive orders. Orders received between July 23 and August 4 will not be processed until we go live. Online stores will close on July 22 at 5 p.m.

If the above dates change for any reason, we will reach out to you with an update as soon as possible.

Once the new system is up and running, members interacting with G.S.O. will have a much improved user experience, allowing for greater ease of ordering, a new self-service portal for updating group records and more complete customer service.

SPECIAL NOTE FOR **AREA REGISTRARS**: More information on training will be provided by G.S.O.'s Records Department as the change-over to the new system is implemented.

SPECIAL NOTE FOR **RECURRING CONTRIBUTIONS ONLINE**: Due to the change-over, members who have been making recurring contributions online will have to reenter all credit card information once the new system is implemented.

SPECIAL NOTE ABOUT **SALES TAX AND EXEMPTIONS**: Based on new sales tax regulations, there are 22 states in which we will have to start collecting sales tax.* Additionally, if you currently have tax exemption status on file with G.S.O., it will be necessary to resubmit your form. We will not be transferring tax exempt status from the old system to the new ERP sys-

AA District 15 Completes Second Successful Year of School Program.

D uring the 1992-93 school year District 15 was again active in their High School AA presentations. Members of the District gave 44 fifty minute presentations in 6 schools within our District, reaching 617 students on two occasions. Due to doing the entire school populations in three schools last year we had a lighter load this year but are looking forward to a larger group again next year.

The students ratings of these presentations again were most encouraging as many of the groups rated over half of them excellent with good running a close second. Their comments are especially interesting with many "Thank You's" for coming to our school.

We continue to see a real explosion in the drinking habits of students between 10th and 12th grades. We feel by their answers to the 14 question quiz many of them are well on their way to becoming a problem to themselves, families, and society as a whole. Hopefully, with the information they receive, some will take a second look at their lives.

We have placed 4 copies of 24 different pamphlets and one Big Book in each library of the schools and will restock as necessary. We have established a good working relationship with school administrators with a number of them contacting us to return the their schools prior to us contacting them. We have copies of all lesson plans, forms and cassette tapes of our presentations available for the asking for anyone interested in starting this program in their district.



This Assembly I brought a newcomer and my sponsor. Neither has seen this process. So, I was honored to have them along. They brought out the best in me, like a blooming flowing and I am grateful. I loved watching the emotions grow when they heard something they didn't like or agree with. For example, when someone at the mic joked about Books for Crooks, I think I had to hold her down for that one. She at one time was on the inside and took offence. A few years back I myself made that same reference and it wasn't liked then either. I explained that to her and tried to explain the meaning, I couldn't justify the term. I will try not be saying that again. Some may think she over reacted (I did at first) then I put myself as if I heard that for the first time with the snicker included.

When I was new in AA, I did not understand a lot and this Singleness of Purpose thing. I mean what is the big deal. An addict is an addict. AA's Singleness of Purpose is hard for the new comer to grasp. Treatment people just says go to meetings. I say, work with a sponsor, go through the steps and traditions, and if you still feel that way, talk with other trusted servants. Through sponsorship and my AA Dad, I learned what the words "Singleness of Purpose" meant and why we have to have it and keep it to one thing. Tra dition 5 tells us in the Twelve Steps and Twelve Traditions (page 150) ... better to one thing supremely well than many badly.

"I'm still mystified by how I got sober, and the only answer that makes sense is that I stopped drinking through the grace of God. I was thinking about the difference between those of us who get sober and those who are still drinking, and I believe the difference is that we have accepted the grace that was offered. Every day, my Higher Power gives me the grace to be sober, and every day I make the choice not to drink, to accept the grace."

"The Gift of Sobriety," La Crescenta, California, February 1993, AA Grapevine

During Saturday and Sunday, my newcomer, was sober 88 - 89 days and she's at an Assembly. She wants to come back, so the loving discussions did not scare her away. When I get frustrated when she is not seeing another way, other than her cloudy ways, I have to remember how was I at that stage in recovery. No one could get through to me, not with alcohol anyway.

On the way we stopped at the jail to pick up a volunteer application, I knew the building would be closed. She had to find out that for herself. I found myself looking at her and telling my sponsor, I am going love watching her grow in recovery. Today she was approved to go in to that jail!!

If you ever want to grow yourself, bring a newcomer to an Assembly or any other Area 35 function. October is our voting Assembly, this process is emotional, humbling and spiritual. Sometimes we choose our trusted servants and sometimes God is the one who chooses...

I just returned from 69th GSC and my heart is full. I can't believe the gift that I have been given to serve all of you and AA as a whole. We had a week full of business and information that needs to be reported and shared. Later, I will be giving my Post Conference Report. I have a few Districts to schedule a time to give my report and those are Districts 12, 18 and 21. Please see me to schedule a time.

The Grapevine is celebrating 75 years and they have a Tool Kit that they are offering. Remember that the Grapevine is supported through subscription and book sales. They do not accept 7^{th} Tradition contributions. The Grapevine is offering gift certificates. This will help eliminate the problem with billing. If you want to give as a gift, purchase a gift certificate, then all the information will go to the person receiving the gift versus the person purchasing.

A little update about alcoholicsanonymous.com, there was mention that, in the next year, there may be conversation-taking place between people to see if there is some sort of resolution that can happen. This will not be legal action, just conversation. The fellowship will be updated as information becomes available.

I want you to know that the 91 employees, at GSO, are working very hard. Last year they saved \$635k in various areas like, credit card processing, shipping and warehouse, French translation and other services. They have listed 1641 new Groups, responded to over 400 emails regarding the new website, answered about 100K general calls and emails and coordinated more than 30 National CPC Conferences.

The new website is projected to be completed by the 2020 GSC, the ERP project is scheduled to go live August 7, 2019 and the AA app project is scheduled to launch in a couple months.

To date, YouTube channel has 3103 subscribers.

Registration opens, for the International Convention in Detroit, on September 9, 2019. There will be need for AA volunteers and formal requests and information should be coming out this fall and communicated on AA.org. Some of the GSO staff put on a fantastic skit about the Convention and YOU can see this skit if you attend the WCR Forum that is coming up August 16th, 17th, 18th in Grand Forks, ND. I have fliers on the back table. This will be a great opportunity to meet some of the GSO staff. I will also be putting together opportunities for you to get together and enjoy conversation with some of the staff over a meal. Since my last ACM/Assembly report in April, I have:

- Reconciled two monthly bank statements and created reports for review by the Financial Oversight Committee
- Deposited all contributions received as of May 29th
- Paid all bills and expenses received as of May 29th
- Completed a balance sheet and income/expense/contribution statement for Period 3 of 2019 (April/May)

As of May 31st, our checking and savings accounts have a combined total balance of **\$18,607**.



Q: Why list our past Delegates?

A: They are a resource to you!

In Alcoholics Anonymous we value experience. Our Twelve Steps did not exist when Bill stepped into the lobby of a hotel in Akron, Ohio. Even after meeting with Dr. Bob and soon founding our program, there were only six steps until the experiences of 100 Alcoholics were summed up. Soon after a book followed, but it was a few years later when the Twelve Traditions were discussed and agreed on. Twelve Traditions that were "hammered out on the anvil of experience". Our past Delegates are a wealth of experience, an interactive living archive if you will. When you plan your next service workshop or need an outside voice to offer help, consider this resource available to you. Some of them even offer great company while fishing!

The Delegate's Duties

Though the high point is the Conference meeting, the delegate's job goes on year-round and involves all aspects of the Conference structure. The delegate should:

- Remind G.S.R.s to inform groups and individuals about the A.A. • Grapevine and Conference-approved literature.
- Attend the Conference meeting in April, fully prepared. Immediately upon election, every delegate is put on the G.S.O. mailing list to receive Conference materials.
- Communicate the actions of the Conference to area committee members and encourage them to pass on this information, and the delegate's enthusiasm, to groups and to intergroups/central offices. If an area is too large for the delegate to cover in person, he or she will ask area officers and committee members to share the load.
- Be prepared to attend all area, state/provincial, and regional service meetings and assemblies. From these meetings, delegates come to better understand their own areas and can make suggestions for the Conference agenda. Here, too, they come in contact with A.A. members who might not be reached otherwise.
- Help area committees obtain financial support for the area and G.S.O.
- Provide leadership in solving local problems involving the A.A. Traditions.

- Cooperate with G.S.O. in obtaining information-for example, making sure that up-to-date information reaches G.S.O. in time to meet the deadline for each Issue of the A.A. directory and helping carry out the triennial membership surveys.
- Visit groups and districts in the area whenever possible.
- Work closely with committee members and officers, sharing experience throughout the year. After G.S.R.s and committee members have reported on the Conference, learn from these A.A.s how groups and members have reacted.
- Assume added responsibility if the area chair and alternate chair are unable to serve. Or, if an area committee is not functioning effectively, the delegate may take an active role in remedying the situation.
- Keep the alternate delegate fully informed and active, so that the alternate can replace the delegate in an emergency.
- Late in the second term, work with newly elected delegates to pass along a basic knowledge of Conference proceedings and problems.

I 2 Traditions of Alcoholics Anonymous (Long Form)

- 1. Each member of Alcoholics Anonymous is but a small part of a great whole. A.A. must continue to live or most of us will surely die. Hence our common welfare comes first. But individual welfare follows close afterward.
- 2. For our group purpose there is but one ultimate authority—a loving God as He may express Himself in our group conscience.
- 3. Our membership ought to include all who suffer from alcoholism. Hence we may refuse none who wish to recover. Nor ought A.A. membership ever depend upon money or conformity. Any two or three alcoholics gathered together for sobriety may call themselves an A.A. group, provided that, as a group, they have no other affiliation.
- 4. With respect to its own affairs, each A.A. group should be responsible to no other authority than its own conscience. But when its plans concern the welfare of neighboring groups also, those groups ought to be consulted. And no group, regional committee, or individual should ever take any action that might greatly affect A.A. as a whole without conferring with the trustees of the General Service Board. On such issues our common welfare is paramount.
- 5. Each Alcoholics Anonymous group ought to be a spiritual entity having but one primary purpose—that of carrying its message to the alcoholic who still suffers.
- 6. Problems of money, property, and authority may easily divert us from our primary spiritual aim. We think, therefore, that any considerable property of genuine use to A.A. should be separately incorporated and managed, thus dividing the material from the spiritual. An A.A. group, as such, should never go into business. Secondary aids to A.A., such as clubs or hospitals which require much property or administration, ought to be incorporated and so set apart that, if necessary, they can be freely discarded by the groups. Hence such facilities ought not to use the A.A. name. Their management should be the sole responsibility of those people who financially support them. For clubs, A.A. managers are usually preferred. But hospitals, as well as other places of recuperation, ought to be well outside A.A.—and medically supervised. While an A.A. group may cooperate with anyone, such cooperation ought never go so far as affiliation or endorsement, actual or implied. An A.A. group can bind itself to no one.
- 7. The A.A. groups themselves ought to be fully supported by the voluntary contributions of their own members. We think that each group should soon achieve this ideal; that any public solicitation of funds using the name of Alcoholics Anonymous is highly dangerous, whether by groups, clubs, hospitals, or other outside agencies; that acceptance of large gifts from any source, or of contributions carrying any obligation whatever, is unwise. Then too, we view with much concern those A.A. treasuries which continue, beyond prudent reserves, to accumulate funds for no stated A.A. purpose. Experience has often warned us that nothing can so surely destroy our spiritual heritage as futile disputes over property, money, and authority.
- 8. Alcoholics Anonymous should remain forever non-professional. We define professionalism as the occupation of counseling alcoholics for fees or hire. But we may employ alcoholics where they are going to perform those services for which we may otherwise have to engage non-alcoholics. Such special services may be well recompensed. But our usual A.A. "12 Step" work is never to be paid for.
- 9. Each A.A. group needs the least possible organization. Rotating leadership is the best. The small group may elect its secretary, the large group its rotating committee, and the groups of a large metropolitan area their central or intergroup committee, which often employs a full-time secretary. The trustees of the General Service Board are, in effect, our A.A. General Service Committee. They are the custodians of our A.A. Tradition and the receivers of voluntary A.A. contributions by which we maintain our A.A. General Service Office at New York. They are authorized by the groups to handle our over-all public relations and they guarantee the integrity of our principal newspaper, the A.A. Grapevine. All such representatives are to be guided in the spirit of service, for true leaders in A.A. are but trusted and experienced servants of the whole. They derive no real authority from their titles; they do not govern. Universal respect is the key to their usefulness.

I 2 Concepts for World Service (Short Form)

- I. Final responsibility and ultimate authority for A.A. world services should always reside in the collective conscience of our whole Fellowship.
- II. The General Service Conference of A.A. has become, for nearly every practical purpose, the active voice and the effective conscience of our whole Society in its world affairs.
- III. To insure effective leadership, we should endow each element of A.A. —the Conference, the General Service Board and its service corporations, staffs, committees, and executives—with a traditional "Right of Decision."
- IV. At all responsible levels, we ought to maintain a traditional "Right of Participation," allowing a voting representation in a reasonable proportion to the responsibility that each must discharge.
- V. Throughout our structure, a traditional "Right of Appeal" ought to prevail, so that minority opinion will be heard and personal grievances receive careful consideration.
- VI. The Conference recognizes that the chief initiative and active responsibility in most world service matters should be exercised by the trustee members of the Conference acting as the General Service Board.
- VII. The Charter and Bylaws of the General Service Board are legal instruments, empowering the trustees to manage and conduct world service affairs. The Conference Charter is not a legal document; it relies upon traditional and the A.A. purse for final effectiveness.
- VIII. The trustees are the principal planners and administrators of overall policy and finance. They have custodial oversight of the separately incorporated and constantly active services, exercising this through their ability to elect all the directors of these entities.
- IX. Good service leadership at all levels is indispensable for our future functioning and safety. Primary world service leadership, once exercised by the founders, must necessarily be assumed by the trustees.
- X. Every service responsibility should be matched by an equal service authority, with the scope of such authority well defined.
- XI. The trustees should always have the best possible committees, corporate service directors, executives, staffs, and consultants. Composition, qualifications, induction procedures, and rights and duties will always be matters of serious concern.
- XII. The Conference shall observe the spirit of A.A. tradition, taking care that it never becomes the seat of perilous wealth or power; that sufficient operating funds and reserve be its prudent financial principle; that it place none of its members in a position of unqualified authority over others; that it reach all important decisions by discussion, vote, and, whenever possible, by substantial unanimity; that its actions never be personally punitive nor an incitement to public controversy; that it never perform acts of government, and that, like the Society it serves, it will always remain democratic in thought and action.

- 10. No A.A. group or member should ever, in such a way as to implicate A.A., express any opinion on outside controversial issues—particularly those of politics, alcohol reform, or sectarian religion. The Alcoholics Anonymous groups oppose no one. Concerning such matters they can express no views whatever.
- 11. Our relations with the general public should be characterized by personal anonymity. We think A.A. ought to avoid sensational advertising. Our names and pictures as A.A. members ought not be broadcast, filmed, or publicly printed. Our public relations should be guided by the principle of attraction rather than promotion. There is never need to praise ourselves. We feel it better to let our friends recommend us.
- 12. And finally, we of Alcoholics Anonymous believe that the principle of anonymity has an immense spiritual significance. It reminds us that we are to place principles before personalities; that we are actually to practice a genuine humility.
