

Since my last Northern Light treasurer's report in early July, I have:

- Reconciled two monthly bank statements and prepared reports for review by the Financial Oversight Committee
- Deposited all contributions received as of September 3<sup>rd</sup>
- Paid all invoices and expenses received as of September 3<sup>rd</sup>
- Completed a balance sheet and an income/expense/contribution statement for Period 4 of 2019 (June/July)

**Income After Expenses:** In early May, our expenses exceeded income by \$8,125. Now expenses exceed income by only \$4,243. Over the past two months, our income has been essentially equivalent to our expenses.

We've paid all expenses to date, including those from our attendance at the West Central Regional Forum. The principal expenses for the remainder of the calendar year will be for the fall assembly and the Area 35/Area 36 joint workshop. I would expect that contributions will far exceed expenses for the remainder of the year.

**Bank Account Balances:** as of September  $3^{rd}$ , our checking and savings accounts have a combined balance of **\$21,115**, which is \$1,550 (7%) less than on this date last year. We are solvent and we have a prudent reserve.

<u>Group Contributions</u>: as of September 3<sup>rd</sup>, our year-to-date group contributions are **\$19,839**, which is \$1,318 (6%) less than on this date last year. If our group contributions were to continue to come in at the same rate as they have thus far, we can expect to receive approximately **\$29,800** for the year. That would be only slightly less than in 2018 (\$30,566), but a lot more than in 2017 (\$24,961). Thank you for your continued support!

<u>Special Contributions</u>: these are contributions made to the Area by various roundups. None have been received yet this year.

<u>Miscellaneous Area Income</u>: this includes registration fees from the service workshop, coffee income from assemblies, Grapevine sales, and Northern Light flyer insert fees. We have received **\$2,500** thus far, about \$119 more than on this date last year.

<u>Miscellaneous Expense</u>: this includes all costs associated with the service workshop, both assemblies, the joint workshop with Area 36, Area Committee Meeting rent, Grapevine purchases, and Financial Oversight Committee travel/meals. Our miscellaneous expenses thus far are **\$3,809**, which is 42% less than on this date last year.

**Officer/Chairs Expense:** this includes all expenses submitted for reimbursement by officers and action chairs for meals, travel, lodging, supplies, printing, postage, and audio equipment. These expenses thus far are **\$22,841**, which is 11% more than on this date last year. Please note that year-to-date we are still \$8,500 below budget. Also, we recently incurred \$3,106 in costs for the regional forum, an event that is only held every other year, which would account for the increase in expenses.

**To summarize our current financial position** (compared to September 3, 2018), our bank account balances are down 7%, our group contributions are down 6%, overall income is down 9%, and expenses are down 2%.

As we know, we are self-supporting, so please continue to encourage members to show their gratitude for their sobriety by contributing to the GSO, Area 35 and their district.

prisons to use E-books than to inspect books coming into the prison. She stated that many of the Federal Prisons are now using a private vender to handle many of the services that prison staff used to handle. Christine went on to explain how AAWS is trying to have the Big Book app a default app when prisoners receive their E-book. That way prisoners won't have to purchase the app later, which can be a difficult task to do. There will be some expense to AAWS to have this installed as default app., negotiations are ongoing.

Area 35 can feel proud of Christine. She did a great job in preparation and presenting her topic "What defines an editorial change and content change?" at the WCRF. There was a lot of discussion on the topic.

For lunch on Saturday, I was fortunate to have lunch with Racy J. G.S.O. Staff Public Information Coordinator. There was discussion about Public Service Announcements (PSA's) and YouTube videos, but what caught my attention was something Racy said in regards to our Tradition of not having an opinion on outside issues. Racy stated that she gets phone calls all the time from prominent papers and news sources to comment on a different alcohol and treatment related issues. When she states that AA has no opinion on outside issues, how that in itself is news and reinforces how we let others promote us. Another interesting tidbit from Racy was that if movies and TV shows use AA literature (pamphlets, books or Step/Tradition window shade display etc.) in their shots, they then have to have AA approval of the script for just that small segment of their script, because of copyright laws. If their movie or TV show doesn't show any AA literature they can show AA in any light they want.

I ran into Roy E., Area 36 Chair, and we talked about the Grapevine conference agenda submission from Area 36, to reprint the <u>Best of the Grapevine</u> volumes one, two and three. I told him Area 35 is preparing to vote on whether to send in an agenda submission to back up Area 36's proposal. Roy said he would send me all his background information on their proposal. Then as luck would have it, both Roy and I ended up talking with Albin Z., the Grapevine Publisher. We asked Albin if it would be difficult to republish the three volumes of the <u>Best of the Grapevine</u>. His answer surprised us, he said it shouldn't be very hard to do a limited reprint of the three books. He stated that it might be 50 cents to a dollar more than a full printing to do the reissue. He said that the plates for publication are already made and that with a new cover and/or as a three set bundle it just might be feasible. We were both in high spirits that it might not be a big lift to get this done.

I attended two workshops Saturday night, one was on Young People in AA and the other was, Are we inclusive to all in AA?

I left the Young Peoples workshop somewhat confused. Were young people feeling left out of AA as a whole? Was it the people that put on Young People In AA (YPIAA) events that think they do not belong to AA? Is it that young people that go to YPIAA events do not feel a part of AA? Do young people feel left out because they think us "old" fuddy-duddies don't like to chant and prefer more structure in AA Meetings? These were questions I had that really were not answered it the workshop. Someone read a letter Bill wrote back to someone about having concerns about hippies joining AA. Look it up, it's a good read. Still spot on as to what should be done. Nothing!

In the workshop, "Are we Inclusive in AA", discussion ranged from how one white suburban group became more racially diversified and that they felt the group was better for it. There was discussion on people with disabilities. One person mentioned how there was a member of their group that was wheelchair bound and couldn't reach the doorbell to enter through the handicapped door because it was too high. The group was able to get the doorbell lowered. There was discussion on not enough sign meetings for the hearing impaired. How to get affordable signers at meetings. Should groups pass a second basket to pay for signers expenses? What was interesting, was that the meeting was chaired and the secretary and mic proctor were all hearing impaired members.

The night was capped off with a GV subscription drawing for first time attendees that lasted a good half hour. They just kept calling names and gave away about fifty subscriptions. Then it was time for the Ice cream social where the GSO staff and Trustees served up the ice cream. There was about 350 people present at the WCRF and what was remarkable was that half were first time attendees.

Thank you for sending me to this year's West Central Regional Forum. It was a delight and very informative. It started with a pleasant drive with beautiful weather, great company and enjoyable conversation. Between Crookston and Grand Forks we hit a bug storm. It sounded like hail hitting the front of the truck and when we arrived around 9ish, the front of the vehicle was just covered in two layers of bug guts.

Saturday morning I was lucky enough to have breakfast with Christine C. (Class A Trustee) she is a retired judge from Missouri. During the course of conversation, the talk turned to getting literature into prisons and jails. The one thing that stood out and quite shocking was how Federal prisons are switching to E-books. # Meeting Guide 3.0

Dear Friends.

We're happy to announce that Alcoholics Anonymous World Services, Inc., is releasing Meeting Guide 3.0.

Meeting Guide is a mobile app focused on helping people find A.A. meetings and resources near them. The app has been updated to include some new features we're pleased to announce:

# "For it is in Giving that we Receive"

L very A.A. group ought to be fully self-supporting, declining outside contributions. (Tradition Seven of the 12 Traditions of Alcoholics Anonymous)

As we mature in our sobriety, we begin to see that not only do the 12 Traditions apply to the group to which I belong, but they also apply to me individually. Tradition Seven reminds me about taking responsibility for my actions and contributions.

When I first came into the rooms of A.A. 41 years ago, it was common place to put a dollar in the basket. According to the Bureau of Labor Statistics consumer price index, today's prices in 2019 are 292.86% higher than average prices throughout 1978. In other words, \$1 in 1978 is equivalent in purchasing power to about \$3.93 in 2019. Thus, if I want to contribute my fair share to the group, I ought to be putting \$4-\$5 in the basket weekly. It doesn't make sense (or cents) that the longer I stay sober the less money I put into the basket. On the contrary, it makes perfect sense (or cents) that the longer I stay sober the more money I put into the basket.

So, where do I get this philosophy that the longer, I stay sober, the more I'm expected to give? I have three primary sources for this concept. The first comes from page 85 in the book Alcoholics Anonymous which says, "What we really have is a daily reprieve contingent on the maintenance of our spiritual condition."

A while back I was getting my car repaired. While waiting for the repairs to finish, my eyes fell upon a sign in the repair shop. The sign was so revelatory, I decided to take a picture of it. The sign showed that the more miles that were on a car, the more money it would take for the maintenance of that car. It occurred to me that this is also true of my sobriety. The longer I stay sober, the more that is required of me in the daily maintenance of my spiritual condi-



ond source this philosophy the same page in the book

Alcoholics Anonymous (page 85) which states, "It is easy to let up on the spiritual program of action and rest on our laurels. We are headed for trouble if we do, for alcohol is a subtle foe." For me, resting on my laurels sounds like this... "Someone else will do it". "It doesn't matter if I miss a "Somebody will make up the shortfall in the few weeks of meetings". Group's budget this month".

The last source for this philosophy comes from a book outside of A.A. conference approved literature, but it is a source that was used quite frequently by the Oxford Groups, the forerunner of A.A. This source states, "From everyone to whom much has been given, much will be required ... " - Luke 12:48.

This quote reminds me that I have been blessed by sobriety. Moreover, an obligation that I incur from that blessing is to share my bounty with others.

Since my last report, I have prepared a presentation for the WCR Forum. The presentation is called "What Defines an Editorial Change and a Content Change?" This will be a Forum Wide Workshop. Speaking of the Forum, I know some of you have not made your hotel reservations, the deadline has been extended so please call and make them so we can meet our quota. When you make your reservations, you will need to mention Group Code #427139. If you have already made your reservations, please call and make sure you are registered under this group code to ensure we are getting credit. I appreciate your help and understanding with this.

I have some time slots set aside to have meals with GSO staff and if you are interested, please let me know and we will get you on the schedule. Mention this to new members and GSRs, this is a great opportunity for people to get to know some of the staff. I will be asking for volunteers to Host the meal so if you are interested, please get with me sometime today or shoot me an email.

I have been busy giving post conference reports and I have two remaining. I will be traveling to Ely, for District 8, on Thursday and then I will stop in District 12, Duluth, on Saturday and then I will have completed all my reports. I have noticed the low attendance of GSRs at these reports and I have been thinking about this. Are we clear with our communication of expectations to the GSRs? Do they understand that this is where they get the answers to their group's conscience from the voting at the Spring Assembly regarding the GSC Agenda items? I ask all DCMs to take this back to their district meeting and discuss this with them and let them know that this is part of their service responsibility. Let's try and get more attendance at next year's reports.

I have emailed my updated Delegate Responsibilities to Roger and Melissa so Melissa can update them in the Area Action book.

I received a summary report from our WCR Trustee, Tom, regarding July Board Weekend. Here are some of the highlights:

- Registration, for the International Convention registration begins on September 9<sup>th</sup> at 9 AM CST.
- Trustee Nominating Committee continues to work on the additional nsideration item from two conferences ago regarding reorganization of the General Service Board. A new subcommittee was constituted to work on it, based on suggestions from the recent Trustee Conference Committee.

- The GSB has a bit over five months to get their work done from the 69th GSC, so committees get formed, staff get tasked, objectives are set.
- AAWS reported that the web redesign continues and the app has gone through another enhancement round which includes a new search feature, Daily Reflections, enhanced menu and a messaging feature. It was also reported that the LegitScript app is progresses so the Google AdWords/Grants can be used.
- The ERP system goes live this week a major milestone for this year at AAWS.
- Contributions were a bit over \$4 million for the first six months and 4.87% higher than last year. Online contributions now account for 11.02% of contributions.
- The Trustee Conference Committee continues to work on the plan on to provide the GSC to "check the math" of items not forwarded to the GSC. It's being worked on by a committee at this time.
- With regard to PI, and A35 GSC item to discontinue YouTube, which was tabled in January until this weekend. The General Service Trustee from Montana, who chairs the PI Committee, shared that while the committee does not support the request at this time, substantial time was spent discussing the background that Area 35 submitted, and will be taking it into account as they continue their work. A formal response will be mailed to me and I will share that if received by the Fall Assembly.

More may be reported once I receive the final approved minutes from the quarterly meeting. Please let me know if you have any questions regarding these items.

The WCR will be having a conference call the week after the Forum.

  - ♦ Finally, the third AAWS recommendation that we passed was that if AAWS needed cash temporarily (between now and 12/31/19), the Trustee Finance Committee made available up to 1 million from the reserve fund and also that it has to be repaid.

I will be attending the Forum in Grand Forks in August and I hope to see a bunch of you there. It should be a great time.

After a few minutes they found out Denise and I were big WWE fans, and one of the ladies asked me if I wanted a couple FREE tickets to the event that night! WOW, absolutely YES I said. She told me she had a couple tickets she received for free and two of her friends were getting them, but at the last minute decided they did not want them. She then went to the ticket office and came back with two tickets for me.

# **Middle of Nowhere**

Last week, in front of my home, a two-year-old boy was killed and his sixteen-year-old cousin was maimed. This was done by a "drunk" driver.

According to the news reports, the driver has been in trouble a number of times.

You need to know that I live in the middle of nowhere so this accident was very unusual. My first thought was had anyone reached out to this fellow?

On the way home from the Area 35 committee meeting a friend and I discussed that no matter what happens this fellow will always have this horrendous tragedy to contend with.

It makes me worry are we (AA as a whole) reaching out to anyone anywhere? Have we relied too much on the police to arrest and the treatment centers to "treat" the still suffering Alcoholic?

I do not have the answer. The reminder (to me), is that alcoholism is a patient-never-ending-problem.

My hope is that I am living in the solution not the problem.

**Editor** - The Editorial Chair position is a two-year rotation picked by the incoming Area Chair and either approved or rejected by the Area Committee at the first Area meeting after the Fall Assembly Elections.

**Desirable qualifications:** Current knowledge MS Publisher, MS Word, MS Excel and other misc. computer programs as needed. The person should also consider the time needed to complete the task required. The candidate should have a working knowledge of A.A. as a whole, i.e., prior experience in service work such as G.S.R., D.C.M., or related position.

**N.L. COMMITTEE** - The N.L. Committee consists of two D.C.M.s in Area 35. Currently, these have been picked randomly at the start of the new rotation. They also serve on a two-year rotation basis. They assist the editor in communications with other area newsletters, in recommendations on general improvements, and with general problems and implementations of new policies. They may also represent the editor at functions when the editor is unable to attend. Seek advice and help from former N.L. Committee members and editors.

The Committee meets every other month, before the start of the Area Workshop and at Spring and Fall Assemblies. Additional meetings may be called for if needed between these times.



## Q: why list our past Delegates?

## A: They are a resource to you!

In Alcoholics Anonymous we value experience. Our Twelve Steps did not exist when Bill stepped into the lobby of a hotel in Akron, Ohio. Even after meeting with Dr. Bob and soon founding our program, there were only six steps until the experiences of 100 Alcoholics were summed up. Soon after a book followed, but it was a few years later when the Twelve Traditions were discussed and agreed on. Twelve Traditions that were "hammered out on the anvil of experience". Our past Delegates are a wealth of experience, an interactive living archive if you will. When you plan your next service workshop or need an outside voice to offer help, consider this resource available to you. Some of them even offer great company while fishing!

# The Delegate's Duties

Though the high point is the Conference meeting, the delegate's job goes on year-round and involves all aspects of the Conference structure. The delegate should:

- Remind G.S.R.s to inform groups and individuals about the A.A. • Grapevine and Conference-approved literature.
- Attend the Conference meeting in April, fully prepared. Immediately upon election, every delegate is put on the G.S.O. mailing list to receive Conference materials.
- Communicate the actions of the Conference to area committee members and encourage them to pass on this information, and the delegate's enthusiasm, to groups and to intergroups/central offices. If an area is too large for the delegate to cover in person, he or she will ask area officers and committee members to share the load.
- Be prepared to attend all area, state/provincial, and regional service meetings and assemblies. From these meetings, delegates come to better understand their own areas and can make suggestions for the Conference agenda. Here, too, they come in contact with A.A. members who might not be reached otherwise.
- Help area committees obtain financial support for the area and G.S.O.
- Provide leadership in solving local problems involving the A.A. Traditions.

- Cooperate with G.S.O. in obtaining information-for example, making sure that up-to-date information reaches G.S.O. in time to meet the deadline for each Issue of the A.A. directory and helping carry out the triennial membership surveys.
- Visit groups and districts in the area whenever possible.
- Work closely with committee members and officers, sharing experience throughout the year. After G.S.R.s and committee members have reported on the Conference, learn from these A.A.s how groups and members have reacted.
- Assume added responsibility if the area chair and alternate chair are unable to serve. Or, if an area committee is not functioning effectively, the delegate may take an active role in remedying the situation.
- Keep the alternate delegate fully informed and active, so that the alternate can replace the delegate in an emergency.
- Late in the second term, work with newly elected delegates to pass ٠ along a basic knowledge of Conference proceedings and problems.

## I 2 Traditions of Alcoholics Anonymous (Long Form)

- 1. Each member of Alcoholics Anonymous is but a small part of a great whole. A.A. must continue to live or most of us will surely die. Hence our common welfare comes first. But individual welfare follows close afterward.
- 2. For our group purpose there is but one ultimate authority—a loving God as He may express Himself in our group conscience.
- 3. Our membership ought to include all who suffer from alcoholism. Hence we may refuse none who wish to recover. Nor ought A.A. membership ever depend upon money or conformity. Any two or three alcoholics gathered together for sobriety may call themselves an A.A. group, provided that, as a group, they have no other affiliation.
- 4. With respect to its own affairs, each A.A. group should be responsible to no other authority than its own conscience. But when its plans concern the welfare of neighboring groups also, those groups ought to be consulted. And no group, regional committee, or individual should ever take any action that might greatly affect A.A. as a whole without conferring with the trustees of the General Service Board. On such issues our common welfare is paramount.
- 5. Each Alcoholics Anonymous group ought to be a spiritual entity having but one primary purpose—that of carrying its message to the alcoholic who still suffers.
- 6. Problems of money, property, and authority may easily divert us from our primary spiritual aim. We think, therefore, that any considerable property of genuine use to A.A. should be separately incorporated and managed, thus dividing the material from the spiritual. An A.A. group, as such, should never go into business. Secondary aids to A.A., such as clubs or hospitals which require much property or administration, ought to be incorporated and so set apart that, if necessary, they can be freely discarded by the groups. Hence such facilities ought not to use the A.A. name. Their management should be the sole responsibility of those people who financially support them. For clubs, A.A. managers are usually preferred. But hospitals, as well as other places of recuperation, ought to be well outside A.A.—and medically supervised. While an A.A. group may cooperate with anyone, such cooperation ought never go so far as affiliation or endorsement, actual or implied. An A.A. group can bind itself to no one.
- 7. The A.A. groups themselves ought to be fully supported by the voluntary contributions of their own members. We think that each group should soon achieve this ideal; that any public solicitation of funds using the name of Alcoholics Anonymous is highly dangerous, whether by groups, clubs, hospitals, or other outside agencies; that acceptance of large gifts from any source, or of contributions carrying any obligation whatever, is unwise. Then too, we view with much concern those A.A. treasuries which continue, beyond prudent reserves, to accumulate funds for no stated A.A. purpose. Experience has often warned us that nothing can so surely destroy our spiritual heritage as futile disputes over property, money, and authority.
- 8. Alcoholics Anonymous should remain forever non-professional. We define professionalism as the occupation of counseling alcoholics for fees or hire. But we may employ alcoholics where they are going to perform those services for which we may otherwise have to engage non-alcoholics. Such special services may be well recompensed. But our usual A.A. "12 Step" work is never to be paid for.
- 9. Each A.A. group needs the least possible organization. Rotating leadership is the best. The small group may elect its secretary, the large group its rotating committee, and the groups of a large metropolitan area their central or intergroup committee, which often employs a full-time secretary. The trustees of the General Service Board are, in effect, our A.A. General Service Committee. They are the custodians of our A.A. Tradition and the receivers of voluntary A.A. contributions by which we maintain our A.A. General Service Office at New York. They are authorized by the groups to handle our over-all public relations and they guarantee the integrity of our principal newspaper, the A.A. Grapevine. All such representatives are to be guided in the spirit of service, for true leaders in A.A. are but trusted and experienced servants of the whole. They derive no real authority from their titles; they do not govern. Universal respect is the key to their usefulness.

## I 2 Concepts for World Service (Short Form)

- I. Final responsibility and ultimate authority for A.A. world services should always reside in the collective conscience of our whole Fellowship.
- II. The General Service Conference of A.A. has become, for nearly every practical purpose, the active voice and the effective conscience of our whole Society in its world affairs.
- III. To insure effective leadership, we should endow each element of A.A. —the Conference, the General Service Board and its service corporations, staffs, committees, and executives—with a traditional "Right of Decision."
- IV. At all responsible levels, we ought to maintain a traditional "Right of Participation," allowing a voting representation in a reasonable proportion to the responsibility that each must discharge.
- V. Throughout our structure, a traditional "Right of Appeal" ought to prevail, so that minority opinion will be heard and personal grievances receive careful consideration.
- VI. The Conference recognizes that the chief initiative and active responsibility in most world service matters should be exercised by the trustee members of the Conference acting as the General Service Board.
- VII. The Charter and Bylaws of the General Service Board are legal instruments, empowering the trustees to manage and conduct world service affairs. The Conference Charter is not a legal document; it relies upon traditional and the A.A. purse for final effectiveness.
- VIII. The trustees are the principal planners and administrators of overall policy and finance. They have custodial oversight of the separately incorporated and constantly active services, exercising this through their ability to elect all the directors of these entities.
- IX. Good service leadership at all levels is indispensable for our future functioning and safety. Primary world service leadership, once exercised by the founders, must necessarily be assumed by the trustees.
- X. Every service responsibility should be matched by an equal service authority, with the scope of such authority well defined.
- XI. The trustees should always have the best possible committees, corporate service directors, executives, staffs, and consultants. Composition, qualifications, induction procedures, and rights and duties will always be matters of serious concern.
- XII. The Conference shall observe the spirit of A.A. tradition, taking care that it never becomes the seat of perilous wealth or power; that sufficient operating funds and reserve be its prudent financial principle; that it place none of its members in a position of unqualified authority over others; that it reach all important decisions by discussion, vote, and, whenever possible, by substantial unanimity; that its actions never be personally punitive nor an incitement to public controversy; that it never perform acts of government, and that, like the Society it serves, it will always remain democratic in thought and action.



- 10. No A.A. group or member should ever, in such a way as to implicate A.A., express any opinion on outside controversial issues—particularly those of politics, alcohol reform, or sectarian religion. The Alcoholics Anonymous groups oppose no one. Concerning such matters they can express no views whatever.
- 11. Our relations with the general public should be characterized by personal anonymity. We think A.A. ought to avoid sensational advertising. Our names and pictures as A.A. members ought not be broadcast, filmed, or publicly printed. Our public relations should be guided by the principle of attraction rather than promotion. There is never need to praise ourselves. We feel it better to let our friends recommend us.
- 12. And finally, we of Alcoholics Anonymous believe that the principle of anonymity has an immense spiritual significance. It reminds us that we are to place principles before personalities; that we are actually to practice a genuine humility. This to the end that our great blessings may never spoil us; that we shall forever live in thankful contemplation of Him who presides over us all.
