OFFICER REPORTS

DELEGATE- Jim

Good Morning Everyone,

As I sit here attempting to type this report, I am filled with deep gratitude for the opportunity you have given me. I would appreciate any feedback during breaks, lunch or after the meeting today as to whether you felt the report could have been condensed further or expanded for great clarity.

I want to say what an unbelievable success in terms of attendance and participation the Annual Service Workshop was. I know Steve will be commenting on this as well. It was truly wonderful to see as in the past 4 years or so attendance was around the 60 to maybe topping out at 80 people per event and this year, I believe we were around the 110 people. I am anxious to read the evaluation forms once Steve has them compiled that I hope you all filled out. I believe the presentations were well thought out and presented in a manner that kept a person's interest. I was thrilled to have the opportunity to have dinner with Cate along with Steve and Gayle.

I do have the hardcopies of the agenda items here with me along with a list of those that wanted them. My count was 14 copies, but I did make 15 in the event another DCM would like it. For anyone else that would like a hard copy it would be the responsibility of the district or group you are a member of to obtain a hardcopy. It is up on the website, thank you Rillis, for those of you who would like to download it directly to your computer. She has uploaded them by committee, so it won't be as difficult to download them. The password is gsc202035. This password has been emailed out to all Area officers and committee chairs, DCM's and past delegates. DCM's, please make sure you are getting this information to your district committee chairs and GSR's so they can relay the information to whoever may sit on their committee or to your group. Why haven't I mentioned the discs you may be thinking? Well, I couldn't find one printer who makes discs anymore. So, I believe the next best solution was to get thumb-drives. I feel confident that the vast majority of computers have a USB drive in that this could be inserted, you can then load the agenda items onto your computer. You can also take this thumb drive to any print shop to make hard copies for your district or group members quite easily. The Area has paid for these so they should be returned in June or August at the ACM meetings to myself.

The WCRAASC is next week and I hope you can all make it. I will be leaving Thursday morning as I plan to be there around 5pm Thursday afternoon. I hope those of you who had reservations at one of the previous hotels called to make sure your reservation was canceled and that a new one was made was the Big Horn Hotel. Your credit card information was not passed from one hotel to the other for confidentiality purposes, so it is important you contact the Big Horn with that information to confirm your reservation. Is there anyone here that hasn't made their reservations and needs the phone number of any other piece of information regarding this event? If you do, please see me at the break, lunch or afterwards. I am leaving Thursday as the delegates of the West Central Region meeting Thursday night with our Regional Trustee that night for about 2.5 hours. Then Friday morning, we have a Past and Present delegates meeting Friday morning. I know these can get long, but I encourage you to come and learn as much as you can. I feel this Area has done a great job in the past with sending its delegates to the GSC well informed and I look forward to that experience myself.

Between the WCRAASC and Spring Assembly we will have a chance to discuss these at our districts. If you would like myself, or you can ask any member of the Area Officers or Committee chairs if they are available to come and assist with going through them, don't hesitate to ask me. I will make every effort to accommodate you. Again, if you are interested please see me at the breaks, lunch or afterwards. I remember a gentleman wanted to set up a time for the delegate's report this summer, if he is here please come find me so we can get that set up.

The Spring Assembly will be held as it has in the past, with the whole assembly meeting in the big room to discuss each agenda item. We will take the time needed to get through them completely but try not to take more time than needed. Please remember, one of the greatest aspects of this process is that while not everyone gets to vote, everyone gets to voice their opinions, unless the opinion has already been expressed then we ask you to hold on to it. We have been at the Hibbing Park and Hotel before and I found the room suffi-

cient to conduct business in.

For those of you who have been sending in contributions to GSO, you may have noticed on the receipt you received from them a different number that your current group number. I have included an excerpt from the letter from the finance officer of the GSO, it states: the recent acknowledgement letter you received indicates a group ID, which is a unique identification number generated by our newly adopted ERP. Typically, this identifier is filled to a standardized length of nine characters by displaying leading zeros. However, these leading zeroes were left out due to a technical issue that did not manifest during our mailing's tests. We will correct this with our mailing vendor.

Additionally, for groups with service numbers from our previous system, you can still use them in your communications with GSO. While they do not appreciate on the new acknowledgements, they are still stored in our system along with the rest of your group's information.

Going forward, we will continue to research the new application to determine how to present both legacy groups numbers and ERP groups ID's where appropriate and will keep you informed of this progress.

In my conversation with Tom A about this, now that the ERP system is being utilized, it was his understanding that the legacy groups numbers will be phased out over a period, of which he was not aware of nor was mentioned in this letter and the new ERP number will be used to identify your group. Please, make your GSR's aware of this change so they will understand what the new number of their receipts for contributions are.

The Hot Topics, I have made the decision to not create the Hot Topics as they are a reflection of what I think are important and not the fellowship. Instead of printing all the background which costs money, the condensed version without background which costs money and then create a shorten version of the condensed version which also costs money doesn't make sense to me. The Hot Topics takes a 6-page document down to 3. If you feel I have made a poor decision, please let me know and I will reconsider my stance. If not, I will proceed as I am.

Greetings from your alcoholic treasurer,

I wanted to share with you my sentiment regarding our previous treasurer, Mike F. This guy has been a great example of steadfast commitment to general DISTRICT 4 - Colleen S service and I thought you all should know it. He has taken responsibility for the transfer of the treasury responsibilities in spite of some very extenuating personal circumstances in his life. He's been available every time I needed to talk to him, and has never expressed any frustration in doing so. His example is going to make it much harder for me to excuse myself from my commitment to the area for any personal reason, which is a blessing for you all, and a resentment for me.

I have yet to create and distribute any contribution receipts this rotation, but I assure you we will be sending them out during this rotation.

It occurred to me during the Service Workshop that we don't have any accountability when the area receives cash. I have made considerable changes to the system which will allow for cash receipts to change hands when the cash is received. This will serve as an agreement between myself and the person giving me the cash. We will both initial the bottom of the receipt so that there can be no question later on how much cash was received, and whether or not it was all accounted for in the system. While we're talking about this, I will also always provide a receipt from any money received or paid, and would like your help in assuring that the transaction is correct, with regards to the amount and

the expense accounts that are associated with the transaction. Two different roundups placed orders with the Cold Spring Printer last year, and we weren't notified and didn't receive the payments. I have since contacted both parties and entered invoices for them into the system so that we can be

sure not to forget about it. We agreed that the Cold Spring Printer should not take orders for Northern Light Flyer Inserts or anything else for that matter except from the Area Committee. This way we can have some control over making sure all of the transactions with them are accounted for. I will contact them and confirm this.

We discussed printing the IEC reports with all of the accounts collapsed in order to save on printing costs, but the group said they wanted to see the group contributions expanded. The next reports will have the income accounts expanded and the expense accounts collapsed.





So, THIS recovering alcoholic will continue to show up... whenever, wherever I can. Because it is PREDICTABLE that I will be better for the experience. And it is PREDICTABLE I will hear something that I need to hear today. Thanks Bob.



Why Do We Need a Conference?

The late Bernard B. Smith, nonalcoholic, then chairperson of the board of trustees, and one of the architects of the Conference structure, answered that question superbly in his opening talk at the 1954 meeting: "We may not need a General Service Conference to ensure our own recovery. We do need it to ensure the recovery of the alcoholic who still stumbles in the darkness one short block from this room. We need it to ensure the recovery of a child being born tonight, destined for alcoholism. We need it to provide, in keeping with our Twelfth Step, a permanent haven for all alcoholics who, in the ages ahead, can find in A.A. that rebirth that brought us back to life. "We need it because we, more than all others, are conscious of the devastating effect of the human urge for power and prestige which we must ensure can never invade A.A. We need it to ensure A.A. against government, while insulating it against anarchy; we need it to protect A.A. against disintegration while preventing overintegration. We need it so that Alcoholics Anonymous, and Alcoholics Anonymous alone, is the ultimate repository of its Twelve Steps, its Twelve Traditions, and all of its services. "We need it to ensure that changes within A.A. come only as a response to the needs and the wants of all A.A., and not of any few. We need it to ensure that the doors of the halls of A.A. never have locks on them, so that all people for all time who have an alcoholic problem may enter these halls unasked and feel welcome. We need it to ensure that Alcoholics Anonymous never asks of anyone who needs us what his or her race is, what his or her creed is, what his or her social position is."

Greetings Area 35,

We just returned from the WCRAASC in Billings, MT. Thank you for giving me the opportunity to attend! We met all of the 8 delegates from each area in our region and heard a brief report on what each is doing. Tom A. presented his Trustee Report. Nontrustee Director AAWS, Deborah K, gave a presentation on what is a Nontrustee Director, which was very helpful.

We had three general sessions. I've listed notes from the presentations and sharing sessions below.

General Session 1 – Attraction through Action

How are we attractive? Be sober people. In our family, workplace and communities. Being a sponsor. Being a member of my homegroup. Having commitments – everyone in AA should have a job! If you push the broom, you're the one that won. General service!

<u>General Session 2 – Recovery - Who is missing in our Rooms?</u>

Far too often, God is missing in the rooms of AA. God early in sobriety removed my obsession with drinking. That changed the focus of our meeting. We changed the focus of our meetings to God. Is God in our meetings? Is God in our Program or in the rooms with us?

We need to pay attention to that door and who is walking in, instead of our own stuff. What message am I carrying in the rooms of AA. We welcome anybody and everybody – but do they have a desire to stop drinking. We can't be all things to all people, are we serving addicts well by not asking them that question. What would someone assume are the requirements of our group if they didn't know the 3rd Tradition? What would someone assume about our group. How are we interacting with other people?

General Session 3 – Unity – Protecting our Principles
What have I found in Unity in AA? Reach out in unity. Learned by making mistakes. Do we know our Traditions and are they being talked about in meetings

Breakout Session One for Area 35 "First Timers Workshop – Focusing on AA Service Basics." - I had the privilege of moderating this sharing session with Melissa M taking notes. The attendees suggested topics and chose several to discuss, including what it means to take on a commitment, why do we receive the agenda items so late and is it appropriate for GSR's to comment on agenda items. There were newcomers and some of us that have been in service for years.

Agenda Items – Here are some brief notes from the agenda item discussion. I have much more detailed notes, if anyone is interested. Please just send me an

<u>Agenda</u> – no discussion

<u>CPC</u> – Linked In, some still don't see the benefit of this for the professionals. Pros want more info online, they lack time for one on one meetings. <u>Corrections</u> – no discussion

<u>Finance</u> – Don't understand the reason for the pie charts. Might be helpful to discuss where the need is and contribute to them. Give to groups that aren't contributing.

<u>Grapevine</u> - A lot of discussion with these agenda items – probably most discussed agenda item. Here is a sampling of what I heard.

D & E) Just say this is a fellowship that shares their experience strength and hope. How would this be offensive to transgender when they still identify as man or woman. Some groups have already made changes to this and no longer call it the AA Preamble. Teens don't identify as men and women so it doesn't apply to them. Our homegroup will probably change this for use in our group only. New York is already using "People." AAWS Literature is gender specific. All of our literature needs to come in-line with non-binary people. It has nothing to do with me. It's not all about you. I need to accept that some people are at a different place – gender identity. I may not understand it, I just need to accept that. I am absolutely opposed to changing the Big Book, this is not the Big Book. Just change to "AA is a fellowship who share…"

Grapevine owns the copyright of the Preamble. Grapevine Board thought it should have a discussion about this.

H) AA is doing its best to stay up to date with technology in the most effective way that we can. Keeping in mind the principles this program was founded on. Instagram is owned by Facebook. Some of this is authorizing FB to use our info. It's a way to grab people's attention. In favor of exploring the options. Alanon already has this. If we don't do it, someone else will. We aren't the future of AA. The future of AA is out there, on Instagram, not us. Literature

D) Great that using QR code. Young people don't look at paper. Are we using a format that young people are using. I am legally blind, this is my first time using QR code on my tablet. This can reach millions of people. Grateful to find out about it. The report was helpful to show how the message is getting out to young people.

k) Should this be in accessibilities instead of literature? Some of us have learning disabilities and need extra help. We can't read the Big Book. We get to learn these things with our sponsor. We look up words. We learn to trust God in our program. Could this be considered a translation from the Big Book? We have other translations in other languages. Who isn't available to get to a person to help them out. Solitary confinement? Bootcamp? Detox? Do any of these places have others that can help them. We have ASL, braille, large print, etc. Will a different Big Book make us different from others in the groups. CAN THIS BE ADDRESSED with a common solution – that is the question. This is worth discussing as 50% of people read at the 8th grade level. Could use both plain language translation and Big Book together. How much can we change the BB until we're no longer inspired. Bill W said the book was "inspired." The plain language translation was difficult to understand.

L) If it's not broke, don't fix it. The solution is the solution. It works. This is

the end of the Bill and Bob era. New era, want to make a whole new version of AA. Some of the translations aren't accurate. The Big Book is for the alcoholic, not the group. Would the revision of the first 164 pages be "FYE committee only" or open to the body? Most changes are FYEO. Tom never saw the 4th edition of the BB before it was published. Does this fall under article 12?

Policy/Admissions

E) In January board meeting, they went through the agenda items not forwarded to conference committee. What is the process of items not forwarded to the conference committee. Does this impede upon Concept 10. The committee looked at their items that didn't get forwarded, we looked at them again. They were looking for more information, not necessarily rejecting them.

G) Something should be done about the floor action process. Floor actions are the worst actions we can perform. At end of conference, tired and no background information.

Public Information

C) I think we investigated it and it's not working. We need to take a step back. It's not reaching the audience that we thought it would. Like to go on effectiveness. What is the cost on this?

D) AdWords: Spent a good amount of time talking about in-kind services. New reporting, we kept exploring requests that were made.. AAWS was doing what they were asked to do. A number of issues came up. Trustees Finance was asked to review the information. How are in-kind contributions treated. \$10k in kind services. IRS - must report. We first must conform to our bylaws and Traditions. Within our control we execute policy in conformance within these. We can't break the law, we must conform to the requirements. PSA's \$20m worth of free time. Traditions 6 & 7, there is an issue. The PI policy attraction not promotion. We go into competition with whomever with the keywords. "We feel better to let our friends recommend us." In kind services, that means money on balance sheets. I think this violates Tradition 7. Feel this is affiliation. We are competing with treatment centers for placement of the same ad words. Montana has tagged words like alcoholism with their hotline and meeting schedules. It was free and done by members of AA. If we build our web presence with keywords, it builds as time goes by. Not so with Google AdWords. Money is running out. I think we need to stop this program and revert back to our PI policy. Rather than cost per click.

I) Cincinnati has radio show on AA. That's a main artery for truckers that drive through. Do readings of Grapevine. Major show for AAs.

K) Questions for many years if survey was giving us accurate information. We wanted to make sure our methodology was right. Was supposed to move 2017. We want to make sure we are doing this correctly with the best technology available.

Report and Charter

B) A lot of discussion about needing directories anymore. Couple things that are important. The group is the most important, not the meeting. When we stop having directories, they will stop finding the groups. They can find a meeting, but not the group. Brooke sees great value in this. If the General Manager decides to discontinue this, do we get to review this? Treatment

B) Have worked with Bridge the Gap, it's not hard. Members go into facilities and do presentations for BTG. Not sure that needs a workbook. Bridging the Gap Chair, there was a lot of work that had to be done. A lot of trial and error so creating a workbook based on experience would be helpful. Excited about this, BTG Chair. A workbook would be helpful, to avoid mistakes. There are plenty materials to put together, already created. This may be the best way to grow AA! If a workbook helps, do it! Treatment workbook and Corrections workbook, there is information in these workbooks regarding BTG. I think we have it covered. Have been doing BTG workshops for years. Would be nice to have a guideline, not much out there.

- ◆ Keep informed of activities and issues going on within Alcoholics Anonymous as a whole. The N.L. Committee could subscribe the Grapevine or other pertinent A.A. news sources.
- ♦ Gather useful service information to publish from sources within the Area, Region and A.A. as a whole. Obtain, read and use other Area newsletters.
- Listen to comments from the Area on the content of the N.L.

EDITORIAL POSITION & N.L. COMMITTEE:

Editor - The Editorial Chair position is a two-year rotation picked by the incoming Area Chair and either approved or rejected by the Area Committee at the first Area meeting after the Fall Assembly Elections.

Desirable qualifications: Current knowledge MS Publisher, MS Word, MS Excel and other misc. computer programs as needed. The person should also consider the time needed to complete the task required. The candidate should have a working knowledge of A.A. as a whole, i.e., prior experience in service work such as G.S.R., D.C.M., or related position.

N.L. Committee - The N.L. Committee consists of two D.C.M.s in Area 35. Currently, these have been picked randomly at the start of the new rotation. They also serve on a two-year rotation basis. They assist the editor in communications with other area newsletters, in recommendations on general improvements, and with general problems and implementations of new policies. They may also represent the editor at functions when the editor is unable to attend. Seek advice and help from former N.L. Committee members and editors.

N.L. COMMITTEE MEETINGS:

The Committee meets every other month, before the start of the Area Workshop and at Spring and Fall Assemblies. Additional meetings may be called for if needed between these times.

Q: Why list our past Delegates?

A: They are a resource to you!

In Alcoholics Anonymous we value experience. Our Twelve Steps did not exist when Bill stepped into the lobby of a hotel in Akron, Ohio. Even after meeting with Dr. Bob and soon founding our program, there were only six steps until the experiences of 100 Alcoholics were summed up. Soon after a book followed, but it was a few years later when the Twelve Traditions were discussed and agreed on. Twelve Traditions that were "hammered out on the anvil of experience". Our past Delegates are a wealth of experience, an interactive living archive if you will. When you plan your next service workshop or need an outside voice to offer help, consider this resource available to you. Some of them even offer great company while fishing!

The Delegate's Duties

Though the high point is the Conference meeting, the delegate's job goes on year-round and involves all aspects of the Conference structure. The delegate should:

- Attend the Conference meeting in April, fully prepared. Immediately upon election, every delegate is put on the G.S.O. mailing list to receive Conference materials.
- Communicate the actions of the Conference to area committee members and encourage them to pass on this information, and the delegate's enthusiasm, to groups and to intergroups/central offices. If an area is too large for the delegate to cover in person, he or she will ask area officers and committee members to share the load.
- Be prepared to attend all area, state/provincial, and regional service meetings and assemblies. From these meetings, delegates come to better understand their own areas and can make suggestions for the Conference agenda. Here, too, they come in contact with A.A. members who might not be reached otherwise.
- Help area committees obtain financial support for the area and G.S.O.
- Provide leadership in solving local problems involving the A.A. Traditions

- Remind G.S.R.s to inform groups and individuals about the A.A. Grapevine and Conference-approved literature.
- Cooperate with G.S.O. in obtaining information—for example, making sure that up-to-date information reaches G.S.O. in time to meet the deadline for each Issue of the A.A. directory and helping carry out the triennial membership surveys.
- Visit groups and districts in the area whenever possible.
- Work closely with committee members and officers, sharing experience throughout the year. After G.S.R.s and committee members have reported on the Conference, learn from these A.A.s how groups and members have reacted.
- Assume added responsibility if the area chair and alternate chair are unable to serve. Or, if an area committee is not functioning effectively, the delegate may take an active role in remedying the situation.
- Keep the alternate delegate fully informed and active, so that the alternate can replace the delegate in an emergency.
- Late in the second term, work with newly elected delegates to pass along a basic knowledge of Conference proceedings and problems.

I 2 Traditions of Alcoholics Anonymous (Long Form)

- 1. Each member of Alcoholics Anonymous is but a small part of a great whole. A.A. must continue to live or most of us will surely die. Hence our common welfare comes first. But individual welfare follows close afterward.
- 2. For our group purpose there is but one ultimate authority—a loving God as He may express Himself in our group conscience.
- 3. Our membership ought to include all who suffer from alcoholism. Hence we may refuse none who wish to recover. Nor ought A.A. membership ever depend upon money or conformity. Any two or three alcoholics gathered together for sobriety may call themselves an A.A. group, provided that, as a group, they have no other affiliation.
- 4. With respect to its own affairs, each A.A. group should be responsible to no other authority than its own conscience. But when its plans concern the welfare of neighboring groups also, those groups ought to be consulted. And no group, regional committee, or individual should ever take any action that might greatly affect A.A. as a whole without conferring with the trustees of the General Service Board. On such issues our common welfare is paramount.
- Each Alcoholics Anonymous group ought to be a spiritual entity having but one primary purpose—that of carrying its message to the alcoholic who still suffers.
- 6. Problems of money, property, and authority may easily divert us from our primary spiritual aim. We think, therefore, that any considerable property of genuine use to A.A. should be separately incorporated and managed, thus dividing the material from the spiritual. An A.A. group, as such, should never go into business. Secondary aids to A.A., such as clubs or hospitals which require much property or administration, ought to be incorporated and so set apart that, if necessary, they can be freely discarded by the groups. Hence such facilities ought not to use the A.A. name. Their management should be the sole responsibility of those people who financially support them. For clubs, A.A. managers are usually preferred. But hospitals, as well as other places of recuperation, ought to be well outside A.A.—and medically supervised. While an A.A. group may cooperate with anyone, such cooperation ought never go so far as affiliation or endorsement, actual or implied. An A.A. group can bind itself to no one.
- 7. The A.A. groups themselves ought to be fully supported by the untary contributions of their own members. We think that each group should soon achieve this ideal; that any public solicitation of funds using the name of Alcoholics Anonymous is highly dangerous, whether by groups, clubs, hospitals, or other outside agencies; that acceptance of large gifts from any source, or of contributions carrying any obligation whatever, is unwise. Then too, we view with much concern those A.A. treasuries which continue, beyond prudent reserves, to accumulate funds for no stated A.A. purpose. Experience has often warned us that nothing can so surely destroy our spiritual heritage as futile disputes over property, money, and authority.
- 8. Alcoholics Anonymous should remain forever non-professional. We define professionalism as the occupation of counseling alcoholics for fees or hire. But we may employ alcoholics where they are going to perform those services for which we may otherwise have to engage non-alcoholics. Such special services may be well recompensed. But our usual A.A. "12 Step" work is never to be paid for.
- 9. Each A.A. group needs the least possible organization. Rotating leadership is the best. The small group may elect its secretary, the large group its rotating committee, and the groups of a large metropolitan area their central or intergroup committee, which often employs a full-time secretary. The trustees of the General Service Board are, in effect, our A.A. General Service Committee. They are the custodians of our A.A. Tradition and the receivers of voluntary A.A. contributions by which we maintain our A.A. General Service Office at New York. They are authorized by the groups to handle our over-all public relations and they guarantee the integrity of our principal newspaper, the A.A. Grapevine. All such representatives are to be guided in the spirit of service, for true leaders in A.A. are but trusted and experienced servants of the whole. They derive no real authority from their titles; they do not govern. Universal respect is the key to their usefulness.
- 10. No A.A. group or member should ever, in such a way as to implicate A.A., express any opinion on outside controversial issues—particularly those of politics, alcohol reform, or sectarian religion. The Alcoholics Anonymous groups oppose no one. Concerning such matters they can express no views whatever.
- 11. Our relations with the general public should be characterized by personal anonymity. We think A.A. ought to avoid sensational advertising. Our names and pictures as A.A. members ought not be broadcast, filmed, or publicly printed. Our public relations should be guided by the principle of attraction rather than promotion. There is never need to praise ourselves. We feel it better to let our friends recommend us.
- 12. And finally, we of Alcoholics Anonymous believe that the principle of anonymity has an immense spiritual significance. It reminds us that we are to place principles before personalities; that we are actually to practice a genuine humility. This to the end that our great blessings may never spoil us; that we shall forever live in thankful contemplation of Him who presides over us all.

I 2 Concepts for World Service (Short Form)

- I. Final responsibility and ultimate authority for A.A. world services should always reside in the collective conscience of our whole Fellowship.
- II. The General Service Conference of A.A. has become, for nearly every practical purpose, the active voice and the effective conscience of our whole Society in its world affairs.
- III. To insure effective leadership, we should endow each element of A.A. —the Conference, the General Service Board and its service corporations, staffs, committees, and executives—with a traditional "Right of Decision."
- IV. At all responsible levels, we ought to maintain a traditional "Right of Participation," allowing a voting representation in a reasonable proportion to the responsibility that each must discharge.
- V. Throughout our structure, a traditional "Right of Appeal" ought to prevail, so that minority opinion will be heard and personal grievances receive careful consideration.
- VI. The Conference recognizes that the chief initiative and active responsibility in most world service matters should be exercised by the trustee members of the Conference acting as the General Service Board
- VII. The Charter and Bylaws of the General Service Board are legal instruments, empowering the trustees to manage and conduct world service affairs. The Conference Charter is not a legal document; it relies upon traditional and the A.A. purse for final effectiveness.
- VIII. The trustees are the principal planners and administrators of overall policy and finance. They have custodial oversight of the separately incorporated and constantly active services, exercising this through their ability to elect all the directors of these entities.
- IX. Good service leadership at all levels is indispensable for our future functioning and safety. Primary world service leadership, once exercised by the founders, must necessarily be assumed by the trustees.
- X. Every service responsibility should be matched by an equal service authority, with the scope of such authority well defined.
- XI. The trustees should always have the best possible committees, corporate service directors, executives, staffs, and consultants. Composition, qualifications, induction procedures, and rights and duties will always be matters of serious concern.
- XII. The Conference shall observe the spirit of A.A. tradition, taking care that it never becomes the seat of perilous wealth or power; that sufficient operating funds and reserve be its prudent financial principle; that it place none of its members in a position of unqualified authority over others; that it reach all important decisions by discussion, vote, and, whenever possible, by substantial unanimity; that its actions never be personally punitive nor an incitement to public controversy; that it never perform acts of government, and that, like the Society it serves, it will always remain democratic in thought and action
