

Hello Everyone, I hope this finds you all safe and sound. I know this has been getting long for me and I am sure it has been long for some of you. I have been doing my best to see the up side and one thing I have found is that I spend a little more quiet time in the morning then I used to. It helps when your fiancé gets up at 5:15 am and leaves the house at 6 am, so I have some extra time to put into meditation now.

Since the WCRAASC I have been getting a lot of responses from the surveys. I would like to thank everyone that took the time to complete it. I have found out why the survey says it takes 4 ½ minutes, that is the average time per question, not per survey. It has been interesting checking the responses to see how many more people have done it. I do appreciate the written in responses as well. It helps to give me some idea of why you agree or disagree with a motion. This could be valuable when discussing these at the conference. Next Thursday I will have a zoom meeting with District 12 to go over the agenda items. I am excited as this will be the first time I have done this. I was in Hibbing a month or so ago before the stay in shelter restriction started and had a wonderful time. Ricco was a gracious host and I enjoyed the time we all had together. I hope those who attended felt their time was well spent.

As for the conference itself, it sounds like the actual zoom conference will be from May 16th to 23rd, but not all the days. Tom A. believes it will be about 3 days in length. I will have a joint conference call with the Trustees committee on Agenda and the Conference committee on Agenda to determine what motions will be discussed and those that won't. Being that the conference has been scaled down for several reasons, each committee will review their current list of motions to determine if something needs to be addressed sooner rather than later versus what can wait til next year. It sounds as if the zoom meeting will start around noon and end at 6 pm. I do not know what other committee meetings or elections will be held outside of those times. There will be some training sessions in the upcoming weeks I will be able to attend to help get acclimated to how this will work. I have set up a couple delegate reports so far but we will have to see if the restrictions will be lifted by then or not. I have been thinking about a Plan B in case the restriction have not been lifted. If I'm willing to listen, change my mind, that is, the answer is usually something like..."Be grateful for what you do have. What can you do to be of service to someone besides yourself? We have asked our literature folks to make sure they can deliver their inventory before making any additional purchases. The Area recently purchased a Zoom subscription so we can continue to hold regular meetings. We have retained all of the expenses typically associated with the Area Assembly.

In the month of April so far this year, we have seen a 86% decrease in contributions compared to April of last year, an 89% decrease compared to last month. I know this sounds pretty grim, but we've also seen a significant decrease in expenses to the Area, 82% less compared to last year, and 84% less compared to last month. So our bottom line for the month of April (-\$659.48) is actually 87% better than it was last year during the same period (-\$5,125.64). For the period of 2/16/20 - 4/20/20 we are pretty much in the same shape as last year, 3% better actually. I have included an additional report showing these details. This has been a challenging time to Cooperate with the Professional Community.

Hospitals have been overwhelmed with Covid-19. Treatment centers not allowing people in or out to meetings. Churches are shut down. Everybody has been concentrating on the Covid-19.

I think about how difficult it would be to try and sober up during this "Shelter in Place".

When I first quit drinking I went to meetings almost everyday. If left to my own desires I would of isolated myself. That is a natural and easy choice for me. Feeling I don't fit in is easy to isolate.

A friend reminded me the other day how Bill W. and Dr. Bob did whatever they needed to do and had very limited resources when working with other alcoholics. We also have to use the resources that are available. I find it difficult to keep myself and people I sponsor focused on our recovery and working with others. It's easy to not do the work when we have to change how we work with others and change how we used to do it

We need to try and reach out with the phone calls and get to the people that make the decisions. Get their emails and contact info and start reaching out with those resources.

We still have more resources than Bill and Dr. Bob ever had. Through online research we can gather information on treatment centers, Judges, Juvenile detention centers, whatever other Social programs are out there. I encourage each district to gather the information and start their own database of contacts.

This could be useful for future CPC/PI people who come into your position when you leave.

The new CPC/ PI representative will not have to start from scratch everytime. Yours in service, Brian P.

Greetings all, I would like to open this by expressing how much I appreciate the opportunity to serve and the trust that has been placed in me by Area 35 and its members.

Essentially immediately after taking the position the Coronavirus spread throughout the nation and quarantine procedures were introduced. Many of our awesome meetings were forced to temporarily cancel, and it became extremely important to document and spread this information

Almost daily I was receiving reports of meetings being cancelled and was updating the calendar and document on the Area home page. In the last couple weeks this flow of communication has slowed. I am expecting at the end of the quarantine when the meetings rev back up the flow of information will continue again but with opposite positive information rather than closings.

After accepting this position, I immediately removed the footer from the webpage that stated: "Powered by WordPress". We Could Blow the Whole Thing

What if suddenly there was no AA? If, in some nightmare future, AA groups forgot all about the Twelve Traditions. . .

NOTHING IN my life had prepared me for the six months through which I had just lived. Not my education, not my drinking, not my recovery in AA. I'd been assigned to the field as a representative for my company, to oversee the operation of an experimental system for mining copper in South America. It meant spending exactly 180 days cut off from civilization, living and working with a hard-drinking bunch of men from everywhere, assembled for the project.

Fresh from the office, a lovely home and family, and an active life in AA locally, I was suddenly thrust into a dark and treacherous existence in a jungle camp, thousands of miles away.

Right from the beginning, it was every man for himself. There were bosses and sub-bosses, some of whom knew only the authority born of physical violence. Cliques were everywhere, and because of the extreme isolation, men's nerves wore thin. Recreation ended in drunken brawls almost every night. In the morning, sick and hung over, everyone got back to work.

I kept asking myself, "What's a nice AA like you doing in a place like this?"

At the end of my stint, there was only one thought in my mind: How fast can I get to a meeting? As it happened, there was a day's layover on my trip home, and I knew there'd be a meeting *somewhere* nearby.

I remember the feeling of excitement as, in the rented car, I pulled out of the hotel parking lot. My *International AA Directory* was safe at my side, and my anticipation grew as I found the street, and then the address of the meeting.

What a welcome sight that church was, as I walked briskly to the side door.

I could almost smell the coffee, and I reached for the handle.

The door was locked. In fact, there wasn't a sign of life anywhere. I checked the directory, and it showed clearly I was in the right place. A glance at my watch told me the meeting scheduled should begin in ten minutes. I scratched my head--where was everyone?--and I walked back to the car.

I stood on the street for a few minutes more, and when no one appeared, I shrugged and got in, and turned on the light. Well, I thought, there should be another meeting somewhere nearby. Looking down the list, I found a Step group across town. Within a few minutes, I pulled up to a large church, its lights beckoning everywhere. My enthusiasm was short-lived, however. A thorough search of the parish house revealed a number of empty rooms, one vestry meeting, and no AA to be found.

The eerie feeling that had begun to grow in me now turned to anger. What the heck was going on here? I left the church and headed my car back out of town, toward my hotel. As I drove, I ranted and raved. Some way to treat a visitor! I was sure nothing like this could ever happen back home--we knew how to keep AA together a lot better! I was halfway through the blistering letter I'd fire off to the AA General Service Office upon my return home, as I pulled into the hotel lot and went to my room. Still grousing, I went to bed.

The next morning, as I stepped out of the shower, I hadn't shaken off the indignant rage that haunted me. On an impulse, I looked at my watch. It was about half past ten in New York, and I knew GSO would be open. I picked up the phone, not trusting my anger to last till I returned home, and placed the call.

The operator and I listened to the recording: "The number you have reached is not in service at this time." My shock was indescribable. A verifying operator obtained the same message, and I hung up. Now, for the first time, I was genuinely afraid. There was obviously something really wrong, and I wasn't sure I knew what to do. Funny, all I could think of was that old saw "Don't drink, and go to meetings." What a laugh! Later, I turned the car in at the airport and boarded a plane for home, arriving late that evening.

Naturally, the first thing I did when I was settled in with my family was to get on the phone to some of my AA friends. There was no one home anywhere I called, and I felt the oddest sensation. I was suddenly in the *Twilight Zone*. Everything I knew about the AA program, all the tools I'd been using for the past few years, were suddenly gone!

The next morning, I was out early, and I drove to the roadside coffeehouse that had become the unofficial AA club. It had always provided an all-day meeting, of sorts, and surely *there* someone could tell me what was going on.

There was only one car in the parking lot. I walked inside, and I saw only George T., who owned the place, sitting at the end of the counter. He greeted me warmly. "Well, hello, buddy. Where've you been? It's been an age since I've seen you!"

I shook his hand eagerly but decided to skip the small talk. "George, what's going on?" I began at the beginning and told him of all the strange things that had happened to me.

George never really changed expression, and when I finished my tale, he just looked at me. Then, staring into his coffee, he said, "Y'know, buddy, I'll bet you're the last guy on earth to hear the news, and I'm sure sorry I gotta be the one to tell you. It's all over, buddy--AA is just a figment of your alcoholic imagination now. It's all gone."

"Just that, buddy. There is no more AA--not here, not anywhere!"

"But--but how can that be?" I stammered.

"Well now, that's a long story," George said, like a man retelling something for the umpteenth time. "It was a case of benign neglect, I guess you could say. Sorta slow, like a cancer, it was. You know, there was always lots a groups-thousands of them--and folks to carry the message all over the place. And that GSO office in New York to send out stuff. Who'd ever think a thing like that could just fall apart? But y'know, buddy, that's just what it did. It just went to seed and died,"

I couldn't speak. I just stared openmouthed at George.

After a minute, he went on. "I guess it was in the spring, just after you left on that trip of yours, that we got a letter from New York appealing to all A As for help. They said it felt like they were under attack from all sides, and the structure was beginning to fall apart. That rash of anonymity breaks, y'know, that started last fall--and that national telethon didn't help, with all those AAs getting their faces on TV. Seems like all our friends at the churches just started closing out our meetings faster than we could get new places. Didn't want any part of the 'new AA,' they said!

Then, in April, there was that last General Service Conference. Boy, it must've been something! See, there was this bloc of delegates that got together, nobody seemed to know how, and just *took over*! They said it was about time the *real* group conscience had its day. Threw out the whole board of trustees and did over the whole general service structure. Yep--they really did it, vote by vote. What a bunch of supersalesmen! Of course, they were only the tip of the iceberg. It turned out they had a regular organized bunch of drunks all over the country.

"Well, the rest was predictable. Before you could blink, they sent out a long 'restructure bulletin' from this new World AA Office, and they laid down a whole set of rules and new procedures, and began to badger the groups for pretty heavy 'donations.' In a few weeks, almost a third of all the groups in the whole Fellowship had already folded. They died like flies! The rest were all confused and couldn't cope with the load, plus all the bickering that broke out. Finally, I guess everybody just gave up. There've been some halfhearted attempts around town to keep It going, on an independent basis--y'know, in homes, here at the club--but believe me, it just ain't the same, if you know what I mean. Nobody feels like a *part* of anything anymore"

George blinked. "The Twelve what?" he asked. . . .

Of course, it's all a fantasy. I'm not even a mining engineer. And one thing I've learned in AA is not to be an alarmist. Still, around the groups I attend, it *does* seem that we A As sometimes get a little funny about the Traditions. That's what prompted me to wonder: What would happen if we *all* decided to let somebody else safeguard these twelve foundation stones?

If you woke up one morning, and found there was simply *no more* AA, where would that leave you?

Yeah, that's the feeling I got, too.

Thoughts from the Fellowship

For me, the global pandemic wasn't real until the day I found out my Alano Club was closed.

I felt extreme panic because, like most of us, my solution starts and ends with a meeting.

Those first few days were a flurry of Facebook invites, copy-and-pastes and Zoom troubleshooting. I was relieved to see there were AAers ahead of the game, creating spreadsheets and resource lists, and emails and invites poured in from all over.

I made it through those first few days by thinking of others, reaching out and checking in. Sharing all the information through all the platforms. And when the dust settled, I had to get knee-deep into the basics. Calling women, sometimes 10 a night. Doing daily gratitude.

An hour's worth of guided meditation before I could even think straight. I was in my daily readers again.

It felt familiar, reminding me of my earlier days in recovery, grasping at suggestion with wild desperation, only this time, I had faith in the work and its workings.

I thought I was doing OK until I saw my sponsor's face during an online meeting. I sobbed through it all in relief to "be" there, and to see the comforting faces of my Friday-morning meeting people, who have watched me recover from alcoholism.

I cried during a lot of them in the beginning. Frustration, grief, relief, love. Seeing the fellowship do its thing was something else, too.

We started a gratitude thread. Women added women, some of them newcomers. My heart went out to them, not knowing what I would've done if I'd gotten sober at a time like this.

I invited one woman to a walk with another AA. She canceled last minute, and I wondered if I would've had the courage for the added pressure of hanging with total strangers outside the structure of a meeting.

What's been a great joy during this is watching another newcomer fight for his life.

I'd been in in-person meetings with him before everything shut down, and he always shared with a raw honesty, the kind that saves our lives. A couple of months sober, he's doing the work. Steps, sponsorship, fellowship.

During Zoom meetings, I see him smoking, playing guitar, petting a cat. Scribbling away in a notebook. All the mindful, soothing things that help you stay present and best of all, remember.

Reminds me of early recovery, and the gift of desperation. The gift that has again landed flat in my lap.

I had suffered through a life ending viral infection 6 years ago, and I am not sure if my body could be revived and survive it one more time, let alone go through the months and months needed to recover from another horrible virus. My problem? Some of us who suffer from depression don't like to be alone in our own world. I was not a very happy person. I have several years of sobriety and here I was, feeling sorry for myself. I wasn't trusting my Higher Power or thinking about other AA's at all. I really needed meetings, but that wasn't possible due to the shut down because of the Daemon from the Deep Black Hell. Then along came a few people with enough smarts and ambition to start Zoom AA meetings. I was miserable and desperate enough to give it a try. It turned out to be my salvation. I was going to many AA meetings each week before the virus, but these Zoom meetings are available everywhere, anytime and on any subject imaginable! I get to meet new people and hear new things, while still Zooming my regular weekly AA meetings. What a blessing for newcomers to be able to reach out, and what a blessing to get to be there for them. I will be forever grateful to those people who have spent time and resources setting up these meetings and continuing to make them available as regular meetings throughout this viral blip in our lives. I don't feel so desperate, lonely or selfish anymore.....OH, the wonders of our AA Program!

Parting thoughts as WCR Trustee

By invitation from the Northern Light Editor, I'd like to share some parting thoughts in my waning days of service as West Central Regional Trustee. Rotation will take place at the 70th [virtual] General Service Conference, where one of the seven past delegates standing for election will succeed me. Our eight current delegates in the West Central Region (WCR), along with four delegates chosen at random from the Conference Trustees Committee and four trustees from the Trustee Nominating Committee will be the voters for this election.

I look back to when I received the call from our delegate Kelly D. in 2016 that my name had come out of the hat. I had never envisioned it ever even making it into the hat, so I was a bit stupefied to find out the results. It seems that even though I had known all the trustees dating back to the late 1980's and saw the service they provided, I suddenly didn't seem to effectively grasp what I was about to undertake.

Between April and July, when I was to attend my first General Service Board (GSB) meeting, I was informed about three GSB committees I was assigned to, and also was placed on three sub-committees, one of which I was to chair. Yes, a bit of the "baptism by fire" if you will. At that first board meeting, on the first day, we had a brief orientation on fiduciary responsibility, a finance orientation, and a couple other items I am but dimly aware of and have little recall. I quickly discovered that the GSB runs on a robust committee system and always tries to accomplish a week of work in a weekend.

The October Board meeting in Rye was right after the World Service Meeting. I had some lasting experiences meeting world service meeting delegates from all around the world. One interesting result of those new friendships was a number of requests for information on the Concepts.

One of the more poignant memories of year one was that at the January Board meeting, I made a video presentation of a minority opinion on an agenda item that came out of the Public Information Committee, where I was a member. The vote was 19-1. It likely set the stage for other votes of similar nature. I had to accept the group conscience, but the GSB always gave me the opportunity to be heard.

In my first year I also was a member of the Trustee International Committee. It was one of the most mind-changing committees during my four-year tenure. Approaching it in the first year, trying to find ways to eliminate expenditures for this committee and to keep our AA dollars focused on services locally, I came to appreciate how, with relatively few dollars from our overall budget, A.A. has the opportunity to carry the message in some incredibly large-scale ways. Also, to see what was happening in countries were A.A. is newly-established showed how much you can do with so little, and how passionate these new countries' memberships were in spreading the A.A. message. In fact, I came to realize how much we could learn from them.....

My second year had committee changes, two of which I've been on for the last three years — Finance and Nominating. Over the course of the three years we've had a broad spectrum of important issues take place on these committees, and I will always be grateful to have been a participant. For example, Nominating has been working on evaluating and considering changes to the GSB that will make it more effective in service to the fellowship. Finance has been wrestling with how to divest ourselves of the large liability on our balance sheet, the pension plan.

There's no doubt that the Printers Copy Manuscript issue that took place over the first and second year proved to be very trying and was easily the most divisive issue during my tenure. Between the challenges during the process as well as the 2018 General Service Conference's discussions on the issue, my serenity and peace of mind were challenged.

The second and third years also brought on a second position: being a director for an affiliate. In a rare departure for a WCR trustee, I was seated on AAWS's corporate board. This doubled the travel to NYC and more than doubled the workload. The hallmark experience is how embedded I was in the operations of AA. Several committees and sub-committees, plus I had the opportunity to be the inaugural chair of the AAWS Internal Audit Committee and I chaired the DELTA Committee, which was put into place to evaluate the literature sales and pricing process.

Year three had me chairing my first Trustee Committee: Nominating. This brought with it an extra benefit, which was the process for selecting two new Class A trustees. This will also go down as one of the best memories of service as a trustee. I was also seated on Trustee International Conventions-Regional Forums, and with the 2020 International Convention looming, I knew it would be a challenging place to serve.

Participation in Regional Forums will also carry lasting memories. I had the opportunity to chair two in the West Central Region. As a region we introduced a process to forums that coordinated meals with trustees, nontrustee directors and staff members with the AA members attending the forum. It became a huge success not only in our region, but it is now being embraced by other regions, too. I also had the chance to be the AAWS director to the Eastern Canada Regional Forum in 2018. One of the most notable memories of that was I was a 2nd-language attendee, as we were in the heart of French-speaking Quebec and wearing a headset for the weekend for translation proved to be an eye-opening experience.

It was a big transition from year 3 to year 4. That is because I left AAWS, which was 60+ percent of my time in service as trustee. However, what I thought was going to be a quieter fourth year didn't occur. I had become part of a committee in my third and fourth years with the goal of improving the orientation process for new trustees. I was tasked with a myriad of writing and presentation topics for orientation. And just when I thought I was done after the July orientation in 2019, I was asked to stay on to help author an orientation manual. Hence, my fourth year can be characterized by a extended writing projects, and I'll barely get it all done by my final GSC in May.

I recently wrote an article for an intergroup newsletter about my experience as a trustee serving the eight delegate areas in the WCR. I won't go into detail on that facet of service, but I want to note it as the highlight of service as trustee. I've had the opportunity to visit all eight delegate areas, some as many as three times, and the spirit of service surely pervades all the areas.

So many "lasts" have been occurring over the past year, and just a couple weeks ago I had my last Board weekend. I must note to everyone that it takes a bunch of drunks on the GSB to label a period of Wednesday to Monday as a "weekend". So a word of warning to those of you who may become the WCR regional trustee: delusion still can run rampant, even on the GSB!

I bid you farewell as the WCR trustee. Area 35 provided three fine delegates that I had the opportunity to serve with over the past four years. It is now time for me to return to my home group and stand by the door, make coffee, and serve were asked once again --- just the way you do, too. I am grateful to have been of service to Area 35 and the West Central Region.

Editor - The Editorial Chair position is a two-year rotation picked by the incoming Area Chair and either approved or rejected by the Area Committee at the first Area meeting after the Fall Assembly Elections.

Desirable qualifications: Current knowledge MS Publisher, MS Word, MS Excel and other misc. computer programs as needed. The person should also consider the time needed to complete the task required. The candidate should have a working knowledge of A.A. as a whole, i.e., prior experience in service work such as G.S.R., D.C.M., or related position.

N.L. Committee - The N.L. Committee consists of two D.C.M.s in Area 35. Currently, these have been picked randomly at the start of the new rotation. They also serve on a two-year rotation basis. They assist the editor in communications with other area newsletters, in recommendations on general improvements, and with general problems and implementations of new policies. They may also represent the editor at functions when the editor is unable to attend. Seek advice and help from former N.L. Committee members and editors.

N.L. COMMITTEE MEETINGS:

The Committee meets every other month, before the start of the Area Workshop and at Spring and Fall Assemblies. Additional meetings may be called for if needed between these times.

Money and Spirituality

Where money and spirituality meet......

Over the past month I have had the opportunity to hear some financial reports from both the Area and GSO. Neither have sounded good in terms of 7th tradition donations. I know my home group hasn't had much in the way of 7th tradition donations as well as we simply aren't meeting. But, that doesn't mean that these groups do not still have bills to pay and the monies that each of them have are being used up to pay these bills. Currently, my home groups checking account hasn't been this low in the 25 years attended this particular meeting, the Area still has money but mainly because we canceled the Spring Assembly, there were very few physical meetings on the agenda items and there won't be any real expense for the service conference, but the Northern Light is still operating at full steam everything other month to bring you the news of what is happening within the Area and any news from GSO. GSO is still moving along as best it can even in these times. But, it still has bills to pay. I'm sure the reader of this article knows plain well I am talking about needing money for these groups as well as district. And that is exactly what I am doing. I am still benefiting in some way from these groups but I am not currently supporting them through my contributions. I need to ensure these groups are still financially stable to provide the services they are during these times, not just so they are there for me, but we still have people looking for AA. In a phone conference with the Regional members the other day, it was decided that GSO would need to draw down 3 million from our cash reserves to be able to pay bills through the end of JUNE, not the end of the year but through JUNE because donation are down about 50% and literature sales are down about 75%. The Area which if I recall from Justin's report has about \$1,200 in monthly donations during this time, and he has seen a couple hundred. We can individually donate to any of the groups, Districts, Area or GSO. While it is always best to go through the group so they represent a group conscience decision about how best to donate, we can do this on our own. I realize 3 million is a large number, but put into perspective, with a fellowship of 1.3 million it would only take \$2.30 on each members part to recoup that money. Even less for the Area to get on track. Same with Districts and Groups. So I encourage each and every one of you to do what you can for these entities so they are still functioning for the still suffering alcoholic when we all can get back to meetings. Jim S.

- 5. Why is the event taking place?
 - The reason for AA events is to carrying the AA message to the still suffering alcoholic (this doesn't have to be printed on the flyer)
 - b) Usually covered in Who and What



Q: Why list our past Delegates?

A: They are a resource to you!

In Alcoholics Anonymous we value experience. Our Twelve Steps did not exist when Bill stepped into the lobby of a hotel in Akron, Ohio. Even after meeting with Dr. Bob and soon founding our program, there were only six steps until the experiences of 100 Alcoholics were summed up. Soon after a book followed, but it was a few years later when the Twelve Traditions were discussed and agreed on. Twelve Traditions that were "hammered out on the anvil of experience". Our past Delegates are a wealth of experience, an interactive living archive if you will. When you plan your next service workshop or need an outside voice to offer help, consider this resource available to you. Some of them even offer great company while fishing!

The Delegate's Duties

Though the high point is the Conference meeting, the delegate's job goes on year-round and involves all aspects of the Conference structure. The delegate should:

- Attend the Conference meeting in April, fully prepared. Immediately upon election, every delegate is put on the G.S.O. mailing list to receive Conference materials.
- Communicate the actions of the Conference to area committee members and encourage them to pass on this information, and the delegate's enthusiasm, to groups and to intergroups/central offices. If an area is too large for the delegate to cover in person, he or she will ask area officers and committee members to share the load.
- Be prepared to attend all area, state/provincial, and regional service meetings and assemblies. From these meetings, delegates come to better understand their own areas and can make suggestions for the Conference agenda. Here, too, they come in contact with A.A. members who might not be reached otherwise.
- Help area committees obtain financial support for the area and G.S.O.
- Provide leadership in solving local problems involving the A.A. Traditions

- Remind G.S.R.s to inform groups and individuals about the A.A. Grapevine and Conference-approved literature.
- Cooperate with G.S.O. in obtaining information—for example, making sure that up-to-date information reaches G.S.O. in time to meet the deadline for each Issue of the A.A. directory and helping carry out the triennial membership surveys.
- Visit groups and districts in the area whenever possible.
- Work closely with committee members and officers, sharing experience throughout the year. After G.S.R.s and committee members have reported on the Conference, learn from these A.A.s how groups and members have reacted.
- Assume added responsibility if the area chair and alternate chair are unable to serve. Or, if an area committee is not functioning effectively, the delegate may take an active role in remedying the situation.
- Keep the alternate delegate fully informed and active, so that the alternate can replace the delegate in an emergency.
- Late in the second term, work with newly elected delegates to pass along a basic knowledge of Conference proceedings and problems.

Resting on our Laurels

How are you doing in this troubled time? Finding meetings and staying sober? Are the Traditions still in your recovery? Still trying to live by the principals AA has presented to you? Why am I asking these questions?

I was thinking what will Alcoholics Anonymous look like after the Covid-19 shelter in place restrictions are lifted. AA has been shut down over the whole country for the past seven weeks (as of this writing). There are roughly 66,000 registered Groups in the United States and who knows how many unregistered meetings. How many will reopen? How many people will attend meetings? It won't be like a light switch and everything is back to how it was. How long before people feel comfortable gathering even after the shelter in place restrictions are lifted. The hat or the basket at meetings will be light because many people's lives have suffered catastrophic financial hardships. It will be slow going for getting Groups back to a regular flow. It could take three or six months even a year or more before AA Groups return to some semblance of normalcy.

It's been seven weeks now since my home Group has held a meeting in a building and able to pass the basket. With a possible three more weeks of isolation. If you extend that to 66,000 Groups that is a lot of contributions not being sent to the GSO. Like you and me, we still have bills to pay even if no cash is coming in. I know from experience. Being laid-off over five times in thirty-nine years while I was working in the mines. Twice for the duration of two years. I owed bills for the house payment, car payment, groceries, and utilities that still needed to be paid. I understand the hardships of meeting expenses.

GSO has rent, payroll and other expenses that still need to be paid, even if Groups are not sending in contributions. Along with lack of book sales GSO is looking at severe financial troubles. Expenses are outpacing income at an unsustainable rate. GSO only has a nine-month operating prudent reserve. They have burned through two months of that already with Groups being shut down for roughly two months. What happens if there is a resurgent? We have a long and hard road ahead.

Picture if you can what AA would look like if GSO went bankrupt. No General Service Office. No Works Publishing. No General Service Conference. How would AA be united? What about the offshoot of AA's wanting to take God out of AA's recovery program? What about people and Groups that believe a drug is a drug and everyone with an addition is welcome? What about the faction of Groups wanting to rewrite the Big Book? What about Areas wanting to take monies from Google and have a strong presence on the Web and social media. It would be utter chaos to rebuild a new General Service Office and Conference. AA would no longer exist, as we know it today. It takes all three legacies for Alcoholics Anonymous to function Recovery, Unity and Service.

Sure there are some out there who say, "Who cares we don't need GSO". Heck, I've had my disagreements with GSO, but I still want a GSO to disagree with. Without Works Publishing who would print your Big Book, 12X12, Daily Reflections and other AA literature? Without Works Publishing instead of Big Books costing \$9.50 they would run about \$25 to \$35 or more to purchase from an outside publisher and buy at a retail outlet. With no GSO who would answer all the calls for help, distribute literature.

It's easier to stop the bleeding now when there's just a small scratch then in a few months and we could have a major hemorrhage. Now is the time to act on Tradition 7 which states, "the hat is where spirituality and money mix". There are solutions to this dilemma. I hate to give more than two choices pink or blue (cotton candy joke).

We can say, "Whatever God's will is for us, so be it, or it will all work out in the end and let AA go bankrupt and see where the chips fall".

This would be a great time to send in a personal contribution to GSO. If every person in AA sent GSO \$2.00 a month until this Covid-19 pandemic is over then we would remain solvent. Or, you as an AA member, can just send a contribution to GSO in any amount up to \$5,000 or as little as \$1.00.

Now is a great time to use and send a birthday contribution. I was at a speaker meeting a while back. The speaker stated he had heard of Birthday contributions when he was first sober. Years passed and he got into service and once again heard about Birthday contributions. Since he never started, he decided he would pony up and start from year one. Well, he had over 25 years of sobriety when he told his story and he said it was a contribution over \$351 and that it's always easier to start at the beginning than play catch-up. Well I just did the same thing. I always gave more than a buck into the basket so figured that was enough. Especially since the Group sent monies to the GSO, I figured I was covered. Well now, that isn't the case. I ponied up and showed my gratitude with a Birthday contribution from year one to now 39 years later.

Why all this fuss about sending contributions to GSO? When you put money into the hat/basket it belongs to Alcoholics Anonymous. The Area will be OK for the next six to eight months. Districts will be OK for a few months for the same reason. GSO on the other hand, the heart of AA, is on the verge of being in dire straights or possibly Bankruptcy.
