

Greetings Area 35, It's been a quiet couple of months. My husband had another spine surgery 3 weeks ago so we've been focused on that. My home group is still meeting via Zoom and I continue to host an afternoon women's meeting each Friday at noon via Zoom.

DCM's, thank you for continuing to send your district minutes to me! I enjoy reading about what everyone is doing in their districts.

Please send me your reports for the meeting minutes, which will also be published in the next issue of the Northern Light. Reports are due Sunday, Aug 9. Thank you for the opportunity to be of service, Heidi B.

TREASURER – Justin W

Greetings Folks, I sure do miss getting together in person with all of you. I guess they say something like... "you don't know what you had until it's gone." I was hoping we could find a way to meet in person and host the ACM over zoom this time. Maybe next time. I sure hope you're all huggers for when we can get back together.

I'm going through some personal things at the moment and I can clearly see how every little thing I've ever done in Alcoholics Anonymous has amounted to the daily reprieve I now have, 24 hours at a time. I am extremely grateful for this opportunity to serve you all.

Contributions to the Area are picking back up; \$1605 this month compared to \$750 last month. While it's less than half of what we received last year in July, it is an indication that things are going a bit better for the groups in the area. Overall for the period, we've seen a loss of about \$600, compared to about a \$5k gain for the same period last year. This is partly because we received less than half of the contributions and had significantly higher expenses. The Delegate's Fee for the GSC was paid this period, as well as the mailing Sally did and a new computer for the NL Editor.

Since there was an agenda item regarding "the mechanization of contributions to the entities", I thought I'd share a little about what I learned in my home group a few years back. Our group treasurer at the time had a really clever way to figure out what we (the home group members) needed to contribute to the group on an individual basis each week, which really cleared up my confusion at least. We took our group budget for the year and divided it by 52 weeks, then divided that by the number of home group members, and viola.... \$7 per week. If we take this same idea and apply it to the area, it looks like this....

64,346.88 / 52 = 1237.44 per week / 277 groups (# of contributing groups from 2019) =

\$4.47 per week per group \$19.36 per month per group \$58 per quarter per group \$233 per year per group

The groups (once you approve the budget) will have agreed to contribute along these lines to Area 35 so we can render the services you have asked for. We have about 540 registered groups in Area 35, but only 277 of them are "home group members" for the Area. That's 51% of known groups contributing to the Area from 2019. This is at least a good starting point, certainly better than anything we could ask for in a pamphlet that couldn't possibly take our budget into consideration. Obviously understanding the financial reports will further help with the decision. When deciding how much to send to the Area, my home group will always ask the question, "How is the Area doing financially?" Hope this helps.

Thanks so much to all of you for this opportunity! It saves my life on a regular basis. Justin W (see page 8-11 for financials)

Since the Area 35 committee meeting the work continues...

Good morning Everyone,

I hope this email finds you safe and sound these days. I don't know about you but I was hoping we would have been back to normal by now. But that is not the case.

Since the August ACM, I have presented my delegate's report twice. Once in Isanti, MN with districts 5 and 6 on August 16th at the Isanti Alano club. We had quite a few people there, I would say there must have been around 15 people in attendance and 4 in zoom. We had a lively discussion about the agenda items and had some great food. Thanks to everyone that helped put that event on. Next, I headed over to Duluth for their district meeting. There were 13 in attendance I believe and unfortunately the church's internet was not cooperating so we didn't have any in zoom. Thank you to everyone who attended and helped bring in food as well. I thought both reports went well, and everyone helped create a lively discussion about the agenda items. Most of all, it was simply great to get out and see everyone. I am not a solitary person and much prefer to see you all as I have been so long. I will be off to Albany, MN on Sept 14th for my next delegate's report. I will send out the zoom information for that meeting a in the coming week.

On August 15th I sat in on a financial report presented by GSO. It was about 2.5 hours in length. Group donations to GSO have picked up some, while literature sales have but not to the extent as donations have. The 2020 budget has been re worked and about 3 million in expenses have been reduced, such as occupancy expense since no on is in the building, water, electricity, office supplies, etc are down, travel isn't occurring so that is down, some staff have been given the opportunity for early retirement which they had til Aug 31st to make that decision. The staff deciding on retirement is not included in the 3 million reduced budget currently. I emailed about the power point and pdf report of the presentation the following week so I hope you had a chance to see it. I will send it separately to Cindy for her to determine if there is enough room in this edition of the NL for inclusion or not. At the time of the report, GSO believes that 95% of all registration fees for the 2020 International have been returned. There are some checks that they received they have not been able to follow up on. One positive thing that came out in the report is, GSO purchased an insurance policy for the international for \$51,000.00. As a result of the convention, we are in negations with the underwriting for a settlement between \$2.4 and 2.9 million, of which \$971,000 has already been paid to us. This will greatly help in paying bills throughout the rest of the year. One thing that was commented on that I was not in favor of, the prudent reserve was re calculated after the reduced budget was created.

The prudent reserve is at 9 months after this recalculation. I am not in favor of this as when GSO reopens at full steam and our expenses go back to "normal", our prudent reserve will be low and a request for donations or rise in literature prices will most likely occur. It seems to me we should have left the initial prudent reserve figures to give the fellowship as much time as possible to address the shortfall from drawing down the 3 million from the reserve earlier this summer. In the end, GSO presented itself as doing ok financially, that doesn't mean we should stop or reduce our contributions. If we want the GSO to continue providing the services we have requested from them over the years, we need to ensure they have the funds to continue doing so.

I hope to see you at the Fall Assembly.

Howdy Ladies and Gentlemen,

I went outside in the evening a week and a half ago (Aug 28) and felt the first hint of fall in the air. Time sure goes by fast. Are you ready for the season change? The Fall Assembly is coming up fast. It will be interesting to see how many GSR's, DCM's and Area Officers and Committee people feel comfortable attending the Assembly. I know Gayle and the Hotel are doing everything they can to make this event safe for us. I'm registered at the hotel, but I'm still keeping an eye to the Covid stats to see if I will attend. Another possibility is to be able to Zoom the Assembly. I know Gayle is working the kinks out of that scenario.

I recently attended the first Zoom for Alt Delegates meeting. There were about fifty-five in attendance from Alaska to Texas and Hawaii to New York and about half of the Canadian Areas. Quite interesting. It was as chaotic as any AA business meeting, I say that in a loving way. Make a motion and people want to tack on four different ideas. We'll get it together as we go. Just so, you are aware, these are the COVID restrictions we are currently facing:

All attendees must be at least 6-ft. apart.

We can seat people classroom style, however, only one person can be seated to every 6-ft. table, and every 6-ft table needs to be 4-5 ft. a part.

Maximum capacity classroom style in our entire banquet hall is going to be 84 people only, so we won't be able to accommodate 125 people if these restrictions don't change by January.

All attendees must be wearing a mask at all times unless seated eating or drinking.

All food and beverage must be individually served. We cannot have water or coffee stations, and all AM break and PM break snacks must be plated and served.

No registration tables to avoid congregating.

After some negotiation, we can have a registration table provided everyone follows the 6-ft separation guidelines. There will be no group water pitchers because the Covid-19 is an air borne pathogen. Water bottles will be available in a cooling trough at a price of \$2.00 ea. Coffee will be available at \$6.00 a carafe on Saturday and we are trying to figure out what to do for Sunday, because that is such a short day.

Because of the reduced capacity imposed by the hotel and possible lower turnout, I am currently renegotiating the hotel room minimums for a discount on the main meeting room. I'll keep you posted.

The topic of the 2021 workshop will be "A.A. in a Time of Change". The Saturday night speaker will be Ken B., past WCR Trustee from Nebraska. Racy J., who runs the PI desk at GSO, will give a presentation by Zoom on Saturday if everything goes right. Districts asked to give presentations this year are Districts 3, 5, 6, 8, 9, 16, 18, 21. I will be calling the DCM's or talking to them at the Assembly on what their topics will be.

If you are like me, when you came to these rooms you hadn't been wanted very many places if any at all while drinking. So, when I first came to these rooms, I didn't feel any different. Why would I be accepted here? I sat in my first meeting with 13 people who were happy, joyous and free. Everything I was not, but so desperate to have. I just didn't know how to get it. At the end of my second meeting I asked this guy, Jim to be my sponsor. He had this crazy notion I should get phone numbers from the other people. Now, there weren't cell phones when I first sobered up, or at least commonly seen ones. We had the touch dial phones with answering machines. One Friday night I was sitting alone at home, dying from loneliness and I thought maybe, just maybe I should call someone. But, I can't just call someone to talk. I need a reason to call, besides being lonely of course. There was a 9pm meeting that night and I devised a brilliant plan that I would call this guy Dave and act like I didn't know what time the meeting started. This would be my in to talk to someone without having to admit I was lonely. I dialed up Dave and I heard the phone ring, all of sudden to my surprise, joy and fear he answered the call. He said hello, as we didn't have caller id back then, and I said, "Hi, Dave." He responded with, "Hey, Jim, what's going on?" So, I asked him if he knew when the 9pm meeting started tonight. He laughed a bit and said, it's starts at 9pm, but added, would you like to go for coffee beforehand. A feeling of utter joy came over me and I said, yes, yes I do. And that my friends, is my first attempt at calling someone in this program. What I can say is that was an important point in my sobriety. I decided that I wanted what you had and was willing to take the steps to get it. Jim S.

Finding new ways to carry the message...

One thing us alcoholics have in common is resiliency, or we wouldn't keep coming back. The cost of closing meetings and having isolation for some is life and death, or death to our way of life as we know it...To take away our purpose no matter how big or small is to set us down a slippery slope, possibly destruction. The virus and restrictions that happened to all of humanity in 2020 pushed us, gave us a nudge to find new ways to carry the message (sometimes even to ourselves) even if we felt uncomfortable or lost at times, or lost for words at times... We adjusted, we took a breath, put our thoughts together and thought outside the box. We all throw out ideas, researched, and kept in contact with each other. We tried zoom meetings online - never canceled the Sunday candlelight meeting in Marble MN. We jumped into the zoom app, posted a link, directions, and a phone list outside the church door in Marble so anyone could reach out or jump on even if we didn't have a way to contact them. We made ourselves available. We reached out to each other. We checked up on each other like family – even when we found ourselves getting used to being quarantined and isolated. Even if we couldn't get outside the house, we were able to get outside of ourselves. From March 13, 2020 to the end of June. July came, we roll the dice follow the CDC guidelines had a meeting again outside every Sunday 7 PM. We put out the word in July to BYOC bring your own chair and coffee so we could hold "no contact" meetings sat 6 feet apart and had masks. Also back in March we started a second meeting on Thursday nights on zoom online which we have continued to the present day now. Some people still are not comfortable or have high-risk health issues or don't have the option to do face-to-face meetings so we continue the meeting online. Some people just want or need an option online that they can just jump onto any time from anywhere and zoom works amazing for them. We are Adjusted, we coped, used our skills, and tools that we had learned in the program. We applied them to ALL aspects of our lives, as the world has chosen to intermingle everything we hold dear.

The one thing that I personally feel kept us all strong and alive thus far (besides God or higher power) is this program of AA and everything that it guides us to, and everything it guides us to do.

We chose to just simply, keep doing the next right thing. Our small group has never have given up hope that the next right thing is going to happen. It may not always be how, when, or why we see or feel fit, but we continue to have hope and faith it is going to be exactly how it is intended to be. Today is a beautiful time to be alive-no matter what the outside world may look like or our personal situations... we know that what matters is how we look on the inside-what we do makes a difference to someone the way it made a difference to each of us at one point or many...we know that what keeps us on the right path, is to keep sharing the message that was so freely given to us-no matter how hard it may be at times. Painstaking even at times.... yet... We went... and we continue to go...to any lengths to get it, and to keep it. We had no guidelines, other than our big book and our higher power by our side....and we get up, we suit up, show up, we face the fear of the unknown. We alcoholics hate change, but we face it and embrace it-together. Most importantly we accepted...it wasn't perfect, but it was progress, and if we worried about it – we prayed about it. And we try not to take it back if we pray about it-easier said than done, but prayers don't work if we don't hand them over is something I learned from a friend a while back... No one knows what tomorrow holds, or if we will each will even see tomorrow, especially in the chaotic world that we live in today. But one thing that the program of Alcoholics Anonymous has taught all of us, that one thing is absolutely certain, is that we have TODAY, and all of our potential tomorrows, are dependent upon the choices and the actions that we make in each today that we are fortunate to have been gifted. HISTORY OF THE HIBBING MONDAY NIGHT DOWNTOWN GROUP compiled 1988 (1971-1988 by Signe A)

I came into AA through my four children who became worried about their mother. They coaxed me into the Minneapolis St. Mary's Hospital Alcohol Treatment Center on Christmas weekend of 1969. I spent six weeks there until they finally convinced me that I was an alcoholic and that it was not how much I drank, a thimble full was more than the chemistry of my body would accept. Finally I accepted that I was an alcoholic.

From the time of my marriage in 1935, we would go to all the name band dances on the range. We would have a few drinks and dance like crazy with friends. When the dances were discontinued we started to go to the taverns. Those times started what I know now were my beginning of alcoholism. After three drinks and a few dances, when we would go to a restaurant to eat, I would spend the time in whatever bathroom was handy, heaving up everything. (The chemistry of my body reacting.) That life didn't last long. We quit going out with friends. I didn't drink much for a few years. Then we moved and were buying a house in Graysher. Now I had a goal. My husband had changed job just before we moved. I sewed drapes in my home for a decorator shop in Hibbing. For the first time in my life I felt good about myself because I was doing my part toward our future security. I worked on drapes like crazy 12-16 hours a day, but after eight years paying on the house, my husband decided to give up the house. While packing for our move elsewhere, I started having a few, sitting on the basement floor with tears pouring down. It was a heart-breaking time for me.

By this time our oldest son was married and had gone away to college and our oldest daughter was married and away from home. We moved back downtown with our two youngest children. I was still doing drapery work but was very unhappy. Little by little a few drinks kept me going. When the youngest son left for college we moved into a two bedroom upstairs apartment. That is when the little drink became a big one especially at night so I could get to sleep. I was even hiding my drinks in baby food jars. I am fortunate that my doctor would never give me a sleeping prescription. I wouldn't be writing this story today if I had had any drugs, the insane part of our behavior.

That is when the youngest daughter contacted the other children and got me into St. Mary's. There I found out that besides the chemistry part, I had a big resentment toward my husband because of the lost house and the loneliness with all four children gone. They had been my world besides my drapery work. My husband's name was brought up at St. Mary's at confrontation because I kept telling the counselors about his heavy drinking everyday and I could handle only a thimble full.

Now my AA story. I was introduced to AA in February 1970 at the old Alano Club on First Avenue in Hibbing. My husband would drop me off at the back door on Monday and Thursday nights. I bummed a ride home with old north Hibbing friends, Wally A. or Lauri G who belonged to the Alano Club. They knew how scared I was and just kept on telling me to keep coming and that it would get better. I was the only female member among 30-40 guys. Some nights I could hardly remember my name. Listening mostly to drunkalogues, didn't help me because I couldn't relate to them at all. After 9 months of attending the Alano Club, I quit. I was asked by the nursing home where my mother was confined to come help her at meals. This was my excuse not to attend meetings. My mother passed away and was buried two days before Thanksgiving. I went through a sad Christmas even though all the family was home plus grandchildren now. I spent a quiet New Year's too. I hadn't had a drink from December 27, 1969 until the 5th of January 1971. On that date I went out and bought a bottle. I took three drinks, heaved all over the walls, bed and floor. When my husband came home at 3 o'clock from work, he couldn't believe it. I got verbal abuse that I needed. I begged him to bring me to Hibbing General Hospital where I stayed the night and came home the next afternoon. January 5, 1971 is my AA Birthday. I have not had a drink since.

Monica R., Ann T., and I got together and started a women's group at the St. James Church on Monday night. We would have maybe 5-6 women one night and maybe 19 another. The next time there would be only 2-3 of us. We were not a very organized AA group Then we invited male AA members to join us. We were very slow at first getting a structured program going. Little by little the group caught on to what we were really supposed to be doing and bringing out at the meeting. With the help from "How It Works" from the Big Book and other advice, and also using the Twelve and <u>Twelve</u> and other books, we became a serious group. We began to organize the offices of chairman, GSR, Grapevine, etc. After going to Open Meetings at other towns on the range, we really became an active group. In the years that I have belonged to Hibbing Monday Night Downtown Group, my home group, I have taken my turn more than once at practically every office, plus district and area. My first official service job came about when Don M. became DCM for our District. He was a member of our group and asked me to take over his GSR job. I accepted and he really showed me the ropes and saw to my attending all the meetings. Next, I was Grapevine Representative for our group. Before long I became District Grapevine representative which I held for 4 years. The time spent in Don's company was an education on AA. He kept pushing me forward. I felt he was my sponsor at that time. He gave so much of himself helping me and others. I still miss him. Also I volunteered at Hibbing General and became the shopping lady for

Also I volunteered at Hibbing General and became the shopping lady for patients on the fourth floor alcoholic center. I enjoyed doing the shopping, but talking to the patients, especially the new ones, was a blessing for me. But, for the Grace of God, I could have been there again. I did the shopping for many years until they moved the hospital.

I didn't start to really grow in AA until the responsibilities of the different offices I held came to mean something in my life. I also found the sharing and caring of all AA members wherever they lived.

I thank God everyday that I am an alcoholic. AA members, I feel are like my family now. They are there for me when I need them, all I have to do is pick up the phone. My higher Power helped me through the roughest year of my life when my husband had cancer and died, a practicing alcoholic on January 1981. Again I thank God and AA for all the miracles that have happened to me for me.

KEEPING IN PRACTICE

I know that if I don't use the "tools of the AA program" (steps, meetings, sponsor, etc.), they become dull, rusty and less effective. I will get restless, irritable and discontented. The worst could happen and I may get drunk. The same can happen in our meetings and activities within our AA service structure. Here the tools are things like group consciences, traditions and concepts, which are there to help us and guide us when challenging circumstances come up, such as the current Covid-19 issue as it impacts our AA meetings. Add to that politics running on the "hot" side and the potential is there for unity to be affected. In the "12 X 12", Tradition One, it states: "The unity of Alcoholics Anonymous is the most cherished quality our Society has. Our lives, the lives of all to come depend squarely upon it. We stay whole, or AA dies." If there is enough disunity, a group can display such unattractive behavior such that a newcomer needing life-saving help may walk out the door, drink again and die. The meeting may even cease to exist. Fortunately for us, borne of the sometimes turbulent beginnings of Alcoholics Anonymous, traditions and group procedures were developed and approved by the Fellowship so that we would have wise guidance and a respectful means of getting through difficulties later on. BUT, just like I need to actually USE the tools of AA recovery to stay sober, groups need to learn about and employ the AA traditions with humility and open-mindedness enough to keep the group sufficiently focused, unified, attractive and unafraid to tackle the occasional thorny issue. In our home we keep a flashlight handy in case the power goes out, making sure the batteries are good and the bulb isn't burned out. Maintaining awareness of the traditions as well as conducting regular group consciences-with AA literature (12 Traditions Illustrated pamphlet, The AA Group pamphlet, as examples) as a guide- are like having and maintaining that flashlight-it will be there and working if there are problems.

Being composed of alcoholics, meetings are, of course, never going to run like some well-oiled machine, without a glitch. The road of Happy Destiny for AA has always had plenty of potholes as it winds its way through history. But we don't have to re-invent the wheel even when problems are tough and somewhat unique. I believe the answers are right there in front of us in the form of our Traditions and in learning the history of how they came about. Kurt N., DCM, District 11

Your GSR is your voice...

I remember hearing early in sobriety, and first exploring service work; that the GSR was maybe the most important service position there is. And as P.I. Chair for the AREA, I've reflected on that a lot in recent months while working with Districts and groups during the Pandemic. Now this is not to diminish any or all the other important service positions...from making coffee to being a Delegate or Trustee. And I am not condemning any groups or individuals. But the General Service Representative is the carrier of the "group conscience" of their home group. They are the link between that group with District, Area and GSO. They are the information conduit to and from that group. They are a logical contact point when anyone is reaching out to a specific group. And yet, with a GSR being so important to the health of an individual group as well as the over-all health of AA; it is sad to report that we are far short of having 100% representation of a standing GSR for every group in the AREA. Now I'm not talking a GSR who attends EVERY District and AREA function...I'm talking a name on file for every group. When groups started suspending or maintaining meetings all over the region due to the pandemic, the logical person to carry that message to the public and to the Fellowship would be the GSR. When Districts and AREA were reaching out to communicate with individual groups, the BEST direct line would be the GSR. With a lot of groups not listing an active GSR, all that communication becomes very difficult or impossible. When times are "normal" and everything seems to be rolling along pretty smooth, the importance of a GSR may seem minimal. But when it is MOST important a GSR is pretty indispensable. So PLEASE, if your group doesn't have one, select a GSR. And once you have one, use them, cherish them, count on them. EVERY group is a vital part of Alcoholics Anonymous. Your GSR is your voice. As the saying goes; are you just attend-

Told them my wife and I would stop by later in the week. Maintaining social distancing of course. And life goes on. To borrow a line from Bobby McFarrin.... Don't worry, be happy!

Sobriety and Loss

I lost my only child to cancer December 9th, 2018 and my life was changed forever. He was 39 years old. I have remained sober only through the grace of God and the fellowship of Alcoholics Anonymous. In my early sobriety I said in a meeting that the only thing I could think of that would make me drink again was if something happened to my son. He died in my home with me holding his hand. In His wisdom, God gave me 26 years to build up enough strength to get me through. Only His grace got me through this. I know that on my own, I would not have stayed sober.

A member of my home group asked me if I thought about drinking. I said no, but after the meeting I realized that I had indeed thought about it. I knew that no one would blame me. I could stop somewhere, buy a bottle and stop the pain, at least temporarily. My current husband has never seen me drink, and I was sure that I could lie and cover it up. Then I did what another member said — I played the tape through to the end. If I drank, I would have to admit it to my belly-button family. They have always supported me and been very proud of my sobriety. I would also have to tell my AA family. I know they also would have been understanding and supportive. Finally, I would have to tell my church family, who went through all of this with me. And, when I sobered up, my son would still be gone. He was always so proud of my sobriety and how I helped people. I will not dishonor his memory this

I am still struggling through some very dark days. His memory is everywhere I look. He had moved home 3 months before he passed away, and I treasure the times we spent together. I go to my weekly Monday night meeting. I fulfill my responsibility as GSR for our group by attending the monthly district meeting and also monthly jail meetings. These activities have helped to keep me grounded in my recovery and to stay focused on other people. AA has taught me that this is the way to handle adversity in my life, one day at a time.





Editor - The Editorial Chair position is a two-year rotation picked by the incoming Area Chair and either approved or rejected by the Area Committee at the first Area meeting after the Fall Assembly Elections.

Desirable qualifications: Current knowledge MS Publisher, MS Word, MS Excel and other misc. computer programs as needed. The person should also consider the time needed to complete the task required. The candidate should have a working knowledge of A.A. as a whole, i.e., prior experience in service work such as G.S.R., D.C.M., or related position.

N.L. Committee - The N.L. Committee consists of two D.C.M.s in Area 35. Currently, these have been picked randomly at the start of the new rotation. They also serve on a two-year rotation basis. They assist the editor in communications with other area newsletters, in recommendations on general improvements, and with general problems and implementations of new policies. They may also represent the editor at functions when the editor is unable to attend. Seek advice and help from former N.L. Committee members and editors.

N.L. COMMITTEE MEETINGS:

The Committee meets every other month, before the start of the Area Workshop and at Spring and Fall Assemblies. Additional meetings may be called for if needed between these times.

A good flyer should answer the following questions:

- 1. Who is involved or sponsoring the event? Examples:
 - a) AA Group
 - b) District
 - c) Area
- 2. What type of event is it? Examples:
 - a) An open or closed meeting
 - b) Speaker meeting
 - c) Call up meeting
 - d) Big Book meeting
 - e) Workshop
 - f) Conference
 - g) Fellowship (ice cream socials, potlucks, chili cook offs, etc.)
 - h) AA must appear somewhere on the flyer
- 3. When is the event to take place? Examples:
 - a) Date and time
 - b) Does it reoccur
- 4. Where will the event take place?
 - a) Name of the facility and the address
 - b) Maps are sometimes helpful but not necessary
- 5. Why is the event taking place?
 - a) The reason for AA events is to carrying the AA message to the still suffering alcoholic (this doesn't have to be printed on the flyer)
 - b) Usually covered in Who and What

*For safety reasons, if a phone number is listed on the flyer consider NOT putting a name in association with the number.



Q: Why list our past Delegates?

A: They are a resource to you!

In Alcoholics Anonymous we value experience. Our Twelve Steps did not exist when Bill stepped into the lobby of a hotel in Akron, Ohio. Even after meeting with Dr. Bob and soon founding our program, there were only six steps until the experiences of 100 Alcoholics were summed up. Soon after a book followed, but it was a few years later when the Twelve Traditions were discussed and agreed on. Twelve Traditions that were "hammered out on the anvil of experience". Our past Delegates are a wealth of experience, an interactive living archive if you will. When you plan your next service workshop or need an outside voice to offer help, consider this resource available to you. Some of them even offer great company while fishing!

The Delegate's Duties

Though the high point is the Conference meeting, the delegate's job goes on year-round and involves all aspects of the Conference structure. The delegate should:

- Attend the Conference meeting in April, fully prepared. Immediately upon election, every delegate is put on the G.S.O. mailing list to receive Conference materials.
- Communicate the actions of the Conference to area committee members and encourage them to pass on this information, and the delegate's enthusiasm, to groups and to intergroups/central offices. If an area is too large for the delegate to cover in person, he or she will ask area officers and committee members to share the load.
- Be prepared to attend all area, state/provincial, and regional service meetings and assemblies. From these meetings, delegates come to better understand their own areas and can make suggestions for the Conference agenda. Here, too, they come in contact with A.A. members who might not be reached otherwise.
- Help area committees obtain financial support for the area and G.S.O.
- Provide leadership in solving local problems involving the A.A. Traditions

- Remind G.S.R.s to inform groups and individuals about the A.A. Grapevine and Conference-approved literature.
- Cooperate with G.S.O. in obtaining information—for example, making sure that up-to-date information reaches G.S.O. in time to meet the deadline for each Issue of the A.A. directory and helping carry out the triennial membership surveys.
- Visit groups and districts in the area whenever possible.
- Work closely with committee members and officers, sharing experience throughout the year. After G.S.R.s and committee members have reported on the Conference, learn from these A.A.s how groups and members have reacted.
- Assume added responsibility if the area chair and alternate chair are unable to serve. Or, if an area committee is not functioning effectively, the delegate may take an active role in remedying the situation.
- Keep the alternate delegate fully informed and active, so that the alternate can replace the delegate in an emergency.
- Late in the second term, work with newly elected delegates to pass along a basic knowledge of Conference proceedings and problems.

12 Traditions of **Alcoholics Anonymous (Long Form)**

- 1. Each member of Alcoholics Anonymous is but a small part of a great whole. A.A. must continue to live or most of us will surely die. Hence our common welfare comes first. But individual welfare follows close
- 2. For our group purpose there is but one ultimate authority—a loving God as He may express Himself in our group conscience.
- 3. Our membership ought to include all who suffer from alcoholism. Hence we may refuse none who wish to recover. Nor ought A.A. membership ever depend upon money or conformity. Any two or three alcoholics gathered together for sobriety may call themselves an A.A. provided that, as a group, they have no other affiliation.
- 4. With respect to its own affairs, each A.A. group should be responsible to no other authority than its own conscience. But when its plans concern the welfare of neighboring groups also, those groups ought to be consulted. And no group, regional committee, or individual should ever take any action that might greatly affect A.A. as a whole without conferring with the trustees of the General Service Board. On such issues our common welfare is paramount.
- 5. Each Alcoholics Anonymous group ought to be a spiritual entity having but one primary purpose—that of carrying its message to the alcoholic who still suffers.
- 6. Problems of money, property, and authority may easily divert us from our primary spiritual aim. We think, therefore, that any considerable property of genuine use to A.A. should be separately incorporated and managed, thus dividing the material from the spiritual. An A.A. group, as such, should never go into business. Secondary aids to A.A., such as clubs or hospitals which require much property or administration, ought to be incorporated and so set apart that, if necessary, they can be freely discarded by the groups. Hence such facilities ought not to use the A.A. name. Their management should be the sole responsibility of those people who financially support them. For clubs, A.A. managers are usually preferred. But hospitals, as well as other places of recuperation, ought to be well outside A.A.—and medically supervised. While an A.A. group may cooperate with anyone, such cooperation ought never go so far as affiliation or endorsement, actual or implied. An A.A. group can bind itself to no one.
- 7. The A.A. groups themselves ought to be fully supported by the voluntary contributions of their own members. We think that each group should soon achieve this ideal; that any public solicitation of funds using the name of Alcoholics Anonymous is highly dangerous, whether by groups, clubs, hospitals, or other outside agencies; that acceptance of large gifts from any source, or of contributions carrying any obligation whatever, is unwise. Then too, we view with much concern those A.A. treasuries which continue, beyond prudent reserves, to accumulate funds for no stated A.A. purpose. Experience has often warned us that nothing can so surely destroy our spiritual heritage as futile disputes over property, money, and authority.
- Alcoholics Anonymous should remain forever non-professional. We define professionalism as the occupation of counseling alcoholics for fees or hire. But we may employ alcoholics where they are going to perform those services for which we may otherwise have to engage nonalcoholics. Such special services may be well recompensed. But our usual A.A. "12 Step" work is never to be paid for.
- 9. Each A.A. group needs the least possible organization. Rotating leadership is the best. The small group may elect its secretary, the large group its rotating committee, and the groups of a large metropolitan area their central or intergroup committee, which often employs a fulltime secretary. The trustees of the General Service Board are, in effect, our A.A. General Service Committee. They are the custodians of our A.A. Tradition and the receivers of voluntary A.A. contributions by which we maintain our A.A. General Service Office at New York. They are authorized by the groups to handle our over-all public relations and they guarantee the integrity of our principal newspaper, the A.A. Grapevine. All such representatives are to be guided in the spirit of service, for true leaders in A.A. are but trusted and experienced servants of the whole. They derive no real authority from their titles; they do not govern. Universal respect is the key to their usefulness.
- 10. No A.A. group or member should ever, in such a way as to implicate A.A., express any opinion on outside controversial issues particularly those of politics, alcohol reform, or sectarian religion. The Alcoholics Anonymous groups oppose no one. Concerning such matters they can express no views whatever.
- 11. Our relations with the general public should be characterized by personal anonymity. We think A.A. ought to avoid sensational advertising. Our names and pictures as A.A. members ought not be broadcast, filmed, or publicly printed. Our public relations should be guided by the principle of attraction rather than promotion. There is never need ourselves. We feel it better to let our friends recommend
- 12. And finally, we of Alcoholics Anonymous believe that the principle of anonymity has an immense spiritual significance. It reminds us that we are to place principles before personalities; that we are actually to practice a genuine humility. This to the end that our great blessings

12 Concepts for **World Service (Short Form)**

- Final responsibility and ultimate authority for A.A. world services should always reside in the collective conscience of our whole Fellowship.
- The General Service Conference of A.A. has become, for nearly every practical purpose, the active voice and the effective conscience of our whole Society i.
- III. n its world affairs.
- IV. To insure effective leadership, we should endow each element of A.A.—the Conference, the General Service Board and its service corporations, staffs, committees, and executives—with a traditional "Right of Decision."
- At all responsible levels, we ought to maintain a traditional "Right of Participation," allowing a voting representation in a reasonable proportion to the responsibility that each must discharge.
- VI. Throughout our structure, a traditional "Right of Appeal" ought to prevail, so that minority opinion will be heard and personal grievances receive careful consideration.
- VII. The Conference recognizes that the chief initiative and active responsibility in most world service matters should be exercised by the trustee members of the Conference acting as the General Ser-
- VIII. The Charter and Bylaws of the General Service Board are legal instruments, empowering the trustees to manage and conduct world service affairs. The Conference Charter is not a legal document; it relies upon traditional and the A.A. purse for final effectiveness.
- IX. The trustees are the principal planners and administrators of overall policy and finance. They have custodial oversight of the separately incorporated and constantly active services, exercising this through their ability to elect all the directors of these entities.
- Good service leadership at all levels is indispensable for our future functioning and safety. Primary world service leadership, once exercised by the founders, must necessarily be assumed by the trus-
- XI. Every service responsibility should be matched by an equal service authority, with the scope of such authority well defined.
- XII. The trustees should always have the best possible committees, corporate service directors, executives, staffs, and consultants. Composition, qualifications, induction procedures, and rights and duties will always be matters of serious concern.
- XIII. The Conference shall observe the spirit of A.A. tradition, taking care that it never becomes the seat of perilous wealth or power; that sufficient operating funds and reserve be its prudent financial principle; that it place none of its members in a position of unqualified authority over others; that it reach all important decisions by discussion, vote, and, whenever possible, by substantial unanimity; that its actions never be personally punitive nor an incitement to public controversy; that it never perform acts of government, and
