

Area 35 Fall Assembly Minutes Meeting via Zoom October 3, 2020

Call to Order: Gayle R. called meeting to order and opened with the Serenity Prayer.

Recognition of Past Area 35 Delegates in Attendance: JoAnne N. – panel 58, Jim K. – panel 64, Kelly D. – panel 66 and Scott A. Area 36 – panel 57

Additions to the Agenda:

Approval of the 2019 Fall Assembly Minutes: Motion made and seconded to approve minutes. Minutes were approved.

<u>OFFICER REPORTS</u>

DELEGATE – Jim S.

Good Morning Everyone, I would like to thank all the DCM's that held a delegate's report either in person or in zoom. It was truly a pleasure getting to meet people I had not met before and to see old faces I already knew. The hospitality was great, the attendances were great, and the conversation was great. I have asked Gayle to switch my delegate's report and the Grapevine presentation tonight so for those that have heard my report I won't be offended if you go find something else to do besides sitting through another hour of my report. We don't want to take away from the other report in the event mine goes over and hour.

On August 15th I sat in a zoom meeting with my fellow delegate's and the staff from GSO and heard a financial report from our CFO Leslie Backus. She did a great job and that report has been emailed out to DCM's so if you are a GSR and have not seen that report please talk to your DCM. If you are a DCM and have not received that report from me, please come find me at the break and let's make sure I have your correct email information. In this report we were told that when the pandemic started 7th Tradition donations dropped 50% and literature sales dropped 75%. Since then, we have seen an uptick in 7th Tradition donations but this hasn't bridged the gap yet. I did talk to Cindy about putting this in the NL and got a call from Steve L. who asked me about this. He said, do you realize this report is 20 some pages long and I said I had no idea. I sat in the meeting for 2.5 hours and we went through the whole report but didn't pay any attention to how long it was. Thus, it was not included in the NL.

The next zoom meeting I had was a Strategic Planning Meeting with my fellow delegate's and GSO staff. There was a questionnaire sent out with specific questions about how to move forward with GSO. There were 3 different zoom sessions with 1/3 of the delegate's in each session. We were broken into 8 delegates and 1 moderator. One topic that came up was how to better utilize our Class A trustees in getting the message out to the professionals about what AA is and what AA isn't. Another move that GSO made was to offer early retirement to staff. In our last West Central regional meeting, Mike Lewis, our regional trustee said there was the expectation that 25% of the people offered early retirement would take it, it turns out that about 80% of the people are taking it. There are no immediate plans for filling those positions with new people, but to combine duties as best as can be expected. When that complete information is all compiled, I will get you a copy of that report.

The next zoom meeting I attended was Friday night with my agenda committee. The main focus of that meeting was how to improve upon the conference. There are 8 of us in the committee but there was only 3 due to scheduling conflicts. The topic of our conversation was looking at moving committee meetings during the conference held on Monday and Tuesday to zoom meetings to give the conference that much more time to address agenda items.

I received a letter that was sent out by Greg T. our GSO manager. I have included that letter below....

In Service, Jim S.

*October 2, 2020

Dear friends and trusted servants,

I am writing to inform you that the General Service Board has authorized a drawdown of \$1.5 million from the Reserve Fund by A.A. World Services, Inc. to cover cash flow requirements in the 4th quarter of 2020.

<u>Note</u>: This will put the Reserve Fund balance at approximately \$13.1 million, which reflects a level of approximately 7.8 months of office operating expenses. (The Reserve Fund calculation is based on recent actual operating expenses.)

Evaluating the finances and cash flow, even with the continued increase in Seventh Tradition contributions, we still expect a decrease in income from last year of more than \$2 million, which creates this immediate cash flow pressure.

Previously, in May, A.A.W.S. drew down \$3 million to address the sudden emergency situation related to the severe drop in revenue we saw in March and April. Also, over the summer we refunded nearly \$4 million for 2020 International Convention registrations.

<u>Note</u>: We received \$972,000 as an advance against our International Convention insurance claim to recover lost income, and we expect the balance of the claim to be paid out very soon.

Since May—through September—the groups have responded with breath-taking generosity in their Seventh Tradition contributions, which have ensured continuation of services to the Fellowship. For six months (March through August), our publishing revenue was well below budgeted levels, but September saw a positive uptick in literature sales. Not a trend yet, but very encouraging. We have cut expenses in as many key areas as possible, without affecting quality of literature production or delivery of services.

The office presented a reforecast 2020 budget to the Board in August, and we are constantly updating and reporting financial results to the trusted servants with fiduciary responsibility for the operating corporation. We have begun work on the 2021 operating budget, with three quarters of 2020 actual results now available.

And, at the direction of the Board, we wanted to share this latest information with you.

Contributions from the fellowship

Bias Confirmation. Now, I'm a pretty well-read person. Try to keep up on things. But this is a new one for me. And it came up twice in the span of two weeks with two very different outcomes. Now Bias, according to Websters, is an inclination of temperament or outlook...or as a verb; to give a settled and often prejudiced outlook to. Confirmation is; confirming proof. In my first encounter with the term Bias confirmation it was the result of brief political conversation. My political conversations are all brief, because I rarely start them and always quickly end them. I had ended this one by referencing a particular information source and was told that it was worthless except for Bias Confirmation. That kind of chaffed me and left me a little wounded as us Alcoholics tend to be when someone suggests that we are wrong. It seemed pretty negative.

Now the second encounter was in an AA meeting. While discussing a step in this 12 and 12 meeting, someone suggested that more in-depth reading and discussion on the principles of the program always provides more Bias Confirmation. Now in this context, I took it as a huge positive! You bet I have a strong Bias about Alcoholics Anonymous. It saved my life! And in that same meeting, two different individuals talked about prayer and the sometimes, immediate impact of that on their lives. It was a profound confirmation of my settled and prejudiced outlook that the program of Alcoholics Anonymous is the best and surest solution to my Alcohol problem. I came home and read some more in my Big Book, continuing my Bias Confirmation, and felt really good about it. The experience also showed me how engaging the Program in my everyday life can really help me shape negatives into positives thus affecting my temperament and outlook. So my readings, my meetings, my Fellowship...all means of providing THIS Alcoholic with confirming proof that it really works if you work it. Greg C.

Covid-19 Effect on AA Financial Needs

As our society deals with increasing challenges to our personal and family daily routines caused by Covid-19, so do we in AA confront the various challenges of the Coronavirus: *Limited meeting spaces due to landlord requirements. *Fears of gathering in large numbers due to local or state regulations which limit options. *Concern for current or future group financial commitments due to limited, or no, collection of 7th step offerings. *Fear. *Fear. *Fear.

No responsible recovering alcoholic will cavalierly dismiss reasonable safety standards or public health guidelines. In sobriety we are learning to accept responsibilities as adults. We need to respect and to exhibit behaviors which will meet regulations or societal requirements while at the same time permit us to meet our primary purpose: To Stay Sober.

From information shared by DCM's and P.I. Chair Greg C. we learn that some meetings have "evaporated" with no knowledge if or when they will resume; Zoom meetings have not uniformly figured out how to collect the 7th tradition proceeds; reduced attendance at "live" meetings has resulted in fewer dollars and coins in their baskets. Yet in this time of less income for the group, District, Area, and GSO many expenses remain static. What will this mean in coming months and years? Costs of materials, rent, and necessary supplies rarely decline...usually they increase by at least cost of living adjustments. Concurrent with this challenge is the fact that for many of us our personal sources of income have declined or perhaps evaporated.

What can we do to observe the 7th Tradition: "Every AA Group Ought to be Fully Self-supporting, Declining Outside Contributions."? The General Service Office (GSO) has issued a Frequently Asked Question fact sheet. "Q. Our group is meeting virtually as a result of Covid-19. Our meeting costs are low, so why do we need to take a Seventh Tradition collection? A. The spirit of self-support ensures that even minimal expenses are borne by the whole group rather than by individual members. In addition, many groups want to continue support for other AA services...Literature sales, which traditionally help pay for services, currently are much lower than

Covid-19 Effect on Finances So, what we do to honor our commitment to be "...self-supporting through our own contributions"? Some suggestions: Hold a group conscience meeting to understand what has changed in these times of Covid-19. Review your group's historical levels of contributions to all entities. Review the AA pamphlet "Self-Support: Where Money and Spirituality Mix". Make a plan which suits your group.

When the basket is passed at meetings, are we prepared for that moment by checking our wallets, purses or pockets before the meeting to make sure we have money at hand? I can recall my good intentions when I put nothing in the basket with the firm resolve that I will double my contribution "next week."

Don't give beyond your capabilities, but give. How many times have I put a buck in the basket while holding onto a few more dollars so that I can enjoy coffee and pie at Perkins after the meeting? A buck doesn't cut it

Most of us have experienced extremely difficult financial set backs because of the consequences of alcoholic behavior. The longer we remain sober the more we can attribute material success to AA. Don't we have an obligation to support financially what gave us a "new life"? Keep it simple. Without the financial contributions of the many thousands who came to AA before my arrival, we would not function today. As we put our dollars in the basket, think of the man or woman who will walk through our doors next week. Meeting space, books, reading materials and a cup of coffee will be here for them, along with our warm smile and a calm expression that "all will be well...keep coming back." Jim T.

Humbled Again

To mask or not? Outside issue or not? To continue to zoom or not? All good questions, no simple answer, and I am continually learning. I truly hope by the time this is printed it will be a non-issue.

Here we are still in this pandemic with this covid-19 crapola and now mask mandates. Churches, schools, meeting places all closed down for the "stay at home" order. AA meetings were held on Zoom and other online formats as we continued to meet to the best of our abilities in this pandemic. I heard some of us continued to meet to the best of our abilities in this pandemic. I heard some of us met in garages, picnic tables at parks, in parking lots, anywhere outside where a few people could gather and social distance. Anything for an AA meeting-oh how we needed them! Now thank goodness we can meet face to face again. Alano clubs, churches and other meeting places are slowly reopening however we are told to limit our numbers, "social distance" and wear a mask? Huh?? So as we begin opening our meetings again there seems to be disagreements in our AA rooms on whether we really wear masks and socially distance? Then the Governor made it an Executive Order that we must follow. Well again I wanted to rebel and the old me came outsaying "no one is going to make me wear a mask!" "I won't live in fear" etc. etc. excuses, excuses, rationalizing 101... Then I was reminded of some of the principles Alcoholics Anonymous has taught me over the years of painstaking growth. I didn't feel right when I would see a sign on the door of the Alano club or church that said "masks are required per governor's order" and I walked without a mask anyway. It didn't feel right.. I felt that nagging dishonesty. I don't like feeling anymore thanks to Alcoholics Anonymous. There is no reason physically why I can't wear a mask and I have no excuse. So what do I have to do to make it right? The program has taught me to do the next right thing even if I don't want to. Believe me, I don't want to wear a mask or social distance., however I feel it is the "next right thing to do" because I have been taught and been changed enough to take direction, follow the rules and obey the laws even if I don't want to. My natural instinct is selfishness, self-centered and rebellious. Only through the teaching, practice and more practice by God's Grace have I been able to change thanks to you all teaching me. So after taking my inventory, asking God for forgiveness and asking what corrective measures I can take. I WILL be wearing a mask to meetings and when in public. First because it is an executive order that I must follow. Second because it is the right thing to do and third because I am sober today and I can be humbled enough to follow directions Especially when I don't want to.

To answer the "is it an outside issue or not?" question—well Traditions 1 and 10 may help. "Our common welfare should come first; personal recovery depends upon A.A. unity." From the Twelve Steps and Twelve Traditions page 129-130 "No A.A. can compel another to do anything; nobody can be punished or expelled...the Twelve Traditions which guarantee A.A.'s unity contain not a single "Don't." They repeatedly say "we ought..." The A.A. member has to conform to the principles of recovery...At first he goes along because he must, but later he discovers a way of life he really wants to live. No one can expel you or me from A.A. for not wearing a mask but our unity seems to be lacking? I finally want to conform to the principles of this program because I do love this way of life, because I ought to and because I want the unity of the meetings back. I don't want people to feel like they are not safe or their health is at risk at an Alcoholics Anonymous meeting therefore they leave. What if that person leaving is a newcomer who walks in with a mask on and sees no one else wearing one? How does that look for A.A.? What if that person is an old timer with health issues? We can't forget the long timers and those that have health issues that choose to stay on Zoom because they are at risk. Yes the newcomer is important and we need to be there for them, but we also need to be there for the elderly and those with health issues. I think Zoom is a blessing and I will keep zooming as well as my regular meetings. As long as there is a need to bring a meeting to an alcoholic who for whatever reason feels they can't physically be at a meeting. We need to help all who suffer from alcoholism, young and old, newcomer and old timer. It's not for any of us to judge when someone should go back to face to face meetings. That's Unity!

So I figure let's not argue about it. If we just do the right thing and live by the principles we have been taught, it won't be an outside issue.

THE AA PREAMBLE: BACKGROUND INFOR-MATION

THE PREAMBLE was introduced in the June 1947 issue of the AA Grapevine magazine. It was written by the then-editor, who borrowed much of the phrasing from the Foreword to the original edition of the Big Book, Alcoholics Anony-

In those early years, the Grapevine had just begun to circulate among nonalcoholics, and the Preamble was intended primarily to describe for them what AA is and is not. It is still often used for public information purposes. As time passed, it began appearing in all Conference-approved publications, and many AA groups now use it to open meetings.

The original version differed in two ways from the familiar form we all know: 1) It stated that the only requirement for membership is an *honest* desire to stop drinking," and 2) it contained only the very brief statement "AA has no dues or

People often ask why the word "honest" was deleted. At the 1958 General Service Conference, a delegate asked about the words "honest desire to stop drinking," suggesting that since "honest" does not appear in the Third Tradition, it might be deleted from the Preamble. In discussion, most Conference members felt that as AA had matured, it had become almost impossible to determine what constitutes an honest desire to stop drinking, and also that some who might be interested in the program could be confused by the phrase. Thus, as part of the evolution of AA, the phrase had been dropped from common usage. The midsummer 1958 meeting of the General Service Board of Trustees ratified the deletion, and since then the Preamble has read simply "a desire to stop drinking."

At the same time, the phrase "AA has no dues or fees" was clarified to read as it presently does: "There are no dues or fees for AA membership; we are selfsupporting through our own contributions." The current version of the Preamble appears on page one of every issue of the Grapevine.

AA PREAMBLE©

Alcoholics Anonymous is a fellowship of men and women who share their experience, strength and hope with each other that they may solve their common problem and help others to recover from alcoholism.

The only requirement for membership is a desire to stop drinking. There are no dues or fees for AA membership; we are self-supporting through our own contributions. AA is not allied with any sect, denomination, politics, organization or institution; does not wish to engage in any controversy, neither endorses nor opposes any causes. Our primary purpose is to stay sober and help other alcoholics to achieve sobriety.

FREQUENTLY ASKED QUESTIONS ON PRAC-TICING THE SEVENTH TRADITION AT VIR-**TUAL MEETINGS**

In recent years a number of groups have utilized digital payment platforms to provide opportunities for members to make cashless contributions. There are different payment platforms to facilitate this service, and it is up to the group to determine which one to use. Experience suggests that the treasurer is a natural choice to handle digital contributions. Some groups, however, share the responsibilities among trusted servants or even create a new service position to inform group members about digital payment options and assist those who are interested in contributing this way.

Q. Our group is meeting virtually as a result of Coronavirus (COVID-19). Our meeting costs are low, so why do we need to take a Seventh **Tradition collection?**

A. The spirit of self-support ensures that even minimal expenses are borne by the whole group rather than by individual members. In addition, many groups want to continue support for other A.A. services. Local intergroup/central offices still have bills to pay, such as rent and utilities. Many have employees who are working hard to keep meeting information updated and respond to calls for help. The Online Intergroup of A.A. also has its own costs which require support, and many districts and areas continue to have expenses as they support the work of committees and plan future events. Furthermore, the General Service Office needs to cover its operating expenses in order to continue providing services. Literature sales, which traditionally help pay for services, currently are much lower than usual.

Q. If our group decides we want to "pass the virtual basket" how would we get started?

A. Often a group will have their treasurer or other members gather shared experience and information on different digital payment options, then present that to the group for discussion at a business meeting.

Q. What kind of options are available?

A. Here are some of the digital payment platforms that groups using: Apple Pay, Cash-App, Google Pay, PayPal, Venmo and Zelle. Information on options being used locally may be available from your intergroup/central office, district or area.

Q. How would we decide between them?

A. Groups often compare the costs and benefits of each platform, considering things like ease of set up and use, payment processing fees, security, privacy, and how commonly known it is. Some groups offer multiple options for their members.

Q. Once the group decides, then what?

A. Often it will be the group treasurer who sets up the account and links it to the bank account the group is using (for more information on setting up bank accounts and tax ID numbers, see the links below). It is helpful to choose a username for the account that is simple and intuitive since it will be shared with those attending the meeting. Groups usually avoid using a personal email that reveals someone's full name so as not to compromise that person's anonymity. Often at the beginning of a digital meeting, or during a break, groups will share the username through the chat or a screen share as they make an announcement about practicing the Seventh Tradition. It is recommended that groups do not share the username as part of the meeting's public online information.

Q. What about anonymity?

A. Some digital payment platforms have social components that members may want to disable to protect anonymity. For example, members have shared about changing the privacy settings on Venmo so contributions are only visible to the sender and recipient. A couple of intergroup/central offices have posted helpful guides to practicing the Seventh Tradition at virtual meetings: Best Practices for Online 7th Tradition Contribution from SF and Marin Of-

- Listen to comments from the Area on the content of the N.L.

EDITORIAL POSITION & N.L. COMMITTEE:

Editor - The Editorial Chair position is a two-year rotation picked by the incoming Area Chair and either approved or rejected by the Area Committee at the first Area meeting after the Fall Assembly Elections.

Desirable qualifications: Current knowledge MS Publisher, MS Word, MS Excel and other misc. computer programs as needed. The person should also consider the time needed to complete the task required. The candidate should have a working knowledge of A.A. as a whole, i.e., prior experience in service work such as G.S.R., D.C.M., or related position.

N.L. Committee - The N.L. Committee consists of two D.C.M.s in Area 35. Currently, these have been picked randomly at the start of the new rotation. They also serve on a two-year rotation basis. They assist the editor in communications with other area newsletters, in recommendations on general improvements, and with general problems and implementations of new policies. They may also represent the editor at functions when the editor is unable to attend. Seek advice and help from former N.L. Committee members and editors.

N.L. COMMITTEE MEETINGS:

The Committee meets every other month, before the start of the Area Workshop and at Spring and Fall Assemblies. Additional meetings may be called for if needed between these times.

G eneral submissions to the *Northern Light* are very welcome! Feel free to send letters or articles that are pertinent to Alcoholics Anonymous. However, please note that if space is limited, first priority will be given to reports from Area Officers, Area Standing Committee Chairs and D.C.M.s from Area 35.

You may also send articles or letters to my postal address, listed on page 2. The deadline for each issue is printed on the front page.

for flyers to be posted on the website or in the Northern Light

A good flyer should answer the following questions:

- 1. Who is involved or sponsoring the event? Examples:
 - a) AA Group
 - b) District
 - c) Area
- 2. What type of event is it? Examples:
 - a) An open or closed meeting
 - b) Speaker meeting
 - c) Call up meeting
 - d) Big Book meeting
 - e) Workshop
 - f) Conference
 - g) Fellowship (ice cream socials, potlucks, chili cook offs, etc.)
 - h) AA must appear somewhere on the flyer
- 3. When is the event to take place? Examples:
 - a) Date and time
 - b) Does it reoccur
- 4. Where will the event take place?
 - a) Name of the facility and the address
 - b) Maps are sometimes helpful but not necessary
- 5. Why is the event taking place?
 - a) The reason for AA events is to carrying the AA message to the still suffering alcoholic (this doesn't have to be printed on the flyer)
 - b) Usually covered in Who and What



Q: Why list our past Delegates?

A: They are a resource to you!

In Alcoholics Anonymous we value experience. Our Twelve Steps did not exist when Bill stepped into the lobby of a hotel in Akron, Ohio. Even after meeting with Dr. Bob and soon founding our program, there were only six steps until the experiences of 100 Alcoholics were summed up. Soon after a book followed, but it was a few years later when the Twelve Traditions were discussed and agreed on. Twelve Traditions that were "hammered out on the anvil of experience". Our past Delegates are a wealth of experience, an interactive living archive if you will. When you plan your next service workshop or need an outside voice to offer help, consider this resource available to you. Some of them even offer great company while fishing!

The Delegate's Duties

Though the high point is the Conference meeting, the delegate's job goes on year-round and involves all aspects of the Conference structure. The delegate should:

- Attend the Conference meeting in April, fully prepared. Immediately upon election, every delegate is put on the G.S.O. mailing list to receive Conference materials.
- Communicate the actions of the Conference to area committee members and encourage them to pass on this information, and the delegate's enthusiasm, to groups and to intergroups/central offices. If an area is too large for the delegate to cover in person, he or she will ask area officers and committee members to share the load.
- Be prepared to attend all area, state/provincial, and regional service meetings and assemblies. From these meetings, delegates come to better understand their own areas and can make suggestions for the Conference agenda. Here, too, they come in contact with A.A. members who might not be reached otherwise.
- Help area committees obtain financial support for the area and G.S.O.
- Provide leadership in solving local problems involving the A.A. Traditions.

- Remind G.S.R.s to inform groups and individuals about the A.A. Grapevine and Conference-approved literature.
- Cooperate with G.S.O. in obtaining information—for example, making sure that up-to-date information reaches G.S.O. in time to meet the deadline for each Issue of the A.A. directory and helping carry out the triennial membership surveys.
- Visit groups and districts in the area whenever possible.
- Work closely with committee members and officers, sharing experience throughout the year. After G.S.R.s and committee members have reported on the Conference, learn from these A.A.s how groups and members have reacted.
- Assume added responsibility if the area chair and alternate chair are unable to serve. Or, if an area committee is not functioning effectively, the delegate may take an active role in remedying the situation.
- Keep the alternate delegate fully informed and active, so that the alternate can replace the delegate in an emergency.
- Late in the second term, work with newly elected delegates to pass along a basic knowledge of Conference proceedings and problems.
