

How do we get people back into meetings after this Pandemic? Call people on call list, keeping people safe, wear mask, continuing having virtual meeting available. Getting email addresses to reach out.

How are we to get more people involved in service work? When going to a new meeting, ask if they have a GSR. Let group of GSR know how much fun we have. In pamphlet, there is a group inventory. Your group could do a group conscious. Let the newcomer come to assemblies.

How long and when do you do your GSR report? Week after district in business meeting. Hold meeting monthly in business meeting.

As DCM, we can visit groups with the Safety in AA yellow card. Inform groups of new safety information. Topic 2 – What do other D 's do for elections and getting people interested in service? Transitioning. Suggestions were to have detailed descriptions of service positions so those interested know what they are getting into. Try not to railroad. Instead of using words like obligation, use opportunities to service. Use a positive attitude, make service attractive. Personal touch and leading others into service is the best way. Bob seconded. Discussion: Jim S – Preamble changes are conference approved. Just because it's on our web page doesn't mean you have to have it in your AA mtg. Men and women are people. This isn't worth the argument. We should be all inclusive. Times are changing. GSR – some groups are reading the Preamble out of the first edition now. I was introduced to AA by a man that is not like me. He's taught me a lot about judgement. God's will for me is to be kind. Looking around this room in northern Minnesota and seeing the differences in people in this room, this program is the most inclusive thing ever. All I have to do is not drink. What is the timeline for agenda items? How much time will we need? Our choices are moving assembly forward or we leave as is and change our ACM to include GSR's / DCM's proposals. GSR's would send DCM's to ACM with possible agenda items. Another option is to submit proposal to move submission date to Oct. Most areas have their fall assembly in October. Trying to figure out why they would take out 1/4 of time from us, the top of the triangle. Why is everything changed because of one committee's amount of work. The entire fellowship is at Fall Assembly. Seems like a lot of work to reorganize for one committee's workload. Three year trial? Move up a few weeks. The Sept 15<sup>th</sup> date is not under negotiation. We have to figure out how we are going to get this done. If we do it at ACM in August, that leaves plenty of time to coordinate paperwork and get to Delegate. My first comment on this year's proposal, where were the GSR's.

Jim – another option. We change the composition. I don't represent the DCM's, I represent the groups. If I'm only hearing the DCM's at ACM, we are cutting out the GSR's. Three year trial. The committee has 2 days to discuss agenda items.

Discussion: Alano club – that building isn't big enough for GSR's to attend. If there aren't proposed agenda items, GSR's don't need to show up. I have enough trouble getting my GSR's to district meetings, let alone ACM. We did this at the August ACM this year. Offer virtual audience to GSR's. Groups would have to budget for Aitkin trip.

December ACM – 12/5 Incoming chair should have incoming area committee ready. If you are interested in area action committee chair, please let the incoming chair know you are interested.

Typically, incoming chair gets to choose committee chairs, but body needs to approve their choices. We must vote on allowing incoming chair to choose their committee chairs.

Motion – To allow incoming area chair to pick the area committee action chairs. Motion passed unanimously, none opposed.

**Archives Storage** – New archive storage – need 500 sq feet. Or 15x20. Currently \$50 a month for the last 2 years. Peter has been searching for climate controlled, protected storage. Centrally located in Area 35. Rent could be up to \$1000 a month or more. Must be moved by 12/31/2021. Current storage was temporary. Must consider utilities (heat, electricity and insurance).

Justin – Have been looking for climate controlled storage in St Cloud – cold storage is \$240 a month. Climate controlled storage – not finding. Must also plan for growth and workspace. Mpls – 200 sq feet, climate controlled \$215 a month. Do we want temp solution or perm solution?

Peter - Have found more possibilities, conversation still needs to be what Area 35 has been paying for the last 10 - 15 years has been very underpriced. It is our responsibility to keep these items protected.

Archives must be accessible to Archives and Archives Chair at all times. Must have space for working area. Can we rent an apartment? Can we share space with Area 36? Can we consider other locations around the area? Alano Clubs? Could approach board of Superior Alano Club about this? Home in Cambridge, basement finished, could residential home be utilized – 800 sq feet. Suggest to all Area members to start looking.

Jim S - In accordance with Mn State Law, effective 1/1/22 rent will be increased to \$300 per month. It's the 11<sup>th</sup> hour. Uhaul has climate control space. Suggest not a private property as they can refuse to allow entrance onto property at any time.

#### As this rotation comes to an end...

How the pandemic impacted my recovery and involvement in Area 35 By Christina H., District 6 (North Branch)

I got sober this last time during the pandemic. A lot of us alcoholics got sober or stayed sober through the isolating effects of the COVID-19 pandemic by leaning on each other and using what the Steps taught us, as well as adjusting to the meetings moving online. On the same note, many alcoholics did not make it through the pandemic sober. Some didn't even make it through alive due to their addiction..

It was a trying and lonely time for everyone.

For me, the only person I can truly speak for, the pandemic cracked my recovery wide open. It brought it to a new level I didn't think possible. I'm not sure I would have stayed sober if not FOR the pandemic! Let me tell

I had my last relapse right before the pandemic came to our shores. I was back to drinking daily and very ill - I couldn't get out of bed most of the time. My kids headed to their dad's in Iowa because of my drinking and I headed to detox on April 5, 2020. I made it through my 5<sup>th</sup> residential treatment episode and came home 90 days sober. It was a couple months after everything had shut down and we were all staying home. It was amazing to see what had happened to the world in the short time I'd been away.

I decided this was a great time to find some new hobbies. My old one wasn't working so well for me. I have a wonderful sponsor, a homegroup that had my back, and a support system that is enviable. I began doing paint by numbers while doing virtual outpatient treatment and meetings. The very first painting I did, I donated to my treatment center and it began a trend for me. I began making things (paintings, baked goods, meals) and giving them to people I love. I also became the secretary for my homegroup, became involved in my district, and attended AA meetings all over the world from my computer. My soul cup had never been so full!

I thought these would be things that I'd only do through the pandemic, and once things opened up again, it would all fall to the way side, but they didn't. I began gardening at my mom's house, created a garden at my partner's house, and began a plant collection that could have landed me in the psychiatric ward! So many plants .... But once winter came and went and I watched as all the work I'd done between these gardens started reappearing with the spring, it was like magic. I was absolutely amazed and in love. And I stayed sober.

I began baking and bringing those goodies to my homegroup, once things opened up. I baked and cooked and gave these things to friends and family members who otherwise would not get to experience homemade goodness. They were thankful. I was thankful. And I stayed sober.

I continued working with my sponsor, saying yes to what was asked of me in AA, helping others, engaging in service work, taking meetings. And I stayed sober.

I'm now just over 18 months sober – the longest period of sobriety in my adult life. The obsession has been removed. I have a Higher Power. I have a position with the Area, within my district, and am relied upon in a positive way. I have a good-paying, professional job, working on my master's degree, and continuing to do the hobbies I've grown to love. I never could have imagined, at the beginning of the pandemic, that my life would look like this a year and a half later. It forced me to step out of my comfort zone and get involved in things that I hadn't thought of before because there was no other option. I'm so grateful to AA, to my sober support network, my friends and family – without all of this together, I wouldn't be living a sober, wonderful life where I can live life on life's terms. Sometimes when we change everything, everything changes ... -Christina H.

My Story on What AA Service Work Has Meant to Me

My introduction to AA service work started shortly after I arrived at AA. At first it didn't seem anything special as I would help to set up the room by rearranging tables, making coffee, setting out and cleaning ashtrays after the meetings. These tasks helped me to gain a feeling of belonging and a part of the group. Over time I started to help even more by chairing meetings.

However here is where I need to diverge a little. When I started going to AA there were five other members that attended our weekly meetings. But somehow AA was taking off and over a period of around two years our little group grew to where we had up to 35 members attending this meeting. What I will say is that I watched many of these people come into AA in a lot of pain, some in denial, while others seemed happy to find a solution to their drinking problem. I saw AA working in their lives and how many of them now had smiles on their faces - I did not; and I was jealous but I didn't know how to change my thinking and attitudes.

Then it happened! My self-appointed sponsor told me that I needed to go to the Fall Assembly with him. I told him that it was deer hunting that weekend (in those days we could only hunt 1 weekend and this was the first of two times I missed deer hunting in the 50 years that I have hunted) and that was a conflict for me. He didn't care and continued to insist until I agreed to go along. As an introvert being in a crowd of people that I didn't know was more than a little overwhelming. But I still clearly remember how Vern R., Area 35 Delegate approached me and I found a connection. I lived in Crookston and he had grown up there and still had relatives that lived there. Again, this interaction by someone stepping up and taking time to visit with me gave me strength and support that ultimately led to a better sobriety. And so, I started my first official service position as the group GSR during the next rotation.

After serving as a GSR I then transitioned to the position of DCM. This was an exciting time. Our District meetings always had about an 80-90% attendance rate and service was something everyone looked forward to. Members would meet and travel to Area events together further building a sense of comradery amongst GSRs and their home groups. The District started holding round robin meeting once a month around the District so in a short time everyone knew everyone. Well, let's move ahead a few years to the present time. Having retired I started to become more involved with AA and attending the Noon Day meeting in Thief River Falls. I knew that the District had been struggling for some time – both GSRs and DCM; so, I volunteered to fill in as DCM to complete the final year for that rotation. As that year came to a close and no one wanted to step up as DCM I decided that I could add some continuity to the District by attracting members to become more involved in service work. I attended meeting around the District and spoke of the importance to be a part of AA on a larger scale. I passed emails along that I received and also fielded questions from others when requested. Now I am finishing up my 3<sup>rd</sup> year as DCM and have informed the District that in the spirit of rotation I will be stepping down at the end of this year. So finally, I will answer the question of what AA service work has meant

First, I have met many new friends as well as being reacquainted with friend from days gone by. I have had the opportunity to learn more about how AA operates especially at the Area, Regional, and National levels. Being a DCM and reading through the agenda items and their background information certainly helped me to understand the dynamics of AA and its workings.

Working with my assigned committee provided me with the sense of having a personal stake in carrying the message of AA across northern MN so all members could benefit.

#### Greetings, Area 35.

My experience with being the Group Records person for Area 35 has never been boring, to say the least. I started out taking over mid-rotation in 2018, and I stayed on for a second rotation. During that time, GSO switched systems starting in in October of 2019, at which time I had to start sending all group changes via email to the records department. The only way of telling which changes had been processed was to print spreadsheets because the records database was not available to registrars in all Areas. I had to start updating aaminnesota.org every time meeting information changed. The previous database version, Fellowship New Vision (FNV) made it possible to upload a file directly to aaminnesota.org, which occurred monthly. The new database, Fellowship Connection (FC), does not have this option available, so all editing of group information must be done by hand.

Then along came the pandemic. When group meeting locations began shutting down, I consulted with our Area chairperson Gayle, our Area webmaster Thomas, and our Area delegate Jim to discuss how to deal with all the changes. It was decided that I would send a letter to everyone on the Northern Light mailing list to ask them to inform me of which groups were going to be temporarily inactive and which were going to meet online. Our webmaster would put a list of changes on area35.org, and I would make changes on aaminnesota.org. The group of volunteers who program for websites that use WordPress made changes that made it possible to put Zoom meeting information onto the website with links directly to the desired meeting. Not all groups that had Zoom meetings utilized this option and preferred to have people contact a member of the group to get the meeting information. This was done because there was a lot of "Zoom-bombing" going on and groups did not want to have to deal with that.

I did not send any of the changes having to do with the pandemic to GSO records. They were already dealing with all the previously emailed changes and were behind on that, and the changes due to COVID-19 would be only temporary. During the pandemic, GSO staff were working remotely, which slowed things down even more. The new records system came online in December of 2020. The transition from the old system to the new system did not go smoothly and it took longer than anticipated. When it did happen, it was discovered that a lot of the changes that were sent by email did not get made and the information in the database had a lot of errors.

After things began opening up again this spring, groups started meeting in person and I updated aaminnesota.org to reflect these changes. Unfortunately, there were a few groups that did not survive the pandemic and I had to inactivate them.

My latest "Good Idea" involves getting the FC database as up to date as possible before the end of the rotation. (I have to run my Good Ideas past my sponsor because some of them are not so good, and she lets me know it! She knew this would be a big project, but we agreed it was a Good Idea, and she helped me with it.) I am currently working on all the changes that have been sent to me. I hope to get the FC database up to snuff by the end of the year.

This has been a challenging time. It has been fun being at all the Area functions with everybody, even on Zoom, and I look forward to the next rotation. I think I have grown some, and I am not afraid of the mic like I used to be! It has been an honor to serve Area 35. In service.

The workshop is finalized. All the DCMs in the districts giving presentations have received their topics. I have sent the flier and workshop agenda to Thomas, our Webmaster, to be posted online. I should be able to find a solution.

I attended the November NAAD (North American Alt-Delegates) meeting and invited Justin, our incoming Alt-Delegate, to attend. He showed up along with fourteen other new Alt-Delegates. An interesting presentation was given by Panel 68, Area 29 (Maryland) Delegate Don B., on the Twelve Concepts. How the Steps, Traditions and Concepts are bound together. In all three legacies the first principle is the issue, the second principle is the solution and principles three through eleven are solutions to the problem, finely the twelfth principal is the pay off.

Example (using the Steps):

Step one overcomes our lack of power.

Step two is finding a higher power.

Steps three through eleven is gaining that power.

Step twelve, its outgoing love, its unselfishness, with its joy, and its design for living. Which manifests the spiritual awakening that is the result of practicing the first eleven Steps.

This also applies to the Traditions and Concepts. It was very informative and easy to understand his way of explaining the meshing of our 42 principles; 12 Steps, 12 Traditions, 12 Concepts and 6 Warranties. If you multiply them, you get 12x12x12x6 = 10,368 solutions that will pretty much solve all difficulties in living sober. I found his presentation very educational and inspiring. If you want more information on his presentation, please let me know.

#### **EDITORIAL POSITION & N.L. COMMITTEE:**

**Editor** - The Editorial Chair position is a two-year rotation picked by the incoming Area Chair and either approved or rejected by the Area Committee at the first Area meeting after the Fall Assembly Elections.

**Desirable qualifications:** Current knowledge MS Publisher, MS Word, MS Excel and other misc. computer programs as needed. The person should also consider the time needed to complete the task required. The candidate should have a working knowledge of A.A. as a whole, i.e., prior experience in service work such as G.S.R., D.C.M., or related position.

**N.L.** Committee - The N.L. Committee consists of two D.C.M.s in Area 35. Currently, these have been picked randomly at the start of the new rotation. They also serve on a two-year rotation basis. They assist the editor in communications with other area newsletters, in recommendations on general improvements, and with general problems and implementations of new policies. They may also represent the editor at functions when the editor is unable to attend. Seek advice and help from former N.L. Committee members and editors.

#### N.L. COMMITTEE MEETINGS:

The Committee meets every other month, before the start of the Area Workshop and at Spring and Fall Assemblies. Additional meetings may be called for if needed between these times.

A good flyer should answer the following questions:

- 1. Who is involved or sponsoring the event? Examples:
  - a) AA Group
  - b) District
  - c) Area
- 2. What type of event is it? Examples:
  - a) An open or closed meeting
  - b) Speaker meeting
  - c) Call up meeting
  - d) Big Book meeting
  - e) Workshop
  - f) Conference
  - g) Fellowship (ice cream socials, potlucks, chili cook offs, etc.)
  - h) AA must appear somewhere on the flyer
- 3. When is the event to take place? Examples:
  - a) Date and time
  - b) Does it reoccur
  - Where will the event take place?
    - a) Name of the facility and the address
    - b) Maps are sometimes helpful but not necessary
- 5. Why is the event taking place?
  - The reason for AA events is to carrying the AA message to the still suffering alcoholic (this doesn't have to be printed on the flyer)
  - b) Usually covered in Who and What

\*For safety reasons, if a phone number is listed on the flyer consider NOT putting a name in association with the number.



#### Q: Why list our past Delegates?

#### A: They are a resource to you!

In Alcoholics Anonymous we value experience. Our Twelve Steps did not exist when Bill stepped into the lobby of a hotel in Akron, Ohio. Even after meeting with Dr. Bob and soon founding our program, there were only six steps until the experiences of 100 Alcoholics were summed up. Soon after a book followed, but it was a few years later when the Twelve Traditions were discussed and agreed on. Twelve Traditions that were "hammered out on the anvil of experience". Our past Delegates are a wealth of experience, an interactive living archive if you will. When you plan your next service workshop or need an outside voice to offer help, consider this resource available to you. Some of them even offer great company while fishing!

#### The Delegate's Duties

Though the high point is the Conference meeting, the delegate's job goes on year-round and involves all aspects of the Conference structure. The delegate should:

- Attend the Conference meeting in April, fully prepared. Immediately upon election, every delegate is put on the G.S.O. mailing list to receive Conference materials.
- Communicate the actions of the Conference to area committee members and encourage them to pass on this information, and the delegate's enthusiasm, to groups and to intergroups/central offices. If an area is too large for the delegate to cover in person, he or she will ask area officers and committee members to share the load.
- Be prepared to attend all area, state/provincial, and regional service meetings and assemblies. From these meetings, delegates come to better understand their own areas and can make suggestions for the Conference agenda. Here, too, they come in contact with A.A. members who might not be reached otherwise.
- Help area committees obtain financial support for the area and G.S.O.
- Provide leadership in solving local problems involving the A.A. Traditions.

- Remind G.S.R.s to inform groups and individuals about the A.A. Grapevine and Conference-approved literature.
- Cooperate with G.S.O. in obtaining information—for example, making sure that up-to-date information reaches G.S.O. in time to meet the deadline for each Issue of the A.A. directory and helping carry out the triennial membership surveys.
- Visit groups and districts in the area whenever possible.
- Work closely with committee members and officers, sharing experience throughout the year. After G.S.R.s and committee members have reported on the Conference, learn from these A.A.s how groups and members have reacted.
- Assume added responsibility if the area chair and alternate chair are unable to serve. Or, if an area committee is not functioning effectively, the delegate may take an active role in remedying the situation.
- Keep the alternate delegate fully informed and active, so that the alternate can replace the delegate in an emergency.
- Late in the second term, work with newly elected delegates to pass along a basic knowledge of Conference proceedings and problems.
