

Like everyone else, when you start you think it's such a long time but before one realizes what happened, the rotation's over. Some of the new system to be able to save information to the computer has a start but much more is needed to be done. With the Covid.19 virus epidemic a lot of the things that I would have liked to get a started on were just impossible to do.

Dear Area 35 Chair, PI Chair, Delegate, Alt Delegate, Treasurer and Secretary with cc to Area 36 Officers and PI Chair:

I'm writing about the PI Booth at the MN State Fair in 2021. Having served as a past PI Chair in Area 36, I know that historically Area 35 and Area 36 have partnered in staffing the PI Booth for the entire 10 day run of the MN State Fair. Setting aside Correction work that is done statewide and sharing in the MN Meeting Locator, I think the PI Booth at the Fair is the only other joint 12 Step work we collaborate in. This is simply an observation.

Below you will find the final costs associated with the Public Information Booth at the MN State Fair 2021. The final costs are \$1,941. I respect whatever Area 35 has decided in 2021 regarding contributing to Area 36 towards these costs.

There were a lot of miracles that happened at this year's PI Booth. For example, due to many agencies pulling out, we found that our traditional booth size of 10×10 was increased tremendously! We ordered only two tables as usual, and clearly needed more. We would have had to pay a substantial late change fee to add more. However, HP in the guise of a State Fair worker, had an extra table, and "loaned" it to us. Once skirted, it blended in just like the commercial ones we rented.

All the shifts got filled due to numerous texts, emails and phone calls and phone calls, primarily made by Patrick (PI Chair A36). Thank you, Patrick! Another memorable miracle is that to my knowledge, none of the volunteers representing AA at the Booth in those ten days came down with COVID as a result of doing Twelve Step work at the Booth! Yeah God!

Setting aside Tales of the Miracles, I do need to share with all of you that there were some misstatements, implying that I made as Area 36 Chair to Area 35 Chair, and as reported by the Area 35 Chair, at the Area 35 Assembly on Oct 2-3, 2021, as found in the recent Northern Light Vol XXXX Issue 6 Nov/Dec 2021 page 4. Contrary to what is written, I consistently encouraged Gayle and I, along with Greg and Patrick to have an online meeting to discuss not just the strengths, but acknowledge the challenges of this year's staffing of the PI booth.

I admit my hope was that an initial discussion amongst the four of us would have possibly led to "us", both Areas, deciding to have a Joint Online meeting about the State Fair PI Booth. I know this has not happened during this rotation. It is something that I will be following up with the next rotation of Area 35 in conjunction with conversations with Area 36 officers, ACM, and Assembly.

I think the time has come to objectively step back and review this joint Twelve Step work. This is not about the ever-increasing costs. At this time, I do not have a list of the past 6 or 10 year State Fair PI Booth costs. That could be drawn up if needed. I have observed that more and more Area 36 volunteers are voting with their feet to not give up a couple of hours for the privilege of this 12 Step work. The appeal went out in March for volunteers, and in past years, day captains and district members stepped up quickly and filled those days. The amount of 9th hour recruitment spoke to me and leads me to paraphrase from the Service Manual, "is this service really needed?..." Granted the Pandemic is an issue and some members are not able to volunteer for health reasons. I certainly respect that. I can only share my observations of Area 36's actions. I do not know what the experience(s) of past or outgoing Area 35 PI chairs is for recruiting volunteers.

In closing, I'd like to suggest perhaps this topic lends itself for some of you to bring forward to the incoming officers to have a conversation on.

May you have a fruitful ACM (12/5/21)! Good Luck to each of you, as your rotate on to whatever new opportunities await you.

Minority opinion: Do we have to have a hybrid if terrible weather, or can Zoom only be an option? Are we limiting ourselves by specifying Zoom app as our only virtual option?

NEW BUSINESS

FOC Report – Christine G: Reports have been reviewed and reconciled Area 35 financials period 5 and 6. All money is accounted for. Justin is doing a fantastic job with the books.

Past Delegate Service Discussion – Gayle: we are all human beings, this is past. We try not to attack people. Please talk about what was done, not about who did it.

Discussion: I've never seen a past delegate sit for chair. I think it should've been talked about before it was done. This was brought up in discussion at Aug ACM, minutes state "This is just a conversation – no vote now, discuss in groups." This was never discussed in our groups.

I brought up the conversation at August ACM about past delegates serving on other positions. I was not a voting member so I couldn't suggest a motion. I felt that it wasn't meant to be underhanded, the very next day at our district meeting there were 19 people and 18 of those people were at the fall assembly. They all had a positive experience and were ok with what happened at the assembly.

I've learned from my sponsor and key mentors over the last 36 years that I need to use the time-tested principles to evaluate any troubling situation, rather than my own self-directed will and desires.

To answer: "Shouldn't there have been discussion with the body and a vote before a past delegate would be allowed to stand for a position after they rotate out?" While there can be conjecture of what is or isn't in the Actions Booklet and its final authority, surely our history, our experience, alternatives available, objections during the process, and likely numerous other critical factors, the answer surely is "Yes".

Third Legacy Procedure, Actions Book. AA is full of trials and tribulations, it's nothing new. The body decides this. We have to fix this and move forward. If this was known, why didn't we have a conversation earlier? This is a discussion that the area needs to have. This is an opportunity

opportunity for growth. As a GSR, I was not at all confused. As a GSR, I was very confused. With Third Legacy Procedure, it was decided. Do we believe in the Third Legacy Procedure or do we not?

I nominated Christine – there was no ill intent, I apologize if that was the message. I think we've spoken and if we're wrong, we have the right to be wrong. I would hope that we could still move forward.

We put this in front of the voting body – GSR's DCM's, Area Committee members, and they spoke. I have not had one GSR, DCM, ACM, Area Officer question this election result. Let's work as a unified group: here are my concerns, here are my objections and then move forward. This is a conversation that should happen in front of the assembly this spring.

AREA OFFICERS & ACTION COMMITTEE NL REPORTS

AREA DELEGATE – Steve L

Howdy Ladies and Gentlemen, I attended the Area workshop in Detroit Lakes, and it is one of the few workshops that a written report could never do it justice. It was something that had to be experienced. All seven Districts that gave presentations were well prepared and the mics were always full with people asking questions or sharing experience. Mike L., our WCR Trustee gave inspiring and informative talks and shared his story with us. There was no dead space between presentations and Justin kept everything moving smoothly and on time. The only hiccup being the ability to eat in a timely fashion. Because of covid, the hotel and nearby eateries were understaffed, making service slow. All I can say is - kudos Area 35 you put on a fantastic workshop!

Since the first of the year, I was assigned to the Literature Committee at the General Service Conference (GSC). I've started to receive lots of info from the GSO about how the conference is held, past actions the Literature committee has had approved at the GSC, a preliminary list of agenda items for the 72nd conference and literature committee specifics. I'm expecting a lot more correspondence including this year's agenda items which come out the week of February 15th and will be posted on our website. I will email all DCMs the password which they can pass on to the GSRs so they can download and review the agenda items before the Area assembly. DCMs, please let me know if you want me to attend your District meeting or special agenda meeting in person or by zoom to go over the agenda items with your district before the spring assembly.

The West Central Regional AA Service Conference (WCRAASC) will be in St. Louis Park this year March 4,5 and 6, 2022. It won't get any closer for five more years when it's in Area 35 again. So, I encourage all GSRs, DCMs and our Area Committee to attend. Look at the flier for details. The hotel is filling up. The WCRAASC committee has increased number of twin beds in the block of rooms. If you were told and paid more than the \$99 per night room rate, call the hotel and ask for the front desk, they are supposed to correct your room rate, they did mine. If you have trouble let me know. On the bright side, a hybrid option is being considered as I write this. Check the reginal website www.wcraasc2022.eventbrite.com often for changes. I will pass on the updated information to the DCMs to pass on as I receive it. If you don't know what the WCRAASC is, it's a gathering of AA members from the seven states-eight Aeras in our Region who discuss the agenda items that will be discussed at the GSC. There are also workshop breakout sessions and presentations. The WCRAASC is asking for volunteers in twohour blocks for coffee, registration, and greeters. If you are planning to attend and are interested, go online to this address bit.ly/WCRAASC.

There is a change to the address for sending contributions to the GSO. Throw away all your birthday and contributions envelopes. The new address is P. O. Box 2407, James A Farley Station, New York, NY 10116-2407. I have asked Heidi to have a permanent posting of the new GSO contribution address in the Northern Light for the next year (thank you Heidi). The reason for the change is GSO has outsourced the opening and possessing of checks to a third-party bank (Lockbox). It will give a cost saving of about \$80,000 per year and redistribute man hours from processing contributions to other vital duties at the GSO. This is not a new system it's been around for a while and is safe, secure and they stated they will be able to differentiate between self-supporting contributions and outside moneys.

Here are highlights from the January Reginal Delegates meeting.

- Finances first, Grapevine is projecting a \$61,000 surplus this year. The budgeting had planned for a \$340,000 loss.
- The Reserve Funds is now sitting at 8.5 months of reserve. At the end of 2019 it was at 7.9 months. The target is 9-12 months of operating expenses.
- Mike moved on to the LaVina Strategic Planning session. There is a sense that perhaps applying the regular Grapevine approach is not a viable one for LaVina. When comparing the distribution process for Plenitude, in Mexico, it was noticed that they don't rely on a subscription approach. Plenitude utilizes their magazine reps to sell the magazine directly at various locations. It is thought that this may be the model that would need to be adapted for distribution of LaVina.
- EDW (Equitable Distribution of Workload). The Literature Committee
- has such a large workload that some of their items will need to be distributed to committees with a lighter agenda. For example, Corrections has a lighter agenda than usual,
- We discuss SMF209 (The Safety & AA document that was distributed in September). It's a service piece that has been in the works for little over a year. The feedback that Mike has received is that it has crossed the line from sharing information to establishing policy.
- Dennis also shared that his term as Regional Admin will end at this year's General Service Conference when a new Regional Admin will be elected by the regional delegates. Dennis explained that he only served a two-year term to get the position going. The full term is a four-year term, which is offset from the Trustees term to help provide continuity to the region. Dennis also noted that the current delegates will need to poll the past delegates in their areas to see if any have an interest in standing for the Regional Admin. position.

I have sent a copy of the SMF 209 to the DCMs. If you wish to read it online, you can go to aa.org, search for SMF 209 and download the

document. We might need to have a discussion on this at the Feb. ACM or the spring assembly. If any past delegate would be interested in the Regional Admin position let me know, so I can put your name forward for nomination.

If you have any questions reach out and I'll try and find you an answer. In service, Steven \boldsymbol{L}

PS: the SMF-209 safety service bulletin has been taken down as of 1/21/2022. A rewrite is in progress, and it needs to be approved both by the lawyers and AAWS board before reposting.

ALTERNATE DELEGATE - Justin W

Greetings Area 35. And thank you so much for another opportunity to serve as your Alternate Delegate for this rotation. It is an honor and a privilege and a real gift to be asked and trusted to do something for Alcoholics Anonymous. My sentiments are in line with Doctor Bob... "I do it for four reasons: 1) Sense of Duty. 2) It is a pleasure. 3) Because in so doing I am paying my debt to the man who took time to pass it on to me. 4) Because every time I do it I take out a little more insurance for myself against a possible slip."

Starting at the beginning of the year here I spent some time reading the final report from last year's conference, the December highlights, as well as the new safety piece <u>Safety and A.A.: Our Common Welfare</u>. If anybody out there hasn't looked at this last document, I would highly encourage it. I'd suggest it is really good hands-on training for the application of our 3rd and 10th traditions. Its contents are in direct opposition to both principles.

But most of my time was spent getting a handle on my new responsibilities as chair for our Area 35 Annual Service Workshop. All of the arrangements with the hotel were made previous to my election by Steve, but there were a considerable amount of logistics left. I did reach out to district 3 to confirm that we were going to have volunteers for coffee and registration. Thanks so much to Gene for accepting the responsibility and for coordinating the volunteers. As well, thank you to Districts 2, 4, 5, 6, 7, 11 and 13 for showing up and presenting like they said they would. Someone asked them to do something in AA...and then they said yes...and then they showed up and did it! It's a miracle that we're all like that now...dependable...behaving like adults! One of the things I learned was that rotation is important because that, in the middle of the second year, we finally figure things out, then we rotate before we can do any damage! I also learned that the difference between a bleeding deacon and an elder statesman is that an elder statesman has bled out. (Smile emoji here)

District 6 showed us that it is possible to have fun in sobriety and in service to AA. They put on a great presentation. District 4 talked about how groups handled changes during Covid. Some groups temporarily stopped having meetings, some kept on meeting, some went to Zoom, and some went to hybrid meetings.

ARCHIVIST – Marc N

I am Marc N, an alcoholic, sober since about 8:15 this morning, same as many mornings stacked end-to-end. I am also your incoming Area 35 Archivist. Many things have changed during my sober days, it will be good for me to look back at our history. Hopefully many memories have been preserved and many more will be.

As I step into this role, I am excited to look into the history of AA in northern Minnesota. I am working with Renell P. (incoming Archive Chair) to receive the digital files from Peter T (outgoing Archive Chair), to continue the search for new archive storage space, and then to move the archive materials. After the archives are moved becoming familiar with what is included in the archives will keep the committee and I busy. I read through the Actions Book items. I have heard good things from the people who worked with the archives in the past! There have been quite a few decisions made regarding the archives over the years. It will be interesting to determine what items can be digitized and how to make that happen.

As the first item of business, I am working to get the archives moved from current storage location to a location that meets a few parameters: 300 to 400 square feet

Space and utilities for work such as sorting and digitizing Climate controlled, heat and AC Accessible 24/7

After finding a heated storage locker at a low price and presenting it for review by peers (officers, DCMs, GSRs, and more) and then turning away from that storage unit, I have found that office space might be more suitable and more available than climate-controlled storage lockers. Climate controlled storage units for the most part are lighted only, do not have electric power available, and have limited access this would make onsite archive work difficult. There is a drawback of office space, that square footage is often more than needed. The upside to office space is that there could be space for work area as well as storage. My focus of search has been near Brainerd, but I'm open to suggestions. Lowest price listed for office space is \$1.00 per month per sqft. For the office unit rental, we would need insurance, electric, and heating fuel, water/sewer and phone would be optional. There are several units in or near Brainerd, but with space is more than we need and would be high cost.

It might be worthy of note that during peer review there were suggestions about utilizing office space for more than just archives, that there could be storage for materials such as Northern Lights, Literature, or for sorting and staging mailings.

At this time, the search for space continues. If you know of available space or know of a shared space partner please let me know. In Unity and Service, Marc N.

GSR Sharing Session

Vote was taken to have an GSR orientation and one sharing session at the Spring Assembly.

Topic: Problems Other than Alcohol

We read out of the pamphlet to get discussion going. Many questions listed. Discussion:

- AA worked for me even though I had other addictions. Because I was received with open arms I wanted to be with the people of solutions.
- This is a slippering slope solve with drug addicts what drug addicts could cause a problem for newcomers.
- We all have mental health and life issues. Love and acceptance in AA
 works. Take them aside afterward to guide them to what is available
 and let them make the choice.
- Should not be about differences but about the "solution". AA is beneficial for anyone willing.
- BB says can't make a non-alcoholic a member. We can't save everyone.
- Our philosophy as I understand, we continue to help anyone who asks for help. We share the message of the meeting you are attending.
- Steps are important. Just keep to the Steps.
- If I come for help a member's responds to that need for help. Together define the help they need.
- Early AA Bill W. had foresight that AA is for alcoholics. AA is pure AA. One can be addicted to many other substances and one of them is alcohol they can be there as a member.
- We can solve addictions together with the Steps, but one should not call themselves an AA member.
- We must never ask a drug addict to leave AA. Pull aside after the meeting and guide them to what approach might fit them best.
- We had a prison parolee attend out meeting. He left with a phone list, and he called several members of AA on the phone list and threatened lives. Be careful to give out personal numbers as someone's first meeting. They were directed to always get law enforcement involved.
- Introduce alcoholic/addict. We can help others with dual issues. Not a negative.
- The 12 Steps work for just about anything and everything. But we should refer them to those with similar addictions/issues.
- I stayed on AA task with Steps and Traditions. Didn't know I was an alcoholic, but "they" gave me the benefit of the doubt and I am recovering.
- It is very difficult to find other Step programs in rural areas. We focus on the similarities and the solutions. We need to hold out our hand to get them started.
- I go to St Paul meetings, and they are very diverse. It seems to work because their primary purpose is to practice the 12 Steps.
- Great to have an "adult" conversation about these various thought-provoking issues. This issue is tough, but we need to discuss.

Session and Vickie, DCM from District 11, volunteered to be the Secretary. We introduced ourselves including the district and towns we were from.


The questions and responses were as follows:

How do DCMs communicate information to the Group? Have a website with a calendar of events. It looked like 4 of the 10 groups had websites. A lot AA information is sent through email. Encourage GSRs to read their email and bring that information to their groups. Most events have flyers that can be read at meetings. Put a flyer in the northern lights. Use snail mail for those who do not use electronic communications. Use text messages to communicate. Use the Area35.org website. Read and use the Northern Light.



EDITORIAL POSITION & N.L. COMMITTEE:

Editor - The Editorial Chair position is a two-year rotation picked by the incoming Area Chair and either approved or rejected by the Area Committee at the first Area meeting after the Fall Assembly Elections.

Desirable qualifications: Current knowledge MS Publisher, MS Word, MS Excel and other misc. computer programs as needed. The person should also consider the time needed to complete the task required. The candidate should have a working knowledge of A.A. as a whole, i.e., prior experience in service work such as G.S.R., D.C.M., or related position.

N.L. Committee - The N.L. Committee consists of two D.C.M.s in Area 35. Currently, these have been picked randomly at the start of the new rotation. They also serve on a two-year rotation basis. They assist the editor in communications with other area newsletters, in recommendations on general improvements, and with general problems and implementations of new policies. They may also represent the editor at functions when the editor is unable to attend. Seek advice and help from former N.L. Committee members and editors.

N.L. COMMITTEE MEETINGS:

The Committee meets every other month, before the start of the Area Workshop and at Spring and Fall Assemblies. Additional meetings may be called for if needed between these times.

A good flyer should answer the following questions:

- 1. Who is involved or sponsoring the event? Examples:
 - a) AA Group
 - b) District
 - c) Area
- 2. What type of event is it? Examples:
 - a) An open or closed meeting
 - b) Speaker meeting
 - c) Call up meeting
 - d) Big Book meeting
 - e) Workshop
 - f) Conference
 - g) Fellowship (ice cream socials, potlucks, chili cook offs, etc.)
 - h) AA must appear somewhere on the flyer
- 3. When is the event to take place? Examples:
 - a) Date and time
 - b) Does it reoccur
- 4. Where will the event take place?
 - a) Name of the facility and the address
 - b) Maps are sometimes helpful but not necessary
- 5. Why is the event taking place?
 - a) The reason for AA events is to carrying the AA message to the still suffering alcoholic (this doesn't have to be printed on the flyer)
 - b) Usually covered in Who and What

*For safety reasons, if a phone number is listed on the flyer consider NOT putting a name in association with the number.

Q: Why list our past Delegates?

A: They are a resource to you!

In Alcoholics Anonymous we value experience. Our Twelve Steps did not exist when Bill stepped into the lobby of a hotel in Akron, Ohio. Even after meeting with Dr. Bob and soon founding our program, there were only six steps until the experiences of 100 Alcoholics were summed up. Soon after a book followed, but it was a few years later when the Twelve Traditions were discussed and agreed on. Twelve Traditions that were "hammered out on the anvil of experience". Our past Delegates are a wealth of experience, an interactive living archive if you will. When you plan your next service workshop or need an outside voice to offer help, consider this resource available to you. Some of them even offer great company while fishing!

The Delegate's Duties

Though the high point is the Conference meeting, the delegate's job goes on year-round and involves all aspects of the Conference structure. The delegate should:

- Attend the Conference meeting in April, fully prepared. Immediately upon election, every delegate is put on the G.S.O. mailing list to receive Conference materials.
- Communicate the actions of the Conference to area committee members and encourage them to pass on this information, and the delegate's enthusiasm, to groups and to intergroups/central offices. If an area is too large for the delegate to cover in person, he or she will ask area officers and committee members to share the load.
- Be prepared to attend all area, state/provincial, and regional service meetings and assemblies. From these meetings, delegates come to better understand their own areas and can make suggestions for the Conference agenda. Here, too, they come in contact with A.A. members who might not be reached otherwise.
- Help area committees obtain financial support for the area and G.S.O.
- Provide leadership in solving local problems involving the A.A. Traditions

- Remind G.S.R.s to inform groups and individuals about the A.A. Grapevine and Conference-approved literature.
- Cooperate with G.S.O. in obtaining information—for example, making sure that up-to-date information reaches G.S.O. in time to meet the deadline for each Issue of the A.A. directory and helping carry out the triennial membership surveys.
- Visit groups and districts in the area whenever possible.
- Work closely with committee members and officers, sharing experience throughout the year. After G.S.R.s and committee members have reported on the Conference, learn from these A.A.s how groups and members have reacted.
- Assume added responsibility if the area chair and alternate chair are unable to serve. Or, if an area committee is not functioning effectively, the delegate may take an active role in remedying the situation.
- Keep the alternate delegate fully informed and active, so that the alternate can replace the delegate in an emergency.
- Late in the second term, work with newly elected delegates to pass along a basic knowledge of Conference proceedings and problems.
