

Area 35 Fall Assembly Minutes Crookston, MN October 1-2, 2022

Call to Order: Area Chair called the meeting to order at 1:00 p.m. on Saturday, October 1, 2022, and opened with the Serenity Prayer. There were 105 people in attendance, 97 in person, 8 on Zoom.

## OFFICER REPORTS

## DELEGATE - STEVE L

Good afternoon, Ladies and Gentlemen, It's great to see everyone again. I have enjoyed the travel to all of the Districts in Area 35 that wanted to hear my report on the GSC. WOW, you guys were great. Great questions, great comments and most of all the great hospitality and warmth you showed me. Thank You. If anyone missed my GSC report, I'll be giving it after we adjourn tonight for anyone who wants to hear it. The GSC final reports are out in PDF format. I emailed the Final Report to all the DCMs and hopefully they have passed them on to you. If you need a copy, let me know and I will send one. I was hoping the printed version would be here by the time of the Assembly.

I passed on to the conference coordinator the four proposed agenda items the Area voted to submit. I also submitted two other agenda proposals. One was to shuffle the pages of the Daily Reflections Book. Not to change any topics or words just shuffle the pages. The other proposed agenda item was from me. During a joint zoom meeting with the Conference Literature (CLC) and Trustees Literature Committees (TLC) which was held after the ACM in August, the subject of using QR codes was brought up. It seems that the TLC had discussed the potential of using QR codes for an alternative communication for pamphlet information, the same as we on the CLC had discussed. However, the Trustees felt they couldn't proceed looking into alternative formats using QR codes without the fellowship asking about other formats to make pamphlet information available. So, I sent a proposed agenda item in.

There were approximately 150 proposed agenda items submitted this year for the 73rd conference. Over 25% of these have to do with overturning 3 advisory actions from the 71st GSC:

Changes in the 12x12

Changes to the Preamble

The translation of the BB into plain and simple language.

It will be interesting to see what makes it to the GSC after the Trustees sort through them.

The Trustees PI Committee (TPIC) must have made the suggested changes to the AA Membership Survey that was discussed during my GSC reports. The Conference PI Committee (CPIC) has sent to me a list of randomly picked groups to partake in the survey. Our Area was assigned eight groups to take the survey. Out of the first eight groups, I was only able to get in touch with two of the groups. The other six groups' contact information was inaccurate, discontinued numbers and such. In the second batch of eight groups, I was able to confirm and get a thumbs up on seven groups wanting to participate in the survey. Six groups are doing it by paper, and one has done it online. I have received the paper surveys and during the assembly I will be getting hold of the DCMs to enlist their help in distributing the surveys. This is a great example on why it is important to keep our Group Record's Secretary up to date on your group's information and be linked to AA as a whole. The survey is not giving a census however, it is used to get a snapshot of an AA across the board. They do use the survey to analyze for trends, but since the last survey was done in 2014 and coming off the pandemic, many groups are unreachable/unresponsive so, we are getting a new baseline to see how well we are reaching alcoholics.

started cutting away at things and got back to the \$1.2 million deficit. Keep in mind we had a surplus last year of a little over a million. That surplus should wipe out the deficit this year and balance it out. We are seeing spikes in shipping charges as well which add to the costs. Group contributions are on pace to hit \$11 million again. Initially, we had budgeted \$10 million. Those extra group contributions are offsetting the loss because of the increase in the COGS.

The WCRAASC's flier is on the table, and it will be posted on our website. The WCR is supposed to have a reserve of \$9,000 for seed money for the next WCRAASC. Right now, we are \$3,000 short of that amount. A big chunk of the shortfall was because Area 36, our neighbor to the south, spent \$2,000 on unnecessary sign language interpreters, along with the extra expense of making it a hybrid meeting. We WCR Delegates have to arrive at a registration fee for 2023, the \$20 might not cut it, the fee might be increased. We have formed an ad hoc committee to go through the West Central Region A.A. Service Conference Host Planning Guide to better help Areas with hosting the WCRAASC. You can be very proud of the Service people we have; they have their shit together.

I was in communication and working with Area 36 Chair for the Joint Meeting that we had on September 18th via Zoom. There were about 20 people total in attendance and the general consensus was they would like to see us get together and meet. We will be having some conversation on this under business. Even though we did not have our joint committee breakout sessions, I would encourage you to reach out to your Area 36 counterpart if you have not done so already. They will be rotating in January, and it will give you an opportunity to meet the new chair and share some of your experience with them.

I have been working with Area 35 Correction Chair and have signed the con-

Some changes have been made at GSO. Marlen G is our new controller for the GV, as I explained in my GSC report, she started Monday 9/26/22. She had been our vendor from Your Part Time Controller; the accounting firm we had been using to handle the books for the Grapevine. We are saving about \$120,000 a year bringing her on full time. Karina C has moved over to AAWS from the GV's La Vina assignment. She is now at the Group Services Desk. She is also our regional correspondent. If you call in from the West Central Region, you will get connected to Karina. La Vina is going to miss her.

Both of the Companies - Grapevine and AAWS are having some issues on the financial side. AAWS (our publishing Company) is affected a bit more due to the volume of material they sell. The more they sell, the lower the profit margin is. The Cost of Goods Sold (COGS) has tripled this year and has caused a lot of pain across the budgeting process. COGS defines our publication expenses. GV expenses are \$159,000 over what we had budgeted. There is going to be a price increase of the top ten Grapevine books starting the first quarter of 2023. Hint, buy now! On the AAWS side, we budgeted a \$1.2 million dollar loss. At the July Board weekend, the loss looked like it would double. AAWS went to work, got their razors out and tract for coffee being served at the Statewide Corrections Workshop that will be held in St. Cloud on October 8th.

Webmaster, Audio Tech and I have been talking and had a meeting on Zoom for the Fall Assembly. I feel we have a decent system down and hopefully it be a good experience for all. We did the best we could do with the small amount of time we had to plan. Please be patient and understanding as we navigate our first hybrid event for this rotation. We will be moving slower during motions to ensure we get it typed correctly and posted for Zoomers to vote.

On Saturday, September 24, I closed the Area Inventory and sent the results to Ted S. for his review. We had 26 responses on the online survey. We will have a sharing session Sunday morning on ideas on how to conduct the review. I would like to hear from the assembly on some ideas for how to go about it.

I will start working on facilities for 2024 and 2025 assemblies. 2024 Spring Assy is Zone I, which is the Zone we are in this weekend and encompasses (Districts 1, 2, 16, 21) 2024 Fall Assy is Zone II (3, 4, 15). I am inclined to look at venues that we have used in the past, that are affordable and that I know meet our needs. It is challenging going to facilities that we have never been to and making sure the space works and that we have enough breakout

Area Chair receives all of the contributions and makes the deposits. We have seen a bit of an increase in contributions received without a group number. One of the things we need to remain focused on the making sure that each contribution has the group service number written directly on the check so that we can credit the contribution properly in the system. Each group should be using the Area Income, Expense and Contribution report to verify that their contributions are being accounted for properly.

### COMMITTEE CHAIR & DCM REPORTS CPC – GREG C

Since our last gathering in Aug, I have been working with a couple of Districts who are without a CPC chair to reach out to various Professional groups. One of these was in District 4, where I was asked to meet with their HR Director and the company Chaplin. We discussed a variety of topics relating to Alcoholism, the AA program and how we might provide assistance as they move forward with employee out-reach programs. One is to meet again, this time including ownership and management to share a broader over-view of the AA program, what it is/what it isn't...and also, they provide a monthly informational program for all employees on things like Health, finance, insurance, etc. We might be able to do one of these on an annual basis.

One of the topics discussed in our initial meeting included the MN Statutes for drug and alcohol testing policy. Subd. 10.Limitations on employee discharge, discipline, or discrimination. It makes for some interesting reading. It is an area that we need to be very aware of as it begins to involve more individuals within any company and an initial intervention to provide help can result in eventual termination...something we certainly don't want to be involved with. I have not attended other district meetings but hope to start. I was able to attend the Heartland Roundup September 9th-11th near Park Rapids which had more than 300 in attendance with 4 AA speakers, 1 Al-Anon speaker. I am looking forward to the January service workshop in Duluth.

We have Open Corrections and PI positions. I am ready to learn how to utilize the area resources for our district.

### **AREA INVENTORY**

At 2:45 p.m. on Saturday, Area Chair got the inventory session started. She explained that we would be recording all the comments exactly, only as they relate directly to the inventory questions, since the written responses were printed exactly as written on the online survey. There will be a sharing session on Sunday to discuss how we will proceed. There are eleven questions in the Inventory. Nine minutes will be allowed per question, and two minutes will be allowed at the mic for each person sharing. Responses will alternate between those at the Assembly in person and those on Zoom.

Ted S. began the Area Inventory.

Is the Area communicating and sharing information, in an effective and timely manner, with the Groups and Districts to prepare them for Area Assemblies and Committee Meetings?

The calendar of events wasn't working properly, but it is now fixed. Now you should be able to go on and see the attachments.

#### What keeps groups from sending GSRs to Area Assembly? Is adequate opportunity given to all to speak and participate in Area Assemblies, workshops, and activities?

- Two groups in District 13 couldn't afford to send GSRs to the Assembly. Zoom is the solution.
- District has prudent reserve. Districts should help financially struggling groups out if funding is available. It is a District responsibility.
- People need to put more money into the hat. Discuss the 7th Tradition responsibility at your group.
- Groups don't understand the responsibilities of a GSR. Sometimes GSRs go to Assemblies and the groups don't want to hear about when they get back. They aren't interested in AA beyond the group. How do you get them interested?
- Talk about the 7th Tradition. One dollar is not enough. It is an individual responsibility. Explain how costs are going up. The price of a drink or a beer is higher than it used to be. One dollar won't even pay for the group's coffee. Keep talking about putting more money in the basket.
- One member said his group is active. He volunteered to be the GSR. GSR is the most important position because it is the connection to the District, the Area, and to GSO. He will be grooming the next GSR to take over. It is important to teach new GSRs how important the position is. Need new people so we can develop leadership. People will move on to new positions, so we need people coming up to fill positions.

Are services that are provided by the Area still purposeful, effective, and prudent? How can they be improved? *IE. Northern Light, aaminnesota.org, Area35.org, archives office/storage space, financial reports, AA literature, Grapevine literature, audio/recording equipment.* 

- Area Chair stated that it is her responsibility to see that events are publicized. She prints flyers for events, has them put on the website, on the information tables at events, and sees that they are uploaded to the Area calendar.
- Webmaster stated that we are doing the bare minimum with technology. There is a lot more we can do. He is working to make it better. Overall access can be improved using technology.
- For years it was possible to go to events calendar and print out flyers for events. Calendar has not been available for the past year and needs improvement.
- One person said she still wants the Northern Light in print.
- We are wasting paper on financial reports that are printed up six times per year. The reports are thick, and paper is expensive. Phones are becoming everything. We can use them to read literature, Grapevine, etc. QR codes are the upcoming thing. They are fast, use less paper, and can help more alcoholics.

# Is the Area spending 7th Tradition contributions prudently? *Consider* the following: Expenses, Committee work, Communications (financials, mailings) and Accommodations (coffee, room rates, Area Committee Meetings, Assemblies)

- The Area Chair and the Delegate are the only ones that should be sent to the WCRAASC and the Forum. The rest of the people can pay their own way.
- In looking at the budget, costs added up for the Forum and the Conference in 2023 add up to more than \$22,000. Room rates for budgets are not consistent. Travel is more than \$9800. Could save money with Zoom.
- We put things in the budget but don't discuss them except for the occasional comment. We used to see how much we had and then decide who to send. We would give them \$100 or \$200.
- We send people to the WCRAASC to become educated, and to network with people, which is important. We need people to become knowledgeable about the Traditions and Concepts, which we deal with in service. Mingling in the halls is as important as the meetings and presentations. Ask groups if they want good information on the agenda items. Delegate travels to districts when the agenda items come out, and then again after the Conference to give reports. Is paying for travel for the Delegate worth it? Groups approve the Area budget. They need to step up and support it. Groups can say what they don't want to spend money on before approving the budget.
- We need a definition of "Other" in the budgets. What items are covered under "Other"?

#### How are we cooperating with Area 36 (Southern Minnesota)? How can we improve? Some areas we have cooperated are Joint A35/A36 Workshop, State Fair Booth, Statewide Corrections.

- Need clarification of what is meant by "cooperation".
- How can we work together to carry the message?
- We have statewide cooperation with Corrections committees, and we cooperate on the Public Information booth at the State Fair.
- Professionals we want to work with don't see us as two Areas and don't care who contributes what to our efforts. They want to know how they can get alcoholics to us. We need to present a unified voice to the State of MN. How can we improve?
- Facilitator Ted S. Trying to work together in a state is not uncommon. California has seven different Areas.
- Who heads up the cooperation?
- Area Chair We have three joint efforts with Area 36 the State Fair, the Joint Workshop, which we haven't done lately, and Corrections. The State Fair falls under Public Information, the Joint Workshop is something the Area Chair heads up, and Corrections, which of course falls under Corrections. In March there will be new way to cooperate with Area 36, a statewide Treatment conference, which will be the

- Need to develop leadership.
- Need strong sponsorship, strong service, need to be "voluntold", need healthy groups that follow the Steps and Traditions. Many groups are not structured and are not healthy. How do we fix that?
- One person became a GSR, the group had no money and didn't understand what a GSR does, didn't know what District meetings are. Group didn't have money, so he paid his own way. Didn't understand the 7th Tradition and that \$1 is not enough. Now he knows that the GSR is the most important position. GSR is the backbone of AA. Two words that come to mind are gratitude and sponsorship.
- The legacy of Recovery comes before the Legacy of Service. Communication to the group is necessary, and more money is needed in the basket. Talk about sending the GSR places in the budget. Explain how important the GSR is. It is not the District's responsibility to send GSRs to events, it is the Group's responsibility.

- Treatment chair's responsibility.
- The word cooperation brings up a question, which is "Are we in harmony with Area 36?" Are we in unity with Area 36? We need to have unity in order to best carry the message. What can I do?
- One person has talked to Area 36 Chair. A35 and A36 are talking a lot, which is helpful. They have gone through a lot this year.
- We have less than 50% representation by GSRs here, which is something we need to consider. People in service have lofty goals. We need to serve our own districts first. We need to get our local people involved. How do we get more participation?
- We need to place Principles before Personalities and remember who we are working for the alcoholic who still suffers.

## When Area decisions are made, is there correct balance between group conscience and the tradition "Right of Decision?" (Concept III)

• District 6 asked themselves the same question. They decided they were acting businesslike and would try "attraction rather than promotion". They started focusing on fun. Their participation is up, donations are increasing, there are more people to have an informed group

- conscience about things. Without representation at the Area, people feel like they are not being heard.
- Read Concept III.

#### Are the Traditions and Concepts guiding our decisions and actions when we conduct business at assemblies?

- Only 1/5 of groups are represented here. He has told his groups that a minority of the groups in the Area are making decisions, voting, and electing people. The minority is ruling. That is not a true representation.
- One person stated that he has to work on keeping his own house in order to keep from making wrong decisions. Goes back to page 164 in the Big Book.
- Another person stated that he doesn't like to lose an argument. If he follows the Traditions and Concepts, it usually works out better. He feels no shame about opinions. He feels better about the issue.

# Does the current format and scheduling, of Assemblies and ACMs, effectively address communication and the business to be conducted? *Consider the following: Length of reports, Assembly topics, Time allowed at microphone, Conducting business, Breaks, Sunday format.*

- Person on Zoom not able to attend in person, so Zoom is essential. If we continue to use Zoom, we need to invest in better technology. She can hear the podium mic just fine, but not the crowd mic. Not hearing everything so might not be prepared to vote if she can't hear everything.
- We should take care of business on Saturday and hear reports on Sunday. The way things are now, Sundays are rushed. People are fresher on Saturdays. Was it ever done that way, and if so, why did it change?
- Would it be possible to form an ad hoc committee to examine and possibly restructure the Assembly format? That would probably require a motion.
- Can we have Assemblies in a central location, always?
- Assemblies used to be in one location. The Area decided to move it around to increase participation. Area is divided into four zones, and events are rotated through the zones. The Area Chair is tasked with coming up with the agenda. If you want change, talk with the Chair. It would be best to have a group discussion on changes. Do we all understand the Rights of Decision and Participation? We need to talk about these things. The Right of Decision means going through the group discussion, and that takes time.
- If we change the order and have business on Saturday, how many would stick around for reports on Sunday? Would people be rushing home to go watch the Vikings game? Rotation was heatedly discussed in the 80's for about a year and a half before it was decided to rotate. This is a common discussion in many Areas.
- People give their reports, and they are put into the Northern Light. Need to be present to take care of the business. It is up to people to stay for the business on Sunday.
- Is it necessary to have the reports read at the mic? Can't we just read them in the NL?

Are Area Officers effectively reporting their activities? Are they making themselves available to groups and districts? Is the Area preparing and providing our Trusted Servants with the tools, equipment and resources needed to effectively perform their duties? What can be improved? Officers are Delegate, Alt. Delegate, Area Chair, Treasurer, Secretary NOTE: Evaluate the positions not the people

- The consensus "yes" when it came to answering questions online.
- One Area Committee Chair said officers not explaining the duties of a position. Help needed.
- Attendee of the Zonal Forum said the face-to-face contact was good. It was helpful to put faces to names. Area Officers are doing a good job.

How are Committee Chairs communicating with their District counterparts? Are they making themselves available? Is the Area preparWhat other concerns do you have that aren't addressed in this inventory?

- This rotation, we are struggling to get GSRs. What can we do to be more attractive? There has been inventory-taking at the mic and in print. We might be the only example of service that people see.
- We are spending too much money. We are not collecting \$0.50 per head. Some groups don't send money anywhere. What do Zoom and Archives cost? Are we overspending?
- Area Chair How can Area Committee Chairs and Area Officers be more helpful to Districts? We need to hear from you what you need.
- How can the Area instill a sense of responsibility in the groups? Sponsorship, and DCMs visiting the groups.
- There were hardships and hard feelings, especially after last fall. It was devastating. We must find common ground. How can we come together and be strong? A strong Area will trickle down to strong groups.
- One member has been in AA for almost 43 years and is extremely proud of people in service. He holds them in high regard. We need to look at the positives. We need to be happy, joyous, and free to attract people.
- Explain the pie chart on the handout. What percentage of the respondents were GSRs?
- One person did not have enough time to bring the inventory to the group.
- How do we improve on the time factor?
- Area Chair Pie chart shows that 36% were GSRs, 20% were DCMs, Area Officers and Chairs were 32%, and District Officers and Chairs were 8%.
- Can we add all the GSRs to the Area Chair's mailing list?
- It is not the Chair's responsibility to communicate directly with GSRs. That is the DCM's job.
- The purpose of an inventory is to look at my life. If DCM doesn't forward information, people can die. It is not the job of Area Officers to help groups.
- Delegate Question to GSRs how many received Final Conference Report from DCMs? Less than half in the room received the report.
- 32% of the members who answered the online inventory. They are not representing a group.
- Emails can go to the Junk folder. Check the Junk folder.
- We need more GSRs! Area Officers and Committee Chairs are a small part of the potential voting pool.
- The number of people in the pie chart is small only 25 people. Doing an inventory is difficult.
- The problems are constant, the same as 40 years ago. We need to have a Higher Power. Gratitude is necessary, and we must keep doing the work.

Area Chair wrapped up the inventory and asked, how do we proceed with our Inventory? Open up the online survey again?

One person said his sponsor is a past Area Chair, and he spoke to other past Chairs. Area Chair is the hardest position. Not in favor of Past Delegate serving as Committee Chair but is in favor of Past Delegate serving as Area Chair.

What about the spirit of rotation? Tradition 12 reminds us to place principles before personalities. Does not want the Area to be bound to a decision. Each Area should make its own decision.

Delegate is just another position.

If the motion is voted down, a Past Delegate will not be able to serve. The Motion will be in the Actions Book.

If they are qualified and willing, why not let them serve? Pick the best qualified for the position.

## Vote: 79 total voting members present in person and on Zoom. 2/3 would be 53 votes needed. Total votes for the motion – 54. MOTION

**PASSED.** Minority opinion: Goes against service manual which says Past Delegates shouldn't serve. This means that a Past Delegate can be nominated for any position.

### Area Inventory Next Steps

Do we want the survey open again online? Not all were aware of online survey and didn't feel heard. Can appoint an ad hoc committee. Being at Assembly was part of the inventory. Online were part of the in-

ventory. Invitations and reminders were sent out, GSRs gave out information. Online survey should be opened up again.

One person sent out multiple emails and thought it needed to be done right away.

An inventory is a benchmark, how do we improve? Need better communication. This inventory is closed, and we can do another one later.

Open the inventory for another couple of weeks.

Close the inventory, look at the info we received, and not discuss how it was done.

What were the results of the 2010 inventory? We should compare and see how we have changed.

One district did not receive the info, no one in the district received the info.

We should compare inventories. Need to consider that questions are different. Should do inventory every couple of years or so.

Area Chair – Who is opposed to opening up the survey again? (No one opposed.) Will put together an ad hoc committee to go over the results.

Ad-Hoc Technology Committee – Web Webmaster – How do we budget/use Office, Word, Excel, etc.? The way we do it is broken. We could use Microsoft for Business for \$3 per person per month. It has all the tools we need. Can use it to make Archives available, can control who has access, can get officers and chairs using the same tools.

We need to improve Zoom capabilities. Need to work on Office tools first. Right now, we are paying approximately \$700/yr. The cost for MS for Business will be a little higher. This proposal is not included in the budget. Have we checked with other Areas? Are we getting the non-profit rate? Webmaster – yes, we are getting the non-profit rate.

Webmaster - We need to have something that is take-over-able by the incoming rotation. The cost will be approximately \$1800/yr. for all licenses, \$750/yr. for online technology. There would be costs for new devices as needed.

If we get the MS system, do we need to have new downloads even if we already have Office on our computers? Is this a network?

Webmaster – Can get Office on all devices – phone, tablet, computer. We rotate every two years. If we use this, we will have continuity, and we can retrieve emails from the previous rotation. Email accounts would rotate to the next people. Same email addresses, new passwords.

Could we use the apps Group Me or What's App?

Webmaster – We have different levels of technical aptitude; email is the lowest common denominator.

Would MS Teams be useful instead of Zoom? Webmaster – It could be useful for small meetings, still need Zoom for big meetings.

Could Districts latch on to this?

Google is not useful. Thanks for all your work.

Each district rotation can draft a financial policy. The district can do a google search on how to draft a financial policy.

Past policy or actions are hard to find when you are handed totes full of past information.

3-ring binder is used keep past minutes.

One district has an action booklet in a PDF format which makes it a searchable document. District pays actual costs for attending area functions.

Past district minutes are saved on a computer although it is hard to find the past action you are looking for.

How can we as DCMs better communicate with and pass information on to the district GSRs and district officers and committee chairs? Email all information and then send a reminder. Email each piece of information separately. Bring this information up at the district meeting. Tell the district that anyone can be on the email list not just GSRs and district committee chairs and officers.

Emails are forwarded to the district email list. Ask past DCMs for their experience. Text information too.

Calling and getting others to communicate with each other. Talk face to face. Check up with GSRs that have drifted away. Sponsor AAs into service and get an AA service sponsor.

Lots of AAs do not know how to use email. Divide up the tasks. Information gets lost transitioning from one rotation to the next. Personally stay connected. With all the spam out there, some of us are hesitant to open emails because it is risky to open files and click on links. There may be new ways to communicate such as computer boards. Communication is done through intergroup in one district. They attend board meetings with intergroup. They depend on others in the district to help communicate.

We are in a culture of change. There are a lot of new communications tools out there. We need to figure out what form will work for a task we want done.

We still have some AAs that we mail information to. Sometimes they do not even answer the phone. Technology has come a long way. Asking questions in the district about communications. Information is sent via email. Sometimes files are so big they are hard to read on phones. There are still people who do not use email and want a paper copy. The area minutes are used to communicate at the district meeting what is going on in the area.

How do you do a district inventory? Download a district inventory from aa.org. One district takes one inventory question a month.

Should we have two DCM sharing sessions instead of participating in the Area action committees?

The intention of the DCMs attending the action committee meetings is to show what the action committees are doing and how to chair an action committee meeting. At rotation time, a DCM can be the next committee chair of that action committee. That person would know what the committee has been working on. In Service Diane R,

Would love to see us mend the fence. Three words that come to mind are gratitude, accountability, and responsibility.

PI Chair – Area 35's part is covering the first weekend. We have had no say in how the booth is run or what is displayed there. Is this the best use of our time and resources?

One group does not want to lose the opportunity for Twelfth Step work.

## Vote will be by simple majority. Those in favor of the motion – 14 in person, 4 on zoom; Opposed – 73; Motion FAILED

Minority voice – Are we reaching the still-suffering alcoholic, or just those already in recovery?

Area 35 will support financially and by staffing the State Fair Booth with Area 36 in 2023

**Delegate Nomination Process Discussion -** How do we elect Delegates? Procedure now is that each district can nominate one person – why is that? Action Book and Service Manual – qualified people are invited to just STAND for election with no nomination needed. Do we need to nominate? What is the history?

We are not missing someone in the pool doing it the current way. Would like more than two people to choose from. Maybe people would like to stand and have no one to nominate them.

In the past, the Delegate was chosen by who could afford it. Later, people were nominated because of personality. Some were elected because no one else wanted the job. Current method in place to take personalities out of it. Can nominate someone from another district.

How many people read the resumés in the Northern Light before they vote? Should we have nominees share their experience before the vote? Not going to "run" for office; need to be asked to serve Maybe have someone from the district take a minute to say why that need

Maybe have someone from the district take a minute to say why they nominated the person.

Area Chair - Will keep this under Old Business

**Northern Light Information -** Northern Light Chair – The NL is limited to 28 pages. Sometimes there is more information than will fit, so we need to determine what to print. What do people want to see in the Northern Light?

Discussion - Want to see more District events.

Can we bring this back to the groups?

One person likes to read District and Area reports.

Area Chair – Will keep this under Old Business; bring back to groups

**2023 Budgets -** Individual budgets were discussed one at a time; total budget to be voted on after all budgets discussed.

Delegate explained his expenses – Other exp. Includes registration fees, \$600 for Conference expenses, District travel costs, room expenses vary and may have increased from last year.

Everything costs more than last year, so expenses increase.

Room rates may vary from budget to budget because some people know that they will be room-sharing. Others budget for rooming alone, though they may wind up with a roommate. Someone's roommate may have to miss the event for one reason or another, so that can be budgeted for. We are using \$5.00 per gallon of gas. Actual cost may be less than that and the expense will be submitted accordingly.

Budgets are estimates. We generally spend less than budgeted. Have to budget higher than what the actual costs will likely be so if something happens, we don't have to go to the groups and ask for more money later in the year.

Treasurer budget could be adjusted when a new treasurer is elected because travel expenses may be different.

This year's budget is higher than last year's budget because the West Central Regional Forum is added in. It is being held in Montana. Webmaster budget does not have the MS Office for Business included.

**Rich motion – Have Kyle move forward with Office 365 to connect DCMs, Area Officers, and Committee Members. Scott seconded.** Discussion – There has been discussion ongoing about records and communications.

Jess made a motion to Table the motion and bring it back to the groups. Rachel seconded.

# Jim R. – We had this discussion at the ACM. Made a motion that "Area 35 not participate financially or by staffing the State Fair Booth." Scott seconded the motion.

Discussion: If someone wants to serve, can participate directly with Area 36.

This is a way we can participate with Area 36. This is a state fair – we can find people and money

Is the motion for perpetuity or for this coming year? Are we utilizing the booth? No. We need visibility. Make the booth educational and show what the history of AA is in MN. Need to participate in booth design. It is all of MN, people from up north do visit. We need to continue to support the booth.

Family members more often pick up pamphlets; we need people to staff the booth.

In the past, we had four people from each district; we had half of the days at the booth. It is hard work, but very rewarding. We need visibility. This is service work, and it needs effort.

Next March, professionals will meet, and AA is invited to participate. The more we work with Area 36, the more we could improve the relationship.

Vote – Motion to Table passed with 2/3 majority, substantial unanimity. Motion tabled until Spring Assembly.

Budgets this year included Archives storage, WCRAASC in Nebraska, and Forum in Montana. Why are we sending everyone? Action Book job descriptions require everyone to attend.

There were no questions on budgets for Alternate Delegate, Area Chair, Secretary, Northern Light, Group Records, Literature, Public Information, Corrections, Treatment, Grapevine, Cooperation with the Professional Community, Archivist, Archives, Area Events, Financial Oversight Committee, and Sound Tech.

Total budget for 2023 is \$89,464.21.

Treasurer – 160 groups have contributed this year. To meet this budget with only 160 groups contributing would require each group to contribute approximately \$560.00.

If we have a \$13,000 deficit so far this year, how do we cover that? Treasurer – From now to the end of the year, we have only the ACM for

expenses. This time of year, groups contribute more.

Groups need to be reminded that things cost more than they did before. We need to educate the groups. Now is the time to cut expenses if we want to lower the budget. If we pass this budget, we are committing to cover these expenses.

Why is there such a big difference between Fall Assembly and Spring Assembly? Amenities cost more, and the venue costs more due to Fall being an election Assembly.

If we want the best people, we need to send them places. Need to trust our trusted servants.

If the checkbook won't allow sending everyone, can limit who we send.

Motion to approve the budget made by Jess. Jeff seconded. Vote – Only one opposed to passing the budget. Budget PASSED. Minority voice – I only spend what I have. Don't know if the money will come in. Have Committee go back and revise budget. Rather not have "hopeful" budget.

## Treasurer Election - John D made a motion – All Area Officer positions shall have an Alternate Officer. Motion seconded.

Discussion: If all officers have alternates, expenses will be doubled. Wouldn't send alternates to events, would have alternates available in the event someone had to resign.

Only the Area Chair, Secretary and Treasurer would have alternates. **Vote – Only four voted in favor. Motion Failed.** 

Minority voice – motion was made due to the Treasurer resigning and having the Chair and Alternate Delegate fill in, which is against our own rules.

#### Election – Marvel nominated Vicki R.; Vicki accepted. Tom nominated Terry P.; Terry accepted.

Justin W. made a motion to pause the Treasurer election and have the two nominees give a brief service resumé. Denise R. seconded. Steve L. offered a friendly amendment to have the nominators give reasons why the nominee is qualified. Friendly amendment not accepted.

Discussion – one member said he would have to abstain from voting since he knows nothing about either nominee.

Vote using simple majority – 29 in favor, 31 opposed. Motion Failed.

Vote for Treasurer went to second ballot; Vicki R. elected as Treasurer.

Ask-it-basket questions were answered by Past Delegates during the election.

Calendar of Events was read.

Motion to adjourn – Jim R. made a motion to adjourn, Heidi B. seconded. Meeting adjourned at 1:09 p.m. Closed with the Lord's Prayer.



We need to do a better job in our own backyards. I BELIEVE FINANCIAL RESTRAINTS KEEP SOME GSR's FROM GOING TO AREA ASSEMBLIES. I HAVE BEEN A GSR, CORRECTIONS CHAIR & DCM AT ASSEMBLIES AND FEEL I HAVE ALWAYS HAD ADEQUATE OPPORTUNITY TO SPEAK AND PARTICIPATE, HOWEVER KNOWING WHAT TO SPEAK ABOUT WAS MORE OF A LEARNING CURVE ISSUE. Costs can keep them away, also lack of interest of groups towards service. I believe there is adequate time for participation. My observations lead me to conclude that newcomers, even some longtime members, show up for the meeting and do not know (or maybe not care) that there are news items or recommendations from District or Area which can help anyone to better understand the "big picture" of AA. Perhaps this is a "normal" progression of groups as they age, but there are many meetings I've attended where groups fail to grow, not only by measuring the numbers or participants, but by the lack of knowledge of AA's purpose and history. Another complicating factor for some groups is the insistence that a newcomer can be addicted to other substances and be considered a member of that AA group because "there aren't enough NA or other 12 step programs to meet their needs." So "come on in" ... we deal not only with Alcoholic dependency but also with other drugs. Does not bode well for AA long term.

It is important to remember that any past delegate that has not attended any assembly or ACM is doing so by their own choice, the Area has never asked them to not attend any



## AREA OFFICER & ACTION COMMITTEE NL REPORTS

#### OFFICER REPORTS DELEGATE – STEVEN L

Howdy Ladies and Gentlemen, First off, thank you to all the Groups that participated in the Public Information (PI) Membership Survey this year. Our Area had eight groups chosen and seven of those completed the survey. Next, thank you to the DCMs for helping me get the surveys to the groups and especially for the rapid return of the surveys to meet the survey's deadline. I went to the Post office on Thursday to next-day deliver the completed surveys to the General Service Office (GSO) and met the deadline. When I got home, there was an email stating that the deadline was extended by ten days. Typical, "Hurry up and wait."

I hope you enjoyed the Fall Assembly as much as I did. It was great talking to old friends and meeting some new GSRs and two new DCMs. Can't beat the tailgate meals and fellowship that District 6 furnished for all who wanted to participate. I found the discussions on, "Giving a quick summary about someone willing to stand for an Area officer", exhilarating. This came up as a spur of the moment motion, in the middle of an election with two people standing for Treasurer. People wanted to hear the experiences of the nominees, so the voting members weren't voting blind. The motion was defeated by two votes. I placed an article in this issue of the NL going into more detail on a proposal for changing the Area's election procedure for Area officers. Please take the time to read the essay and discuss it with your Group.

Planning of the West Central Regional AA Service Conference (WCRAASC) is underway. One thing that is still to be discussed at our monthly WCR Delegate's meeting is, "Do we want to turn the WCRAASC into a hybrid meeting?" We are looking into the cost and function of the meeting place. We have just a few small tweaks to make and then the updated guidelines will be ready for approval at the next Delegate's meeting. We have two new people rotating in as Panel 73 Delegates, Meg H. from Area 36, S MN and Julie S. from Area 24, Iowa.

I'm writing this report on Halloween, it's a beautiful day, warm and sunny, the complete opposite of the Halloween of 1991, when a huge blizzard hit and dumped tons of snow on us. I feel like the calm before the storm knowing a blizzard is about to hit, pertaining to what's going to happen come agenda item season starting in February. There are 185 new proposed agenda items to be considered for next year's conference. That's 185 plus what was passed through to reconsider from last year's conference. Of the 185, 92 are for the Literature Committee, which is the committee I sit on, that's a whopping 50% of the proposed agenda items. Of the 92 proposed agenda items for the Literature Committee, roughly a little over half are about two things, changes to the 12x12 and the plain and simple translation of the Big Book. The Literature Committee (CLC) met with the Marita R., Chair of the Trustees Literature Committee (TLC). The meeting's purpose was to discuss how to handle agenda items addressing the same topic. I'll follow up on this thread in person at the December ACM. It will be interesting to see how the Trustees dole out agenda items with the Equitable Distribution of Workload (EDW) test in its second year.

I'm sorry and disappointed to say that at the time of this writing, I have not received the Final Conference Reports in printed form yet! If anyone is interested, GSO is updating its file of applications from A.A. members who are interested in being considered for possible future openings for the position of G.S.O. staff members. G.S.O. staff people are A.A.s who carry out rotating assignments and correspond with A.A.s throughout the world on all aspects of recovery and service. If you are interested or would like more information, please contact me.

Now would be a good time to start thinking if you want to have me come visit your District to discuss agenda items before our Spring Assembly. The next time ACM meets is the end of February 2023. The list of agenda items according to Mike L., WCR Trustee, is that translations have begun, and we should expect to have agenda items available the middle of February.

In Service, Steven L

opened up on October 4<sup>th</sup> and I closed it on October 19<sup>th</sup>. There was a total of 46 responses and I extracted them and these will also be printed in this edition of the Northern Light. I will be forming (2) ad hoc committees that will each review half of the question and report their findings. I will have an update at the December ACM. I am excited to see how we can improve the way we communicate and do our business in the area along with other suggestions that may be offered.

I also want to let you know that the inventory responses have been published, as written, without any revisions, alterations, or spelling corrections. I recognize that there are some responses that may be hurtful toward individuals. I did not want to start editing and adjusting what people wrote so NO edits were made to any of the inventory responses. I pray that God will be invited into the inventory review process and we are able to overcome these challenges.

I spoke with Area 36 Chair and we have decided to have an Area 35/A36 Joint Committee Meeting on July 23<sup>rd</sup>, 2023 via ZOOM. We needed to quickly come up with a date so Area 36 could get it on their event calendar. This gets set and is made available for their fall assembly.

I look forward to seeing you all at the December ACM on December 4<sup>th</sup>. The first year of this rotation went by fast.

### **TREATMENT – RICCO R**

I attended the MARRCH conference/Expo in St. Paul MN. This is mainly being written to let the Area 35 Treatment Committee know what went on at the MARRCH booth that Carla the Area 36 Chair invited me to attend and help Ken S. The Area 36 CPC chair to staff the Alcoholics Anonymous booth.

I thought of the committee often while I was there. It was exciting, informative, and productive for the Area 36 booth to be there. Ken brought a ton of pamphlets, and other materials to give out to the people (Professionals, Treatment Centers, and many professionals in many fields that are out there helping to carry the message to the still suffering alcoholics and alcoholics that are recovering from alcoholism. There were also other booths with different recovery programs.

We had a very busy booth. Sometimes both me and Ken were talking with someone at the same time and there were people looking at the things Ken brought or just waiting to talk to one of us. We had a lot of treatment centers, halfway houses for alcoholics, and a wide variety of professionals that were involved in helping alcoholics in other ways. I brought some of our Area 35 literature on the Bridging the Gap Temporary contact program. I explained the program and gave out our district sheets for A.A. members to fill out and gave them the Client Sheet for the treatment center to fill out. I also explained that they could just change the district number to their district on the sheet and use it like District 9 uses it.

I then told the treatment center professionals that we in Area 35 are printing up a brochure to explain the Bridging the Gap Temporary Contact Program. I told them if they wanted a copy of the brochure they could leave me their e-mail address and I would send them a copy of it when it is finished. I got a total of 45 e-mail addresses. The Treatment Centers were really interested in the temporary contact program. I left a pile of our (District 9 A.A. member Temporary Contact Forms) and the (District 9 Treatment Client forms) and some meeting schedules that the Area 35 Districts gave me to bring to the expo. ### ARCHIVIST – MARC N

Several magazine covers were displayed at the Fall Assembly archives exhibit. A few people asked about how or why these were part of our archives. The answers were on the cover page as displayed. These magazines all had something to say about alcoholism and the solution offered by Alcoholics Anonymous. These were from the early years of Alcoholics Anonymous. Sometime later either these publications ceased publishing similar articles, or the articles were considered "outside issues" and were no longer valued to carry the AA message.

I was asked about Freedom Fest, two Minnesota events that happened in 1976 and 1986. I attended both, neither was exclusively AA, but both regarded sobriety or recovery from addictions. Yet there is very little noted in Area 35 archives. There are many local events around NMAA, some are called Round Robins, some are called Round Ups, and now there is a new one called Tailgating. These events remind us of the legacies of "Unity" and "Service" that are often forgotten as groups observe their autonomy. Many with long tern sobriety have fond memories of service work and the unity observed, but these memories will be lost if not recorded in our collective archives.

In years past local newspapers included as public service the location and sometimes contact information for local AA meetings. Recently there have been websites and apps to help locate AA meetings. In some places there are billboards extending an invitation to problem drinkers. There are groups, districts, etc that have placed "business cards" with hotline phone numbers and various other information in locations frequented by people who might reach out for help to get sober. An album of published announcements, the cards, or pictures of billboards would be welcomed into our archives.

So here is a challenge: Reach out to the archivist in your district or your area (me) to tell them your story of how you or your group has experienced unity with other AAs via service work. Our area archive committee has already begun to assemble memories into written short stories that will serve well as archive exhibits in the future. Some of these memory short stories could become part of NMAA online archives. Add to this that pictures of Tailgating, Round Robins, or Roundups could become part of our archives (remember anonymity, no full names, no pictures showing faces).

I would like to be invited to your district meeting to present some ideas for recording our memories.

## Your Experience, Strength and Hope

### **Proposed Area Officer Election Changes**

While anxiously waiting for the election of a new Treasurer for our Area, a very interesting floor motion was put on the floor for the Assembly to resolve. Ballots cast, but not counted, there was a motion put forth on the floor that the voting body hear a brief summary of the people standing for Treasurer, the motion was seconded, followed by discussion at the mic. A vote was taken, the motion was defeated, but it was close. The election process was resumed, and the Area voted on a new Treasurer.

I'm enthused people were inspired to have a discussion about how the Assembly holds its election procedure at an election Assembly. Though, the middle of a vote is poor timing to have this conversation. I think the Area should consider having a discussion about changing the Area's election process at the 2023 Spring Assembly. There is always new GSRs and other voting members attending our Fall Election Assemblies. Some of these new voting members may have no idea who the nominated people standing for the elected positions are. Adding a quick description of the nominees will help give an awareness of who they are voting for.

Currently, only people standing for Delegate post a resumé of their qualifications for the membership to review. After the vote for Delegate is decided, only the remaining pool of people that stood for Delegate are able to stand for Alt Delegate. Presently, in the Area's election procedure there is no provision to introduce the voting members to the people standing for Treasurer, Secretary or the Chairperson. I believe that this is a disservice to the voting members because people are voting blind. Some call it promoting or campaigning when describing a nominee's qualifications, yes extremes can happen, but I call this informing the voting members.

At the General Service Conference (GSC), I observed two Trustee elections. Before the voting began for the elections, every Delegate that put forth a person to stand for Trustee from their Area, was allowed to give a two-minute presentation on why they thought their nominee for Trustee should be selected. These presentations took on different forms, from giving just a service resumé to giving a personal profile on what a good person and AA member they were. Then the third legacy procedure started, and a Trustee was decided on. I found this to be fascinating and beneficial. I couldn't wait to bring this idea back to our Area and see if we wanted to implement a similar process.

What I am proposing, is that the Area change its election procedure when voting for Area officers. Before the voting begins, we include time for a 60 second introduction about the person standing for Delegate given by the DCM of their nominating District. Subsequentially, we do the same thing for the people standing for Chair, Secretary and Treasurer. After the nominations close and before the voting begins, let the person who nominates a candidate give up to a 60 second introduction on why they nominated that person to stand for that position.

In summary, I believe that changing the voting procedure will better inform the voting members at an Election Assembly about the people that are asking to serve them. This will help give the Area the great leadership it has come to expect. By posting this in the Northern Light, I'm hoping to give Groups time to discuss this issue for changing the election process before the next Spring Assembly. If approved, we can implement this voting change at our next Election Assembly (Fall 2023). I'm also bringing this topic up at the December Area Committee Meeting so the DCMs have plenty of time to discuss this proposal at their District meetings and this will give you plenty of time for discussion at your home Group. We should have ample time to get an informed group conscious before the Spring Assembly.

I ask that you publish it at your convenience when it works within the very challenging aspects of putting together our fine publication. Thank you.







## 12 Traditions of Alcoholics Anonymous (Long Form)

- 1. Each member of Alcoholics Anonymous is but a small part of a great whole. A.A. must continue to live or most of us will surely die. Hence our common welfare comes first. But individual welfare follows close afterward.
- 2. For our group purpose there is but one ultimate authority—a loving God as He may express Himself in our group conscience.
- 3. Our membership ought to include all who suffer from alcoholism. Hence we may refuse none who wish to recover. Nor ought A.A. membership ever depend upon money or conformity. Any two or three alcoholics gathered together for sobriety may call themselves an A.A. group, provided that, as a group, they have no other affiliation.
- 4. With respect to its own affairs, each A.A. group should be responsible to no other authority than its own conscience. But when its plans concern the welfare of neighboring groups also, those groups ought to be consulted. And no group, regional committee, or individual should ever take any action that might greatly affect A.A. as a whole without conferring with the trustees of the General Service Board. On such issues our common welfare is paramount.
- 5. Each Alcoholics Anonymous group ought to be a spiritual entity having but one primary purpose—that of carrying its message to the alcoholic who still suffers.
- 6. Problems of money, property, and authority may easily divert us from our primary spiritual aim. We think, therefore, that any considerable property of genuine use to A.A. should be separately incorporated and managed, thus dividing the material from the spiritual. An A.A. group, as such, should never go into business. Secondary aids to A.A., such as clubs or hospitals which require much property or administration, ought to be incorporated and so set apart that, if necessary, they can be freely discarded by the groups. Hence such facilities ought not to use the A.A. name. Their management should be the sole responsibility of those people who financially support them. For clubs, A.A. managers are usually preferred. But hospitals, as well as other places of recuperation, ought to be well outside A.A.—and medically supervised. While an A.A. group may cooperate with anyone, such cooperation ought never go so far as affiliation or endorsement, actual or implied. An A.A. group can bind itself to no one.
- 7. The A.A. groups themselves ought to be fully supported by the voluntary contributions of their own members. We think that each group should soon achieve this ideal; that any public solicitation of funds using the name of Alcoholics Anonymous is highly dangerous, whether by groups, clubs, hospitals, or other outside agencies; that acceptance of large gifts from any source, or of contributions carrying any obligation whatever, is unwise. Then too, we view with much concern those A.A. treasuries which continue, beyond prudent reserves, to accumulate funds for no stated A.A. purpose. Experience has often warned us that nothing can so surely destroy our spiritual heritage as futile disputes over property, money, and authority.
- 8. Alcoholics Anonymous should remain forever non-professional. We define professionalism as the occupation of counseling alcoholics for fees or hire. But we may employ alcoholics where they are going to perform those services for which we may otherwise have to engage nonalcoholics. Such special services may be well recompensed. But our usual A.A. "12 Step" work is never to be paid for.
- 9. Each A.A. group needs the least possible organization. Rotating leadership is the best. The small group may elect its secretary, the large group its rotating committee, and the groups of a large metropolitan area their central or intergroup committee, which often employs a full-time secretary. The trustees of the General Service Board are, in effect, our A.A. General Service Committee. They are the custodians of our A.A. Tradition and the receivers of voluntary A.A. contributions by which we maintain our A.A. General Service Office at New York. They are authorized by the groups to handle our over-all public relations and they guarantee the integrity of our principal newspaper, the A.A. Grapevine. All such representatives are to be guided in the spirit of service, for true leaders in A.A. are but trusted and experienced servants of the whole. They derive no real authority from their titles; they do not govern. Universal respect is the key to their usefulness.

## 12 Concepts of Alcoholics Anonymous (Short Form)

- I. Final responsibility and ultimate authority for A.A. world services should always reside in the collective conscience of our whole Fellowship.
- II. The General Service Conference of A.A. has become, for nearly every practical purpose, the active voice and the effective conscience of our whole Society in its world affairs.
- III. To insure effective leadership, we should endow each element of A.A.—the Conference, the General Service Board and its service corporations, staffs, committees, and executives—with a traditional "Right of Decision."
- IV. At all responsible levels, we ought to maintain a traditional "Right of Participation," allowing a voting representation in a reasonable proportion to the responsibility that each must discharge.
- V. Throughout our structure, a traditional "Right of Appeal" ought to prevail, so that minority opinion will be heard and personal grievances receive careful consideration.
- VI. The Conference recognizes that the chief initiative and active responsibility in most world service matters should be exercised by the trustee members of the Conference acting as the General Service Board.
- VII. The Charter and Bylaws of the General Service Board are legal instruments, empowering the trustees to manage and conduct world service affairs. The Conference Charter is not a legal document; it relies upon traditional and the A.A. purse for final effectiveness.
- VIII. The trustees are the principal planners and administrators of overall policy and finance. They have custodial oversight of the separately incorporated and constantly active services, exercising this through their ability to elect all the directors of these entities.
- IX. Good service leadership at all levels is indispensable for our future functioning and safety. Primary world service leadership, once exercised by the founders, must necessarily be assumed by the trustees.
- X. Every service responsibility should be matched by an equal service authority, with the scope of such authority well defined.
- XI. The trustees should always have the best possible committees, corporate service directors, executives, staffs, and consultants. Composition, qualifications, induction procedures, and rights and duties will always be matters of serious concern.
- XII. The Conference shall observe the spirit of A.A. tradition, taking care that it never becomes the seat of perilous wealth or power; that sufficient operating funds and reserve be its prudent financial principle; that it place none of its members in a position of unqualified authority over others; that it reach all important decisions by discussion, vote, and, whenever possible, by substantial unanimity; that its actions never be personally punitive nor an incitement to public controversy; that it never perform acts of government, and that, like the Society it serves, it will always remain democratic in thought and action.



- 10. No A.A. group or member should ever, in such a way as to implicate A.A., express any opinion on outside controversial issues—particularly those of politics, alcohol reform, or sectarian religion. The Alcoholics Anonymous groups oppose no one. Concerning such matters they can express no views whatever.
- 11. Our relations with the general public should be characterized by personal anonymity. We think A.A. ought to avoid sensational advertising. Our names and pictures as A.A. members ought not be broadcast, filmed, or publicly printed. Our public relations should be guided by the principle of attraction rather than promotion. There is never need to praise ourselves. We feel it better to let our friends recommend us.
- 12. And finally, we of Alcoholics Anonymous believe that the principle of anonymity has an immense spiritual significance. It reminds us that we are to place principles before personalities; that we are actually to practice a genuine humility. This to the end that our great blessings may never spoil us; that we shall forever live in thankful contemplation of Him who presides over us all.

## EDITORIAL POSITION & N.L. COMMITTEE:

**Editor**: The Editorial Chair position is a two-year rotation picked by the incoming Area Chair and either approved or rejected by the Area Committee at the first Area meeting after the Fall Assembly Elections.

**Desirable qualifications:** Current knowledge of MS Publisher, MS Word, MS Excel and other misc. computer programs as needed. The person should also consider the time needed to complete the task required. The candidate should have a working knowledge of A.A. as a whole, i.e., prior experience in service work such as G.S.R., D.C.M., or related position.

**N.L. COMMITTEE:** The N.L. Committee consists of the Area Group Records Chair, Area Webmaster and Area Audio Technician along with two D.C.M.s in Area 35. DCM's are picked randomly at the start of each rotation and serve on a two-year rotation basis. They assist the editor in communications with other area newsletters, in recommendations on general improvements, and with general problems and implementations of new policies. They may also represent the editor at functions when the editor is unable to attend.

**N.L. COMMITTEE MEETINGS:** The Committee meets every other month, before the start of the Area Workshop and at Spring and Fall Assemblies. If needed, additional meetings may be called.

General submissions are welcome! Feel free to send letters or articles that are pertinent to AA and Area 35. Please note that if space is limited, first priority will be given to reports from Area Officers, Area Standing Committee Chairs and D.C.M.s from Area 35.

  - f) Conference with itinerary
  - g) Fellowship (ice cream socials, potlucks, chili cook offs, etc.)
  - h) AA must appear somewhere on the flyer
- 3. When is the event to take place?
  - a) Date and time
  - b) Does it reoccur
- 4. Where will the event take place?
  - a) Name of the facility and the address
  - b) Maps are sometimes helpful but not necessary
- 5. Why is the event taking place?
  - a) The reason for AA events is to carry the AA message to the still suffering alcoholic
  - (this doesn't have to be printed on the flyer)
  - b) Usually covered in Who and What

\*For safety reasons, if a phone number is listed on the flyer consider NOT putting a name in association with the number.

### Only Area 35 AA members may submit a flier. Fliers for AA sponsored events only.



## Q: Why list our past Delegates?

## A: They are a resource to you!

In Alcoholics Anonymous we value experience. Our Twelve Steps did not exist when Bill stepped into the lobby of a hotel in Akron, Ohio. Even after meeting with Dr. Bob and soon founding our program, there were only six steps until the experiences of 100 Alcoholics were summed up. Soon after a book followed, but it was a few years later when the Twelve Traditions were discussed and agreed on. Twelve Traditions that were "hammered out on the anvil of experience". Our past Delegates are a wealth of experience, an interactive living archive if you will. When you plan your next service workshop or need an outside voice to offer help, consider this resource available to you.

# The Delegate's Duties

Though the high point is the Conference meeting, the delegate's job goes on year-round and involves all aspects of the Conference structure. The delegate should:

- Remind G.S.R.s to inform groups and individuals about the A.A. Grapevine and Conference-approved literature.
- Attend the Conference meeting in April, fully prepared. Immediately upon election, every delegate is put on the G.S.O. mailing list to receive Conference materials.
- Communicate the actions of the Conference to area committee members and encourage them to pass on this information, and the delegate's enthusiasm, to groups and to intergroups/central offices. If an area is too large for the delegate to cover in person, he or she will ask area officers and committee members to share the load.
- Be prepared to attend all area, state/provincial, and regional service meetings and assemblies. From these meetings, delegates come to better understand their own areas and can make suggestions for the Conference agenda. Here, too, they come in contact with A.A. members who might not be reached otherwise.
- Help area committees obtain financial support for the area and G.S.O.
- Provide leadership in solving local problems involving the A.A. Traditions.

- Cooperate with G.S.O. in obtaining information—for example, making sure that up-to-date information reaches G.S.O. in time to meet the deadline for each Issue of the A.A. directory and helping carry out the triennial membership surveys.
- Visit groups and districts in the area whenever possible.
- Work closely with committee members and officers, sharing experience throughout the year. After G.S.R.s and committee members have reported on the Conference, learn from these A.A.s how groups and members have reacted.
- Assume added responsibility if the area chair and alternate chair are unable to serve. Or, if an area committee is not functioning effectively, the delegate may take an active role in remedying the situation.
- Keep the alternate delegate fully informed and active, so that the alternate can replace the delegate in an emergency.
- Late in the second term, work with newly elected delegates to pass along a basic knowledge of Conference proceedings and problems.




