

AREA 35 MEETING MINUTES - UNAPPROVED

Area 35 December 2022 ACM Minutes Aitkin, MN December 4, 2022

Call to Order: Area Chair Christine G. called the meeting to order at 10:30 a.m. on Sunday, December 4, 2022, and opened with the Serenity Prayer.

Recognition of Past Delegates In Attendance: None present.

Additions to agenda: Discussion on hybrid ACMs going forward; Treasurer's budget; Bridging the Gap; January Service Workshop hybrid

Point of order: Two-minute limit for sharing at the mic

Approval of August 2022 ACM Minutes: Heidi B. motioned to approve the minutes, Jeff seconded, MOTION PASSED UNANIMOUSLY

OFFICER REPORTS DELEGATE – STEVEN L

Good morning, Ladies and Gentlemen - It has been busy since my last report. I finally received the printed copies of the 2022 final General Service Conference (GSC) report. They were stuck in Chicago for the past month and a half. Please take as many as you want to bring back to your Districts, they are stacked on the back tables. I've been in correspondence with a District to help them hold a GSR workshop in February to try to get more GSR participation in their District. On Dec 15th, I attended a zoom meeting with 80+ Delegates to welcome the new panel 73s and say goodbye to the panel 71s. It was interesting to hear the concerns of the incoming Delegates on what the conference is like, what to wear, how to pack and what to expect. I welcomed three new groups to the Area and invited them to attend our workshop in January.

At the WCR Delegates meeting Nov 28th, Mike L., (WCR Trustee), reported that we moved \$1.1 million from the reserve fund (this came from the insurance money received on the cancelled International Convention which was to be held in Detroit) to the General Operating fund to cover deficits. \$250k of the Insurance money stayed in the reserve fund. We are now on track with the revised budgets. Grapevine's operating loss is currently at \$300,000. Through Equitable Distribution Workload (EDW) there is one Proposed Agenda Item (PAI) going to the Grapevine Conference Committee, three items are going to the Finance Conference Committee, two items are going to Corrections Conference Committee, and two are going to the Treatment Conference Committee with about five other items distributed among the other committees. Public Information (PI) still has the bulk of PAIs with 16 proposed items. Literature is second with 11 proposed items with one new addition. If an item was previously distributed to a committee, we kept it on that committee due to the work already/previously done on the item.

The Grapevine Inc. has been hard at work with an app development. Bids have gone out. We anticipate half a dozen vendors responding, costs will probably be between \$250,000 to \$300,000 to develop this app. Tentative rollout date will be September 2023.

The GV podcast has over 300,000 downloads now. Another podcast is in the works with shorter topics and different moderators. We have noticed that Grapevine products in digital material provide the most downloaded material available and is the most complete material we provide. Even on the AAWS side, the audio books were downloaded much more frequently than the printed material. Call the GV if you haven't received a GV product you ordered for 3 months or more.

I booked my rooms at both the Area workshop in Duluth and the WCRAASC in Omaha. Speaking of the WCRAASC, there was a snafu on getting fliers distributed in the Northern Light (NL). I brought 200 copies of the flier for the event, please take ten or more home with you to distribute at your district meetings. You can also download them off of our website. I'm happy to announce that the WCRAASC will be a hybrid meeting this time also.

I have heard from the conference coordinator about all the proposed agenda items (PAI) our Area sent in.

PAI#121: Consider the use of QR codes to carry the information contained in pamphlets using diverse technologies.

The following is the outcome of their deliberations:

"The committee discussed three proposed agenda items related to the use of QR codes and took no action to forward this item to the 2023 General Service Conference. The committee discussed that use of QR codes on materials is occurring on various projects at the General Service Office (GSO), such as the Young People's Video project and the PI/CPC service cards under development. The ability to determine when to incorporate QR coding into materials should remain within the purview of the office."

Why the TPIC I don't know, possibly because of equitable distribution of workload (EDW).

PAI #77: Motion to shuffle the Daily Reflections pages.

The following is the outcome of their deliberation:

"The A.A.W.S. Board discussed the proposed agenda item related to the motion to shuffle the Daily Reflections pages and is forwarding this item to trustees' Literature Committee."

PAI #47: Motion to change the wording of the Open Meeting Statement on the Primary Purpose Statement F-17 (blue card) to incorporate the Open meeting Statement in the AA Group Pamphlet - The new "open meeting statement" to read - "This is an open meeting of Alcoholics Anonymous. Open meetings are available to anyone interested in Alcoholics Anonymous' program of recovery from alcoholism. We are glad you are all here - especially newcomers. In support of our Third Tradition that states "The only requirement for A.A. membership is a desire to stop drinking" we ask that nonalcoholics attend as observers only.

The following is the outcome of their deliberation:

"The A.A.W.S. Board discussed the proposed agenda item related to the motion to incorporate the Open Meeting Statement in the AA Group pamphlet and took no action to forward this item to the General Service Conference, noting that this topic was considered in 2019 by the 69th General Service Conference and was not carried forward."

PAI #46: Motion for any new, updated or addition to existing service material to be sent to the appropriate conference committee for review before being printed or posted on our website www.aa.org. Those items that clearly do not fit under a specific committee can be referred to the Report and Charter Committee.

The following is the outcome of their deliberation:

"The A.A.W.S. Board discussed the proposed agenda item related to the motion to have any new, updated or addition to existing service material be sent to the appropriate conference committee for review and took no action to forward this item to the General Service Conference, noting that processes related to service material are currently being studied by the A.A.W.S. board "

PAI #44: The trustees' Literature Committee discussed your proposed agenda item PAI 44: We are making a proposal regarding the translation of the book Alcoholics Anonymous (fourth edition) into plain and simple language. We propose that the Twelve Steps, the Twelve Traditions, and the Twelve Concepts, not to be translated into plain language in any way; that these remain in the existing form in English as in the Fourth Edition of the Book Alcoholics Anonymous.

The following is the outcome of their deliberations:

"The trustees' Literature Committee agreed to forward to the 2023 Conference Literature committee all new proposed agenda items related to the Plain Language Big Book as one grouped item. The committee also discussed requests from some members regarding access to the draft of the Plain Language Big Book. After legal consultation, the committee agreed to provide a monitored closed reading room for Conference members only during the 2023 General Service Conference, where Conference Literature Committee members will be given first viewing of draft chapters in a controlled environment."

PAI #45: The 2002 Conference unanimously recommended the Advisory Action that the text in the book, Twelve Steps and Twelve Traditions, written by Bill Wilson remain as is recognizing the Fellowship's feeling that Bill's writings be retained as originally published. We propose that changes made by the 71st General Service Conference: Advisory Action 18 for changes to page 117 phrase "opposite sex" with the word "partner" Advisory Action 19 changes to page 66, "No one wants to be angry enough to murder, lustful enough to rape, gluttonous enough to ruin his health" with "No one want to commit the deadly sins of anger, lust or gluttony" in the book Twelve Steps and Twelve Traditions, be returned to their original text.

Note: This would include the Introduction be returned to its original text.

The following is the outcome of their deliberations:

"The trustees' Literature Committee reviewed proposed agenda items related to the changes approved by the 2021 General Service Conference to the book Twelve Steps and Twelve Traditions and noted the importance and interest of the Advisory Action to the Fellowship. Twelve Steps and Twelve Traditions PAIs: The trustees' Literature committee agreed to forward to the 2023 Conference Literature Committee all proposed agenda items related to the changes in the book Twelve Steps and Twelve Traditions as one grouped item with the suggestion that the Conference Literature Committee consider forwarding the item to the general service areas for wider discussion looking toward setting a policy on how and whether to edit A.A. founder's words in our current literature. The agenda item would be discussed by the Fellowship during the 2023-2024 Conference year and considered by the Conference Committee on Literature at the 2024 General Service Conference." This reply by the trustees Literature Committee was discussed at a Conference Literature Committee (CLC) meeting on Oct 18th. I've had a few sleepless nights over this recommendation.

To me, the request that the Trustees Literature Committee wanting the AA fellowship to discuss a policy on the changing the writings of AA founders for a year (2023 to 2024) is redundant, also to note: a Conference action is not binding on future Conferences.

I believe, if the discussion is to make a policy and get group input until the 74th GSC in 2024, there should be a <u>moratorium on the publishing and selling of the 12X12</u> until this issue is resolved. In 2021, 400,000 copies of the 12X12 were printed. If we keep printing and selling the 12X12 in its changed form that would make 1.5 million to two million copies of the 12X12 distributed out to the fellowship by 2024 and cause further confusion and disunity

if this change is revoked.

I sent an email to the Trustees Literature Chair and the Delegates on the Literature Committee about my concerns. I also brought this concern up at the WCR Delegates meeting and Mike L., (WCR Trustee), stated that it would take a conference action to put a moratorium on the publishing and selling of the 12X12, since it was a conference action to sell the 12x12 in its current changed form.

I have had a couple of video conferences with Dennis and one with the three of us and I think they're comfortable with their presentation material and we've come up with an interesting format for their presentations.

I still have to get the voice book updated and a few other odds and ends, but we're in good shape for the event and I'm excited and looking forward to it. Thank you for the opportunity to serve.

CHAIR - CHRISTINE G

Greetings Area 35, Since my report in the Northern Light, I have compiled the results from the area inventory and created two committees to review the responses and come up with any recommendations that they may have. Thank you to all who agreed to be a part of the committee. Each committee consists of a GSR, DCM, Area Officer/Committee Chair, a Past Delegate and a secretary for taking notes.

Each committee has met one time and has another time scheduled. The plan is to have all recommendations typed up and made available at the Spring Assembly so you can take them back to your districts and groups for discussion. Groups are more than welcome to come up with additional recommendations/motions for the assembly to consider. At the Fall Assembly we will discuss the recommendations/motions to see what needs to happen next.

On October 29, I presented at a District 13 workshop and the topic was "Basics & Intro to AA Service." I presented on what the area make up is and what the basic responsibilities are of the Area Officers and Committee Chairs. I spoke about the events the area has and what takes place at those events. I also spoke about 7th Tradition Contributions to the three entities that are a part of the Area 35 general service structure.

Prior to this workshop, I met with new Area Treasurer at Wells Fargo to get her set up as a signer on the checking account with full administrative rights. I was also able to hand over the information that was given to me from our past Treasurer.

As we are coming into the year, I would like all the committee chairs and officers to think about how you can help districts/groups that are local to you. DCM's, we have the WCRAASC coming up and all committee chairs and officers can help with going over agenda items. Our Delegate is not the only individual who can help you with the agenda items. Please contact an Area Officer/Committee chair that is close to you. All individuals should be knowledgeable in the agenda items if they attend the WCRAASC. By visiting districts that are close to us we help save expenses of gas and lodging. This afternoon we will need to discuss if we are going to send all our area officers and committee chairs to the WCRAASC to attend in person. I have taken some time over the weekend to touch base with each committee chair to see if they have a preference how they attend the WCRAASC. TREASURER - VICKI R

Thank you for allowing me to serve as treasurer. I've spent the time since elected learning the procedures and getting help, mostly from Justin. He said it's okay if I say I've paid the Archives storage bill on time twice!

As you can see on the IEC and the Financial Summary I provided, the Area finances are as follows:

Group contributions for period 6 = \$4,636.72 and other income sources = \$3,489.79 totaling \$8,126.51 for the period.

Area expenses for period 6 total \$14,316.44 leaving a net loss for the period of (\$6,189.93).

Year to date group contributions =\$28,884.08 and other income sources = \$12,044.11 totaling \$40,928.19.

Total Area expenses are \$59,187.50 leaving a net loss of (\$18,259.31) for the end of November.

To meet the budgeted income of \$60,432 we need to bring in \$19,503.81 by Dec. 31.

I expect we will spend over the \$60,437.01 budgeted expenses by the end of Dec. 31. There is \$1,249.51 remaining but this meeting will generate more expenses than that.

I have concerns about the 2023 budget we passed at the Fall Assembly. The budget totals \$88,457.21 in expenses and the most I can estimate we would take in as income it \$42,000, leaving a shortfall of \$46,457.21, well beyond our prudent reserve of \$6,000 should we have to spend into it.

Therefore, I am requesting a discussion to find a solution to bring the 2023 budgeted expenses in line with the expected income.

I have added the budget totals for WCRAASC, WCR Forum, and District travel to be budgeted at \$32,758.95, which would make up most of the estimated shortfall. Should we decide to remove those budgeted items, there is still a shortfall of \$13,698.26 to reduce from the budgets.

Archives- John is doing old-timer interviews and has gone through material. He is very involved in his role.

<u>PI/CPC</u>- Doug talking about looking into getting luncheons going again. We've had some new GSRs attend district meetings. And other groups stepping up to host district meetings who haven't in the last year.

I'm still making my rounds to groups in the district, slowly but surely.

I plan to attend the West Central Regional Conference in Omaha, I made plans, but I don't plan the outcome. Thank you for letting me serve.

OLD BUSINESS

Financial Oversight Committee – Books checked out fine. In order to be prudent, the report was given electronically.

Tabled Motion – "Have Kyle move forward with Office 365 to connect DCMs, Area Officers, and Committee Members." This will be discussed and voted on at the Spring 2023 Assembly.

Area Inventory – Tabled until Spring 2023 Assembly

Ad Hoc Technology Committee – Webmaster had nothing to report.

Joint A35/A36 Workshop, Sept. 18th – The workshop has been scheduled for July 23, 2023, on Zoom. This date was selected due to Area 36's tight calendar schedule. Area Chair will be working with the incoming Area 36 chair to put this together.

Statewide Corrections – Corrections Chair stated that there will be elections in January for Statewide Corrections Committee officers. There is going to be a meeting on Wednesday, but acting Secretary is unable to attend. Corrections Chair will send out an email if meeting is cancelled.

State Fair Booth – We committed to support the State Fair Booth with finances and participation. Anyone willing to volunteer, contact our PI Chair

Delegate Nomination Process Discussion – We will be discussing this at the Spring Assembly, so discuss this with the groups. Question: Where in the Actions Book does it say that districts can only nominate one person? Answer: In the Elections section, page 19. This started in March 1977.

Northern Light Content Discussion – There are 28 pages in the Northern Light. Sometimes we have more information than we can print. Discuss with your groups to see what information they would like to have in the Northern Light.

NEW BUSINESS

Treasurer Budget Presentation – Treasurer made a presentation to the Committee.

Treasurer – We don't have funds to meet our budget. She could send the budgets back to the Officers and Committee Chairs for revision. How do we want to approach this budget overage?

Alt. Del. – We can't vote on this at this ACM. The groups voted to approve the budget. Possible suggestion: don't send everyone to the WCRAASC in Omaha.

Treas. – Budget projection for 2023 is \$46,000. Can we reduce Archives and NL expenses? Get serious about digitizing and lower printing costs by reducing number of NLs printed. Can we reduce expenses for WCRAASC and Regional Forum? Hold WCRAASC gatherings locally.

Archivist – Can reduce supplies budget. Equipment for digitizing is \$1300. If we don't get it, we can't digitize. Space under 500 SF for Archives is very hard to find. There is one available only for storage with no workspace. Other spaces cost more. Need climate-controlled space. Can we have NL be electronic rather than printed? Answer: The only problem with that is it is anonymity-protected, which means that contact info for officers, chairs, and DCMs will be harder to get. No phone numbers will be online.

If people carpool and share rooms, can save \$1800. Treasurer: Projected balance in the checkbook when WCRAASC comes around is only \$2000. If we don't have the funds, we don't send people. We have to decide what to do

We need to talk about budgets and how \$1 in the basket is not enough. Many groups have a lot of money in their treasury. What are they doing with that money?

Denise R – MOTION TO HAVE AREA OFFICERS AND CHAIRS ATTEND WCRAASC BY ZOOM, AND SEND DEL. AND ALT. DEL. Second – Jim R

Discussion – Archives: Individuals can pay their own way if they want to go. Friendly amendment: MOTION SHOULD SAY "REIMBURSE" RATHER THAN "SEND." Friendly amendment accepted.

Discussion – There is a difference between in-person and Zoom. Why didn't we have this discussion at the Assembly? GSRs needed to know this so they could bring this back to their groups. Only one GSR at the

assembly was opposed to the budget they voted on.

Chair - This is not an uncommon conversation. Action Book shows that we have had to have these discussions in the past at ACMs.

We have to show responsibility and leadership. Treas. has shown that we have a problem. We are trying to be responsible with funds.

We approved the budget. Budget is \$40,000 more than we have. Can't go to bank and get a loan. We need to talk about the budget at District meetings. How many DCMs have talked to their GSRs? Ask what is their sobriety worth? Budget was approved, now need to contribute. What services do they want?

GSRs at the Assembly didn't know we were going to be \$40,000 short when they approved the budget.

All for using Zoom and saving money. We didn't have Zoom in the past, but now people can get all the info online, so we don't need to send every-

We need to have unity and keep the doors open for new people. Groups could use Venmo and use their debit cards because a lot of people don't carry cash. Would be willing to rent a bus to get people to events. That would save roughly \$7,000.

That would save only 20% of the budget.

Had this discussion at their group and talked about inflation. Got more money in the basket. Have to discuss with group where to send the money. A lot of groups don't contribute to the Area.

Comm. Chair – We can save \$7000 now, but that won't instantly fix the problem. Things have to fundamentally shift. Right now, the 175 groups that contribute to the Area would have to send in \$500 per year to meet the budget. If we get a bunch of contributions before the next ACM, we can revisit.

We are \$18,000 in the hole right now. This is urgent.

This does not address the underlying problem. Groups must increase contributions. Where is the money? Are groups exercising the power of the

The WCRAASC and the Forum cost \$25,000. That is where the overage is compared to last year's budget. We were asked to budget for these events. The minimum requirements for an Area are to have one Assembly per year and to send the Delegate to the General Service Conference. What do we want to cut? Educating our Area Committee members? Quit reimbursing for travel to ACMs?

We have spent last year's budget exactly, but we were sent \$20,000 less than what was voted for by the Assembly.

Aaron made a FRIENDLY AMENDMENT TO HAVE THE DELE-GATE AND ALT. DELEGATE CARPOOL AND SHARE A ROOM. Friendly amendment not accepted. MOTION TO HAVE AREA OFFICERS AND CHAIRS ATTEND WCRAASC BY ZOOM AND REIMBURSE DELEGATE AND ALT DELEGATE. Vote: 17 in favor, 5 opposed. MOTION PASSED.

Discussion – Treasurer: What do we want to do going forward? DCMs go to groups in their district that don't contribute and explain how they would benefit from contributing. Do we want to revisit this in February? Resubmit budgets?

Chair – Have to bring this back to groups. Area Committee has to be prudent. We will talk about this again at the February ACM and the Spring

If we take away the Regional Forum, we could save \$25,000. We can consider this later.

Spring Assembly Agenda Format Discussion

Chair – According to the evaluations from the Fall Assembly, many want to have the business done on Saturday. Do a trial run at the Spring Assembly? Can shift things around. Focus of Spring Assembly is on agenda

Discussion – Agenda items are important. Talk about old and new business before the agenda items. This was discussed in the morning's committee meeting.

Trust Area Chair to change format. Heard many discussions about wanting

Chair – Area 35 uses Roberts Rules as the basis for the agenda.

There are many comments in the Area Inventory about wanting change. People are in a rush to get out on Sunday. There is not enough patience on Sundays. Budget discussion was rushed. We need exhaustive discussion to get the true group conscience.

We are here for AA, not for ourselves.

Chair asked for a sense of the meeting. How many would be opposed to changing the agenda? Only two were opposed.

Area Officer Elections Discussion

Delegate – At the General Service Conference, the Delegate from the Area that is nominating a Trustee gives a two-minute introduction of the person being nominated. These include qualifications of the nominee, and some may get more personal. Idea – Have the person doing the nominating give a one-minute introduction of the nominee explaining why they think the person is qualified. This would be for the Chair, the Treasurer, and the Secretary positions. For Delegate nominations, have the DCM of the nominating district do the same thing.

Discussion – It is a good idea. New people have no idea who the people they are voting for are.

Need to know who they are. Do they have the qualifications. Tricky when nominating from podium - might be considered politicking. Use resumé. Do away with nominations and just have people stand for positions. Chair – We will leave this on the agenda and bring it back to the groups. Why are we talking about this now?

This came up at the Fall Assembly because people did not know anything

about the nominees. Getting to know something about them would help a lot in choosing who to vote for.

Can we get resumes in advance, so we know who they are? Answer: That is what we want to know. Bring this back to the groups to discuss. Do we want to form a nominating committee? Sense of the meeting was

Bridging the Gap Brochure

Ricco R. made a motion that the AREA 35 COMMITTEE PAY \$178.24 FOR 1,000 BROCHURES PRINTED ON COLORED PA-PER AND FOLDED, FOR THE BRIDGING THE GAP/ TEMPORARY CONTACT PROGRAM. Denise R. seconded the mo-

Treatment Chair Ricco explained what the brochure is and why it can be helpful. The brochure explains the Bridging the Gap Program, how to become a volunteer, and why this can help the treatment center's clients. It also explains what to do and what to avoid, and it explains what pamphlets may be helpful. The brochure cost about \$0.18 each.

Discussion – Is this going to be a statewide thing involving MPLS Intergroup? Treatment Chair has heard nothing about that.

It is possible there could be 100 calls per week. Can the Committee handle

Treatment Chair – This will be done by district. District Treatment Chair will give brochures to the treatment centers and the volunteers. Could have DCMs of the districts arrange for contacts.

Are the forms online? Will be using paper for forms. Motion is for printing brochures only. Forms will have to be printed out by districts/ individuals.

Shouldn't this expense be covered under the Treatment Chair's budget? Treatment Chair – It wasn't included in the Treatment budget. Didn't know this would come up. It came up during treatment committee meet-

Why not use what comes from GSO? This brochure is personalized for our Area and our districts.

GSO brochure is generic. We could just put a label on it and use that. Cost would be about the same.

Treatment Chair: that is a question for the Area.

Corr. Chair – Forms for treatment and corrections are different, require different information. Minneapolis Intergroup will be involved with the statewide Corrections contact program.

Vote - Ten votes in favor of the motion, 8 opposed. MOTION

Minority opinion – GSO has this form, and our budget is already maxed out. Now we are going to spend more?

GSO's brochure is \$0.20 each, plus shipping costs.

Hybrid Meetings for Area Events Going Forward

Discussion

NL Chair - We looked at costs in our committee meeting.

Treasurer – ACM costs \$1500 to \$2500 per meeting. The Workshop costs

If that is based on travel and lodging, we have already booked those rooms.

If we start now, does the Area have to pay for rooms not used? YES Zoom is not a reason for us not to go.

Zoom would get more attendees.

What was the cost of adding Zoom at the Fall Assembly? Was it worth it? Webmaster – Requirements of having Zoom at hotels might be a problem. Equipment rental/purchase is \$100 to \$300 per month. We need costs and specifics to bring to groups.

Delegate – We are not the only Area with this dilemma. How do we want to produce this? Some venues are better than others. Chair - Webmaster will provide costs

Discussion about January Workshop -

Some people can't afford to attend. Do we have the needed equipment? Using Zoom would give people an excuse to stay home.

Webmaster - Can get some equipment for a trial run for free

Singleness of Purpose

I recently completed the Eighth Step and have decided that my first amends should be to Alcoholics Anonymous itself, which I believe I have harmed to some extent by violating its singleness of purpose.

I used to identify myself as an alcoholic and an addict. I do not anymore because I now believe other addictions are irrelevant at AA meetings. But, aside from that, I also used to insist on talking about my other addictions beyond what was necessary to relate them to alcohol. I justified this by saying that alcohol was just another drug and so it was unfair to expect me not to talk about all my addictions. And refused to attend any other fellowship because I claimed to prefer the wisdom and sobriety in AA. I realize now how rude and self-centered this position was. It is not a question of what is fair or whether alcohol is just another drug. The Traditions and primary purpose of AA are what they are whether I agree with them or not.

In the past, when I was active, I often had dinner at the homes of people who did not use drugs, but who did drink. I never considered insisting that I had the right to smoke a joint at their dinner table because they were drinking wine. And imagine if I had, and then added insult to injury by saying: "And not only do I have a right to use any drug I want to around here if you're going to drink, but I'm going to keep coming back and I'm going to keep using any drug I want to in your home because I like the food you serve and your company better than the food and company I find in the homes of my drug addict friends. And I have a right to do this because all drugs are the same and I don't care what the rules or customs of your home are."

Such a gross abuse of hospitality sounds preposterous, but that is essentially what I was doing by insisting that I had a right to violate AA's singleness of purpose. I was abusing the hospitality of this Fellowship. This is not an apology. I was too sick to realize how selfishly I was acting, and a mere apology is not necessarily an amends. I am hoping to amend the harm I did by stating clearly what I did, for the benefit of others, and, further, by not doing it again.

In all A.A.'s public relations, A.A.'s sole objective is to help the still suffering alcoholic; always mindful of the importance of personal anonymity at the public level.

Public information takes many forms, from the simple sign outside a meeting place, to distribution of A.A. literature, A.A. websites, anonymity protected PSAs, informational videos, radio, television and digital media. A thoughtful and informed group conscience is encouraged to be responsible for deciding how best to inform members and the public about A.A. and how as members we can use digital media, practice anonymity and avoid anonymity breaks.

Below is sharing from A.A. resources as a reminder of the importance of A.A.'s anonymity Traditions in our digital lives.

In 2013 the General Service Conference affirmed "... that the Internet, social media and all forms of public communications are implicit in the last phrase of the Short Form of Tradition Eleven, which reads: '... at the level of press, radio and films.'"

General Principles

"When appearing on radio, television, film or on the Internet as A.A. members, we refrain from showing our faces or revealing our last names. In printed articles, on websites or email, we are identified by our first names and last initials only."

"When using digital media, A.A. members are responsible for their own anonymity and that of others. When we post, text, or blog, we should assume that we are publishing at the public level. When we break our anonymity in these forums, we may inadvertently break the anonymity of others."

A.A. Websites

"We observe all of A.A.'s principles and Traditions on our websites. As anonymity is the "spiritual foundation of all our Traditions," we practice anonymity on A.A. websites. Some A.A. websites contain password-protected sections for members only, but publicly accessible pages of an A.A. website have the potential for reaching the broadest possible audience and, therefore, require the same safeguards that we use at the level of press, radio and film. For more sharing on this topic, see the resource page Anonymity — A Vital Spiritual Principle on G.S.O.'s website."

- "... social networking websites are public in nature. Though users create accounts and utilize usernames and passwords, once on the site, it is a public medium where A.A. members and non-A.A.s mingle...'
- "...As long as individuals do not identify themselves as A.A. members, there is no conflict of interest. However, someone using their full name and/or a likeness, such as a full-face photograph, would be contrary to the spirit of the Eleventh Tradition, which states in the Long Form that, "... our [last] names and pictures as A.A. members ought not be broadcast, filmed or publicly printed..."
- "... Even "closed" or "private" groups might still reveal an individual's identity. Being well-informed prior to joining or starting such a group is the key to protecting your own anonymity, and that of others."

Emai

"When using email it is necessary to consider the anonymity of the recipients of messages. Sending messages to multiple recipients that disclose the email addresses of everyone on the addressee list is a potential break of someone else's anonymity. Therefore, it is a good idea to obtain a recipient's explicit permission before using his or her e-mail address for A.A. correspondence, especially if it is a workplace email address. When sending A.A. mail to multiple recipients who wish to remain anonymous, use can be made of the BCC (Blind Courtesy Copy) option available on most computers."

Internet

"Many technological options are possible and, presumably, more are being developed each day. Yet . . . it is important not to let the speed of technological development pressure a committee [or an A.A. group] into a quick solution as opposed to a well-thought-out A.A.-oriented decision. Of course, all decisions must include careful consideration of any situations where an A.A. member's anonymity could be compromised at the public level."

Videos and Audios

Sound and visual media help to carry the message of recovery of Alcoholics Anonymous and to inform the public and professionals about A.A. Public Service Announcements (PSAs) are available in both video and audio formats (for television and radio broadcast), as well as other materials specifically for young people and for professionals working with alcoholics. (These are examples of anonymity protected media to carry the A.A. message.)

Tradition Three by Bill W. Copyright © The A.A. Grapevine, Inc., February 1948

"Our membership ought to include all who suffer alcoholism. Hence we may refuse none who wish to recover. Nor ought A.A. membership ever depend upon money or conformity. Any two or three alcoholics gathered together for sobriety may call themselves an A.A. group, provided that, as a group, they have no other affiliation." The Third Tradition is a sweeping statement indeed; it takes in a lot of territory. Some people might think it too idealistic to be practical. It tells every alcoholic in the world that he may become, and remain, a member of Alcoholics Anonymous so long as he says so. In short, Alcoholics Anonymous has no membership rule.

Why is this so? Our answer is simple and practical. Even in self protection, we do not wish to erect the slightest barrier between ourselves and the brother alcoholic who still suffers. We know that society has been demanding that he conform to its laws and conventions. But the essence of his alcoholic malady is the fact that he has been unable or unwilling to conform either to the laws of man or God. If he is anything, the sick alcoholic is a rebellious nonconformist. How well we understand that; every member of Alcoholics Anonymous was once a rebel himself. Hence we cannot offer to meet him at any half-way mark. We must enter the dark cave where he is and show him that we understand. We realize that he is altogether too weak and confused to jump hurdles. If we raise obstacles, he might stay away and perish. He might be denied his priceless opportunity.

So when he asks, "Are there any conditions?" we joyfully reply, "No, not a one." When skeptically he comes back saying, "But certainly there must be things that I have to do and believe," we quickly answer, "In Alcoholics Anonymous there are no musts." Cynically, perhaps, he then inquires, "What is this all going to cost me?" We are able to laugh and say, "Nothing at all, there are no fees and dues." Thus, in a brief hour, is our friend disarmed of his suspicion and rebellion. His eyes begin to open on a new world of friendship and understanding. Bankrupt idealist that he has been, his ideal is no longer a dream. After years of lonely search it now stands revealed. The reality of Alcoholics Anonymous bursts upon him. For Alcoholics Anonymous is saying, "We have something priceless to give, if only you will receive." That is all. But to our new friend, it is everything. Without more ado, he becomes one of us.

Our membership tradition does contain, however, one vitally important qualification. That qualification relates to the use of our name, Alcoholics Anonymous. We believe that any two or three alcoholics gathered together for sobriety may call themselves an A.A. group provided that, as a group, they have no other affiliation. Here our purpose is clear and unequivocal. For obvious reasons we wish the name Alcoholics Anonymous to be used only in connection with straight A.A. activities. One can think of no A.A. member who would like, for example, to see the formation of "dry" A.A. groups, "wet" A.A. groups, Republican A.A. groups, Communist A.A. groups. Few, if any, would wish our groups to be designated by religious denominations. We cannot lend the A.A. name, even indirectly to other activities, however worthy. If we do so we shall become hopelessly compromised and divided. We think that A.A. should offer its experience to the whole world for whatever use can be made of it. But not its name. Nothing could be more certain.

Let us of A.A. therefore resolve that we shall always be inclusive, and never exclusive, offering all we have to all men save our title. May all barriers be thus leveled, may our unity thus be preserved. And may God grant us a long life –and a useful one!

"Not one of us is given a torch big enough to lead the drunks of the world out of the darkness and into the light.

Instead, each of us has been given a candle that burns for a short while with a flickering flame.

If we stand together, the light will outshine the greatest torch.

If we argue and bicker and blow at each other's candle so that each of us starts shielding our own little flame, then the alcoholics of the world will continue to suffer in darkness, and so will we."



AREA OFFICER & ACTION COMMITTEE NL REPORTS

<u>DELEGATE – STEVEN L</u>

Howdy Ladies and Gentlemen, May you all enjoy a happy and joyous New Year. First, I made a mistake. I have to retract a statement from my report at the December Area Committee meeting. I misunderstood a statement Mike L. (WCR Trustee) said at the WCR Delegates meeting November 28, 2022. I stated, "Mike L. reported that we moved \$1.1 million from the reserve fund (this came from the insurance money received on the cancelled International Convention which was to be held in Detroit) to the General Operating fund to cover deficits, \$250k of the insurance money stayed in the reserve fund." I should have written that the insurance monies were not being held in the reserve fund. They were being held in a special account in the general fund while the Trustees and AAWS board determined where the money would be used.

At the December Delegates meeting, we discussed the budgets for AAWS and the Grapevine. The budgets will be ready for approval at the January Board Weekend. As it looks right now, AAWS has a \$20,000 surplus. This may be tweaked with a couple of items that came in after the budget was put together. The Grapevine budget is still a work in progress. Over the last several years Grapevine has been tasked with providing services from the General Service Conference (GSC), our YouTube channel, our Instagram pages and GV Podcast. These items are provided at no cost to the fellowship, but they are incurring expenses on the Grapevine side. Loving discussion is going on right now about unfunded services that we are providing from the GSC. This money should be coming from the general fund of the General Service Board. This discussion is ongoing and will probably carry over to the February meeting.

Grapevine is working on an app development (this will be capital expenditure, not a budgeted item for the year). When Mike was delegate in 2003-2004, we had over 95,000 GV subscriptions. We are currently at the 60,000 mark. We are trending down about 5,000 to 6,000 GV subscriptions every year. In the next four years, we will be losing \$800,000 a year staying with just a print format. The business model we built with the app in that same time period will be seeing revenue of \$1,000,000 a year. Once it hits that point, we will have to adjust the price of the app because we cannot accumulate excess funds. The starting price is \$3 a month, this will drop down to \$2 or \$1 a month. With digital material, the only costs are to maintain the platform and to produce the material. There will never be a time when we don't need the Grapevine in print for corrections and PI/CPC work. Also, some members of our fellowship still want a printed copy to hold and read. The tentative schedule we have is to do a hard rollout of the app in September of 2023.

Bob W. (GSO general manager) has restructured the way we are tracking international licenses by establishing two separate departments outside of the publishing department. The first department contains Legal, Licensing and Intellectual Property. The second department is Language Services. The reason they formed the two departments is because foreign offices are losing their license to print and sell our literature, this is causing disruption in carrying the AA message because they have no literature to sell. This has nothing to do with copyrights. Another issue being looked at is that Grapevine has a lot of material copyrighted that happens to be printed in AAWS materials, the Service Manual, the Big Book and pamphlets. For example, the pamphlet Problems Other Than Alcohol, was originally a Grapevine article. This is an example of Grapevine intellectual property that is now generating revenue for AAWS. We don't have any guidelines in place defining how we handle inter-company licensing issues. This is a problem that will probably require some legal assistance for the new ad-hoc committee. The agenda item rollout is still planned for the middle of February with all three translations (English, French, Spanish). Mike L. stated that there doesn't appear to be as many agenda items as last year. They started translating the agenda items earlier. These two things will help with the roll out of agenda items being on time.

Here is the reason there are fewer agenda items this year. The Trustees bundled two big agenda items this year. One is the production of the <u>Plain and</u> Simple Language of the BB which had about 28 agenda items submitted by the fellowship which was bundled into one agenda item. The 28 submitted agenda items were split between dropping the project and having the whole conference read and decide if the production of the Plain and Simple Language of the BB should continue. The second big bundle of agenda items is the change in the language of the 12 X 12. This had about 24 submissions from the fellowship, most requesting to reinstate the old writings with one submission wanting to keep the changes. I will be addressing what bundling means when we discuss agenda items at the Spring Assembly. Two items that our Area is interested in were deemed not to be discussed at the conference by the Trustees, they are: the use of the Google Ads grant and the changing of the words in the preamble from "men and women" to "people". The change to the preamble had about 14 submissions from the fellowship, most requesting to reinstate "men and women". The Trustees' reasoning was there was not enough interest from the fellowship to address the change. Mike L. stated that the Plain and Simple Language of the BB should have five to eight chapters in rough draft form available to view at the conference this year. The Literature committee is getting first crack at viewing the draft.

Did you enjoy the workshop?? I did! What a bunch of great presentations. The guest speakers Brooke and Dennis did wonderful jobs and there was enough ice cream for everyone. One takeaway I got was a comment Dennis made during the ask-it basket session. As he was answering a question, Dennis asked, "Is your Group an active part of AA or an Associate meeting?" An associate being a meeting that only wants the benefits of AA but doesn't participate in the decisions of AA, having no GSR, not attending Area As-

semblies or District meetings. Whereas, an active Group participates in AA, has a GSR, attends Area Assemblies and is involved with the communications between the Group and GSO. What is your Group??

I want to discuss Tradition Seven and the Area 35's budget. Remember, Area 35 has no revenue stream. Moneys for Area 35 are solely provided by the generous contributions from the Groups. Tradition 7 states, "Every A.A. group ought to be <u>fully self-supporting</u>, declining outside contributions." Let's break this down. Declining outside contributions is just that, its simplest meaning is we don't solicit or take money from outside of AA. Fully self-supporting gets a little more complicated. One might say that just keeping the Group afloat by paying rent, buying coffee and maybe literature is enough. But, they are forgetting their responsibility to their District and our Area and GSO.

Remember, when the Groups approve a budget for their District or Area, they are implying that they will send contributions to fulfill their commitment of the approved budget for the services they requested. In Area 35 some services provided to the Groups are: the Northern Light newspaper, our Website, Archive storage space, holding two Assemblies a year, holding a workshop once a year, holding four Action Committee Meetings in Aitkin a year, sending your Delegate to the yearly General Service Conference (GSC) in NY, having the Delegate give reports back to the Districts on the GSC, sending your Area Officers and Action Chairs to the West Central Reginal AA Service Conference (WCRAASC) once a year and to a Reginal Forum once a rotation. These are the services you have asked for through the years and all make 12 step work possible and available to you.

I want to end with an amend. At the workshop during our officers meeting, I was guilty of butting in and interrupting other people's comments. I apologize for speaking out of turn, not listening and being rude.

<u>ALTERNATE DELEGATE – JUSTIN W</u>

Greetings Area 35. Since the December ACM I have mostly been working on the January Workshop. I contacted the presenting districts and had the privilege of helping prepare them in some cases. Thanks to all of you for doing such a great job with the presentations. I worked with Scott and Terry from District 12 to finalize their responsibilities for registration and coffee, and they did a presentation as well. Thanks to District 12 for hosting the workshop and for a job well-done. I finalized the details with the hotel regarding the specifics for set up and signed and approved multiple revisions to the banquet event order. The hotel was a pleasure to work with for the most part. I finalized the Evaluation Forms, and the Voice Book and got the Evaluations and some other things printed. Thanks to Christine for printing the Agendas at the last minute.

To start with, there were a few errors that I'm aware of. The agenda was missing any reference to the GSR and DCM sharing session reports so those will be in the next issue of the Northern Light. I added this into the templates for the Agenda and the Voicebook for next year which should keep it from happening again. Also, I neglected to put together a list of restaurants in the area and have added notes to the Voicebook template about this, so it is not overlooked in the future.

There were also a few issues that I consider to be much more significant. The audio was inadequate for the zoom attendees. It was suggested we might need wearable microphones if it's going to be successful. Our equipment did include integrated mics that weren't able to be used, and I wonder how this might have helped. We need to get a handle on this if we are planning on hybrid area events in the future, and I am available to help with it if I can. Worst of all, there were 2 past Delegates attending via Zoom for the entirety of the event and I did not recognize them as past Delegates nor include them in the Ask-it-basket; Susie Ardolf – Panel 48 and Tom Ardolf – Panel 50 (also past West Central Regional Trustee). There was a note passed to me after the event asking if they should have been involved in the Ask-it-basket, to which I respond "Yes...Absolutely". I have spent a considerable amount of energy wishing that note had been passed to me a little sooner so I could have addressed the error during the workshop. One of the evaluations I received asked "why weren't the past Delegates on Zoom used for Ask-itbasket?" The short answer is because I did not know that they were attending via Zoom when we started the Ask-it-basket. I neglected to ask and didn't have any indication that they were present. I did receive text messages at 11:33 and 11:39 letting me know, but I did not see either of them until after we closed the event. It was an oversight; an egregious error by my own estimation, for which I am culpable and responsible.

I am sincerely sorry and remorseful for this, and I humbly ask your forgiveness. My dictionary and our program say that making amends is about
compensating for the injury; paying for it; trying to make it right. I've had a
few days to think about this and have spoken to multiple people about it,
each of them more than once. I will address the personal injuries directly at
the earliest possible opportunity. But there has been an injury to the groups
in area 35. We all stand to benefit a great deal from the experience and advice of our past Delegates and because of this error, we suffered the loss of
this privilege and opportunity. I can't think of a way to repay this debt directly; that is return what was lost. But I will do all that is within my ability to
make sure it doesn't happen again. Since I will have the opportunity to help
the incoming alternate delegate set up the next workshop, I assure you it will
not occur at the next workshop; or any future event I attend, even if it means
making a point-of-order from the mic and interrupting the event. Also, I have

edited the Voicebook template such that Zoom participants cannot be overlooked by the chair in the future. While I cannot single-handedly solve the technical issues we had with Zoom, I will certainly suggest that we should create something of a "procedure" for hosting area events over zoom. We need to bring the Zoom participants into the room a little better, so we can see that they're with us on the projector screens, and do what we can to make their experience the best it can be.

We received a total of 39 evaluation forms for the event, about 13 from GSR's and 26 from repeat offenders. This is an estimation because it's based on how many workshops each person has attended. There's a rating system built into the form based on the checkboxes for how satisfied each person was, and the event scored 3.5 out of a possible 4. So, this is pretty good... I guess it was a 3 and a half Star Workshop! I received quite a bit of feedback including several suggestions for improving the workshop. Several folks thought the hotel was too expensive. This was definitely a consideration when selecting the venue. There were a couple of other hotels I looked at that were cheaper but literally could not accommodate us. Last year's hotel was priced just right but failed in multiple ways to accommodate us. It's tough to find a good balance between the cost of the venue and the actual value we expect. The costs associated with lodging and events have gone through the roof here recently.

There were a few suggestions like having a list of restaurants and I have added notes for this to the Voicebook template; possibly having another AA meeting during the sharing sessions and committee meeting time slot so folks that aren't involved in those would have something to do. This has also been added as an option to both the Voicebook and Agenda templates. One person said we should have had a box for the evaluation forms which I have added to the Voice Book template for next year. It was suggested that we might consider providing some guidance on how to conduct the sharing sessions. We've heard this before and I'd like to see the area committee develop a format document for the sharing sessions if it is in line with the conscience of our group here.

But the words used most often in the comment section of the evaluations we got back were "thanks", "awesome", "loved", "excellent", "special thanks", "very informative" and "great job". A few even said it was the best workshop they had been to, or one of the best they had been to. And I did verify that they had been to more than just this one!

Saturday morning, before the event started, the saleslady took me into the kitchen to show me where the freezer was so we could keep our ice cream in there. She mentioned that they'd be offsite for a wedding as we passed the coffee machines, and I tried to tell her how important coffee was to our group. I mentioned we were really good at making coffee and would be willing to make a pot if need be. She said that there "should be" a server available if we needed any additional coffee. So, in the afternoon when Scott and I were faced with the unthinkable dilemma of running out of coffee in a room with a hundred sober alcoholics, and no server in sight, I remembered seeing the coffee machines in the kitchen earlier while simultaneously and conveniently forgetting select and pertinent parts of my earlier conversation with the saleslady about not making our own coffee. Scott and I went into the kitchen, and to make matters worse, there was a cook in there who was pretty easy going and turned out to be no match for 2 desperate drunks. Scott made the pot of coffee....not me! Later on, Scott told me that the sales lady came back from the wedding and was none too happy about his shenanigans! I did make amends to the saleslady over the phone and assured her that were not trying to steal the pot of coffee, but that our common welfare had to come first and that running out of coffee was a real threat to the unity of our group! Later that evening when Christine arrived with the ice cream....the freezer was one of those walk-in freezers like they have in the movies; with a door that closes by itself and locks from the outside, like they have in the movies. I put the ice cream in there and the door closed behind me, just like they do in the movies. By the grace of God, I hadn't quite gone in there all the way and the door hit me in the britches instead of closing and latching!

Thank you all for letting me be a part of this!

CHAIR - CHRISTINE G

Greetings Area 35, since the December ACM, I have been working with the committees that are reviewing the Area inventory to ensure that they have upcoming meeting times available. Thank you to all of you working on the committee, we are excited to see your recommendations for distribution at the Spring Assembly.

I have been working with our Area Treasurer and communicating to the area committee about the area finances to ensure the information is getting communicated to the groups. It has been requested that a plan of action be established that does not only include the cutting of spending. This is the contents of the email that was distributed:

Good Afternoon,

There has been a request to see a plan of action from the area that addresses "the contribution crisis, not just cut our spending." Thank you for this request.

We will continue communicating, that in order to perform the activities that were approved at the Fall Assembly with the approval of the 2023 budget, group contributions do need to be increased to meet those expenses. We have asked that this information be shared with the GSRs at the district meetings. To help with this, our Area 35 Treasurer is putting together a letter for each DCM that will provide information to be shared with the groups. It will also provide contributions from the

groups in that district during 2022 so DCMs can have a better look at who is contributing and where there may need some outreach.

With this letter, there will be another informational sheet that will explain the services that are provided with the contributions. This will be good information to get to the groups to help them understand where their contributions are going and hopefully spark an interest in taking another step to send a GSR to these events. DCMs can look for these letters coming in the mail by February 1st.

We have also reached out to districts local to us to let them know that our services are available and if you would like presentations, workshops or us to come to have a chat, we are available to do so. The format of the workshop was fantastic, and our Alternate Delegate did a great job organizing and chairing the workshop. 

12 Traditions of Alcoholics Anonymous (Long Form)

- 1. Each member of Alcoholics Anonymous is but a small part of a great whole. A.A. must continue to live or most of us will surely die. Hence our common welfare comes first. But individual welfare follows close afterward
- 2. For our group purpose there is but one ultimate authority—a loving God as He may express Himself in our group conscience.
- 3. Our membership ought to include all who suffer from alcoholism. Hence we may refuse none who wish to recover. Nor ought A.A. membership ever depend upon money or conformity. Any two or three alcoholics gathered together for sobriety may call themselves an A.A. group, provided that, as a group, they have no other affiliation.
- 4. With respect to its own affairs, each A.A. group should be responsible to no other authority than its own conscience. But when its plans concern the welfare of neighboring groups also, those groups ought to be consulted. And no group, regional committee, or individual should ever take any action that might greatly affect A.A. as a whole without conferring with the trustees of the General Service Board. On such issues our common welfare is paramount.
- 5. Each Alcoholics Anonymous group ought to be a spiritual entity having but one primary purpose—that of carrying its message to the alcoholic who still suffers.
- 6. Problems of money, property, and authority may easily divert us from our primary spiritual aim. We think, therefore, that any considerable property of genuine use to A.A. should be separately incorporated and managed, thus dividing the material from the spiritual. An A.A. group, as such, should never go into business. Secondary aids to A.A., such as clubs or hospitals which require much property or administration, ought to be incorporated and so set apart that, if necessary, they can be freely discarded by the groups. Hence such facilities ought not to use the A.A. name. Their management should be the sole responsibility of those people who financially support them. For clubs, A.A. managers are usually preferred. But hospitals, as well as other places of recuperation, ought to be well outside A.A.—and medically supervised. While an A.A. group may cooperate with anyone, such cooperation ought never go so far as affiliation or endorsement, actual or implied. An A.A. group can bind itself to no one.
- 7. The A.A. groups themselves ought to be fully supported by the voluntary contributions of their own members. We think that each group should soon achieve this ideal; that any public solicitation of funds using the name of Alcoholics Anonymous is highly dangerous, whether by groups, clubs, hospitals, or other outside agencies; that acceptance of large gifts from any source, or of contributions carrying any obligation whatever, is unwise. Then too, we view with much concern those A.A. treasuries which continue, beyond prudent reserves, to accumulate funds for no stated A.A. purpose. Experience has often warned us that nothing can so surely destroy our spiritual heritage as futile disputes over property, money, and authority.
- 8. Alcoholics Anonymous should remain forever non-professional. We define professionalism as the occupation of counseling alcoholics for fees or hire. But we may employ alcoholics where they are going to perform those services for which we may otherwise have to engage nonalcoholics. Such special services may be well recompensed. But our usual A.A. "12 Step" work is never to be paid for.
- 9. Each A.A. group needs the least possible organization. Rotating leadership is the best. The small group may elect its secretary, the large group its rotating committee, and the groups of a large metropolitan area their central or intergroup committee, which often employs a full-time secretary. The trustees of the General Service Board are, in effect, our A.A. General Service Committee. They are the custodians of our A.A. Tradition and the receivers of voluntary A.A. contributions by which we maintain our A.A. General Service Office at New York. They are authorized by the groups to handle our over-all public relations and they guarantee the integrity of our principal newspaper, the A.A. Grapevine. All such representatives are to be guided in the spirit of service, for true leaders in A.A. are but trusted and experienced servants of the whole. They derive no real authority from their titles; they do not govern. Universal respect is the key to their usefulness.
- 10. No A.A. group or member should ever, in such a way as to implicate A.A., express any opinion on outside controversial issues—particularly those of politics, alcohol reform, or sectarian religion. The Alcoholics Anonymous groups oppose no one. Concerning such matters they can express no views whatever.
- 11. Our relations with the general public should be characterized by personal anonymity. We think A.A. ought to avoid sensational advertising. Our names and pictures as A.A. members ought not be broadcast, filmed, or publicly printed. Our public relations should be guided by the principle of attraction rather than promotion. There is never need to praise ourselves. We feel it better to let our friends recommend us.
- 12. And finally, we of Alcoholics Anonymous believe that the principle of anonymity has an immense spiritual significance. It reminds us that we are to place principles before personalities; that we are actually to practice a genuine humility. This to the end that our great blessings may never spoil us; that we shall forever live in thankful contemplation of Him who presides over us all.

12 Concepts of Alcoholics Anonymous (Short Form)

- Final responsibility and ultimate authority for A.A. world services should always reside in the collective conscience of our whole Fellowship.
- II. The General Service Conference of A.A. has become, for nearly every practical purpose, the active voice and the effective conscience of our whole Society in its world affairs.
- III. To insure effective leadership, we should endow each element of A.A.—the Conference, the General Service Board and its service corporations, staffs, committees, and executives—with a traditional "Right of Decision."
- IV. At all responsible levels, we ought to maintain a traditional "Right of Participation," allowing a voting representation in a reasonable proportion to the responsibility that each must discharge.
- V. Throughout our structure, a traditional "Right of Appeal" ought to prevail, so that minority opinion will be heard and personal grievances receive careful consideration.
- VI. The Conference recognizes that the chief initiative and active responsibility in most world service matters should be exercised by the trustee members of the Conference acting as the General Service Board.
- VII. The Charter and Bylaws of the General Service Board are legal instruments, empowering the trustees to manage and conduct world service affairs. The Conference Charter is not a legal document; it relies upon traditional and the A.A. purse for final effectiveness.
- VIII. The trustees are the principal planners and administrators of overall policy and finance. They have custodial oversight of the separately incorporated and constantly active services, exercising this through their ability to elect all the directors of these entities.
- IX. Good service leadership at all levels is indispensable for our future functioning and safety. Primary world service leadership, once exercised by the founders, must necessarily be assumed by the trustees
- X. Every service responsibility should be matched by an equal service authority, with the scope of such authority well defined.
- XI. The trustees should always have the best possible committees, corporate service directors, executives, staffs, and consultants. Composition, qualifications, induction procedures, and rights and duties will always be matters of serious concern.
- XII. The Conference shall observe the spirit of A.A. tradition, taking care that it never becomes the seat of perilous wealth or power; that sufficient operating funds and reserve be its prudent financial principle; that it place none of its members in a position of unqualified authority over others; that it reach all important decisions by discussion, vote, and, whenever possible, by substantial unanimity; that its actions never be personally punitive nor an incitement to public controversy; that it never perform acts of government, and that, like the Society it serves, it will always remain democratic in thought and action.

- ♦ Keep informed of activities and issues going on within Alcoholics Anonymous as a whole. The N.L. Committee could subscribe to the Grapevine or other pertinent A.A. news sources.
- ♦ Gather useful service information to publish from sources within the Area, Region and A.A. as a whole. Obtain, read and use other Area newsletters.
- Listen to comments from the Area on the content of the N.L.

EDITORIAL POSITION & N.L. COMMITTEE:

Editor: The Editorial Chair position is a two-year rotation picked by the incoming Area Chair and either approved or rejected by the Area Committee at the first Area meeting after the Fall Assembly Elections.

Desirable qualifications: Current knowledge of MS Publisher, MS Word, MS Excel and other misc. computer programs as needed. The person should also consider the time needed to complete the task required. The candidate should have a working knowledge of A.A. as a whole, i.e., prior experience in service work such as G.S.R., D.C.M., or related position.

N.L. COMMITTEE: The N.L. Committee consists of the Area Group Records Chair, Area Webmaster and Area Audio Technician along with two D.C.M.s in Area 35. DCM's are picked randomly at the start of each rotation and serve on a two-year rotation basis. They assist the editor in communications with other area newsletters, in recommendations on general improvements, and with general problems and implementations of new policies. They may also represent the editor at functions when the editor is unable to attend.

N.L. COMMITTEE MEETINGS: The Committee meets every other month, before the start of the Area Workshop and at Spring and Fall Assemblies. If needed, additional meetings may be called.

NORTHERN LIGHT SUBMISSIONS:

General submissions are welcome! Feel free to send letters or articles that are pertinent to AA and Area 35. All submissions will be approved by the Northern Light committee, in accordance with Tradition Two; For our group purpose there is but one ultimate authority – a loving God as He may express Himself in our group conscience. Our leaders are but trusted servants; they do not govern. Please note that if space is limited, first priority will be given to reports from Area Officers, Area Standing Committee Chairs and D.C.M.s from Area 35.

 - h) AA must appear somewhere on the flyer
- 3. When is the event to take place?
 - a) Date and time
 - b) Does it reoccur
- 4. Where will the event take place?
 - a) Name of the facility and the address
 - b) Maps are sometimes helpful but not necessary
- 5. Why is the event taking place?
 - The reason for AA events is to carry the AA message to the still suffering alcoholic (this doesn't have to be printed on the flyer)
 - b) Usually covered in Who and What

*For safety reasons, if a phone number is listed on the flyer consider NOT putting a name in association with the number.

Only Area 35 AA members may submit a flier. Fliers for AA sponsored events only.

Please submit flyers in PDF format when possible. Flyers will be posted on area35.org and in the Northern Light at the Area 35 Webmaster's and Northern Light Editor's discretion. Email northernlight@area35.org with any questions.


AREA 35 EVENTS INCLEMENT WEATHER PROCEDURE

Q: Why list our past Delegates?

A: They are a resource to you!

In Alcoholics Anonymous we value experience. Our Twelve Steps did not exist when Bill stepped into the lobby of a hotel in Akron, Ohio. Even after meeting with Dr. Bob and soon founding our program, there were only six steps until the experiences of 100 Alcoholics were summed up. Soon after a book followed, but it was a few years later when the Twelve Traditions were discussed and agreed on. Twelve Traditions that were "hammered out on the anvil of experience". Our past Delegates are a wealth of experience, an interactive living archive if you will. When you plan your next service workshop or need an outside voice to offer help, consider this resource available to you.

The Delegate's Duties

Though the high point is the Conference meeting, the delegate's job goes on year-round and involves all aspects of the Conference structure. The delegate should:

- Attend the Conference meeting in April, fully prepared. Immediately upon election, every delegate is put on the G.S.O. mailing list to receive Conference materials.
- Communicate the actions of the Conference to area committee members and encourage them to pass on this information, and the delegate's enthusiasm, to groups and to intergroups/central offices. If an area is too large for the delegate to cover in person, he or she will ask area officers and committee members to share the load.
- Be prepared to attend all area, state/provincial, and regional service meetings and assemblies. From these meetings, delegates come to better understand their own areas and can make suggestions for the Conference agenda. Here, too, they come in contact with A.A. members who might not be reached otherwise.
- Help area committees obtain financial support for the area and G.S.O.
- Provide leadership in solving local problems involving the A.A. Traditions

- Remind G.S.R.s to inform groups and individuals about the A.A. Grapevine and Conference-approved literature.
- Cooperate with G.S.O. in obtaining information—for example, making sure that up-to-date information reaches G.S.O. in time to meet the deadline for each Issue of the A.A. directory and helping carry out the triennial membership surveys.
- Visit groups and districts in the area whenever possible.
- Work closely with committee members and officers, sharing experience throughout the year. After G.S.R.s and committee members have reported on the Conference, learn from these A.A.s how groups and members have reacted.
- Assume added responsibility if the area chair and alternate chair are unable to serve. Or, if an area committee is not functioning effectively, the delegate may take an active role in remedying the situation.
- Keep the alternate delegate fully informed and active, so that the alternate can replace the delegate in an emergency.
- Late in the second term, work with newly elected delegates to pass along a basic knowledge of Conference proceedings and problems.
