

# **AREA 35 MEETING MINUTES - UNAPPROVED**

Northern Minnesota Area Assembly Area 35 Fall Assembly Minutes St. Cloud, MN October 7-8, 2023

**Call to Order:** Area Chair called the meeting to order at 1:00 p.m. on Saturday, October 7, 2023, and opened with the Serenity Prayer. There were 105 people in attendance.

**Recognition of Past Delegates In Attendance:** Area 35 – Bob J, Panel 40; Tim C, Panel 52; Charlie C, Panel 54; Jim K, Panel 62; Jake J, Panel 64; Kelly D, Panel 66; Area 36 – Scott A, Panels 57 and 59

**Additions to Agenda:** January Workshop Registration Fee; Election Process; Area 35 Website Upgrade; Treasurer Electronic Payments

Approval of April 2023 Spring Assembly Minutes: Heidi B. motioned to approve the minutes; Kyle H. seconded. Motion carried.

**Points of Order:** Please limit sharing at the mic to two minutes, and please refrain from crosstalk.

### OFFICER REPORTS DELEGATE – STEVEN L

Good Afternoon Ladies and Gentlemen,

It is nice to see everybody here. How many here are attending their first Assembly? Take time to say howdy and shake hands with the people next to you. This is my last report to the full Assembly. Thank you for allowing me to serve as your Delegate these past two years. I've enjoyed traveling to your Districts. Meeting and getting to know you all has been a pleasure. We have had some robust discussions with the pre- and post-GSC agenda items and a few differences of opinion, it's been great, and I've loved every minute of it. The hospitality and warmth you have shown me will be unforgettable. It has been a joy and humbling experience to bring the Areas voice to the GSC. It's been an honor and privilege being chosen to sit and participate in the Conference Literature Committee in this monumental time in Alcoholics Anonymous. I enjoyed bringing back to you the full scuttlebutt from the General Service Conference.

Thank you for sending me to the WCRF in Missoula Mt. in August. I gave a full report in the NL for you to look at. We had about a dozen people from Area 35 in attendance, which I thought was a tremendous turnout, considering the distance. If you talk with the people who attended, you will get different perspectives on the event. I thought it was very informative. In November I will attend District 2's District meeting in Thief River Falls and give my final post-GSC report.

Just another reminder that the GV's app is out in both formats iOS and Android. The download is free for partial use. If you want full access to the app which gives you the ability to read the current GV and access the GV Archives, this will cost you \$2.99 a month, which you may cancel at any time.

Speaking of the new AA Grapevine App, it was a topic of discussion at the last WCR Delegates meeting. The cost of producing the app was brought up. A couple of Delegates were under the impression and in their reports gave the cost of the app to be over \$1m, \$500k from the reserve fund, and another \$670k from the Subscription Liability Fund. In reality, the cost for the GV app development was \$400k; Podcast, Instagram, and YouTube were \$100K making a total of \$500k from the reserve fund. The \$670K that Grapevine took from its Subscription Liability Fund is for normal operating expenses: printing, mailing, payroll, etc., to get us through our low print subscriptions in 2023 until app subscriptions build. We also heard from Area 40, Montana, that the WCRF was highly informative and it got a lot of people excited about service work in their Area. I'm also finishing up my WCR subcommittee duties. We put together a presentation for an introduction to WCRAASC to be presented Friday before the Conference starts in lieu of the paper trifold pamphlet that has been passed out in the past.

Here are a few other topics we discussed at the last WCR Delegates meeting: Meg the Southern Minn. Delegate inquired about an update to the Trustee's nominating committee with their work on selecting a Board Chair for the 2024 slate of Trustees? Kerry M., WCR point of Contact, responded that there are 3 finalists (she does not know who they are yet). The Board is going to NYC a day early in October to interview the candidates, then they will vote sometime over that weekend and at the end of the October Board weekend, there should be a nominee for a new GSB Chairperson. Rachel N Dakota Delegate asked if they were going to use all the \$15,000 approved for finding a new GSB Chair. Kerry responded, the contract was drafted for much less than that, but does not know how the true cost.

The 2023 General Service Conference reports are on the back literature table with Pat. Please take one so Pat doesn't have to bring any home with him. There is also an anonymity protected version online at aa.org. It was brought up at the last WCR Delegates meeting that The Final Conference Report claims there is an advisory action to allow alternate delegates to have the same access to the dashboard as the Delegates have, that 'advisory action' did not get substantial unanimity, so I think the Final Conference Report has an error. The answer Kerry received about the alternate delegate vote reporting issue was this. In 1989 the following statements were made as Advisory Actions "Although the following item did not receive the necessary two-thirds vote to become a Conference recommendation, it did receive a substantial majority and is therefore a strong suggestion for the board's consid-

eration". Now labeled as passed by simple majority as a signal to Trustees Committees. Based on the confusion labeling this as "passed" in the final report, Kerry will send a formal memo to the Conference Committee Chair to change how similar votes are labeled in future Final Conference Reports.

After being promised for the past six months I finally received printouts by District, Group contributions to the GSB for the 2<sup>nd</sup> Quarter. The glitch is fixed. I emailed them to all the DCMs to look at, so they can see and share how their District is contributing to the GSB. The report lists 1,140 Groups registered in Area 35. Of these it had 93 Groups contributing to the GSB which is only 8.16% of Groups sending contributions. In reality we have about 560 active Groups in Area 35 and with 93 contributing to the GSB then the percentage changes to 16.61% of the Groups contributing to the GSB for the 2<sup>nd</sup> quarter. I hope the DCMs will look at the list I sent them and get hold of Denise, our Group Records Secretary and see what we can do to correct the discrepancy in the Group count for Area 35.

Speaking of emails, we have Microsoft 365 now. The first batch of emails I sent most came back undeliverable. People hadn't set up their new email accounts, I hadn't. With this new tool we want to get the most from it we are going to offer training sessions to the incoming Offices and Action Chairs. Look and listen for more details on the training.

I mentioned in my last Northern Light report about a mystery announcement. While attending a GSC fall online meeting, during the PI Trustee's report, she mentioned that Google Ads and AA are parting ways. The separation was initiated by Google and is about 85% complete. Google Ads stated that we don't fit their definition to qualify for their subsidy.

I attended the tri-District workshop in Hibbing two weeks ago. It was put on by Districts 8, 9 and 16. I'll let the DCMs from those Districts comment on how it went. All I know is the two people I brought, who had never attended a workshop before, enjoyed it and sparked their interest in service work. There are fliers at the registration table about the upcoming 2024 WCRAASC being held in Minot, ND March  $1^{st} - 3^{rd}$ . Minot is hosting the state girls' basketball tournament that same weekend. Book a room Grand Hotel quickly to insure you get a room in the same Hotel as the Conference if you know you will be attending the WCRAASC. Grand Hotel, 1505 N Broadway, Minot, ND 701-852-3161 I Repeat 701-852-3161

My rotation as your Delegate is coming to an end. Tomorrow, we pick a new slate of officers to lead us for the next two years. Please, give them the same warmth and support you have shown me over the past two years. I have had the pleasure of serving Area 35 for the past 14 years as, Webmaster, Treasurer, F.O.C. chair, NL Editor, Alt-Delegate and finishing up as your Delegate. All have been a learning and humbling experience. Having said this, I'm not accepting any nominations to stand for any office tomorrow. As they say, I'm going out to pasture, and a new learning experience is waiting for me, keeping my mouth shut and being called on if needed, it's called being an Elder Statesman, this could be the toughest challenge and greatest learning experience for me in sobriety.

As I've gotten to know and listen to so many of you and experience talking with other Delegates on how their Areas conduct business, A lot of things I've heard wouldn't fly in Area 35, but three things stand out that I'd like to suggest to you that could improve Area 35's effectiveness.

First: We use a secret ballot for all voting at an Assembly, not just elections. I know this would slow down the business at an Assembly, by contrast, a secret ballot would preserve the integrity of the minority opinion. It would give those voters who are undecided an opportunity to vote without any peer pressure. This would refer to Assemblies only, not ACMs in Aitkin that's another matter to be decided for the ACMs.

Second: Only voting members of the Assembly would be able to participate in discussion at the mic. This is how business is done at the Conference. Others could be invited by a voting member to join in the discussion at the mic if that person has pertinent information about technical, historical, or procedural knowledge of the topic at hand. This would give the GSRs, Area officers and Area Committee Chairs the ultimate authority and decision in both discussion and voting in Area and AA affairs. It would also help with each Group having only one voice in Area and AA affairs.

Third: Have the June ACM become a one-day Assembly. This way, the Delegate could give their post-GSC report to the whole Area at once. The Assembly could be in a central location so everyone could make the round trip in one day. This meeting would be a few hours long, starting at one in the afternoon. We could provide an opportunity for committee meetings to take place before the Assembly starts. This could save the Area a lot of money in Delegate travel costs. This could also provide GSRs a timely manner to receive GSC information. If a group wanted to Propose an Agenda Item for the next GSC the Area would have a few months to discuss the PAI fully.

I hope you will take my suggestions back to your groups to give them some more consideration. It has been a blast visiting and getting to know you. I will be forever thankful for the opportunity you have given me to serve as your Delegate. My journey with you is waning and I'm looking forward to answering questions put in future ask-it baskets. With that, I pass.

And after much study, many group meetings and extensive individual feedback, I have developed the impression that what most professionals and professional groups "need" is how to find us. I am constantly amazed at the degree to which most of them actually KNOW the basic tenets and working parts of the AA program. They don't "need" more speeches and brochures as much as they simply want to know where and how to find meetings and expanded information on the program that they can resource electronically.

I've shared this model with several Districts over the past two years and hope to return to my home District to further apply this model in that 5-county area in the coming years. My fire was lit for service work when I first came to an event like this Assembly a number of years ago. And that passion is still there. Thanks for your support in the past and I hope to keep working with many of you in the future.

It was said, "... We must remember that AA will continue strong only so long as each of us freely and happily gives it away to another person, only as each of us takes our fair share of responsibility for sponsorship of those who still suffer, for the growth and integrity of our Group, for our Intergroup activities, and for A.A. as a whole."

When you start your search for Temporary Contacts or Corrections Volunteers, and when sharing about corrections service, refer to an excerpt from a letter that our cofounder Bill W. wrote to a prison group in 1949:

"Every A.A. has been, in a sense, a prisoner. Each of us has walled himself (Continued on page 8)

out of society; each has known social stigma. The lot of you folks has been even more difficult: In your case, society has also built a wall around you. But there isn't any real essential difference, a fact that practically all A.A.s now know. Therefore, when you members come into the world of A.A. on the outside, you can be sure that no one will care a fig that you have done time. What you are trying to be-not what you were-is all that counts with us."

I would like to share Bill W's feelings about Corrections work and A.A. Behind These Walls:

# From The Manuscript of A.A. World History 1985 by Bob P. A.A. "Behind The Walls"

Bill W. at the St. Louis Convention told with obvious glee how what he called "A.A.'s first prison group" came about in 1942. Even prior to that time, Bill said, "San Quentin's enlightened and liberal warden, Clinton T. Duffy, had given much thought to the urgent and pressing problem of prison reform, including the special needs of the inmates imprisoned for crimes committed while drinking. As Warden Duffy said, the program he proposed 'would include' education, vocational training, medicine, psychiatry, and religion. But the alcoholic did not' seem to fit completely into this program...all the rest would not help him if the problems which drove him to drink were not solved. In line with this new approach to rehabilitation, I looked upon Alcoholics Anonymous as a tool to help us rebuild lives.'

"To Warden Duffy's aid came Warren T. and other members in 'the San Francisco area," Bill continued. "As Warden Duffy has since said, 'Had it not been for the regular help and understanding given by our A.A. friends outside, the San Quentin chapter of Alcoholics Anonymous would most assuredly have failed. And by the same token, if it had not been for the persistence of that first group of alcoholic inmates who realized their serious problem and their need for help, we never could have continued beyond the first few meetings.'

"But even with such enthusiasm and willingness, there were formidable problems to solve," Bill pointed out to the St. Louis audience. "A.A. meetings would bring carloads of A.A.'s from the outside running in and out of prison. [They] would probably draw the ridicule of other prisoners. Those penologists who still thought hard-boiled methods to be the only way and those skeptics who thought A.A. only a 'useless fad' would shake their heads. It would mean large gatherings of prisoners unattended by guards. The risks were great, but Warden Duffy took them, and his faith was justified. A.A. soon won the respect of other prisoners A.A.'s came and went freely. . . The meetings had only one guard stationed outside the meeting room." The clincher came, according to Bill, when the recidivism rate of alcoholic prisoners "suddenly dropped from the usual 80 percent to a spectacular 20 percent, and held that way. Skeptics everywhere were convinced. This piece of pioneering made A.A. history." Bill spoke at San Quentin's A.A. group meeting on November 28, 1943.

What made this event particularly important to Bill was undoubtedly that the initiative had come from Warden Duffy. Actually, as the Fellowship spread in the early years, pioneer members usually tried to carry the message "behind the walls" of jails and prisons wherever they were—but not always with such success. After all, the standard treatment for drunks for a century or more was to throw them in jail. And on occasion, as was chronicled in early A.A. stories, the drunk would awake to find that this time he was not charged with public intoxication disorderly conduct, but with a far more serious crime—assault robbery or even murder—that he had committed in a blackout or during temporary alcoholic insanity. So penal institutions were one of the likeliest places to find alcoholics who needed help—and A.A. members responded accordingly without direction from anybody, but acting out of their compassion and desire to work the Twelfth Step.

Area Chair explained that this motion was made to allow more time for the ACM minutes and the Northern Light to be completed and sent to the printer by the printing deadline. Vote: Motion PASSED

# Minority Opinion:

- Delegate will not get printed agenda items out for the February ACM.
   DCMs and others who want printed copies will not be able to get them.
- Days are shorter and early February is cold.
- Why are we wanting to do this?

- To increase the time frame for the Northern Lights editor to get the publication ready in time to get it to the printer. Agenda items will be posted on area35.org for people to access.
- To increase the time frame for the Secretary to complete the minutes for inclusion in the Northern Light

Dennis made a "Motion to Reconsider." Bob N. seconded the motion. Vote: Motion to Reconsider FAILED.

Comment was made that Robert's Rules of Order uses the original number of voting members present at the beginning of proceedings for a quorum. If he beginning count is 100, 2/3 is needed, which is 67. If 20 people are not present for another vote on another item, 2/3 of 100 is still used.

Delegate explained that at the Conference, 2/3 of the total voting members in the room is what is used, not 2/3 of the number of the people who voted. People may come and go from the room, so a head count of the total number of voting members can change from vote to vote.

Past Delegate Jim K. explained that Area 35 loosely follows Robert's Rules and uses the number of voting members present in the room at the time of the vote

### **Alternate Delegate Position Update**

Area Chair – The Alternate Delegate resigned at the August ACM. Past Delegate Kelly D. was asked to step in to arrange the January workshop, and that has been done. Location is secured, flyers are made, and the agenda is completed.

### Discussion

- Don't see a need to fill the Alt Delegate position at this time. The workshop has been taken care of.
- The new Alt Delegate can be asked to step in if the current Delegate is unable to complete the rotation.
- The incoming Alt Delegate will be chairing the January workshop.

The sense of the meeting was that it is not necessary to fill the Alternate Delegate position at this time.

#### **Articles of Association**

Area Chair – The original Articles of Association said a person that completed a partial rotation could only complete that rotation and not be eligible for the next rotation.

### Comments

- Do we have to change the Articles whenever we vote?
- Delegate We do not have to change the Articles for ordinary business. The reason we have Articles of Association is to have a tax ID number. One reason to change the Articles is so that a person can complete their own two-year rotation after doing a partial rotation that someone else was unable to complete. Another reason is to change the description of who can vote. The Articles currently state that only GSRs can vote. That has changed over time. Other positions were added to the list we have of who can vote, but that is not reflected in the current Articles. The State does not regulate us. The Articles are for us to follow.
- A GSR requested more time for GSRs to discuss this with their groups.
- The new language in the handout is underlined, and the black bar on the left side of the page means that something is changed in that paragraph. The old language from the original Articles is crossed out.

Jess S. made a motion "To approve the updates to the Articles of Association." Seconded by Scott.

# Discussion

 Diane R. recommended that the motion be tabled that an ad hoc committee be formed to review why the proposed changes are necessary.

Vote: Motion to Table PASSED.

Area Chair will use the right of decision to form an ad hoc committee.

# **Discussion About How We Vote**

Area Chair explained that Area 35 currently uses the number of voting members present in the room at the time of the vote. Don't consider abstentions.

# Discussion

- The Area loosely follows Robert's Rules and counts a quorum differently than what is done under Robert's Rules.
- We need to get a head count before each vote to ensure that the number of votes does not exceed the quorum so we know if people are voting when they shouldn't be. We need to protect the integrity of our elections.
- Area Chair asked if the body wants to implement the counting of voting members present before each vote to insure that non-voting members do not vote. There was no discussion.

Steve L. suggested using secret ballots as a means of getting an accurate count of all the votes and using that number to determine how many votes are needed.

Steve L. made a motion "To use secret ballots when voting so we have a running total of the number of votes going forward for the remainder of this Assembly." Kyle H. seconded the motion.

# Discussion

the voting members to one part of the room and non-voting members to another part of the room.

- This is a good idea, but not at this time. This is getting a bit convoluted.
- Vote: Motion "To use secret ballots when voting so we have a running total of the number of votes going forward for the remainder of this Assembly." Motion FAILED.
- A member asked for more explanation of the changing of the head count for each vote.
- We don't count abstentions because they choose not to participate in that vote, so the head count becomes less for that vote.
- Example: If the number voters in the room is 120, 2/3 of that is 80. If two people abstain, the total number of votes becomes 118, 2/3 of that is 79, which would be used to assess whether or not the vote is carried.

#### **Area Inventory Recommendations**

Area Chair explained that we have the recommendations that two ad hoc committees came up with. This process took a few months, and the groups have had a chance to review the items since the Spring Assembly. The floor is now open for discussion.

#### Discussion

Sarah made a motion "To reinstate the GSR Orientation and DCM Orientation before Assemblies." Jess S. seconded the motion.

Clarification: The GSR Orientation has already been taking place at the Assemblies. There was a motion at a previous Assembly to do that. There is a DCM Orientation at the beginning of each rotation in the even years at the January Workshop.

Friendly amendment "To remove the DCM orientation from the motion."

Since there was a motion at a previous Assembly to have GSR Orientations, and that they are already taking place, the **Motion was WITHDRAWN**.

Inventory recommendation #3

- One member stated that we need to use the hybrid option for Assemblies. We will get more people involved and attract more people to attend in person. It costs a lot for childcare for a weekend. Hybrid would be useful.
- Area Chair said she is seeing some momentum building for some items and we will keep them on the list of recommendations moving forward.
- A GSR stated that we should form an ad hoc committee to review the recommendations overall and see which ones they think should be implemented.

Area Chair said we should not focus on one item and talk about other ones as well.

- One DCM said we still have to consider costs of hybrid equipment. At this time we are not ready to make the purchase.
- Regarding Recommendation 1, DCM from Zone 4 stated that there was not enough time given for the districts in the Zone to get together and discuss whether to have a Zonal Forum.
- Regarding Recommendation #3, a GSR stated that, to protect anonymity, personal contact info should be removed from the Northern Light.
- Hybrid takes Fellowship out of AA. We need to meet in person to have Fellowship.
  There are enough people interested in hybrid meetings. We should create
- an ad hoc committee.
   Printing the Northern Light costs about \$700 per issue. Email version
- Printing the Northern Light costs about \$700 per issue. Email version would save money.
- Check into free electronic voting systems.
- The Northern Light is the official repository of the Area minutes.

Chair will put together an ad hoc committee to review all the recommendations.

# **NEW BUSINESS**

Clarification on definition of Failed Motion "For 2023 only, Area 35 will hold ACMs virtually, and offer hybrid Assemblies and workshops."

Clarification by Chair: There is concern that the Area is going against this motion and asked that there be further discussion at this Assembly to clarify the meaning of the motion.

- Committee Chair Zoomed someone into a Committee meeting at the June ACM. This was not approved or even asked about prior to the meeting. At the August ACM that was partially hybrid to allow GSRs to vote on proposed General Service Conference agenda items. We could have easily fit the 12 people who Zoomed in for the agenda items for Assembly portion of that meeting.
- The Area is allowing things to happen, and this is unacceptable. The Area is going against our wishes.

Background: We don't know if we will have proposed agenda items. Chair used right of decision to allow GSRs in to vote at the Assembly portion of the ACM. Another point was that it was thought that since the motion failed, we would not be allowing any hybrid meetings.

# Discussion:

Note: ("Zoom" is used interchangeably with "virtual" in the discussion. It does not mean that we will be limiting virtual meetings to the use of Zoom. For example, we now also have Microsoft Teams for our virtual meetings.)

- What was the intent of the motion? Was the intent to not have Zoom for committee meetings and ACMs? If Zoom is available for one committee meeting, it should be available to all.
- The motion was interpreted by some to say, "We will have ACMs 100% in-person with no hybrid and have hybrid Assemblies and Workshops." The motion failed and did not necessarily eliminate the possibility of using Zoom. It was still a possibility that could be offered.
- Webmaster said he was the one that made the motion, and he made it because the Area was having financial difficulty. The intent was not to totally prohibit the use of Zoom.
- One member stated that when we voted at the Assembly, he understood that to mean we wouldn't use hybrid at all for the rest of the year. Right of Decision was used to nullify the vote.
- Past Delegate clarified that Right of Decision never supersedes motions that are passed. In the spring we voted to not have virtual ACMs. Virtual ACMs would have meant that no one would physically be at the meeting place, everyone would be online. It did not mean that there would be no use of Zoom. Action Committee members may meet any time outside of Area meetings. They could meet before the Area meeting, two weeks after the meeting, anytime they wanted to meet. Action Committee meetings are not part of the ACMs or Assemblies. Also, there were proposals to be voted on, and if we wanted the GSRs to be able to vote, we would need to use Zoom.
- We voted in the past to allow an Assembly session prior to the August ACM to vote on whether we wanted to send proposals to the General Service Conference to be included in the Agenda Items for the Conference.
- We do have an inclement weather policy that incorporates the use of Zoom. Our Statewide Corrections committee uses Zoom for their meetings.
- We do not need a new motion to allow for the use of hybrid. There is nothing in place that precludes the use of hybrid.
- Chair stated that if we interpret the Spring Assembly motion strictly, that
  will mean we would not have Statewide Corrections meetings, statewide
  Treatment Committee meetings, no use of hybrid for inclement weather.
  We would have to bring it up for a vote any time we need to use hybrid
  for ACMs due to inclement weather, etc.
- Not everyone can get online to use hybrid or virtual option.
- We elect people to positions that require the right of decision. We will have to use that in the elections. God puts the right people in the right places to make those decisions.

Heather L. made a motion: "That we investigate and come up with a hybrid meeting that will work for everyone and have it available for bad weather." Seconded by Kenneth.

# Discussion

Webmaster's motion did not include anything about the Statewide Corrections, Treatment, or the inclement weather policy. It was only about ACMs and Assemblies.

Kyle H. offered a friendly amendment, "or when inclement weather dictates." Friendly amendment not accepted.

# Discussion

- Aitkin Alano would not hold all the GSRs. Being able to attend via hybrid would be awesome.
- The question was about the Spring Assembly motion and needed clarification. It was not about prohibiting attendance more attendance is always good.
- Leave it to the Chair to use the Right of Decision.
- We vote at Assemblies twice a year. Chair plus one more year of EDW (Equitable Distribution of Workload) when we vote in August on proposed Agenda Items.

Broke for Action Committee meetings, Area Officers meeting, and an AA meeting for anyone that wanted to attend at 5:00, dinner from 6:00 to 7:30. Resumed at 7:30.

Vote on motion "That we investigate and come up with a hybrid meeting that will work for everyone and have it available for bad weather." Vote: Motion PASSED

Minority voice -

- We don't need this, and it will only cause more confusion. The Chair has the Right of Decision.
- We should have a plan for supporting and executing before we vote for it.

Jess S. made a "Motion to Reconsider." Jim R. seconded.

No discussion.

Motion to Reconsider PASSED.

Discussion

- Some people may not have a good experience, like at the Service Workshop in January. The people that Zoom in have a hard time hearing.
   Some people may not get the notification that there is a Zoom possibility until the last moment.
- How much participation do we actually get on Zoom?
- There was an attempt to rescind the original motion, but that is not allowed after the motion is voted on and passed.

Vote on the original motion "That we investigate and come up with a hybrid meeting that will work for everyone and have it available for bad weather." Vote: Motion FAILED.

- GSRs can join committees in their District and talk to DCM.
- Go with DCM to a committee meeting and talk to people.

- Joining a committee opens a new level of understanding of service and understanding of the business structure.
- Going to committee meetings at assemblies.

### 3) How GSRs get district involvement

- Start by getting people involved in service at their meetings.
- Go to other meetings and discuss service opportunities.
- Share hot topics that are being discussed in the district with groups.
- Potlucks and inviting service speakers.
- Sponsors should encourage sponsees to attend area and district meetings to learn more about the service structures.
- It was suggested to attract more people by offering food. Bring a pie, etc.

### 4) How GSRS can help their groups make proposals

- Fill out the proposal form after getting group-conscious
- DCM can help GSR with form
- To get proposals up for consideration, it is essential to bring those issues to the group.
- The website has email addresses where proposals can be sent from individuals or groups.
- If a group wants, they can go straight to GSO with proposals.
- There is no way to see proposals not being brought forward to the conference.
- It is crucial to keep track of the proposals brought to the conference and inform the group.

# DCM SHARING SESSION REPORT

We had 11 DCMs from District 3, 4, 5, 6, 7, 8, 9, 11, 12, 13, 16 and one A.A. district chair from district 13 attend the DCM Sharing Session.

We took one question. We talked about the Right of Decision. Is it important and the best thing to do? Sometimes new information come to light and we must make a decision with that new information. The following are the discussion points about the Right of Decision.

- There were three A.A.s standing for Delegate and now there are two. Some G.S.R.s and D.C.M.s will have to use the Right of Decision to vote. The Area Chair used the Right of Decision to allow G.S.R.s to vote at the August ACM Meeting.
- We need to keep it simple. We need to consider cost. We sometimes have a limited amount of time to make decisions so we can use the Right of Decision.
- Right of Decision is in the Service Manual. Sometimes at an Assembly
  we get more information. I know my home group and we are trusted
  servants who can use the Right of Decision because we have more information.
- We are elected as trusted servants, and the body believes it is the best for the whole. I have been given the right to vote with the information that I have. I must trust our trusted servants to rightly use the Right of Decision. They may have additional information.
- I ask God to direct us. I ask that egos get out of the way. I give that will
  up and let others be in charge and give them the freedom to make their
  own decisions. Remember to always invite God in.
- We put trust in the people we elect. Sometimes we have an ax to grind and sometimes we just have to be okay with it.
- We are in the position of DCM because they liked what we do. I trust in God and believe that God wants me to be there. When there are decisions to make, I ask the elder members and look to others with more experience. I like the minority opinion and how it turns the vote around.
- I am here for a reason.
  This is Concept 3. We must remember why we are here. We are the Area, and we are carrying the A.A. message to the still suffering alcoholic.
- ea, and we are carrying the A.A.
  I do have the Right of Decision.
- I believe that the GSRs believed that I was trustworthy, or I would not be here. I try to get the information from the groups and that was why they voted us in.
- In the end we do the Right of Decision. We must go back to the groups and say why we voted the way we voted. The Right of Decision should not be used to make hasty decisions. A.A. Groups, whenever possible, should be the ones making the decisions. We need to have the tough discussions. It is important to remember that it is principles before personalities. Everyone has what is best for A.A. at the heart of their decisions, they believe that it is the best decision for A.A.
- Our Area Chair is a Trusted Servant and has a lot of experience to share.

When we make a decision, we need to follow that decision. We need to leave the past alone. A.A. is about unanimity. Plain and Simple, Love and Tolerance is our Code. Look for the Good.

#### **Proposal from Area Treasurer**

DCM's - Please bring back to your groups for discussion.

Do groups want to have the option to contribute to the Area using electronic methods?

If so would they like to use any of the following: PayPal; a Debit or Credit Card.

Would they like to use a debit card to purchase Literature or Grapevine at Area events?

Would members like to pay for registration at the January service workshop using a debit or credit card? If so, do they support the Treasurer position having a cell phone (for use in setting up the electronic payments accounts (square processes card payments). The cell phone would be for Area financial business only, not for personal use.

To accept debit or credit card payments for Literature or the Grapevine the following would apply:

### **Proposal**

- Use Square to process cash sales at Area events for Literature and Grapevine
- Simple to use
- Transaction fees: Swipe: 2.6% plus 10 cents per transaction (this is the non-profit rate) Keyed: 3.5% plus 15 cents per transaction
- Can accept all major credit cards, Cash App and prepayment options
- Chargeback no fee
- Refunds: No fee, the customer receives their full payment, and the merchant receives the transactions fee
- Does invoicing
- Best for use with in-person sales and revenue of less than \$5,000/month

### **Upfront costs:**

I would suggest either:

- Mobile POS Kit for Square Reader plus an iPad \$478 plus tax
- Or Square terminal \$299

#### Advantages:

- Money is deposited into the checking account right away; receipts are printed for the customer.
- Don't need a phone number, can use it by accessing a personal hotspot on a phone or connecting to internet (although I do recommend a phone with a data plan: tradition of self-support).
- Can hand over this equipment for the next rotation, making options consistent. More Districts and Groups are using debit cards for transactions, so it is easier for them and for the Area.
- PayPal processing fees from 1.9% of the transaction plus .49 (non-profit rate). Venmo processing fees 1.9% of the transaction plus .10 (doesn't offer non-profit rate)
- Even though as Treasurer I can use Square by using my personal phone as a hotspot, there are still data charges that apply. In the spirit of self-support, I propose that the Area provide a cell phone for the Treasurer position. Square uses approximately up to 10kb of data.

# Disadvantages:

- Credit and Debit card processing fees. These can definitely add up.
- There would be some technology maintenance to be aware of. If we change to QuickBooks online you can tie your bank accounts to it, there are definite ways to enter those types of transactions, not as intuitive as it could be.

# My proposal:

- 1. Set the Treasurer up for the future and for growth by purchasing a phone and data plan
- Set up Venmo, PayPal and Square to allow various payment types for Districts and Groups. The benefit is that a lot of people use these apps, and it makes it easy to donate to the Area. Another advantage is if Groups set up these apps, they can also contribute easier and save time and money.



Projections are my best guess based on information at hand, they may or may not be accurate.

# Dr. Bob on Anonymity

"As far as anonymity was concerned we knew who we were. It wasn't only AA, but our social life. All of our lives seemed to be spent together. We took people home with us to dry out. The Cleveland group had the names, addresses, and phone numbers of all the members," said Warren. "In fact, I remember Dr. Bob saying, .....

"If I got up and gave my name as Dr. Bob S., people who needed help would have a hard time getting in touch with me."

Warren recalled, "He [Dr. Bob] said there were two ways to break the Anonymity Tradition: (1) by giving your name at the public level of press or radio; (2) by being so anonymous that you can't be reached by other drunks."

In an article in the February 1969 Grapevine: "Dr. Bob on Tradition Eleven," Volume 25, Issue 9, D. S. Of San Mateo, California, wrote that Dr. Bob commented on the Eleventh Tradition, "We need always maintain personal anonymity at the level of press, radio and films," as follows:

"Since our Tradition of Anonymity designates the exact level where the line should be held, it must be obvious to everyone who can read and understand the English Language that to maintain Anonymity at any other level is definitely a Violation of this Tradition."

"The AA who hides his identity from his fellow AAs by using only a given name Violates The Tradition just as much as the AA who permits his name to appear in the press in connection with matter pertaining to AA."


"The former is maintaining his anonymity ABOVE the level of press, radio and films, and the latter is maintaining his anonymity BELOW the level of press, radio and films—whereas the tradition states that we should maintain our anonymity 'AT' the level of press, radio and films."

Ernie G. of Toledo, commenting on what he saw to be an increase of anonymity within AA today as compared with the old days, said, "I made a lead [trip to bring message] over to Jackson [Michigan] one night, and everybody's coming up to me and saying, 'I'm Joe; 'I'm Pete.' Then one of the guys said, 'Safe journey home. If you get into any trouble, give me a buzz.'

Later, I said to the fellow who was with me, 'You now, suppose we did get into trouble on the way home. How would we tell anyone in AA? We don't know anyone's last name.' They get so doggone carried away with this anonymity that it gets to be a joke." I had a book [evidently one of the small address books compiled by early members or their wives] with the first hundred names-first and last-telephone numbers, and where they lived.

Dr. Bob's views on anonymity remained clear in the recollections of Akron's Joe P. [The Dartmouth grad]. Though it was not the custom in the mid-1940's to give AA talks to anyone except drunks, Joe noted, a few members formed an unofficial public information committee that started to speak to Rotary and Kiwanis Clubs throughout the state.

# **EDITORIAL POSITION & N.L. COMMITTEE:**

Editor: The Editorial Chair position is a two-year rotation picked by the incoming Area Chair and either approved or rejected by the Area Committee at the first Area meeting after the Fall Assembly Elections.

Desirable qualifications: Current knowledge of MS Publisher, MS Word, MS Excel and other misc. computer programs as needed. The person should also consider the time needed to complete the task required. The candidate should have a working knowledge of A.A. as a whole, i.e., prior experience in service work such as G.S.R., D.C.M., or related position.

N.L. COMMITTEE: The N.L. Committee consists of the Area Group Records Chair, Area Webmaster and Area Audio Technician along with two D.C.M.s in Area 35. DCM's are picked randomly at the start of each rotation and serve on a two-year rotation basis. They assist the editor in communications with other area newsletters, in recommendations on general improvements, and with general problems and implementations of new policies. They may also represent the editor at functions when the editor is unable to attend.

N.L. COMMITTEE MEETINGS: The Committee meets every other month, before the start of the Area Workshop and at Spring and Fall Assemblies. If needed, additional meetings may be called.

General submissions are welcome! Feel free to send letters or articles that are pertinent to AA and Area 35. Please note that if space is limited, first priority will be given to reports from Area Officers, Area Standing Committee Chairs and D.C.M.s from Area 35.

  - b) Maps are sometimes helpful but not necessary
- 5. Why is the event taking place?
  - The reason for AA events is to carry the AA message to the still suffering alcoholic (this doesn't have to be printed on the flyer)
  - b) Usually covered in Who and What

Only Area 35 AA members may submit a flier. Fliers for AA sponsored events only.



- Meeting format (virtual, in person or hybrid) is based on DOT report and national weather service, individual safety being paramount. Decisions will be made by 9pm the day before the meeting.
- Chair contacts webmaster with meeting format information (including any virtual links) which will be posted on area35.org
- Chair notifies the Alano Society in Aitkin on food preparations.
- Chair remains available and in close contact as they are the focal point and main contact; Chair must make the decision and be available for calls.
- Districts contact their DCM in inclement weather for updates on meeting format.

# Q: Why list our past Delegates?

# A: They are a resource to you!

In Alcoholics Anonymous we value experience. Our Twelve Steps did not exist when Bill stepped into the lobby of a hotel in Akron, Ohio. Even after meeting with Dr. Bob and soon founding our program, there were only six steps until the experiences of 100 Alcoholics were summed up. Soon after a book followed, but it was a few years later when the Twelve Traditions were discussed and agreed on. Twelve Traditions that were "hammered out on the anvil of experience". Our past Delegates are a wealth of experience, an interactive living archive if you will. When you plan your next service workshop or need an outside voice to offer help, consider this resource available to you.

# The Delegate's Duties

Though the high point is the Conference meeting, the delegate's job goes on year-round and involves all aspects of the Conference structure. The delegate should:

- Attend the Conference meeting in April, fully prepared. Immediately upon election, every delegate is put on the G.S.O. mailing list to receive Conference materials.
- Communicate the actions of the Conference to area committee members and encourage them to pass on this information, and the delegate's enthusiasm, to groups and to intergroups/central offices. If an area is too large for the delegate to cover in person, he or she will ask area officers and committee members to share the load.
- Be prepared to attend all area, state/provincial, and regional service meetings and assemblies. From these meetings, delegates come to better understand their own areas and can make suggestions for the Conference agenda. Here, too, they come in contact with A.A. members who might not be reached otherwise.
- Help area committees obtain financial support for the area and G.S.O.
- Provide leadership in solving local problems involving the A.A. Traditions

- Remind G.S.R.s to inform groups and individuals about the A.A. Grapevine and Conference-approved literature.
- Cooperate with G.S.O. in obtaining information—for example, making sure that up-to-date information reaches G.S.O. in time to meet the deadline for each Issue of the A.A. directory and helping carry out the triennial membership surveys.
- Visit groups and districts in the area whenever possible.
- Work closely with committee members and officers, sharing experience throughout the year. After G.S.R.s and committee members have reported on the Conference, learn from these A.A.s how groups and members have reacted.
- Assume added responsibility if the area chair and alternate chair are unable to serve. Or, if an area committee is not functioning effectively, the delegate may take an active role in remedying the situation.
- Keep the alternate delegate fully informed and active, so that the alternate can replace the delegate in an emergency.
- Late in the second term, work with newly elected delegates to pass along a basic knowledge of Conference proceedings and problems.
