

AREA 35 MEETING MINUTES - UNAPPROVED

Area 35 August 2023 ACM Minutes Aitkin, MN August 6, 2023

Call to Order: Area Chair Christine G. called the meeting to order at 10:30 a.m. on Sunday, August 6, 2023, and opened with the Serenity Prayer.

Recognition of Past Delegates In Attendance: Mike J, Panel 64; Kelly D, Panel 66

Area Chair opened the Special Assembly:

We will now open for a Special Assembly session to allow voting on the GSC proposals and to allow GSRs to participate and vote.

- Welcome to all who have joined via Zoom. Please keep yourself muted, raise your hand when you have something to share. Raise your hand by pressing the REACTIONS icon at the bottom of the screen, next to RECORD or SHARE SCREEN. Then select RAISE HAND. Once you have been called on, you can select LOWER HAND.
- After we are done discussing and voting on the (4) proposals, we will log off Zoom and proceed with reports.
- We will be using 2/3 majority for the vote being these items are being forwarded to the GSC. Voting members are Area Officers, Area Action Committee Chairs, DCMs (Alt DCMs if your DCM is not present) GSRs (Alt GSRs if your GSR is not present) District Action Committee Chairs do not vote. All voting members please raise your hands. (Take a count)
- We will be allotting 2 mins of sharing at the microphone with sharing only once until everyone has had an opportunity.
- Let's avoid cross talking as it gets disruptive and hard to hear discussions.
- When asking questions or speaking, please go to the mic or raise your hand on Zoom. We will alternate between microphone and Zoom.
- The purpose of this discussion is to determine if the (2) proposals should get forwarded to the Conference Committees for them to determine if the proposal should be added to 2024 GSC Agenda Items.

GSC Proposals

GSC Proposal 1, Big Book – District 9

District 9 DCM Diane R. read the motion:

Proposal 1. We propose the Twelve Steps from the book Alcoholics Anonymous in the First, Second, Third, and Fourth editions remain as originally written in the First, Second, Third and Fourth editions; and that the proposed side by side comparison in the current draft of the Plain and Simple translation of the Twelve Steps be removed; and that no other translation of the Twelve Steps be written for the proposed Plain and Simple Book.

Diane R. read the Motion (proposal), John M., a GSR, seconded. Discussion

- People are not able to log in. Webmaster addressed that problem.
- Some groups in District 6 are against changes to the 12x12 and the Big Book.
- Most people in one group are against any changes in either book.
- Leave Bill's writings alone.
- There is so much help out there there are plenty of books out there to help with reading.
- The 12x12 has some harsh words.
- Sometimes we need harsh words.
- If it ain't broke, don't fix it.
- Outside interests are pushing the changes.

Steve L. offered an amendment to **remove the first two lines to clear up the motion**. Diane R. said amendment not accepted. Vote was taken, most in favor of the motion, no one opposed, one abstention. **MOTION PASSED.**

GSC Proposal 2, 12x12 - District 9

District 9 DCM Diane R. read the motion, Mike U. seconded the motion. Proposal 2 We propose that changes made by the 71st General Service Conference: Advisory Action 18 for changes to page 117 phrase "opposite sex with the word "partner" Advisory Action 19 changes to page 66, "No one wants to be angry enough to murder, lustful enough to rape, gluttonous enough to ruin his health" with "no one want to commit the deadly sins of anger, lust or gluttony" in the book Twelve Steps and Twelve Traditions, be returned to their original text. Note: This would include the Introduction be returned to its original text.

Discussion

- Are the changes made to the 12x12 a translation? NO
- Keep the changes, footnotes are clear and concise. We need to be inclusive.

VOTE – Area Chair read the motion. 52 were in favor of the motion, 10 were against, one abstention. Need 2/3, **MOTION PASSED.**

Minority opinion

- If there are already footnotes, it is not fiscally responsible to make changes.
- There are already books with changes out there. If we change it back, it could be confusing.

- Both proposals will be submitted to the General Service Board before the September 15th deadline.
- Area Chair Christine G. thanked the GSRs for bringing their groups' consciences to the Assembly portion of the meeting, then closed the Assembly portion at 11:02 a.m. and logged off the hybrid session.

Area Committee Meeting

Opened at 11:02 a.m.

Additions to agenda: Articles of Incorporation; Treatment Contact Coordinator email; Alternate Delegate position; Statewide Corrections workshop budget; Zoom discussion.

Points of order:

- The purpose of the Area Committee and this meeting is focused on the health of the area and thus on growth and harmony in the AA Fellowship. The area committee does not create policy. We take care of "maintenance and upkeep issues."

<u>OFFICER REPORTS</u> <u>DELEGATE – STEVEN L</u>

Good morning ladies and gentlemen, I have given all of my GSC reports to Districts that have asked for one. It was a pleasure and a humbling experience visiting with everyone and allowing as much time as needed to thoroughly discuss what happened at the GSC. I will be reporting on the GSC via Zoom for all that missed my in-person reports. The Zoom meeting will be held on Tuesday, August 22nd starting at 6:00 pm. The Zoom details will be emailed out shortly.

At the monthly Delegates' meeting on July 24th, Kerry M., our Regional Point of Contact, reported that the following weekend is the July Trustee General Service Board weekend. Since the WCR Delegate meetings are scheduled on the 4th Monday of the month, we decided to move the monthend meeting to Thursday, August 10th so the Delegates can receive the information from Kerry M. on what happened at the General Service board weekend earlier.

Our main topic of discussion was the WCRF being held in Missoula MT. GSO is seeking an AA member who is deaf or hard of hearing for the workshop, "Who Is Not In The Rooms". Currently, they are not finding anyone. It was brought up that perhaps GSO would want to have another topic for that workshop's time frame, Kerry M. is going to bring that issue up at the board meeting.

Current registration numbers for the WCRF are pretty low, hopefully they will pick up closer to the date of Forum. Room rates and availability were a concern for the WCRF. A few people mentioned that they were not receiving the room block rate of \$139. Instead, they were charged \$1,200 for their 3-night stay. If anyone is having this kind of trouble, try calling the hotel directly, they might be able to help because there was some trouble at the being of May with the flier codes. Otherwise, let me know and we can get hold of the METS / Regional Forums people at the GSO to straighten this out. As of the July 28th meeting, there are no longer rooms available through the WCR room block for the Forum. Kacie N., the Delegate from Montana, spoke with Eileen, our Regional Forum Staff person, and said if anyone still needs a room to contact Attallah at sophasa@aa.org.

In my report in the July NL, I mentioned that there will be 11 trusted servants from GSO, GV, and Trustees available for Share A Meal. Share A Meal is having lunch or Dinner with one of these servants to ask questions and get to know them a little better. I have Area 35 booked with Mike L. our WCRT and the interim GSB chair for Saturday's Lunch. We might be able to squeeze in one or two people in one of the other meals if there is an interest. The other people are: Carolyn W., Non-Trustee Director AAWS, Kevin P. Class A Trustee and GSB Treasurer, Cindy F. GV Director, Hon. Kerry M. Class A Trustee and current WCR Liaison, Eileen E. GSO Staff, James H. GSO Staff, Bob W. GSO General Manager, Chris C. GV Publisher, Robert Trustee At Large – Canada, Karina C., WCR GSO staff contact and Groups Services. Please let me know if you are interested and who you would like to dine with.

I sent out three notices of vacancy to the DCMs. One is for the West Central Regional Trustee position. Mike L.'s term is over next year at the end of the 74th GSC. The Area has a chance to vote on a nominee for this vacancy at the fall Assembly. There is also a vacancy for a GV Non-Trustee Director which starts at the end of the 74th GSC. There was also a vacancy for someone to be part of the working group for the pamphlet for "A.A. for the Native North American Alcoholic.". There is also a call for stories for the pamphlet "A.A. for the Native North American Alcoholic." Deadline for submission is October 31, 2023. Please submit via email to: pamphletstories@aa.org. I received a second notice from GSO that the District Quarterly Contribution Statement Summary Reports are having some trouble being distributed. Seems there was a glitch in the new software launch and things got messed up. Supposedly it is now fixed, so look for these reports in the near future.

I'll send pdf copies of the Articles of Association to the DCMs to forward to the GSRs so they can discuss them at their Groups before the Assembly.

<u>ALTERNATE DELEGATE – JUSTIN W</u>

Area Chair read Justin W.'s report:

Greetings Area 35, I have experienced an overwhelming sense of discouragement during this rotation and have spoken with a few people about it. In trying to determine the source of the discouragement, I realize it really started during covid, when for the first time I was presented with the idea that I must not attend an AA meeting, in spite of the fact that my primary purpose really was the carrying of this message to a potential alcoholic that stood at the door of my meeting place. I can see now that this conflict was the direct result of our sacrificing the principles that this fellowship is built on, specifically that Alcoholics Anonymous at all levels had begun to develop an opinion on this outside issue. The admission of this issue into the fellowship in direct opposition to our principles was irreconcilable in my own heart, and still is to this day. Since then, we have seen a plethora of other outside issues, some political in nature, some extremely personal, and our unity, without which we as a fellowship cannot survive according to our own literature, has been absolutely shattered. We have seen even the most fundamental of principles embodied in our twelve steps abandoned for the sake of personal grievances by our own trusted leaders, the wrath of vengeance being ruthlessly executed upon us here in the service structure by the very people that taught us better...for almost two years now. This browbeating discouragement has all but eliminated the participation of the groups in our general service structure and without that participation the Area committee seems to have lost its purpose. "How do we get the groups involved" should not be a question in the General Service Structure, yet we continue to try and work out this top-down management of the groups, as if we are supposed to direct them. The principles in our steps, traditions and concepts are simply being cast to the side at all levels of the service structure, and I believe we have some real work to do in our home groups. It is my opinion that we need to prioritize the recovery of our own home group members, so that recovered AA members might start to flow back down into the service structure from the top of the upside-down triangle.

When I started in general service there was a real sense that I was doing the right thing, that serving in the fellowship was directly connected with the carrying of the message to the still suffering alcoholic, the perpetuation of our twelfth step. This is where all of my passion originated, and it was the basis of my commitment and the justification for the sacrifices that I had made in order to participate. But if a District isn't in service to its GSR's, and an Area isn't in service to its Districts and groups, then I cannot see where my participation at the Area can possibly serve our primary purpose and I cannot reconcile this.

In spite of all of this, I am sober and living a reasonable life by the daily graces and providence of God alone, for which I am eternally grateful. He is the Spirit of our principles, the substance of our steps, traditions, and concepts, and I pray that our fellowship would return again to Him by the honoring and reverence of these principles above all personalities, and certainly to the exclusion of all outside issues.

I am no longer willing to attend any event that is held on Sundays because I will not sacrifice my attendance at church services on Sunday mornings. Obviously, that precludes me from fulfilling my responsibilities as Alternate Delegate with regards to attendance at ACM's, Area Assemblies, and West Central Regional events, which unfortunately has been almost the sum total of my service tenure.

As such, I must resign my position as Alternate Delegate and hope that you will find another AA member who is able to meet the responsibilities of the position.

The first speaker stood at mic and said "Hello, I'm Dick and I'm an alcoholic, I'm Dick VanDyke". This was an anonymity break because it was an "outside of AA" event. The recording has been published; it is on a website now.
- Zonal workshops... organized by DCMs of districts for purpose of presenting info by Area Committee Members to an audience of interested AA members who don't typically attend area assemblies.

We propose that changes made by the 71st General Service Conference: Advisory Action 18 for changes to page 117 phrase "opposite sex with the word "partner" Advisory Action 19 changes to page 66, "No one wants to be angry enough to murder, lustful enough to rape, gluttonous enough to ruin his health" with "no one want to commit the deadly sins of anger, lust or gluttony" in the book Twelve Steps and Twelve Traditions, be returned to their original text. Note: This would include the Introduction be returned to its original text.

Motion was made and seconded to forward the proposal as written to Area 35. Discussion followed: There is a comment in the new 12x12 they like Bill's writing. Motion passed with substantial unanimity. The minority was given an opportunity to speak and did not.

The Tri-District workshop met in June and we continue to make progress. If you like a flyer, please let me know. Christine will tell her service story, talk about Rules of Order and the Third Legacy Procedure.

I attended the Area 35 and Area 36 Joint Committee Meeting on July 22 on Zoom and attended the breakout Corrections Committee Meeting. Because the Statewide Corrections Committee meets monthly, I have gotten to know Area 36 A.A. committee members quite well and we work well together. Discussion

- It is not an Area position, it is a Coordinator for the Treatment committee.

- Trying to do it the way Area 36 does it. This is a statewide service, and we need to coordinate with Area 36 and have similar setups.
- Corrections uses email which is free. Do we have to do what Area 36 does?
- The treatment committee is doing things seeing action.
- Treatment should be allowed to do what they need to do.
- Treatment Committee had lot of discussion about this role (not a position). Decided it makes sense to have an Area Coordinator. It makes it easier for the districts and for the treatment centers.
- Need to maintain continuity of discussion. It makes sense technically and it is a good idea.
- Isn't this position the Area Treatment committee's responsibility?
- Corrections Committee coordinates with Area 36. Mark R. as Statewide Corrections Chair is the liaison between the two Areas. Area 36 created the Temporary Contact Coordinator position to solve the problem of who gets what emails.
- Is a separate person going to manage the email? YES
- Are we going to use MS Office for this? Why add an account? It adds to Area expenses.
- We will use MS Office for this.
- It makes sense to have only one contact email for the whole Area rather than one for each district.
- It makes it less likely for emails to be missed.

Denise R. made a "Motion to Table." Seconded by Bob N. Vote-14 in favor, 1 opposed. Motion Tabled

Statewide Corrections Budget

Mark R. – There is a statewide Corrections Workshop coming up in November. The current budget for the workshop is \$500. Costs have gone up, and he would like to have \$650 in the budget. He needs approval to exceed the current budget.

Jim R. made a Motion to approve \$150 additional funds for the Statewide Corrections Workshop. Diane R. seconded the motion. MOTION CARRIED UNANIMOUSLY.

ACMs/Assemblies on Zoom Discussion

- Mike U. At the Spring Assembly we passed a motion to not have hybrid or Zoom at ACMs. A Committee chair zoomed someone into their committee meeting at June's ACM. This was not approved or even asked about prior to the meeting. Today we could easily have fit the 12 people who Zoomed in for the Agenda Items/Assembly portion of today's meeting. The Area is allowing things to happen, and this is unacceptable. The Area is going against our wishes.
- Denise R. attended the June ACM morning committee meeting on Zoom because that was the only way she could attend. She did ask permission and got the okay from the Area Chair, the Webmaster, and the Northern Light editor. Are we going to prohibit Zoom entirely?
- Area voted to not have Zoom or hybrid. The Area subcommittee is a part of the Area. The 4th Tradition was violated. We need to make decisions collectively and not have people doing their own thing.
- People can't vote if they are not allowed to participate.
- Area Chair stated that we voted at the Fall Assembly in 2021 "that for the years 2022 and 2023, we allow GSR's voting privileges at the August ACM for proposed agenda items only." Used the right of decision to have today's assembly portion virtually to make GSR voting more accessible. Didn't intend to go against Area's wishes. We have virtual use included in our inclement weather policy.
- We need to rethink not having virtual meetings. It's an accessibility issue.
- It is hard for some to travel due to physical issues.
- It is hard to hear everything on Zoom.
- Didn't understand that by passing that motion we would be prohibiting the use of Zoom.
- One person stated that when we used Zoom before, he couldn't hear anything, and it was a mess.

- Having the virtual option is a plus. We need a motion at the Assembly.
- The more people we can get involved, the better. Use whatever methods to achieve that.
- We voted to not have Zoom, we used Zoom today.
- One small group (8 to 10 people) sends their GSR wherever they can.
 Their GSR did not think it was practical to travel just to cast two votes.
 She attended via Zoom.
- This meeting was an assembly. Didn't think we voted not to have virtual assembly. We need to discuss this at the Assembly with the GSRs in attendance.

Alternate Delegate Position

Area Chair – Can we get a sense of the meeting about do we need to fill the Alternate Delegate position?

- The Alternate Delegate has the job of putting on the January workshop. There are only four months left in this rotation. The next Assembly is a voting Assembly. Delegate Steve said he has been the Alternate Delegate and can put on the workshop. Do we want to vote on a replacement, or can we have someone fill in to do the workshop?
- Find someone who has experience putting on the workshop.
- Maybe we have someone here who would be willing to do the workshop and fill position for four months.
- Kelly D. said she is willing to step in.
- Would the Alternate Delegate replacement be a liaison for whoever steps forward? Could we have a subcommittee to do the workshop? Else we would need to have vetting process and vote on it at the Assembly.
- Alternate Delegate is a voting position and needs to be voted on at a voting assembly.
- We need to read the Action Book about Structure. In the Action Book it says under Area Officers, Area Structure, June 1, 1997, "If Delegate cannot fulfill responsibilities, Alt. Delegate replaces until election can be scheduled. If Alt. Delegate cannot fulfill responsibilities, Area Committee decides if need to be replaced, depending on the length of rotation left."

The sense of the meeting was to leave the Alternate Delegate position open until the Fall Assembly when the Area Chair has more information about open tasks.

Articles of Association

Steve L. – Articles of Association were filled out with the State because we needed an EIN for tax forms. We filed as a non-profit organization, and we file the tax form 99-EN every year. We also needed the EIN for our checking account. Groups need an EIN for checking accounts. We did the original filing in 1988, and the Area Officers thought we needed to update the Articles. Proposed changes are shown in the Articles of Association on the back table. The changes include describing all voting positions at the Area, including GSRs. The original Articles had no provision for what happened when someone took over a position mid-rotation. It said the new person could only fulfill the remainder of the term, not that they could have their own full term after that if they were asked to do so or were voted in by the Assembly. Please discuss these proposed changes with your groups so we can vote on them at the Fall Assembly.

ACMs/Assemblies on Zoom Discussion - revisited

- Why did we not have a vote to end the previous discussion?
- Clarification is needed as to what the voting process was like at the Spring Assembly. Did we vote to not have Zoom or hybrid at the ACMs?
- Area Chair We moved on because there were no more people at the microphone. We don't usually vote to end discussion; we just proceed with business.

From the April 2023 Spring Assembly minutes:

- Tabled motion: "Area 35 will host ACMs virtually going forward and offer hybrid assemblies and workshops."
- Nels P. made a friendly amendment to the motion "For 2023 only, Area 35 will hold ACMs virtually, and offer hybrid Assemblies and workshops." Denise R. seconded. Kyle H. accepted the friendly amendment.
- VOTE: "For 2023 only, Area 35 will hold ACMs virtually, and offer hybrid Assemblies and workshops." MOTION FAILED UNANI-MOUSLY

What the motion at the Spring Assembly meant will be defined at the Fall Assembly. It will be on the agenda.

Calendar of Events was read.

Motion to adjourn – Jim R. made a motion to adjourn, Aaron seconded. Meeting adjourned at 2:32 p.m. Closed with the Responsibility Statement.

What About Members With Long-term Sobriety?

For all the good and right reasons, we pay a lot of attention to AA newcomers. They are the lifeblood of our fellowship, and tradition says they are the primary reason we have meetings. But what about members with long-term sobriety? We're taught the seeds of relapse are found in attitudes that precede the actual picking up of that first drink. While these might be easier to spot with new people, they seem much more difficult to detect in our friends with long-term sobriety.

Telling a new AA member to call us before picking up the first drink is excellent advice. But it almost never works for those who no longer have deep cravings for alcohol, because in a subtle, insidious way, they have entered into a private period (weeks, maybe even months) of irrational thinking about their lives, work, this program, loved ones, hobbies, the government or other drivers! In other words, a dangerous form of alcoholic insanity has emerged. With nothing in its path to prevent it, drinking is the natural, instinctive reaction. Fortunately, we have ways to prevent this from happening. The bond of trust we establish between each other in AA is a powerful ally. If we confront those fellow members closest to us suspected of having difficulties, and if we do this with compassion and a willingness to listen and help in a true 12th Step Spirit, the outcome may be lifesaving.

Following is a checklist of relapse symptoms we can watch for - and help a troubled friend explore in a sort of short-form 4th and 5th Step process. (1) Exhaustion - Allowing oneself to become overly tired; usually associated with work addiction as an excuse for not facing personal frustrations. (2) Dishonesty - Begins with pattern of little lies; escalated to self-delusion and making excuses for not doing what's called for. (3) Impatience - I want what I want NOW. Others aren't doing what I think they should or living the way I know is right. (4) Argumentative - No point is too small or insignificant not to be debated to the point of anger and submission. (5) <u>Depression</u> - All unreasonable, unaccountable despair should be exposed and discussed, not repressed: what is the "exact nature" of those feelings? (6) Frustration - Controlled anger/resentment when things don't go according to our plans. Lack of acceptance. See #3. (7)Self-pity - Feeling victimized, put-upon, used, unappreciated: convinced we are being singled out for bad luck. (8) Cockiness - Got it made. Know all there is to know. Can go anywhere, including frequent visits just to hangout at bars, carry out's, boozy parties. (9) Complacency - Like #8, no longer sees value of daily program, meetings, contact with other alcoholics, (especially sponsor!), feels healthy, on top of the world, things are going well. Heck may even be cured! (10) Expecting too much of others - Why can't they read my mind? I've changed, what's holding them up? If they just do what I know is best for them? Leads to feeling misunderstood, unappreciated. See #6. (11) Letting up on disciplines - Allowing established habits of recovery - meditations, prayer, spiritual reading, AA contact, daily inventory, meetings - to slip out of our routines; allowing recovery to get boring and no longer stimulating for growth. Why bother? (12) Using mood-altering chemicals - May have a valid medical reason, but misused to help avoid the real problems of impending alcoholic relapse. (13) Wanting too much - Setting unrealistic goals: not providing for short-term successes; placing too much value on material success, not enough on value of spiritual growth. (14) Forgetting gratitude - Because of several listed above, may lose sight of the abundant blessings in our everyday lives: too focused on # 13. (15) "It can't happen to me." - Feeling immune; forgetting what we know about the disease of alcoholism and its progressive nature. (16) Omnipotence - A combination of several attitudes listed above; leads to ignoring danger signs, disregarding warnings and advice from fellow members.

<u>DELEGATE – STEVEN L</u>

Howdy Ladies and Gentlemen, I made it back from the WCRF, held in Missoula MT. Missoula is nestled in a bowl, so you can see mountain peak vistas in any direction. There were 285 people present at the Forum, plus or minus a few. Roughly 1/4 were first-time Forum attendees. I was pleasantly surprised that Area 35 had over a dozen people in attendance. Friday night started with a Forum introduction followed by opening remarks by Mike L., our Interim General Service Board Chair, and Bob W., our General Service Office Manager. This was followed by two presentations; the first one's topic was on the Role of the Class A Trustees. Kerry Meyer, our acting WCR Trustee and a current Class A Trustee, spoke of the duties of the Class A Trustee. In Kerry's presentation on her career as a Judge, she shared how people and family lives changed because of the importance of AA. Then Carolyn W., Class B AAWS Trustee Director, talked about the duties of the Class B Trustee. In the second presentation, we heard from Cindy F., AAGV Non-Trustee Director, about the importance of the GV and how the GV is changing to meet today's world. Ending the evening was a general sharing session.

Saturday morning started the day off with four presentations by four current Delegates;

Experiences from a Pandemic - Julie S., Area 24, Iowa Making Structure in AA - Steve L., Area 35, Northern Minnesota Leadership a Vital Need - Cara G., Area 41, Nebraska Bringing Newcomers into Service - Katie B., Area 63, South Dakota

I might be biased, but these presentations made the Forum. Throughout the morning we had a presentation from Chris C., Publisher of the AAGV. Chris had some big BIG news- The GV app for Apple and Android phones and tablets will be ready to download on Sept. 1st. The app is free but if you want to get the GV magazine and GV archival articles there is a cost of \$2.99 a month. I will talk further on this subject at the fall Assembly. Robert L., the new Trustee-at-Large Canada, gave an interesting talk on his trip to Mongolia and how AA has grown there. Gerry R., an Appointed Committee Member chairing the remaking of the pamphlet "A.A. for the Native North American Alcoholic.", gave a good history of the need for the remake of this pamphlet and stated stories will be accepted for review until late October. Gerry also said the committee has a workshop on how to write your story. It's a PowerPoint presentation and it can be made available by way of online formats to anyone who would like to submit a story to this project. Kevin Prior, General Service Board Treasurer Class A Trustee, gave a financial report and received many interesting questions.

I was able to get everyone who wanted a seat at a dinner table with one of the GSB or GSO staff. Six people from Area 35 had lunch with Mike L., conversation flowed all through lunch and some questions got answered and some misunderstandings explained.

At one of the General Sharing sessions, I asked Bob W. a question someone had asked me on my post-GSC reports. "Why when I sign up to get notices about a new Box 459 being published, I don't get one? I have to keep looking online at AA.org to see if a new issue is out." I received two answers on this question. The short answer was there hadn't been a new issue of Box 459 since March 2023. The long answer was a reorganizing of some duties at the GSO and the software that took care of putting people on the mailing list for Box 459 and other things was faulty and lower on the priority list. As of the Forum, Bob said the bugs were fixed and to please sign up again and you should be notified when a new issue is published.

Saturday was finished by an ice cream social. I got to help. Wow what a job that was! The ice cream came in 5-gallon containers and nobody thought to bring them out to soften until a half hour before serving the ice cream. They were harder than concrete to scoop out (yes there was a container of hot water to dip the scooper in, but that didn't help). Everybody was patient and joking about the scooping difficulty, but it took its toll on me.

If you have read this far, I'm going to let you in on something I heard. I was attending an online meeting on August 20th about the plain and simple translation of the BB. At the very end, John W., Non-Trustee Director of AAWS, stated that the array of the 12 steps (original 12 steps in one column and a translation of the 12 steps in a side-by-side column) has been removed from the draft of the translation. There was a stipulation with his statement that a work around for the array might still be in the works (whatever that would look like). At the WCRF it was confirmed that the array was removed from the draft and that having the side-by-side array was a step too far). I believe Area 35's voice was heard.

I have another interesting tidbit to share, but I'm going to wait until the fall Assembly to reveal that one. I want one more confirmation before saying anything.

I hope your District elections are going well. This fall Assembly is our voting Assembly. We vote on five officers; Delegate, Alt-Delegate, Area Chair, Area Secretary and Area Treasurer. Just three positions are nominated off the floor; Area Chair, Area Secretary and Area Treasurer. These are the two questions I asked at the West Central Forum held in Missoula, Montana on 8/26/2023 to 8/28/2023. The questions were taken out of THE A. A. SERVICE MANUAL by Bill W. Edition 2021-2023 revised and updated.

<u>First Question:</u> Taken from the <u>CURRENT CONFERENCE CHARTER</u> (<u>United States and Canada</u>) Page 119

<u>Number 1.</u> Purpose: The General Service Conference of Alcoholics Anonymous is the guardian of world Conference shall be a service body only, never a government for Alcoholics Anonymous.

Number 3. Conference Relation to A.A.: The Conference will act for A.A. in the perpetuation and guidance of its world services, and it will also be the vehicle by which the A.A. movement can express its view upon all matters of vital A.A. policy and all hazardous deviations from A.A. Tradition. Delegates should be free to vote as their conscience dictates; they should also be free to decide what questions should be taken to the group level, whether for information, discussion, or their own direct instruction. But no change in Article 12 of the Charter or in the Twelve Traditions of A.A. or in the Twelve Steps of A.A. may be made with less than the written consent of three-quarters of the A.A. groups, as described in the Resolution adopted by the 1955 Conference and Convention. Page 119

My question at the mic addressing Bob the General manager of GSO: Is GSO going to do what it says in Number 3. of the Charter that when there is a change made putting different wording in our 12 steps of recovery of the Twelve Steps in the printing of the new version of the plain and simple language Big Book and get the written consent of three quarters of the A. A. groups in the world to make the changes, Bob pointed out Carolyn W., Class B Trustee, to give the answer. Carolyn said no, we will not get the consent of three-quarters of the groups in the world because there has already been changes in the 12 Steps made in the pamphlet 12 Steps Illustrated so there is no need to get the consent of three quarters of the groups in the world in A.A. anymore to make changes in the Twelve Steps. So, I was left to believe that our A.A. Service Manual will no longer protect Bill Wilson's Twelve Steps from being changed in any kind of pamphlet or book or anywhere the Twelve Steps are printed.

Appendix L: Page 123: Resolution offered by Bill W. and adopted at the 20th Anniversary Convention of A.A., in 1955. (This Resolution Authorizes the General Service Conference to Act for Alcoholics Anonymous and to Become the Successor to Its Co-Founders.) AND IT IS UNDERSTOOD: That neither the Twelve Traditions of Alcoholics Anonymous nor the warranties of Article XII of the Conference Charter shall ever be changed or amended by the General Service Conference except by first asking the consent of the registered A.A. groups of the world. [This would include all A.A. groups known to the general service offices around the world. 3 These groups shall be suitably notified of any proposal for change and shall be allowed no less than six months for consideration thereof. And before any such Conference action can be taken, there must first be received in writing within the time allotted the consent of at least three-quarters of all those registered groups who respond to such proposal.

Footnote: 3 Resolution: It was resolved by the 1976 General Service Conference that those instruments requiring consent of three-quarters of the responding groups for change or amendment would include the Twelve Steps of A.A., should any such change or amendment ever be proposed. Page 123 APPENDIX O: BYLAWS OF THE GENERAL SERVICE BOARD OF ALCOHOLICS ANONYMOUS, INC. Conference and Convention.

TRUSTEE VACANCY: Except for Class B Regional Trustee vacancies, in the event that any member trustee shall resign, die, retire, be removed, become disqualified, or shall be otherwise unable to serve, the trustees may, at any regular or special meeting of the Board of Trustees, elect a new member trustee to fill such vacancy, or, alternatively, permit such a vacancy to continue until the next annual meeting of the members of the General Service Board. With respect to Class B regional member trustee vacancies occa-

sioned by resignation, death, retirement, removal, disqualification or other inability to serve, an election, as set forth hereinafter may be held, depending on when the vacancy occurs, or the vacancy \may remain unfilled for the remainder of the term, and regional coverage may be provided by the trustee-at-large or the regional trustee from an adjacent region.

My question at the mic addressing Bob the General Manager of GSO was: After reading the above TRUSTEE VACANCY PARAGRAPH To Bob and the A.A.s present at the forum. I asked Bob why we need the Class A Trustee to take over the vacancy made by the previous Trustee Mike L., when it states in what I read about TRUSTEE VACANCY: above that the Trustee needs to be a Class B Trustee. Bob then asked Mike L. to address the Issue. Mike L. told me he was still the West Central Trustee. I was confused because Mike L. had said earlier in our session of the forum that he could not handle the job of having two trustee roles and he needed the Class A Trustee to fill in his old job. Mike L. took the role of the interim Trustee of the Board of trustees for the main board of Trustees. I didn't know what to say because the earlier part and many other times in the forum the Class A Trustee was highly praised for taking on Mike L's position as the West Central Trustee as he said he could not do the position of two trustees.

In closing, I was happy I got to ask my two questions. I tried to stick with principles rather than personalities. Maybe I made some sense to some of the fellowship. I got a little angry at times and it showed. I know I will be welcomed back because our fellowship is a forgiving bunch. All in all, it was a very informative forum and the fellowship seemed to have a good time. I had to scale back and could not get all I wanted to say or explain in what I copied out of the service manual but I put page numbers so you could look up the issues at hand and make your own conclusions. That's all I got, so all I can say is I love our fellowship, I love being sober, and I hope to keep on doing different things in service work because that is our mission, to help the still suffering alcoholic. Hi, Marc here, an alcoholic, and your Area35 archivist. Near the end of August I attended the West Central Regional Forum. I was not impressed, rather I was a bit discouraged. The event was mostly business, very little discussion of the spiritual part of AA. As an archivist there was little that I could take away and little to contribute. I am not likely going to attend another WCRAAF. I am hoping that when I attend the National Alcoholics Anonymous Archive Workshop I will be able to contribute and to take away things spiritual that will help our area archives.

My life is like a book, the stories are told in the printed words, but life is/was lived in the white space. Yours is too. In that white space are the distant memories of good times, your first friend, your first dalliance with alcohol... But then, maybe not soon after the white space filled with memories that were wanting to be forgotten. Alcoholism had set its grip. For those of us who were fortunate we found a way out, we worked these 12 steps and let go of the old memories, ready to make new ones. One of the promises tells us that "we will not regret the past nor wish to shut the door on it". As we move forward our white space once again fills, and a few words define our stories for others.

Our Area 35 Archives have a lot of history of AAs early days, a good amount of district and area business, and many books and recordings. Some of these books could be considered outside issues and per AA traditions we should not have any opinion of them. My observation is that we tend to remember the good points, the softer not so harsh realities of our alcoholism. The stories seldom delve into the really dark side, maybe because our blackouts really do blank out those bad times. Then the recovery process begins to make new memories. The stories of recovery are often the more comfortable experiences, DTs are not mentioned, aversion therapies are glossed over, "the cure" is mentioned but not the "jag farm", jail or prison. Most of the books, recordings and personal stories are from many years ago, there is an immense white space left by stories untold. Please help to record Area 35 history as told by the people who are here. Your story will very likely help another person find sobriety and serenity.

Please remember when telling your story to remain anonymous, the stories you tell could be displayed with Area 35 virtual archives. Keep your stories related to alcoholism, singleness of purpose does matter. And also please no mention of treatment center name or place of incarceration where you found sobriety.

Says the old proverb, "Shoemaker, stick to thy last." Trite, yes. But very true for us of AA. How well we need to heed the principle that it is better to do one thing supremely well than many things badly.

Because it has now become plain enough that only a recovered alcoholic can do much for a sick alcoholic, a tremendous responsibility has descended upon us all, an obligation so great that it amounts to a sacred trust. For to our kind, those who suffer alcoholism, recovery is a matter of life or death. So the Society of Alcoholics Anonymous cannot, it dare not, ever be diverted from its primary purpose.

Temptation to do otherwise will come aplenty. Seeing fine works afoot in the field of alcohol, we shall be sorely tempted to loan out the name and credit of Alcoholics Anonymous to them; as a movement we shall be beset to finance and endorse other causes. Should our present success continue, people will commence to assert that AA is a brand-new way of life, maybe a new religion, capable of saving the world. We shall be told it is our bounden duty to show modern society how it ought to live.

Oh, how very attractive these projects and ideas can be! How flattering to imagine that we might be chosen to demonstrate that olden mystic promise: 'The first shall be last and the last shall be first." Fantastic, you say. Yet some of our well-wishers have begun to say such things.

Fortunately, most of us are convinced that these are perilous speculations, alluring ingredients of that new heady wine we are now being offered, each bottle marked "Success"!

Of this subtle vintage may we never drink too deeply. May we never forget that we live by the grace of God — on borrowed time; that anonymity is better than acclaim; that for us as a movement poverty is better than wealth. And may we reflect with ever deepening conviction, that we shall never be at our best except when we hew only to the primary spiritual aim of AA. That of carrying its message to the alcoholic who still suffers alcoholism.

Is sobriety all that we are to expect of a spiritual awakening? No, sobriety is only a bare beginning; it is only the first gift of the first awakening. If more gifts are to be received, our awakening has to go on. As it does go on, we find that bit by bit we can discard the old life—the one that did not work—for a new life that can and does work under any conditions whatever.

Regardless of worldly success or failure, regardless of pain or joy, regardless of sickness or health or even of death itself, a new life of endless possibilities can be lived if we are willing to continue our awakening, through the practice of A.A.'s Twelve Steps.

Editor: The Editorial Chair position is a two-year rotation picked by the incoming Area Chair and either approved or rejected by the Area Committee at the first Area meeting after the Fall Assembly Elections.

Desirable qualifications: Current knowledge of MS Publisher, MS Word, MS Excel and other misc. computer programs as needed. The person should also consider the time needed to complete the task required. The candidate should have a working knowledge of A.A. as a whole, i.e., prior experience in service work such as G.S.R., D.C.M., or related position.

N.L. COMMITTEE: The N.L. Committee consists of the Area Group Records Chair, Area Webmaster and Area Audio Technician along with two D.C.M.s in Area 35. DCM's are picked randomly at the start of each rotation and serve on a two-year rotation basis. They assist the editor in communications with other area newsletters, in recommendations on general improvements, and with general problems and implementations of new policies. They may also represent the editor at functions when the editor is unable to attend.

N.L. COMMITTEE MEETINGS: The Committee meets every other month, before the start of the Area Workshop and at Spring and Fall Assemblies. If needed, additional meetings may be called.

AREA 35 EVENTS INCLEMENT WEATHER PROCEDURE


- Area Chair asks for weather reports from all DCMs from respective Districts, either by email or phone.

Q: Why list our past Delegates?

A: They are a resource to you!

In Alcoholics Anonymous we value experience. Our Twelve Steps did not exist when Bill stepped into the lobby of a hotel in Akron, Ohio. Even after meeting with Dr. Bob and soon founding our program, there were only six steps until the experiences of 100 Alcoholics were summed up. Soon after a book followed, but it was a few years later when the Twelve Traditions were discussed and agreed on. Twelve Traditions that were "hammered out on the anvil of experience". Our past Delegates are a wealth of experience, an interactive living archive if you will. When you plan your next service workshop or need an outside voice to offer help, consider this resource available to you.

The Delegate's Duties

Though the high point is the Conference meeting, the delegate's job goes on year-round and involves all aspects of the Conference structure. The delegate should:

- Attend the Conference meeting in April, fully prepared. Immediately upon election, every delegate is put on the G.S.O. mailing list to receive Conference materials.
- Communicate the actions of the Conference to area committee members and encourage them to pass on this information, and the delegate's enthusiasm, to groups and to intergroups/central offices. If an area is too large for the delegate to cover in person, he or she will ask area officers and committee members to share the load.
- Be prepared to attend all area, state/provincial, and regional service meetings and assemblies. From these meetings, delegates come to better understand their own areas and can make suggestions for the Conference agenda. Here, too, they come in contact with A.A. members who might not be reached otherwise.
- Help area committees obtain financial support for the area and G.S.O.
- Provide leadership in solving local problems involving the A.A. Traditions

- Remind G.S.R.s to inform groups and individuals about the A.A. Grapevine and Conference-approved literature.
- Cooperate with G.S.O. in obtaining information—for example, making sure that up-to-date information reaches G.S.O. in time to meet the deadline for each Issue of the A.A. directory and helping carry out the triennial membership surveys.
- Visit groups and districts in the area whenever possible.
- Work closely with committee members and officers, sharing experience throughout the year. After G.S.R.s and committee members have reported on the Conference, learn from these A.A.s how groups and members have reacted.
- Assume added responsibility if the area chair and alternate chair are unable to serve. Or, if an area committee is not functioning effectively, the delegate may take an active role in remedying the situation.
- Keep the alternate delegate fully informed and active, so that the alternate can replace the delegate in an emergency.
- Late in the second term, work with newly elected delegates to pass along a basic knowledge of Conference proceedings and problems.
