

The purpose of the Area Committee and this meeting is focused on the health of the area and thus on growth and harmony in the AA Fellowship. The area committee does not create policy. We take care of "maintenance and upkeep issues."

When speaking or asking questions, go to the mic.

Approval of August 2024 ACM Minutes: Cathy R. motioned to approve the minutes, Jess S. seconded, MOTION PASSED UNANIMOUSLY

#### OFFICER REPORTS DELEGATE – DIANE R.

Delegate report for Dec 1, 2024

I am Diane R., area 35 panel 74 delegate.

On November 2, 2024, I attended the joint area 35/36 Minnesota corrections workshop. I want to extend my gratitude to everyone who contributed to its success, especially Mark, R, area 35 correction's chair, for coordinating this very informative event. Karl D. delivered an inspiring presentation about his love of bringing meetings into correctional facilities and his love of fellowship. Jesse Pugh, warden at the MCF St. Cloud shared about alcoholics anonymous is being of service in the prison system. Peggy gave a heartfelt success story about be corrections temporary contact program. Craig H. highlighted both the corrections temporary contact program and the corrections correspondence program. The day was filled with fellowship and information. Thank you to all participants and presenters.

2025Wwest Central Regional Alcoholics Anonymous Service Conference, WRAASC, flyers are out for registration. This conference will be held in Casper WY from February 28 to March 2 at the Best Western downtown. Room rates are \$99.00. Reserve rooms by January 27, 2025. Registration is \$25.00 and after February 19, 2025, it will be \$30,00. Registration information is online at WRAASC2025. Eventbrite.com. Zoom information will be provided to all registrants.

At the west central region delegates meeting on November 17, 2024, we discussed several topics. The Plain Language Big Book came out and sold 70,000 copies. The advisory action was not followed because the book did not replace the references to "addiction" and "addicted" with language related to alcoholism. Language updates are in progress and will be printed in the next edition. A preliminary list of conference agenda items for the 2025 general service conference is available. Usually, area 35 receives a list of all submitted proposed agenda items. They will not be available until the end of February. A letter from the general service conference coordinator stated that there is confusion over the list, and they need time to translate it.

There is now 6.41 months of the prudent reserve. The financial issues coming up will be the renovation project at the general service office, the 2025 International convention that is sometimes profitable, and the grapevine will have a deficit again this year.

More financial information as of the third quarter 2024 (end of September 2024) is the following:

#### Aaws/GSB

- $\cdot$  Contributions of \$8.1m, which is 7% greater than budgeted and 11% more than last year.
- $\cdot$  Gross literature sales are \$10.8m, which is 10% less than budgeted and 3% less than last year.
- $\cdot$  Operating expenses are \$13.4m, which is 3% less than budgeted but 3% more than last year.
- · Operating surplus is \$1.2m before depreciation vs \$341k budgeted.

#### Grapevine/La Viña

- $\cdot$  Grapevine total circulation is 59,263 which is 5% behind on budget and 10% ahead of last year.
- $\cdot$  Grapevine total subscription income is \$1.5m which is 2% behind budget and 20% ahead of last year.

- · Grapevine gross margin on subscriptions is \$685k and \$576k gross margin and books and other items.
- · Grapevine operating expenses are \$1.9m, which approximately equals the budget but a 34% increase from last year.
- · Grapevine net loss is \$612k which a loss of \$565k was budgeted.
- · Total La Viña subscriptions are 6,986 which is 8% behind budget and 10% greater than last year.
- · La Viña gross margin is \$84k which is 4% behind budget and a decrease of 2% from last year. \$23k on subscriptions and \$61k on books and other items.
- · La Viña expenses are \$520k which is approximating the budget and a decrease of 21% from last year.
- · La Viña loss is \$437k which is approximating the budget.

There is a plan to release the grapevine/La Viña apps internationally soon with a good potential for domestic and international sales at the international Vancouver convention in July 2025.

You can still attend the international convention in Vancouver in July 2025. There is still time to register. Vancouver hotels and universities have rooms available. Check out all the options for yourself online at AA.org/international convention.

As we approach the next election cycle in October 2025, consider potential nominees for 2026-2027 trusted servants. Right now, each district can have a nominee for delegate. The nominee does not have to be from your district. Consider which trusted servants are fulfilling their responsibilities, who are dedicated to alcoholics anonymously, who are involved area 35 service, who always shows up and willing to help, and who knows and supports our traditions and concepts. Read concept 9 and the article titled "leadership in AA.: Ever a vital need." Our leaders do not drive by mandate but lead by example. Act for us but don't boss us. Ask someone in advance and see if that person would stand and then see if your district agrees. Keep in mind nominees for area chairperson, secretary, and treasurer. It is a bit early but keep this in mind as we are attending area 35 events next year.

I have to remind myself that words and jokes can be hurtful. I have to remember to be mindful of others and their feelings. I try to treat everyone with love, kindness, tolerance, and patience. I love you all.

-Discussion of Digital Archives and Archies display on our website-Marc N.

Digitizing Archives – Displaying on Website

It has been suggested that digitizing our archives would reduce the cost of storage. This is partially true. Items such as area (and district or group) business records and recordings of meetings and events are easily digitized, but these that are items already preserved in Paper, Photo, Record, Tape, CD/DVD, or USB should be kept as well as the digitized copy. Currently new area business and recordings are kept in digital format only, this could be hazardous as these items were kept in digital format for several years, then lost. Hopefully a better storage plan is in place now.

Requests to make archives viewable on our website have been made a few times in the past several years and more recently have been made by a few GSRs. The next several paragraphs explain complications in doing that.

- · Books are not easily posted on our website, but a list of books could be. Books would not be available for checkout like a library but could be read at the archives. Pictures of our books on bookshelves could be posted.
- · Audio recordings are not suitable for publishing on websites because of the tendency to include personally identifiable information. Listening would be at the discretion of the archivist. An index of digitized audio recordings could be published on our website.
- $\cdot$  Most documents are either area or district business and are available for research when requested via DCM or Area Chairperson. Viewing would be at discretion of archivist.
- · Pictures and poster boards that do not show personally identifiable features could be assembled into slide shows and posted on our website. (the pictures available to buy from GSO archives are not to be posted on our website, but can be displayed at Assemblies, Conventions, Roundups, etc.)
- · Personal correspondence is only for research purposes, a listing is available by requesting of the archivist, not posted online. (i.e.: letters from/to Duluth, Hibbing, St Cloud, and Crookston in early 40s as well as things like letters to GSO, Delegates, Trustees, WCRAA, and more)

· Archived items or collections that are on other websites will not be duplicated on our website. (Grapevine Magazines, Box 459, GSO published items, etc.)

A proposal for including an archive section on the Area35 website would be something like this:

- · An explanatory letter that describes both the inclusions of our archives and the listing of those items on the website. This would include the methods that could be used for requesting and then accessing, viewing or listening to archived items. It would also state that items such as area and district business audio recordings or written meeting minutes and some personal correspondence could be available by extended approval.
- · An inventory list of books. Books are not available for checkout like a library but would be viewable at the archive repository.
- · An inventory list of audio recordings. MP3 recordings would be shared via MS365 or Google Drive with copying disabled and for limited time.
- · Slide shows of (anonymous) pictures, posterboards, magazine covers and articles, and more.

Cost of inclusion on website per our webmaster is mainly his time.

Bonus info:

I inquired about GSO Archives regarding the plan that I outlined for Archives on Area35 website. I received feedback that the plan is aligned with many other areas. The only suggestion they made was that transcribing audio would be easier to anonymize (scrub). They also gave warning of copyright technicalities, but in light of the circumstances of the recording sessions, this is not a likely concern.

WHAT IS "A.A. POLICY" ON ANONYMITY?

Confusion arises from time to time when someone identifies himself in print, on the air or in other media as "a member of Alcoholics Anonymous."

As a result, editors, publishers, writers, radio and television people and others have asked us to define "A.A. policy" on public identification of members.

The guiding principles of the A.A. movement have been expressed in "Twelve Traditions" adopted unanimously at the time of our International Convention in Cleveland in 1950, when the movement was fifteen years old.

The Eleventh and Twelfth Traditions are particularly pertinent:

Our public relations policy is based on attraction rather than promotion; we need always maintain personal anonymity at the level of press, radio and

films. (Underlining added)

Twelfth: Anonymity is the spiritual foundation of all our Traditions, ever reminding us to place principles

above personalities.

Clearly, the vast majority of A.A. members believe it harmful to themselves and to the movement to discard personal anonymity.

There are compelling practical reasons for this belief.

First: Experience shows that many who want and need help with their problem drinking will hesitate to turn to A.A. when they see members identified publicly; they are concerned lest their own anonymity not be preserved.

Second: There is the danger that an A.A. member whose sobriety has been well publicized may depart from the recovery program and revert to equally wellpublicized drinking. Obviously, such occurrences tend to give a distorted picture of A.A. and its contributions to the solution of the terrible problem of alcoholism.

Third: Over the years a few men and women have undoubtedly sought to exploit their association with A.A. for purposes of personal prestige or financial gain. We believe, however, that most "breaks" in anonymity result from two

#### The Reason YOU Were Chosen for This Work

God in his wisdom selected this group of men and women to be the purveyors of his goodness. In selecting them through whom to bring about this phenomenon he went not to the proud, the mighty, the famous or the brilliant. He went instead to the humble, to the sick, to the unfortunate. He went right to the drunkard, the so-called weakling of the world. Well might he have said to us, "Unto your weak and feeble hands I have entrusted a power beyond estimate. To you has been given that which has been denied the most learned of your fellows. Not to scientists or statesmen, not to wives or mothers, not even to my priests or ministers have I given this gift of healing other alcoholics which I entrust to you.

"It must be used unselfishly; it carries with it grave responsibility. No day can be too long; no demands upon your time can be too urgent; no case be too pitiful; no task too hard; no effort too great. It must be used with tolerance for I have restricted its application to no race, no creed, and no denomination. Personal criticism you must expect; lack of appreciation will be common; ridicule will be your lot; your motives will be misjudged. You must be prepared for adversity, what men call adversity is the ladder you must use to ascend the rungs toward spiritual perfection, and remember, in the exercise of this power, I shall not exact from you beyond your capabilities.

"You are not selected because of exceptional talents, and be careful always, if success attends your efforts, not to ascribe to personal superiority that to which you can lay claim only by virtue of my gift. If I have wanted learned men to accomplish this mission, the power would have been entrusted to the physician and scientist. If I had wanted eloquent men, there would have been many anxious for the assignment, for talk is the easiest used of all talents with which I have endowed mankind. If I had wanted scholarly men, the world is filled with better qualified men than you who would be available. You were selected because you have been the outcasts of the world and your long experience as drunkards has made or should make you humbly alert to the cries of distress that come from the lonely hearts of alcoholics everywhere.

"Keep ever in mind the admission you made on the day of your profession in AA, namely that you are powerless and that it was only with your willingness to turn your life and will unto my keeping that relief came to you."

The Plain Language Big Book is a tool to help readers understand the book Alcoholics Anonymous, which was first published in 1939. This new book is designed so that the A.A. Twelve Step program of recovery from alcoholism may be easily understood and accessible by all people who have a desire to stop drinking.

Members of A.A. fondly call the original book Alcoholics Anonymous "the Big Book." It is the basic text of the A.A. program. The Plain Language Big Book has been written to present the original ideas and same spiritual message of the Big Book, Alcoholics Anonymous.

This new text is not intended to replace the much beloved Big Book. Rather, the Plain Language Big Book is a book crafted over several years by A.A. members and publishing professionals to support alcoholics on the path to recovery. The book is intended to help people who have a problem with alcohol gain access to A.A.'s lifesaving message.

For years, A.A. members have expressed a need for a Plain Language Big Book. Based on the shared experience of A.A. members, some people may not have regular contact with other A.A. members to help them understand the A.A. program of recovery and the specific vocabulary as it is used throughout the original book Alcoholics Anonymous. Other people have a hard time reading, especially books that were written long ago. This Plain Language Big Book is written in simpler language to support readers in their recovery.

This book is published in accordance with Advisory Actions passed by substantial unanimity of the General Service Conference (GSC) of Alcoholics Anonymous. In 2021, the 71st GSC advised that this book be developed. Progress reports, then sample chapters were reviewed at the 72nd and 73rd GSCs. The final draft of the Plain Language Big Book was reviewed and approved by substantial unanimity at the 74th GSC, in April 2024. This process and outcome adopts this text as Conference Approved Literature.

The Plain Language Big Book covers the core content of what is the "abridged version" (the edition without personal stories) of the original Big Book.

Readers are also encouraged to seek out the current edition of the book Alcoholics Anonymous and meet with A.A. members to support their own individual paths of recovery from alcoholism

#### **NORTHERN LIGHT PRIMARY PURPOSE:**

- ♦ Keep informed of activities and issues going on within Alcoholics Anonymous as a whole. The N.L. Committee could subscribe to the Grapevine or other pertinent A.A. news sources.
- ♦ Gather useful service information to publish from sources within the Area, Region and A.A. as a whole. Obtain, read and use other Area newsletters.
- Listen to comments from the Area on the content of the N.L.

#### **EDITORIAL POSITION & N.L. COMMITTEE:**

**Editor**: The Editorial Chair position is a two-year rotation picked by the incoming Area Chair and either approved or rejected by the Area Committee at the first Area meeting after the Fall Assembly Elections.

**Desirable qualifications:** Current knowledge of MS Publisher, MS Word, MS Excel and other misc. computer programs as needed. The person should also consider the time needed to complete the task required. The candidate should have a working knowledge of A.A. as a whole, i.e., prior experience in service work such as G.S.R., D.C.M., or related position.

**N.L. COMMITTEE**: The N.L. Committee consists of the Area Group Records Chair, Area Webmaster and Area Audio Technician along with two D.C.M.s in Area 35. DCM's are picked randomly at the start of each rotation and serve on a two-year rotation basis. They assist the editor in communications with other area newsletters, in recommendations on general improvements, and with general problems and implementations of new policies. They may also represent the editor at functions when the editor is unable to attend.

**N.L. COMMITTEE MEETINGS:** The Committee meets every other month, before the start of the Area Workshop and at Spring and Fall Assemblies. If needed, additional meetings may be called.

#### **NORTHERN LIGHT SUBMISSIONS:**

General submissions are welcome! Feel free to send letters or articles that are pertinent to AA and Area 35. All submissions will be approved by the Northern Light committee, in accordance with Tradition Two; For our group purpose there is but one ultimate authority – a loving God as He may express Himself in our group conscience. Our leaders are but trusted servants; they do not govern. Please note that if space is limited, first priority will be given to reports from Area Officers, Area Standing Committee Chairs and D.C.M.s from Area 35.

#### **Area 35 Event Flyer Guidelines**

To be included in the Northern Light, all flyers must answer the following questions.:

- 1. Who is involved or sponsoring the event? Examples:
  - a) AA Group
  - b) District
  - c) Area
- 2. What type of event is it? Please include itinerary. Examples:
  - a) An open or closed meeting
  - b) Speaker meeting
  - c) Call up meeting
  - d) Big Book meeting
  - e) Workshop with itinerary
  - f) Conference with itinerary
  - g) Fellowship (ice cream socials, potlucks, chili cook offs, etc.)
  - h) AA must appear somewhere on the flyer
- 3. When is the event to take place?
  - a) Date and time
  - b) Does it reoccur
- 4. Where will the event take place?
  - a) Name of the facility and the address
  - b) Maps are sometimes helpful but not necessary
- 5. Why is the event taking place?
  - a) The reason for AA events is to carry the AA message to the still suffering alcoholic (this doesn't have to be printed on the flyer)
  - b) Usually covered in Who and What

\*For safety reasons, if a phone number is listed on the flyer consider NOT putting a name in association with the number.

Only Area 35 AA members may submit a flier. Fliers for AA sponsored events only.

Please submit flyers in PDF format when possible. Flyers will be posted on area35.org and in the Northern Light at the Area 35 Webmaster's and Northern Light Editor's discretion. Email northernlight@area35.org with any questions.

# AREA 35 EVENTS INCLEMENT WEATHER PROCEDURE


- Area Chair asks for weather reports from all DCMs from respective Districts, either by email or phone.

### Q: Why list our past Delegates?

#### A: They are a resource to you!

In Alcoholics Anonymous we value experience. Our Twelve Steps did not exist when Bill stepped into the lobby of a hotel in Akron, Ohio. Even after meeting with Dr. Bob and soon founding our program, there were only six steps until the experiences of 100 Alcoholics were summed up. Soon after a book followed, but it was a few years later when the Twelve Traditions were discussed and agreed on. Twelve Traditions that were "hammered out on the anvil of experience". Our past Delegates are a wealth of experience, an interactive living archive if you will. When you plan your next service workshop or need an outside voice to offer help, consider this resource available to you.

### The Delegate's Duties

Though the high point is the Conference meeting, the delegate's job goes on year-round and involves all aspects of the Conference structure. The delegate should:

- Attend the Conference meeting in April, fully prepared. Immediately upon election, every delegate is put on the G.S.O. mailing list to receive Conference materials.
- Communicate the actions of the Conference to area committee members and encourage them to pass on this information, and the delegate's enthusiasm, to groups and to intergroups/central offices. If an area is too large for the delegate to cover in person, he or she will ask area officers and committee members to share the load.
- Be prepared to attend all area, state/provincial, and regional service meetings and assemblies. From these meetings, delegates come to better understand their own areas and can make suggestions for the Conference agenda. Here, too, they come in contact with A.A. members who might not be reached otherwise.
- Help area committees obtain financial support for the area and G.S.O.
- Provide leadership in solving local problems involving the A.A. Traditions

- Remind G.S.R.s to inform groups and individuals about the A.A. Grapevine and Conference-approved literature.
- Cooperate with G.S.O. in obtaining information—for example, making sure that up-to-date information reaches G.S.O. in time to meet the deadline for each Issue of the A.A. directory and helping carry out the triennial membership surveys.
- Visit groups and districts in the area whenever possible.
- Work closely with committee members and officers, sharing experience throughout the year. After G.S.R.s and committee members have reported on the Conference, learn from these A.A.s how groups and members have reacted.
- Assume added responsibility if the area chair and alternate chair are unable to serve. Or, if an area committee is not functioning effectively, the delegate may take an active role in remedying the situation.
- Keep the alternate delegate fully informed and active, so that the alternate can replace the delegate in an emergency.
- Late in the second term, work with newly elected delegates to pass along a basic knowledge of Conference proceedings and problems.
