

Call to Order: Area Chair Vicki R called the meeting to order at 10:30 a.m. on Sunday, June 1, 2025, and opened with the Serenity Prayer.

Recognition of Past Delegates in Attendance: None in attendance

Additions to agenda: None

Points of order:

Two-minute limit for sharing at the mic.

The purpose of the Area Committee and this meeting is focused on the health of the area and thus on growth and harmony in the AA Fellowship. The area committee does not create policies. We take care of "maintenance and upkeep issues."

Avoid crosstalk as it makes it hard to hear.

When speaking or asking questions, go to the mic.

Approval of February 2nd ACM Minutes: Cathy R. motioned to approve the minutes, Peggy M. seconded, Motion passed unanimously

OFFICER REPORTS **DELEGATE – DIANE R.**

General Service Conference Report

Thank you for allowing me to serve Area 35 at the 75th General Service Conference. The General Service Conference is a busy time of year. Providing information to our fellowship is crucial so you can make informed group conscience decisions.

The conference began with a "Meet the Delegates" event on Saturday night, which we did not have last year. It was a wonderful opportunity to meet all 136 delegates, including trustees, non-trustee directors, office staff, and area delegates, as we are all conference delegates.

We picked up our conference manuals, badges, and voting clickers (voting clickers are electronic devices used by delegates to cast their votes during the conference). During the roll call, I said "present." The conference manuals are binders containing the week's schedule, participant rosters, general information, reports from the Board, GSO, and Grapevine/LaViña, committee reports, financial information, and presentations.

Karen, our delegate chair, greeted us and reminded us of our role in upholding the spiritual nature of the 75th General Service Conference. She encouraged us to use our diverse voices, listen respectfully, and engage fully in discussions. The purpose of our service work is to support the vital 12-step work, ensuring our message remains consistent and clear for those we help and those who assist us.

Our Co-Founder, Bill W., wrote in January 1948, from "Tradition Two", "The Language of the Heart".

"With respect to its own affairs, the collective conscience of the group will, given time, almost surely demonstrate its perfect dependability. The group conscience will, in the end, prove a far more infallible guide for group affairs than the decision of any individual member, however good or wise he may be."

Next was Sister Judith Ann Karam, Class A Trustee. A Class A Trustee is a non-alcoholic trustee who serves on the General Service Board. She worked at St Vincent Charity Hospital in Cleveland and became familiar with Sister Ignatia as she walked the halls of the hospital. In 2019 she was elected as a Class A Trustee and rotated out of the conference after six years. She said, "In this Fellowship, a profound trust exists between all of you. You trust in yourselves, in each other, and in your higher power. You trust your graced journey of sobriety. You trust that in handing your will over to God, your higher power, you will overcome the disease of alcoholism. Over these past six years, I have witnessed you working together and living the spiritual principles. Working together is hard but so rewarding for achieving and maintaining sobriety. Working together means trusting one another. Working together means placing your needs in the hands of others and carefully caring for their needs in return. Your care for each other is palpable. I experience it when I attend Board meetings, regional forums, and gatherings. We are responsible. We together are responsible for reaching out to the suffering alco-

She also said, "You have handed over your ability to recover to a higher power, and trusted that whoever is Sacred to you, will give you grace while remaining sober. You have the strength to unite with one another. You trust in spiritual principles and trust each other to keep it going – together. Your life depends on it. Your loving service to others makes it so that each individual alcoholic's life depends on it. Your hands, your heart, your love and dedication to each other are what carries the message of A.A. forward. This Fellowship, this Conference makes the future of A.A. go on and what a blessing that is to all. "

We discussed the mechanics of the conference. Bob W. was supposed to give an overview of "How the Conference Operates." He and Scott H. mentioned that this was just an overview of the rewritten "How the Conference Operates." However, there were differences between Bob's overview, the rewritten version, and the "How the Conference Operates" section in Appendix W of the service manual. This caused confusion as we tried to follow along. After a long discussion, a vote was taken, and the updated version was approved by a simple majority. Before the vote, we asked if it required a simple majority or substantial unanimity, but the chairs did not answer. When we reconvened on Wednesday before the committee reports, it was decided that we would proceed without a defined "How the Conference Operates" and see what happened. That is how it turned out.

Before attending the conference, we were asked to answer nineteen questions for a Conference Inventory. Out of 117 responses, I read all of them at least twice before arriving at the conference. We divided into fifteen groups; each assigned four questions to discuss. I was in group D, and we had two hours to discuss our four questions. Each group had a Chair and a recorder, and I served as the recorder for our group. Each recorder had 20 minutes to report to the conference on the discussions within their group. These reports will be included in the final conference report. We will continue to discuss this inventory and seek input from the areas on the questions.

We listened to area highlights from the Panel 75 delegates. Hopefully, we will continue to hear highlights from the delegates in the future. It is a learning experience for everyone and can even be fun at times.

Scott H., the Board Chair, presented the General Service Board report. He began by discussing the International Convention, the Plain Language Big Book, and Grapevine's 80th anniversary celebration. A cross-functional group of conference members has been created to identify improvements in communication and reporting between the Board and Conference Members.

The General Service Board has finalized and adopted several policies required by New York State law, including a Whistleblower Policy, a Confidentiality Policy, and a Code of Conduct Policy. Additionally, they have developed a procedure for establishing a Compliance Committee to address complaints and concerns in an objective and impartial manner.

There were questions about the Code of Conduct and the compliance committee. There was some confusion about the compliance committee's actions, specifically interviewing A.A. members. They were addressing the concerns of a member who resigned and trying to determine how her resignation letter was leaked outside of the board.

Scott H. apologized on behalf of the Conference to Kevin Prior, who was set to resign at the end of the conference. Kevin Prior, a Class A Trustee, resigned Friday night during the censure discussion.

Financial statements were provided to show the financial health of the General Service Board, Alcoholics Anonymous World Services (A.A.W.S.), and Grapevine Inc. The financial report was presented by the auditors from BDO and Kevin Prior, Class A Trustee. The auditor stated that BDO performed the audit and confirmed that the consolidated financial statements fairly represent the financial position of our organization in all material respects. There were no new risks or modifications to the financials. We are in better financial health, with a well-funded pension plan and no debt. Our current assets exceed our current liabilities.

Kevin Prior presented highlights in the Picnic Table Slides:

- · The Seventh Tradition of Self-Support increased by 3% to \$11.249 million.
- · Operating expenses before depreciation rose by 6.9% to \$18.684 million.
- · Self-Support covers 60% of the operating expenses.
- · AAWS Publishing gross profits were \$7.64 million, up 13%.
- · Gross margin on Grapevine subscriptions was \$766,004, and other published items were \$824,391.
- \cdot Operating expenses for Grapevine were \$2,457,623, resulting in an operating loss of \$851,735.
- · LaViña service activity support from the General Fund was \$571,939.
- The budget for GSO showed an operating surplus of \$1,027,932, but also included a capital retrofit for GSO costing \$2,374,982.
 Grapevine's budget for 2025 aims to increase subscribers to almost 9,000
- new subscribers, with an expected deficit of \$134,862.

 LaViña's circulation is projected to increase to 7,683 in 2025, with General Fund support of \$455,626---

There are 31,629 registered attendees for the International Conference, but the projected break-even point is 32,500 attendees. Budgets have been reviewed to identify areas where expenses can be trimmed. The remodel cost is \$2 million, and although deferring the remodel was considered, existing contracts and increasing costs make it necessary to proceed with the renovation. Therefore, there will be a drawdown for the renovation.

On Monday and Tuesday morning, we met with our committee members to discuss our Conference Agenda Items. Our Grapevine/LaViña committee had several sessions with Chris C., the Publisher, who answered all of our questions. I was skeptical about the 5-year plan because they review budgets twice a year. Therefore, I wanted to know how Grapevine and LaViña were performing in the first quarter of 2025. LaViña subscriptions were up for this quarter and were on target for their budget. Grapevine has invested in prod-

ucts, and the International Convention attendees are expected to purchase a lot of that inventory, making it a promising year for Grapevine.

Carolyn W., Class B Trustee, presented the A.A.W.S. report. A.A.W.S. is a not-for-profit organization with a nine-director board that meets at least eight times a year to fulfill its responsibilities. The A.A.W.S. Board implements the actions of the General Service Conference and the General Service Board (GSB). They oversee reprint permissions, copyright concerns, and legal or policy requirements. The A.A.W.S. Board oversees the General Service Office (GSO), which serves as the headquarters and hub for supportive services. Much of the work of the A.A.W.S. Board is conducted through committees, subcommittees, and ad hoc committees between board meetings. From February 2024 to February 2025, the A.A.W.S. Board held 168 meetings and engaged with 1,750 documents to fulfill its service responsibilities. The organization has ninety employees.

Robert L., Trustee at Large Canada, Marita R., Trustee at Large U.S., and Irene D., GSO Staff, presented the highlights of the A.A. International World Service Meeting. The primary purpose of the World Service Meeting is to carry the message to alcoholics who still suffer, regardless of their location or language. This meeting serves as a platform for discussing common challenges and successes, but it does not make decisions except for those applicable to the meeting itself.

The international desk at GSO is the contact point for members on all continents and supports the global activities of A.A. You can see A.A. emerging in places where it did not exist before.

Patrick C., GSO Staff, provided an update on the 2025 International Convention. Currently, there are over 31,000 registered attendees from about eighty-one countries. Registration will now be onsite at the Vancouver Convention

Joyce S., Class A Trustee, presented on the A.A. Grapevine/LaViña. The Grapevine/LaViña rely on subscriptions and book sales because they do not accept advertising or direct contributions. They have published forty-five books. Recently, they released greeting cards with popular daily quotes and a collection of cartoons. Grapevine/LaViña also has a digital presence through their websites, Instagram, and YouTube. They produce a weekly podcast, and Deaf members' stories in ASL are available on their YouTube channel. The "Carry the Message" initiative allows A.A. members to provide Grapevine and LaViña subscriptions to those who cannot afford their own. Their new motto is "Download the app and subscribe."

From Wednesday evening to midnight on Friday, we had committee reports and discussions. On Saturday morning, trustees and non-trustee directors gave farewell talks. One farewell talk stood out to me. The Trustee stated, "we need to find ways to continue talking to one another, one alcoholic talking to another alcoholic. We do not need more pamphlets or to divide ourselves into separate groups of members." Of course, this is my interpretation of what was said.

Goodbyes were said, and hugs were given. It was another conference, and I felt grateful to attend and represent the voice of Area 35. Delegate Report for June 2025

The report will include information from the General Service Conference. Pat and I attended the first Report-Back from the conference in Bemidji. We were welcomed with supper and Fellowship. Thank you, District 21, for having us and all your support and questions. While I was there, one of the members was having his 50th sobriety birthday in a few weeks. Congratulations, Brent.

My next Report-Back was in Duluth. Ricco and I had a very good supper. It was good to see old friends and some new ones. There were lots of questions and interest in the report back from the conference. Thank you, District 12. Pat and I attended the Report-Back in Isanti. Thank you to Districts 5, 6, and 16. Again, we had lunch. We took a break, and it was wonderful to see all the fellowship among our members. It is always hard to get back to the business of the Report Back.

The next Report Back was close to home, Hibbing with District 9. We had a few interesting discussions. Thank you, District 9.

The next two Report-Backs will be on June 4th in District 8 and June 9th in St. Cloud with District 13 and District 15. Pat arranged a Report Back with Districts 1 and 2 on June 15. Looking forward to seeing everyone and the fellowship.

THE HANDWRITING ON THE WALL - Seeing is believing... and listening is understanding...

June visit to Akron AA Intergroup Office:

Being told while visiting Akron that the group's plan was to spend 3 hours (or more) at the small Intergroup office sounded a little excessive. We were met there by Gail L.; Akron Historian, Archivist, and Curator of Dr. Bob's House & Library. She was to give us the "tour". They had a lot of archives; displayed.

We sat on benches and chairs underneath the large stained glass re-creation of the famous picture of "The Man on the Bed" (Bill & Dr. Bob doing a 12-Step call on Bill D, who was to become AA # 3).

As Gail began, it was immediately apparent that she was a "teacher". I had the curious feeling I was back in time, early school years. She had a commanding presence. And what was the first thing she talked about? It happened to be the CONCEPTS. Yep. Not what I expected. She began by relating how our Concepts (and the included Warranties) had provided the overarching formal structure that kept our crazy fellowship together, enabled our Three Legacies, and had ultimately kept AA from splintering apart from our competing petty human egos just like the groups and organizations that came before AA.

Within the first 10 minutes she had my full attention.

The next 3 hours now seem like 3 minutes. Seeing and hearing the backstories for the many the hand written notes in books, letters, and accompanying photos gave me a much greater depth of understanding of what it was really like during those early and formative days of AA. Long before any of the people involved ever dared to hope or imagine as to what and how their actions would ultimately touch millions of people world-wide and become not only one of the most printed and read books of all time, but also one of the most copied and plagiarized.

Seeing Bill's, Dr. Bob's various letters preserved on these walls, listening to Gail tell their stories, seeing the collections of all the various Big Books in different languages, plus all the other items from press, film, etc., and a copy of the "redlines" of the first manuscript of the Big Book, was quite the expe-

STORY TELLING - The Primal Core of AA.

Since man evolved and created communications via language we have been telling stories. At the earliest of times much of human to human learning was passed on via verbal stories, long before the written word. Humans have an affinity for stories told, and to this day we use such to reinforce and drive understanding of the written word. Story telling is still one of the most effective ways to really impress and cultivate use of the information provided.

One Alcoholic relating to another. Our personal stories and experience make the program come alive. We don't have to be professional teachers to do this either. As the AA BB says, "Our own experience is our greatest gift / as-

Gail's personal tour / instruction of the archive contents made the books I've read much more meaningful. Also, she added significant additional depth and weight, plus sidebar information, facts, and stories that had great impact on my understanding.

WANDERING IN THE WILDERNESS - And the gift of desperation.

Despite, or maybe because of the "white light" experience that helped enable Bill to get sober, he had to struggle mightily for months before he hit on the right way to impress on another a way to achieve lasting sobriety. Trial and error. Ongoing failures. Little to no success at all until Dr. Bob.

And Bill was slowly losing it. At the Mayflower that night his sobriety (and probably life) really hung in the balance. Professional and personal failure (again) surrounded him on all sides. Broke, lonely, and at about the end of his mental strength; he made a fateful decision to turn away from "the ease and comfort" of drink at the hotel bar and instead went in the opposite direction of more effort to help someone else and likely more failure. As it turned out, he needed help as much as Dr. Bob did.

I can relate in many ways and across many personal experiences. Easy lessons may be quickly forgotten. Those learned the harder way; slowly, sometimes very painfully, stick with us better. Getting a sponsor and really working the steps is much more difficult and time consuming vs. just going to meetings and reading about it. The "gift of desperation" is a big key. Having our egos and selves beaten senseless typically enables us to be much more willing. Willing to work and do what we otherwise would not want to.

I also believe that when we are at the "end of our rope", exhausted, and truly desperate, and when we admit such "to ourselves, God, and another human being", and ask for help; small miracles often seem to be enabled...



As I sit here at mom's bedside waiting for the inevitable, I think of how many times we have done this before. The amazing thing is being able to be sober to date through all of them-

At 2 years sober I sat by my dad's bedside and helped him die of cancer. He was a sober member of Alcoholics Anonymous for 10 years.

At 19 years sober I sat by my brother's beside and helped him die of cancer. He was sober 20 years, although he didn't find his "home group" in Alcoholics Anonymous, he maintained sobriety until his death.

Now at 37 years sober, I sit at my mother's bedside to help her die of Alzheimer's and Cancer. She is a 46 year member of Alcoholics Anonymous who loves the Big Book! They weren't kidding when they said it is a family illness. Fortunately for us there is also family sobriety!

Mom has had a home group all her 46 years and is grounded in the Big Book of Alcoholics Anonymous. Having to give up her home group when she could no longer attend was very difficult for her. We attended many meetings together the last few months, in person as well as attending virtually. While she loved seeing her AA friends at the local Alano Club where most of our meetings are held, she would rather focus on the newcomer and make them feel welcomed. That was her special gift.

I am forever grateful for the program of Alcoholics Anonymous that was there when my family needed it. Starting in the 1960's when my Grandpa needed it, then in the late 70's when my mom and dad needed it, and finally the 80's when my brother and myself needed it. By God's grace we were all able to stay sober and live wonderful lives and I am forever grateful. I hope Alcoholics Anonymous continues to be there for the next generations as it was for us and will continue to be for me as long as I carry on one day at a time in sobriety.

We never know what a life of sobriety will bring us, even in the hard times it is so much more than I could have imagined.



- 3. Or email them at: corrections@aa.org
- 4. Provide them with the name of the man or woman whom you are corresponding with. The staff at GSO will do a "Look-Up" using the VINELink website.
- 5. Upon locating where your Incarcerated Person is now at, they will re-register your information with that individual and provide you with their new address for corresponding

I continue to be available to help our Area 35 District Corrections Chairs & DCMs with their respective Corrections opportunities and questions/ concerns. I want to thank District 13 for having me at their District meetings and allowing me the opportunity to continue to attract volunteers for MCF-St Cloud Prison and facilitate the Thursday evening A.A. meeting for those men incarcerated there. With the help of Mike R. on Tuesdays, we have 10 volunteers that rotate on Tuesdays and 9 of us on Thursdays (Yes, 19 in total and more starting!). The Program Coordinators and Warden Pugh at MCF St Cloud on several occasions have extended how grateful they are for our participation in their program structure and the unbelievable number of dedicated volunteers.

For over 4 years, we had been informed Kanabec County Jail did not want A.A. Meetings there. After I contacted Joel Stevens at Kanabec County Jail, he informed me they did not know who to contact about getting A.A. meetings started there and had been wanting meetings for over 4 years. Another brochure I have found helpful is titled... "How A.A. Members Cooperate with Professionals". #20 states... "Does Cooperating witty professionals really do any good? There is overwhelming evidence that cooperation does pay off handsomely for the individual alcoholic and for A.A. as a whole. This evidence comes from the latest Membership Survey of A.A. groups in the U.S. and Canada. It is this: Before coming to A.A., 59% of the members received some type of treatment or counseling (such as medical, psychological, spiritual, etc.) related to their drinking."

So, it does strongly appear that communication and cooperation with professionals is very important and fulfills an important link of commu-

Hi, Marc here, an alcoholic, and your Area35 archivist.

My work with archives at times is overwhelming, a bit depressing. I get to thinking: "why am I doing this, why is no one interested in these archived things, why have donations to archives declined over the past several years". But then a thought from my higher power reminds me of Rule 62 and I sit back and let my wander to fun things. Remember how that Moose and Squirrel always defeated Boris and Natasha. Funny how enjoying life as it comes can defeat the serious nature of what comes against us. To write this I went back to an article that I wrote in September 2023, weird how the past repeats itself, here it is:

My life is like a book, the stories are told in the printed words, but life is lived in the white space. Yours too. In that white space are the distant memories of good times, your first friend, your first dalliance with alcohol... But then, maybe not soon after the white space filled with memories that were wanting to be forgotten. Alcoholism had set its grip. For those of us who

were fortunate we found a way out, we worked these 12 steps and let go of the old memories, ready to make new ones. One of the promises tells us that "we will not regret the past nor wish to shut the door on it". As we move forward our white space once again fills, and a few words define our stories for others

Our Area 35 Archives have a lot of history of AAs early days, a good amount of district and area business, and many books and recordings. Some of these books could be considered outside issues and per AA traditions we should not have any opinion of them. My observation is that we tend to remember the good points, the softer not so harsh realities of our alcoholism. The stories seldom delve into the really dark side, maybe because our blackouts really do blank out those bad times. Then the recovery process begins to make new memories. The stories of recovery are often the more comfortable experiences, DTs are not mentioned, aversion therapies are glossed over, "the cure" is mentioned but not the "jag farm", jail or prison. Most of the books, recordings and personal stories are from many years ago. There is an immense white space left by stories untold. Please help to record Area 35 history as told by the people who are here. Your story will very likely help another person find sobriety and serenity.

Archives might not be interesting now, but without memories of the past our future might be as bright for the next generation.

Please remember when telling your story to remain anonymous, the stories you tell could be displayed with Area 35 virtual archives. Keep your stories related to alcoholism, singleness of purpose does matter. And please no mention of treatment center name or place of incarceration where you found sobriety.

In closing, I want to say that if you want to share your story, contact me. I have some guidelines and some methods that just might make it easy.

Editor: The Editorial Chair position is a two-year rotation picked by the incoming Area Chair and either approved or rejected by the Area Committee at the first Area meeting after the Fall Assembly Elections.

Desirable qualifications: Current knowledge of MS Publisher, MS Word, MS Excel and other misc. computer programs as needed. The person should also consider the time needed to complete the task required. The candidate should have a working knowledge of A.A. as a whole, i.e., prior experience in service work such as G.S.R., D.C.M., or related position.

N.L. COMMITTEE: The N.L. Committee consists of the Area Group Records Chair, Area Webmaster and Area Audio Technician along with two D.C.M.s in Area 35. DCM's are picked randomly at the start of each rotation and serve on a two-year rotation basis. They assist the editor in communications with other area newsletters, in recommendations on general improvements, and with general problems and implementations of new policies. They may also represent the editor at functions when the editor is unable to attend.

N.L. COMMITTEE MEETINGS: The Committee meets every other month, before the start of the Area Workshop and at Spring and Fall Assemblies. If needed, additional meetings may be called.

 - h) AA must appear somewhere on the flyer
- 3. When is the event to take place?
 - a) Date and time
 - b) Does it reoccur
- 4. Where will the event take place?
 - a) Name of the facility and the address
 - b) Maps are sometimes helpful but not necessary
- 5. Why is the event taking place?
 - a) The reason for AA events is to carry the AA message to the still suffering alcoholic (this doesn't have to be printed on the flyer)

AREA 35 EVENTS INCLEMENT WEATHER PROCEDURE


- Area Chair asks for weather reports from all DCMs from respective Districts, either by email or phone.

Q: Why list our past Delegates?

A: They are a resource to you!

In Alcoholics Anonymous we value experience. Our Twelve Steps did not exist when Bill stepped into the lobby of a hotel in Akron, Ohio. Even after meeting with Dr. Bob and soon founding our program, there were only six steps until the experiences of 100 Alcoholics were summed up. Soon after a book followed, but it was a few years later when the Twelve Traditions were discussed and agreed on. Twelve Traditions that were "hammered out on the anvil of experience". Our past Delegates are a wealth of experience, an interactive living archive if you will. When you plan your next service workshop or need an outside voice to offer help, consider this resource available to you.

The Delegate's Duties

Though the high point is the Conference meeting, the delegate's job goes on year-round and involves all aspects of the Conference structure. The delegate should:

- Attend the Conference meeting in April, fully prepared. Immediately upon election, every delegate is put on the G.S.O. mailing list to receive Conference materials.
- Communicate the actions of the Conference to area committee members and encourage them to pass on this information, and the delegate's enthusiasm, to groups and to intergroups/central offices. If an area is too large for the delegate to cover in person, he or she will ask area officers and committee members to share the load.
- Be prepared to attend all area, state/provincial, and regional service meetings and assemblies. From these meetings, delegates come to better understand their own areas and can make suggestions for the Conference agenda. Here, too, they come in contact with A.A. members who might not be reached otherwise.
- Help area committees obtain financial support for the area and G.S.O.
- Provide leadership in solving local problems involving the A.A. Traditions

- Remind G.S.R.s to inform groups and individuals about the A.A. Grapevine and Conference-approved literature.
- Cooperate with G.S.O. in obtaining information—for example, making sure that up-to-date information reaches G.S.O. in time to meet the deadline for each Issue of the A.A. directory and helping carry out the triennial membership surveys.
- Visit groups and districts in the area whenever possible.
- Work closely with committee members and officers, sharing experience throughout the year. After G.S.R.s and committee members have reported on the Conference, learn from these A.A.s how groups and members have reacted.
- Assume added responsibility if the area chair and alternate chair are unable to serve. Or, if an area committee is not functioning effectively, the delegate may take an active role in remedying the situation.
- Keep the alternate delegate fully informed and active, so that the alternate can replace the delegate in an emergency.
- Late in the second term, work with newly elected delegates to pass along a basic knowledge of Conference proceedings and problems.
