

### OFFICER REPORTS

### **DELEGATE-DIANE R**

Hi,

We have not received minutes from the January General Service Board meeting.

I attended the West Central Regional Alcoholic Anonymous Service Conference (WCRAASC) in Casper, WY. There were 365 registrations, with 209 in person. All General Service Conference Agenda Items were discussed.

There were four General Sharing Sessions. Two of them focused on our financial reality and responsibility, while the other two emphasized making every voice count and asking for help through delegation. Contributions are used to keep our doors open, provide public information, maintain meeting schedules and websites, send our representatives to service functions, and pay rent. It is essential to inform the groups about the use of their contributions, as we do not accept outside donations. Communication within our fellowship is crucial. We listen to each other and continue to value all the voices in the rooms. Our efforts are concentrated on the spiritual entity rather than the material entity. Remember, we have no membership to increase, no money, no property, no prestige, and no business corporation that will divert us from our primary spiritual aim. Delegating is a way to involve others in carrying the message to still suffering alcoholics.

My favorite session is the presentations and questions answered by the past trustees from our West Central Region. These are some of my takeaways.

- · It was important to reach out and offer support to other alcoholics.
- · Studying the Traditions guides the group's actions and maintains unity.
- · Prayer and a loving God in the group's conscience are important in making group decisions.
- $\cdot$  The group needs to study the Traditions, not just read them, to fully understand and implement them.
- · It is not only important to trust the Trustees but to express concerns about the implementation of the Code of Conduct. We have our traditions as a Code of Conduct.

- · There is a need for transparency and the flow of information to maintain trust within the fellowship.
- · Rulemaking can cause division, and trust is essential for unity.
- · Focus on the importance of maintaining trust and working towards the group's principles.
- $\cdot$  It is a privilege to be part of a group, and the group has the responsibility to create unity.
- $\cdot$  There is an upcoming rotation of the General Service Board, and we will need good leaders.
- · Question whether the program is adequately represented, and do we have the issue of unrecovered alcoholism?
- · It is important to practice the principles in all affairs or risk the potential loss of long-term spiritual awakening.
- · Recommended reading is Dr. Harry Tiebout's work in A.A. Comes of Age to understand the challenges of ego, selfishness, and self-centeredness. (Pages 245-251)
- · Stress the importance of the Traditions for group unity and the need to introduce and practice the Traditions for Harmony.

As the conference approaches, a lot of information is coming in. The General Service Conference will be held from April 27, 2025, to May 3, 2025. We will be busy from the moment we arrive until we leave, with no time for sightseeing. Thank you for allowing me to be of service. I will be available to attend your district and present a report from the conference. I have three report presentations scheduled for May. Please call or email me to arrange a suitable time.

In the conference manual, specifically in the section on How the Conference Operates (Appendix W of the A.A. Service Manual), it was noted that this section had been edited. Forty-nine other delegates and I wrote a letter to Scott H and Bob W, expressing our disagreement with the changes. Scott H stated he had the authority to make these changes. Warranty 3 states, 'None of the conference members shall ever be placed in a position of unqualified authority over any of the others.' Warranty 4 states, 'All important decisions should be reached by discussion, vote, and, whenever possible, by substantial unanimity.'

I received an email regarding the International Conference with an attached flyer. The flyer pointed to a link selling mugs with the International Conference Logo and the email said there was Trustee's Committee approval for this. I did not forward the email as it is a violation of our seventh tradition. It can also create an issue with the logo which is Warranty Five. There was no conference agenda item to sell mugs through an online business. It also implies affiliation with an online business. We receive seventy-five cents for each mug sold.

There have been two resignations from the Board. Morgan B., a Non-Trustee Director, resigned effectively immediately. Kevin Prior, Class A Trustee and GSB Treasurer, will not accept another year and will resign effective immediately after the conference.

Pat M. and I had a busy month presenting the discussion on the General Service Conference Agenda Items. Thank you to Districts 13, 11, 5, 6, 21, 16, 8, and 9. We enjoyed the discussion and listening to your comments. I hope you brought your group conscience with you today. May the love for our fellowship be with us this weekend. Thank you, Pat M., for all your help and support.

### Motion to add all Intergroups back to Area 35 Website -

Discussion-

- By removing we are not supporting a service entity of AA past decision was based on personalities hidden misinformation isn't relevant, there have been changes- restore all to the website
- -Historical information on St. Cloud Intergroup- Area 36 or Area 35 were contacted by anybody when SCI started . There is no "Central MN" defined in our service Area- last rotation Area 35 Chair and Group Records were notified a board member of SCI "pirated" information from some Districts in Area 35 page 169 in Service manual number 6 about intergroups that Assurances of keeping with the 12 Traditions.
- -Page 19 of service manual- number 3- To carry out Twelfth Step work that may not be practical for groups, district or intergroups to take on by themselves etc... are we doing that or are we stopping the Intergroups from helping us do that?
- -My experience cooperating with Central Officers/Intergroups have been positive except for members of St. Cloud Intergroup- they operate in a way not consistent with other Central Officers/Intergroups they do not want to cooperate, have direct representation of groups serving the management of the Intergroup. My vote would be to add links to Intergroups/Central Offices that do operate appropriately, but not ones that do not.

- Going off Tradition 3 no group having an outside affiliation-Tradition 6 long form is about affiliation or endorsement actual or implied, SCI is affiliated with Recovery Community Network (RCN) both meet in same office building, same suite. So intertwined the newcomer would not have a clear idea of what AA is. SCI did not go through proper channels to be listed with GSO- Area and District were never contacted, employees at Group Services didn't do their job.
- -We've been speaking on this 1 and half years- We are 119 miles north this doesn't affect us; I can't vote on a particular intergroup I don't deal with we have Duluth Intergroup which is great-
- A lot of time talking about this causing disunity for us-
- going with Traditions 6 affiliation concerning SCI- they moved from St. Cloud Alano to Recovery Community Network (RCN) due to inability to pay rent- SCI used to pay for 24hr phone line- it is now free since moving to RCN-SCI no longer pays rent, or their phone line and now uses RCN's PO Box- this goes against the Traditions- Current members of SCI don't seem to care about our Traditions

Julie Nordquist from district 6 DCM, chair for ad hoc committee for virtual meetings at ACM and assemblies. On committee Jennifer, Terry, Kyle, Mark, Terri, Dennis, Scott as past delegate.

We have a lot to consider here. 1st, I would like to ask everyone to close their eyes. Take a deep breath in.....exhale ..... OK

Take this minute to feel this energy in this room. What do you hear? what do you smell? what do you see? Did you see someone new that you've never seen before, did you welcome them? How about a person that has been around for a very long time, you see them at all these functions? Did you see an old friend? Did you catch up with them? How did that hug feel? Did you have a few tasty meals? And how about some really good laughs? Could you go on a break and ask questions freely? Could you feel the passion of your fellow AA.

Before, I started coming to these assemblies and ACM's. I compared myself as just a member of AA. I considered you as THEM. Someone that had more power I couldn't trust you because I didn't know who you were.

Until I walked in these rooms of an assembly as a GSR I started to have an understanding what they are, and I started to trust people in this room. Not because I see their name in the northern light because I see you out at the restaurants. I seen you standing up at the mic I could recognize you. I just think about how a lot of us don't trust GSO, is it because we don't see them in the meetings and only their name in letters? Could be.

I Asked the committee members to ask younger generations an older generation what they thought about going to virtual meetings. Most of their response was they feel uncomfortable but they felt more comfortable when they learned on how to use their device.

If we go virtual and figure out what it could look like at an assembly or ACM, we have options. First option would be 100% virtual meetings. You can be at home or in your car going to the grocery store getting bugged by household members or even be on a family vacation while still attending your assembly and trying to focus on what's going on. Second option hybrid still having the meeting in person but you can stay home if you can't make it. Third option, just continue doing what we're doing today. Meeting in person.

I had my alternate DCM go to the West central because I could not make it. She had spoken to a lot of the delegates and DCMS that were attending. We are the only ones in the West central that is not virtual in some kind of capacity. She reported back saying that it is convenient for their committee members to attend but sometimes attendance is lower than normal. Some of the delegates reported back saying that they lost quite a bit of members when they went virtual but now is doing well.

Some of the good things about having a virtual assembly or ACM is that it is more accessible to the deaf and handicap. Also, More GSR's can attend from smaller groups because their group would not be able to afford \$900 a year to send their GSR to the assemblies and workshop for hotel stays alone. We would save money doing our ACM online for space to rent.

I suppose you have your own opinion on the subject. But before I sit down, I'd like to go ahead and share what it would cost Kyle and Terry Mark put this together for us. What they would recommend is purchasing a few camer-

as, one higher end for the front of the room and one on a lower end for the microphone in the audience if one is being used. Both cameras would be Participate in teams meeting and be connected to a laptop. We should be able to use two of our existing position laptops for this. This would allow video and audio from both mics. If we wanted to go on the low end we could get by with the high-end camera if we keep the question mic within range of the camera this would not be ideal but could certainly work one camera option camera 699 dollars cables 100 to \$200. 2 camera option cameras \$1000 and cables 150 to \$250 we may want to include a dedicated Laptop to this option, which would be about 3 to \$400. So High end is \$1650 and low end is \$700. Mark also has a unit he would be willing to sell area 35 for lease money. WE already pay for teams.

In closing are we doing this for accessibility or convenience.

Unlike the General Service Conference Delegates, Trustees, the voters at the Assemblies and ACMs are not necessarily knowledgeable with Robert's Rules as they could be. Each vote may have differences in how many members vote- We use 2/3<sup>rd</sup> of whatever the total number of votes are.

### ARCHIVIST - MARC NOERENBERG

Hi, I'm Marc with a "C", an Alcoholic and your current Archivist.

I have been doing mostly preservation work, and I got to say this, that I've talked often enough about the work of preserving the audio recordings. This work is ongoing.

We have received grapevine magazines from several people, groups and districts. The archive committee will sort the magazines received and identify those still missing. That's the Grapevine magazine. We would also appreciate donations of grapevine books, even though these are archived at GSO. Our area voted in 1995 or 96 to keep collecting these for our archives. Now, like I said, these are archived. They are available from GSO online with a subscription, but we've got 'em also, we've got the paper copies

There's also a lot of effort needed to preserve our paper documents, the area, district, and group records. These are an essential part of our history. We've had a couple searches through some of those, not very many, but sometimes people ask for stuff such as was so-and-so meeting in great in a such and such a year that I can't answer that because we don't have a list of names of who was meeting, or other, other stuff like that.

We don't have all the meeting minutes for Area Assemblies and ACMs. What we do has needs to be preserved. Preserving papers is accomplished by various means. Sometimes scanning to digital format, other times preservation by deacidifying is necessary. Digitizing makes the documents

available via remote viewing, either is a tedious process and will require many hours of paper shuffling and purchase of equipment. I've been sorting these documents from various file locations into logical file arrangements first by area or district then by date.

There was a mess of things when I inherited the archives and I don't know what caused it, whether it was bad filing or just packing up the stuff from various locations. I found district notes in several different places, area minutes in several different places and not well organized. So going through this stuff and getting it organized takes some time. I do that when I'm at the archives when nobody comes to visit. So, if people come to visit, I can still do that stuff while you're reading, so please come and visit me every third Sunday, but not at Easter.

We do have an abundance of magazines from early years, and some of them have been properly preserved, some have not. These are from beyond our area, and many archives or places such as GSO archives and Publishers Archives. Nonetheless, we should be preserving the ones that we have. And another note, wherever I go, as I travel, I look for hints about AA archives stuff. And today I noticed that one of our past delegates, Duffy, is pictured out in the hallway on the Minnesota Baseball Hall of Fame. I know that is an out of scope for what we do. It's, a, what do you call it, an outside issue, but it's still interesting to see Duffy's picture out in the hallway.

PS: As I was packing up John (from Pierz) offered to do some digitizing of paper documents. We will connect soon to begin this process.

We read version 1 and compared it to the current version of the Big Book. Amazingly enough, we are learning from them both. The history of AA is interesting but not in the way we learned about history in high school. There are no tests, no grades or scores. We begin to understand how the world works in a sober environment and how we, as sober folks, fit into it.

In a message through the Contact button on the Chair App (Minnesota Meeting Guide), I was asked why we do our Chair App the way we do it. And, why we don't just go out and check if a meeting is still there. If a meeting is reported locked and absent, I do send a message to the DCM to please check it out.

The process we follow is to post only groups and not simply meetings to the Meeting Guide. This was agreed upon with the programmers from the start of our Minnesota plug-in into the AAWS Meeting Guide. This means we agreed to only post meetings that are registered and active with our database, Fellowship Connection (GSO). We keep a confidential contact for each meeting for 2 reasons:

This keeps the group registered and active at GSO and identifies the meeting as a responsible group that will take care to be there for the newcomer and each other.

This contact is entered into a confidential field so when questions come up about a group, there is someone to ask and make contact with, as well as the DCM.

I am wondering if our Minnesota Meeting Guide could publish a first name and a phone number for each meeting that someone could call before attending the meeting to see if it's still there. Our district 9 website does this. Both the Minnesota Meeting Guide Chair App and the district websites built by Tyler were built in WordPress. Anyone know if this is possible?

Or, we could separate the Meeting Guide from GSO (Fellowship Connection) registration and post meetings and not limit it to only groups. This would take an agreement from Area 35 and Area 36 which would start with a joint Area 35/36 Committee Meeting. If passed there, then a proposal would be brought to our areas to vote on. We would need a contact system to make sure a meeting is still there for the newcomer and each other. Thoughts? If you are passionate about this process, bring your motion to your district and then our area for consideration to see if we want to approach Area 36 for a joint committee meeting, ok?

Then too there is an observation that we have lots of "old" stuff but nothing new since the mid-nineties. What happened yesterday might be archivable today, a magazine or news media story concerning alcohol abuse or recovery, a movie poster depicting alcohol abuse or recovery, etc. I remember a movie from the mid-seventies, "Sarah T the Teen Aged Alcoholic", this movie has a poster that could be in our archives just like "The Lost Weekend" or "Days of Wine and Roses". Recently my husband and I treated ourselves to a cruise to the Hawaiian and the French Polynesian Islands. We were gone for a total of 32 days.

Soon after we boarded the ship, we spoke with the Cruise Director about having "Friends of Bill W." meetings.

The first meeting (ironically held in a bar that was only used at nights) had 8 attendees. Wow!!! Their sobriety dates ranged from 50 years to 18 days.

We ended up having meetings about every other day or so. The regular attendees were 6 of us. Because we had a returning person with not much time we talked a great deal about the first 3 steps.

One of our main topics covered having a Higher Power. It was wonderful to listen to everyone's stories about their Higher Powers and how they integrated them into their lives.

Over the years it has been said that the most important person at a meeting is the new person. This became abundantly clear as we had more meetings and listened to the new person's struggle to figure out what their Higher Power was. For this alcoholic it was a spiritual review.

The other learning I came away with is to ask for what I need.
Suppose I hadn't asked for an AA meeting?

However, thanks to my Higher Power meetings were asked for and received.

Recently a newcomer showed up at our AA meeting. He shared a rather unique story with us that I would like to share with others. It seems we often don't know what brings people to us, or in this case, back to us.

This gentleman told us that he had been sober for about six years and active in AA until a personality conflict caused him to leave AA and conduct a lengthy research project. He dedicated the next thirty-six years of his life to this effort. Along the way, both of his parents passed away. He totally isolated himself from society and lived in a primitive cabin in the woods. No electricity or running water.

One day a stray cat showed up, and he befriended that little animal. He shared that he kept seeing the little notice in our local paper about the two AA meetings in our area. As his disease worsened, even the little cat would leave him. The cat returned occasionally but left whenever the drinking became excessive.

On Christmas Eve his drinking became so bad that the cat disappeared seemingly for good. He really missed his little four-legged friend but discounted his loss as a punishment he deserved. After four months our friend decided it was time to do something about his drinking and cut the notice out of the paper and pinned it to the wall in his cabin.

He made a decision not to drink that day. That was on a Thursday, and the cat returned the very next day. Our friend saw this as a sign and made the decision to check out our local AA meeting. The next scheduled meeting was on a Tuesday, and he came into our meeting and shared this incredible story. He tells us the cat comes and goes as he pleases now but is there at the cabin to provide companionship to our new friend on a regular basis. He tells us this was a most powerful spiritual experience and does not want to minimize its importance in his new life. As of this writing, he is 1 month sober but already has a sponsor and is working on his steps.

### Tradition Five APRIL 1948

Says the old proverb, "Shoemaker, stick to thy last." Trite, yes. But very true for us of AA. How well we need to heed the principle that it is better to do one thing supremely well than many things badly.

Because it has now become plain enough that only a recovered alcoholic can do much for a sick alcoholic, a tremendous responsibility has descended upon us all, an obligation so great that it amounts to a sacred trust. For to our kind, those who suffer alcoholism, recovery is a matter of life or death. So the Society of Alcoholics Anonymous cannot, it dare not, ever be diverted from its primary purpose.

Temptations to do otherwise will come aplenty. Seeing fine works afoot in the field of alcohol, we shall be sorely tempted to loan out the name and credit of Alcoholics Anonymous to them; as a movement we shall be beset to finance and endorse other causes. Should our present success continue, people will commence to assert that AA is a brand-new way of life, maybe a new religion, capable of saving the world. We shall be told it is our bounden duty to show modern society how it ought to live.

Oh, how very attractive these projects and ideas can be! How flattering to imagine that we might be chosen to demonstrate that olden mystic promise: "The first shall be last and the last shall be first." Fantastic, you say. Yet some of our well-wishers have begun to say such things. Fortunately, most of us are convinced that these are perilous speculations, alluring ingredients of that new heady wine we are now being offered, each bottle marked "Success"!

Of this subtle vintage may we never drink too deeply. May we never forget that we live by the grace of God—on borrowed time; that anonymity is better than acclaim; that for us as a movement poverty is better than wealth.

And may we reflect with ever deepening conviction, that we shall never be at our best except when we hew only to the primary spiritual aim of AA. That of carrying its message to the alcoholic who still suffers alcoholism.

### THE LANGUAGE OF THE HEART PART 1: 1944-1950

### Tradition Seven JUNE 1948

Our growth continuing, the combined income of Alcoholics Anonymous members will soon reach the astounding total of a quarter of a billion dollars yearly. This is the direct result of AA membership. Sober we now have it; drunk we would not.

By contrast, our overall AA expenses are trifling.

For instance, the AA General Service Office now costs us \$1.50 per member a year. As a fact, the New York office asks the groups for this sum twice a year because not all of them contribute. Even so, the sum per member is exceedingly small. If an AA happens to live in a large metropolitan center where an intergroup office is absolutely essential to handle heavy inquiries and hospital arrangements, he contributes (or probably should contribute) about \$5.00 annually. To pay the rent of his own group meeting place, and maybe coffee and doughnuts, he might drop \$25.00 a year in the hat. Or if he belongs to a club, it could be \$50.00. In case he takes the AA Grapevine, he squanders an extra \$2.50!

So the AA member who really meets his group responsibilities finds himself liable for about \$5.00 a month on the average. Yet his own personal income may be anywhere between \$200 and \$2,000 a month—the direct result of not drinking.

"But," some will contend, "our friends want to give us money to furnish that new clubhouse. We are a new small group. Most of us are still pretty broke. What then?"

I am sure that myriads of AA voices would now answer the new group saying, "Yes, we know just how you feel. We once solicited money ourselves. We even solicited publicly. We thought we could do a lot of good with other peoples' money. But we found that kind of money too hot to handle. It aroused unbelievable controversy. It simply wasn't worth it. Besides, it set a precedent which has tempted many people to use the valuable name of Alcoholics Anonymous for other than AA purposes. While there may be little harm in a small friendly loan which your group really means to repay, we really beg you to think hard before you ask the most willing friend to make a large donation. You can, and you soon will,

pay your own way. For each of you these overhead expenses will never amount to more than the price of one bottle of good whiskey a month. You will be everlastingly thankful if you pay this small obligation yourselves."

When reflecting on these things, why should not each of us tell himself: "Yes, we AAs were once a burden on everybody. We were 'takers.' Now that we are sober, and by the grace of God have become responsible citizens of the world, why shouldn't we now about-face and become "thankful givers"! Yes, it is high time we did!"

# Guardian of AA

Our General Service Conference - From the April

1958 Grapevine

EVERY AA wants to make sure of his survival from alcoholism, and his own spiritual well-being afterward. This is just as it should be. He also wants to do what he can for the survival and well-being of his fellow alcoholics. Therefore, he is bound to have a vital interest in the permanence and well-being of AA itself.

In his AA group, every good member feels deeply about this. He knows, once the miracle of sobriety has been received, that Providence expects all of us to work and to grow--to do our part in maintaining our blessings in full force. A perpetual miracle—with no effort or responsibility on our part--simply isn't in the cards. We all understand that the price of both personal and group survival is willingness and sacrifice, vigilance and work.

What is so true for each member and for each group must also be true for AA as a whole. Yet many of us have never given this self-evident proposition the thought it deserves. We are apt to take it for granted that AA, as a whole, will go on forever--no special attention or contribution being required of us. Save an occasional glow of pride in AA's size and reach, it is possible that half of AA's members and groups still have little active concern for the total welfare. That isn't negligence on their part at all. They simply haven't seen the need.

There are two good reasons for this. One is that AA as a whole has never run into any trouble. The other is that, until recently, a small group of AA's old-timers--acting as parents--have tended to the perils and problems of our whole Society without consulting the membership very much about such matters.

Never have we had a problem that cut clear across us. The public admires us; our friends love us; religion and medicine are in our corner. Nobody has seriously exploited us. We have avoided public controversy. The world's political strife hasn't touched us. We haven't had even one full-sized family quarrel. While members and groups have had just about all the woe there is, AA as a whole has never had any. This is the miracle of our twenty-three years of existence.

No wonder so many truly believe that nothing can ever happen to AA itself!

That we have been so long exempt from the pains that all nations and societies must suffer is something for the deepest gratitude. But we certainly cannot presume that this benign phenomenon will last forever. I, for one, do not think that it should last. We can never call ourselves grown-up until we have successfully met with all those temptations and problems that invariably harass every large grouping of men and women. This will be good for us--very good, I'm sure.

Someday, we may have to resist all the pressure that a destruction-bent world can put upon us in this craziest and most perilous century that the human race has ever seen. As a fellowship, we shall always need to make whatever sacrifices are necessary to insure AA's unity, service, and survival, *under any conditions whatever*. That is why I'm now writing to you about AA's General Service Conference, the guardian of our future.

Until recently, we have behaved like a still-young family. This family, like all families, has had parents. These parents have been the so-called old-timers and originators of AA. I was fortunate enough to have been one of them. Since the earliest days, we parents have been more concerned with the future welfare of AA than with anything else. At local levels, we old-timers used to look after things; until very recently, Dr. Bob and I, mightily assisted by dedicated alcoholic and nonalcoholic friends, have been doing the same at national and international levels.

As parents of AA, we had to see to it that our growing brood was protected against itself, and against the world outside. Very early, our family had to have principles to live by, and schooling in those principles. The good news of AA had to be spread far and wide, so that we could grow in numbers as well as in quality. Such were our responsibilities.

It was in 1937 that Dr. Bob and I first began to see what we must do. We knew there would have to be an AA text of principles and methods. Other old-timers agreed. By 1939, with lots of help, we had published the Big Book, *Alcoholics Anonymous*. This ended all doubt about AA's methods. The 300,000 Big Books today in circulation [by the middle of 1980, about 2,500,000] constitute the platform of recovery upon which our whole Fellowship stands.

We next realized that AA would have to have publicity--lots of it, and of the right kind. We commenced work on this problem. Maybe half of today's members owe their lives and their fortunes to the telling efforts of the press and other means of communication.

From 1940 to 1950, we were beset by group problems of every sort, frightening beyond description. Out of these experiences, the Twelve Traditions of AA were forged--Traditions that now protect us against ourselves and the world outside. This effort, requiring immense office correspondence and experience, finally resulted in a whole new literature dealing with AA's unity and services. Under these influences, we grew solid.

The news of AA began to spread around the world, finally reaching into seventy lands [in 1980, 106]. This brought a host of new problems and the need to publish AA literature in many tongues. Hospitals and prisons and Loners and men on ships also had to be reached and helped. AA's lifelines had to extend everywhere. AA needed a monthly magazine. Today, the AA Grapevine reaches 40,000 subscribers [128,000 now], plus countless thousands of others each month.

These have been the duties and privileges of our parenthood worldwide. We did our best to protect AA so that it could grow undisturbed. Not troubling the growing family about these critical matters, we acted on the principle that "Father knows best." In the early days, it was just as simple as that. It was then far too soon to throw the full weight of responsibility onto our whole Fellowship.

From the beginning, Dr. Bob and I found that we needed special help ourselves. Therefore, we called upon certain dedicated nonalcoholics to give us a lift. With these men, we formed a trusteeship for Alcoholics Anonymous. It was created way back in 1938, and we called it the Alcoholic Foundation (since renamed the General Service Board of AA). In 1940, our trustees acquired the AA book and assumed full responsibility for AA's general funds, its world service office [now the General Service Office], and its public relations.

To this body of trustees—alcoholic and nonalcoholic-must go most of the credit for making our world Headquarters what it now is. In our new history book, AA Comes of Age, you can read what they did for us in our pioneering time as the moving drama of AA unfolded.

During the year 1948, we workers at AA's Headquarters got a terrific jolt. Dr. Bob was stricken with a consuming and slowly fatal malady. This created a severe crisis in our affairs, because it made us face up to the fact that the old-time parents of AA weren't going to last forever.

We were filled with foreboding as we realized how insecure were the existing links between our head quarters and the vast sprawling Fellowship that it served. There was of course, Our small board of trustees. But not one AA in a thousand could name half of them. At the head quarters office, there were Bobbie, Ann, and Charlotte. There were Dr. Bob and myself. We few were just about the *only links* to worldwide AA!

Meanwhile, thousands of our members went serenely about their business. They knew little or nothing about AA's overall problems. They vaguely supposed that God, with maybe a slight assist from Dr. Bob and me, would go right on handling them. Thus, they were completely ignorant of the actual state of our affairs, and of the awful potential there was for an ultimate collapse.

It was a racking dilemma. Somehow, AA as such-AA as a whole--would have to take over the full responsibility. Without doubt, the groups would have to elect numerous delegates and send them to New York each year, where they could sit with and guide the trustees. Only by so doing could AA assume effective direction of its own policy and business. Only through these elected delegates could the increasing isolation of the trustees from the movement itself be halted. Only such a body could take binding decisions in any future crisis.

When our scheme for a joint conference of trustees and delegates was first proposed, a howl went up country-wide. At first, it looked as though the AA family didn't want any part of this new and unexpected responsibility. To them, "AA delegates" spelled nothing but politics, controversy, and confusion. "Let's keep it simple," they cried.

But after a couple of years of agitation and education, our Fellowship clearly realized that the ultra simplicity of the early days could be no more. Direct family responsibility there would have to be, or else AA would fold up at its very center. The erstwhile elders, fathers, and founders would have to be taken off the hook and replaced by delegates. There was no other way. The family would have to "come of age" or suffer dire penalties for failure to do so.

So we called in some seventy-five delegates from the U.S. and Canada. Together with the trustees and the Headquarters and Grapevine staff, those delegates formed themselves into the General Service Conference of Alcoholics Anonymous. By then, it was 1951.

At first, this was an experiment, pure and simple. If it worked, it would mean that AA had truly "come of age," and could really manage its own affairs. Through its representative Conference, it could become the guardian of its own future and the protector of its own lifelines of service.

Well, our Conference did work. Its performance, God be thanked, exceeded all our expectations. At the end of its five-year experimental period, we knew that it could become a permanent part of our Fellowship.

In July of 1955, at AA's twentieth anniversary, I stood before the great St. Louis Convention. Amid a dwindling band of old-timers, and on their behalf, I delivered the destiny of AA into the hands of its chosen representatives, the General Service Conference of Alcoholics Anonymous. I cannot remember any happier day in my life. A gaping chasm had been bridged. AA was secure at last

Some people still ask these questions: Will the AA family send to the Conference its finest delegates? Will we continue to choose able and wise trustees? Will AAs back their Conference members, their trustees, and their world Headquarters with enough funds, enough interest, and enough understanding?

For me, these are questions no longer. The history of AA shows that whenever a great need arises, that need is always met. In this respect, I'm quite sure that our history will go on repeating itself. Indeed, I can have no doubt whatever.

I think, too, that my own influence at the Headquarters should continue to lessen. Through its Conference, complete authority and responsibility are now fully vested in AA. The parent who overstays his time can only hamper the growth of his offspring. This, I must not do. My proper place will soon be along the sidelines, cheering you newer ones as you carry on. Our family is now fully of age, and it should firmly remind me of that fact if I am ever again tempted to take charge.

For these all-compelling reasons, my friends, the future belongs to you. Embrace these new responsibilities eagerly; fear naught; and the Grace of God will surely be yours.







### **NORTHERN LIGHT PRIMARY PURPOSE:**

- ♦ Keep informed of activities and issues going on within Alcoholics Anonymous as a whole. The N.L. Committee could subscribe to the Grapevine or other pertinent A.A. news sources.
- ♦ Gather useful service information to publish from sources within the Area, Region and A.A. as a whole. Obtain, read and use other Area newsletters.
- Listen to comments from the Area on the content of the N.L.

### **EDITORIAL POSITION & N.L. COMMITTEE:**

**Editor**: The Editorial Chair position is a two-year rotation picked by the incoming Area Chair and either approved or rejected by the Area Committee at the first Area meeting after the Fall Assembly Elections.

**Desirable qualifications:** Current knowledge of MS Publisher, MS Word, MS Excel and other misc. computer programs as needed. The person should also consider the time needed to complete the task required. The candidate should have a working knowledge of A.A. as a whole, i.e., prior experience in service work such as G.S.R., D.C.M., or related position.

**N.L. COMMITTEE**: The N.L. Committee consists of the Area Group Records Chair, Area Webmaster and Area Audio Technician along with two D.C.M.s in Area 35. DCM's are picked randomly at the start of each rotation and serve on a two-year rotation basis. They assist the editor in communications with other area newsletters, in recommendations on general improvements, and with general problems and implementations of new policies. They may also represent the editor at functions when the editor is unable to attend.

**N.L. COMMITTEE MEETINGS:** The Committee meets every other month, before the start of the Area Workshop and at Spring and Fall Assemblies. If needed, additional meetings may be called.

### **NORTHERN LIGHT SUBMISSIONS:**

General submissions are welcome! Feel free to send letters or articles that are pertinent to AA and Area 35. All submissions will be approved by the Northern Light committee, in accordance with Tradition Two; For our group purpose there is but one ultimate authority – a loving God as He may express Himself in our group conscience. Our leaders are but trusted servants; they do not govern. Please note that if space is limited, first priority will be given to reports from Area Officers, Area Standing Committee Chairs and D.C.M.s from Area 35.

All submissions should have a title. Please include the first name, last initial and city where the author is from. Anonymous submissions will not be accepted. If you have any questions regarding submitting an item for the *Northern Light*, please do not hesitate to contact me. Thank you!

### **Area 35 Event Flyer Guidelines**

To be included in the Northern Light, all flyers must answer the following questions.:

- 1. Who is involved or sponsoring the event? Examples:
  - a) AA Group
  - b) District
  - c) Area
- 2. What type of event is it? Please include itinerary. Examples:
  - a) An open or closed meeting
  - b) Speaker meeting
  - c) Call up meeting
  - d) Big Book meeting
  - e) Workshop with itinerary
  - f) Conference with itinerary
  - g) Fellowship (ice cream socials, potlucks, chili cook offs, etc.)
  - h) AA must appear somewhere on the flyer
- 3. When is the event to take place?
  - a) Date and time
  - b) Does it reoccur
- 4. Where will the event take place?
  - a) Name of the facility and the address
  - b) Maps are sometimes helpful but not necessary
- 5. Why is the event taking place?
  - a) The reason for AA events is to carry the AA message to the still suffering alcoholic (this doesn't have to be printed on the flyer)
  - b) Usually covered in Who and What

\*For safety reasons, if a phone number is listed on the flyer consider NOT putting a name in association with the number.

Only Area 35 AA members may submit a flier. Fliers for AA sponsored events only.


# AREA 35 EVENTS INCLEMENT WEATHER PROCEDURE

### Q: Why list our past Delegates?

### A: They are a resource to you!

In Alcoholics Anonymous we value experience. Our Twelve Steps did not exist when Bill stepped into the lobby of a hotel in Akron, Ohio. Even after meeting with Dr. Bob and soon founding our program, there were only six steps until the experiences of 100 Alcoholics were summed up. Soon after a book followed, but it was a few years later when the Twelve Traditions were discussed and agreed on. Twelve Traditions that were "hammered out on the anvil of experience". Our past Delegates are a wealth of experience, an interactive living archive if you will. When you plan your next service workshop or need an outside voice to offer help, consider this resource available to you.

### The Delegate's Duties

Though the high point is the Conference meeting, the delegate's job goes on year-round and involves all aspects of the Conference structure. The delegate should:

- Attend the Conference meeting in April, fully prepared. Immediately upon election, every delegate is put on the G.S.O. mailing list to receive Conference materials.
- Communicate the actions of the Conference to area committee members and encourage them to pass on this information, and the delegate's enthusiasm, to groups and to intergroups/central offices. If an area is too large for the delegate to cover in person, he or she will ask area officers and committee members to share the load.
- Be prepared to attend all area, state/provincial, and regional service meetings and assemblies. From these meetings, delegates come to better understand their own areas and can make suggestions for the Conference agenda. Here, too, they come in contact with A.A. members who might not be reached otherwise.
- Help area committees obtain financial support for the area and G.S.O.
- Provide leadership in solving local problems involving the A.A. Traditions

- Remind G.S.R.s to inform groups and individuals about the A.A. Grapevine and Conference-approved literature.
- Cooperate with G.S.O. in obtaining information—for example, making sure that up-to-date information reaches G.S.O. in time to meet the deadline for each Issue of the A.A. directory and helping carry out the triennial membership surveys.
- Visit groups and districts in the area whenever possible.
- Work closely with committee members and officers, sharing experience throughout the year. After G.S.R.s and committee members have reported on the Conference, learn from these A.A.s how groups and members have reacted.
- Assume added responsibility if the area chair and alternate chair are unable to serve. Or, if an area committee is not functioning effectively, the delegate may take an active role in remedying the situation.
- Keep the alternate delegate fully informed and active, so that the alternate can replace the delegate in an emergency.
- Late in the second term, work with newly elected delegates to pass along a basic knowledge of Conference proceedings and problems.
