

Delegate Report for August 3, 2025

First, I would like to correct a misprint I made. It was District 11, which was in Isanti at the Report Back and not District 16.

I would like to thank District 13, District 21, District 15, District 8, District 3, District 1, and District 2 for having me present the Report-Back from the General Service Conference. This included two tailgates, two potlucks, and one with coffee, donuts, and fruit. It also included some district meetings. It is wonderful to see A.A. fellowship in action. Thank you all for your service.

Registration is open for the West Central Regional Forum, which will be held from September 19-21, 2025, in Omaha. There is flyer information available on the table. For those who cannot attend in person, a "live audio only" option is being offered. Pre-registration is encouraged, but on-site registration will also be available.

If you plan to attend in person, please make your room reservations by August 28, 2025, to secure the rate of \$137.00 per night. The pre-registration OR code is on the table, or I can email you a link. You can also register at aa.org by navigating to the Calendar of Events and selecting the West Central Regional Forum.

The AA Grapevine Corporate Board will have a vacancy for the position of Non-Trustee Director following the General Service Conference in April 2026. The Board of Trustees has requested that the AA Grapevine Board's

recommendation be presented for this position to the trustees' Nominating Committee for review by its January 2026 meeting. Since resumes need to be screened and applicants interviewed by members of our Corporate Board in a timely fashion, the process must begin well in advance. They plan to review resumes in the second half of November so that we can schedule interviews during December of this year. They therefore ask that completed resumes be submitted by Wednesday, November 12, 2025.

Steve L., Past Delegate, and I received a letter from the secretary of the GSC Committee for Report and Charter. It stated, Your proposal in Area 35, was included in the discussion of the following agenda item, "Consider a request to expand Article Three in the Conference Charter to protect the co-Founders' writings," by the Conference Committee on Report and Charter. This agenda item resulted in the following Committee Consideration: The committee recommended that the General Service Board classify all AAWS and AA Grapevine literature written prior to 1971 as Recovery, Service, or Archival/Historical; review existing policies and consider proposing additional policies as appropriate for updating each classification, and that a progress report be provided to the 2026 General Service Conference. Once again, thank you and Area 35 for your participation in the General Service Conference process.

Just a reminder: We have an Election Assembly coming up in October at the Area 35 Fall Assembly. Please review all resumes for the delegate position. The Delegate and the Alternate Delegate will be elected from these resumes.

Nominations will also be taken for the positions of Area Chairperson, Area Secretary, and Area Treasurer. If you would like to nominate someone for these positions and you are a voting member of the assembly, please ask them if they are interested in the position before nominating them. We have many A.A. members who would make excellent officers. Please help us choose the best candidates.

More than 34,000 members and guests from over 90 countries were present to celebrate the International Convention in Vancouver.

The 8th and 11th floors at the General Service Office will be consolidated to the 11th floor only. This will not only realize a savings in occupancy costs but also allow for better collaboration and effectiveness among all departments and services we provide. This consolidation will require modifications to our 11th floor office space to accommodate our Publishing and Communication Services Departments, which currently are on the 8th floor.

In order to keep associated costs and disruption to services to a minimum, the office will be operating remotely beginning Monday, August 11, and will do so for the duration of the project, which is expected to be about 10-12 weeks. Please know that our mail and shipping operation and our phones will be operational throughout. Unfortunately, visiting the office during this time will not be possible, but GSO tours will resume when the project is complet-

### **OLD BUSINESS**

-Ad hoc Committee updates- We have been discussing when the Area voting procedures uses  $2/3^{rd}$  Substantial Unanimity and when to use Simple Majority. At this time, we could only verify that we use  $2/3^{rd}$  Substantial Unanimity for Fall elections, voting on Proposed Agenda Items and possibly the Area Budget. We have no policy that clarifies this procedure and in the past the decision has been left to the discretion of the Area Chair. We would like to create a policy on how/when to use 2/3 Substantial Unanimity vs. Simple Majority. The Service Manual page 25 suggests a standard for Substantial Unanimity is typically employed for issues that are controversial or complex as well as elections. A Simple Majority is typically defined as one-half plus 1 vote cast and is generally used for simple or routine matters. The use of Substantial Unanimity can help promote unity in the Area body. Please review the proposed new policy with your GSR's for discussion and vote at Fall Assembly.

"Before any business has begun, We suggest the Chairperson confirms with a vote from the body what business items should use 2/3 Substantial Unanimity for passage of a vote and what passes with a simple majority.

### **NEW BUSINESS**

-Archives Presentation- by Cathy R. - some items presented on Power-Point- Many editions of the Big Books- Tapes of First Trustees speechspeech given by Ebby, West Central Regional Conferences etc. Many editions of the Twelve Steps and Twelve Traditions, all items in archives are available to you- it is not a library to check things out, you remain onsite to review. Contact the Archivist Marc, or Cathy Archives Chair to visit. Marc posed some questions, one being how does the archives help the still suffering alcoholic? It is through us by getting information from the archives and passing it on. Members' contributions to archives are very important to keep our archives in good condition. The Archives Repository is open before and after ACM's and by appointment. In early 2000's an action was passed to put the archives on our webpage, which didn't happen. Hopefully soon there will be an index on the webpage for what's available from our archives. Archives do not get as many items as they used to besending in event flyers, district minutes, any recordings from meetings so we can document our history. This is a spiritual program, it's not about money, it's about participation.

-Discussion to go back to using Zoom as a virtual option- Zoom is much more hackable and data privacy- there is no control over data privacy- Microsoft Teams has tighter controls-

There has been issues with Teams-

- Microsoft 365 is a great for streamlining and keeping access to previous rotations emails and documents-

-Not to stop using Microsoft 365 but to add Zoom as a virtual option-possibly using Teams for internal committee meetings also the option of using Zoom for external meetings or events

- a little more than 40 people joined the Area 35/36 joint meeting held on Teams, 5 people that couldn't get into the breakout rooms, 2 that were beyond the control of Teams-

-how many people attended workshops to learn teams? 5, 2, 0 no one else responded- part of the issue is people don't want to make the effort to learn. Webmaster is willing to help and understand how to use Teams

-at a breakout session from joint workshop it was asked what participants thought of the Teams experience and if they would prefer Teams or Zoom-100% said Zoom

-I can use teams however we have had problems with others logging in every time we have used it- It's not about me being able to use it, it's about others and being more accessible to them.

-Literally hundreds of different workshops, meetings etc. From FB Groups I attend use Zoom- never seen anything other than Zoom- Trustees from GSB, Delegates, etc... all on Zoom platform

-Teams is not as accessible to the general AA members- we want to be accessible- not asking to discontinue using Teams- just add Zoom as an option when we are asking others to join us like at the GSR Workshop, Area 35/36 joint workshop any hybrid Assemblies/ etc...

- Pro/Con Discussion at Fall Assembly

- I don't understand technology- the 3 or 4 times I have used Teams there has always been an issue- when I attend with zoom, they send me a link, and I just click on the link- much easier

-Zoom can be secured through the use of settings- doesn't understand how we could lose anonymity using zoom

-Recording meetings using Teams is anonymity break as it records everything- faces, transcripts, chats etc... if you record using Zoom it also records if you Chat? - I can't rename myself on Teams as I can on Zoom

- Zoom is used by the Office of Alcoholics Anonymous and the West Central meeting – with all the online meetings I attend I have never seen anywhere else use Teams -

-Office 365 is wonderful

- we are wasting people's time if we have a 2-hour meeting and we spend 30 minutes figuring it out- I was kicked out of breakout room using Teams had to be teleported back in- not a good use of time- doesn't feel it is the platform for us-

-Sending Officers to West Central Regional Forum(WCRF) – Last October the GSR's were part of the vote to pass the budget which included sending only Delegate and Alt Delegate to WCRF it was felt we couldn't afford to send more- Treasurer's report now is that we have a little over \$20,000 plus a prudent reserve- what do you think GSR's would think if we made a decision to send Area Officers and Chairs to the WCRF?- Do we want to reconsider that?

- If you go keep your receipts and request for reimbursement at the Fall Assembly to see what GSR's say-

-In the past for all the years that I served the Area we have always sent the committee chairs – how can you serve and understand service if you don't go to the WCRF and Conference- if members commit to serve, they should be allowed to go and serve-

-DCM's how do you think your GSR's would respond- there are quite a few GSR's in attendance today-

 When we voted to lower expenses, I asked my group, and I couldn't vote today without discussing it with the group-

-I would love to go to the WCRF-I did not go to the WCRSC last year because of the nonsupport-I like the idea if we save receipts and take a vote on it at the Area Assembly- we are trusted servants of the fellowship we make a commitment to serve and be involved-

my Group is still trying to pay me back from the spring assembly- we are a small group of 4-5 people with no reserves- most people still only contribute \$1 or \$2 to the pot- We need to contribute more

-Area Officers/Committee Chairs if they want to go, save your receipts for the Fall Assembly to see if the GSR's will approve-

-Voted at Fall Assembly for the Officers/Chairs to attend virtually- trying to save money by allowing them to attend virtually instead of in person-maybe we need a biannual budget? We need a new way to revisit for times like this when we have money and also at times where money is tight-having a more fluid budget-

-ideas from my groups was that it was important for people to attend these events-

- Wyoming Newsletter from the WCRSC mentioned that "their friends from Minnesota were missing in large numbers" I think we need to try and have a presence.

- in the next 2 years these events will be in Minnesota- that will be cheaper- 2027 every Chair and every Officer should be at the WCRSC and WCRF as it is here in MN

-I think it will make some people angry, GSR's, if we bring receipts back expecting reimbursement-


Proposed Voting Policy for 2/3rd Substantial Unanimity

Before any business begins at an Assembly or Area ACM the Area Chair reviews the business items to discuss. Any potential complex or controversial business items are to be voted on by the body whether to use Substantial Unanimity or Simple Majority.

Again, before any business begins, Voting members of the Assembly or Area Committee may request the Chairperson to take a vote from the body on any item the member deems controversial or complex on whether to use Substantial Unanimity or Simple Majority.

Motion to approve the use of Substantial Unanimity would pass using simple majority vote

Pondering AA on a Warm Minnesota Summer Afternoon:

How Effectively Are We Sharing and Providing Answers to Those Still Suffering from this Fatal Disease: We Now have 90 years of Experience. What Would Bill W. and Dr. Bob say to Us if they Could Come Back to Evaluate the Status of what they Started?

This letter arises from my sometimes curious mind while sitting on our deck on a fine summer day. It is an outcome from a lunchtime discussion with my sponsor regarding a number of my observations of the content of the July/August, 2025 Northern Light. I raise the issues presented in this letter as a matter of concern for the District, and perhaps for all of AA as what I believe is an important topic for those of us who live and attend meetings in Area 35. In a broad sense, these observations touch upon the larger issue of communications between and among us.

Here in the 21st century are we taking advantage of various means of sharing information in a timely, easily accessible manner more in conformance with today's society's expectations? While that major topic is discussed, can our well-documented success story also examine what we need to alter, if anything, to come to the aid of the 21st century person dying from alcoholism? The disease hasn't changed since 1935 when AA was founded; society has changed.

I ask you to read these comments in which I offer in a non-condemning, but honest examination of our newspaper, The Northern Light, created in 1982. None of my observations are intended to criticize the current or past editors; I am not finding fault with the many officers at the Area and District levels who take time to write reports. On the contrary, members of AA who, before their current assignment, have perhaps never written a newsletter article, produce for our society great words for thought and reflection. This newspaper captures for future AA's what has been accomplished by our society over the years, so it's an historical guidepost and we can understand how things have changed...or not.

So what is a relevant list of concerns, shortcomings or down right out-of-date AA practices in newsprint which, from my limited perspective, deserve attention? Can we undertake a process for purposes of communicating more effectively to newcomers, or to people unaware that their living problems stem from the disease for which we have found answers? What various methods of communication can be adopted to communicate with alcoholics, either those in recovery or those who yet don't realize they have a problem? In short, what is the purpose of The Northern Light?

I will ask that this article appear in the upcoming edition of The Northern Light. Since the newspaper is delivered to a relatively small number of subscribers, I will also send a copy of

this letter to the DCM in each of our districts so they can assist in distribution of it to members of each group.

I also will request that it be given time for discussion at the Fall Assembly in Ely sometime during the gathering October 4 & 5.

### From Minnesota... - Delegates to the General Service Conference have had a busy time since April--but not too busy to tell us about it

MY FIRST GENERAL SERVICE CONFERENCE is now a memory, but those few days in New York will never be forgotten. The vital function of General Service Headquarters to our wonderful AA movement became very vivid to me, and I was filled with a feeling of the magnitude and humility of our way of life.

Only a few short and happy years ago AA touched my life; a new group of three members was formed. We met at my home, and I still remember how eagerly I waited for the literature from Headquarters in New York, and how wonderful it was to look through it for the first time after it arrived. I soon found that I had an affiliation with other AAs in other groups, and very soon I learned to know our friend Pat, Minnesota's first AA.

This year at the Conference I met one of Pat's two sponsors, and we talked one night until the early morning hours. Our conversation illustrated so clearly the gratitude we should all have for the existence of our General Service Headquarters. Here is the story:

Pat found the AA "Big Book" in the Minneapolis public library. He opened it to the section "How It Works,"--and a ray of hope came into his life. Somewhere he found the courage to write to New York. People there in turn wrote a letter to the AAs in Chicago. Two men from the small group there took time off and bought railroad tickets to Minneapolis--to give away the wonderful thing they had been given and thus did AA take root in Minnesota. . . .

That morning last spring as I closed my eyes to get a few hours' sleep before our next Conference session, some horrible thoughts flashed through my mind: "What if there had been no place for Pat to write for help!" "What if there had been no letter from New York to Chicago?" "What if there had been no distribution of the Big Book?" I knew then that you could have written "Finished" to many useless and wasted alcoholic lives, because I and most of the AAs in Minnesota owe our very lives to the fact that those letters had a channel—a pipe line—to follow. At our next Conference session when one of the GSH staff members stated, "Direct correspondence with the groups is the life line of service," my heart said a grateful "Amen."

We have been given something very precious in the Third Legacy of General Service. The small staff at Headquarters who now are of service to 7000 AA groups are devoted and dedicated people, and I am confident that when all our members understand the very important part the Conference and General Service Headquarters have played in their own sobriety—and the part they will play in the sobriety of those who are to follow—their hearts cannot help but be filled with gratitude.

Bill W.'s forthcoming new book, "AA Comes of Age," which the Conference learned had now gone to the printers; the projected 90-minute TV show; and the proposed two new pamphlets, tentatively entitled "What Kind of Old Timer Are You?" and "You and Your 1,999,-999 Partners in AA," will be of great service in linking every AA member to our worldwide movement.

As I sit at home writing these few words about the Conference my heart again murmurs a grateful "Amen" and "Thanks." Being a delegate is a mountain-top experience.

# A Place of Either/Or

My name is Alf and I am an alcoholic. I was born in July 1915, and I had my first drink of alcohol in 1925, at the age of ten. It happened this way. Because of prohibition, moonshine was delivered to customers in tin cans. Our brand was called Minnesota 13, and we supplied Al Capone in Chicago. A young man (who later died of alcoholism) poured a little moonshine into a tin cup, added water, and placed it in my hands. I drank it down and my love affair with alcohol began immediately.

My drinking progressed and during my college days in the nineteen-thirties, I first saw tears in my mother's eyes. She and my father came to see me in the county jail where I'd been kept overnight after being stopped by the police while leaving an all-night place called the Bloody Bucket. Perhaps some of you have memories of a place such as that. My road to the pain and darkness that comes with alcoholism had begun.

In 1934, Bill W. was in the hospital in New York, and in Akron, Ohio, Dr. Bob was still getting drunk, even though he was attending Oxford Group meetings. This was also the year when I began attending Oxford Group meetings held at St. Olaf College. Even while getting good grades, I was deep into my alcoholism, knowing that something was wrong and looking for a way to control my behavior while using alcohol.

Attending Oxford Group meetings failed to relieve most of us of the desire to use alcohol, plus most of us didn't care to be preached at about sin and conversion. Pat C., the first AA member in Minnesota, told me how he was living on Skid Row, heard about an Oxford Group meeting being held at a plush hotel in Minneapolis, rented a cheap suit from a pawn shop, went to the meeting, rejected it all, turned his suit in, got a cheap bottle of wine, and got drunk again. My experience with the Oxford Group was identical with Pat's. I rejected it.

My marriage to Genevieve occurred in 1942, and I was still searching for a way to control the effect drinking alcohol had on my behavior. I read Jack Alexander's article on early AA experience that year, hoping that someday it might reach me. AA had arrived in Minnesota in 1940 when Chan F. from Chicago brought the message to Pat C., and because of him, the good news was brought to me in 1944. Two members with only a few months of sobriety drove a great distance to tell me that if I were an alcoholic, as were they, I was at an either/or place in my life. Either I could continue to drink (and if I were alcoholic, tragedy would enter my life), or I could drive a hundred miles to a home where AA meetings were being held once a

The words they spoke were true, but I continued to drink until September 6, 1951, when I surrendered at what I term gut level. There were no AA groups in a two-county area surrounding my home, but an alcoholic with almost a year of continuous sobriety moved to my town, and I called him. The circumstances surrounding this call are called coincidence but to me are a miracle. He told me that all we needed was two persons and God to have an AA meeting. He had no car, so for our first meeting I drove him and his wife to our home. He and I met in our living room and the wives met in the kitchen. At the first meeting we discussed how living the AA way of life would eventually bring balance into the work, play, love, and spiritual aspects of our one-day-at-a-time existence. Our topic came from a small pamphlet printed by the AA group in Akron, Ohio. During the business part of that first meeting, we decided to send five dollars to what we called the "headquarters" in New York City.

It took us a month before we had our third member, but at the end of a year we had about twenty coming to my home. After forty-six years, the group is still in existence. Of those three members, two never drank alcohol again. After many years of continuous sobriety, I relapsed but never stopped going to AA meetings. God was always there for me, and sobriety, one day at a time, returned to me as soon as I became completely honest with myself in all areas of my life.

I served as secretary for the small number of groups we had in southern Minnesota, and in July 1955, the only year the delegates had met outside of New York, I, Genevieve, and our three young children drove to St. Louis for the Second International Convention. There with the delegates seated on the stage, Bill W. made his talk about all that had happened since 1935 and asked us to vote as to whether or not the General Service Conference should become permanent. The vote was taken, and to me, it seemed a unanimous decision that now guidance and direction of our Fellowship belonged to the members. God as expressed through our group conscience became the ultimate authority for our group purposes, working through the General Service process. I still get a warm feeling when I pass by old Kiehl Auditorium in St. Louis. There I met Bill and Lois W., Ebby T., who brought the message to Bill, Father Dowling, Dr. Tiebout, Sam Shoemaker, Nell Wing, Bill's secretary, and many others to whom we owe a great debt of gratitude. I was elected to serve as delegate for Panel 7 (1957-58), the first elected from that Minnesota area after it became permanent.

So the year 1957 found me at the General Service Conference in New York. My name was drawn out of the hat to serve on the Committee of Conference and Charter. Our small committee held meetings in a hotel room, and Bill was always present. He would stretch out his long legs on the bed and talk about his Wall Street days, his spiritual experience, and his concern that even though AA might change in the future, the Twelve Steps should not. An attorney, nonalcoholic, named Bernard Smith was a great help to our committee. He drew up a document for us which, after being presented on the floor for a vote, was accepted by the delegates. The terms of this document make it almost impossible to change the Twelve Steps.

Another thing we accomplished during my term of service was the removal of the word "honest" from the requirement for membership. Prior to this the requirement for membership had been given as "an honest desire to stop drinking alcohol." Now the doors of AA opened even wider as the only requirement for membership became simply a desire to stop drinking alcohol.

Alcoholics Anonymous was spreading over the entire world. At the Conference I noticed a short bald-headed man sitting not far from me. I asked where he was from. I was told he was not a delegate but an observer for Norway. I'm Norwegian, and he and I became close friends. After the Conference I brought him back to Minnesota to show the few small groups we had that now AA was even in Norway. I hauled him around to speak at many groups in southern Minnesota, and the members were always impressed.

Another example of how we tried to impress early members was how my friend lcky S. from Texas used to do it. Icky was an early delegate and trustee. Part of his drunk story included this escapade. During the war he was a demolition expert, and he continued working with explosives after the war. He received a contract to blow up a bridge. While drunk, he blew up the wrong bridge! Ebby T. stayed at Icky's home for some time while trying to stay sober. Bill always called Ebby "my sponsor," even when Ebby was drinking. In 1966, at the age of seventy, Ebby died sober.

Other memories of the Conference include the delegate who asked our general manager, Hank G., who was conducting the session, "Why do we delegates have to stay in this fleabag of a hotel?" The blood rushed to Hank's face; he remained silent and marched out of the room. In a few minutes he returned and said, "If you wish to see fleabag places, I'll give you a tour within a few blocks of here where I used to stay while drinking." I remember the dedication of staff members such as Hazel R., Ann M., and Nell Wing. In my mind's eye, I can still see us passing our Big Books around for everyone to sign, including Bill. I still see Lois making coffee and Bill playing the fiddle at their home. Other memories: Bill walking around with the manuscript of AA Comes of Age, shouting out, "I finally got it finished!"; Naomi B., delegate from Kentucky, and I sitting next to him before his talk about the book, his head bowed and his hands folded as though in prayer. He compared our Fellowship to a cathedral; the Steps being the solid floor, the Traditions becoming the walls holding us together, and beautiful spire representing our service. Naomi began to cry. Her tears flooding down soaked her dress! Tears of joy.

Years later when I had my relapse, Bill really became my friend through one-on-one visits, telephone calls, and letters. He was never judgmental and assured me that the sobriety I'd had in the past would always be a part of me. During this difficult period, I never stopped going to AA meetings, and Bill always tried to help and encourage me, even getting me certain vitamin tablets at a wholesale pharmacy in New York. They had, he thought, helped his depression. Bill died in 1971, and my last drink of alcohol the second time around did not occur until March 3, 1977, which is now over twenty years ago. I believe Bill knows that I am sober today. When I think about it, I get a glow, much better than the glow alcohol produced at the beginning of my drinking days. Thank you, God.

One last word about my relapse. Bill wrote in the "Twelve and Twelve" that "unless one attains some degree of humility, one is condemned to drink again." For me, humility is being honest with myself in all areas of my life and accepting what I find during the examination of my conscience. I was dishonest in one area, and I drank. Today, in the eternal Now, I am honest in that area of my life, and I have no desire to drink—a gift granted me, I believe, by the God of my understanding. As long as I remain honest with myself and try to live by the directions given in the Twelve Steps and the book *Alcoholics Anonymous*, I believe the miracle will continue.

### **AREA OFFICER & ACTION COMMITTEE NL REPORTS**

#### **DELEGATE- DIANE R**

I attended the Dower Lake Campout and gave my report back from the conference around a Saturday afternoon campfire. Thank you, District 18, for inviting me to share. It was a wonderful opportunity for fellowship.

On the third Sunday in August, I attended the online West Central Regional Meeting, which is our yearly business meeting. By the time you read this, the West Central Regional Forum in Omaha will have concluded. Please keep in mind that in 2027, Area 35 will host the West Central Regional Forum. All Area Officers and Committee Chairs should attend this, Forum. Additionally, in 2025, we will host the West Central Regional Alcoholics Anonymous Service Conference (WCRAASC). We want to ensure we have sufficient funds to send all Area Officers and Committee Chairs to this event as well. We should make sure we have funds for both.

The next WCRAASC will be held in Cedar Rapids, Iowa. It is always an excellent opportunity to meet others from our region and to gather information on all agenda items so our area can have an informed group conscience. They also plan to have it as a hybrid event. More information will be available in the next couple of months as they are still busy planning.

Our Regional Trustee, Charlie H., attended the General Service Board weekend in New York, the first weekend in August. The Trustee's Literature would like the 5th Edition Big Book ready to be brought to the 76th General Service Conference for approval. The Conference Literature Committee is reading and grading final stories for the book.

Information from an online Forum reported 7th Tradition of Self Support is \$4.643 million, down 17% from last year. AAWS publishing's gross profits were \$4,346, up 19% from 2024. Program Service Expense before Depreciation -is \$9.34 million, up 2%. Operating surplus before depreciation of \$56,452.

Grapevine has an operating shortfall for the first half of the year of \$240,908. General Fund support of La Vina is \$250,654.

The General Service Board has authorized \$2.1 million from the Reserve Fund for the Retro-Fit and \$350,000 drawdown to Grapevine. That would leave 5.1 million in the reserve fund.

I hope to see everyone at the Area 35 Fall Assembly in Ely, October 4 and 5. It is an election assembly where we choose our next Delegate, Alternate Delegate, Area Chairperson, Area Secretary, and Area Treasury. We have a busy agenda so come and participate and enjoy the fellowship.

During August I traveled to a District 9 meeting at the Hibbing Alano. The intent was to discuss the role of a district archivist. In my opinion a district archivist should preserve items that influence(d) the groups within the district. Items such as district meeting minutes, event fliers, news or stories from individuals or groups that relate to AA life, and more. These need not cost a lot, most can be stored digitally. A scrap book could be utilized to present the artifacts at district or group meetings as a method to make AA attractive. The most important work of AA is to be there when anyone reaches out for help, this is accomplished best by AA member's personal conversations.

There were a few questions about area archives:

Why does it cost so much? The cost is due to renting a secure and accessible, climate-controlled storage space.

Have there been rodent or insect issues? To date I have not seen evidence of rodents or insects.

Are the artifacts insured? No. I searched for insurance, it gets complicated and is costly.

Can AA members listen to the audio recordings? Yes, by requesting of the archivist who will send an mp3 file. There is a plan to add a catalog of audio recordings to the area website.

### **EDITORIAL POSITION & N.L. COMMITTEE:**

**Editor**: The Editorial Chair position is a two-year rotation picked by the incoming Area Chair and either approved or rejected by the Area Committee at the first Area meeting after the Fall Assembly Elections.

**Desirable qualifications:** Current knowledge of MS Publisher, MS Word, MS Excel and other misc. computer programs as needed. The person should also consider the time needed to complete the task required. The candidate should have a working knowledge of A.A. as a whole, i.e., prior experience in service work such as G.S.R., D.C.M., or related position.

**N.L. COMMITTEE**: The N.L. Committee consists of the Area Group Records Chair, Area Webmaster and Area Audio Technician along with two D.C.M.s in Area 35. DCM's are picked randomly at the start of each rotation and serve on a two-year rotation basis. They assist the editor in communications with other area newsletters, in recommendations on general improvements, and with general problems and implementations of new policies. They may also represent the editor at functions when the editor is unable to attend.

**N.L. COMMITTEE MEETINGS:** The Committee meets every other month, before the start of the Area Workshop and at Spring and Fall Assemblies. If needed, additional meetings may be called.

- 3. When is the event to take place?
  - a) Date and time
  - b) Does it reoccur
- 4. Where will the event take place?
  - a) Name of the facility and the address
  - b) Maps are sometimes helpful but not necessary
- 5. Why is the event taking place?
  - The reason for AA events is to carry the AA message to the still suffering alcoholic (this doesn't have to be printed on the flyer)
  - b) Usually covered in Who and What

\*For safety reasons, if a phone number is listed on the flyer consider NOT putting a name in association with the number.

Only Area 35 AA members may submit a flier. Fliers for AA sponsored events only.


## AREA 35 EVENTS INCLEMENT WEATHER PROCEDURE

### Q: Why list our past Delegates?

### A: They are a resource to you!

In Alcoholics Anonymous we value experience. Our Twelve Steps did not exist when Bill stepped into the lobby of a hotel in Akron, Ohio. Even after meeting with Dr. Bob and soon founding our program, there were only six steps until the experiences of 100 Alcoholics were summed up. Soon after a book followed, but it was a few years later when the Twelve Traditions were discussed and agreed on. Twelve Traditions that were "hammered out on the anvil of experience". Our past Delegates are a wealth of experience, an interactive living archive if you will. When you plan your next service workshop or need an outside voice to offer help, consider this resource available to you.

### The Delegate's Duties

Though the high point is the Conference meeting, the delegate's job goes on year-round and involves all aspects of the Conference structure. The delegate should:

- Attend the Conference meeting in April, fully prepared. Immediately upon election, every delegate is put on the G.S.O. mailing list to receive Conference materials.
- Communicate the actions of the Conference to area committee members and encourage them to pass on this information, and the delegate's enthusiasm, to groups and to intergroups/central offices. If an area is too large for the delegate to cover in person, he or she will ask area officers and committee members to share the load.
- Be prepared to attend all area, state/provincial, and regional service meetings and assemblies. From these meetings, delegates come to better understand their own areas and can make suggestions for the Conference agenda. Here, too, they come in contact with A.A. members who might not be reached otherwise.
- Help area committees obtain financial support for the area and G.S.O.
- Provide leadership in solving local problems involving the A.A. Traditions

- Remind G.S.R.s to inform groups and individuals about the A.A. Grapevine and Conference-approved literature.
- Cooperate with G.S.O. in obtaining information—for example, making sure that up-to-date information reaches G.S.O. in time to meet the deadline for each Issue of the A.A. directory and helping carry out the triennial membership surveys.
- Visit groups and districts in the area whenever possible.
- Work closely with committee members and officers, sharing experience throughout the year. After G.S.R.s and committee members have reported on the Conference, learn from these A.A.s how groups and members have reacted.
- Assume added responsibility if the area chair and alternate chair are unable to serve. Or, if an area committee is not functioning effectively, the delegate may take an active role in remedying the situation.
- Keep the alternate delegate fully informed and active, so that the alternate can replace the delegate in an emergency.
- Late in the second term, work with newly elected delegates to pass along a basic knowledge of Conference proceedings and problems.
